INTRODUCTION

SEBASTIEN JANELLE, A HISTORY BUFF, DISCOVERED BY CHANCE ACCORDING TO A COPY OF JEAN BOURDON'S 1640 CARD REWORKED BY PIERRE-LOUIS MORIN FOUND AT THE MONTREAL LIBRARY IN 1970 THAT THE SO-CALLED MAP DID NOT REPRESENT THE CITY OF QUEBEC IN 1640 BUT THAT OF CHAMBLY AND CARIGNAN IN 1640. ACCORDING TO THIS MAP, HE DISCOVERS THE EXACT LOCATION OF THE CHAMPLAIN CHAPEL IN CHAMBLY, THE EXACT LOCATION OF SAMUEL DE CHAMPLAIN'S TOMB IN CHAMBLY, THE EXACT LOCATION OF THE FIRST FORT ST. LOUIS FROM 1626 TO CHAMBLY, AND THE EXACT LOCATION OF THE CHAPEL OF THE RECOLLETS IN CHAMBLY. THE PURPOSE OF HIS PREVIOUS RESEARCH WAS TO FIND THE EXACT LOCATION OF THE CHAMPLAIN CHAPEL AND THE TOMB OF SAMUEL DE CHAMPLAIN. AND, BY CHANCE WITHOUT KNOWING IT ACCORDING TO A POINT ON THE MAP OF 1640 AND FOLLOWING A NATURAL EVENT OF AUGUST 2015 THAT HAPPENED IN THE OLD CHAMBLY HE DISCOVERS THE EXACT LOCATION OF THE EXIT OF THE TUNNEL OF A CAVE GIVING ACCESS TO THE VAULT CONTAINING THE TREASURE OF SAMUEL DE CHAMPLAIN.

SAMUEL DE CHAMPLAIN FOUNDED QUEBEC CITY IN 1608 AND FOUNDED ANOTHER CITY NAMED QUEBEC (CITY OF CHAMBLY AND CARIGNAN) IN 1626.

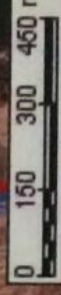

MAIN PART #2

THE MAP OF QUEBEC IN 2016 AND THAT OF CHAMBLY IN 2016 ARE ALMOST IDENTICAL.

IT IS IMPOSSIBLE TO GET THE MAP BY GOOGLE EARTH OF ST. LOUIS CREEK VIA THE QUEBEC TOPONYMY COMMISSION BECAUSE OF THE EXCESSIVE PRESENCE OF MATURE TREES IN THE OLD CHAMBLY. IN THE REGULAR MAP FROM THE SITE OF THE QUEBEC TOPONYMY COMMISSION, THE PART OF THE CREEK THAT COMPLETES THE ISLAND IS MISSING.

BY DIRECTLY LOCATING THE TOPONYMY, THE ST-LOUIS A CHAMBLY CREEK IS ALSO SEPARATED IN TWO BY PASSING IN THE MIDDLE OF THE 3 LANGEVIN ARRIERE FIELD FOLLOWING THE BACK COURSES TO 11 LANGEVIN STREET IN VIEUX-CHAMBLY.

WE DRIVE BETWEEN THE ARRIERE COURSE AT 11 LANGEVIN STREET UNDER IRENEE AUCLAIR STREET TO 3 COOPER STREET. IT IS SEEN IN THE BACK OF 3 COOPER STREET TO RETURN TO THE CHAMBLY CANAL STRIP AT THE MAIN BRANCH OF ST. LOUIS CREEK.

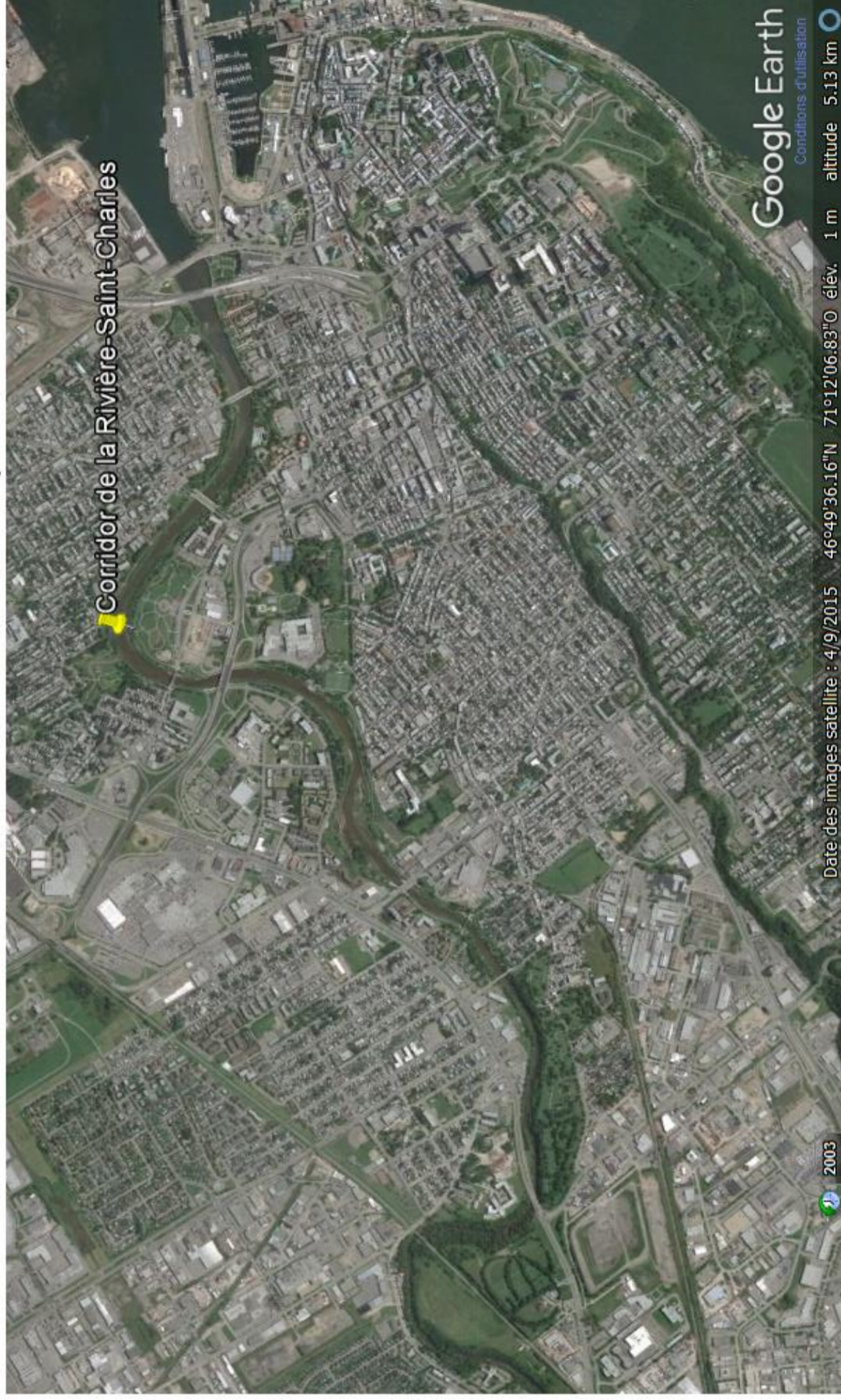
WE'RE BURIED BELOW THE STREET IRENNÉE AUCLAIRE, BETWEEN THE 1ST AND 3RD LANGEVIN IN THE OLD CHAMBLY.

IF THE MAP OF 1640 WOULD BE THAT OF QUEBEC IN 1640, IT WOULD HAVE INDICATED RIVIERE AND NOT STREAM.

ESPECIALLY SINCE QUEBEC DEMONTRE PRESENTS THE BASIN LOUISE WHICH WAS THERE IN 1640 THAT IS NOT FOUND ON THE MAP OF 1640.

SO THE MAP OF 1640 DID NOT REPRESENT QUEBEC IN 1640 BUT CHAMBLY IN 1640.

IN QUEBEC, THERE IS THE UPPER CITY AND THE LOWER TOWN

IN CHAMBLY, THERE IS ALSO THE UPPER CITY AND THE LOWER TOWN.

THE 1640 MAP ROAD THAT STARTS FROM NOTRE DAME STREET OR THE LOWER TOWN TO THE UPPER TOWN IS MOUNTAIN STREET AND ENDS UP IN THE TOWN OF CARIGNAN IN 1626 WHICH WE WILL SEE IN PART 3.

THE CEMETERY AND FORT ARE LOCATED IN THE UPPER CITY.

THE CLOSURE OF SIEUR COUILLARD DELIMITE HAS CHAMBLY THE LOWER TOWN AND UPPER TOWN OF THE ST-PIERRE COAST (YULE BRIDGE) TO ST. LOUIS CREEK WHICH THREW ITSELF INTO THE CHAMBLY BASIN.

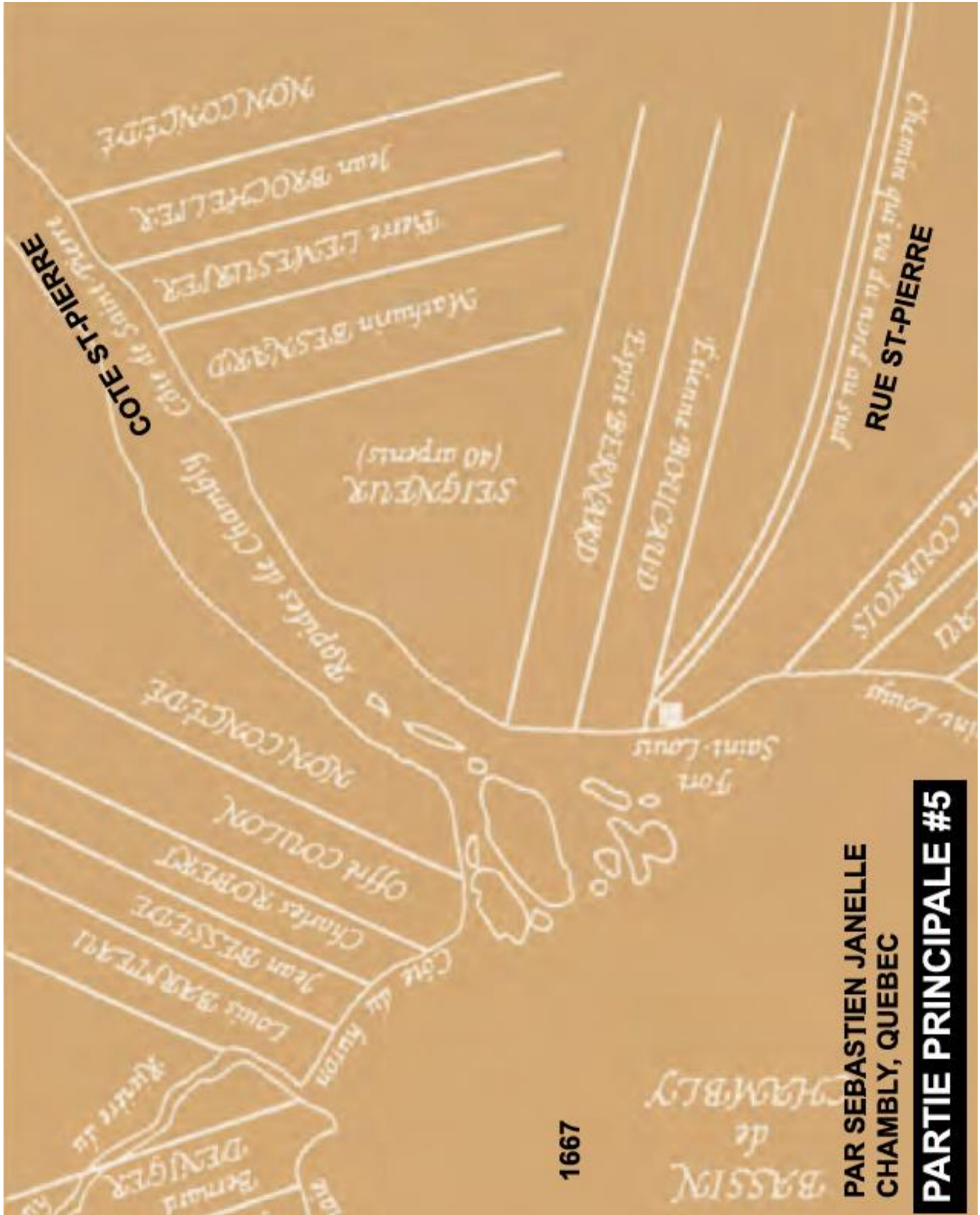
MAIN PART #5

ON THE 1667 CHAMBLY MAP OF THE CONCEDED SEIGNRIES, THE PART OF THE MAP WAS CUT BEFORE FORT ST. LOUIS IN 1626.

HOWEVER, INSTEAD OF SHOWING US THE BUILDINGS AND THE FORT STREET THAT RUNS FROM THE LOCATION OF MR. BOURDON TO THE FORT ACCORDING TO THE MAP OF 1640, WE ARE SHOWN THE STREET THAT RUNS FROM FORT ST. LOUIS (CHAMBLY) OF 1665, ST. PIERRE STREET AND THE MENTION OF THE ST-PIERRE HILL AT THE TOP OF THE CHAMBLY RAPIDS.

IF WE TAKE THE MAP OF QUEBEC IN 2016, WE CAN SEE THE LOCATION OF ST-PIERRE STREET AND THE ST-PIERRE COAST ON THE BANKS OF THE ST. LAWRENCE RIVER.

THIS CONFIRMS THAT CHAMBLY IS A SMALLER REPRESENTATION OF QUEBEC IN 1640; CHAMBLY AND QUEBEC ARE ALMOST IDENTICAL TO THE EXCEPTION OF THE LOUISE BASIN, WHICH IS IN QUEBEC. WHAT CONFIRMS US THAT THE MAP OF 1640 IS INDEED THE ONE TAKING OVER CHAMBLY IN 1640.

- SEBASTIEN JANELLE LOCATES THE ST-PIERRE COAST ON THE MAP ACCORDING TO THE MAP OF CHAMBLY IN 1667.

POINT A IS ND OF RECOUVERANCE LOCATED AT THE INTERSECTION OF THE STREET VIENS AND BOURGOGNE STREET, IN FRONT OF THE CHURCH OF THE HOLY HEART OF MARY.

POINT B IS THE SITE OF THE REMAINS OF THE CHAMPLAIN CHAPEL LOCATED BETWEEN THE BACK CORNER OF THE CHURCH OF THE HOLY HEART OF MARY AND THE STREET VIENS. THERE IS NO REASON WHY THIS STREET SHOULD BE LIKE THIS INSTEAD OF BEING IN A STRAIGHT LINE EXCEPT TO BYPASS THE REMAINS OF THE CHAPEL CHAMPLAIN. LOOK AT THE IMAGE OF THE QUEBEC TOPOLYMIE COMMISION, THE VERY WIDE STREET BEFORE THE CITY REDOES IT IN EARLY 2010.

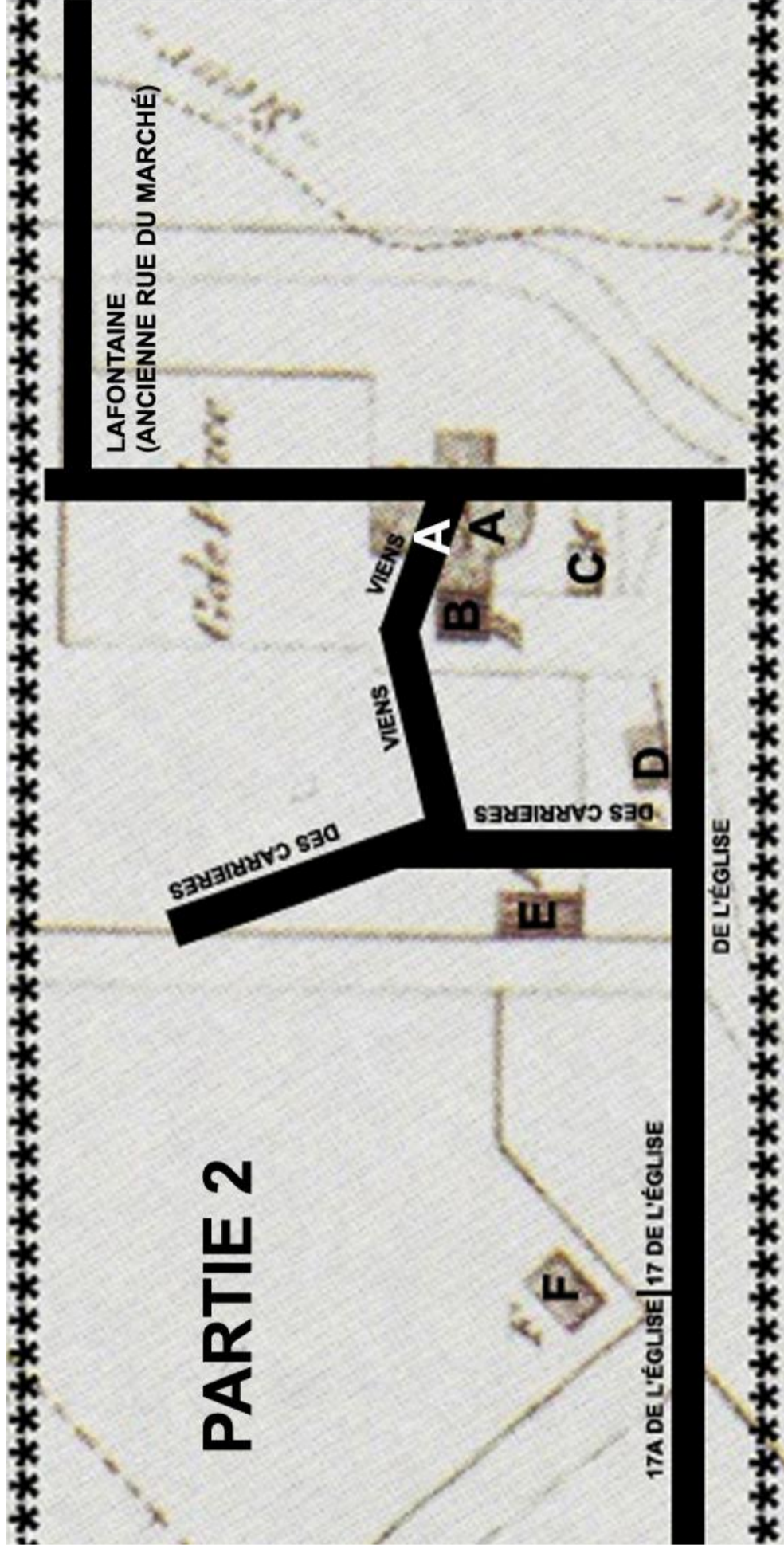
AT THE PLACE OF BUILDING C, THE PRESBYTERY IS LOCATED IN THE SAME PLACE AS THE FORMER PRESBYTERY OF THE HOLY HEART OF MARY.

THE CHURCH OF THE HOLY HEART OF MARY OF 1956 IS LOCATED BETWEEN POINTS A B C.

POINT D, MR. BOURDON IS THE SITE OF THE CHAPEL THAT BURNED DOWN ON MAY 21, 1957. PHOTO A L'PRESSE.

THE E POINT, THE LOCATION OF THE HUNDRED ASSOCIATES IS THE CHURCH WHICH LATER BECAME A FUNERAL SALON AND NOW THE OFFICES OF THE FUNERAL SALON.

POINT F, THE LOCATION OF THE SENECHAUSE WHICH IS LOCATED WHERE ARE THE HOUSES OF 17 AND 17A OF THE CHURCH.

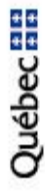

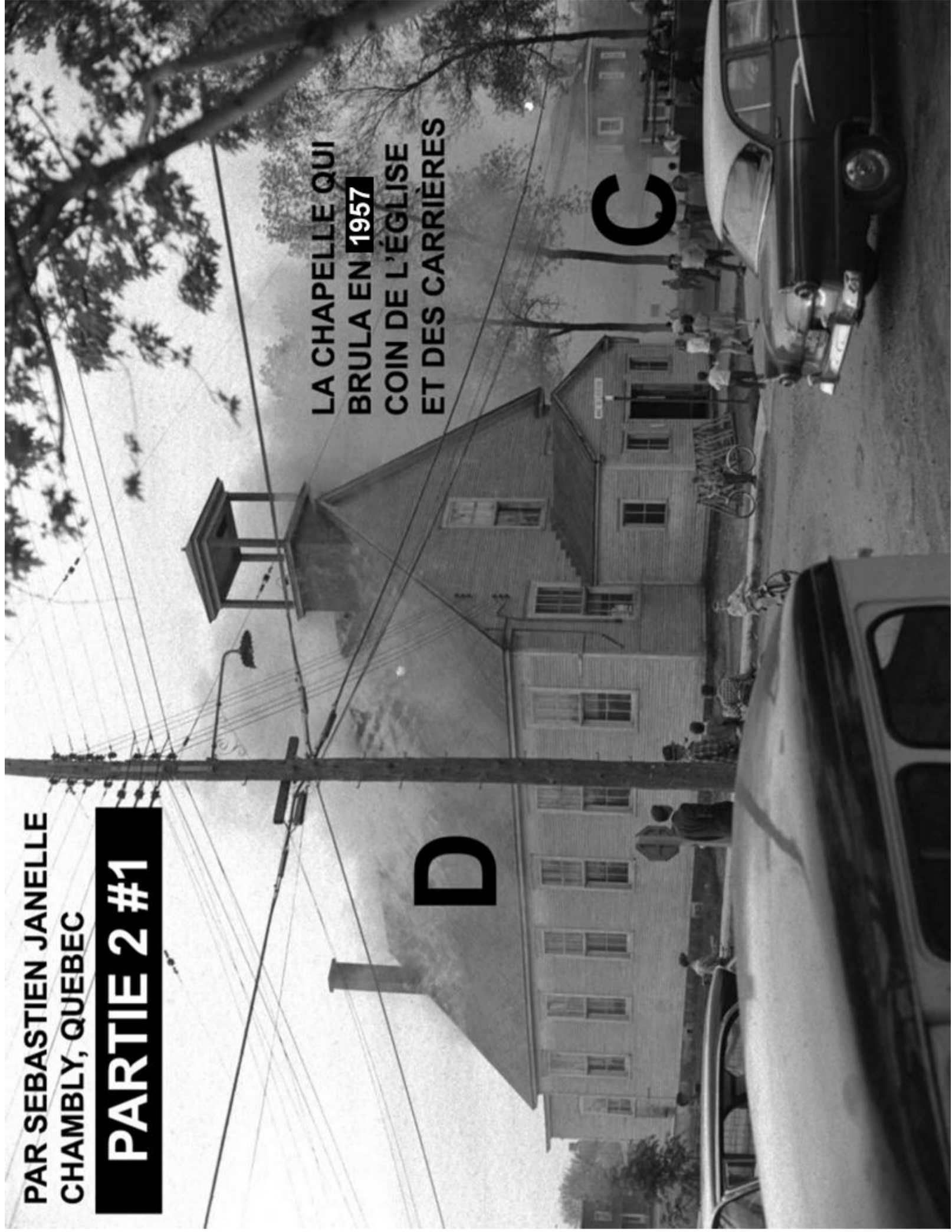

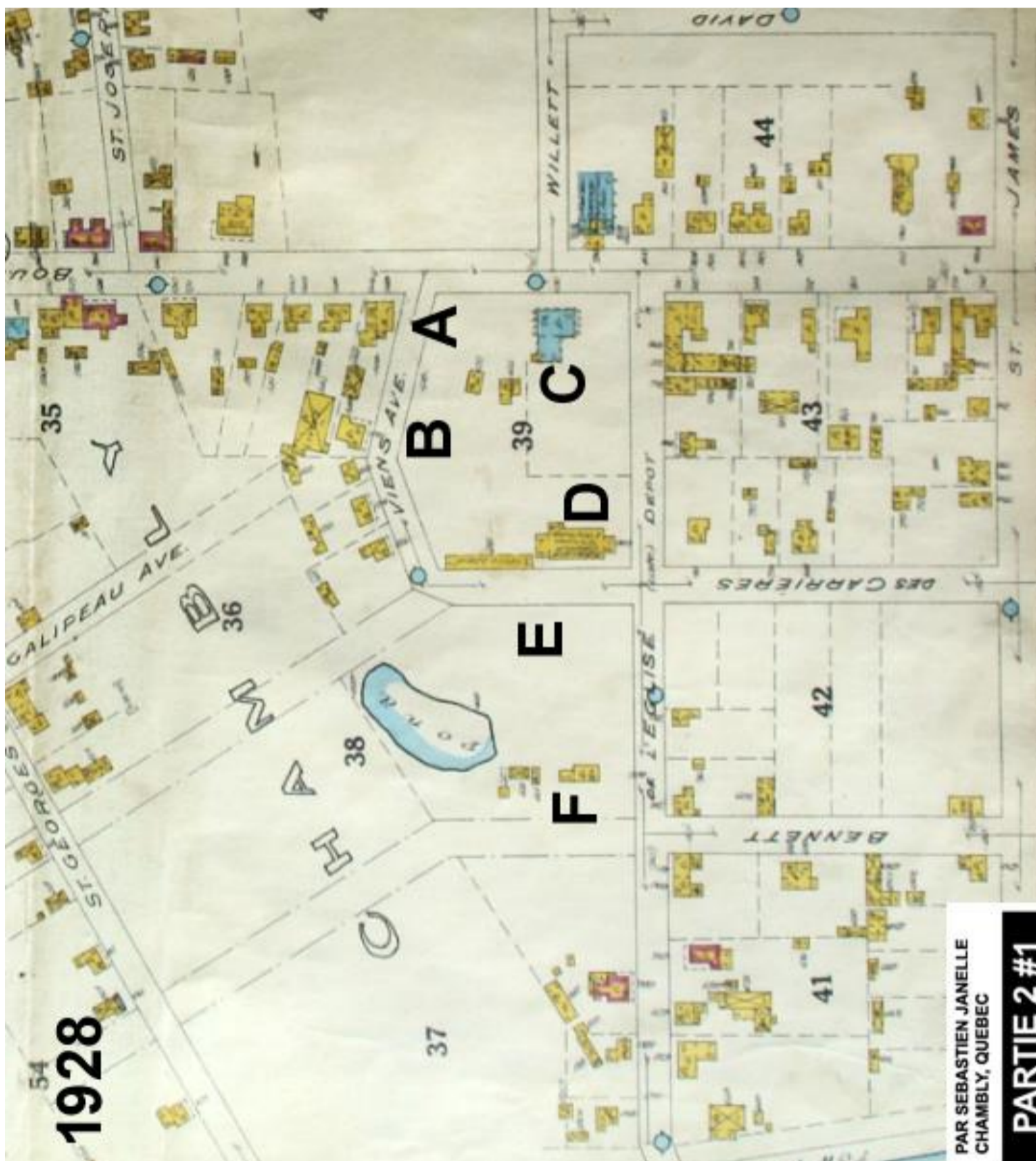
ON THE FOLLOWING MAP IN 1913 OF CHAMBLY, THE PRESENCE OF A BUILDING AT POINT B SHOULD BE THAT OF THE CHAMPLAIN CHAPEL AND WOULD GIVE THE EXPLANATION WHY THE STREET VIENS BYPASSES THIS IMPORTANT BUILDING. IF THIS BUILDING WOULD SIMPLY BE A BARN, IT WOULD HAVE BEEN EASY TO DEMOLAR AND POSITION THE STREET COME RIGHT. THE FIRST CHAMPELLE CHAMPLAIN WAS ENGULFED IN FLAMES IN JUNE 1640 AND LATER REBUILT BEFORE MAY 1641.

AT POINT D, IT IS CLEAR THAT THE CHAPEL THAT BURNED DOWN IN 1957 IS NOT ON THE MAP. THIS LOCATION IS THAT OF MR. BOURDON AND THE TREASURY. THERE IS MENTION OF DEPOT IN FRONT OF POINT D ON EGLISE STREET.



ON CHAMBLY'S 1928 MAP, WE SEE IN POINT B OF THE CHAMPLAIN CHAPEL THAT THE BUILDING IS NO LONGER THERE.

AT POINT D, WE CAN CLEARLY SEE THE PRESENCE OF THE CHAPEL THAT BURNED DOWN IN 1957. THERE IS STILL MENTION OF DEPOT BUT THIS TIME WITH THE STREET OF EGLISE INSCRIBED. IS THIS A MENTION TO TELL US THAT THE TRESOR IS WELL IN PLACE AT POINT D AND THIS HAS THE EXACT EMPLECE OF THE NAME DEPOT. THIS MENTION DEPOT IN ENGLISH AND UPSIDE DOWN GIVES "TOPED" WHICH MEANS IN CROWNED FRENCH.

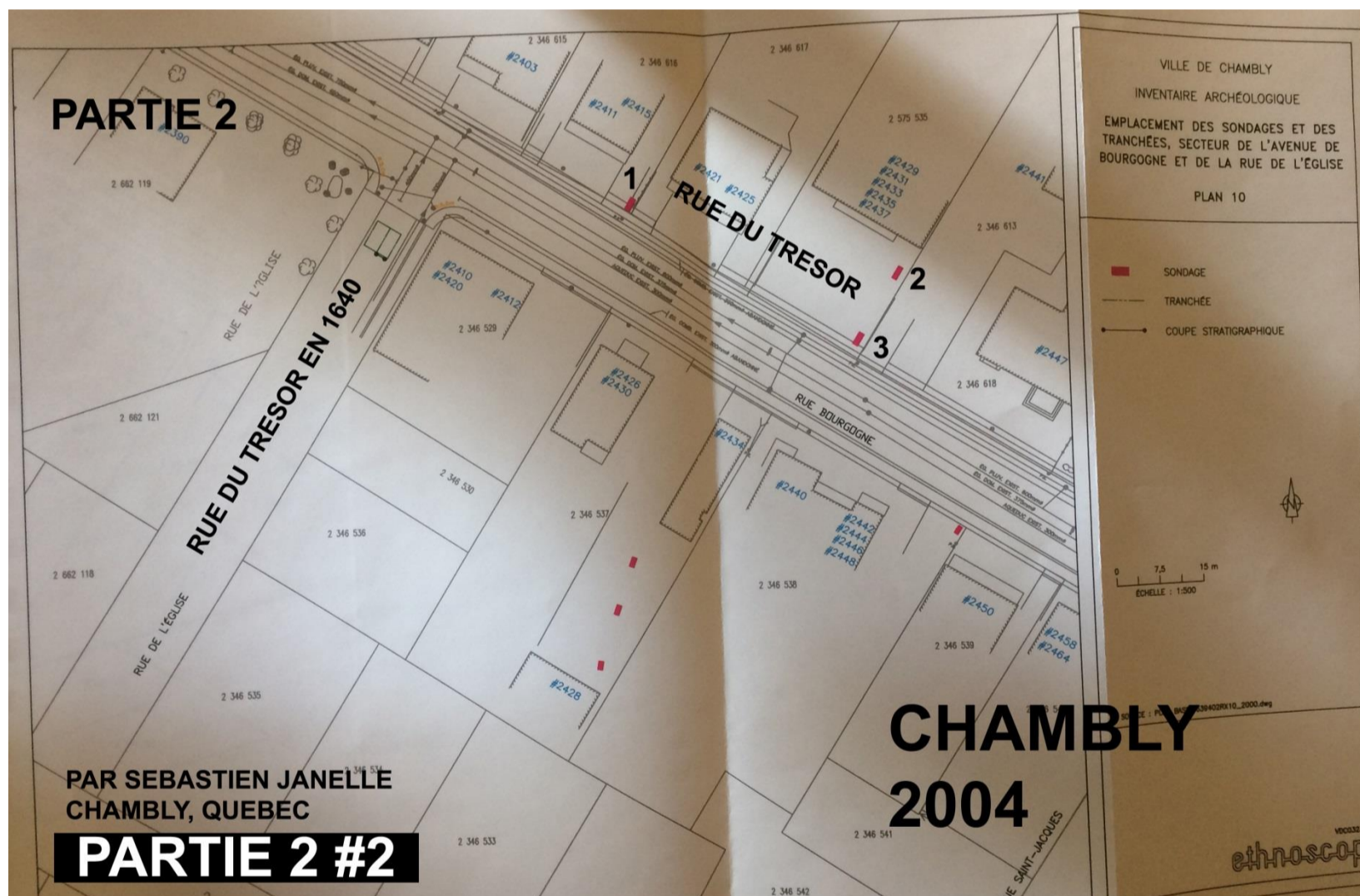


PART 2 #2

DURING THE REFLECTION OF RUE BOURGOGNE IN 2004, AN ARCHAEOLOGICAL INVENTORY WAS MADE BETWEEN THE TOWN HALL AND THE YULE BRIDGE IN THE OLD CHAMBLY.

IN THE FIRST SECTION OF CHURCH STREET AT THE INTERSECTION OF BOURGOGNE STREET IN CHAMBLY, THE CONCLUSION SHOWS THE PRESENCE OF AN OLD STREET. IT IS FROM STREET DU TRESOR ON THE MAP OF 1640.

IN 2004, ARHEOLOGISTS LOCATED THE STREET DU TRESOR OF 1640 WITHOUT KNOWING IT EITHER NEXT TO BOURGOGNE STREET IN THE LOWER TOWN. SÉBASTIEN JANELLE IDENTIFIES THE STREET DU TRESOR FROM THE 2004 MAP AS WELL AS POINTS 1 2 3 OF THE PLACES WHERE ARCHAEOLOGISTS HAVE FOUND THE OLD STREET.

6.0 CONCLUSION

PARTIE 2 #2

L'inventaire archéologique réalisé à Chambly au printemps 2004 a permis de déterminer si des ressources archéologiques préhistoriques pouvaient être menacées par le projet de réfection de l'avenue Bourgogne et d'établir la présence éventuelle de vestiges de l'occupation historique des lieux. Malgré la mise en œuvre d'une cinquantaine de sondages, aucune trace d'une occupation préhistorique n'a été décelée aux abords de l'avenue Bourgogne. Toutefois, des vestiges de la période historique ont été découverts en plusieurs endroits. Ainsi, le long de l'avenue Bourgogne, des couches d'occupation du XIX^e siècle ont été mises au jour aux numéros civiques 2271, 2554 et 2560 et des rehaussements datant probablement de la même période ont été identifiés aux numéros civiques 2274 et 2545. Sur la rue Beattie a été retrouvée une aire de circulation du milieu du XIX^e siècle, alors qu'une aire de circulation un peu plus ancienne a été identifiée sur la rue de l'Église. Un niveau d'occupation du milieu ou de la deuxième moitié du XIX^e siècle était présent dans la rue Viens. Enfin, deux sites archéologiques ont été délimités lors de l'intervention. Le premier, BiFh-16, regroupe le 2136 avenue Bourgogne et l'extrémité nord de la rue Dumaine; un dallage et un mur de refend d'une écurie construite en 1813 y ont été découverts. Le second, BiFh-17, correspond au 2259 avenue Bourgogne, où fut mis au jour le coin sud-ouest d'un bâtiment datant du milieu ou de la deuxième moitié du XIX^e siècle.

Ce bilan révèle que les abords de l'avenue Bourgogne recèlent un potentiel archéologique significatif, malgré les perturbations engendrées par le développement domiciliaire au cours du XX^e siècle. Il est donc recommandé que toute autre excavation aux abords de l'avenue Bourgogne, y compris sur les sites BiFh-16 et BiFh-17, soit à nouveau accompagnée d'une intervention archéologique. Par ailleurs, un archéologue devrait être mandaté lors de travaux d'excavation à l'emplacement du camp militaire (entre le fort Chambly et la rue Beattie) afin de déterminer l'impact de ces travaux sur les ressources archéologiques et de formuler le cas échéant une stratégie d'intervention au terrain.

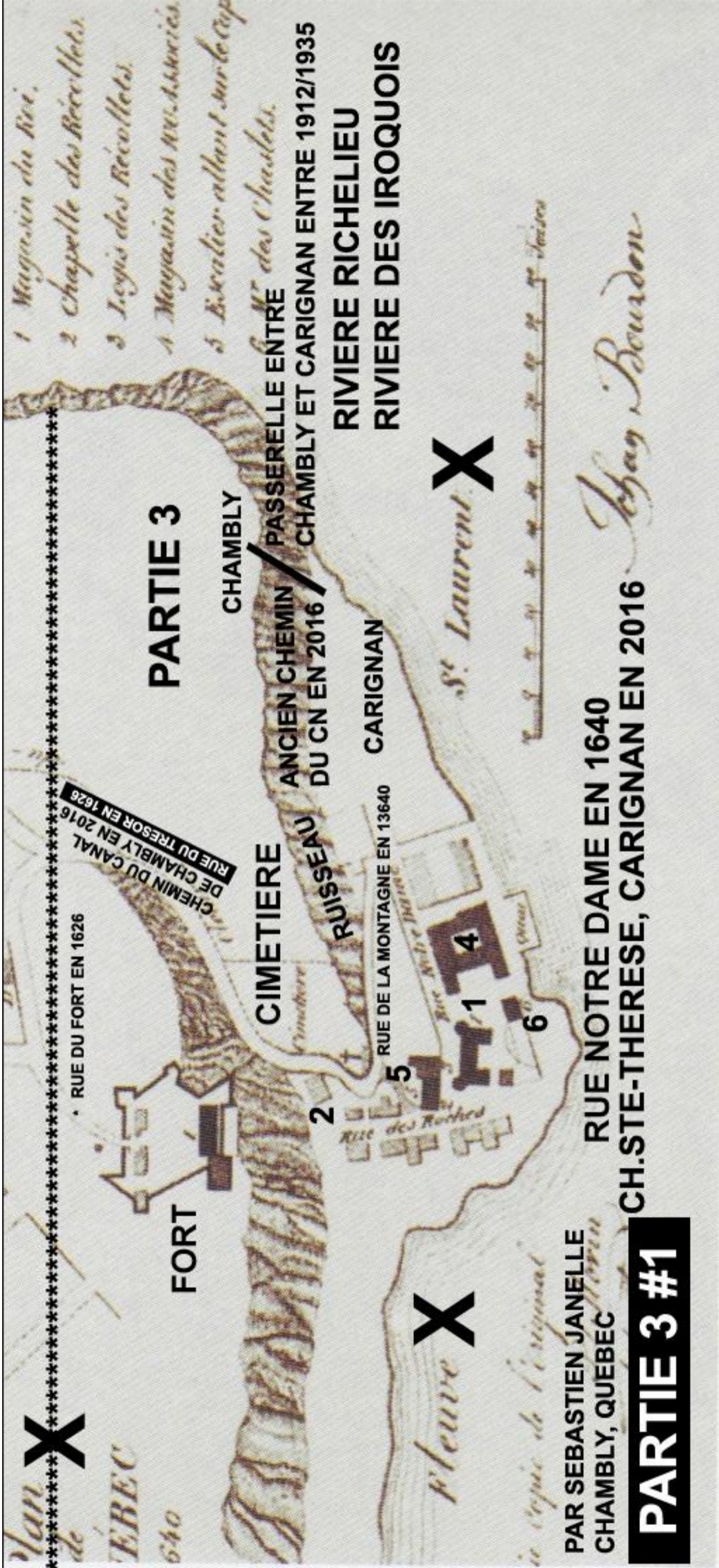

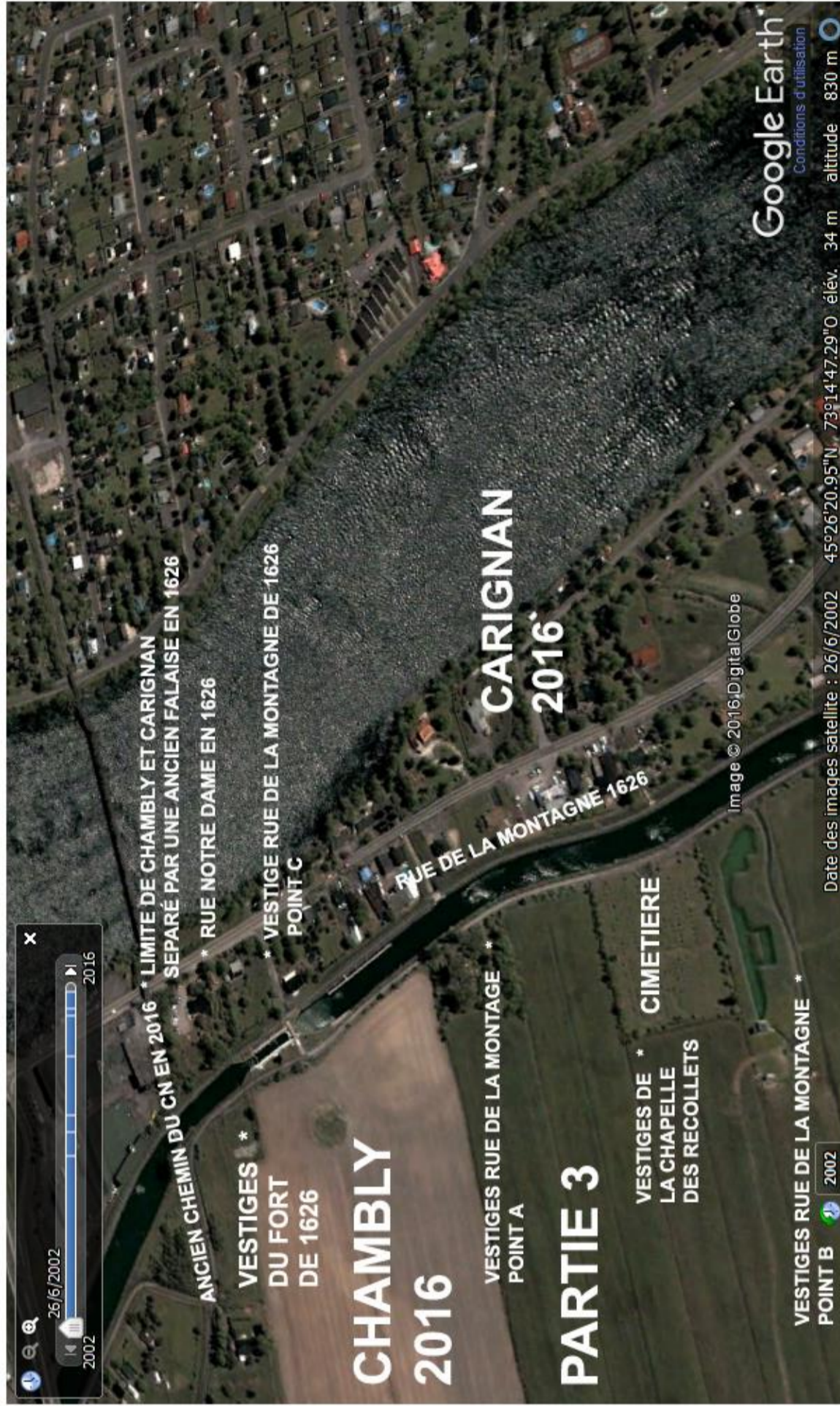

THE CEMETERY OF THE MAP OF 1640 IS THE CEMETERY VERY HOLY HEART OF MARY A CHAMBLY ON THE CANAL STRIP. THE CEMETERY WAS GIVEN TO THE PARISH BY DECLARATION OF TRANSMISSION IN 1914. THE HEAD OF THE PARISH CONFIDED IN THE SUMMER OF 2015 THAT THE CEMETERY WAS GIVEN TO THEM BECAUSE OF TWO HEADSTONES LEFT THAT IS NO LONGER THE ONE TODAY AND A RIGHT THAT IS STILL PRESENT CARVED IN STONE. THIS TOMBSTONE SHOULD BE THAT OF SAMUEL DE CHAMPLAIN, SAMUEL DE CHAMPLAIN WAS BURIED IN A CEMETERY WITH TWO OTHER PEOPLE. HE DIED ON DECEMBER 25, 1635 IN QUEBEC CITY... QUEBEC CITY OF 1626 (CITY OF CHAMBLY AND CARIGNAN).

ON THE VIEW OF THE SATELITTE YOU CAN SEE AT THE TOP RIGHT, THE LOCATION OF THE REMAINS OF THE CHAPEL OF THE RECOLLETS. IN THIS CEMETERY, AROUND 1982, THERE WAS A MOZAIC ON THE GROUND OF THE FLAG OF NEW FRANCE.

LOOKING AT THE PLAN OF THE CEMETERY, THE TOMBSTONE IS TOO MUCH IN THE CEMETERY AND NOT LISTED.

CONCLUSION #1

SAMUEL DE CHAMPLAIN ON HIS 1609 VOYAGE, WHICH LEFT QUEBEC CITY BY THE ST. LAWRENCE RIVER UP THE RICHELIEU RIVER OF THE IROQUOIS. ARRIVING AT THE SAULT (CHAMBLY RAPIDS), THE TRAMPLED AROUND ON FOOT AND CONTINUED ALONE WITH ANOTHER MEMBER OF HIS TEAM BY CANOE TO LAKE CHAMPLAIN.

DURING HIS VISIT TO CHAMBLY IN 1609, SAMUEL DE CHAMPLAIN CARTOGRAPHIE ON MAP CHAMBLY. HE IMMEDIATELY SEES THAT CHAMBLY IS A COMPLIANT BUT SMALLER COPY OF QUEBEC.

IN 1626, DURING THE CONSTRUCTION OF FORT ST-LOUIS SUR CAP AUX DIAMANTS AT QUEBEC AND THE TRENCH THAT CIRCLED THE FORT, SAMUEL DE CHAMPLAIN AND HIS CREW OF DIAMONDS (CRYSTAL QUARTZ). AS HE HAD ALREADY THREATENED THE ENGLISH ENEMI, SAMUEL DE CHAMPLAIN BROUGHT THE SO-CALLED TRESOR BACK TO CHAMBLY FOR THE HIDDEN ONE. SAMUEL DE CHAMPLAIN LEFT FRANCE IN 1626 FOR QUEBEC. HE TRAVELLED FROM THE ATLANTIC OCEAN TO NEW HAMSTERDAM, NEW YORK. SAMUEL DE CHAMPLAIN WAS IN NEW HAMSTERDAM, NEW YORK IN 1626. IT RAN FROM THIS LOCATION TO LAKE CHAMPLAIN AND THEN THE IROQUOIS RIVER (RICHELIEU) TO CHAMBLY WHERE THERE WAS A DEAD END BECAUSE OF THE SAULT (RAPIDS OF CHAMBLY TO FOUND THE OTHER CITY NAMED QUEBEC. THIS ROAD IS THE MISSING ROAD IN THE HISTORY BOOKS.

THE OLD CHAMBLY BETWEEN 17/17A OF THE CHURCH AND UP A LITTLE DOWN THE STREET DES CARRIERES AND BETWEEN EGLISE STREET AND ST. GEORGE RESTS ON THE ROCK FROM 3-4 FEET BELOW THE GROUND.

THE TUNNEL AND VAULT CONTAINING SAMUEL DE CHAMPLAIN'S TRESOR IS IN A CAVERN IN THE ROCK OF OLD CHAMBLY. SÉBASTIEN JANELLE SUPOSE THAT IN THE VAULT THERE IS CRYSTAL QUARTZ, MAPS, PAINTINGS OF THE FOUNDATION OF THE NEW FRANCE, MONEY OF THE 17TH CENTURY, ETC. THIS CAVE PRESENT IN THE OLD CHAMBLY IS OF THE SAME TYPE AS THE ONE DISCOVERED IN ST. LEONARD IN MONTREAL THAT YOU CAN SEE ON THE FOLLOWING LINK :

IN AUGUST 2015 WITH THE CONSTRUCTION SITE CAMERA, SEBASTIEN JANELLE CAPTURES A CLOUD OF STEAM COMING OUT OF THE GROUND, EITHER 2-3 FEET FROM THE 17/17A LIMIT OF THE EGLISE STREET OR ON THE GROUNDS OF 17A OF THE EGLISE STREET. TAKING THE MAP OF 1640, THE LOCATION OF THE CORRESPONS STEAM CLOUD IN THE CENTER OF THE SENECHAUSSEE (F).

THE ENTRANCE TO THE CAVE TUNNEL IS ON 17A STREET EGLISE IN CHAMBLY AND THE VAULT IS AT THE LOCATION OF MR BOURDON.

IF YOU LOOK AT THE JUNCTION BETWEEN FORT STREET AND TRESOR STREET, IT ALSO ARRIVES AT MR BOURDON'S LOCATION.

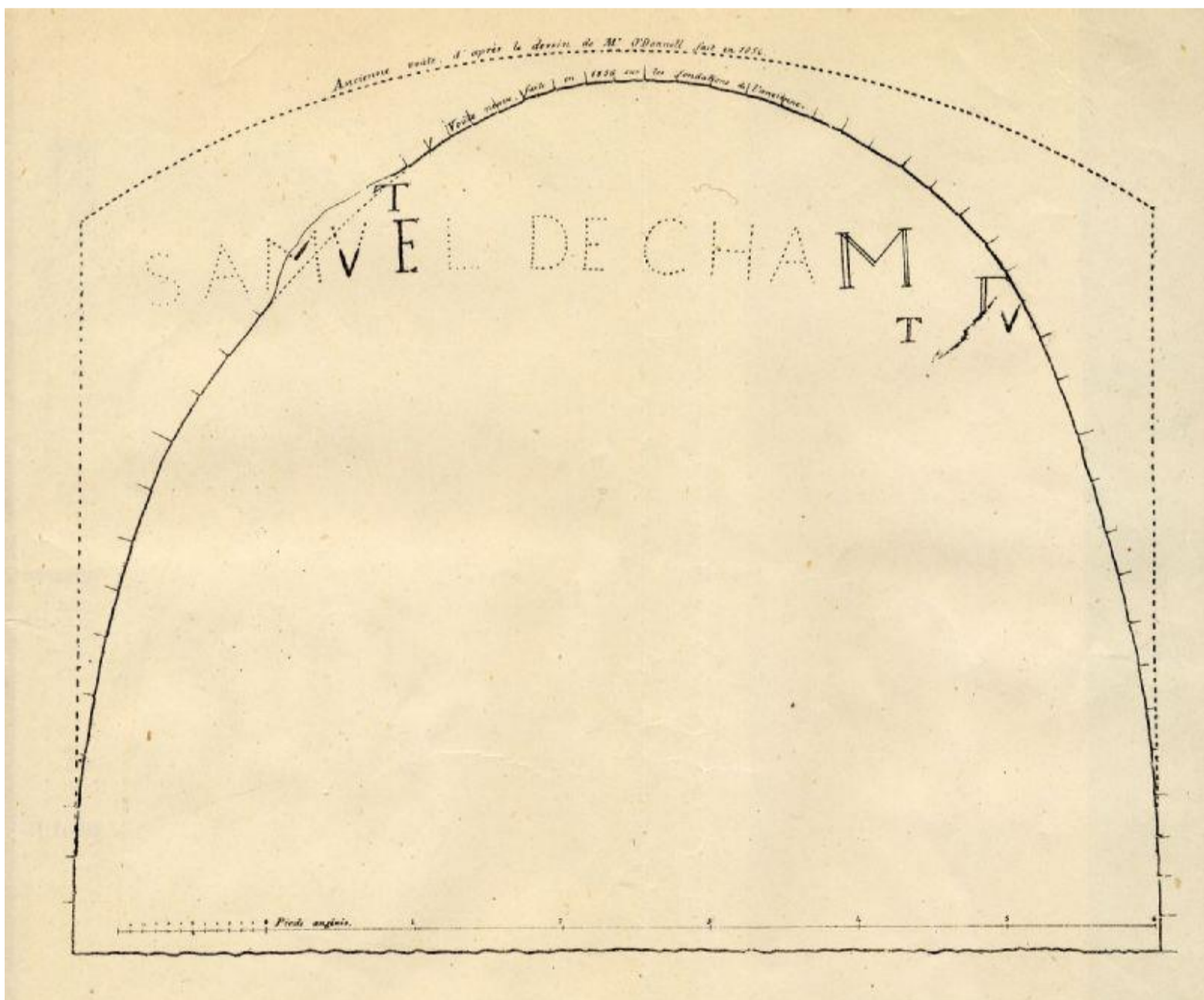

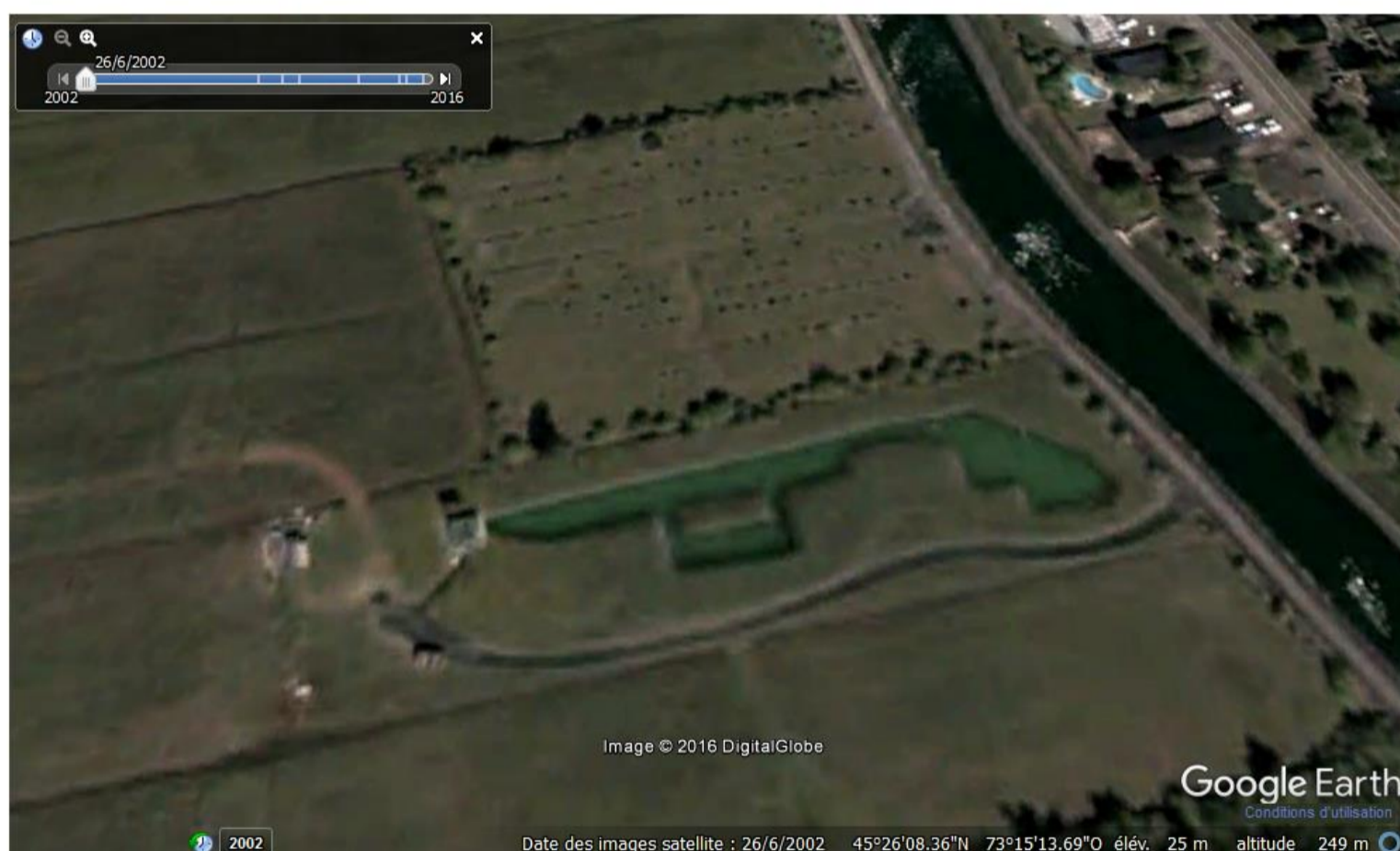
THERE ARE NINE (9) CLUES TO THE PRESENCE OF THIS TREASURE IN CHAMBLY AS WELL AS THE PRESENCE OF THE TOMB OF SAMUEL DE CHAMPLAIN A CHAMBLY.

- THE FIRST (1) CLUE IS THAT OF MR. BOURDON ON THE 1640 MAP WHICH SHOWS THE EXACT LOCATION OF THE TREASURE.
- THE SECOND (2) IS THAT OF THE ST-PIERRE RATING ON THE MAP OF 1667 WHICH SHOWS THAT CHAMBLY IS QUEBEC OF 1626.
- THE THIRD (3) CLUE IS ON THE WILL OF SAMUEL DE CHAMPLAIN. ON HIS WILL, SAMUEL DE CHAMPLAIN HAD TAKEN HIS OWN TO MENTION THAT THE HEIR TO HIS PROPERTY IS OUR LADY OF RECOVERANCE. THE OWNER OF THE TRESOR WAS SAMUEL DE CHAMPLAIN. THE TRESOR IS THE PROPERTY OF SAMUEL DE CHAMPLAIN. THE TRESOR IS THE PROPERTY AT THE DEATH OF SAMUEL DE CHAMPLAIN OF OUR LADY OF RECOVERY. THE HEIR TO THE TREASURY IS THE PARISH OF OUR LADY OF RECOVERANCE. THE HEIR TO THIS PROPERTY IS THE PARISH OF OUR LADY OF RECOVERANCE WHICH MEANS THAT SAMUEL DE CHAMPLAIN'S TRESOR IS LOCATED IN THE PARISH OF OUR LADY OF THE RECOVEROVER IN CHAMBLY.

WHAT COMES IN, HOWEVER, IS SAMVEL DE CHAMBLY WHICH MEANS THAT SAMUEL DE CHAMPLAIN IS A CHAMBLY. WE HAVE FIVE CODES ON THIS TAKEOVER. A T ABOVE SAMVEL, A T AND A V BELOW CHAM, THE GROUND LEVEL LINE AND THE UPSIDE DOWN. THE SECOND LINE WITH SMALL SPIKES LIKE TURF IS THE GROUND LEVEL. SO THE T ABOVE SAMVEL MEANS THE TOMB OF SAMUEL DE CHAMPLAIN A CHAMBLY UNDER THE GROUND. THE T AND V BELOW CHAM MEANS THE TRESOR IN THE VAULT IN THE SOL OF CHAMBLY IS DEEPER THAN THE TOMB. NEXT TO THE V THERE IS A LINE UPSIDE DOWN THAT GOES UP TO THE V. THIS L UPSIDE DOWN SHOWS THE TUNNEL THAT GOES FROM THE GROUND LINE TO THE ROCK WHERE THE VAULT IS IN CHAMBLY. A PERSON CAME TO WRITE 1856 ON THIS REPRESENTATION THE MENTION VAULT AT THE TOP IN A SENTENCE. IT IS ALSO NOTED THAT THE MENTION ENGLISH FEET IS A UNIT OF MEASUREMENT AT THE BOTTOM OF THE REPRESENTATION. SO IT REMAINS TO BE BELIEVED THAT THIS REPRISE IS ALSO THAT OF A VAULT.



- THE FIFTH (5) IS THE MENTION OF THE DEPOSIT ON THE 1913 CHAMBLY MAP AS WELL AS THE CHAMBLY MAP OF 1928. UPSIDE DOWN, THE WORD DEPOT IS "TOPED" IN ENGLISH, WHICH MEANS CROWNED IN FRENCH. THIS MENTION GIVES US THE ACCURACY OF THE PRESENCE OF SAMUEL DE CHAMPLAIN'S TREASURE ON THE CORNER OF CHURCH STREETS AND QUARRIES IN CHAMBLY.

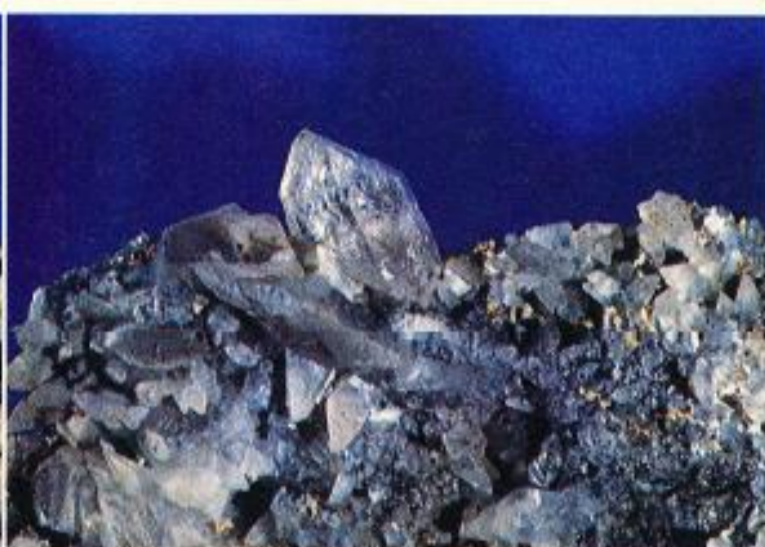

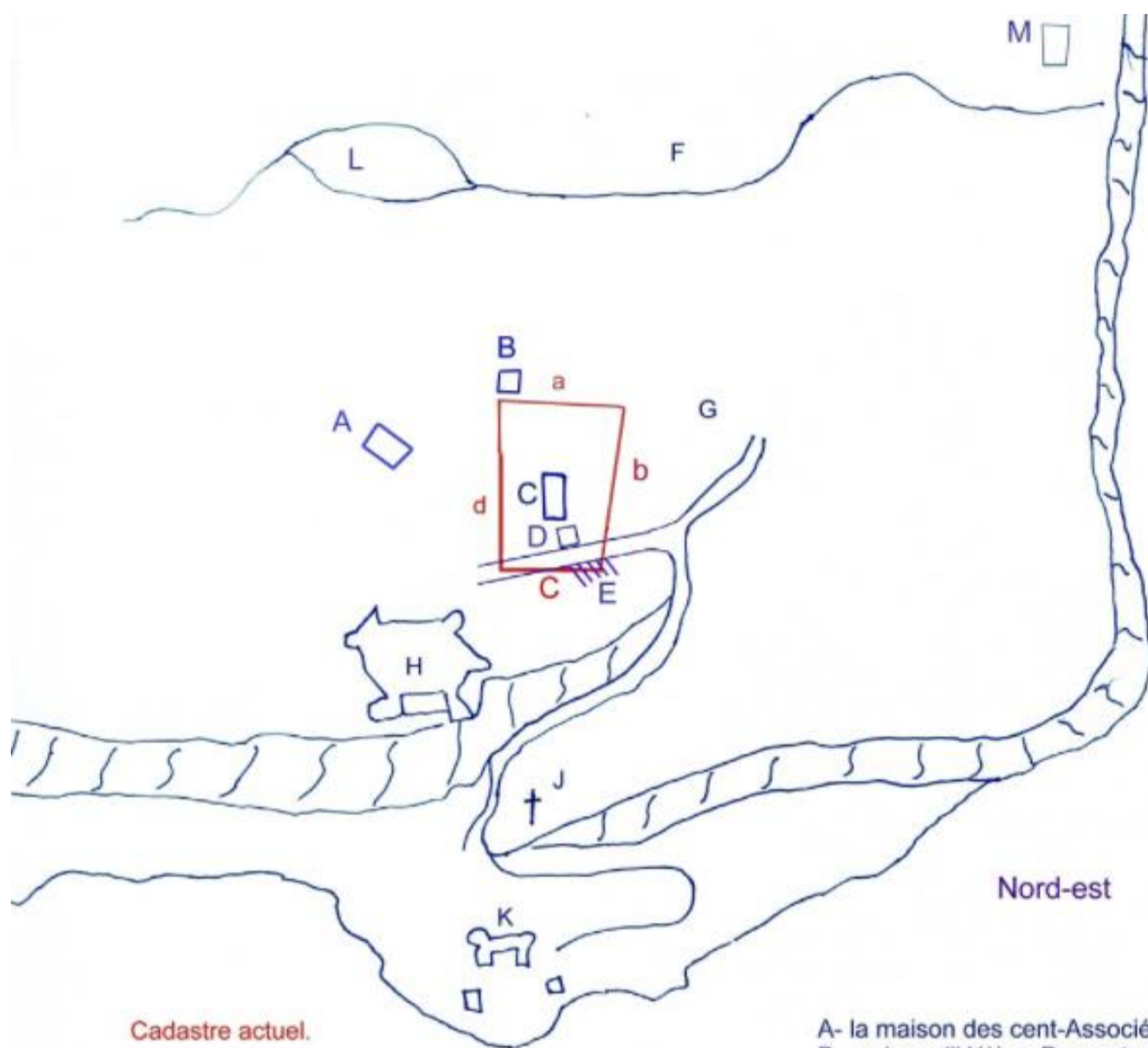

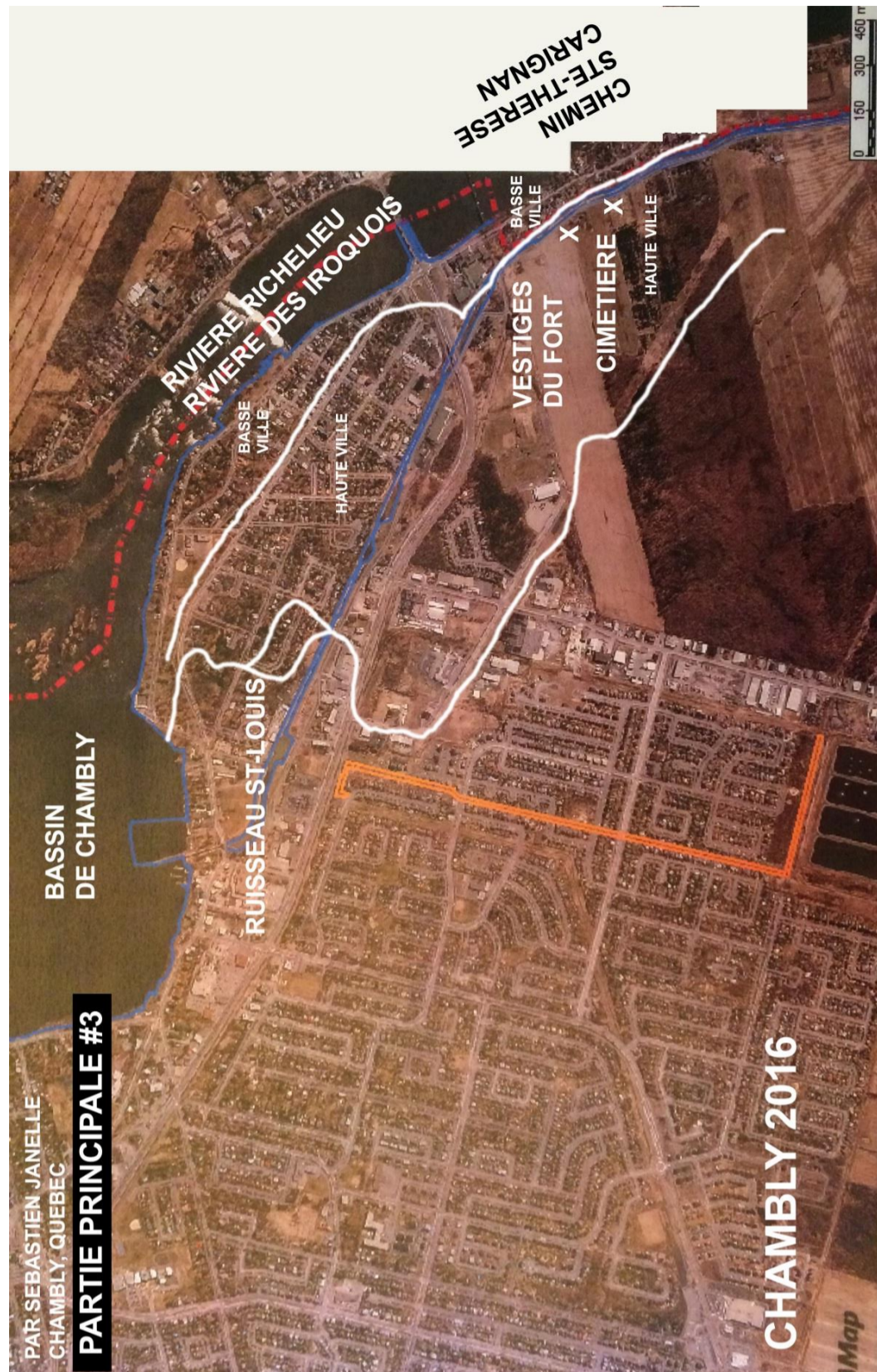

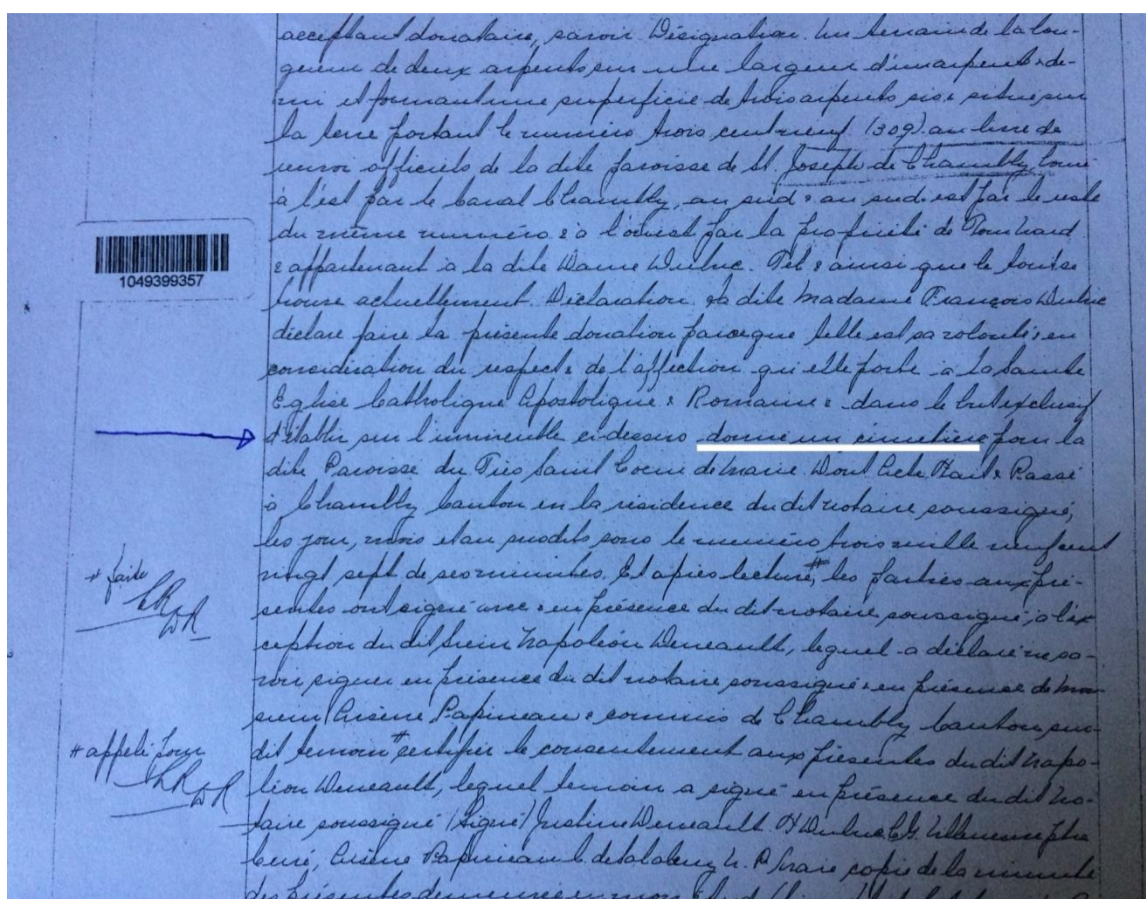

IN 2015, SEBASTIEN JANELLE MET THE RATHER OLD LEADER AT ST. JOSEPH DE CHAMBLY PARISH, WHICH NOW INCLUDES THE VERY HOLY HEART OF MARY PARISH. THE LATTER TOLD HIM THAT WHEN THEY WERE GIVEN THE LAND WHERE THE CEMETERY OF THE MOST HOLY HEART OF MARY IS NOW LOCATED IN 1914 THAT THERE WERE 3 TOMBSTONES ALREADY ON SITE. A HEADSTONE IS STILL IN THE CEMETERY (THE ONE PROPOSED IN HIS SEARCH) AND THE OTHER TWO LEFT OUTSIDE THE CEMETERY BUT THE HEADSTONES ARE NO LONGER THERE TODAY, THE OLD MAN TELLS HIM.

IN 1914, THE PARISH OF THE HOLY HEART OF MARY WAS GIVEN A CEMETERY AND NOT A PLOT OF LAND AS MENTIONED IN THE DECLARATION OF TRANSMISSION.

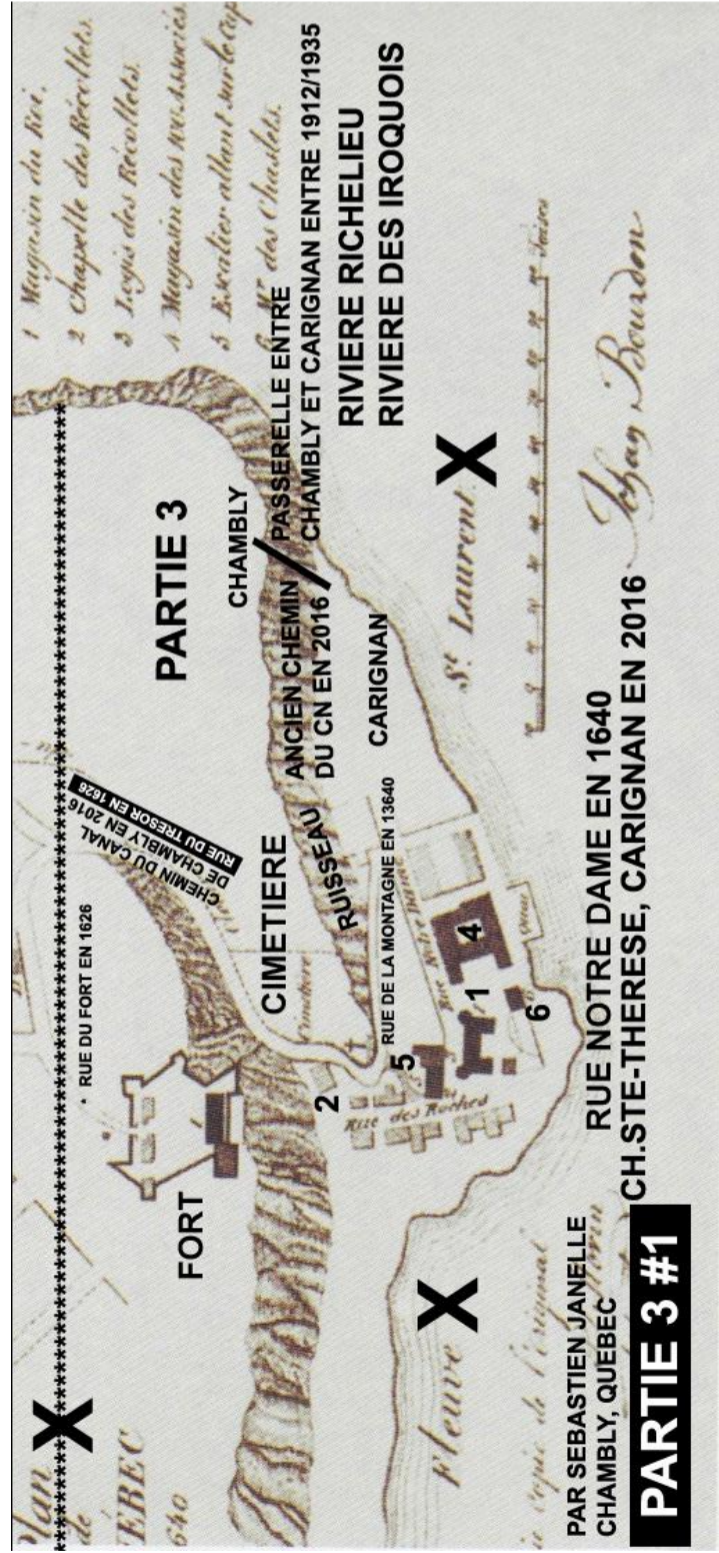

IF ONE LOOKS IN DETAIL AT THE CEMETERY GROUNDS, IT IS NOT RECTANGULAR AS IT SHOULD BE BUT WITH A SHAPE TO ENCOMPASS THE REMAINS OF THE CHAPEL OF THE RECOLLECTIONS FOUND ON THE MAP OF 1640 AT POINT 2 NEAR THE CEMETERY. WHERE THE REMAINS OF THE CHAPEL OF THE HARVESTED WERE LOCATED, AROUND 1982 WAS A MOZAIQUE ON THE GROUND OF THE FLAG OF NEW FRANCE.



THE HEADSTONE TOO MANY IN THE PRESENT-DAY CEMETERY OF THE HOLY HEART OF MARY SHOULD BE THAT OF SAMUEL DE CHAMPLAIN AS SEBASTIEN JANELLE HAS BEEN PROPOSING SINCE THE BEGINNING OF HIS RESEARCH. BUT IT IS TRUE THAT SAMUEL DE CHAMPLAIN IS BURIED WITH TWO OTHER PEOPLE IN A CEMETERY NEAR A CHAPEL. THIS CHAPEL IS THE CHAPEL OF THE HARVESTERS. IF WE TAKE THE WORDS OF THE OLD MAN OF THE PARISH IN 2015, THE OTHER TWO TOMBSTONES WOULD BE THAT OF FRANCOIS DERÉ GRAND (MAY 21, 1641) AND CHARLES RAINBAULT (OCTOBER 22, 1642).

A VERIFICATION IN THE TOMB UNDER THE TOMBSTONE BY AN ARCHOLOGIST WOULD BE REQUIRED TO VALIDATE WHO IS IN THIS TOMB (SAMUEL DE CHAMPLAIN, FRANCOIS DERÉ GRAND OR CHARLES RAINBAULT). REGARDLESS OF WHETHER IT IS SAMUEL DE CHAMPLAIN OR ONE OF THE TWO OTHER PEOPLE IN THIS TOMB, WE WILL KNOW THAT THIS CEMETERY IS THE ONE WHERE SAMUEL DE CHAMPLAIN IS BURIED.

- *THE CHURCH OF OUR LADY OF THE RECOVERY*

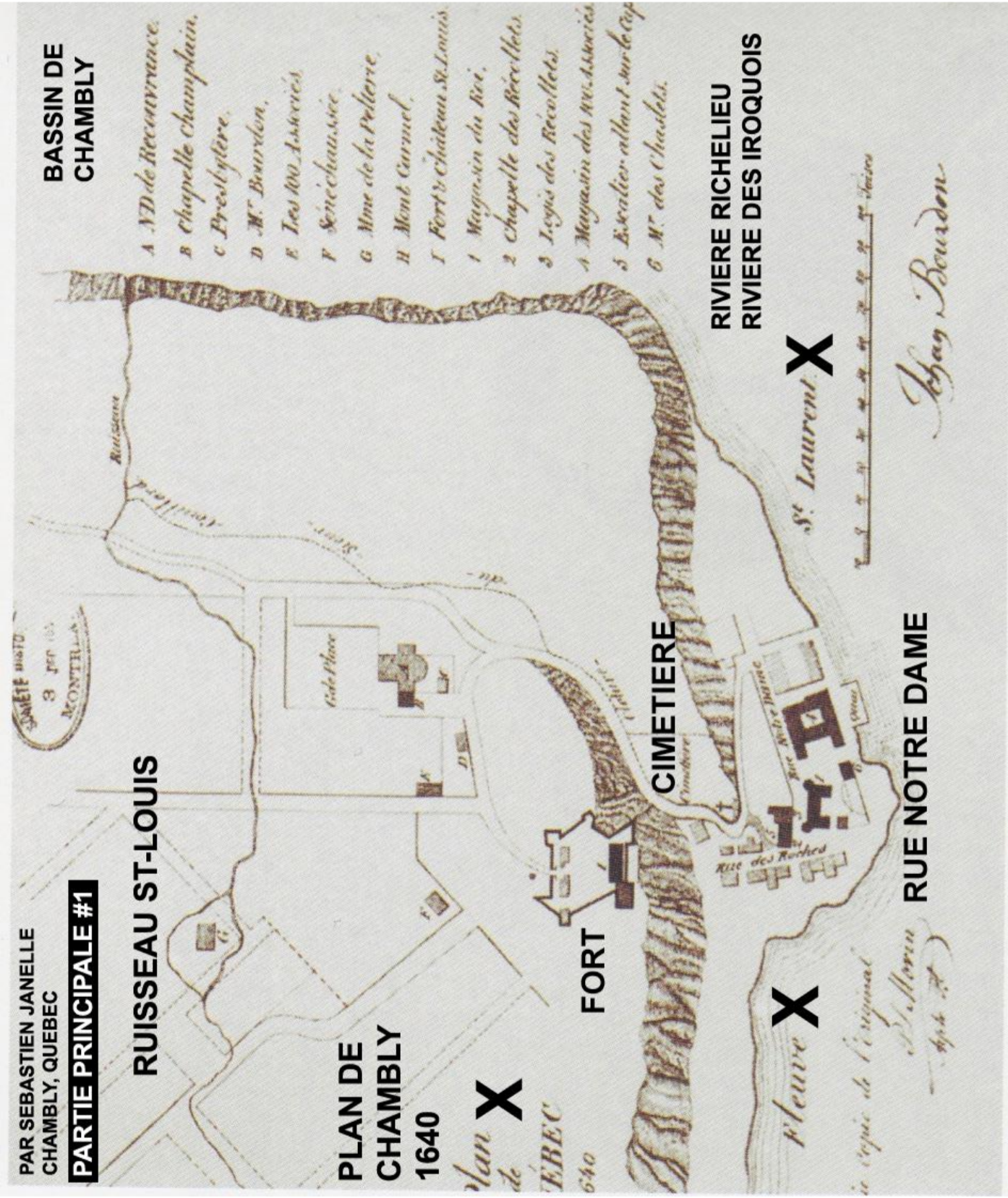
IN THE 2008 CHAMPLAIN COMMITTEE DOCUMENT (THE CHAPEL AND CHAMPLAIN'S TOMB) PREPARED BY PIERRE DUBEAU, HE TELLS US ABOUT THE CHURCH OF NOTRE DAME DE LA RECOLVRANCE IN QUEBEC CITY.

IN OLD CHAMBLY, THERE IS THE PARISH OF THE VERY HOLY HEART OF MARY. IN THIS PARISH THERE IS THE CHURCH OF THE HOLY HEART OF MARY WHERE ONE CELEBRATES THE MASS AND ALSO THE CEMETERY VERY HOLY HEART OF MARY.

CHAMPLAIN DIED IN QUEBEC CITY IN 1626 (CHAMBLY AND CARIGNAN) IN THE CHURCH OF OUR LADY OF RECOVERANCE. THERE WERE TWO CHAPELS IN THIS CHURCH IN THE UPPER CITY; THE CHAMPLAIN CHAPEL (STREET VIENS TO CHAMBLY) AND THE CHAPEL OF THE HARVESTS IN THE CEMETERY (VERY HOLY HEART OF MARY IN CHAMBLY). SO THE CHURCH OF OUR LADY OF THE RECOVERANCE IS NOT A BUILDING (CHURCH) BUT SIMPLY THE PARISH.

SAMUEL DE CHAMPLAIN IS BURIED NEAR A CHAPEL IN THE UPPER CITY IN THE CHURCH OF OUR LADY OF THE RECOVERANCE... THIS MEANS : SAMUEL DE CHAMPLAIN IS BURIED NEAR THE CHAPEL OF THE HARVESTERS IN THE PARISH OF OUR LADY OF RECOVERY.

ON JEAN BOURDON'S 1640 MAP REPRESENTING QUEBEC OF 1626 (CHAMBLY AND CARIGNAN), WE FIND THE MENTION OF ND OF RECOVERANCE AT POINT A. THE CHAMPLAIN CHAPEL AT POINT B CANNOT BE ATTACHED TO THE SAME BUILDING AS POINT A (ND OF RECOVERANCE). THEREFORE, THE MENTION OF ND OF RECOVERANCE (OUR LADY OF RECOVERANCE CHURCH) IS NOT A BUILDING BUT AN INDICATION OF THE CHURCH (PARISH) OUR LADY OF THE RECOVEROVER.
