

COMPTON WILL HAVE ANOTHER ELECTION.

Mr. Hunt Resigns, Admitting Irregularities On The Part Of His Agents, Without His Knowledge—Counter Petition Withdrawn—Sherbrooke And Stanstead Cases Will Proceed.

Saturday and today conferences were held in connection with the Compton election case.

Both sides this forenoon admitted as a basis of agreement had been reached, and that this afternoon a formal agreement will be signed, by which the trial proceedings in the Compton election case will not take place.

The principal conditions of this settlement, it is learned, are as follows: 1. That Mr. A. B. Hunt resign as M.P. for Compton county, admitting irregularities on the part of his agents without his knowledge and which have come to his knowledge since his recent examination in discovery.

2. That all other litigation in connection with the Compton election is to be discontinued.

There will, therefore, be no trial at Sherbrooke to-morrow.

The court will render formal judgment by which the constituency will be declared vacant.

Many witnesses had been summoned for this trial which would certainly have continued many days and would cost five thousand dollars or more.

Another election will now be in order in Compton county. It may be brought on before Christmas or it may be deferred for a year.

Some one has suggested that just prior to the elections as it would bring all the boys home for Christmas, and also incidentally might contribute to the holiday trade following the election. A barrel of flour or a turkey would be most acceptable to many Compton families, on or before the 25th of the coming month.

There is an impression among politicians that a bye-election in Compton County will develop as a contest as the Townships have witnessed.

There is no doubt that Mr. A. B. Hunt will again be the Liberal candidate.

It is extremely probable that Mr. R. H. Pope will again be the Conservative candidate. He will surely be urged to do so.

Dr. Mooney, of Scotstown, is looked upon as a possible candidate, should Mr. Pope decline to again contest the county.

DOES NOT AFFECT SHERBROOKE OR STANSTEAD.

The ending of the Compton protest case does not affect the Sherbrooke and Stanstead cases. The Compton agreement is entirely independent of these.

It is understood that both the Sherbrooke and Stanstead cases are likely to be proceeded with.

The bill of particulars in the Sherbrooke case will be filed in a few days. There is some talk of a "saw-off" arrangement in settlement of the Sherbrooke and Stanstead cases. This, however, is said to be unlikely.

The Sherbrooke Liberals are opposed to this as the Compton Conservatives were opposed to the proposed Compton-Sherbrooke saw-off.

COUNTER PETITION COMPTON ELECTION.

Judge Lemieux, in Superior Court Saturday gave judgment on the preliminary objections of Repondent R. H. Pope in the counter petition of the Compton election case.

The preliminary objections were dismissed with costs.

SHERBROOKE ELECTION PROTEST.

Mr. Justice Hutchinson granted a motion, this morning, in the Sherbrooke County election protest case, that the petitioner file particulars by Saturday next.

39 PERISH IN THE FLAMES.

Terrible Results of Fire in Glasgow.

BROKE OUT IN CHEAP LODGING HOUSE — INMATES COULD NOT ESCAPE.

Glasgow, Nov. 20.—The most terrible fire that has occurred in Great Britain for many years, broke out here yesterday morning, in a cheap lodging house for men, in Watson street, and resulted in the loss of 39 lives and the severe injury of many others. The flames were first noticed at six o'clock yesterday morning on the fourth floor of the building, which was occupied by 33 men. An alarm was raised and the firemen were speedily in attendance, but flames and smoke were then issuing from most of the windows on the fourth floor. An extraordinary scene was created by a procession of almost naked men issuing from the door of the building and against their frantic efforts to escape the firemen had actually to fight for admission. Reaching the upper floors the firemen found that the narrow passages were becoming congested with men who dropped to the floor overcome by smoke.

STRANGE LETTER TO GRANBY PRIEST.

Writer Demands Five Hundred Dollars.

ELSE THREATENS LIFE OF PRIEST OR DESTRUCTION OF CHURCH.

Granby, Nov. 20.—(Special.)—A dastardly attempt at blackmail has been made on the Rev. Father Gill, Roman Catholic priest. He received a letter by Friday evening's mail stating that unless he deposited five hundred dollars in a certain place, either he would be shot or his church blown up. He was also warned not to send any one to watch at the place designated. Father Gill, who is very popular, has been very active in building the magnificent church edifice now nearing completion. He professes to treat the matter lightly, although inwardly he cannot help feeling a little anxious in regard to the outcome. The letter was evidently written by an educated person.

DAUGHTER OF RICH MAN DIES FOR LOVE.

MISS BEATRICE RUSSELL, OF NEW LONDON, WHO SPENT SUMMER AT NORTH HATLEY.

A New London, Conn., press dispatch, dated Nov. 8th, gives particulars of the sad death of Miss Beatrice Russell, who spent a portion of the summer at Glen Villa, North Hatley.

It is as follows:—

New London, Conn., Nov. 8.—Miss Beatrice Russell, daughter of H. E. Russell, a wealthy retired manufacturer of New Britain, who has made his home in Ocean avenue for several years, died at two o'clock this morning, after swallowing a dose of carbolic acid, taken with suicidal intent.

Mrs. Russell, the girl's mother, has for years been a sufferer from a nervous disorder, which prevented her cherishing her daughters, and the position was filled by Miss Louis A. Miner, of this city, who looked after the household generally. Mr. Russell spent a vast sum on his summer home here and decided lately to make his abode permanent. It was for years president of the Russell & Erwin Manufacturing Company in New Britain.

Miss Russell was 25 years old. She was a graduate of the New Britain High School, and of attractive appearance. A doctor was called to the Russell home to attend Miss Beatrice, but she was beyond human aid. The girl, it is said left a note asserting the cause that led to her taking her life. It is rumored she was disappointed in her love affairs and concluded to end her life by taking the poisonous draught.

RUSSIAN STRIKE ENDS TO-DAY.

Serious Disorders Are Thus Averted.

SEVERAL SHOPS HAD ALREADY BEEN FIRED BY WORKMEN.

St. Petersburg, Nov. 20.—(London Times and New York Times Service)—The Central Labor Committee finally decided on the resumption of work to-morrow. The decision comes just in time to avert serious disorders. The workmen had already set fire to several shops the owners of which refused to obey the injunction to close.

Two collisions occurred between strikers and Horse Guards at the descent of the police and troops upon the printing offices of the Novaya Zin, Gorky's paper. Protests were made against this act as illegal, in view of the absence of any warrant, and the bulletin is full of violent denunciations of Premier Witte. It contains a number of resolutions demanding the cessation of the state of siege, the abolition of capital punishment, the formation of a national militia, and an 8-hour day.

SULTAN WILL NOT YIELD.

IS RELYING UPON EMPEROR WILLIAM TO INTERVENE, IT IS SAID.

Constantinople, November 20.—The hope in diplomatic quarters here that the Sultan would yield to the demand of the powers regarding the financial control of Macedonia is rapidly vanishing. It is now believed he is almost certain to refuse. It is stated that the Sultan is relying upon Emperor William to intervene in his behalf with the powers and has been in direct communication with him on the subject. He is now awaiting the Kaiser's reply. It is also stated that the attitude of Baron Marshall Von Bismarck, the German ambassador, towards the Porte does not accord with the assurance that Germany is co-operating with the other powers. Meanwhile the warships that the powers will use in their demonstration against Turkey are now on their way to the Bosphorus. The port of Athens where they have been ordered to rendezvous. A report that vessels of the Russian Black Sea fleet left Sevastopol on Saturday is assumed to show that they will be connected with the demonstration.

PRINCE'S LIFE WAS THREATENED.

EXTRA PROTECTION FOR LOUIS OF BATTENBERG—ONE THOUSAND SAILORS DESERT.

New York, November 20.—Now that the stay of Prince Louis of Battenberg here is so nearly over, the fact was allowed to become known Saturday that the Prince had received numerous anonymous letters threatening his life, and that he deemed them serious enough to call them to the attention of the police department, and also to ask for protection. Accordingly, the force of detectives assigned to the Prince was doubled. One of the letters informed the Prince that an effort would be made to blow him up with dynamite. Prince Louis announced Saturday that he had decided to sail Monday morning instead of yesterday, as at first arranged. Delay in sailing the fleet is the cause. As a farewell message to the American people the Prince issued the following: "It is difficult to express adequately how much I have enjoyed this visit, and how perfect the hospitality has been. The entertainments provided for us were, like many other things in this country, on an unprecedented scale. The methods employed were such as to make even the most formal affair thoroughly enjoyable. (Signed) Louis Battenberg, Rear Admiral."

IS INJURED ON THE Q. C. R.

RUPERT GILBERT, BRAKEMAN, MEETS WITH BAD ACCIDENT.

Mr. Rupert Gilbert, a brakeman on the Quebec Central, met with a serious accident last night at Levis.

The train on which Gilbert was working was shunting in the yard at Levis when he fell and the back track of one of the cars passed over him.

Two of his fingers were cut off and his knee so badly bruised that it is feared amputation will be necessary.

He was taken to the Hotel Dieu Hospital, and, this morning, his condition was reported to be about the same.

Mr. Gilbert, a resident of Lennoxville, formerly of Marleton, is married, and has one child.

KING HAakon VII.

CHARLES OF DENMARK UNANIMOUSLY ELECTED BY NORWAY'S PARLIAMENT.

Christiania, November 20.—The Norwegian Parliament Saturday unanimously elected Prince Charles of Denmark to be King of Norway. There were 110 members present.

Richmond, Nov. 20.—(Special.)—The late Mr. Henry W. Gallup, who died suddenly at Melbourne last week, left legacies by his last will and testament to the Sherbrooke Protestant Hospital and to the authorities of the Salvation Army.

ACCIDENT ON RIVER AT ST. JOHNS.

St. Johns, Nov. 20.—(Special.)—As the season of navigation nears its close each year there is considerable straining of nerves on the part of the boatmen to land their cargoes at the port of destination and to return to their home port before the river freezes over. Yesterday (Sunday) a spicet of excitement was added by a peculiar accident. In passing through Lacolle bridge en route for St. Johns a canal barge loaded with coal struck heavily against one of the stone abutments of the bridge staying a hole in her side below the water line. It was impossible to effect even temporary repairs, and it looked very much as if the boat and her cargo would go to the bottom. But through the ingenuity and efforts of the crew an expedient was found of saving both. The tug "Defender" was detached from the tow of which the injured barge was one and lashed to the side of the latter. The "Defender" then set out under full head of steam with her lame consort for St. Johns, which she reached in surprisingly short time. During the race down the river the pumps of the "Defender" were kept constantly going at high pressure. On reaching the Singers wharf men were immediately set to work to unload the coal, the "Defender's" pumps working all the while, and by one o'clock the barge was empty and temporary repairs were begun.

SKATING AT WATERLOO.

Waterloo, Nov. 20.—(Special.)—Skating has been excellent for a few days and our young people are taking advantage of the same. Some of our young men have already been courageous enough to cross the lake on skates. It is hoped that carelessness will not lead to fatalities as is often the case.

By this time quite a number of our old hunters and good marksmen were on the alert after him, but the deer having a few rods start, seemed equal for the occasion and got away to the thicket, and up to the time of writing none of the hunters have been fortunate enough to capture him.

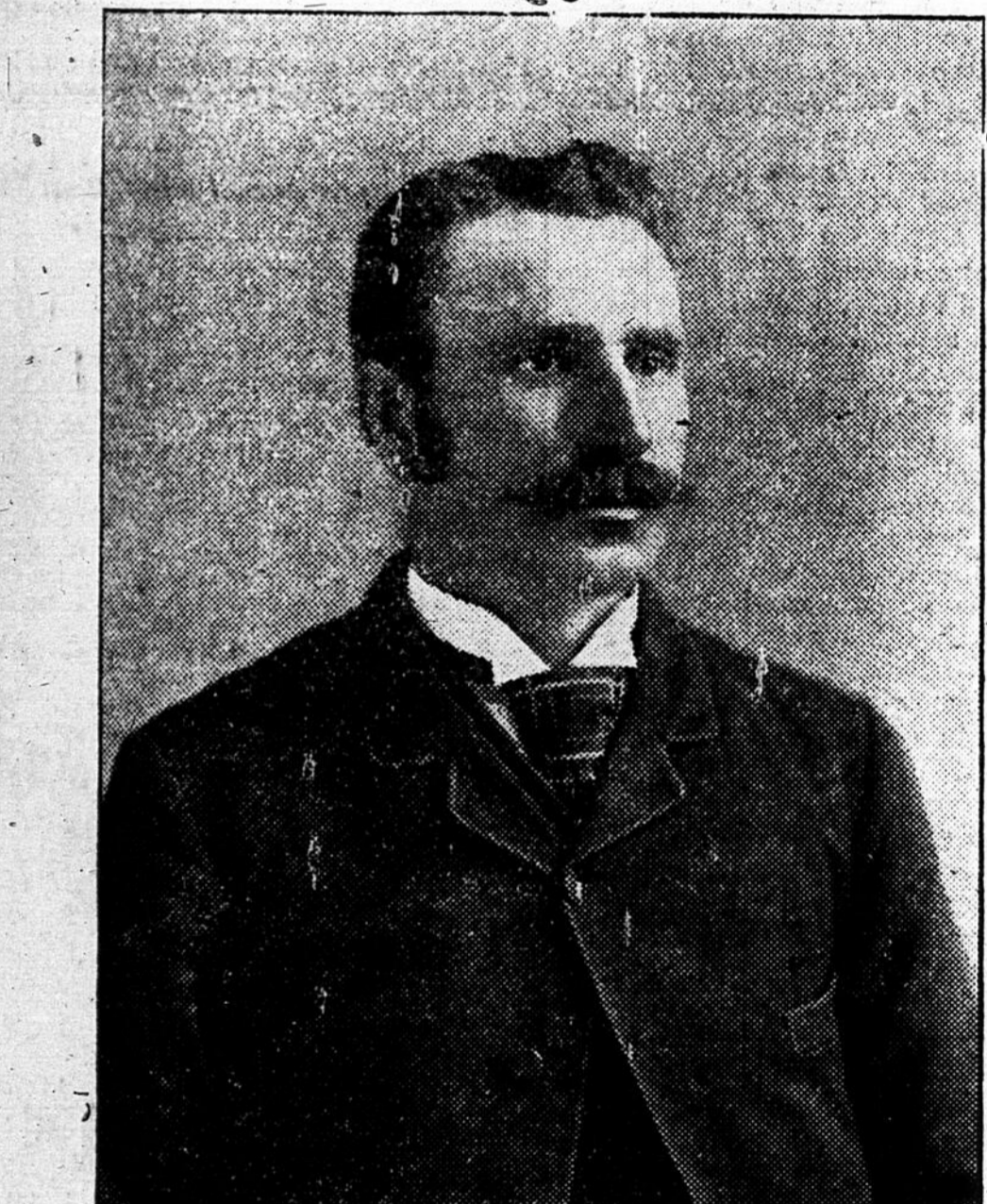

MORE THAN 100 LIVES ARE LOST.

Steamer Founders Off French Coast.

SEVERE SNOW STORM RAN ON TO THE ROCKS.

London, Nov. 20.—The South-western Railway's cross-channel steamer *Hilda*, bound for the French coast, yesterday morning, with a loss of more than 100 persons on board. One of the passengers and one member of the crew were rescued by a passing steamer, and now are on their way to Southampton. An unconfirmed report has reached Paris that 70 persons were saved.

The *Hilda* left Southampton Friday night for St. Malo, on the north coast of France. Her passage was greatly delayed by a fog in the channel, and when nearing St. Malo she ran into a severe snowstorm, apparently missed her course, and foundered on the rocks off Gardin Light-house, three miles from St. Malo.

WERE RUSSIAN PRISONERS.

RETURNED CANADIANS HAVE A TALE OF CRUELTY TO TELL.

Halifax, N.S., November 20.—Among the Allan line steamer *Parisian's* passengers yesterday were Robt. Finlay, of Prince Edward Island, and Charles Grant, of Pictou, N.S. They had been members of the crew of the Japanese fishing schooner *Hokusei*, which was captured during the war by the Russian cruisers *Rossia* and *Grom* and taken in prison three months in Japan, when, through the representations of the Canadian Government, through the British authorities, they were released and given transportation to London. They have a tale of cruelty by Russian soldiers and of hardships endured at the hands of their captors.

A WIFE FOR KING ALFONZO

SPANISH PAPER SAYS IT WILL BE PRINCESS EVA OF BATTENBERG.

Madrid, November 20.—The newspapers are again predicting King Alfonso's marriage. The latest report appears in the *Correspondencia de Espana*, which says he will marry Princess Eva of Battenberg, in May, 1906.

Paris, November 20.—The visit to Paris of King Alfonso, who has arrived here on his return from Berlin, Vienna and Munich, is unofficial. He accompanied this morning, and subsequently drove to the Palace of the Elisee in a motor car to see President Loubet, who, immediately after the King's departure, returned his visit at the Hotel Bristol. The King was shot with M. Loubet at Rambouillet to-day.





NORTH POLE EXPEDITION

GOVERNOR MOODIE OF HUDSON'S BAY BRINGS NEWS OF CAPT. AMUNDSEN.

St. John's, Nfld., Nov. 20.—Major Moodie, Governor of Hudson's Bay, reports having had a communication from Captain Ronald Amundsen's Norwegian expedition in search of the North Magnetic Pole as recently as May 22 of the present year. The sloop Gjoa, with the expedition on board, spent last winter in Simpson Strait, King William Land, four hundred miles north of Fullerton.

Capt. Amundsen, hearing a Canadian steamer was at Fullerton, despatched letters there last November, reporting himself and his companions well, but short of dogs. The messenger reached Governor Moodie's headquarters March 13 of this year, and on March 26 he started back with ten dogs. The messenger reached Captain Amundsen's party May 22, and then returned to Fullerton with a second letter. The second letter reported that the observations of the party and been conducted undisturbed since the establishment of the magnetic station in October, 1903. Half of the party began an exploration of Victoria Land in April last, hoping to achieve the North West passage this summer and come out through the Behring Strait next season. It was agreed if any mishap occurred efforts would be made to report to Fullerton.

Laroque. His Lordship congratulated the society upon the zeal and devotion that they had displayed in their work for the poor, and their ministry to the necessities of all who required assistance, and addressed them in glowing words of encouragement for the future. The meeting closed with the solemn benediction of the Blessed Sacrament.

ARRESTED FOR THEFT.

Stanislas Moissau was arrested on Saturday night at the Montreal House charged with theft. It appears that he had been around the house drinking and finding one of his friends a little overloaded, proceeded to go through his pockets. He succeeded in getting four dollars but was caught in the act and held until his arrest was made. He appeared, this morning, in Police Court, and was remanded to stand his trial before District Magistrate Mulvena.

NEW FENCE COMPANY SEEKING INCORPORATION.

"The Province of Quebec Hedge Fence Company" is the name of a new industry seeking incorporation under the laws of the Province of Quebec.

W. Bennett, Charles C. Cabana and Major Hanson.

Col. Pope officiated as chairman and Dr. Fred. H. Bradley as secretary of the meeting. The syndicate is seeking incorporation with a capitalization of \$50,000.

The company has purchased the rights from the origin patentee for the manufacture, sale and construction of the hedge fence for the entire Province together with the contracts and nursery of the original company in this province.

Sherbrooke will likely be chosen as the location for the head office of the company.

AT THE Y.M.C.A.

Striking tributes were paid to the late Sir George Williams, the founder of the Young Men's Christian Association at the Y.M.C.A. yesterday afternoon by Rev. G. E. Read and Rev. P. L. Richardson. This great man entered a large store in London, sixty years ago and at once began to work for the other young men of the establishment. The result was the beginning of this movement which now belts the globe, reaching and elevating the lives of men of every trade and profession and every creed. The world owes a great debt to him because as a result of the movement the world has been bettered. The Associations now enroll over 700,000 members who through its various departments, are being moulded into men of character. One example is sufficient to illustrate the far-reaching influence of the work. Fifty years ago only 7 per cent. of the college students were Christians. They were regarded as an irreligious lot of men. To-day an American college is the safest place in which parents can place their children; 87 per cent. of the students are Christians; 2,960 college students in U. S. and Canada have volunteered for Christian service in foreign lands. This transformation has been brought about by the movement of which Sir George Williams was the illustrious founder. Energy, faithfulness, steadfastness, love for men and consecration to God won for him the esteem of all ranks of men and through these traits he became one of the world's benefactors. He has gone home to be with the Master; he died, but the work he did shall live after him, and though dead he still lives.

London, Nov. 20.—A Bucharest despatch to the Chronicle says that a mob devastated a number of Jewish shops in Kishineff, Sunday, robbing and burning. The houses on one street were lately destroyed. The Jews and students combined to fight the criminals. A large number on both sides were killed and wounded. The despatch adds that a great number of Jews in Bessarabia are dying from starvation.

CUBAN TROUBLE

SECRET DEPOSIT OF MUNITIONS OF WAR DISCOVERED.
Havana, Nov. 20.—The truth in the reports of plots to overthrow the Government was revealed in part yesterday. The Government received a confidential report to the effect that an ostensibly vacant house in the Cerro suburb was being utilized as a secret depository for arms and ammunition, and ordered the secret police to investigate. It resulted in the finding of 41 rifles, 21 carbines, 35 packages, each containing a thousand cartridges, and some barrels filled with ammunition and accoutrements. Considerable suspicion is directed towards the Liberal and Radical leaders.

THE HABITS OF SQUIRRELS. While certain members of the squirrel tribe store their winter's supply of food in hollow trees, I think most of them hide it on the ground, under old roots, brush piles, and even beneath heaps of dead leaves. Their tracks in the winter woods seem to bear this out. While it may be that this frequency of the tracks indicate a scarcity of food, and the traveling about a desire to find a supply, I believe in the main, that these outings of the squirrels have a definite destination, because when you see them skip across the snow, stop short, and scratch a hole in the ground, bringing out a supply of nuts or cones placed there in the months of plenty, you are apt to attribute their luck more to a good memory than to any haphazard speculation.

Of the squirrel family, the most prominent are the blacks. He seems to be flowing over all the time with pent-up energy, which keeps him in constant motion, and you sometimes feel that you would like him to be able to talk and tell you how pleasant it is to have the joy which flows from a glad heart. Now watch him jump from limb to limb, rush headlong down the trunk, and course across the snow in long graceful bounds, with no apparent purpose but to exhibit the happiness within him.

His red cousin once in a while may be seen at the entrance to his home in the heights of some tree, but in him is no sign of exultation. He looks around as if he were looking and wishing for spring to come and clear away the snow, and no amount of coaxing will cause him to utter a note of scolding or alarm. Not all the red squirrels, however, keep to the trees. Many of them, through want of food, have to take to the earth, and their track in the deep snow is a heavy floundering of labored bounds as they go from tree to tree in search of the scanty provisions hidden beneath the surface. Here and there we find the gummy seals of the pine cones, the shells of the acorn, the seed cones of the birch and cedar scattered about on the snow, showing the food on which they subsist in greater contrast to the delicacies just named.

Often one will find during long and severe winters that the squirrels have attacked the hemlock trees by stripping them of their bitter seeds. When one finds this, it is evidence of great want, and material to be used to bring some food and scatter it about to assuage the pangs of hunger which these little fellows are enduring.—John Boyd, in Recreation for November.
