A NEW U. S. LUMBER RULING.

Washington, D.C., Nov. 23.—(Special.)—Assistant Secretary Howell, of the Treasury Department, has made a ruling that lumber produced in the forests of Maine, on the St. John's River or its tributaries, and sawed and hewed in a mill in Canada, leased by an American citizen, can be admitted into the United States free of duty under the provisions of the Dingley tariff law.

Span of Bridge Fell.

Portage du Fort, Que., Nov. 23.—About noon yesterday the entire long span between the piers at the Ontario end of the bridge across the Ottawa, at this place, suddenly gave way, and fell into the river.

WILL LEASE SOCOTRA.

Great Britain Will Permit the U.S. to Use the Island as a Coaling Station.

London, Nov. 23.—The Vienna correspondent of the Daily Chronicle says it is semi-officially announced that negotiations are in progress between Great Britain and the United States with a view of ceding to the latter a coaling station in the Straits of Bab-el-Mandeb, the straits uniting the Red Sea with the Indian Ocean.

With this object in view, the island of Socotra, in the Indian Ocean, 120 miles east of Cape Guardafui, the eastern extremity of Africa, has been leased to the United States, who undertake to erect lighthouses east and west of the island, which must not be fortified.

It is further stipulated, the correspondent says, that only warships are allowed to coal there, so as not to injure the English coal trade at Aden and on the Persian coast.

AUSTIN WRITES A POEM.

London, Nov. 23.—The Times this morning publishes a poem from the pen of the poet laureate, Mr. Alfred Austin, entitled "Pax Britannica," in which he sings of England's display of pre-eminence for war and peace, and her enemies. The eleventh stanza reads thus:

"But they who watch From where the west wind blows Since Greece and Rome are dead, Proud that their kith are great, Sail, See what comes When England with her foes Speaks at the gate."

THE MAYOR CRITICISED.

Several Harbor Commissioners Resent the Mayor's Attack in His Somher Park Speech.

ENTIRELY UNCALLED FOR.

The Mayor Replies and Defies the Board to Have its Plans Accepted by the Government.

STILL ON HIS HIGH HORSE.

The Harbor Commissioners had a lively time of it yesterday afternoon, when several of the commissioners expressed their views very strongly on the speech made by the Mayor at Somher Park on Monday evening. It did not take long to get over the routine business, and then there was a pause, but it was the calm before the storm. The discussion arose out of a suggestion made by Mr. Bickerdike, that a letter be sent to the Minister, pointing out the inevitable loss of time in getting ready the plans for the dry dock.

The Mayor—"The law is passed, and that settles it. Exorbitant prices can be got over by expropriation."

Mr. Lemay—"But the money property can be purchased without expropriating."

The Mayor—"No, it can't."

Mr. Bickerdike—"Is there anything in the way of the purchase, Mr. Chairman?"

The Chairman—"There are difficulties, but they can be made all right in court."

The Mayor—"That is not the question. The Minister has said he wants a complete plan."

Mr. Bickerdike—"We are getting it."

The Mayor—"You will not get the Minister's assent unless you have complete plans."

Mr. Racine—"That is what Mr. Kennedy has been ordered to prepare. He is now visiting other ports with this object in view."

Mr. Bickerdike—"I don't think Mr. Kennedy can prepare the plans, when we take into consideration the difficulty with the railways, in less than a month, perhaps five months."

The Mayor—"Five years, you mean?"

Mr. Thomson—"That brings up for our consideration what was said at a public meeting held last night, and presided over by the Mayor. It is utterly impossible for the harbor engineer to prepare plans until he knows what the railways want."

"There are some things in the Mayor's speech I resent. I find in a report of his opinion that we have not been generous to the East End. Later on the Mayor said: 'None of the plans had been worked upon, and the workmen were still waiting for the promised employment. Who promised them employment? I don't know. It was not the Board, and it is not the Board's fault if they did not get this promised employment.' As to the railways, it was on the Mayor's own motion that they did not want to meet the Board, to state what they wanted. The Mayor was the only person who saw the railway authorities, and he informed the Commissioners that the railways would not meet them, as they did not want to show or say where they wanted any improvement, as the land would advance in price, and it would either have to be looked for elsewhere or an exorbitant price paid. I do not think that can be the case, for, if the railways want accommodation, they should be equally as anxious to meet the Commissioners and say what they wanted as the Commissioners were desirous of meeting them. We have asked again for a conference, and we are not to blame in the matter."

"When the Mayor stated that no dry dock in America was more than 600 feet long, and laughed at the idea of an 800-foot dock. I think it is worth getting a site permitting an 800-foot dock; not that we would build it at present. The dock should be 600 feet at least. The largest vessel coming here is 504 feet in length. Ten years ago a vessel of that length coming to Montreal was not thought of, and is as likely as likely that ten years hence a vessel of 800 feet in length will be coming here."

"The Mayor goes on to speak of conspiracy, but I fail to see it. If there is one, it is his duty to show it. How the Mayor let himself loose and abused his fellow commissioners last night I don't understand."

Mr. Thomson then spoke of the choice of a site, saying that when the Government appointed its representatives upon the Harbor Board it did so knowing that they were men of business capacity, and honest men, and just as capable as the Mayor of judging where a dry dock should be for Montreal. The responsibility should not be put on Mr. Tarte's shoulders. It was not a question of east or west with the commissioners; it was the good of the port. "I am very sorry," concluded Mr. Thomson, "that the Mayor spoke as he did, and sorry that I had to bring it up, but I certainly do not let it pass."

Mr. Robert Mackay—"I did not know that the Board had any right to take notice of outside utterances. The Board and the Mayor differed, and when the Mayor spoke outside he differed from the Board."

I think the only reason could be that he did not get what he wanted in regard to the site. He should respect his colleagues' opinions sufficiently to believe that they were acting in good faith, and that they had only the honest object in view of obtaining the most suitable site and the cheapest, so that they would have more money to spend in building a dry dock and making the other improvements. I can't agree with the Mayor's figures. If the site cost \$30,000 instead of \$210,000, we would have to make an other improvement. Then we differ in regard to depth. I hold it is better to have too much than too little, and in the site the Mayor advocates, bridging for the railways might cost \$100,000 in addition to the cost of the site. Lower down there would be no such item. As far as I can understand the feeling of the shipping interest, it does not matter how far down we go. Besides, the engineer was in favor of an inland protection instead of a wharf protection, as suggested by the Mayor. If the Mayor had properly understood us, I am sure he would have held the meeting at which he distinguished himself as chairman.

"East, west, north or south, makes no difference to me, and the question of nationality or religion never entered into my calculations at all. I simply wanted to do the best I could. If I was wrong, I am willing to be corrected, but in my desire to do the best for Montreal, I will not take a back seat even to His Worship. I think that have as high an object in doing as well as I know how for the benefit of the city as has the Mayor, and do not think that the remarks his worship was so courteous as to extend to the board were at all called for."

The Mayor began his reply by asking the draught of a vessel 600 feet long.

Mr. Andrew Allan—"Loaded or not?"

The Mayor—"Loaded."

Mr. Allan—"Probably about 27 or 28 feet."

The Mayor—"All right. Since the matter has been brought before the Board I explain my position. I have a right to go before the people who had elected me to sit on this board and render an account of my conduct and of what was going on in regard to harbor matters. I have never reproached any of the commissioners for having gone before their boards and got resolutions passed condemning the action of the majority of the Harbor Board because they were appointed by the Government, and I don't see why I should be questioned when I go before the electors, not of Maisonneuve, but of Montreal, the people who had elected me. I went before them last night and gave them an account of how things were going. I have not read the report in the Gazette or in La Minerve, but I am told they are correct and I stand by them."

"When I stated there was a conspiracy against the East End, I did not speak of my own authority alone. There is the old starying you in the face \$750,000 below St. Mary's current. That was to be expended in the carrying out of the other improvements. That was carried unanimously in Commons and in the Senate. Not only in this board but for ten years back there has been a disposition to give the East End what it wanted, and stating what Parliament said, and what I stated in Parliament. The money was voted ten years ago and the work is only commenced. When it was commenced I said, 'If I had wanted to carry out the law to the letter, I could have done it. We will not start that work in the centre of the harbor until the plans are prepared for the outside work.'"

"I was now almost December and nothing has been done in the dry dock matter. If I had known before what I know now I would never have consented to the site for the dry dock being limited to 800 feet, because it put out of the market most of the land that could be used for the purpose and limited the site to three or four lots. This was done with the intention of leaving the works contemplated by the act."

THE MAYOR AND THE BOARD.

When His Worship the Mayor of Montreal loses his temper it is a good sign, for it indicates pretty clearly that he is not getting his own way, and a long course of municipal history has made it clear that when Mr. Prefontaine gets his own way about things it costs a pretty penny to pay the piper.

And above all, why did he withhold his denunciation of that property so long as it was tendered at \$62,500 and only launch denunciations against it when the Board decided it would only pay \$30,000 and there was a likelihood of getting it at that figure?

A MODERN WIZARD.

BATTLE OF THE BULLETIN BOARDS.

The Chief of Police Ordered the Police to Swoop Down on the Herald's Bulletin Boards Yesterday.

Diplomatic relations between The Herald and the Chief of Police are at an end. This was made plain this morning when the chief, with great emphasis and clearness of expression, refused to speak to or answer one question put by a Herald representative.

He is going to confine himself to gathering up the Herald bulletin boards. He commenced work last night. Of course, he couldn't very well command his minions to seize Herald boards and not touch those of other papers. So other papers also had to suffer.

Acting under orders, the patrol wagon of No. 4 Police Station started out about five o'clock yesterday afternoon, and covered St. Catherine, Bleury, Craig streets and Beaver Hall Hill. The round-up resulted in the following captures: Herald boards... 13, Le Minerve boards... 9, Gazette boards... 8, Witness boards... 6, Metropolitan boards... 2, Ladies' Journal boards... 1, Scripps' boards... 1.

The load was landed at the City Hall, and the boards piled in the hallway leading from the Central Station to the detectives' office. They are there yet, and the Chief says that the proprietors can have them by going for them. That is the gravest punishment to be inflicted.

What puzzled the patrol men most was that they were told to go and collect the boards, because it was against the by-law to have anything of the kind standing on the sidewalks, and while they were told this no instructions were given to carry them to the station. There was one Herald board on Craig street which the patrol men nearly missed. They jumped off the wagon, and would have had no difficulty in getting at the board, but the street was fairly well crowded, and traffic was impeded by about a dozen chairs, some tables, etc., which were standing on the sidewalk in front of a second-hand store. It would never have done, however, to have carried off these things placed there in defiance of the by-law; all they were told by the Chief to do was to gather up those awful bill-boards, the headline on one of which read: CHIEF HUGHES VS. THE HERALD.

And so the pedestrians struggled to get past each other and the chairs and tables remained where they were, while the board was carried off triumphantly. There was another board which they tried hard to get, but six good clamps held it securely to the wall. In trying to remove this they acted clearly outside of their jurisdiction.

The by-law is very plain. It provides that any board or sign attached to a building may project six inches from that building, without being a nuisance, but if it is free, and an encumbrance on the sidewalk, it may be removed by the police. So that in interfering with some of

the bulletin boards the chief has made a mistake. But he is quite happy over it. He discussed it with the police reporters this morning at length, not with The Herald reporter, of course. He made it very plain when a Herald reporter asked him a question that he had no news for The Herald, and that he would absolutely refuse to answer any question put by a representative of this paper.

He paced the floor in the office this morning and said: "The police have no objection, but the by-law says that no obstruction whatever must be left on the sidewalk." "Who complained?" The Herald asked. "Who, why but you belong to The Herald, and I have nothing to say to you. No, no, no, I will not talk to you as a representative of that paper."

After the storm one of the other reporters mildly asked: "Did any one complain?" "Several people have complained to me. One man on Bleury street has written several letters. I do not, however, consider that Bulletin boards leaning up against a wall are a nuisance, and I gave no orders that they should be removed. Merchants cannot put cases on the sidewalk, and newspapers have no more rights than other people."

Here The Herald reporter suggested that the boards would be eventually returned to the owners. He was off again: "I will not answer you because you are on The Herald. Now understand that." Soon the opportunity came for some one else to ask about the return of the boards. The chief said they could be taken back at the time so long as they were not returned to the same place.

Some of The Herald's bulletin boards are in jail. The rest are under police surveillance. The bulletin boards placed under arrest last evening by Chief Hughes' orders will please take notice that the police are waking up. They will not allow newspaper bulletins to be paraded on the sidewalks. Perhaps the department is thinking of instituting a whole lot of reforms. But then, again, perhaps not. And to think that a few inoffensive bulletin boards should have to bear the brunt of all this wrath.

That is, he will not be recommended by the Crown for dismissal, but must be punished for his crime. He who confesses his guilt is apt to receive a less severe sentence than he who does not. It is, that is probably what Holden thinks of. He is a man up in years, and his offence called for a long term of imprisonment. The Crown can make a bargain with a man in his position; he takes his chances."

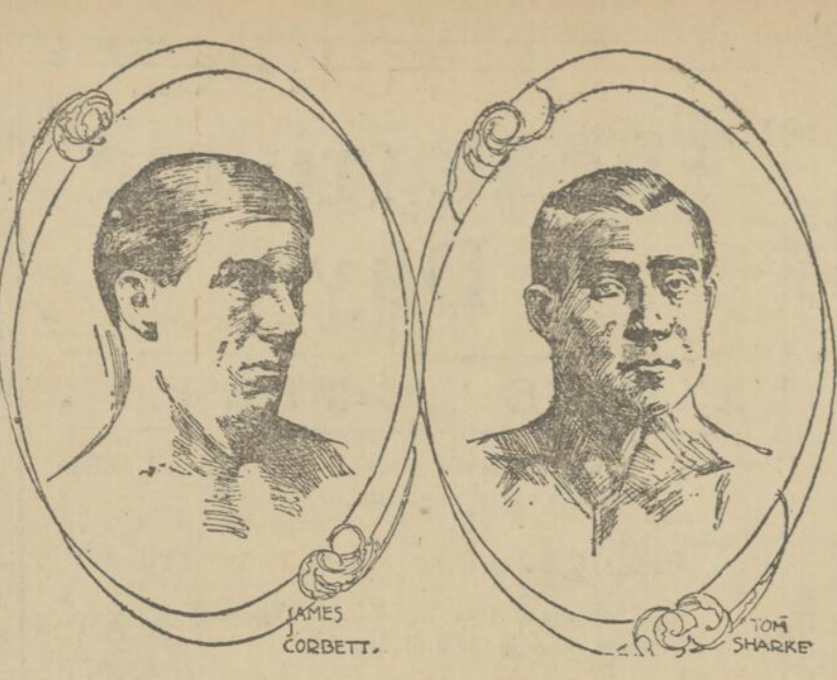

CORBETT'S SUN HAS SURELY SET

The Big Californian Was Worsted Last Night by the Sailor, Tom Sharkey.

New York, Nov. 22.—The Corbett-Sharkey fight, which was witnessed by the largest and most representative gathering of sporting men that ever congregated to see a ring contest, ended in a most disgraceful fiasco to-night at the Lenox Athletic Club. Corbett had all the worst of the encounter when one of his seconds, Connie McVey, jumped into the ring, appealing to the referee, thus violating the rules, and Referee "Honest" John Kelly had no alternative but to disqualify Corbett and award the bout to Sharkey. McVey's intrepidity was absolutely inexcusable and the referee, believing that there was a "job" in McVey's action, took upon himself to declare all bets off. Before Kelly did so, however, many of those who had bet on Corbett, and they were legion, appealed to the referee to take such action, while the Sharkeyites shouted against such interference on Kelly's part, and protested that he had no authority to declare the bets off. However, the referee's word went with the majority of the spectators, and consequently all money paid on wagers made will be refunded. It was a most unfortunate and abrupt ending to what promised to be an interesting fight.

For weeks both Corbett and Sharkey had trained faithfully and carefully for the contest, and when they stripped to-night both of them showed in excellent condition. Sharkey was very confident of success, and the manner in which he acquitted himself in the ring while the fight lasted, showed very plainly that his confidence was founded on good grounds. Those who believed that Sharkey could not fight fairly changed their opinion, after the bout had gone one round. On the other hand, Corbett hit rather low, and Sharkey protested. Sharkey's quickness and aggressiveness were astonishing from the very beginning, and from the very first it was very evident that he held Corbett safely.

Floored Corbett. In the second round there were wild yells from the admirers of the Irishman when he floored Corbett with a right swing on the head, which was proceeded with a powerful blow on the body. Sharkey's rushes were successful invariably, and Jim's quickness and leg work were tested to their utmost in trying to evade the aggressive sailor-pugilist. In the ninth round, which was so productive of disappointment and unlooked-for incidents, Corbett seemed to strengthen that at any time during the fight, but it was evident that he was slowly but surely fading under Sharkey's onslaughts. It was two to one on Sharkey after the second round, and had not McVey acted as he did there is very little doubt but that Sharkey would have won handily.

Some of the most prominent bankers, brokers, lawyers, doctors and business men in this and other cities were present during the fight, and not one of them could see any reason for interference by McVey. The general belief is that McVey acted for some unexplained motive, and some persons said that he jumped into the ring to prevent Corbett's going under. When McVey first put his leg through the ropes the referee evidently did not or would not look in that direction, but continued to pay close attention to the fighters, who were mixing it up in the centre of the ring. Inspector McLaughlin caught hold of McVey to pull him out again, but the latter was evidently more than anxious that Kelly should see him. In this he was successful, but not until after the people in the house had yelled repeatedly to Kelly to disqualify Corbett.

Corbett's backers forced the price of the Californian to \$100 to \$70, just as it was learned that the ex-champion had reached the club-house, and was in his dressing-room.

The Men Appear. At twenty-three minutes after ten o'clock a buzz of excitement was through the betting crowd. He was attired in a light blue dressing gown, underneath which he had an American flag wound around his waist, for a belt. He was accompanied by his manager, Tom O'Rourke, John T. Dougherty, George Dixon, Bob Armstrong and Jack Reid, who acted as his seconds.

Professor DeForest held the watch for the Irishman. Sharkey never looked better in his life, and said he weighed 178 pounds. He was very confident, and exhibited no signs of nervousness.

Announcer Charley Harvey called the attention of the onlookers to the fact that the principals wished them to refrain from smoking, and immediately all the cigars which were being industriously puffed were trodden underfoot most willingly.

The crowd was beginning to be uneasy at Corbett's delay in making his appearance, when some one in the gallery shouted "Three cheers for Sharkey." They were given with a will.

Corbett did not reach the ring until 10:38 o'clock. Just 15 minutes later than Sharkey. There was a wild cheer as he was seen making his way to the ring side. When he reached the steps leading up to the ring, Corbett stopped for a moment to shake hands with some friends, then climbed nimbly through the ropes. He was enveloped in a dark olive green dressing gown. His hair was parted in the middle, and carefully combed and brushed. Corbett's seconds were Charley White, George Considine and Jack McVey. John Considine, of Detroit, acted as his time-keeper.

Both men had their choice of two sets of gloves. Corbett selected his pair, which were made for him in California. They were a pair of typical fighting gloves, being just shaped like the clinched fist, whereas Sharkey's were the long, tapering glove usually donned by boxers. They were nearly 1 1/2 inches longer than his opponent's, which would give him an opportunity of forcing the hair in the glove away from the knuckles. The gloves were of the regulation weight of five ounces as provided by the Horton law.

When the men were introduced, Sharkey's name was mentioned first, and there was prolonged cheering, to which Sharkey responded by a bow.

Corbett landed with his left, Tom going right back at him the same moment. Clinches were frequent, and the men refused to break together. Corbett struck Tom rather low on the body, and the sailor appealed to the referee. Corbett shoved Tom from him and said: "Oh, you go away." The men were in the centre of the ring mixing it up in the liveliest manner, O'Rourke calling to Tom not to let Corbett's work hitting. Just at this moment, for some unaccountable reason, McVey, one of Corbett's seconds, jumped through the ropes, protesting that Sharkey had done something wrong to Corbett. The moonlight glimmered behind the ropes Police Inspector McLaughlin grabbed hold of him, while the crowd frantically yelled "Foul, Corbett is out!" at his second in the ring.

Referee Kelly seemed to try to see to the matter, but kept looking at the fighters, who continued their aggressive work. McVey tried to pull away from the inspector, who was shouting and yelling at the referee, who finally separated the fighters and ordered them to their corners. Corbett seemed not to understand why the referee should interfere and protested, but Kelly was obstinate and stopped the bout.

Bets Declared Off. Meanwhile the spectators stood up and yelled that bets should be declared off, as they believed McVey's conduct to be a breach of ring rules intentionally. It looked for a while as if a riot would ensue, but as soon as the referee declared Sharkey the winner on a technicality he announced that he was not stating that McVey's action was undoubtedly prearranged. As soon as this announcement was made, the spectators resumed their seats and awaited the departure of the men from the ring.

Everybody Makes Statements. New York, November 23.—Statements made late last night by those concerned in the Sharkey-Corbett fiasco are as follows: John Kelly, the referee—"I stopped the bout and gave the decision to Sharkey because McVey, one of Corbett's seconds, in violation of all rules, jumped into the ring."

"I called all bets off because I believe the action of McVey was paid for by somebody, who had bet on Sharkey, and I did not propose to decide publicly on a case which I believe I would not be a party to such a fraud."

"No one can tell me McVey lost his head. He has been behind fighters for years, and he has never been behind his own movements. So far as I can see the fighters were on about even terms after I stopped the bout in the ninth round."

McVey's statement—"I jumped into the ring because I saw Sharkey hitting in almost every clinch and sometimes so low that anybody ought to have been able to see it. I called to the referee to stop the fight after time in the last round and then I could stand it no longer and stuck my head through the ropes, but Kelly did not see me. And then I saw Sharkey hit me with another clinch. I lost my head and put my foot over the ropes, and they gave the fight to Sharkey."

"I am sorry that I am the cause of the decision being given against me. It is a pity, but I have no certainty. He had Sharkey whipped, but I could not stand seeing Jim getting fouled without making a protest."

"The man who saw the fight will agree that I had Sharkey whipped and could have had the decision in another round or two. I did not want to win a fight on a foul, and it was my misfortune that McVey jumped into the ring to call the referee's attention to Sharkey's foul fighting."

"He did fight foul. He hit me low, once in the second round and again in my seventh. I did not see McVey jump into the ring. My back was turned to him, and when Kelly said 'You win,' I thought he meant me, because I knew I had away the best of it."

THE TWO OTTAWAS MEET TO-MORROW.

The Capital Teams Have Made Up Sufficiently to Play the Final Game.

QUEBEC UNION MET. Ottawa College Was Urged to Give the Granites a Game Before the End of the Season.

WALTERS PROTESTED AGAINST. Ottawa College and Ottawa City will meet to-morrow in the Capital for the championship of Canada. There is no doubt about this, as it was settled early last evening.

A large number of football enthusiasts will go up from here to witness the game, which will undoubtedly prove to be one of the finest struggles ever witnessed on a Canadian gridiron.

Quebec Union Meeting. There was a meeting of the Quebec Rugby Football Union, held at the M.A.A.A. last evening. Those present were:—Dr. Clarke, W. Nickle, Kingston; J. J. O'Reilly, C. Sparrow, Ottawa College; T. Molson, J. F. Savage, Montreal; A. G. B. Claxton, president; E. H. Brown, secretary.

The Granite representatives urged the Union to declare last Saturday's fiasco no game, and order Ottawa College and granites to play the final in the Quebec series. Dr. Clarke, early in his address, apologized on behalf of the Granites for a childish effusion written by one of the Granites to the president of the Union and read at the meeting.

Mr. Nickle showed consummate skill in handling his "brief," and heightened the good impression created by Dr. Clarke. They are a model pair of representatives. The following motion, which carried, showed the feeling of the meeting:—Whereas, in the opinion of this meeting, the referee for the recent match between Ottawa College and Granite football teams, was illegally appointed, and whereas Ottawa College claims the said match, in accordance with the referee's decision;

Be it resolved, that the championship of Quebec be hereby awarded to Ottawa College.

Further that this meeting suggests that in the interests of sport, Ottawa College should, if possible, accept the offer of the Granites to play an exhibition game, the time and place to be arranged later.

Mr. O'Reilly protested against the last paragraph, saying that it implied that the College players were not sufficiently sportsmanlike to meet the Granites without being urged to do so by the Union. But the other delegates could not see it that way, and the motion carried.

It is now in order for College to give the Granites a game, and if they do not, the onus for it will be on the Granites. The Union will be on the whole satisfied with the decision.

On motion, it was decided that the Quebec Union would protest against the playing of M. Walters on the Ottawa City team to-morrow, and that the protest will be handed to the referee before the game commences. The Canadian Union will then have to show its hand.

CALEDONIAN TROPHY. A Circular Issued Dealing With the Handsome Prize Donated by the R.C.C.C. The following circular which has been sent out by Mr. Alex. Murray, secretary of the Canadian branch of the Royal Caledonian Curling Club, speaks for itself:

At the annual meeting of the branch, the following officers were elected for the current year, 1913-14.—President, Mr. G. H. Baufour; first vice-president, Mr. David Guthrie; second vice-president, Mr. Ed. W. Wood; Ontario champion, Rev. Dr. Barclay; secretary-treasurer, Mr. Alex. Murray. And to act as members of the executive board: Messrs. F. Standiford and G. W. Wood.

The allocation of district medals for the coming season was postponed, pending the playing off of the following unfinished competition for next season:—Montreal Thistle vs. Kingston; Glenora vs. Cornwall; Pembroke vs. Carleton Place. These clubs are required by resolution of the branch to make arrangements for completing the matches before 31st December next, the winning clubs to report to the undersigned, when the district medals will be forwarded. Any obstacle to the carrying out of this duty must be reported at once for adjudication by the executive.

ROYAL CALEDONIAN TROPHY. The branch has now received from the R.C.C.C. the handsome and valuable trophy which is to take the place of the old "Laird's" trophy in curing the winter past by the Montreal Caledonian Club. By resolution of the branch, I am instructed to invite suggestions from the several clubs as to the conditions under which the trophy should be competed for. The parent organization is donating the trophy, made it a condition that it should be a perpetual challenge trophy, and the rules to be those of the R.C.C.C. should be on the lines of those established for the Branch Tankard. These conditions were accepted by the branch, but there is room for suggestions as to the details, and these are now invited. The branch has had under consideration a proposition to donate an annual prize to be known as the Caledonian trophy for the year. But, as this involves an outlay which the current revenue of the branch will not bear, the executive deem it best to ask the co-operation of the clubs, as was done when presenting the Branch Tankard. In the present case, the trophy being a perpetual one, it would be desirable to have from the clubs an annual contribution of one dollar each as the minimum, or a donation which when invested would give an annual subscription equal to the same amount. As, however, some of the clubs may not be in a position to guarantee any contribution, the executive express a more liberal donation from the stronger clubs, so that at least an annual prize of twenty dollars might be secured to accompany the trophy each year.

It being essential that this matter be placed without delay on a satisfactory basis, the attention of clubs is earnestly requested, and the decision arrived at must be communicated to the secretary of the branch before the 1st of December next. THE TWO OTTAWAS MEET TO-MORROW.

The Capital Teams Have Made Up Sufficiently to Play the Final Game.

QUEBEC UNION MET. Ottawa College Was Urged to Give the Granites a Game Before the End of the Season.

WALTERS PROTESTED AGAINST. Ottawa College and Ottawa City will meet to-morrow in the Capital for the championship of Canada. There is no doubt about this, as it was settled early last evening.

A large number of football enthusiasts will go up from here to witness the game, which will undoubtedly prove to be one of the finest struggles ever witnessed on a Canadian gridiron.

Quebec Union Meeting. There was a meeting of the Quebec Rugby Football Union, held at the M.A.A.A. last evening. Those present were:—Dr. Clarke, W. Nickle, Kingston; J. J. O'Reilly, C. Sparrow, Ottawa College; T. Molson, J. F. Savage, Montreal; A. G. B. Claxton, president; E. H. Brown, secretary.

The Granite representatives urged the Union to declare last Saturday's fiasco no game, and order Ottawa College and granites to play the final in the Quebec series. Dr. Clarke, early in his address, apologized on behalf of the Granites for a childish effusion written by one of the Granites to the president of the Union and read at the meeting.

Mr. Nickle showed consummate skill in handling his "brief," and heightened the good impression created by Dr. Clarke. They are a model pair of representatives. The following motion, which carried, showed the feeling of the meeting:—Whereas, in the opinion of this meeting, the referee for the recent match between Ottawa College and Granite football teams, was illegally appointed, and whereas Ottawa College claims the said match, in accordance with the referee's decision;

Be it resolved, that the championship of Quebec be hereby awarded to Ottawa College.

Further that this meeting suggests that in the interests of sport, Ottawa College should, if possible, accept the offer of the Granites to play an exhibition game, the time and place to be arranged later.

Mr. O'Reilly protested against the last paragraph, saying that it implied that the College players were not sufficiently sportsmanlike to meet the Granites without being urged to do so by the Union. But the other delegates could not see it that way, and the motion carried.

It is now in order for College to give the Granites a game, and if they do not, the onus for it will be on the Granites. The Union will be on the whole satisfied with the decision.

On motion, it was decided that the Quebec Union would protest against the playing of M. Walters on the Ottawa City team to-morrow, and that the protest will be handed to the referee before the game commences. The Canadian Union will then have to show its hand.

CALEDONIAN TROPHY. A Circular Issued Dealing With the Handsome Prize Donated by the R.C.C.C. The following circular which has been sent out by Mr. Alex. Murray, secretary of the Canadian branch of the Royal Caledonian Curling Club, speaks for itself:

At the annual meeting of the branch, the following officers were elected for the current year, 1913-14.—President, Mr. G. H. Baufour; first vice-president, Mr. David Guthrie; second vice-president, Mr. Ed. W. Wood; Ontario champion, Rev. Dr. Barclay; secretary-treasurer, Mr. Alex. Murray. And to act as members of the executive board: Messrs. F. Standiford and G. W. Wood.

The allocation of district medals for the coming season was postponed, pending the playing off of the following unfinished competition for next season:—Montreal Thistle vs. Kingston; Glenora vs. Cornwall; Pembroke vs. Carleton Place. These clubs are required by resolution of the branch to make arrangements for completing the matches before 31st December next, the winning clubs to report to the undersigned, when the district medals will be forwarded. Any obstacle to the carrying out of this duty must be reported at once for adjudication by the executive.

ROYAL CALEDONIAN TROPHY. The branch has now received from the R.C.C.C. the handsome and valuable trophy which is to take the place of the old "Laird's" trophy in curing the winter past by the Montreal Caledonian Club. By resolution of the branch, I am instructed to invite suggestions from the several clubs as to the conditions under which the trophy should be competed for. The parent organization is donating the trophy, made it a condition that it should be a perpetual challenge trophy, and the rules to be those of the R.C.C.C. should be on the lines of those established for the Branch Tankard. These conditions were accepted by the branch, but there is room for suggestions as to the details, and these are now invited. The branch has had under consideration a proposition to donate an annual prize to be known as the Caledonian trophy for the year. But, as this involves an outlay which the current revenue of the branch will not bear, the executive deem it best to ask the co-operation of the clubs, as was done when presenting the Branch Tankard. In the present case, the trophy being a perpetual one, it would be desirable to have from the clubs an annual contribution of one dollar each as the minimum, or a donation which when invested would give an annual subscription equal to the same amount. JIM CORBETT.

Corbett received a more demonstrative ovation, the cheering lasting more than a minute. Corbett wore white trunks and a red, white and green sash, which his seconds took off as soon as he stood erect. Sharkey wore a green sash, held by a belted American flag. There was a long confab between the principals, their seconds, and the referee, after which the men retired to their corners, after having agreed not to hit in clinches or in break-aways, and that they would step back when ordered to break. Everything was in order for the bout to begin.

Round I. The men fiddled for several seconds and Jim made a left jab at the head. Tom responded with his left and right in the same spot. Corbett led again, Tom responding with a left swing for the head, which landed. Sharkey ripped in his left and right for the body with some effect. He kept forcing Jim into the various corners, punching with his right and left on the body, which seemed to be his objective point. Jim seemed to be drawing his man on. Sharkey was always ready with his left jab and right swing, which landed on the body. Corbett failed to show any of the great cleverness with which he has been credited.

The round ended with Sharkey at his man. Round ii. Corbett landed with the left lightly. There then was an exchange with lefts and rights on the head, in which Sharkey showed to advantage. Jim kept trying to push his left into Tom's nose and the sailor would come right back at a swing on the body. He was inclined to be a trifle wild, and was frequently cautioned by O'Rourke, his chief seconds. Tom put up a straight right on Jim's nose which seemed to bring the blood to that member. Sharkey put in a right hand smash on the jaw which sent Corbett down. He attempted to resist the dose, but was felled as Jim clinched.

Round iii. Corbett landed with his right for the body, Jim reached the body several times, but Tom came right back with lefts for the head. A right on the body staggered Jim. Sharkey whipped over a tremendous right hand smash on the jaw. The sailor's leads were ineffective, his counters being jabbed lightly for the head, and Sharkey came right back at him with right smashes on the wind.

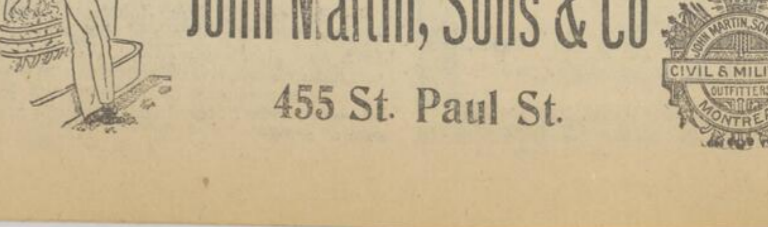

ROYAL ELECTRIC IS STRONGER.

There was quite a little activity to the stock market this morning, and there were one or two features of more or less interest.

One of these was the fact that Royal Electric was sold down by Hanson & Ferguson, one sale being made as low as 151. Afterwards, however, it recovered to 153. In the aggregate, though, only a few shares changed hands.

Gas was conspicuous again, as were, in fact, all the Light securities, Heat and Light bonds coming in for another advance. Gas, as stated some days ago, is being steadily absorbed by L. J. Forget & Co., who have taken something like 7,000 shares in the past ten days.

Brokers had it on pretty good authority that the rate war was settled, and any doubts were dispelled by one o'clock, when both the railroads came out with an official announcement that hatches were buried by both sides. The news created a firmer feeling in Pacific both here and in London, but there were evidences that the news had been pretty

beforehand. Over 1,800 shares of Pacific changed hands, and fully 1,000 shares of Gas. Heat and Light bonds on business involving \$1,100 sold as high as 99 1/2, and \$2,000 Colored Cotton bonds went at 100. It is noticed in connection with the trading in Pacific that Berlin interests continue to sell heavily, and the fact that the loan holding's of the stock are increasing more and more every day suggests to brokers that the directors of the company might give more earnest consideration to the matter of having the books brought to Montreal.

Roseland, B.C. Nov. 23.—An effort is apparently being made to bear Deer Park stock. It has been originated by interested parties. The mine never was in better shape. There is no reason for any decline in the price of the stock. The contract for the resumption of work on Silver Bell has been let, and sinking will begin forthwith. There is considerable enquiry for stock in the new company. Including Silver Bell there are now seven properties working in the South Belt. A revival in that section of the camp is anticipated in consequence.

The market for barley was quiet and prices show no change. We quote: No. 1, \$2.00 to \$2.10; No. 2, extra, \$1.75 to \$1.85; No. 2, clover mixture, \$1.50 to \$1.60; and clover, \$1.40 to \$1.50.

FRUIT AT AUCTION.

But It Was Mostly Damaged Stuff and the Prices Were Lower Than Usual.

The sale of any class of merchandise that is damaged by fire or water always attracts a good business in Montreal. This was the case yesterday at the Montreal Fruit Auction Company's warehouse yesterday, 55 barrels of apples in fire-damaged boxes, brought \$2.5 to \$3.05, a great price, bringing \$2.65 to \$2.75. The lemons, of which there were 16 boxes, brought \$1.75 to \$1.80. The underwritten lots were not lost much by the fruit trade. The lots were admirably arranged, the sale well managed, and the bidding as brisk as possible. The result of this sale shows that apples are a good risk as far as the Montreal Fruit Auction Company is concerned. Foster & Morin conducted the auction.

WHEAT EXPORTS HEAVY

And Will Increase Unless Russian Shipments Become a Good Deal Larger.

Counselman & Day wire from Chicago that primary receipts of wheat promise to continue large for thirty days. Exports are heavy and will increase unless Russian shipments are large. Argentine wheat may come later but the United States is practically without competition in supplying the Continent. Requirements. The visible supply of wheat is 22,000,000 smaller than last year and 35 million less than the previous year. The European visible is 11 million smaller than the year ago. Corn placed a little from the government report, but no one at all posted the corn crop places the old reliance on it. The oat crop is small, there are no large reserves and the cash demand is large. It advises customers to buy provisions freely, especially if corn continues strong.

THE CROPS.

Nothing Has Interfered With the Movement—Winter Wheat Holds Its Own.

Prime, in the Daily Stockholder, says so far in November nothing has interfered with moving of crops, and last week was the best for many years. We quote: Strictly new crop, except those of the Government, have been all one way. A very poor crop in quantity and quality. Winter wheat crop is holding its own. There is no more disposition among farmers to market their surplus. They can keep wheat in their bins as a safe investment and a good speculation.

"Tuckahoe House," the historic housestead of Virginia's famous Randolphs, has been purchased by J. R. Coolidge, of Boston.

Cannot Confirm Report.

London, Nov. 23.—(Special.)—The Daily Mail's Montreal correspondent cable reports that the Canadian Steamship Company has arranged for connection with the Great Western Railway, starting a fast Atlantic line, running to Milford Haven, beginning with the Pasphebian in December. The company is not known here, and he says well informed regarding the affairs of the Great Western Railway profess ignorance of any such arrangement, though the company is undoubtedly interested in Milford Haven.

Toronto's Trial.

Toronto, Ont., Nov. 23.—(Special.)—A preliminary trial of the steamer Toronto, which the Bertram Company is building for the Richelieu & Ontario Navigation Company, was made yesterday. The vessel made a three-hour trip out into the lake, and her conduct in a rather heavy sea was very satisfactory to both builders and buyers. On Saturday next the regular trial trip will be made, when a number of R. & O. directors will be present.

Car Cleaner Killed.

Toronto, Ont., Nov. 23.—(Special.)—Jas. Bonar, a G.T.R. car cleaner, was struck by a train in the G.T.R. yard west of the Union Station yesterday afternoon and instantly killed.

Grand Forks is Booming.

Roseland, B.C. Nov. 23.—(Special.)—The Bank of Montreal and the Merchants' Bank of Halifax have opened branches in Grand Forks. This gives the Boundary Creek district five banks. Rosseland now has five banks, the same as Victoria, and the only city in the province having more banks is Vancouver, which has seven.

ARE SLIGHTLY PESSIMISTIC.

The Canadian Commissioners Are Meeting With Opposition to a Couple of Their Demands—The Navigation Laws.

Toronto, November 23.—(Special.)—A Globe special from Washington says:—The Canadian Commissioners are somewhat pessimistic as regards the outcome of the discussion on two important discussions still open—free labor and free fish. Were the lumber difficulty adjusted as is believed that the reciprocity schedule could be speedily put in shape, but up to this time lumber stands in the way of progress. One of our commissioners said yesterday that with the best intentions in the world the commissioners might yet fail to agree. In all reciprocity negotiations heretofore, free fish and free lumber have been regarded as essentials from the standpoint of Canada. Indications pointed to a failure to secure free fish, although they had not altogether given up hope. If ever the Americans meant to do business at all, it would be necessary to include either fish or lumber in the reciprocity schedule. Until a definite answer could be had from the American commissioners on these points no assurance could be given as to whether the negotiations as a whole would be successful or not. Were the President clear of the Philippine negotiations, it is believed he could speedily bring things to a head.

The Open and Closed Doors. There was much discussion to-day of the momentous announcement from Paris that the United States will maintain "the open door" in the Philippines, and that, for a few quiet talks at the White House or in Mr. Dingley's apartments at the Hamilton, which will settle the matter one way or the other.

St. Gabriel's Bazaar. Although this evening will witness the close of the bazaar in St. Gabriel's parish, the attendance last evening was even larger than any since the bazaar has opened, and one could tell by the look on the zealous and hardworking pastor of the parish that he was well pleased. One of the prettiest booths in the hall, and which we failed to mention in our last account, is the Flower Booth. The whole West-Indian trade situation is becoming so complicated that special negotiations between Canada and the United States may be necessary to straighten out the tangles.

Cost of Lighting.

A 16-candle power electric lamp costs one-half cent per hour when in use. A gas jet costs very little less. An ordinary office desk lamp will keep ten of such lights burning all day, say for seven hours during daylight. There are very few offices, either in the city or in the suburbs, that do not require artificial lighting during the day. Assuming the above as a fair basis in an average office, we will surmise lamp hours, at a cost of thirty-five cents per day, making for the year, an expense of over one hundred dollars for artificial lighting, which, with a proper installation of Luxifer prisms, would be saved.
