MONTREAL SOUTH

A Town on the south shore of the River St. Lawrence adjoining Longueuil and one mile from St. Lambert Station, County of Chambly.

The Montreal & Southern Counties Electric Railway (now operated by the Canadian National Railways) gives the residents a 20-minute service with Montreal via Victoria Bridge, and buses, operated by the Montreal Tramways Co connect with Montreal via the Harbour Bridge.

The Jacques Cartier Bridge over the St. Lawrence river ends in the centre of the town.

There are three churches, Catholic, United and Anglican, a Town Hall and three schools, including the English High School of Montreal South and Longueuil. Population about 1,200.

This beautiful suburb, in the County of Jacques Cartier, is easy of access and is in great favor for residential building. Trains connect with the city at almost all hours both by the Canadian Pacific and Canadian National Railways, while the Upper Lachine and Sherbrooke Boulevard roads afford delightful drives. The Montreal Tramways Co cuts through the lower part of the town affording a 20-minute service with the city, and enters the Town by the Sherbrooke Boulevard with a 6 minute service.

There is also a frequent motor bus service between Montreal West and Lachine, operated by the Montreal Tramways Company. Public and high schools and a post office with postal delivery twice a day. Population about 3,300.

OUTREMONT

(Incorporated in 1875.)

A City situated near the west end of Mt. Royal Park, forming part of the parish of Montreal, county of Hochelaga. It is bounded on the east by Laurier and St. Michael wards, on the north by St. John ward and Town of Mount Royal, on the west by Mount Royal ward. Two electric car service routes are provided by the Montreal Tramways Co. (Laurier av., St. Catherine rd. and Bellingham rd. for southern section; Bernard av., Outremont av. and Van

Horne av. for northern section). A two and a half and five minute service is provided on each route, also autobus service on Bernard av. and Boulevard Mount Royal (its whole length) to Montreal Tramways terminus.

Queen Mary road leads right into the township.

Hampstead is a beautifully laid out garden Township, and has very rigid building restrictions. Population about 1,600.

TOWN OF MOUNT ROYAL THE MODEL CITY

Eight minutes from the heart of Montreal via the electrically-operated Tunnel of the Canadian National Railway, lying on the northwest slope of Mount Royal and adjoining the cities of Montreal and Outremont.

The Town is conveniently reached by automobile from Outremont by following St. Catherine road to Rockland avenue, crossing the Canadian Pacific Railway tracks. The Town of Mount Royal's territory commences at this point. To the westward it can be reached by Core des Neiges rd which is the continuation of Guy street.

Montreal Tramway buses (corner Queen Mary rd. and Cote des Neiges) cross the Town of Mount Royal to Park av. and Jean Talon with a ten-minute service.

Education—For Protestant and Catholic School purposes the territory of the Town of Mount Royal has been created into a separate school district. The School Commissioners have built a fire-proof two-story and basement school, built of brick and re-inforced concrete where elementary and high school grades are taught. A new modern school has been built to accommodate the first four grades. The classes are conducted by teachers of high scholastic degree. The Catholic education is taken care of by a new Catholic school, modern in every detail. Population about 3,600.

VERDUN

The City of Verdun is ideally located at the south-western limits of Montreal on the banks of the St. Lawrence River, which is about 8 miles wide at this point. The municipality was incorporated as a village under the name of Riviere St. Pierre in 1874,

changed to the Village of Verdun in 1876, erected into a Town in 1907 and a City in 1912. Since 1901 its population has increased from 1838 to about 64,000. Possessing very few industries it is almost entirely composed of homes and stores. Its famous boardwalk is now being replaced by a modern asphalt promenade, brilliantly lighted, along the entire three-mile river front and banked with attractive lawns and shrubbery. Municipal tennis courts, a bowling green and a dance pavilion are also situated here, while further progress is evidenced in the present construction of a municipal auditorium and hockey arena, and two large open air swimming pools, also on the River front.

Under the Town Planning and Zoning Commission a determined effort is being made to encourage the building of homes under the National Housing Act, the City offering suitable lots for sale at very low prices.

Educational facilities are excellent, with thirteen Catholic and eight Protestant schools. There are two hospitals and eighteen churches. Services such as public health, police, water and electricity are of the best. Through its Municipal Playgrounds Commission the City is giving special attention to providing playgrounds for children, and new areas are continually being designated for this purpose.

The form of civil government consists of a mayor and eight aldermen elected every two years. Four aldermen are elected by proprietors only, and the Mayor and four aldermen by all rate payers. The City Manager System has been in force since 1918. The Mayor and four aldermen constitute an Executive Committee. Population, 62,944.

WESTMOUNT

The City of Westmount is beautifully situated on the western slope of Mount Royal, and from the upper level a magnificent view of the St. Lawrence River, Lake St. Louis and surrounding country is obtained. The city is almost exclusively residential and may be designated a "city of homes." Available properties for building sites are rapidly being occupied. The city is governed by a Mayor and five aldermen, elected for a term of two years by the city at large. The city manager form of government has been in vogue for 26 years, and the civic progress is evidence of the wisdom of the adoption of this system of government.

The city owns and operates in a very efficient manner an electric light and power station and a garbage destructor plant.

Park and playground spaces owned by the city cover an area of about 77 acres. Twelve greenhouses are maintained. A flower clock has proved to be a novel attraction.

Thirty municipal tennis courts are in great demand during the summer months and every facility is given for the enjoyment of this sport.

With the purchase of the M.A.A.A. Grounds on St. Catherine Street the playing field activities were much increased. These grounds have an area of 7.8 acres and contain a quarter-mile running track, a field for football, cricket and other sports, sixteen tennis courts, two bowling greens, grand stand and club house.

The city owns a free public library. During the year 188,426 volumes were circulated for home use.

The Victoria Hall as a community centre is continually in use for church, charitable, educational, municipal, political and social activities.

Public education is provided by the school commissioners of Westmount and the City of Verdun, of St. Leon de Westmount. In addition there are a number of private schools.

The city is supplied with filtered water and a per cent efficiency is required. The water is rigorously tested to assure that a maximum of purity is maintained. Population about 26,000.

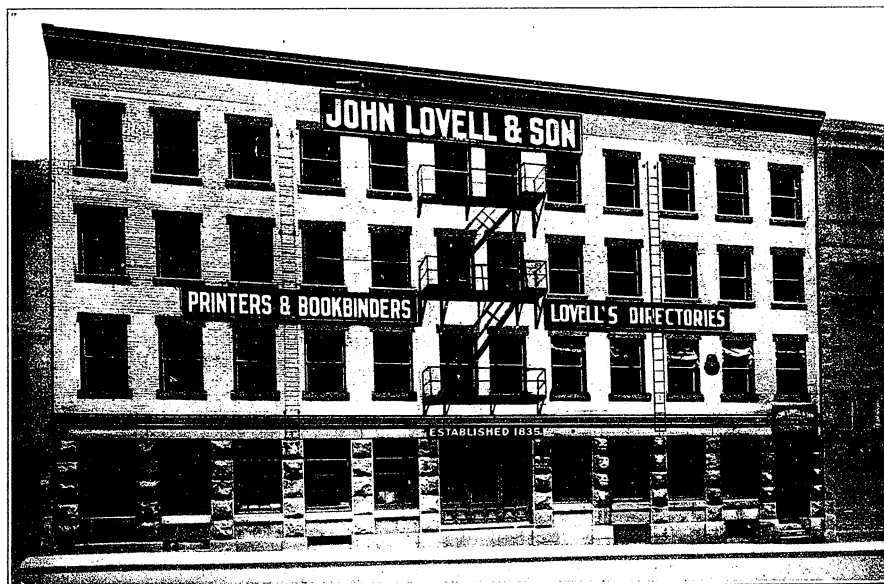
