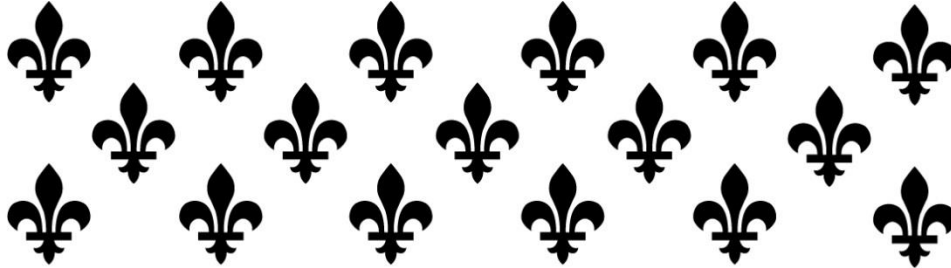

Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

At the request of the President, Mr. Legault, Premier, withdrew certain words deemed unparliamentary.

Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Ms. Zaga Mendez (Verdun), together with Mr. Fortin (Pontiac), Mr. Bérubé (Matane-Matapédia) and Ms. Nichols (Vaudreuil), moved:

THAT the National Assembly recall that last summer, forest fires burned over 4.5 million hectares in Québec, forcing the evacuation of around 27,000 people;

THAT it recognize the Government's efforts to increase the SOPFEU's resources to prepare for the next forest fire season;

THAT it underline that this situation is exacerbated by climate change;

THAT it recall that there are solutions for managing our forests to make them more resilient and better adapted to withstand forest fires;

THAT, lastly, the National Assembly ask the Government to take the necessary actions to increase forest resilience, with the quick tabling of a strategy for adapting forest management to climate change.

THAT it invite Quebecers to express their pride and their sense of belonging to the Québec nation by participating in the hundreds of activities that will take place in all regions of Québec.

THAT, lastly, it thank the recipients for their remarkable achievements and actions to put an end to prejudice, discrimination and racism in our society.
