### World News In Brief

Paris, Sept. 28.—(AP)—British, United States and French foreign ministers have approved the terms of their note to the United Nations on the Berlin crisis and the text will be handed to secretary-general Trygve Lie tomorrow, an official British source said today. He said the text will be made public tomorrow.

Paris, Sept. 28.—(AP)—Defence chiefs of the five western alliance countries continued today their top secret talks on speeding their joint programs.

After two sessions yesterday, the defence ministers and their chiefs-of-staff met again with Canadian and American military observers attached to the permanent military commission set up by the Brussels pact.

Vancouver, Sept. 28.—(AP)—A more positive program for stricter Lord's Day observance will come up for debate today by the United Church's 13th General Council. Action will be taken to prevent "Sunday becoming simply another day for most people."

Sydney, Australia, Sept. 28.—(Reuters)—An unconfirmed report said today that at least seven people were killed when an R.A.A.F. plane, believed to be a Catalina flying boat, crashed at Lord Howe Island, in the South Pacific.

Budapest, Sept. 28.—(Reuters)—The Hungarian government today published a "grey book" giving details of alleged large-scale sabotage of Hungarian oil production by United States oil companies.

Production was said to have been deliberately decreased from 800,000 tons under the German occupation to 500,000 tons today.

Washington, Sept. 28.—(AP)—The World Monetary Fund said today many of its 47 member countries must cut government spending and keep taxes high.

World recovery plans may be ruined unless these and other budget-balancing steps are taken by inflation-plagued countries in Europe, Latin America and Asia, the fund declared in its third annual report.

### Foreign Minister Schuman Says Russians Failed To Show Minimum Of Goodwill

Paris, Sept. 28.—(AP)—France appealed to the United Nations today to end the Soviet blockade of Berlin because the three western powers have "exhausted every possibility of direct agreement" with the Russians.

Foreign Minister Robert Schuman, in a policy speech to the General Assembly, said Britain, the United States and France had not found even "a minimum of goodwill" in their talks with "our Russian partners."

Schuman spoke as the three western powers prepared their appeals to the Security Council, formally citing the blockade as a threat to international peace and security.

State Secretary Marshall and Foreign Secretary Bevin conferred during the morning on the strategy the western ministers will follow in the Security Council. Officials said the talk also concerned the British-American position and strategy in Germany after the Berlin question is referred to the Council.

### Soviet Mark Is Dropping In Value

Berliners Are Losing Faith in Russian-Issued Currency.

Berlin, Sept. 28.—(AP)—Berliners have lost some of their faith in the Russian-issued currency in their city following the break-up of the four-power talks on the Berlin blockade.

The "ostmark" issued by the Soviet authorities is steadily dropping in value, although at no time was it considered equal to the "deutsche mark" on a one-for-one basis.

Berliners are losing faith in the Russian-issued currency in their city following the break-up of the four-power talks on the Berlin blockade.

The "ostmark" issued by the Soviet authorities is steadily dropping in value, although at no time was it considered equal to the "deutsche mark" on a one-for-one basis.

While there still seemed hope the four occupying powers were getting somewhere in their conversations about lifting the Soviet-imposed blockade of Berlin, the ostmark was being traded at the rate of between two and three for one west mark.

As of last night, the ostmark was quoted at 3.9 to one deutsche mark. This is almost the lowest point the Soviet mark has reached since midsummer, a short time after the dual east-west currency reform.

Communists have a healthy respect for the west mark. They demonstrated that soon after the currency reform by trying to collar as many as they could.

At the same time, British and American sources said, experts of the three western powers continued drafting the note to be sent to the U. N. secretary-general, Trygve Lie, either late today or tomorrow. A French source said the powers would deliver identical notes to Lie early this afternoon, but this was believed earlier than most sources expected.

A Russian source at U.N. headquarters, meanwhile, hinted a Soviet surprise when the big four dispute is argued in the Security Council.

This usually-reliable informant said the Russians will be present in the Council chamber when Berlin is discussed and "you will see what happens then."

Schuman, who spoke as the U.N. faced the severest test of its turbulent history, championed the return of a democratic Germany to the family of nations.

"A renewed Germany must take her place in democratic Europe," he said. "Deprived of self-government, she must first achieve her own internal re-education and then take her place, with her own special qualities, among the European nations."

Schuman was the last big-fixer leader to make a general policy declaration to the Assembly. State Secretary Marshall listened attentively to the French, but both Foreign Secretary Bevin and Andrei Y. Vishinsky were absent.

In Berlin, Schuman said, "we are faced with a situation as regards currency, transport and municipal administration, which has constantly been getting worse. In spite of the division into four zones, there ought to be a four-power control and administration."

"But the Assembly will readily understand that living together in such a way requires a minimum of goodwill."

"This we have not found on the part of our Russian partners and as we do not intend to allow ourselves to be deprived of our rights or to abandon the population entrusted to our care, we now, after two months during which we exhausted every possibility of direct agreement, appeal to the United Nations to settle the dispute and put an end to the act of force represented by the blockade imposed and maintained by Soviet authorities."

Meanwhile, Sir Alexander Cadogan of Britain, September president of the Security Council, said the Council will begin the Berlin debate some time this week. He told reporters the exact date still was undecided, but might be Thursday if it could be arranged.

Sir Alexander said he believed the Russians would use every possible means, including the veto, to keep the Council from taking a decision on the Berlin question.

In the U.N.'s main arena, Prime Minister Mackenzie King, in what may be his last major speech as head of the Canadian Government, joined with other leaders in a series of general opening statements.

The notes were drafted yesterday by special deputies on instructions from their respective foreign ministers. The ministers decided Sunday to break off indirect negotiations with the Russians over the three-month-old crisis in Berlin.

The notes carry the label "urgent," which means the three western powers want the Security Council to consider their complaint on an emergency basis. #### Spy Probers In U.S. Seek Scientist

Unidentified Man Is Linked With U.S. Communist Organizer.

Washington, Sept. 28.—(AP)—United States spy probers pressed their hunt today for four persons they accused of tampering with atomic secrets.

The House of Representatives un-American activities committee linked the unidentified scientist with Steve Nelson, who the committee said should be tried as an outright wartime spy. Nelson is a Communist party organizer in Pennsylvania.

The house group's preliminary report last night also declared that Dr. Clarence F. Hisey, his former wife, Marcia San Hisey, and Dr. John J. Chapin should be prosecuted on charges of conspiring to hand over atomic secrets to Soviet agents. Hisey and Chapin worked on the atomic bomb project during the war.

Chapin, whom the committee described as a "very co-operative" witness, declined comment in New York. Hisey and his ex-wife could not be reached.

The committee said its first report on a month-long inquiry tells "only a small part" of the whole story of atomic spy activities. Chairman J. Parnell Thomas (Rep., N.J.) announced that locked-door hearings will continue indefinitely.

The committee report referred to the "vigorous and expeditious manner" in which the spy ring in Canada was broken up in 1946. It forecast that similar prosecutions would take place in the United States.

Any further delay in proceeding with prosecutions of the members of these espionage groups, the report asserted, "could result in tragic consequences to the United States and to the world."

Attorney-General Tom Clark, who has denied previous committee charges that his staff has been lax in prosecuting spy cases, is travelling as President Truman's campaign train.

The President has called the committee's investigation a "red herring" designed to divert attention from other national issues.

#### Warsaw Fire Toll Is 20

Warsaw, Sept. 28.—(Reuters)—Twenty persons were burned to death and 20 severely injured when fire broke out at a dance organized by a voluntary firemen's organization, at nearby Osuchow last night.

Police made several arrests on charges of negligence. Barred windows prevented firemen and their guests from jumping to safety from the first floor of the building. The fire started in hay stacked in a grain store on the ground floor.

### Athletics Score 10-9 Win Over St. Hyacinthe After Tense See-Saw Encounter

Climaxing one of the most successful seasons in local baseball circles, the Sherbrooke Athletic Baseball Club last night edged out St. Hyacinthe 10-9 at the local ball park before a record crowd of 5,147 fans to win the Provincial Independent Baseball League championship.

In a game which was a real test of champions from the opening frame until the ninth inning, and with the championship riding on every pitch, the jammed-packed stadium of supporters were kept on edge more times during the tilt than during the whole season. Besides seeing two good ball clubs battling for the loop crown the fans were treated to a fight as well.

In the second frame when Umpire Ripley called Lauro Pascual safe at third on a close decision, Ed Weisler, came charging out of the Saints' dugout, and started to protest vigorously to Ripley. He was given the thumb, and then turned around and swung at the umpire.

Before long all the players, and a few over-excited fans, were on the field swinging and pushing one another around. It was hard to tell what happened in the melee but Claro Duany came up with a bruised nose, but he was none the worse for wear and continued in the game. Connie Creedon had been given the boot for being one of the main attackers, but after a meeting between the managers and umpires it was decided to let him in the game. St. Hyacinthe threatened to leave the field but Manager Paul Martin persuaded his players to stay and finish the game.

Adrian Zabala, who won Sunday's game to eliminate the series at 4-4, went to the rescue of Ralph McCabe in the second inning after the Saints drove two runs across the plate for an early lead, and for seven and two-thirds innings Zabala hurled his heart out to give the locals a lead in the tilt until the ninth.

Zabala was the hero of the game as he banged out four hits in four official trips to the plate, drove in one run and tallied once himself before he gave way to Paul Calvert in the ninth. Calvert stepped into the breach after the Saints had tied the game at 9-9 and retired the side.

Sherbrooke in the second inning got to Fred Martin, the Saints' chunky right-hander, for four hits and pushed three runs across the plate. In the third they added one more after Gladu and Duany had struck out as Coimbre singled and Tony Ross came through with a timely triple to score Coimbre and put the locals out in front 4-3.

In the fourth Zabala held the

Saints to one hit, a triple by Valois, with two away, but he forced Fred Martin out at first. In the fifth they went down 1-2-3 and in the sixth when Paul Martin singled Mike Rollins drove him home when he connected for a double.

In the sixth the locals pushed further out in front when they tallied three times as Duany doubled to start matters, was sacrificed to second by Coimbre, and a double home when Ross connected for a single.

Taillefer went out at first, Pascual walked and Zabala banged out his third single of the evening to score Ross. Gilles Dube connected for another single and Pascual came home to put the A's out in front 7-4.

In the eighth the Saints started as Creedon and Pite tallied. Nance singled and Fred Taillefer committed the only Sherbrooke error to permit P. Martin to reach first safely and Nance to pull up at third. Rollins walked to load the sacks, and when Clovisky fled out to left field one run came in. Valois doubled to push two more tallies home and tied up the ball game.

In the lower half of the frame the locals went out in front once again when they tallied two runs on three safeties. Zabala singled to start the uprising, and Dube and Torres followed suit. Zabala reached home on a passed ball, and Dube came home right after him when Coimbre hit a long fly to centre field. Gladu had gone out at first and Duany was given an intentional walk. Tony Ross was thrown out at first by Fred Martin to end the rally.

### Mr. Justice C. D. White Will Retire From Bench

After serving almost twenty-seven years as a judge of the Superior Court of the District of St. Francis, Mr. Justice Charles D. White has tendered his resignation to the Minister of Justice, Judge White, who underwent a serious operation a few months ago, took this action on the advice of his physician.

The member of a pioneer Sherbrooke family, Judge White was born here September 6, 1871, the son of Hon. William White, for many years a judge of the Superior Court for this district, and his wife, Mary V. Dickinson.

He received his education at the old Sherbrooke Academy, Bishop's College School, Lennoxville, and McGill University, Montreal, where he received the degree of B.C.L. in 1896. Returning to Sherbrooke, he started the practise of law and was named a King's Counsel in 1912.

In 1911 he contested Sherbrooke County in the interests of the Conservative party but was defeated by a narrow margin. He served on the City Council as an alderman for

three years and was also mayor for a term.

In 1921 he was named a judge of the Superior Court for this district. In 1946, he was the guest of honor at a dinner tendered by the Bar of the District of St. Francis to mark a quarter century of service as a judge and the fiftieth anniversary of his admittance to the Bar.

He married Elizabeth Owen Woods of Quebec City in 1903. He has one son, Charles A. White, practising law in Sherbrooke, a daughter, Mary, Mrs. Graeme Tay-

lor, and a daughter, Mrs. Graeme Taylor.

### High Commissioners May Be Given Precedence Promotion

London, Sept. 28.—(AP)—A brisk promotion in the table of precedence for the High Commissioners who represent the Dominions in the United Kingdom may result from the Commonwealth Prime Ministers' meeting here in October.

When Princess Elizabeth was married in Westminster Abbey last year, Prime Minister Mackenzie King at the ceremony sat next to Prime Minister Attlee, given a place on honor higher than any other United Kingdom minister. This was recognition of the status of the senior Dominion.

But while the high status of self-governing Dominions is recognized at such ceremonies when heads of government or their deputies are present, the representatives of the Dominions are in a different position.

In the table of precedence recognized at official functions, the High Commissioners are far down. Ambassadors for foreign countries, no matter how small, are fifth in order of precedence, preceded only by the King, Duke of Gloucester, Duke of Windsor and the King's nephews.

The Ambassadors precede the Archbishop of Canterbury, the Lord High Chancellor, the Archbishop of York and seven the Prime Minister of the United Kingdom.

But the High Commissioners from the Dominions, who serve the same function in London as do Ambassadors, are placed in 39th position, far below the sons of dukes and earls, bishops, ministers and envoys. They are sandwiched between secretaries of state under the degree of baron, and viceroys' eldest sons.

Constitutional authorities said they could see no insuperable difficulty in giving Dominions' representatives in London the status, and even the title of Ambassador, although it would mean that King accredited Ambassadors from the Dominions to himself.

Apart from precedence, the High Commissioners have the facilities available to Ambassadors and their contacts with British government officials, as befits the unique Commonwealth relationship, is on a frank, free basis. They have frequent meetings with ministers and are kept completely informed of government policy and programs that concern them.

But with recognition of the complete independence of the Dominions, who now have their own Ambassadors in many countries, the feeling is that their representatives should be accorded a higher status in the table of precedence. If the Prime Ministers make such a request in October, few in London doubt it will be promptly approved by the United Kingdom.

### P.C. Leadership Contenders To Arrive In Ottawa Today

Ottawa, Sept. 28.—(AP)—Contenders for the leadership of the Progressive Conservative party are due here today to mingle with the advance guard of delegates to the party's national convention Sept. 30, Oct. 1-2.

Premier Drew of Ontario and John Diefenbaker, member of the Commons for Lake Centre in Saskatchewan, are due to arrive by plane. Garfield Case, member of the Commons for Grey North in Ontario, is expected by train. Donald Fleming, member of the Commons for Toronto Eglinton, already is in Ottawa.

Mr. Drew, 54-year-old Toronto lawyer, author and soldier, announced Sept. 29 that he would be a candidate for the leadership which John Bracken is relinquishing. Mr. Bracken, 65, announced July 19 that he planned to retire because of his age and ill-health.

Mr. Diefenbaker, 53-year-old Saskatchewan criminal lawyer and one of the Government's sharpest critics in the Commons, announced Sept. 17 that he would again be a leadership candidate. He placed third at the 1942 convention which chose Mr. Bracken.

Mr. Fleming, a 43-year-old Toronto lawyer who only entered the Commons in 1945, announced last week that he would be a candidate. One of the party's few bilingual members, he is counting on heavy support from Quebec.

Mr. Case, 49-year-old former

mayor of Owen Sound, Ont., was a comparative unknown in the political field until 1945 when he defeated Gen. A. G. L. McNaughton, then Defence Minister, in a North by-election. The by-election was fought on the Government's policy with respect to re-inforcements for troops overseas and drew international attention.

Early arrivals include delegates from all parts of Canada. Their support of the leadership candidates now in the field was split. None expected that others will decide to enter the race, even if nominated.

Some of the delegates said Mr. Drew will win in a "walk away." Others were equally confident of Mr. Diefenbaker's chances. Most were inclined to describe Mr. Fleming as a dark horse, whose support could not be judged in advance. A few believed that Mr. Case will withdraw before the actual balloting Oct. 2.

A candidate must obtain a clear majority over all others before being declared elected.

Arrival of the leadership candidates will coincide with the inaugural sessions of a 100-man resolutions committee which will plough through the 500 or more resolutions submitted as potential planks in the party's platform.

The committee, under the chairmanship of Fred Gardiner of Toronto, will meet in camera today and tomorrow and will report to Mr. Case, 49-year-old former

## Eastern Townships Historical Society Hears T. L. Quimby

A meeting of the Eastern Townships Historical Society was held last evening in the St. Charles College with Rev. Canon J. N. Codere presiding. A short business meeting took place, during which the minutes of the last meeting were read by Rev. Father Maurice O'Brady. A short discussion followed on future plans of the society.

Rev. Canon Codere then introduced the guest speaker of the evening, T. L. Quimby, of the Stanstead Historical Society, who, as Rev. Canon Codere said, is the soul of that society. Mr. Quimby's subject was "Highlights of Stanstead County." He explained that gathering information on pioneer days is his hobby.

The history of the Eastern Townships dates back to 1792, when the government became anxious to promote colonization. This was made attractive through grants of land to settlers. Several New Englanders took advantage of this opportunity to settle in the Townships. One of the first places to be settled was Hatley.

Mr. Quimby mentioned the names of Capt. Ebenezer Hovey, the Ives family and the Rexford family as being some of the first to settle here. These men came to explore the country in 1794, and after spending a short time, living in cabins along Lake Massawippi, they returned for their families. This settlement grew until there were 47 associates banded together to constitute the county of Stanstead. They obtained land grants of 23,000 acres.

Mr. Quimby stated that much credit is due Colonel Call, who was able and willing to give the necessary financial help to develop that section. In 1821, the population of Stanstead County had mounted to 1,600 residents, in comparison with 100 to 600 in surrounding townships.

With a touch of humor, Mr. Quimby remarked that, at that time, Stanstead County was even larger than Sherbrooke.

Settlers suffered great hardships and privations. Miles of unbroken forests made travel difficult but not impossible. In the early days, blazed trails were used. Later makeshift roads took their place. At one time, Mr. Quimby cited, his great-grandfather had remembered several oxen teams on their way to Montreal. To us, this seems an impossible feat, but to them it was their sole means of reaching other places.

Game and fish were their principal food. They became fur dealers, and through this, monetary difficulties were surmounted. Illness was probably the most dreaded hazard, and Mr. Quimby explained that doctors and nurses were a premium. Nurses, who were usual—

### EVERY PROPERTY OWNER SHOULD VOTE

One of the basic principles of municipal government in Canada is that the elected representatives of the people can involve the municipality in no major capital expenditure without the approval of the property-owners accorded by means of a referendum. Tomorrow, Sherbrooke ratepayers are being called upon to express their approval or disapproval of three by-laws involving a total estimated expenditure of \$1,700,000. In detail the by-laws call for spending some \$700,000 on a water filtration plant, \$200,000 for the construction of a central autobus terminal and \$800,000 for the erection of a new bridge linking the East and West wards.

In an effort to increase the public interest in this referendum, Mayor Alphonse Trudeau has addressed a personal letter to each voter explaining the views of the City Council on the three loan proposals and carefully listing where the ratepayer can cast his ballot. Thus His Worship leaves no reasonable act undone to assure that the citizens show greater concern in loan by-laws than they have in the past, when it has often been difficult to get the ten per cent poll required by law. Regardless of whether they approve or oppose the individual by-laws, it is to be hoped that few property-owners will ignore the call of Mayor Trudeau to express their views on the issues.

Of the three projects being submitted to the ratepayers, only one, the filtration by-law, appears to have any degree of urgency. Action must be taken without delay to improve the local water supply which is far from satisfactory, especially in the warm weather. Filtration seems the only economical solution. To bring the water supply from one of the surrounding lakes would involve the expenditure of three to four times the amount involved in a filtration plant and even then the results would be doubtful and the city might find itself still faced with the need of a filtration system. This particular by-law deserves general support from all groups in the City and it is to be hoped it will be given an overwhelming majority.

The proposed new bridge might ultimately prove a distinct asset to the City but its erection is less urgent than the filtration plant. Even the sponsors of the project admit that difficulties in obtaining labor and material may force an indefinite postponement in carrying it out. In view of this situation, it would have been more logical for the City Fathers to withdraw the plan for the time being and submit a fresh by-law when they are prepared to proceed with the scheme, the new law to be based on revised price estimates and other changed conditions at the time it is to be undertaken.

Even more difficult to justify is the proposed municipally-owned autobus terminal. In effect the City is proposing to involve itself in considerable capital outlay to provide operating facilities for a group of private concerns and is planning to enter into a line of business which is foreign to its set-up. In other towns and cities, the terminals are provided by the autobus operators or by a private terminus company and the same situation should prevail here.

However, the main thing for the property-owners tomorrow is to vote, regardless of which by-laws they favor and which they oppose. The man or woman who fails to exercise his rights cannot with justice criticize the Council for any action they might take on these projects.

### SAFETY IN THE WOODS

The beginning of October marks the opening of the hunting season in many parts of the Province of Quebec, a season which unfortunately is marked by too heavy a toll among the hunters than among the hunted. One of the tragic features of the hunting season deaths is the fact that the great majority, if not all, of them could be avoided by the display of a reasonable amount of caution by hunters or would-be hunters.

The first excuse, of course, is the well-worn claim that "I did not know it was loaded." Despite constant preaching by exper-

enced woodsmen and safety organizations that gun-toters should regard every gun as loaded, the "unloaded gun" continues to take a heavy toll each year.

Then there are the trigger happy hunters who believe that everything that moves in the woods is either a deer, a bear or some other game animal. They adopt this attitude despite the fact they know their companions are operating in the same district. By following the principle of being better safe than sorry, hunters could avoid many tragedies of this nature.

Aside from these two major causes, there are several minor reasons for woodland tragedies. Perhaps the hunter fails to carry his gun in the proper manner, thus endangering his fellows if he happens to fall or the trigger becomes caught in a tree. Improperly cleaned guns also take their toll.

An expert woodsman could give a lengthy list of do's and don'ts to the amateur hunter, but in almost every case, they can be summed up in the simple call to apply commonsense and reasonable care to the trips.

Remember, it is better to lose a deer than shoot a human.

### SENATOR T. D. BOUCHARD

The illness which forces Senator T. D. Bouchard to retire from an active role in the Canadian political scene administers a severe blow to those Canadians who genuinely are seeking to improve the relationships between the two great races who populate this country.

A dynamic figure, to say the least, and a man who was prone to express his views with considerable force, Senator Bouchard has been in the vanguard of the fight against extreme nationalism over a period of fifty years. The very nature of the man was such that it became inevitable that he make serious enemies in the camp of those whose views differed from his own. On several occasions this tendency to plain speaking involved him in difficulties with the powers that happened to be in control of the government at the particular moment when he unloosed one of his particularly devastating attacks and on more than one occasion he found himself at odds with the leaders of his own party over his determined views.

Even if blindness forces him to curtail his editorial activities, it is doubtful if he will be removed completely from the fight for improved inter-racial feeling. His physical infirmities may somewhat hamper his actions and to a degree slow him down but to a man of Senator Bouchard's nature, complete inactivity is impossible until the last breath has been taken from his body.

#### "SMILING MAN" DOES GOOD JOB SMOOTHING WAY FOR PRESIDENT

President Truman's current political junkies around the country are now pretty efficient operations as far as arrangements and management go. They are in sharp contrast to the one he made out West last June which featured an address to an almost empty auditorium in Omaha, Neb. The man mostly responsible for the difference is Oscar Chapman, undersecretary of interior and called the "smiling man" in Washington.

When the June junket started Oscar was sent straight to the West to start making plans for the President's arrival there. He had done the same thing for Roosevelt in 1940. The White House had asked local politicians along the way to handle the arrangements in the various cities through which the President was to pass. Right from the start this didn't work out very well. The local big shot who was asked to do the job would ignore other important Democrats in the city and make great promises that the President would show up at functions which he obviously would never be able to attend.

The President became increasingly disgusted with the way things were going and the Omaha incident capped it. He immediately ordered that Chapman be made the exclusive "advance man" for the trip with sole authority to make arrangements.

Chapman proved up to the job. From then on, all along the journey, the crowds got bigger, ending up with a million people seeing the President in Los Angeles. Efficient arrangements apparently produce the biggest crowds.

**FIVE DAYS AHEAD OF PRESIDENT**  
Chapman has found that exactly five days ahead of the President is the best timetable. When it's longer, the careful schedules he plans get fouled up. When it's shorter, the local politicians don't have time to handle their part of the arrangements. In one city where Chapman only happened to be three days ahead, the mayor hit the ceiling because he said the President's arrival didn't give him time to get his only swallow-tail coat back from the cleaners.

Even the seeming impromptu stops in the small cities along the way have to be carefully arranged. Chapman has to determine just who of the local big shots will be asked inside the parlor car for a quick chat with the President and who will be limited to a handshake outside. And then that list has to be checked and approved by the Secret Service. It frequently requires some delicate decisions.

About the highest favor which can be bestowed on a politician is to be asked to board the train and ride through his state on it. The man who is thus honored is expected to appear on the back platform each time the train stops for the President to say a few words. Chapman usually decides who this person is to be.

### IT'S A TICKLISH AND TIRING JOB

It's obvious that Chapman's job is plenty ticklish and plenty exhausting. Regardless of local difficulties he encounters he's got to keep a set schedule. The President's party is on his tail and doesn't stop for anything. It just doesn't do to leave irate politicians in his wake who might vent their wrath by sabotaging the President's visit in some way.

Chapman has an easy manner and a quiet Southern drawl. It is hoped that the latter will make it easier for him in the hostile South as he plans for the President's various visits. He claims he was born under a tobacco plant in Halifax County, Va. He went to school with Virginia's present governor, William Tucker, in a one-room affair.

Sent to Colorado to recover from an illness contracted in World War I, Chapman's first venture into politics was in organizing a group of other veteran patients and capturing one of Denver's Democratic precincts in the party organization. Later he served as probation officer for Judge Ben Lindsey's famous juvenile court.



### Press Comment

#### MR. DREW AND A VITAL ISSUE

Globe and Mail

Premier George Drew of Ontario has been for some time the target of a vicious propaganda campaign conducted by Liberal speakers and newspapers. One of its main objects is to persuade the country that he is a narrow-minded champion of Ontario's interests against the interests of Canada as a whole. He is accused of selfishly refusing to "share Ontario's wealth" with the rest of the country because he would not agree to the Federal Government's 1945 tax proposals. This charge is a lie and a calumny.

The first point to note about the tax proposals is that they were rejected by Quebec as well as Ontario, and condemned in principle by the Governments of Nova Scotia and Alberta. These four Provinces have close to 75 per cent of Canada's population. The grounds of their objection to the Ottawa Government's fiscal scheme are perfectly clear and valid. Canada is a federation. It is too big physically and too variegated in culture and economic interests to be a unitary state. This means that the Provinces must remain secure in their local autonomy, and strong enough to fulfil the duties, respecting schools and highways, for instance, assigned to them by the Constitution. They can only be strong enough and keep their freedom of action if they retain their proper taxing powers. It was because the Dominion proposals invaded and seriously curtailed these powers that Mr. Drew, with three other Premiers, objected to them.

Mr. Drew is on record, time and again, in favor of fiscal aid to the Provinces which need it. There would be no difficulty at all in devising a system under which, without impairment of Provincial rights, the richer parts of the country could help the less rich to maintain proper standards of education, public health and social security. Mr. Drew has committed himself repeatedly to such a system, as these extracts show:

"The concern of each one of us is to find the highest possible stand-

ard of life for every Canadian. (Speech by Premier Drew at Dominion-Provincial Conference, August, 1945.)

The main purpose of the Dominion-Provincial Conference is to place the Dominion and Provincial Governments in a position to use their combined powers for the most effective advancement of the welfare of the people of Canada. (Ontario brief, January, 1946.)

Our proposals are made in the belief that they should be equally acceptable in every part of Canada and are in no instance put forward with the thought of giving any special advantage to those who live in the Province of Ontario. (Speech by Mr. Drew to the conference, April, 1946.)

What we are discussing here is the allocation of taxes paid by the same taxpayers across Canada. What we are seeking is a procedure by which these combined taxes may be channelled into the most effective courses for the advantage of all the people who live in the nine Provinces. . . . What we are discussing is the way in which, by our combined goodwill and judgment, we may use the total money the taxpayers are called upon to pay to produce the best results in living conditions, production and security, for all those people. (From the same speech by Mr. Drew.)

The Ontario Government has at all times expressed its belief in the principle of fiscal aid to those Provinces which from time to time require financial assistance. (From the same speech.)

Ontario has said, and said very emphatically, that it recognizes certain advantages it possesses and that it is not only willing, it is insistent upon combining with the other Provinces of Canada to share any advantages it possesses. . . . May I once again repeat that it recognizes its advantages and is anxious to make due compensation, and that it is prepared to do that, not on a basis dictated by the Province of Ontario, but on a basis agreeable to them (the other eight Provinces). (From the same speech by Mr. Drew.)

Such is the record. It does more than answer the deceitful propa-

A healthy well-formed body, developed by exercise and sport is an asset of the greatest value in all walks of life. Well-formed limbs and torso, however, could be put to much better use than for display like animals at a fat stock show. It was Euripides, if we remember rightly, who said that of all the pests which plagued Greece in his day, athletes were the worst. The remark would apply with equal force today to the beautiful young men in the Montreal body contest. The man who enters such a competition is surely writing himself down as purely in "the head."

#### NEXT PREMIER OF ONTARIO

If Premier George A. Drew is chosen leader of the Federal Progressive Conservative Party, not an improbability, it will become necessary to fill his position at Queen's Park. This would not be easy. He has been a vigorous and effective party leader and premier, the dominating figure in the Ontario Government.

It would be unfortunate for the Party if, in an attempt to strengthen it in the national field, it should be unduly weakened in Ontario where it has been strongest. It does not follow, however, that this will occur. Good men are available.

Among those spoken of are Attorney-General Leslie E. Blackwell, Provincial Treasurer Leslie M. Frost, and Mr. Gordon Graydon, M.P., Peel, former Progressive Conservative House leader in the Commons. The two first-named have indicated a desire to retire from public life, but either of them perhaps could be prevailed upon to accept the premiership. It is to be hoped both will remain in the Cabinet. Ontario needs men of their calibre.

Mr. Graydon has been one of the Party's most effective men at Ottawa. He did a good job as its House Leader under singularly trying conditions. He could serve well at Queen's Park.

### McKENNY ON BRIDGE

**SHREWD PLAY NETS OVER-TRICK HERE**

During the world championship mixed team-of-four contest at Chicago, I was sitting beside Mrs. Virginia Harms and William McGhee of that city, when board No. 56 came to their table. McGhee had a great deal to do with bringing the national tournament back to Chicago, and he is one of the fine card players of the Midwest.

The development of the play on this hand by Mrs. Harms was interesting. The bidding given is exactly as it occurred at the table. On the opening lead of the nine of hearts, the ten was played from dummy and East covered with the king. Mrs. Harms won with the ace and led the eight of spades. West played low and declarer went up with dummy's queen, came back with the five of spades, putting on the jack from her hand and West winning.

West returned the queen of clubs. Mrs. Harms played the king from dummy. East played the ace and Mrs. Harms trumped it. Now she led the ace of diamonds. West, not realizing that maybe he would have to unblock, played the nine. Then Mrs. Harms cashed the eight of hearts and took two more rounds of hearts in dummy, discarding a diamond from her hand. Next she led the eight of clubs and trumped it, thus stripping her hand and dummy of hearts and clubs.

A diamond was led. West had to win, and had nothing to return but a club. Thus Mrs. Harms was able to discard dummy's losing diamond and make five-odd for a top score on the board.

Remember that in tournament bridge, it is the extra trick that counts. At the other tables, most declarers, after picking up the trumps, cashed out the hearts and ruffed the club, then laid down the ace of diamonds. Naturally West was smart enough to unblock the king of diamonds and the hand was held to four-odd.

than-universal basis." In this valedictory address, the man whose span of office exceeds that of any other free-elected and representative government, made these other points:

1. Canada will support the Atomic Energy Commission on international control of atomic energy as the only method whereby "these new dread forces may be brought under effective control."

2. "Certain nations" had misrepresented and obstructed the efforts of others in aiding Western Europe's reconstruction.

On this point, the Canadian leader said: "It will come as a painful surprise and shock to my fellow-countrymen in Canada to learn that anyone addressing this Assembly could have left the impression that members of the United Nations had ignored the interests of the peoples of those countries which suffered most from the war."

But that was the impression left with him by Soviet Delegate Andrei Vishinsky's speech to the Assembly last Saturday. In reply, Mackenzie King spoke of the farm implements, motor trucks, locomotives, food supplies and medical aid sent to Poland, Czechoslovakia and Yugoslavia since the war.

Canada had taken her full share in this relief program through mutual aid, through military relief, through U.N.R.R.A., and through direct governmental credits of more than \$500,000,000 to the continent of Europe.

In listing this support, he said he was speaking for the Parliament of Canada which had made the appropriations possible and for the people of Canada who had supported the policy of rehabilitating war-devastated economies.

Mr. King's concluding remarks were on the lack of interest of the modern youth in the history of their locality. He said more local history should be taught in the schools, and, in that way, arouse the interest of the modern generation in pioneer days.

"Let us not be deceived," he said today. "The terrible truth is that nations have yet to decide which is to prevail—the law of blood and death, or imagining new means of destruction and forcing the nations to be constantly ready for the battlefield; or the law of peace, work and health, ever evolving new means of delivering man from the scourges which beset him."

"Mankind has still to discover whether violent conquest or the relief of humanity is to triumph in the end."

The peoples of the world want peace, he concluded, and the U.N. proceedings "may help to determine whether the world is to be plunged into the darkness of anarchy or whether mankind is to continue to move toward the light of ordered freedom and universal peace."

Mackenzie King, leader of the Liberal party in Canada since August, 1919, relinquishes the Prime Ministership to Louis St. Laurent, former External Affairs Minister, when he returns to Canada.

After the speech, State Minister Hector McNeil of Great Britain told The Canadian Press, on behalf of the British delegation, that Mackenzie King's "statesmanship" once again had been made evident.

"The United Kingdom feels that the United Nations must take very carefully Mr. King's warning about the need of reconciling our aspirations with our abilities," he said. "He also very properly drew attention to the crucial importance of the atomic energy problem now facing the Assembly."

Members of the South African delegation described the address as "encouraging."

money after failing to obtain Soviet accord for a German-wide currency reform. The Russians retaliated with new money of their own.

In Berlin it became one of the chief sources of the vexing discord. The city government, plagued by the split, ruled employees would be paid three-fourths of their regular pay. The Russians refused to agree to half their pay in western currency.

The Russians have demanded complete control of Berlin's currency. Having been burned once, the western powers opposed the move strenuously. In the early days of the occupation the Russians coined a still-undisclosed number of Allied marks in their Leipzig mint, apparently as they needed them.

It was reported in the latest Moscow talks the Russians might lift the Berlin blockade if the west agreed to let the Soviet Union issue and control all currency in Berlin. The western allies were willing to use only Soviet-issued marks in Berlin but insisted on four-power supervision.

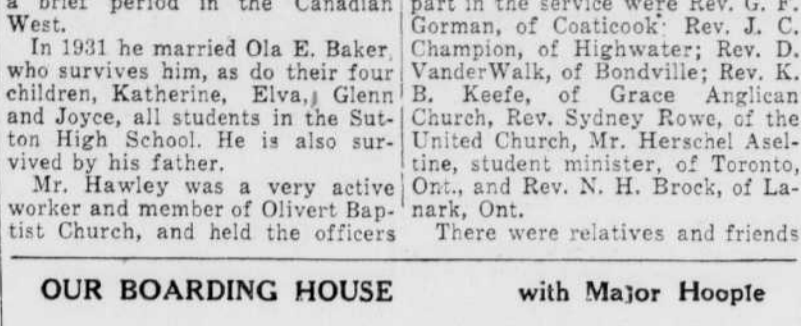
OBITUARIES

## The Doctor Says

**PHLEBITIS IS HARD TO CURE,  
SO PREVENTION IS  
IMPORTANT**

By Edwin P. Jordan, M.D.

Inflammation of the veins is  
called phlebitis. It is often accom-  
panied by the formation of clots  
in the veins in which case it is called  
thrombophlebitis. The two are  
so closely related that it is often  
difficult to say that one is present  
and not the other.

Phlebitis or thrombophlebitis  
can come on suddenly or  
gradually. It can be present  
in almost any vein, though it  
is most common in the veins of  
the leg and lower abdomi-  
nal region. The first sign of  
trouble often starts soon after a  
blow or other injury. Phlebitis  
sometimes follows operation.

The treatment of phlebitis or  
thrombophlebitis, when it is acute,  
includes absolute rest in bed, rais-  
ing of the affected limb, and appli-  
cation of heat. After the acute in-  
flammation has subsided the most  
important problem of treatment is  
to prevent swelling. Elastic band-  
ages are particularly helpful in  
this kind of thing, but they must  
be properly applied.

**Tend to Return**

Phlebitis, or thrombophlebitis,  
are hard to cure entirely and tend  
to come back. When this hap-  
pens treatment is often difficult.  
It may be necessary to remove the  
inflamed veins by surgery if they  
are near the surface. A thorough  
search for sources of infection is  
usually made, including examina-  
tion of the teeth and tonsils.  
Small treatments with X-rays and  
small doses of one of the sulfona-  
mide drugs may be helpful.

The prevention and treatment is  
being constantly improved. Early  
rising or mild exercise soon after  
an operation helps by preventing  
the blood in the veins from having  
a chance to stagnate. Some new  
drugs also help to prevent blood  
clotting. Phlebitis and thrombo-  
phlebitis are so difficult to get rid  
of entirely once they have started  
that prevention is particularly im-  
portant.

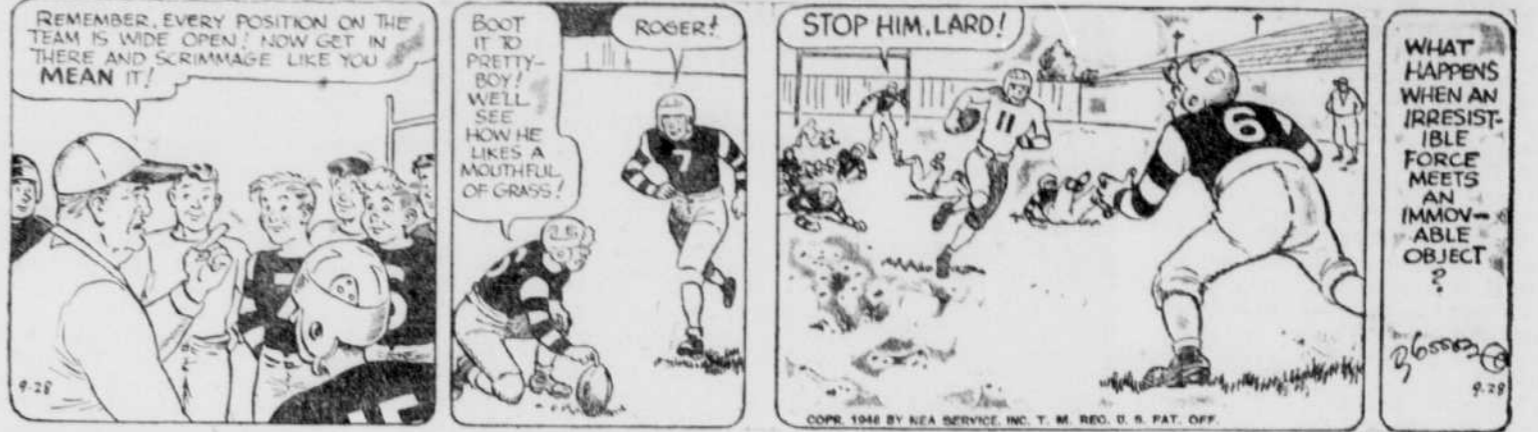

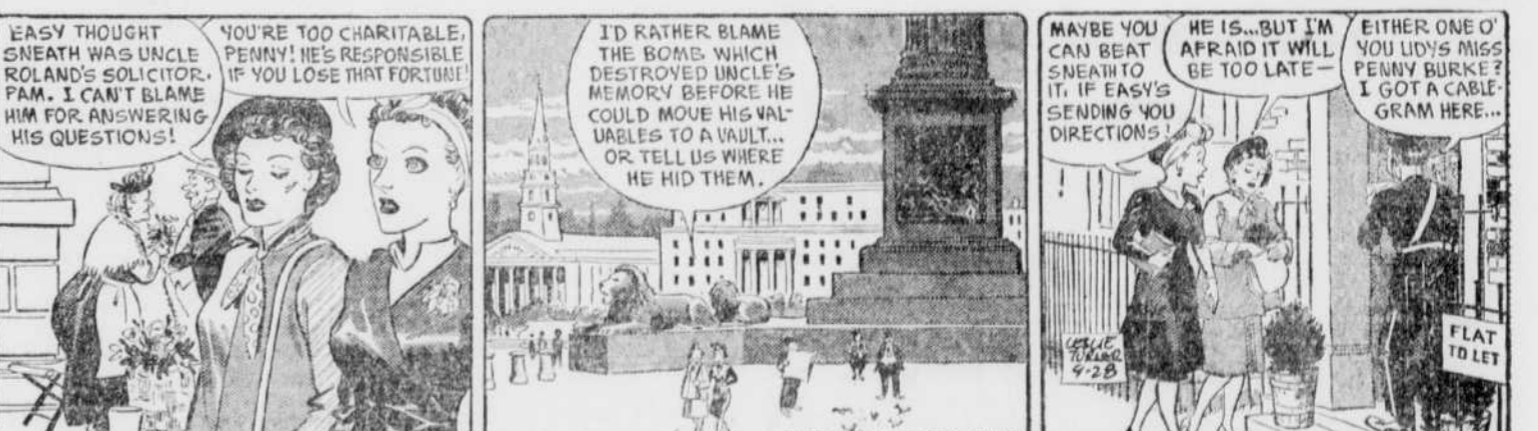

### J. W. Gregoire Suggests New Site For St. Francis Bridge

One of the civic projects to be voted on tomorrow, by property owners is the construction of a bridge to cross the St. Francis River, starting from Galt Street and ending at the foot of Joffre.

Mr. Gregoire, local architect, is of the opinion that the proposed bridge should be built to the north of Aylmer bridge and not to the south.

By way of argument, Mr. Gregoire states that the important factor in this project, is not the development of any particular section of the city, but the de-congestion of the centre of the city, and the relieving of the traffic problem on Aylmer bridge.

The construction of such a bridge on Montreal and Dufferin streets would facilitate circulation from the east, in the following manner: traffic could leave the intersection of Belmont, Murray, King, and follow the ravine which would become a new street, to Park Avenue and from there, take St. Sacrament Boulevard to cross Ciernieanu to the intersection of Terrill, where would be found the approaches to the bridge.

The traffic would then cross the river above the railroad tracks of the Canadian National and the Brompton Road and would come out on Dufferin, opposite Montreal street. From Montreal street, west bound traffic could proceed along

Mr. Gregoire points out that there would be no stopping for railroad crossings at any spot in the plan and that there is less chance of losing time than anywhere else, because of the fact that all the streets along this route are 66 feet wide.

Were the bridge to be built on the south side of the river, the width of railroad tracks would add to the length of the outlet at Joffre, which street is very far from the centre of the East Ward.

On the west side, the outlet would be on Galt, which is a narrow street to Alexander, and a traffic bound for King west would have two railroad crossings in its way, that on Alexander and Aberdeen and that on King west and Belvidere.

Estimating the cost of both bridges, Mr. Gregoire declared that a bridge to the north of the river would be approximately 25 per cent cheaper because it would be shorter.

He also referred to the congestion, outside of business hours, which results from crowds making their way to the arena, the baseball stadium, the exhibition grounds and so on, and said that this traffic is no longer seasonal, as it was in the past, but that there are activities in that vicinity all the year round.

"People of the east ward returning to their homes do not need the bridge," he said, "it is the people of the west, the centre, the south and the north wards who would make use of it."

More reason why he believes a bridge from Montreal to Terrill would be of greater advantage. The entrance to the bridge on

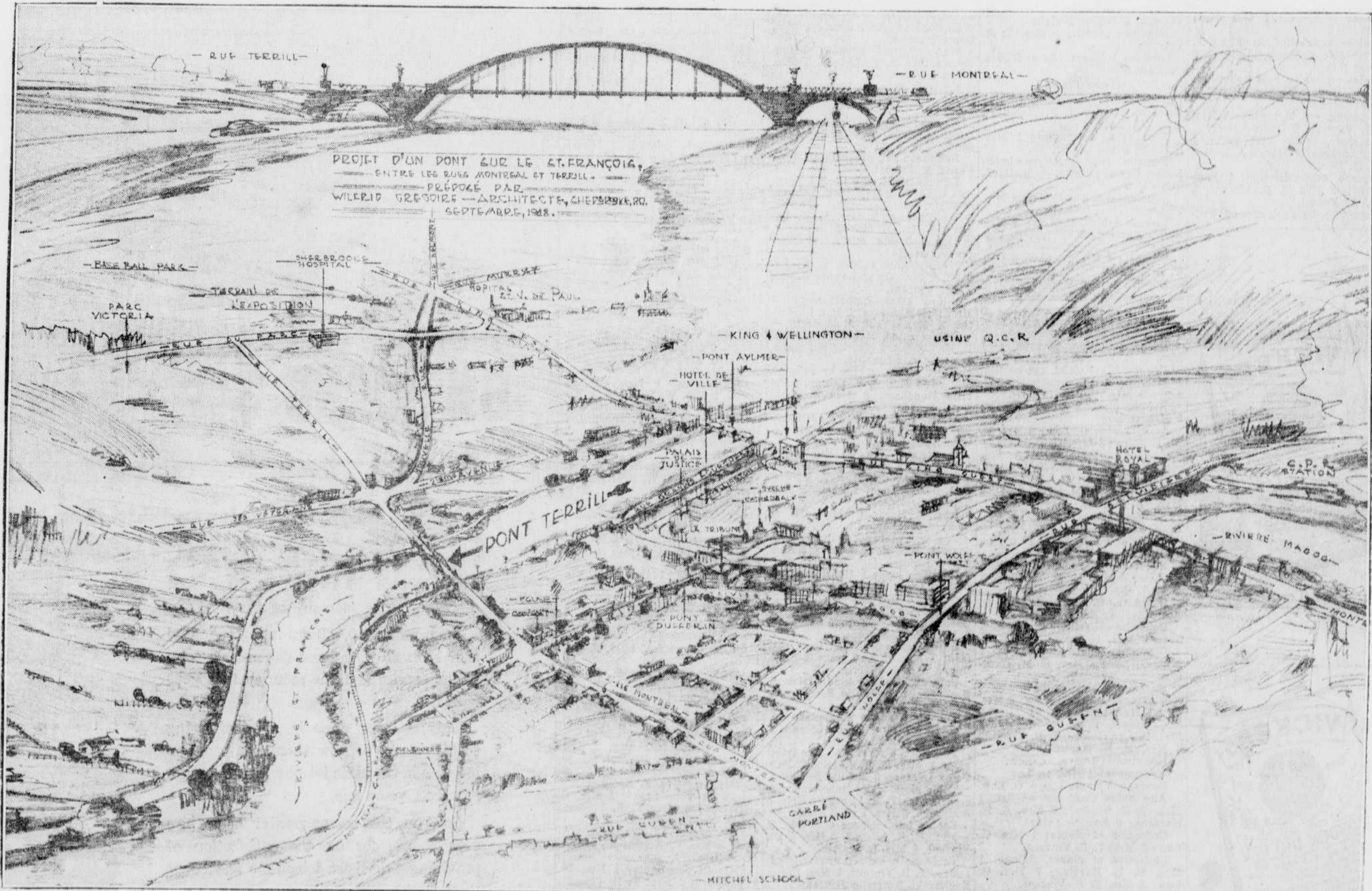

## Cleveland Indians Appear Cinch For American League Flag As Three Contenders Shift Site For Today

The tightest three-team flag fight in the American League in 40 years continues at the boiling point as Cleveland Indians, New York Yankees and Boston Red Sox hitch up their pants and prepare to slug it out to the bitter end.

One game ahead of the Yankees and Red Sox—deadlocked in a second-place tie—the Indians are in a strategic spot to grab off the first Cleveland pennant in 28 years.

Not since Detroit Tigers nailed down the championship on the last day of the 1908 season has the junior loop seen such a struggle.

Two afternoon games between the Red Sox and Washington Senators at Boston and the Yankees and Athletics at Philadelphia will set the stage for tonight's encounter between the Indians and Chicago White Sox in Cleveland.

Since Boston Braves are already "in" having wrapped up the National League, hunting Sunday, baseball fans have little interest left for anything but the scrap between the three American League contenders.

The World Series is slated to start next Wednesday in Braves' Field at Boston, but they can't do anything about that until the Indians, Yanks and Red Sox do something about the immediate situation.

Everything favors the Indians—so much so that Manager Lou Boudreau has settled the fears of Cleveland fans by stating without reservation that the Tribe has it in the bag.

Cleveland could lose twice, and New York or Boston still would have to cop five in a row to win the pennant.

The fly in the ointment is that New York has a pair of games Sat-

urday and Sunday with the Soxers in Boston. They proved in New York the other day that only one team can win at a time. Cleveland has two games with the White Sox, then winds up against the Tigers Friday, Saturday and Sunday.

New York plays three against the A's before moving into Boston for the final pair. The Red Sox have three engagements with the Senators.

Getting back to that 1908 American League finish, and just to show what could always happen when the races are as tight as this one.

Detroit defeated the White Sox in the final game, and the Tigers beat out the Indians by a slim half-game margin, with Chicago finishing third. However, had the White Sox won that last game from Detroit, they would have taken the flag, just a percentage points better than Cleveland and Detroit would have finished third.

Vic Raschi, with 19 victories for the season, will toil for the Yankees, Manager Bucky Harris said. Either Carl Scheib or Lou Brissie is expected to get the call for the A's.

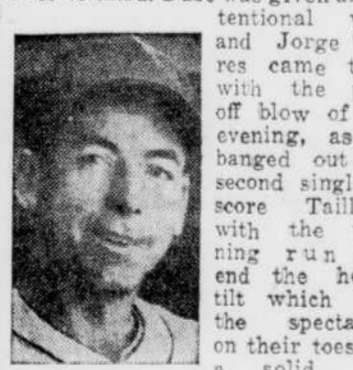

A total of 62 rookies are struggling to win berths on the four teams.

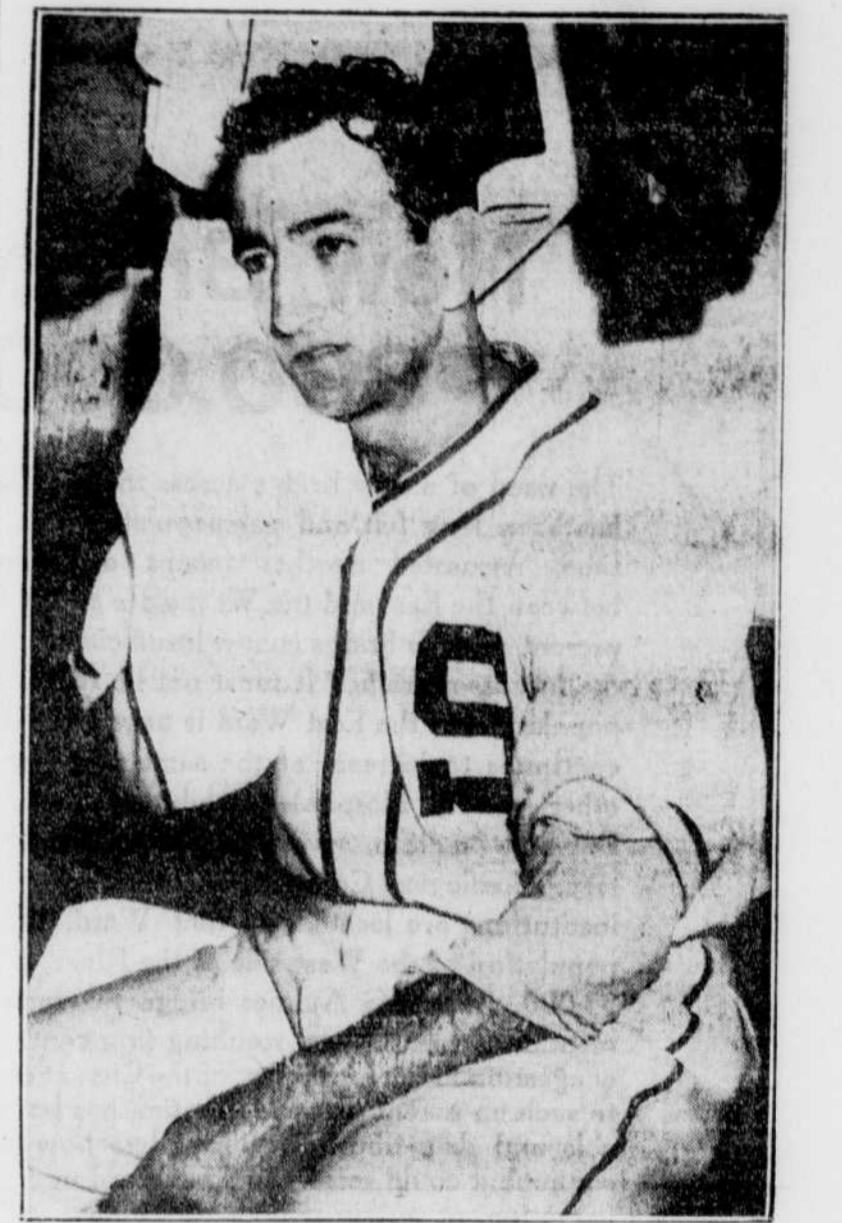
## Bishop's Hard At Work For Opening Tilt; Harry Andrews Turns Out To Help Bolster Weakened Backfield

**New Bridge**  
**\$800,000**

The need of a new bridge across the St. Francis River has been long felt and our population has, for a long time, requested another means of communication between the East and the West sides of the River. The present Aylmer bridge is now insufficient to take care of the increased traffic. It must not be forgotten that the population of the East Ward is now 13,000 and that it continues to increase at the same pace as that of the other wards. Hospitals, Exhibition Grounds, Arena, Baseball Stadium, several important industries, Cemetery, Theological College and several other educational institutions are located in that Ward. Forcibly, the population of the West side of the River, which is now 33,000, must use Aylmer bridge to reach the above mentioned institutions, resulting in a continuous traffic congestion in the lower part of the City, at certain hours, to such an extent that the situation has become intolerable and dangerous. One wonders how fire fighting equipment could reach the East Ward in case of a conflagration, at certain periods of the day.

**Filtration Plant**  
**\$700,000**

This most important project has been discussed many times for the last twenty years. It can be proved that our water is dirty and that at certain periods of the year, it is dangerous, as shown by analysis. Our source of supply (the Magog River) is contaminated by the ever increasing number of cottages along the shores of the River and Little Lake Magog. Competent Engineers, after a careful survey, have reported that the project of securing a water supply at some distant lakes is almost unfeasible, owing to its prohibitive cost.

It is universally recognized that filtration is the only scientific process known to clean and purify water. Hundreds of cities in Canada and the United States have erected filtration plants to furnish drinkable and safe water to their citizens. The plans and specifications of the proposed filtration plant have been prepared by an expert filtration engineer, well-known in Canada and the United States. Our population must be protected against filthy and infected water. Prospective Manufacturers demand filtered water. For a long time, the Provincial Board of Health has recommended that our water be filtered in order that our population be protected against epidemics resulting from a dirty and contaminated water.

**Central Bus Terminal**  
**\$200,000**

Here is a project which will remove traffic congestion in the lower part of the City and specially on King and Wellington Streets. All interurban busses now have their terminal, either on King Street West, Meadow or some other Streets in the City. The traffic on King Street West for instance, between Wellington and Aylmer bridge, is almost completely jammed at certain hours. With the new central bus terminal, all busses will arrive at and leave the same terminal, and use the new bridge, thus removing completely the traffic congestion on King and Wellington Streets. Moreover, this project is self-liquidating in twenty years, as the revenue from its operation will be more than sufficient to cover interest charges and sinking fund.

If the present revenue of the City is insufficient to provide for the payment of interest and sinking fund of the loans made for the construction of the Bridge and the Filtration Plant, the Council will provide new sources of revenue which will not affect the real estate tax.
