Message from the Minister

Sexual and domestic violence persist despite the progress made in relation to equality between women and men in our society. In 2022, it is unacceptable for women and girls to still fear for their safety.

The *2022-2027 Integrated Government Strategy to Counteract Sexual Violence and Domestic Violence, and to Rebuild Trust* is a continuation of the actions we have taken over the past few years in the fight against sexual and domestic violence, of which women and girls remain the primary victims. Much work has been done to better understand these issues, namely the work of the Viens Commission, the Domestic Violence Death Review Committee, the Expert Committee for the Support of Victims of Sexual Assault and Domestic Violence, and the Select Committee on the Sexual Exploitation of Minors.

This new Integrated Strategy is the product of collaborative work between government departments and organizations, and a follow-up to consultations with various partners. The result is in keeping with the collaborative spirit of the Rebuilding Trust report. In particular, we have taken into account the realities of women in situations of vulnerability in relation to sexual and domestic violence, including those experienced by First Nations and Inuit women and girls. The Integrated Strategy to Counteract Violence also recognizes that boys, men, and people of sexual and gender diversity can also be subjected to these forms of violence. Lastly, the assistance provided to the perpetrators of violence is part of the solution proposed in counteracting sexual and domestic violence.

I would like to thank the partner organizations for sharing their expertise, which is essential for pursuing the mission of the Secrétariat à la condition féminine and, more broadly, of the Québec government in counteracting sexual and domestic violence.

Our government is determined to establish the means to counteract sexual violence and domestic violence. There is an urgent need to change the way persons who are victims receive support and to send them a strong message: “You are our foremost priority. We are here to help you.”

Message from the Minister of Justice of Québec

In recent years, the Québec government has made improving support for persons who are victims of sexual and domestic violence a matter of national priority. We no longer want persons who are victims in Québec to hesitate to file a report and lodge a complaint.

Thus, a major cultural change has been undertaken within the justice system to place persons who are victims at the heart of the process, to adapt services to their needs and realities, and to better support them in their healing process.

Beginning with 10 pilot projects to be carried out across Québec, we will establish a court specializing in sexual violence and domestic violence. Persons who are victims will be able to benefit from the support and guidance of specialized stakeholders before, during and after the legal process. Québec will become the first jurisdiction in the world to establish such a court. We should be very proud of that.

Moreover, after being sought for more than 20 years, the compensation system for victims of criminal acts has also undergone major reform. The *Act to assist persons who are victims of criminal offences and to facilitate their recovery* has been in effect since October 13, 2021. This reform has made it possible to broaden the concept of victim, abolish the list of eligible offences so that all criminal offences against the person are recognized, whether committed in Québec or abroad, and put an end to the maximum time limit for filing a claim in cases of sexual violence, domestic violence and violence experienced during childhood.

We should also acknowledge the implementation of a free legal consultation service for victims of sexual violence and domestic violence via the *Rebâtir* telephone line (1-833-REBÂTIR).

Much like these recent initiatives, the deployment of the new Integrated Strategy to Counteract Violence is also consistent with the government's strong desire to respond to the recommendations of the Rebuilding Trust report, presented by the Expert Committee for the Support of Victims of Sexual Assault and Domestic Violence.

Context

A context for the development of the Integrated Strategy to Counteract Violence

The collective statements of recent years concerning sexual and domestic violence, including the #MeToo movement, denounced the lack of confidence that persons who are victims have in the legal system, among other things. The Expert Committee for the Support of Victims of Sexual Assault and Domestic Violence (Expert Committee) was formed under these circumstances and was given the mandate of proposing ways to improve support for persons who are victims.

On December 15, 2020, the Expert Committee tabled its report, [*Rebâtir la confiance*](#) (Rebuilding Trust, in French only), the recommendations of which aim to provide more sustained support that is better adapted to the realities of persons who are victims of sexual assault and domestic violence, both within and outside the justice system.

The Québec government then undertook to follow up on the recommendations of this report and mandated the SCF, in collaboration with the MJQ, to coordinate a large-scale concerted effort between the departments and organizations concerned.

Meanwhile, the [*2016-2021 Government Strategy to Prevent and Counteract Sexual Violence*](#) (Strategy to Prevent and Counteract Sexual Violence), which targeted sexual assault and sexual exploitation, was extended for a year to allow the necessary steps to be taken for its renewal.

In December 2020, then again in April 2021, the Québec government announced the [*Plan d'action spécifique pour prévenir les situations à haut risque de dangerosité et accroître la sécurité des victimes 2020-2025*](#) (2020-2025 specific action plan to prevent high-risk domestic violence and increase victim safety, in French only) and the [*Actions prioritaires pour contrer la violence conjugale et les féminicides 2021-2026*](#) (2021-2026 priority actions to counteract domestic violence and femicides, in French only). The [*2018-2023 Government Action Plan on Domestic Violence*](#), which includes actions to prevent and share expertise in domestic violence, will end in 2023.

Finally, in December 2021, the Québec government launched the [*Plan d'action gouvernemental 2021-2026 en réponse aux recommandations de la Commission spéciale sur l'exploitation sexuelle des mineurs – Briser le cycle de l'exploitation sexuelle*](#) (2021-2026 government action plan in response to the recommendations of the select committee on the sexual exploitation of minors – breaking the cycle of sexual exploitation, in French only) to consolidate and improve government action to prevent and counteract sexual exploitation and its consequences.

It is within this context that the Québec government is announcing the establishment of the *2022-2027 Integrated Government Strategy to Counteract Sexual Violence and Domestic Violence, and to Rebuild Trust* (Integrated Strategy to Counteract Violence). This strategy consolidates the government response to the Rebuilding Trust report while ensuring that the Strategy to Prevent and Counteract Sexual Violence is renewed and that complementary actions are implemented in the area of domestic violence.

The main objectives of the Integrated Strategy to Counteract Violence are to counteract sexual and domestic violence, and to provide more sustained support that is better adapted to realities of persons who are victims. The strategy has three areas of intervention, namely: Area 1) Prevention, awareness and detection; Area 2) Psychosocial, medical, legal, police and correctional interventions; and Area 3) Development of knowledge, training and sharing of expertise. Each of these areas of intervention has specific objectives, which are to be achieved through the associated actions.

Since the development and implementation of government actions in the areas of sexual and domestic violence often involve the same public, parapublic and community partners, the Integrated Strategy to Counteract Violence facilitates and reiterates the importance of concerted effort. Considering that a person can be a victim or perpetrator of both sexual and domestic violence and that these two forms of gendered violence share common origins, addressing them in a joint strategy allows for the implementation of structuring actions, at times concerted or specific, which are likely to better respond to various realities.

The Rebuilding Trust report

Several work projects and actions aimed at responding to the recommendations of the Rebuilding Trust report were initiated and announced by the departments and organizations during the development of the Integrated Strategy to Counteract Violence. In addition to ensuring follow-up on these recommendations over five years, the Integrated Strategy to Counteract Violence expands upon a large number of these actions and offers additional means for their implementation.

Moreover, the Integrated Strategy to Counteract Violence presents key actions aimed at focusing interventions on persons who are victims. These actions also respond to the recommendations of the Rebuilding Trust report.

- **Action 18**, Conduct pilot projects that integrate services in the areas of sexual violence and domestic violence, by supporting initiatives coming from the community, under the joint responsibility of the MJQ and the MSSS.
- **Action 26**, Increase the number of staff within the office of the Director of Criminal and Penal Prosecutions who are assigned to files involving sexual violence, under the responsibility of the DCP.
- **Action 30**, Conduct pilot projects for courts specialized in sexual violence and domestic violence, that include taking Indigenous realities into account, under the responsibility of the MJQ.

- **Action 31**, Gradually implement the use of electronic tracking bracelets in cases involving domestic violence, under the responsibility of the MSP.
- **Action 32**, Increase the number of police assigned to matters involving domestic violence and sexual violence, under the responsibility of the MSP.

Still in the same vein as the Rebuilding Trust report, many actions under the responsibility of the MSSS propose enhancements to services for persons who are victims (see also the “Community resource funding at a glance” section).

Moreover, the majority of the actions of the Integrated Strategy to Counteract Violence were developed to fully or partially respond to one or more recommendations of the Rebuilding Trust report. A total of 98 recommendations are addressed by the proposed actions. These recommendations are identified under the relevant action summaries in this document.

However, the response to certain recommendations of the Rebuilding Trust report lay in government interventions that were already underway or planned for before or at the time this strategy was developed. Other government interventions respond fully or partially to 68 of the recommendations.

When the Integrated Strategy to Counteract Violence is launched, it will contain actions that respond fully or partially to 166 recommendations in the Rebuilding Trust report. Appendix 2 of this document provides an overview of all the recommendations of the Rebuilding Trust report. Without being exhaustive, the appendix presents the main government interventions that fully or partially respond to each of the recommendations. It also presents the reasons why certain recommendations remain unanswered for the time being.

Violence against women

Violence against women occurs on a continuum and stems from historically unequal power relations between women and men. This is a systemic social problem that concerns the entire population. This gender-based violence is one of the most frequent violations of fundamental rights in the world and knows no borders, be it economic, social or geographic.¹

It can manifest in different ways, including sexist jokes, harassment on the street, online hostility, sexual harassment in the workplace, honour-based violence, female genital mutilation and excision, sexual exploitation, reproductive coercion, domestic violence, anti-feminist remarks and attacks, sexual assaults, femicides,² etc.

In all cases, these are mechanisms of control and domination resulting in the subordination of women to men.³ According to data that the police force in Québec released in 2019, 76% of the victims of domestic violence,⁴ 88% of the victims of sexual assault⁵ and 95% of the victims of crimes related to pimping and human trafficking⁶ were female. According to the same police data, men represent 77% of the alleged perpetrators of domestic violence offences, 94.9% of the alleged perpetrators of sexual offences and 89.6% of the alleged perpetrators of sexual exploitation.

Inequalities among women

The intersections between different systems of discrimination place some women in contexts of heightened vulnerability to sexual and domestic violence. Consider, in particular, immigrant, racialized and Indigenous women, seniors, women living in poverty or with disabilities, and people of sexual or gender diversity. While sexual assault, sexual exploitation, sexual harassment and domestic violence stem first from the patriarchal system, other systems of discrimination are indeed intertwined. To propose effective actions, it is necessary to focus on the interactions, that is, the intersection between the different identity and social factors at play in the experience, and the victimization of women.

Certain actions of this strategy are a result of taking these realities into account. Other actions propose rather to adapt the intervention to the specific realities of different groups of women when being implemented.

First Nations and Inuit women and girls

Numerous reports published⁷ in recent years reveal that First Nations and Inuit women and girls are overrepresented among the persons who are victims of sexual and domestic violence, and that they are subject to more severe forms of violence than non-Indigenous women and girls.⁸ According to Statistics Canada's 2014 *General Social Survey on Victimization*, approximately 10% of Indigenous women reported being subjected to physical or sexual violence by a current or former spouse in the five years preceding the survey, compared to 3% of non-Indigenous women.⁹

They were also more likely to report having sustained physical injuries (58% compared to 41% among non-Indigenous women) and to fear for their lives (52% compared to 31% among non-Indigenous women).¹⁰

This particularly high prevalence of violence in Indigenous communities results from several interacting factors.¹¹ Colonization and the imposition of assimilation policies suffered by Indigenous peoples, such as the residential school system, have had devastating effects on their well-being and quality of life that continue to this day. Identity and family upheavals, as well as the intergenerational trauma caused by these historical events, lead Indigenous populations to live with a higher rate of addiction, consumption, suicide and violence. Added to these factors are often precarious socio-economic conditions (poverty, insufficient and overcrowded housing, low level of education, etc.) and frequent experiences of discrimination, which accentuate their vulnerability to situations of multiple forms of violence and sexual exploitation, both in the communities and in urban settings.¹² The insufficient or lack of services offered to persons who are victims of violence in the communities and even an underdeveloped offer of culturally reassuring services in the Québec public network, while in the process of being deployed, are also obstacles to decreasing these situations of multiple forms of violence.

It is essential that in order to be culturally adapted and reassuring, the prevention of sexual, domestic and family violence in an Indigenous context, similar to intervention in this field, take into account the impacts of the past and be based on a holistic understanding of the problem of violence, which includes all those affected by it: women, men, family and community.¹³

The Integrated Strategy to Counteract Violence proposes 11 actions to respond to the specific needs of First Nations and Inuit women and girls. These actions, which either include an Indigenous component or are specific to Indigenous populations, are identified by the icon **A**. Appendix 1 presents a table with all of these actions.

While not exclusively addressing Indigenous women and girls, the Integrated Strategy to Counteract Violence partially responds to Recommendation 2, “We call upon the Government of Québec and Indigenous governments to work with Indigenous women and girls in Québec, including members of 2SLGBTQIA communities, immediately to prepare an action plan to prevent and eradicate all forms of violence against Indigenous women, girls, and 2SLGBTQIA people; we call upon the Québec Government to further participate in the development and implementation of a National Action Plan as outlined in Call for Justice 1.1 in the National Report” of the Québec Report of the *National Inquiry into Missing and Murdered Indigenous Women and Girls*.¹⁴

Among the persons who are victims: boys, men and people of sexual and gender diversity

In the Integrated Strategy to Counteract Violence, the Québec government recognizes that boys, men, and people of sexual and gender diversity are also subjected to these forms of violence.

The Integrated Strategy to Counteract Violence proposes to reach out to and support a wide variety of groups to better prevent and Counteract Sexual Violence and Domestic Violence, regardless of the age, sex, gender identity or sexual orientation of the victim or the perpetrator.

The fight against these forms of violence concerns the entire population. It must focus on persons who are victims, perpetrators, the personal and professional entourage of the victims and perpetrators, the general population as well as stakeholders working with victims and perpetrators, whether in the public, parapublic or community sectors.

Definitions

Despite their common roots, sexual assault, sexual exploitation, sexual harassment and domestic violence have their own characteristics and often call for distinct interventions and analytical frameworks. Thus, through at times common or specific actions, this strategy recognizes the importance of proposing responses adapted to the multitude of situations that persons who are victims of these different forms of violence may experience.

Sexual violence

The concept of sexual violence as used in the context of the Integrated Strategy to Counteract Violence refers, in particular, to the problems of sexual assault, sexual exploitation and sexual harassment, including their various manifestations. Rooted in a dynamic of power relations, exposing persons who are victims to multiple consequences and violating fundamental rights, these forms of violence have several points in common. However, this strategy takes specific aspects into account and proposes both actions that concern sexual violence in general and actions relating, in particular, to at least one of these problems.

Sexual assault

The definition of sexual assault presented in the [*Orientations gouvernementales en matière d'agression sexuelle*](#) (government orientations on sexual assault, in French only) prevails within the Québec government.

“Sexual assault is a sexual act, with or without physical contact, committed by an individual without the consent of the victim or, in some cases, and especially when children are involved, through emotional manipulation or blackmail. It is an act that subjects another person to the perpetrator’s desire through an abuse of power, the use of force or coercion, or implicit or explicit threats. Sexual assault violates the victim’s fundamental rights, including the right to physical and psychological integrity and security of the person. This definition applies regardless of the age, sex, culture, religion or sexual orientation of the victim or of the perpetrator of the assault, regardless of the type of sexual act committed or the place or life setting in which it is committed, and regardless of the relation between the victim and the perpetrator.

Among other things, the *Orientations gouvernementales en matière d'agression sexuelle* defines the guiding principles aimed at underpinning intervention in the area of sexual assault. In particular, these orientations stipulate that sexual assault is a crime, that it involves acts of power and domination over a person, that victims must be supported and that perpetrators must be held accountable.”¹⁵

The government’s definition of sexual assault is broader than the three sections of the *Criminal Code* that refer to sexual assault (simple sexual assault, sexual assault with a weapon and aggravated sexual assault),

and includes other sexual offences such as sexual interference and invitation to sexual touching, luring and the publication of an intimate image without consent.

Statistical portrait¹⁶

- The rate of sexual offences reported by police forces shows an upward trend of 59.9% over 10 years.
- Sexual assault continues to make up the majority of sexual offences. Sexual interference is the second most common type of sexual offence committed.
- Women and girls represent a large majority of victims of sexual assault (88.3%). They also remain the primary victims of other sexual offences (82.0%).
- The majority (54.4%) of victims of sexual assault are adults. The number of victims under the age of 18 is increasing more than that of adult victims, with respective annual increases of 9.5% and 4.3% in 2019. Victims of other sexual offences, such as sexual interference and invitation to sexual touching, luring or the publication of an intimate image without consent, are almost exclusively minors (90.8%).
- Alleged perpetrators of sexual offences are predominantly male (94.9%). In the case of several crimes, more than 9 out of 10 perpetrators are men, including voyeurism (94.7%) and invitation to sexual touching (97.0%).
- More than four out of five victims know the perpetrator (81.4%), whether they are an immediate family member (13.8%), a current or former intimate partner (18.5%) or from another type of relationship (49.1%).
- Indigenous peoples are overrepresented among victims of sexual assault. The rate of sexual assault among Indigenous peoples is almost three times that of non-Indigenous people.¹⁷
- People of sexual and gender diversity are at greater risk of experiencing sexual violence in their lifetime than those who identify as heterosexual and cisgender.¹⁸ This risk is estimated to be between 1.4 to 3 times greater.¹⁹⁻²⁰
- The rate of violent incidents, including sexual assault, perpetrated against women with disabilities aged 15 and over is three times higher than that of women without disabilities.²¹

Sexual exploitation

According to the definition of sexual exploitation presented in the Strategy to Prevent and Counteract Sexual Violence and reiterated in the *Plan d'action gouvernemental 2021-2026 en réponse aux recommandations de la Commission spéciale sur l'exploitation sexuelle des mineurs – Briser le cycle de l'exploitation sexuelle*, sexual exploitation is a complex problem, in particular because of the different contexts in which it can occur, e.g. prostitution, erotic massage parlours, strip clubs, and so on, and the attendant criminal activity such as procuring, human trafficking for the purpose of sexual exploitation, the purchase of sexual services, and so on. Through its numerous forms, sexual exploitation usually implies a situation, a context or a relationship in which one individual takes advantage of the vulnerability or the dependency of a person, or an unequal power relationship, in order to use the person's body for sexual purposes for their personal benefit. The benefit can be pecuniary, social or personal, such as sexual gratification, or any other form of advantage. The victims of sexual exploitation are deemed to include the victims of human trafficking for the purpose of sexual exploitation. Furthermore, it is recognized that prostitutes are at a high risk of being the victims of sexual exploitation.²²

Statistical portrait

- Research shows that more than 80% of adult prostitutes in Canada became a prostitute when they were minors and that the average age of entry into prostitution is between 14 and 15.²³
- Offences related to sexual exploitation for commercial purposes or committed against a minor rose steadily from 2015 to 2019, with a rate increase of 123.3%.²⁴⁻²⁵
- Among the four defined categories of sexual exploitation, crimes related to child pornography and the non-consensual distribution of intimate images of a minor accounted for more than half of the offences reported in 2019 (58.1%).²⁶
- Victims of sexual exploitation are predominantly female. The category of pimping and human trafficking accounts for the most, with 95.0% of female victims. As for alleged perpetrators, they are predominately men, this proportion being the highest in the category of the commodification of sexual services (96.4%).²⁷
- In cases of pimping and human trafficking offences, 35.1% of the victims considered the alleged perpetrator an intimate partner²⁸ and 58% considered them an acquaintance.²⁹

- Studies in various countries have shown that 89% or more of female prostitutes want to leave prostitution, not continue it.³⁰
- In Canada, prostitutes are exposed to many dangers and, as a result, have a mortality rate 40 times higher than the national average.³¹
- In Canada, as in Québec, Indigenous women are among the groups identified as the main targets of human trafficking, along with immigrant and racialized women.³²

Sexual harassment

Based on the definition of psychological harassment in the workplace (which includes sexual harassment) set out in the *Act respecting labour standards*, sexual harassment can be described in terms of the following: any vexatious behaviour in the form of repeated and hostile or unwanted conduct, verbal comments, actions or gestures of a sexual nature, that affects a person's dignity or integrity and that results in a harmful environment for the person. A single instance serious misconduct can also be considered harassment if it has lasting negative consequences for the person.

Many verbal comments, gestures or actions can constitute sexual harassment. It can be non-verbal behaviour, such as insistent stares or whistles, or even verbal comments, such as sexist or lewd jokes, questions about a person's private life, unwanted advances, threats, etc. Sexual harassment can also be physical, manifesting itself in brushing, touching or other acts of a sexual nature.

Sexual harassment can be perpetrated by a person known or unknown to the victim and occur in any setting, e.g. at work, during a sports practice, at school, in public spaces (street, park, public transportation, in particular), online, etc.

By its very nature and its consequences for the persons who are victims, sexual harassment constitutes an abuse of power. It is an assault on equality and an obstacle to the full social participation of women and girls as it excludes them from common spaces.

It is important to know that the intention of the perpetrator needs not be taken into account; the experience of and consequences for the victim are the decisive elements in identifying a situation of harassment.

Although sexual harassment in itself does not constitute a criminal offence, it is nonetheless a practice prohibited by two laws, namely the [Charter of human rights and freedoms](#) (sexual harassment is recognized as a form of discriminatory harassment) and the [Act respecting labour standards](#) (sexual harassment is recognized as a form of psychological harassment in this case). In addition, certain behaviours perpetrated in a dynamic of sexual harassment can themselves be recognized as criminal offences (e.g. criminal harassment, harassing communications, sexual assault).

Statistical portrait

- In public spaces, “women are the main targets of street harassment, and men are the main perpetrators.”³³
- In the last year, 38% of cisgender women report being whistled at or called out to by strangers in public places in Montréal.³⁴
- In the past year, 23% of cisgender women report having experienced rude remarks or offensive jokes of a sexual nature made by strangers in public places in Montréal, a rate that is even higher for trans people (29%) or people identifying as non-binary (37.5%).³⁵
- One-quarter (25%) of the women who participated in Statistics Canada’s *Sexual Misconduct and Gender-based Discrimination at Work, 2020* survey reported having personally been the target of sexualized behaviours in their workplace in the preceding year.³⁶
- Fifty-six percent of women who had experienced inappropriate communications, 67% of those who had been exposed to sexually explicit material, and 78% of those who had experienced unwanted touching or were offered sex mentioned that a man was behind this behaviour.³⁷
- Nearly half (47%) of women in certain male-dominated occupations (trades, transportation, machinery and related occupations) have had personal experiences of inappropriate sexualized behaviours.³⁸

Sexual violence and the education sector

Sexual violence can occur in different contexts, particularly within the education sector. Since the prevention of sexual violence among young people is a priority for the Québec government, sexuality education content has been mandatory for all elementary and secondary school students since 2018. Moreover, the revision of the Culture and Citizenship in Québec program will also take into consideration the mandatory content on sexual violence. The Integrated Strategy to Counteract Violence proposes actions concerning the school environment. Legislative work underway in spring 2022, particularly with respect to the development of the role of student ombudsman, also aims to better meet the needs of young victims in the education sector.

Sexual violence and higher education

In recent years, several studies in both Québec and Canada have documented the high prevalence of gender-based and sexual violence in higher education, the repercussions associated with these events and the low reporting rate.

In Québec, the *Enquête sexualité, sécurité et interactions en milieu universitaire* (sexuality, safety and interaction in the university environment survey, ESSIMU)³⁹ and the *Projet intercollégial d'étude sur le consentement, l'égalité et la sexualité* (intercollegiate project for the study of consent, equality, and sexuality, PIECES)⁴⁰ revealed that more than a third of students have experienced at least one form of sexual violence in a university or college setting. Sexual violence directly affects more than a third of the college and university community (members of the student community and staff of institutions higher education) (PIECES 2020: 35.9%; ESSIMU 2016: 36.9%) and is associated with negative repercussions for those who are victims: sexual victimization, recurring thoughts or nightmares, heightened state of alertness and avoidance of situations conducive to harassment.

Action 7 of this Integrated Strategy to Counteract Violence proposes to further support institutions of higher education in the implementation of the obligations under the [Act to prevent and fight sexual violence in higher education institutions \(CQLR, c. P-22.1\)](#).

Domestic violence

The concept of domestic violence presented in the [Politique d'intervention en matière de violence conjugale : prévenir, dépister et contrer la violence conjugale](#) (policy on intervention in the matter of domestic violence: preventing, detecting and counteracting domestic violence, in French only) remains at the core of government commitments.

“Domestic violence is characterized by a series of repetitive actions, which generally occur in an upward trend. Specialists call this progression the “escalation of violence.” In the perpetrator, it proceeds according to a cycle defined by successive phases marked by the rise of tension, aggression, disempowerment, remission and reconciliation. These phases correspond to the victim’s fear, anger, feeling that they are responsible for the violence and, lastly, hope that the situation will improve. These phases are not always all present and do not always follow each other in this order.

Domestic violence includes psychological, verbal, physical and sexual assaults as well as acts of economic domination. It does not result from a loss of control, but rather constitutes a chosen means of dominating the other person and asserting one’s power over them. It can be experienced in a marital, extramarital or romantic relationship, and at all ages and stages of life.”⁴¹

Among First Nations and Inuit peoples, the concept of family violence is largely favoured over that of domestic violence or violence between intimate partners, insofar as it is understood that the dynamics of violence go beyond that of the domestic or intimate relationship, and that it has undeniable consequences on family and social dynamics. It is understood that family violence can certainly take place within the framework of intimate relationships, but it can also take root within extended family units, the people around the individual and the community.⁴²

It should also be noted that the concept of family violence is increasingly recognized and used in family law, particularly since the adoption of the new *Divorce Act*, which expressly introduces this concept. Specifically, family violence includes in particular any form of violence occurring in a family context, by one family member toward another to which a child may be exposed, or by a family member toward a child. Family violence is a particularly important factor when assessing decisions that must be made in the best interests of children.

Statistical portrait

- According to statistics reported by police forces, the last decade has seen an overall increase of 7.5% in offences against the person committed in a domestic context.⁴³
- Victims of domestic violence are mostly female (76.2%), while the alleged perpetrators of these violent offences are mostly male (77.1%).⁴⁴
- A total of 464 crimes related to homicides and attempted murders were committed in a domestic context from 2010 to 2019, which corresponds to an annual average of 33 attempted murders, 11 homicides and 2 crimes of criminal negligence.⁴⁵
- In 2019, 55.8% of violent crimes committed in a domestic context were perpetrated by the current intimate partner. This percentage is even higher for crimes related to homicides and attempted murders (82.1%).⁴⁶
- Offences of indecent or harassing communication and intimidation are almost all perpetrated by a former intimate partner (93.4%), as are criminal harassment and threats (82.1%).⁴⁷
- In 2021, 18 women lost their lives at the hands of their violent spouse or former spouse in Québec. Many stakeholders have estimated that the context of the health emergency linked to the global COVID-19 pandemic was not unrelated to this increase.
- Indigenous women are at a higher risk of being victims of domestic violence and experience more severe forms of violence than non-Indigenous women. They are also overrepresented as victims of intimate partner homicide.⁴⁸

- According to the 2014 *General Social Survey on Victimization*, homosexual and bisexual people were twice as likely as heterosexual people to report having been victims of violence in their intimate or romantic relationships in the five years preceding the survey.⁴⁹

Counteracting stereotypes and promoting egalitarian relationships

Sexual and gender stereotypes lead to judgements or expectations that differ based on a person's presumed gender. They influence the ties and relationships between women and men, and promote the renewal of unequal relationships of power.

A person's emotional and romantic life is influenced by the models presented to them since childhood, starting with the family model. In films, books and songs, jealousy is often presented as proof of love, and insistence upon refusal as proof of perseverance and romanticism. Media and advertisements also distort perceptions of gender and intimate partner relationships. For example, in pornography, the models of the submissive woman and the dominant man can lead to serious consequences, such as the "glamorization" of prostitution and the normalization of violence against women.

The fight against sexual and sexist stereotypes as well as the promotion of egalitarian relationships remain the cornerstone for achieving equality between women and men and, by the same token, act to prevent sexual and domestic violence.

Complementarity of government interventions

The actions proposed in the Integrated Strategy to Counteract Violence are in addition to the many actions on sexual and domestic violence taken in the past that are now integrated into the practices of government departments and organizations.

For the sake of complementarity, the actions of this strategy have been developed and will be implemented taking into consideration the other government interventions in effect with regard to these issues. Consider in particular the following:

Consultations

The foundation of the development of the Integrated Strategy to Counteract Violence rests upon the analysis of the Rebuilding Trust report by all government departments and organizations concerned by its recommendations. The recommendations of the Expert Committee are based on consultations with some 100 specialized organizations and online consultations with 1585 victims.

In fall 2021, the SCF, on behalf of the departments and organizations involved in the development of this strategy, also conducted [an online consultation](#) (in French only) on sexual violence. The consultation focused on issues covered less by the Rebuilding Trust report, including prevention and research needs in the area of sexual violence. A total of 268 organizations took part, mainly community organizations, but also those from the public, parapublic and research sectors.

Other work also contributed to the development of the strategy, such as that carried out by the Domestic Violence Death Review Committee of the Bureau du coroner and the [Comité de travail sur la violence faite aux femmes](#) (working committee on violence against women, in French only), coordinated by the SCF. Statutory meetings set up by the SCF during the pandemic and aimed at ensuring proper communication on current issues between organizations helping victims of domestic violence and the government, as well as the work of the MSSS and its field partners on the consolidation and development of places in shelters have also fuelled government reflection.

In 2018, the SCF coordinated a collaborative work process with organizations representing First Nations and Inuit peoples to jointly determine priorities for government action in the areas of domestic and family violence. In addition, the SCF and the SRPNI also established the Comité femmes autochtones (Indigenous women's committee) to ensure collaborative efforts between organizations representing Indigenous women and the Québec government. In particular, this committee was consulted in the context of the renewal of the *Government Strategy for Gender Equality Toward 2021* and the Strategy to Prevent and Counteract Sexual Violence. The recommendations of the *Final Report of the National Inquiry into Missing and Murdered Indigenous Women and Girls* and the *Final Report of the Public Inquiry Commission on relations between Indigenous Peoples and certain public services in Québec: listening, reconciliation and progress* were finally also taken into consideration in the development of this strategy.

In addition to the undeniable expertise of civil society partners in the areas of sexual and domestic violence, there is the expertise of government departments and organizations, which have developed concrete actions to respond to the current concerns they share regarding this violence.

Structure of the strategy and investments

The Integrated Strategy to Counteract Violence contains 58 actions. Among these actions, 18 relate to sexual violence,⁵⁰ 24 relate to domestic violence and 16 address both issues at once. Among the actions that address sexual violence, 11 focus on the problem of sexual exploitation, and complement the *Plan d'action gouvernemental 2021-2026 en réponse aux recommandations de la Commission spéciale sur l'exploitation sexuelle des mineurs – Briser le cycle de l'exploitation sexuelle*.

The Integrated Strategy to Counteract Violence brings together 18 government departments and organizations that have worked jointly to offer a coherent response to the issues it addresses, thus releasing \$324.9 million in new confirmed credits in the 2022-2023 Québec budget⁵¹ and \$137.5 million in self-financed credits for a total of \$462.4 million over five years.

This strategy is intended to evolve over time. Considering that new specific interventions in the areas of sexual and domestic violence will continue to be developed, these new initiatives could be integrated into the strategy with a view to establishing a consistent overall vision and consolidated follow-up.

Areas of intervention and investments

The amounts are distributed according to the three areas of intervention that make up the strategy. Each of these areas are accompanied by objectives which the associated actions aim to meet:

Area of intervention 1, “Prevention, awareness and detection,” proposes seven actions in the area of sexual violence, five in domestic violence and one concerning both issues. These actions aim to:

- Continue and support efforts to raise awareness of sexual and domestic violence among persons who are victims, perpetrators, the people around them and witnesses.
- Reach and accompany a wide variety of groups and organizations in the fight against domestic violence, sexual violence, and psychological and sexual harassment.
- Ensure the prevention of violence in a romantic context and sexual violence among young people.

Total investments (new credits and self-financed credits) for Area of intervention 1 amount to \$86.14 million.

Area of intervention 2, “Psychosocial, medical, legal, police and correctional interventions,” includes 4 actions in the area of sexual violence, 11 in domestic violence and 7 concerning both issues. These actions propose to:

- Improve the availability and diversity of services offered to persons who are victims and perpetrators of sexual and domestic violence throughout Québec and promote their integration.
- Support individuals who wish to leave prostitution.
- Improve the experience of persons who are victims of sexual and domestic violence, including children, in the justice system and standardize legal practices.
- Increase the intervention capacities of police and correctional resources in the areas of sexual and domestic violence, particularly in the evaluation of the risk of violent acts and recidivism.

Total investments (new credits and self-financed credits) for Area of intervention 2 amount to \$370.53 million.

Area of intervention 3, “Development of knowledge, training and sharing of expertise,” presents seven actions in the area of sexual violence, eight in domestic violence and eight concerning both issues. These actions aim to:

- Ensure a coherent and continuous training offer for stakeholders from various sectors in the areas of sexual and domestic violence.
- Analyze certain current prevention and intervention practices in sexual and domestic violence with a view to proposing avenues for improvement.
- Support the development and dissemination of knowledge and data on sexual and domestic violence.
- Create opportunities for the sharing of expertise between different sectors concerned with sexual and domestic violence.

Total investments (new credits and self-financed credits) for Area of intervention 3 amount to \$5 million.

Note that \$700 000 are also allocated to the governance, monitoring and evaluation of the Integrated Strategy to Counteract Violence. It should also be pointed out that a significant number of actions in the areas of sexual and domestic violence are now regularly funded through the budgets of the lead departments and organizations.

Community resource funding at a glance

The government recognizes the contribution of organizations that help women who are victims of domestic violence and their children, persons who are victims of sexual violence and perpetrators of these forms of violence. Consequently, over time, it plans to increase the funding dedicated to these important networks of front-line organizations.

Community resources will receive a direct allocation of 56% of the new credits⁵² of this strategy. This funding also contributes to the objectives of PAGAC, namely that of increasing financial support for the overall mission of community organizations to promote consolidated services and sustainable interventions.

Shelters for women and children who are victims of domestic violence

The network of support centres and emergency shelters meets the needs of women who are victims of violence and their children throughout Québec, through shelter and external services. It comprises more than 100 shelters offering some 1500 places.

Second stage housing offers women and their children specialized services related to post-separation domestic violence through safe transitional housing. Thirty-five houses currently offer these services. They can accommodate 230 women and more than 170 children. More than 30 houses are in development.

Financial support for support centres and emergency shelters for women who are victims of domestic violence in Québec has recently benefited from successive increases. On the one hand, the 2021-2022 budget announced an increase of \$22.5 million over five years. On the other hand, the *Actions prioritaires pour contrer la violence conjugale et les féminicides 2021-2026* have allowed for a new additional investment of \$92 million over five years for the creation or consolidation of new places in housing as well as the hiring of resources in shelters to improve external services. Thus, in 2021-2022, support centres and emergency shelters benefited from a recurring increase of \$20 million.

Under this strategy, and in accordance with the 2022-2023 Québec budget, \$138.3 million has been allocated to community resources specializing in domestic violence, in particular to support centres, emergency shelters and second stage housing services for the next five years (Actions 14, 15 and 16).

In 2021-2022, organizations offering shelter for women who have experienced abuse or who are in difficulty as well as the three provincial groups obtained financial support of \$125.2 million⁵³ from the MSSS. By the end of the Integrated Strategy to Counteract Violence, the MSSS will have increased recurring annual funding for shelters by \$76.1 million since 2019-2020 through this strategy, the *Actions prioritaires pour contrer la violence conjugale et les féminicides 2021-2026*, the *Plan d'action spécifique pour prévenir les situations à haut risque de dangerosité et accroître la sécurité des victimes 2020-2025* and the *2018-2023 Government Action Plan on Domestic Violence*.

Support organizations for spouses demonstrating violent behaviour

The MSSS provides funding to 36 community organizations in Québec offering an assistance program for spouses who demonstrate violent behaviour. Funding for these organizations in 2021-2022 was \$17.8 million, taking into account recent investments.

The 2020-2021 budget announced an increase in financial support for these organizations by \$5 million over five years. This increase falls under the *Plan d'action spécifique pour prévenir les situations de violence conjugale à haut risque de dangerosité et accroître la sécurité des victimes 2020-2025* (2020-2025 specific action plan to prevent situations of domestic violence at high-risk of danger and increase the safety of victims).

The *Actions prioritaires pour contrer la violence conjugale et les féminicides 2021-2026* have provided additional financial support in the amount of \$19.8 million over five years to organizations helping men who demonstrate violent behaviour in a domestic or family context.

In the wake of the 2022-2023 Québec budget, \$18.6 million will be provided over five years under this strategy to increase funding for organizations helping men who demonstrate violent behaviour (Action 22).

Support organizations for victims of sexual assault

In 2020-2021, financial support from the MSSS for organizations working with victims of sexual assault increased by \$7.8 million and was allocated to 48 resources to improve access to assistance and follow-up services, thus raising the total support granted to \$22.8 million.

Under this strategy and following the 2022-2023 Québec budget, organizations that help victims of sexual assault, including the Centres d'aide et de lutte contre les agressions à caractère sexuel, will be granted \$16 million by the MSSS by 2026-2027 for additional resources to carry out their mission (Action 20).

In addition, an envelope of \$9 million administered by the SCF will make it possible for these organizations to continue the deployment of the *Empreinte – Agir ensemble contre les agressions à caractère sexuel* program (Action 4).

Child abuse prevention organizations

Moreover, from 2019-2020 to 2020-2021, financial support for ESPACE-type organizations working to prevent violence against children, particularly sexual assault, was increased by \$2.5 million by the MSSS.

Support organizations for perpetrators of sexual assault

The MSSS increased their financial support to organizations offering assistance services to perpetrators of sexual violence by \$1.4 million in 2020-2021 for the consolidation of their support, evaluation, treatment and maintenance services.

Funding in 2021-2022 for the group and the nine organizations recognized and supported by the support program for community organizations, present in nine regions, represented an envelope of \$5.5 million.⁵⁴

Support organizations for victims of sexual exploitation

As part of the *Plan d'action gouvernemental 2021-2026 en réponse aux recommandations de la commission spéciale sur l'exploitation sexuelle des mineurs – Briser le cycle de l'exploitation sexuelle*, the MSP, in collaboration with the SCF, the MSSS and the MESS, will establish a program to support the overall mission of community organizations with recognized expertise and know-how in the area of sexual exploitation.

This program will make it possible to increase the sums already granted to these organizations and support their current activities. This financial support should also make it possible to ensure long-term support for the programs and services offered by these organizations, as well as the underlying partnerships.

Actions

Area of intervention 1 – Prevention, awareness and detection

Objectives

- Continue and support efforts to raise awareness of sexual and domestic violence among persons who are victims, perpetrators, the people around them and witnesses.
- Reach and accompany a wide variety of groups and organizations in the fight against domestic violence, sexual violence, and psychological and sexual harassment.
- Ensure the prevention of violence in a romantic context and sexual violence among young people.

1. Mount campaigns and support activities that raise awareness of sexual and domestic violence, making sure that they are tailored to the realities of certain groups and that some address perpetrators directly.

Plans have been made for government campaigns and to support awareness-raising initiatives arising from the field that take into account persistent or emerging issues and challenges related to sexual and domestic violence. Particular attention will be paid to initiatives relating to people of sexual and gender diversity. Different means will be used depending on the sectors and clientele to be prioritized, for example, traditional media, websites, social media, paper or digital tools and awareness-raising workshops.

2. Pursue prevention and improve the support and guidance provided to schools and centres with regard to sexual violence.

The prevention of sexual violence in schools and adult education and vocational training centres is fundamental to ensuring a healthy and safe environment for students, thus contributing to their well-being and educational success. The particularity of this form of violence and the issues it raises require taking into consideration the specific situation of the institutions. To do so, procedures ensuring the prevention of sexual violence and the support of school staff working with students (victims, witnesses or perpetrators) will be formally included in the anti-bullying and anti-violence plans of educational institutions. To this end, the MEQ will offer targeted support and guidance to the school network, namely through regional support officers and persons responsible for sexuality education.

3. Develop an educational tool in sexuality education to present content on the prevention of violence in a romantic context.

An educational tool in sexuality education will be developed to present content on the prevention of violence in a romantic context. This tool will offer more specific details on the content and a template for presenting the content to secondary school students. Developed by the MEQ in accordance with ministerial orientations, it will be offered to school staff members who can either use it in its entirety or improve upon it according to student needs.

4. Support initiatives aimed at raising awareness of sexual violence among secondary school students, including the deployment of the *Empreinte – Agir ensemble contre les agressions à caractère sexuel* program.

Support will be provided for prevention initiatives led by organizations helping victims of sexual assault. The main initiative concerned is the *Empreinte – Agir ensemble contre les agressions à caractère sexuel* program. This is a sexual assault prevention program for secondary school students, their parents and school staff. The objective of the program is to reduce social tolerance toward different forms of sexual violence. The program will be updated and its deployment extended to other regions of Québec. Work aimed at adapting the program to different populations (e.g. young people in special education) will also be initiated. Recurrent financial support will be offered to support these initiatives.

5. Support projects to raise awareness of violence in romantic relationships among young people.

New or existing field initiatives adapted to young people (from preadolescence to early adulthood) will be deployed to prevent and counteract violence in romantic relationships. In its first report, the Domestic Violence Death Review Committee recommends the promotion of egalitarian relationships in couple relationships among young people as a tool for preventing this form of violence. It is also important to help young people recognize violence in everyday intimate or romantic relationships, and encourage them to react as witnesses to a situation of violence.

6. Renew the [SportBienEtre.ca](https://sportbienetre.ca) web platform, namely by adding one or more sections on sexual violence.

The [SportBienEtre.ca](https://sportbienetre.ca) web platform brings together awareness and information tools on violence and sexual abuse intended for and adapted to the sports sector. The content of this platform will be revised and enhanced to make it more dynamic and inclusive, and to allow new concepts to be integrated and adapted to current realities. One or more sections relating specifically to sexual violence will be added.

7. Support institutions of higher education in carrying out their obligations under the *Act to prevent and fight sexual violence in higher education institutions*.

As part of the establishment of a new *Plan d'action pour prévenir et contrer les violences à caractère sexuel en enseignement supérieur 2022-2027* (2022-2027 action plan for preventing and counteracting sexual violence in higher education institutions), institutions of higher education will be further supported in pursuing the implementation of the obligations prescribed by the *Act to prevent and fight sexual violence in higher education institutions* (CQLR, c. P-22.1), according to the following three areas of intervention:

- Further support institutions in the prevention of sexual violence (training, awareness and organization of safe campuses).
- Maintain and enhance funding for institutions of higher education to ensure the continuity of support and guidance services for individuals, paying particular attention to those most at risk of experiencing sexual violence.
- Develop knowledge and share expertise to take better action, by continuing to support research and consultation between all stakeholders involved in the fight against sexual violence in institutions of higher education.

8. Develop and centralize tools to support workplaces in dealing with domestic, family or sexual violence.

In the context of the sanctioning of the *Act to modernize the occupational health and safety regime*, which sets out obligations for the employer in this regard in the *Act respecting occupational health and safety*, the CNESST, in collaboration with specialized partners, will make various tools available to support workplaces in their management of domestic violence occurring in the workplace. Awareness-raising and information activities on domestic violence, as well as the promotion of available tools, will also be carried out in various regions of Québec, in particular by prevention counsellors specializing in psychological health in the workplace.

9. Set up a pilot project to offer prevention and psychosocial support services to people in the arts sector demonstrating behaviours at risk of sexual violence.

Plans are in place to establish, in the form of a pilot project, prevention and psychosocial support services for people from the arts sector demonstrating behaviours at risk of sexual violence. This service would make it possible to take action before problems arise in the arts sector. Artists' agents could be involved in the implementation of this program, considering their close relationship with the artists. This pilot project will provide inspiring learning opportunities leading to eventual broader development for various sectors and for the population as a whole.

10. Make immigrants and people from ethnocultural minorities aware of domestic violence and organizations working in the area of domestic violence aware of the realities of these individuals.

Workshops have been proposed on the prevention and awareness of domestic violence by and for immigrants and ethnocultural minorities. Workshops are also planned to raise the awareness of the realities of immigrants and people from ethnocultural minorities among public and community sector stakeholders working in the area of domestic violence. Awareness-raising video capsules will also be developed on the importance of recognizing domestic violence in order to prevent it.

Financial support is planned for structuring projects aimed at counteracting the domestic and family violence of which Indigenous women and girls are victims, in partnership with Indigenous organizations. The funded projects will make it possible to implement prevention, awareness-raising and intervention initiatives, by and for Indigenous peoples, aimed at counteracting domestic and family violence. Projects intended to train stakeholders could also be funded.

Financial support is planned for prevention and healing initiatives for men and the people around them in Indigenous communities with regard to sexual, domestic and family violence. This measure will make it possible to respond to the needs expressed by the partners, that is, to work in a more holistic manner on the problems of violence and healing by including men. Funded projects could include counselling offered by traditional caregivers, activities for the reappropriation of elements of intangible culture (e.g. Indigenous languages), reappropriation of history, talking and healing circles, healing stays in the community, etc.

Financial support is planned for prevention and intervention projects, by and for Indigenous women and girls, aimed at counteracting sexual assault and sexual exploitation. The projects supported may target prevention, awareness, education, support, the healing process, follow-up, stakeholder training, etc. Projects may address, as a priority, Indigenous women and girls who are victims of sexual violence, but also all those affected in one way or another by these problems, including stakeholders, families, communities, etc.

Area of intervention 2 – Psychosocial, medical, legal, police and correctional interventions

Objectives

- Improve the availability and diversity of services offered to persons who are victims and perpetrators of sexual and domestic violence throughout Québec and promote their integration.
- Support individuals who wish to leave prostitution.
- Improve the experience of persons who are victims of sexual and domestic violence, including children, in the justice system and standardize legal practices.
- Increase the intervention capacities of police and correctional resources in the areas of sexual and domestic violence, particularly in the evaluation of the risk of violent acts and recidivism.

Psychosocial and medical intervention component

14. Consolidate the funding of services offered in specialized resources to intervene with persons who are victims of domestic violence. **A**

A funding increase is proposed for community organizations offering specialized services in domestic violence. In recent years, these resources, in particular support centres and emergency shelters, have been in higher demand for various projects, namely rapid intervention cells, or to support professionals who wish to intervene appropriately with persons who are victims of domestic violence or their children who have been exposed to violence. The resources must also intervene with people whose situations are complex for various reasons (e.g. due to a precarious migratory status, the fact of being allophone, etc.). These interventions are often longer and require more support. Furthermore, the occupancy rates of these support centres are constantly rising, requiring more interventions, including outpatient services. Sums are planned to help consolidate and enhance the services offered in these community organizations, including Indigenous resources in urban areas and those of communities under agreement.

15. Develop new domestic violence support centres and emergency shelters.

The work of the working group on the shelter capacity of domestic violence resources, bringing together groups of shelters, domestic violence respondents from the health and social services network as well as the MSSS, has highlighted the important issue of the lack of places in certain regions of Québec. It is therefore suggested that four support centres and emergency shelters for domestic violence be developed in partnership with the community network and the SHQ, particularly in the regions of Montréal, Outaouais and Abitibi-Témiscamingue.

16. Pursue the development of the network of second stage housing. **A**

The *2018-2023 Government Action Plan on Domestic Violence* made it possible to consolidate the network of second stage housing. New second stage housing will open in the next few years. This action aims to continue funding services in more than 30 new second stage housing projects currently under way, including 2 Indigenous houses in urban areas.

17. Implement mechanisms to reduce obstacles in the development of the network of shelters for women who are victims of domestic violence, based on established priorities.

Financial support will allow for the hiring of project managers for the development of new places within the provincial groups of shelters for women who are victims of domestic violence in order to offer their expertise, support the preparation of field projects and ensure follow-up, in accordance with the provincial and regional priorities identified by the MSSS. The creation of an interdepartmental committee to weigh in on development projects will aim to ensure the optimal alignment of government stakeholders at all stages, with a view to facilitating the deployment of new places under development.

18. Conduct pilot projects that integrate services in the areas of sexual violence and domestic violence, by supporting initiatives coming from the community.

It is proposed that liaison and referral mechanisms between the partners be improved and continuums of services between them be established in order to offer better support to persons who are victims, whether or not they choose to go through the legal process. This integration of services will be implemented on the basis of existing services through actions taken at the local level, in response to national standards for the integration of services. Pilot projects are also planned for the integration of services without a physical location and an integrated service centre bringing together several specialized partners under the same roof. In addition, initiatives aimed at integrating services in an Indigenous context are included in the *Government Action Plan for the Social and Cultural Wellness of the First Nations and Inuit*.

19. Support the deployment of initiatives designed to facilitate the process for individuals who wish to leave prostitution.

Support from resource persons offering assistance in leaving prostitution will continue in the five regions covered and will be extended to four new regions of Québec. The funding to be granted will consolidate field initiatives and can be maintained. Resource persons are called upon to inform and support individuals in their efforts to leave prostitution as well as promote their social reintegration. It is with this aim that support for targeted initiatives related to housing for individuals leaving prostitution will also be considered.

20. Consolidate the funding of organizations for victims of sexual assault.

The Rebuilding Trust report demonstrates the need to consolidate services for victims of sexual assault, including female victims and assaulted men. Resources must be available to meet the needs of persons who are victims throughout their journey, regardless of their decision to initiate legal proceedings or not. This measure aims to respond to the increase in requests for help that continues following the wave of denunciations during the #MeToo movement.

21. Equip and support specialized resources in counteracting domestic violence in connection with new information and communication technologies.

It is proposed, as a pilot project, to implement activities aimed at equipping and informing organizations that provide assistance in the area of domestic violence about the problems related to information and communication technologies that can undermine victim safety. It will be a matter of supporting the development and regular updating of reference tools in addition to offering a consulting service.

22. Consolidate the funding of organizations that work with men who demonstrate violent behaviour in situations of domestic violence. A

Organizations offering services to men who demonstrate violent behaviour are seeing an increase in requests in the field. Intersectoral projects on domestic violence lead various partners to seek the collaboration of these organizations. In this context, increased funding will be allocated to men's organizations to consolidate the service offer and support the teams in place. Sums are also planned for communities under agreement to support services that meet their needs in terms of prevention and intervention with perpetrators of violence.

23. Set aside 100 rent supplements under the Programme de supplément au loyer d'urgence et de subvention aux municipalités (emergency rent supplement and municipal grant program) for low-income women who are victims of domestic violence.

This rent supplement provides access to affordable housing (equivalent to 25% of one's income) for low-income women who are victims of domestic violence. To do this, about 100 emergency rent supplements will be reserved specifically for this clientele and distributed in the housing offices according to regional needs determined by the MSSS. In addition, with regard to the 1000 other emergency rent supplements available in all regions of Québec, low-income women who are victims of domestic violence are always given priority when applying for funds, regardless of their residence and citizenship status.

24. Continue to enhance the Programme d'amélioration des maisons d'hébergement (shelter improvement program).

The Programme d'amélioration des maisons d'hébergement is intended for non-profit organizations whose mission is to temporarily house women, their children and young people aged 30 or under who are victims of domestic and family violence. Therefore, it concerns shelters that require repairs or that lack the facilities essential to the pursuit of their mission.

By continuing to enhance this program, this measure makes it possible to improve the shelters being assisted, while contributing to the implementation of the *Plan d'action spécifique pour prévenir les situations de violence conjugale à haut risque de dangerosité et accroître la sécurité des victimes 2020-2025*. Since 2019, an annual budget of \$2 million has been provided for under this program.

Legal intervention component

25. Create a support office for services for persons who are victims of criminal offences.

The *Act to assist persons who are victims of criminal offences and to facilitate their recovery* provides for the establishment of a formal complaint and follow-up process with regard to the services offered to persons who are victims of criminal offences by various departments and organizations to improve respect for their rights.

The creation of a Bureau de soutien aux services aux personnes victimes d'infractions criminelles (support office for services for persons who are victims of criminal offences, BSVV) will make it possible to steer persons who are victims of criminal offences and support them, if necessary, in their complaint process with the departments and organizations concerned. The BSSV will also be able to guide the departments and organizations concerned in moving toward better practices in terms of services for persons who are victims of criminal offences and in improving respect for their rights.

26. Increase the number of staff within the office of the Director of Criminal and Penal Prosecutions who are assigned to files involving sexual violence.

An increase to the number of staff within the DCPD assigned to cases involving sexual violence cases is proposed, in particular, so as to implement the recommendations of the Rebuilding Trust report. These recommendations suggest accompanying the victim, adding meetings before the day of the testimony at all stages of the process, continuously transmitting information to the victim, systematically soliciting the victim before the conclusion of a plea, ensuring the presence of dedicated prosecutors with victim support organizations and submitting requests for testimonial assistance before the date of the hearing.

Files relating to sexual violence require time, if only to give the victim all the attention and consideration that they deserve, thanks to specific expertise. The additional staff will ensure the quality of services offered to persons who are victims.

27. Protect persons who are victims of domestic or sexual violence through legislative changes.

Legislative amendments to the *Civil Code* are planned:

- in family matters, youth protection and any other civil matter, to allow the court to prevent an unrepresented party from carrying out the cross-examination of the victim themselves and order that a lawyer be appointed to do so
- to allow a parent, because of a situation of domestic or sexual violence committed by the other parent, to make certain decisions relating to the care and support of a child in the legal process without the consent of this other parent
- to ensure that family violence is taken into account when analyzing the best interests of the child

28. Ensure the deployment of the Programme témoin enfant et autres témoins vulnérables (program for child witnesses and other vulnerable witnesses) across Québec, including Indigenous witnesses from a perspective of cultural safety. A

The purpose of the Programme témoin enfant et autres témoins vulnérables is to provide preparation and support adapted to the situation of vulnerable witnesses in a court case related to a criminal offence. In particular, the Programme témoin enfant will become accessible to all persons who are victims of sexual and domestic violence, including adult victims. Among other things, it will make it possible to better support and accompany persons who are victims and witnesses in cases of sexual assault and sexual exploitation, and those related to domestic violence.

29. Provide all persons who are victims of sexual and domestic violence with free emergency legal advice and representation, regardless of income and in all areas of law.

A consultation service with a lawyer is offered free of charge to persons who are victims of sexual and domestic violence, regardless of their income. They can benefit from four hours of legal consultation, in all areas of law related to this violence. A toll-free telephone line (1-833-REBÂTIR) and a website (Rebatir.ca) are available to person who are victims to access this service.

Emergency representation service by permanent legal aid lawyers has also been established for persons who are victims of sexual and domestic violence, regardless of their income.

It is also expected that a partnership with Juripop will allow for the creation of a bank of specialized private practice lawyers from different areas of law trained to represent persons who are victims of sexual and domestic violence who are not eligible for legal aid or during conflicts of interest, as well as for the development of specific training for these lawyers.

30. Conduct pilot projects for courts specialized in sexual violence and domestic violence, that include taking Indigenous realities into account. A

The court specializing in the areas of sexual and domestic violence, in compliance with the rules of evidence and law, aims to rebuild the confidence of persons who are victims in the justice system and to offer them integrated and adapted psychosocial and legal services, right from the first contact with a police department.

Pilot projects are developed from a concerted perspective to both improve the experience of persons who are victims and better coordinate interventions and services. Thus, these projects propose a support model centred on the victim, and reorganizations in the courthouses to make them safer and more secure. They also provide for the offer of continued, basic and specialized training on the realities of sexual and domestic violence, intended for all the stakeholders likely to intervene in the specialized court. The Court of Québec is also responsible for seeing to the planning and legal organization of cases of sexual and domestic violence.

Police and correctional intervention component

31. Gradually implement the use of electronic tracking bracelets in cases involving domestic violence.

Québec will be able to count on a new tool aimed at preventing violent crimes in a domestic context and reducing the risk of recidivism by the perpetrator of violence: the electronic tracking bracelet. Through geolocation, the electronic tracking bracelet will detect when an offender has breached a victim's minimum distance perimeter and immediately initiate a police intervention to secure the victim.

These devices will be deployed at the provincial level over the next two years. Eventually, it is expected that Québec will have nearly 500 bracelets at its disposal. The imposition of a bracelet will be decided by a judge when determining the conditions of release or as part of a sentencing measure.

It could also be imposed when a correctional measure (temporary leave or conditional release) is granted. This decision will depend on the willingness of the victim of domestic violence to benefit from the electronic tracking bracelet program.

32. Increase the number of police assigned to matters involving domestic violence and sexual violence.

Financial support will be granted to municipal police forces and the Sûreté du Québec (SQ) in order to increase the resources available to handle cases of sexual violence. The additional funding will also allow for an increase in police capacity in the area of domestic violence in regions that have not already benefited from the additional investment of \$27 million announced by the government in spring 2021 as part of the *Actions prioritaires pour contrer la violence conjugale et les féminicides 2021-2026*. The initiatives to be funded must, in particular, allow the following objectives to be attained:

- better care and support for persons who are victims throughout the investigation process
- increased surveillance of individuals at high risk of recidivism and verification of compliance with the conditions imposed on perpetrators
- better coordination with the other networks of stakeholders, in particular in the health, justice, correctional services and community sectors

This financial support will make it possible to increase the capacity and quality of police interventions in the areas of sexual and domestic violence, and for new practices to emerge that can be exported to other police services in Québec. Ultimately, these new investments will add approximately 30 new staff members in the area of sexual violence within the SQ and municipal police forces and 11 staff members specializing in domestic violence in municipal police forces so as to better meet the needs of the population.

33. Support the initiatives of Indigenous police forces with regard to support for persons who are victims of sexual violence and the supervision of perpetrators at all stages of the intervention continuum. A

Support is planned for the development, implementation and follow-up of projects by Indigenous police forces with regard to support for persons who are victims of sexual violence and the supervision of perpetrators at all stages of the intervention continuum. The projects will be co-developed and, for this purpose, Indigenous police forces will be able to count on the guidance and support of professionals from the shared support services structure of the Quebec Association of First Nation and Inuit Police Directors.

This initiative will have tangible effects on the quality of interventions by Indigenous police forces in the area of sexual violence, while allowing them to use intervention and support strategies specific to Indigenous populations that are based on local expertise and take into account the specific realities of their communities. The involvement of the shared support structure will also reduce the administrative burden of Indigenous police forces and ensure better sharing of information, expertise and best practices among them.

34. Conduct a pilot project with certain police forces on the use of a structured domestic violence risk assessment tool such as the Ontario Domestic Assault Risk Assessment (ODARA).

It is planned to document the use of a structured (actuarial) domestic violence risk assessment tool by certain police forces in Québec and to determine whether the use of such a tool leads to better results, in terms of predicting the risk of domestic violence and homicide, than the tools traditionally used by police forces, which are based on an unweighted assessment of the various risk factors.

The in-depth analysis that will be carried out will validate the relevance of its use by front-line police teams. The search for better results with regard to assessing the risk of violent acts or recidivism in the area of domestic violence is essential, as this assessment makes it possible to identify situations of high risk of danger and deploy a safety net around persons who are victims by directing them to services adapted to their situation.

35. Ensure the periodic updating of police practice in the area of domestic violence, including its appendices, and promote it to police forces.

By reviewing police practice in the area of domestic violence and its appendices every three years, the MSP will ensure that up-to-date guiding principles and orientations for police intervention in domestic violence are made available to all police forces. This periodic review will also allow for the development of police practices based on the recommendations of the Bureau du coroner and the observations made by the MSP's Direction de la vérification interne, des enquêtes et de l'inspection as part of its inspections of police forces. The next review of police practice in domestic violence will, in particular, make it possible to once again address certain recommendations of the Rebuilding Trust report, such as those in connection with the process of recovering the victim's personal effects from their home and cross-complaints, among others.

Since the review of a police practice is conducted by a committee of experts from organizations with relevant expertise in police intervention in domestic violence, this action promotes consultation and mobilization between key stakeholders in the area of domestic violence. It is also likely to directly impact the quality of police interventions with persons who are victims and offenders.

Area of intervention 3 – Development of knowledge, training and sharing of expertise

Objectives

- Ensure a coherent and continuous training offer for stakeholders from various sectors in the areas of sexual and domestic violence.
- Analyze certain current prevention and intervention practices in sexual and domestic violence with a view to proposing avenues for improvement.
- Support the development and dissemination of knowledge and data on sexual and domestic violence.
- Create opportunities for the sharing of expertise between different sectors concerned with sexual and domestic violence.

36. Offer coherent and complementary bodies of work for training with regard to sexual and domestic violence that include addressing these forms of violence in Indigenous contexts and the realities faced by certain groups of people. A

The need for training for various stakeholders involved in the journey of persons who are victims is built into the foundation of the majority of the observations of the Rebuilding Trust report. It has been identified that the creation of flexible guidelines for procedures, vocabulary, definitions and content is essential. These guidelines will ensure consistency in the development and deployment of government training initiatives on domestic and sexual violence. The SCF assumes a coordination role, in collaboration with the MJQ in the context of the specialized court, in the review of existing training, the development of guidelines and the follow-up on the training offered.

37. Update the knowledge of police forces on sexual and domestic violence.

Initially, it is planned to develop training for the exclusive use of police forces, in the form of a video, on the use of the checklist “Prévenir l’homicide du partenaire intime” (preventing intimate partner homicide). The training video and the facilitation guide to be produced will ensure the better use of the tool and greater uniformity in its application by all police officers in Québec. A better understanding of the dynamics of the domestic violence in question will also allow the police to adapt their interventions and provide referrals to appropriate support services for persons who are victims and perpetrators of domestic violence according to the level of risk observed.

Secondly, two days for updating knowledge on domestic and intrafamily violence and one day for updating knowledge on sexual violence will be organized in collaboration with the École nationale de police du Québec. This is an exceptional forum to showcase the innovative actions of certain police forces for the benefit of the entire police community. In addition, by engaging with researchers and community organizations, this initiative will provide an opportunity for networking and exchanges between participants, which is essential for sharing best practices and facilitating intersectoral co-operation.

38. Support and equip stakeholders in the health and social services network working with senior victims of sexual and domestic violence.

The training modules in the fight against the mistreatment of seniors that were developed by the MSSS to support stakeholders in the health and social services network in cases of mistreatment will be enhanced. The connection will be made with existing training on sexual assault and domestic violence. A section specifically covering sexual abuse could also be created to help identify and intervene more effectively in cases of sexual violence against seniors. The MIFI will collaborate in the work as an expert for the training elements relating to intercultural specificities.

39. Train school staff to intervene when students disclose sexual assault or problematic sexualized behaviours.

It is a matter of promoting training already available for school staff, offered by the Centre d’expertise Marie-Vincent in the context of sexuality education. This training aims to develop the level of comfort with which elementary school staff can intervene in situations of problematic sexualized behaviours and the reporting of sexual assault by students. Complementary training intended exclusively for professionals who work with students has also been developed. These training sessions will help to equip school staff to be comfortable in intervening in such situations and to expand the safety net around students in the school.

40. Develop expertise on domestic violence and exposure to domestic violence for youth protection workers and increase consultation on the subject.

For domestic violence to be better detected, recognized and taken into account in the files reported or followed up on in youth protection, the content on the subject will be enhanced in the training to be offered to stakeholders. In fact, references to and connections with current initiatives could be made, such as rapid intervention cells, integration of services and the specialized court. The consolidation of the consultation mechanisms between the Direction de la protection de la jeunesse (DPJ) and the organizations involved in this area is also planned, by ensuring that the representatives of the DPJ in these situations actively representing and making decisions. These actions are in line with the those taken to implement the recommendations of the Laurent Commission and with the legislative amendments regarding exposure to domestic violence made to the *Youth Protection Act*.

41. Establish online training for the staff of designated centres on medico-social intervention for persons who are victims of sexual assault.

In Québec, there are more than 80 designated centres (DC), generally hospitals, equipped to receive persons who are victims of sexual assault. The staff of DCs work the front line with persons who are victims of sexual assault. Given the delicate nature of this intervention and the considerable number of people to be trained regularly, it is proposed to develop provincial training that can be easily accessed at all times to ensure the sustainability of the expertise. This training is intended to complement the reference documents and other tools (medico-social intervention guide, medico-social and medico-legal kit forms, etc.) the update of which was undertaken as part of the Strategy to Prevent and Counteract Sexual Violence.

42. Form a working committee to analyze the accessibility of services for persons who are victims of domestic violence who have disabilities and propose ways to improve.

The *2018-2023 Government Action Plan on Domestic Violence* enabled support centres and emergency shelters that wished to adapt their services to the realities of people living in vulnerable situations, particularly for women or their children living with disabilities.

This committee aims to analyze the adaptations made and then propose actions for continuing to improve the response to their needs, for example, with regard to home support or adapted transportation.

43. Mandate the Table de concertation nationale sur l'intervention policière en violence conjugale (national table on police intervention in domestic violence) to carry out work to monitor and follow up on the conditions imposed by police officers and/or the court in cases of sexual and domestic violence.

A working subcommittee stemming from the Table de concertation nationale sur l'intervention policière en violence conjugale will be set up and will bring together all the stakeholders involved in monitoring and following up on the conditions imposed in cases of sexual and domestic violence. In particular, this initiative aims to standardize the interventions made by all the relevant stakeholders with persons who are victims and perpetrators following a breach of condition at the provincial level and, thus, to better ensure the safety of victims and prevent multiple recidivism.

Tools and training aimed at clarifying the roles and responsibilities of police teams and the preferred best practices with regard to the processing of breach of condition files will also be produced and distributed.

44. Create an interdepartmental working committee to assess the possibility of implementing legislative provisions aimed at achieving the objectives of *Clare's Law*.⁵⁶

It involves creating an interdepartmental working committee that will analyze the relevance and feasibility of including provisions in the Québec legislative corpus authorizing police services to disclose, proactively or on request, the personal information of a third party to their intimate partner to help this partner determine if they are at risk of domestic violence. A report presenting the committee's conclusions will be submitted to the authorities concerned at the end of the work.

Clare's Law could be an additional tool in the prevention of domestic violence in Québec. Nevertheless, its application is likely to pose challenges of an operational nature and with regard to the protection of personal information that must be rigorously analyzed to ensure informed decision-making by government authorities.

⁵⁶ *Clare's Law* authorizes police departments to release information about the abuse history of a spouse or former spouse of a person whose safety may be at risk. This law was adopted in the United Kingdom in response to the death of Clare Wood, murdered in 2009 by her ex-husband. In recent years, some Canadian provinces have also adopted it.

45. Continue the activities of the Domestic Violence Death Review Committee.

Established in 2018, the Domestic Violence Death Review Committee is a multidisciplinary committee composed of representatives from some 20 groups, institutions and government departments, whose mandate is, among other things, to identify the main findings and systemic issues related to such deaths, based on the analysis of the coroners' investigation files. After acquiring solid analytical tools, the committee published its first annual report in December 2020. It also submitted a brief to the parliamentary committee in January 2022, during the detailed study of Bill 15, *An Act to amend the Youth Protection Act and other legislative provisions*. It is now necessary to ensure that this work continues and to improve the resources allocated for the continuation of the Committee's activities.

The Committee's work has had a significant impact on the prevention of domestic homicides. The study of the circumstances in which certain homicides occurred in the past provides important information on the actions to be implemented before crisis situations arise to prevent their recurrence. By highlighting the shortcomings of the intervention processes in place and by suggesting courses of action to remedy them, this work contributes to better protect persons who are victims of this form of violence in Québec.

46. Form a working committee mandated to study how cases of sexual assault and sexual harassment are handled in the workplace.

Noting the complexity and multiplicity of recourse with regard to sexual harassment in the workplace, the Ministère du Travail will set up a working group responsible for carrying out a comprehensive evaluation of the consistency and effectiveness of the recourses available to a victim of sexual assault or sexual harassment in the workplace, and studying the processing of these assaults occurring in a work context.

47. Design and computerize a clinical-administrative data collection sheet on the services offered in designated centres for medico-social intervention with persons who are victims of sexual assault.

This tool will collect information and draw up a portrait (provincial, regional or by designated centre) of the clientele of the designated centres; the types of assaults experienced; the tie to the perpetrator; the location of assaults; the tests, care and services offered; follow-ups carried out; and best practices, and, if necessary, make adjustments or issue guidelines to better serve this clientele that requires specialized care. Access to information is the first step toward improving knowledge and services to the population. Design work on the sheet was started as part of the Strategy to Prevent and Counteract Sexual Violence.

48. Identify the procedures for setting up an anonymous, confidential provincial help and referral line for people who have committed or are at risk of committing sexual assault or domestic violence.

The Rebuilding Trust report suggests the establishment of a provincial help and referral line for people who have committed or are at risk of committing:

- A. sexual assault
- B. domestic violence

Such a resource could facilitate the journey of perpetrators of violence and minimize obstacles in accessing services. The terms of implementation of these lines will be analyzed and determined jointly with the partners concerned according to the specificities of each issue.

49. Draw up a portrait of the services to be implemented by region or by local territory with regard to prevention among children and intervention with persons who are victims and perpetrators of sexual assault.

Following the #MeToo movement, recurring credits were granted for the consolidation of existing organizations that work in prevention among children and intervention with persons who are victims and perpetrators of sexual assault. However, these organizations cannot cover an entire region, given the size of the territory, and are not present in certain regions. This portrait, developed in collaboration with the public network and the community network, will make it possible to better define the issues, priorities and methods necessary for the development of new services.

50. Produce and disseminate specific statistical portraits based on police data in the areas of sexual violence and violence committed in domestic contexts.

Statistical analyses of sexual offences and offences against the person committed in a domestic context recorded by Québec police forces will be released annually. They will make it possible to measure their evolution and present different portraits of their characteristics, in particular how they are spread out among the administrative regions. The profile of persons who are victims and alleged perpetrators, for example according to gender, age and nature of the relationship, will also be presented. These analyses will be published on the MSP website no later than June 30 of each year.

The MSP has been compiling and disseminating such statistics for several years, in various forms. However, it intends to optimize its methods by opting for more flexible dissemination methods in order to maximize the accessibility of this statistical data.

Work will also be undertaken to assess the feasibility of including in this data publications from the DCP, the MJQ, the Direction générale des services correctionnels and the Commission québécoise des libérations conditionnelles.

51. Analyze intimate partner violence experienced by women with disabilities.

This action consists of establishing a statistical portrait of violence between intimate partners experienced by women with disabilities aged 15 and over. Using data from an existing population survey, the *Survey of Safety in Public and Private Spaces* (Statistics Canada 2019), the prevalence of violence between intimate partners in Québec within this population will be analyzed, as will certain characteristics of the violence experienced. The portrait will also provide statistics allowing for a comparison of the situations experienced by women with a disability and by those without a disability.

52. Study the recourse to restorative justice by persons who are victims or perpetrators of domestic violence.

In continuity with the *Les personnes victimes d'agressions sexuelles ou de violence conjugale face au système de justice pénale* (persons who are victims of sexual assault or domestic violence and the criminal justice system) study (CSF 2020), the CSF will conduct research on the experience of persons who are victims or perpetrators of domestic violence who make use restorative justice programs. The study will identify the benefits, risks, limits and conditions associated with this type of approach.

53. Conduct a second population survey aimed at documenting the phenomenon of domestic violence in Québec.

The *2018-2023 Government Action Plan on Domestic Violence* was the opportunity to conduct, through the ISQ, the first population survey aimed at measuring the phenomenon of violence between intimate partners in Québec. To assess the evolution of the problem over time, particularly in the aftermath of a global pandemic, and to collect data that is still current, a second version of this survey is planned, six years after the first was held.

54. Advance knowledge of sexual violence experienced by female tenants and boarders.

A study on the sexual violence experienced by female tenants and boarders will be conducted to demystify the problem, assess its prevalence and identify the various elements that define it (players involved, type of violence suffered, contexts in which it occurs, etc.). The dissemination of knowledge

will involve, in particular, an information and awareness-raising campaign aimed at the housing and accommodations sector as well as the general population.

55. Establish a reference framework for supervising intervention practices with male perpetrators of domestic violence, focusing on accountability.

The study of best practices and programs that intervene with men who demonstrate violent behaviour and that focus on accountability will allow for the development of a related reference framework. The evaluation or monitoring processes for reporting on the effectiveness of these programs will also be analyzed. This work will be carried out in collaboration with organizations specializing in intervention with perpetrators of domestic violence.

56. Work with Indigenous partners to promote the sharing of expertise in intervention with men who demonstrate violent behaviour in the context of domestic and family violence within organizations wishing to develop these specific services. A

The presence of specific services to help men who commit domestic and family violence is not equal across all regions of Québec. Collaborative work between partners from the health and social services network and organizations in Nunavik, the health region of the Cree Territory of James Bay and the Naskapi community will be carried out to promote the development of specific expertise in the field of intervention with men who demonstrate violent behaviour and to assess the needs in this area while respecting the autonomy of these territories.

57. Promote collaboration among organizations that help persons who are victims of sexual and domestic violence and organizations that support groups of people living in contexts of vulnerability to these forms of violence.

The creation of opportunities for discussion between organizations helping persons who are victims (of sexual assault, sexual exploitation and domestic violence) and those who intervene with various population groups is proposed, illustrating the diversity of realities in the face of these forms of violence.

These events, which could take the form of symposiums or forums, would allow the organizations to become more familiar with each other, to establish connections and to discuss the realities experienced in their different environments. At least three events are planned for the duration of the Strategy.

58. Collaborate with the Regroupement des intervenants en matière d'agression sexuelle (sexual assault stakeholders group, RIMAS) to find and implement lasting solutions to attract and retain staff working with sexual perpetrators.

RIMAS represents various stakeholders from all areas involved in the processes of assessing and intervening with minor and adult perpetrators of sexual offences in Québec. The issue of human resources of particular importance in this sector, given the scarcity of specialized resources for this problem. This measure focuses on joint efforts to allow for the attraction and retention of staff and, consequently, more services as well as reduced waiting lists and pressure for the staff involved.

Governance, follow-up and evaluation

Coordination

The Rebuilding Trust report highlights the importance of strengthening the connections between the initiatives implemented by government departments and organizations in the areas of sexual and domestic violence. Increased coordination of government action will be facilitated by consolidating and expanding the role of the SCF as coordinator of government action on sexual and domestic violence. Its role and responsibilities will be intensified as part of the implementation of the Integrated Strategy to Counteract Violence, in keeping with the vision of the Rebuilding Trust report. The creation of the Direction de la lutte à la violence sexuelle et à la violence conjugale (department for the fight against sexual and domestic violence) within the SCF is a first step aimed at formalizing and strengthening this role. This new department is responsible for ensuring the implementation and consistency of government commitments in the areas of sexual violence, domestic violence and violence against women in general. In particular, it will play a pivotal role at the interdepartmental level and with regard to the connections to be pursued with partners in the field, such as groups of shelters or organizations working with persons who are victims.

The coordination role of the SCF will also continue through the various forums for exchange between partners that it facilitates. The SCF heads the Comité de travail sur la violence conjugale (working committee on domestic violence), bringing together, in a place for mutual sharing at the provincial level, non-governmental organizations, representatives of the research community as well as members of the government involved in counteracting domestic violence.

Note also the establishment in 2021 by certain departments and organizations of partnership consultation structures on violence related to the implementation of targeted actions, which also complement the work of the Comité de travail en violence conjugale, namely:

- the Table nationale sur l'intervention policière en violence conjugale (national roundtable on police intervention in domestic violence)

Consultation

Interdepartmental

The Integrated Strategy to Counteract Violence brings together 18 government departments and organizations that have contributed, by means of their mission and their respective expertise, to its development. The departments and organizations identified as being responsible for implementing actions ensure the fulfilment and follow-up of their commitments. For their part, the departments and organizations registered as collaborators solicit their expertise to contribute to the realization of these actions.

In order to ensure effective, transparent government leadership that promotes the sharing of expertise, the SCF will once again handle the coordination of government consultation mechanisms, including interdepartmental committees. This governance structure includes three interdepartmental committees on sexual and domestic violence, more specifically one committee at the associate deputy minister or assistant deputy minister level, one at the director level and one at the professional level. These three committees include people responsible for Indigenous issues in the government departments and organizations concerned.

The Integrated Strategy to Counteract Violence proposes the implementation of innovative structuring initiatives for which interdepartmental connections are essential. It is in this vein that specific interdepartmental work is also being carried out, in particular by the MJQ with regard to establishing a specialized court and jointly with the MSSS for the integration of services in areas of sexual and domestic violence.

Partnership

Meeting the Strategy's objectives also depends on the collaboration of various public, parapublic and community partners. In addition to supporting the government during the development of the Integrated Strategy to Counteract Violence, the partners will be involved during its implementation, whether to carry out initiatives in the field, or to share their expertise and participate in reflection activities with various authorities.

In this sense, this Strategy also makes it possible to establish new consultation mechanisms between government departments and organizations and community partners, namely:

- A committee composed of the SCF, other government partners, in particular the MSSS, the three provincial groups of women's shelters, SOS violence conjugale and *À cœur d'hommes*, proposing frequent meetings and a flexible mode of operation, which aims to take stock of housing issues and other elements relating to actions in the area of domestic violence. This select committee, under the coordination of the SCF and the function of which was tested during the context of the pandemic, is complementary to the Comité de travail sur la violence conjugale.

Implementation follow-up and evaluation

The SCF will ensure the implementation of an effective and transparent monitoring and evaluation process for the Strategy, with a view to continuous improvement. This Strategy will therefore be accompanied by an evaluation framework that will meet the requirements formulated by the Conseil du trésor in this regard. This framework will allow for the implementation of the Strategy's actions to be monitored and, ultimately, the results to be measured. It will also make it possible to assess the governance of the strategy. As departments and organizations are responsible for the actions listed therein, they guarantee the accuracy of the information provided. To better promote the government's achievements in the areas of sexual and domestic violence, and to encourage the dissemination of information between the government and civil society, a document reporting on the implementation of the Strategy's actions will also be published annually. This Strategy can be enhanced through the implementation of new actions, which would be integrated into the various reports to be produced.

Some initiatives may be the subject of specific evaluations. These mechanisms will allow practices to be updated, if necessary, and will promote their deployment and implementation. For this purpose, evaluation mandates will be carried out, in particular as part of the pilot projects for a court specializing in the areas of sexual and domestic violence, the projects of resource persons with regard to leaving prostitution and the projects of rapid intervention cells to ensure a safety net around the persons who are victims of domestic violence and the people around them. The government departments and organizations concerned, as the parties responsible for the actions, see to their evaluation.

The consolidation and formalization of the SCF's role in coordinating government action on sexual and domestic violence partially responds to recommendations 189 and 190 of the Rebuilding Trust report.

New or Enhanced Actions

New (N) or enhanced (E) actions to fight gender-based violence

On November 6, 2023, the Government of Canada and the Government of Québec, represented by the Minister Responsible for the Status of Women, signed the *Canada–Québec Agreement to Address Gender-based Violence* (“the Agreement”), which will provide \$97.3 million over four years and boost Québec’s investment under the Integrated Strategy to Counteract Violence.

Consequently, 13 actions have been added, that is 9 completely new actions and 4 enhanced existing actions. Of these, one addresses sexual violence, two address domestic violence, and ten address both problems together. In addition, 5 of the 13 actions apply, in part or in whole, to the Indigenous Peoples. The actions included in this addition to the Integrated Strategy to Counteract Violence fall under the responsibility of four government departments and organizations, namely Ministère de la Justice du Québec (MJQ), Ministère de la Sécurité publique (MSP), Ministère de la Santé et des Services sociaux (MSSS), and Secrétariat à la condition féminine (SCF).

These new actions will fully or partially address three recommendations set out in the *Rebuilding Trust report* that had not been covered to date:

- 114. Establish victim services offices within the Direction des services correctionnels du Québec [Québec correctional services division] and the Commission des libérations conditionnelles du Québec [parole board];
- 118. Improve the Written Submissions form, to avoid duplicating the information already provided in the Witness Statement filed in court and allow victims to add new elements that may have an impact on the evaluation of the danger posed by the incarcerated individual, the development of the offender’s correctional intervention plan and the decisions relating to the offender’s conditional release;
- 134. Ensure that there is a sufficient number of workers to supervise visits or exchanges of custody¹ and provide them with specialized training in matters of domestic violence.

These three additional recommendations bring to 169 the number of *Rebuilding Trust* recommendations that have been addressed fully or partially through government action. The 13 actions that will enhance the Integrated Strategy to Counteract Violence will also help step up the government’s response to 48 prior recommendations and better address the needs of victims of sexual and domestic violence in Québec.

Monitoring of the implementation of these new and enhanced actions will be carried out under the existing framework for the Integrated Strategy to Counteract Violence.

C. **Support the development of concrete initiatives by community organizations to better meet the needs of victims and perpetrators of sexual or domestic violence**

Following a Québec-wide call for interest, financial assistance will be provided to various initiatives proposed by community organizations that support victims or perpetrators of sexual and domestic violence. These initiatives must align with one of the areas of intervention of the Integrated Strategy to Counteract Violence: prevention and detection; psychosocial intervention; and development of knowledge, training, and sharing of expertise.²

Possible objectives of these initiatives could include adapting services for people in situations of vulnerability, developing pilot projects for services aimed at populations that are underserved or not served at all, and developing knowledge on emerging realities or best practices to address the needs of all victims or perpetrators of violence.

Additional funding will be earmarked to support activities designed to ensure the coordination of the integration of services in every judicial district where the court specialized in handling cases of sexual and domestic violence operates. Service integration coordinators will be in charge of implementing the service integration model and national standards, for example, by fostering joint action and local partnerships, and coordinating the work of the local committee. In addition, a team will be set up at Centre physique d'intégration de services de Québec (SIVA [integrated services centre]) including nurses and social workers. An evaluation will also be carried out to assess the implementation and effects of the integration of services related to sexual and domestic violence, both virtual and at Centre physique de services intégrés de Québec.

G. Conduct pilot projects for courts specialized in sexual violence and domestic violence, that include taking Indigenous realities into account

Enhanced funding for Action 30 will allow for the addition of and training for social-legal liaison officers, as well as improvements for the support dog service and the expansion of the specialized court network, in cooperation with Crime Victims Assistance Centres (CAVAC). New funding will also be earmarked for training activities for all stakeholders who may be involved in the specialized court. Lastly, funding will go to support a portion of the costs associated with the need for representation of victims of domestic violence by the Commission des services juridiques [legal services board], regardless of their income, in situations where a safeguard order is required for their safety and that of their children.

H. Identify the best means of reinforcing the safety of victims of domestic violence, for example, by assessing the relevance of implementing a “serious-danger device” program in Québec, and launch a pilot project to this end

Despite the various legal and psychosocial measures in place, many victims of domestic and sexual violence find themselves in highly dangerous situations. The aim of this action is to improve the safety of victims by adding a protective measure specifically for situations of grave danger. One of the many measures that will be analyzed is a “serious-danger device” program that is already in use in France and Spain, as well as other physical and technological protection measures to prevent further aggression. Based on the findings of this analysis, a pilot project will be set up to introduce the best solution(s).

I. Enhance communications and support measures for victims at the sentencing stage

This action entails a number of different components. First, a Victim Support Office will be created at the Commission québécoise des libérations conditionnelles (CQLC [Québec's parole board]) as well as a Centralized Victim Services Office within Québec's correctional services. A secure exchange platform will also be developed and shared by the two organizations, to promote the use of popular means of communication to contact victims. Information tools and processes for victims will also be reviewed and improved, including the Written Submissions form. In addition, in order to promote the full exercise of victims' rights at the sentencing stage, victim support network workers will be advised of CQLC's mandates and activities. Lastly, a continuing education plan for sexual and domestic violence will be developed and put in place for CQLC members.

J. Provide program funding in secure and open custody settings for correctional clients with a history of sexual and domestic violence

To reduce the risk of reoffending and promote the safety of victims, programs will be enhanced for correctional clients in secure and open custody settings who have a history of sexual and domestic violence. For instance, a housing pilot project for those on conditional release will be set up at two Community-based Residential Centres (CRC), one in Québec City and the other in Montréal, for alleged perpetrators of domestic violence.

K. Introduce a monitoring service for persons accused of domestic violence at the conditional release stage

A monitoring service will be set up for alleged perpetrators of intimate violence who have undergone an assessment by the Service d'évaluation des personnes accusées en matière de violence conjugale at the conditional release stage, and who have been released by the court. Monitoring will be conducted at the specific request of a judge by way of a condition included in their court order. This service will enable authorities to verify compliance with the legal conditions set by the court for provisional release and, where warranted, refer the accused to community resources.

L. Enhance the provincial collaborative team for offences that threaten the safety or integrity of First Nations and Inuit people (family and sexual violence), to promote culturally safe prevention and police intervention strategies



Prevention and intervention practices in the area of domestic, family, and sexual violence will be identified and analyzed in order to propose prevention and intervention tools that are culturally adapted to the realities of the First Nations and Inuit. A provincial community of practice will be developed to help disseminate a range of tools concerning domestic, family, and sexual violence as it affects Indigenous Peoples, and will provide opportunities for sharing between Indigenous and non-Indigenous police forces.

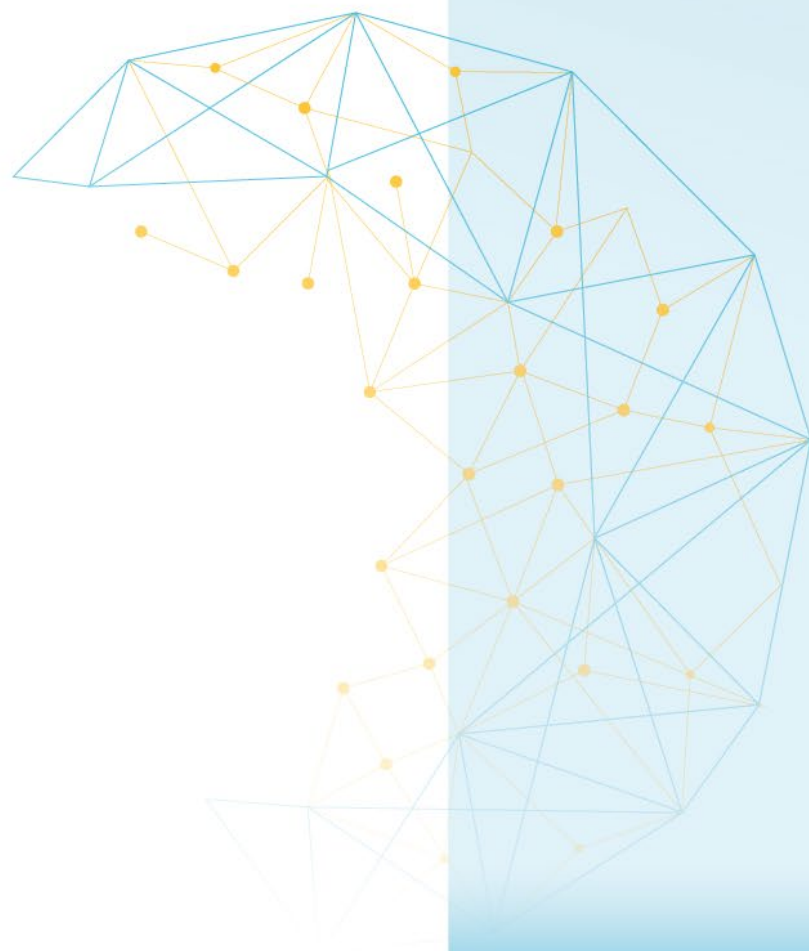


The training in sexual violence intervention with children and teens, currently developed and offered by Centre Marie-Vincent, will be adapted in collaboration with Indigenous communities.
