## \$4,750 DAMAGES.

This is the Jury's Award to Motorman Kerr.

## STREET RAILWAY RESPONSIBLE.

Case Continued Till Wednesday for Judgment.

When Court opened on Saturday afternoon last, H. R. Fraser, Esq., addressed the jury on behalf of the plaintiff in an able manner, stating the plaintiff's pretences, which, he argued, had been fully sustained by the evidence adduced.

H. B. Brown, Esq., Q.C., counsel for defendants, then rose, and called the attention of the Court to the fact that plaintiff had made no answer to the 4th and 5th paragraphs of the plea, and asked that the Court instruct the jury that all pleas not answered were held to be admitted.

The Hon. Mr. Justice White then addressed the jury in a clear and concise manner. He first referred to the respective duties of the Judge and jury, reading the law regarding their functions, which was to the effect that the Judge determined all questions of law and that the jury were to be guided by the Judge on questions of fact, while the jury were the sole judges of questions of fact. The learned Judge then went on to explain that under the English common law, it was undoubtedly true, that where a person, who was suing another for damages, was proved to have by his own negligence or imprudence contributed to the accident, such contributory negligence was a bar to his recovering damages, and his action would be dismissed. The American law was a modification of the English common law, but the Court now sitting was not to be governed by either English or American law, but by the law of this province as it existed under our own Civil Code. The Court stated that most of the authorities submitted by the defendants were English or American authorities.

The Court instructed the Jury, in the law of this province, by which they were to be guided as follows: Should they find that the accident in question was the result of the negligence, imprudence, or want of care on the part of the plaintiff solely, his action must be dismissed. On the other hand, should they decide that the accident was the result of fault, imprudence, or negligence on the part of the Company solely, the plaintiff was entitled to recover. There was also a third position, which it was necessary to refer to, and in regard to which His Honor stated the law to be, that if they came to the decision that both were in fault, i. e., if the defendants were in fault in having the extra car at the time and place of the accident, on the single track line, running there on the regular time of plaintiff's car, and that it being there was a proximate cause of the accident and if plaintiff was also in fault, in not having used ordinary care to stop his car in time to avoid the collision, the plaintiff's neglect even then was not a total bar to his action; but such neglect on his part should be taken into consideration by the jury, in estimating the amount of damages for which defendants should be held responsible.

The Court did not refer at any length to the evidence, inasmuch as the Jury were the sole judges of all questions of fact. After thanking them for the able manner in which they had performed their duties, he allowed them to retire to their jury room for deliberation.

After being out of Court about three quarters of an hour, the Jury returned with their verdict, in the form of nine answers to nine questions of fact, which had previously been assigned by the Court.

The questions and answers are as follows:—  
1st. On the 17th of July last, 1898, was the plaintiff in the employ of defendants as a motorman, and as such charged with the duty of moving one of their cars on their railway line between Lennoxville and Sherbrooke?  
Answer.—Yes. Unanimously.

2nd. On said date, on defendants' railway line, at a point at or near the trestle (so called) on the highway between Lennoxville and Sherbrooke within the limits of the said City of Sherbrooke, did a collision take place between the car on which plaintiff was employed in moving it from Lennoxville to Sherbrooke, and a second car belonging to the defendants?  
Answer.—Yes. Unanimously.

3rd. Was the said car, on which plaintiff was employed, at the time of said collision being controlled by him in a careful and prudent manner and being moved at an ordinary rate of speed on the regular schedule time, established by defendants for the running thereof, in accordance with their service between Lennoxville and Sherbrooke?  
Answer.—Yes. Unanimously.

4th. Was the second car, at the time and place of said collision, then and there, wrongly or imprudently on the said defendants' said railway line, in charge of one of said defendants' servants?  
Answer.—Yes. Unanimously.

5th. At the time and place of said collision was the said second car being moved in the direction towards the car on which plaintiff was employed, or had it been reversed, and was it moving back towards Sherbrooke?  
Answer.—We unanimously agree that the second car was moving towards the car on which plaintiff was employed at the time of the collision.

6th. Shortly previous to the said collision had the said second car reached a point, where it could be seen by the plaintiff, and could he with ordinary care have stopped the car on which he was employed so as to have avoided said collision?  
Answer.—No. Unanimously.

7th. Did the plaintiff in consequence of said collision receive serious bodily injuries by the breaking of both his legs in several places, and also internal injuries, and is said plaintiff permanently injured as a result thereof?  
Answer.—Yes. Unanimously.

8th. Has the plaintiff sustained damages from said injuries, and if so to what amount?  
Answer.—Yes. He suffered damages, and we unanimously agree the defendants should be condemned to pay to plaintiff the sum of \$4,750.

9th. Were the said injuries caused by negligence or imprudence or want of care on the part of the said defendants, or were they caused by negligence or want of care on the part of the plaintiff?  
Answer.—We unanimously agree that the said injuries were caused by the negligence and imprudence and want of care on the part of the defendants.

In their answer to the 8th question the jury had stated the amount of damages to be \$4,750 with costs, but the Court ordered the words "with costs" to be struck from the answer, inasmuch as the jury had no right to adjudicate upon the costs, which were entirely in the discretion of the Judge. H. B. Brown, Q.C., stated that the defendants took exception to the Judge's charge in regard to the law. The case was continued till Wednesday next for judgment on a motion presented by Mr. Fraser to be allowed to file an answer to the 4th and 5th paragraphs of the defendants' plea, upon the ground that it was a matter of inadvertence that these paragraphs had not been answered.

With the thanks of the Court the jury were then discharged.

## THE BIG HOTEL FIRE

### Efforts Made to Recover Bodies From the Ruins.

#### 16 Dead and 50 Still Missing—Chimneys Blown Up With Dynamite.

New York, March 20.—In a drizzling rain, from midnight on Saturday, more than 200 men continued to work among the debris and smouldering ruins of the Windsor Hotel, searching for the bodies of those who perished in the flames, and to recover any valuables that might have escaped the ravages of the fire. The efforts of the searchers were futile, however, as the ruins were too hot to permit them to make much progress, and the smoke arising from the burning material was rendered more dangerous by the dampness of the atmosphere. At intervals during the night flames burst forth from the burning embers, and drove back the workmen. When daybreak came no bodies had been recovered. Early church-goers stopped on their way to gaze at the scene of devastation.

Work was begun yesterday morning to demolish the fragmentary portions of walls on the east and north sides of the burning building, and later the number of workers was reinforced, and the work of removing the rubbish pushed as vigorously as was practicable.

The chimney, 85 feet high, standing on the 46th street side of the ruins, near Fifth avenue, was blown up at noon today. Thirty pounds of dynamite were placed under the base of this chimney, and electricity was used to explode it.

The fire lines are more rigidly kept today than ever before, and all persons without a special permit are kept out side. During the day workmen were engaged in picking up pieces of the six-story wall that is standing on the 47th street side of the hotel site, in order to make the search in the ruins safe. The second 85-foot chimney was dynamited shortly after three o'clock this afternoon. The explosion wrecked a number of plate glass windows and doors in the vicinity.

Daniel Sweeney, the emergency wrecker of the building department, and three men had a narrow escape from injury and possibly death about five o'clock. The four men were on top of the six-story wall, which was still standing on the 47th street corner of the hotel, tearing it down. A stiff north wind blew up rather suddenly, and Sweeney felt the wall trembling beneath him. Sweeney cried out a warning and the men hurried from their dangerous perch. They were just outside the danger zone when a great section of the wall, 30 feet or more square and including that portion where they had been working, went down with a roar. A portion of it fell on the roof of the house back of the hotel, wrecking the roof. The house had been emptied by order of the building department and nobody was injured.

The death list now numbers 16, with 50 missing.

GAVE THE ALARM IN VAIN.  
New York, March 20.—David S. Dudley, an intelligent colored man; who had been Miss Gould's chef for a number of years, blames the clerk and cashier of the hotel for the Windsor Hotel fire. Dudley says that he notified these men that the hotel was on fire 15 minutes before the fire was discovered by anybody else, so far as he could see, and that not the slightest heed was paid to the warning. Dudley's story is corroborated by Fred Johnson, a colored cornet player, who was with him at the time. Dudley said:

"Johnson and I left Miss Gould's at about ten minutes of 3. We went diagonally across the street and were half-way down the block when I looked up and saw smoke coming through the roof in the centre of the hotel, just beneath the flagpole.

"I turned to Johnson and said: 'There's a fire in that hotel. We'd better go over and tell them about it.' We crossed the street, and I ran into the hotel and up to the desk. 'Your hotel is on fire!' I said to the clerk. He told me to go to the devil and that I was crazy. I went over to the cashier and said: 'The hotel is on fire!' You had better send in an alarm or send some men upstairs to put it out.

"The cashier never as much as looked up from the book in which he was writing. I leaned over him and touched him on the shoulder. 'Your hotel is on fire!' I said. 'Can't you hear me?'

"The clerk looked up at me for a moment, then resumed his writing, without a word. I became very much excited and ran over to a porter, who was standing about 20 feet away. He was in uniform. I said to him: 'For God's sake, do something, because the hotel is on fire!'

"He said: 'You are crazy man,' but a moment later he made up his mind that I wasn't crazy, for the elevator around the corner came down the shaft with a crash. The elevator man was shouting 'Fire!' at the top of his lungs."

#### I. C. R. Train Stalled on the Drummond Line.

The Q. C. R. line is open as far as Beauce Junction, but from that point to Quebec, as well as G.T.R. and other lines in the vicinity of Quebec, the storm is so severe that no trains are moving, and the through trains have been cancelled.

Montreal, March 20.—(Special)—The Intercolonial Railway train which left here for Halifax last night at 7.05 is stalled at Forestdale on the Drummond section of the road, just 103 miles from this city. The line is badly blocked and storm is so fierce in the country that little can be done to clear the track until it abates. The train has a large crowd of passengers, but it is a well victualled in a dining car attached.

MAY BE ONE OF THE HEIRS.

Dr. Norreys Worthington is suffering from blood poisoning in the hand, but his many friends will be pleased to learn that he is comfortable today, and serious results are not anticipated. It appears that on Monday last he operated on a child at the hospital. During the operation he chanced to prick the forefinger of his left hand with a safety pin. It was a very slight wound and not noticeable at the time. He proceeded with the operation.

On Friday last, he felt a pain in the finger and it began to swell. Dr. Smith was called and lanced it. On Sunday morning the swelling began to extend rapidly and spread over the hand. Dr. Smith opened the hand in several places and since then the doctor has been very comfortable. Dr. Armstrong came out from Montreal last night and returned this morning. He found that everything possible was being done. While it is a case of blood-poisoning, it is believed that the action which has already been taken, will bring about an early recovery.

MR. CHICOYNE'S CONCILIATION BILL.

The Richmond Guardian has the following to say regarding Mr. Chicoyne's conciliation bill:

"Mr. Chicoyne's bill for the establishment of courts of conciliation passed the Legislative Council with only one slight amendment; it was not 'mutilated' as the daily papers alleged. It is now law, and we hope and believe it will work satisfactorily. It throws considerable gratuitous work on the persons designated as the conciliators, but we presume there will be men found everywhere who will do that work and thereby protect the people from the horrors of our system of law costs. If it does the work intended Mr. Chicoyne will go down in history with a record that any man might envy, and we congratulate him most heartily."

DEATH OF PRINCESS KAIULANI.

Honolulu, March 10, via San Francisco, A. H.—Princess Kaiulani died on March 6 at Aiea. She had been seriously ill for some weeks with inflammatory rheumatism. When the news of her death was received flags were ordered at half mast and the Cabinet tendered the use of the throne room to allow the body to lie in state. Her father, Mr. Cleghorn, declined the offer, saying he preferred a funeral at the Princess's home according to the Episcopal rites. The body lay in state in a front room of the Princess's home for several days and was viewed by thousands. The funeral was to take place on March 11.

About the middle of this century there migrated to Honolulu from Sydney, Australia, a Scotchman named Cleghorn, who became a trader. His son, Archibald Scott Cleghorn, married Likelike Pakea, the daughter of a Hawaiian of the rank of chief, and was the father of Kaiulani. This chief had another daughter, Liliuokalani, who was married to an American named John Dominis, and a son, Kalakaua. When the reigning family, the Kamehamehas, became extinct, Kalakaua was elected King, and his sisters suddenly found themselves Princesses. Liliuokalani became Queen after the death of her brother and Kaiulani was regarded as heiress presumptive to the throne and was sent to England in 1889 to be educated. After the revolution in Hawaii in 1893 and the deposition of Liliuokalani, an unsuccessful effort was made to secure the throne for Kaiulani. She visited this country several times. She was 24 years old.

Mr. G. T. Curtis, formerly of Waterloo, who went to British Columbia a year ago, has purchased a quarter interest in the Ennismore mine owned by the Avon Mining and Milling Company.

The other day Mr. Walter Horner of West Shefford discovered a beautiful doe in the rapids near his father's grist mill. The deer had been chased by hounds till she was completely exhausted and had taken to the water as a last resort. The hounds were on both banks. Mr. Horner succeeded in capturing the poor, hunted animal, which was too exhausted to make any resistance and placed her in his barn. By good care he resuscitated the deer and she is now growing strong as well as tame. Deer are becoming very plentiful in the Townships and the law for their protection is to be rigorously enforced in future.

Mr. Asa Knowlton, an old Waterloo boy, son of Mr. T. A. Knowlton, who is now living in Boston, has invented an ingenious device by which Springfield rifle bayonets are turned into candle stick holders, vase holders for flowers and electric light stands. He was granted a United States patent on the 27th December, and has applied for a patent in Canada, with the intention of manufacturing and selling the holders in Canada. These holders were a feature of the banquet which the Boston Home Market Club tendered President McKinley last month. The American Government having discarded the Springfield bayonet, Mr. Knowlton and his associates have purchased twenty-five thousand of them, which will be converted into holders of various kinds. The invention embodies a patriotic idea and already there is a brisk demand for the holders, so that their sale in large quantities is assured.

MISSION WORK IN THE DARK CONTINENT.

Miss Melville, who will address a meeting in Plymouth Chapel this evening at eight o'clock, is a missionary of the Canadian Congregational Station in West Central Africa. She is home at present on furlough and is making a tour of the Canadian churches. She is a bright and pleasing speaker, and gives much interesting information concerning the work being done in the Dark Continent. The public are cordially invited. A silver collection will be taken to defray her travelling expenses.

TROPHIES OF THE SPANISH WAR.

Washington, March 20.—The Trophy Board, consisting of Commander F. W. Dickers, of the navy, and Major George H. Hopkins, military aide to the Secretary of War, have made their report upon the proper distribution to be made of the guns and other trophies captured from the Spanish in the war. The report shows that the number of guns in the custody of the War Department is 141, all but 19 of which are now in this country. There are 56 guns in the possession of the Navy Department, and the board recommends the following distribution: That the captured guns taken from Spanish ships and now in the custody of the Navy Department—four from the Vizcaya, four from the Maria Teresa, and two from the Oquendo—be delivered to the War Department; that the eight cannon captured at the Morro Castle now in the possession of the Navy Department, be delivered to the navy; that the five mortars captured at Morro Castle be retained by the War Department; that the nine guns captured at the battery east of the Morro, seven guns and two mortars captured at La Estrella battery and four guns captured at Lower Socapa battery, now in the possession of the army, be delivered to the navy, and that all other captured guns in the possession of either department be retained there.—The board declares that the captured guns are of no value except as trophies.

Seattle, Wash., March 20.—Five Finlanders say they have discovered evidence of the real Russian boundary line, which, if established, would bring the Klondike within American territory. To United States Consul McCook at Dawson they said the boundary was marked by a series of mounds constructed of loose stones, upon which appeared a number of regularly engraved characters. These had been more or less obliterated by the action of the elements and could be only partially deciphered. The Finlanders say the mounds are identical with those employed by the Russian Government in marking boundaries.

WOMAN AND HOME.

HER SUCCESS-AS A GOVERNMENT CLAIM SOLICITOR.

Causes of Women's Nervousness.

In this modern life of rush and worry a woman's main reliance is upon her nerves. If they are strong and healthy, there is strength of sinew, firmness and vigor of mind and body, she can coolly meet the demands of society, and life and its duties are rendered a pleasure.

The many cases of nervous prostration or utter collapse of the nervous system, under which women "go all to pieces," as the saying is, have caused much thought and investigation on the part of physicians.

Certain inorganic substances are well known to cause various forms of nervous diseases, which are readily traced to alum. Further research leads to the belief that alum is a prevailing cause of the so-called nervous prostration, for the symptoms it produces on the nervous system after its absorption into the blood are very remarkable indeed.

Experiments physiologically made upon animals by Orfila, Professor Hans Mayer and Paul Selin show that alum produces no visible symptoms for many days after its introduction into the body. Then follow loss of appetite and other elementary disturbances, and finally a serious prostration of the whole nervous system. The symptoms are those observed in a species of nervous paralysis in a human being. The theory is therefore advanced by the most prominent physicians that "nervous prostration" and many affections of the nerves from which both women and men suffer are caused by the continued absorption of alum into the system.

It is probable that many medical men are unaware of the extent to which salts of alumina may be introduced into the body, because they are under the impression that the use of alum in bread is forbidden by law. It is, however, still used to whiten bread, as well as in making cheap kinds of baking powder.—Pittsburg Dispatch.

There is sometimes a strong temptation to tell our troubles to others, but if we wish to retain the good opinion of those same friends we will think twice before so doing and decide to keep them securely locked in our own bosom.

There are times when an outpouring of one's earthly woes does one a world of good, but as a rule the more one keeps the annoyances of life quiet the happier she will be.

There is a problem for every mother with growing children, answers God House-keeping, and yet their own good health is of such paramount importance that some method of solving this difficulty must be devised. Of course most mothers do not want to deny their children all pleasures, but those of such a late hour as mentioned ought to be very rarely indulged in, not often than once a year, and then in vacation time.
