

COMMISSION ON VOTERS' LISTS

Quebec Govern. Likely to Investigate Assessor's Methods. WHENCE CAME INSTRUCTIONS By Which Many Voters in City Divisions Were Summoned to Show Citizenship, and Swept From Lists When They Failed to Appear?

The principles employed in the last revision of the voters' lists in the city of Montreal have been the subject of a good deal of controversy, and for some time past the friends of the chief candidate to suffer by the revision, Mr. Peter Lyall, have been endeavoring to secure an investigation into the proceedings of the city assessor's department, and a pronouncement upon their legality. To-day it is announced upon good authority that the Provincial Government has practically promised to appoint a commission to inquire into the matter.

As a corollary to this comes the announcement that Mr. James Cochrane, M.L.A., will during the next session, with the assistance of Mr. Godfrid Langlois, M.L.A., introduce legislation to deprive the assessor's department of any control which it may be decided to leave over the electoral lists for provincial and municipal elections, and to secure to the taxpayer the right to vote for mayor and aldermen even if he be an alien.

Assessor's Operations. "During my majority," said Mr. Cochrane, a man named who had received a post card from the city assessor's department calling on him to go down, and prove his citizenship. He told me he had been naturalized twenty years, and I myself have known him as a resident of Montreal for thirty years, and as a voter for a great number of years. He called upon me and produced his citizenship papers. "I didn't know what the authority was, and I hurried around to the assessor's department to find out what it was all about. I was told by Mr. Lyall, the member for the district, that he would not tell me from whom those instructions were received. However, there is only one source from which such instructions can come to the assessor's department, and that is the Finance Committee.

Of course the department was acting wrongly when it was acting in the name of the assessor. The law is there that gives the city assessor the power to say that a man who pays taxes shall be swept of the list of voters for municipal elections. Why should a man whose name is on the list be called to prove his citizenship any more than you or I?

Were They Legal? "If the truth ever comes out about the instructions to the Assessor's Department you will find that not only were they a piece of election trickery but that they were not even within the meaning of the law." Mr. Peter Lyall this morning said that he did not think anyone would seek to come to the City Hall on a personal connection with any improper action in regard to the lists. The situation simply was that a great number of names had been removed by the assessor upon grounds which he believed to be legally insufficient, and he earnestly hoped that a full investigation could be secured, and the citizens' names traced to their source.

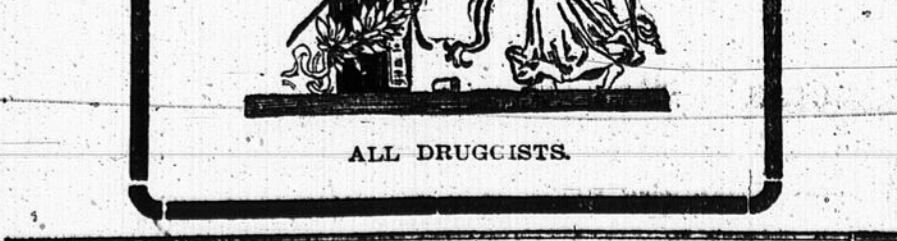

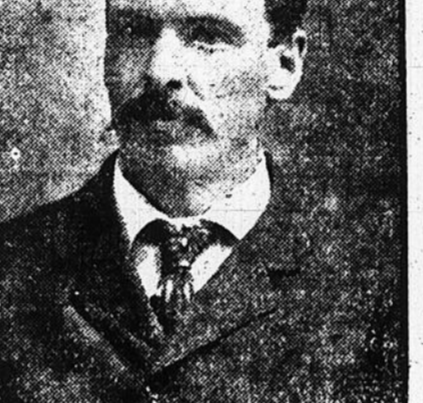
