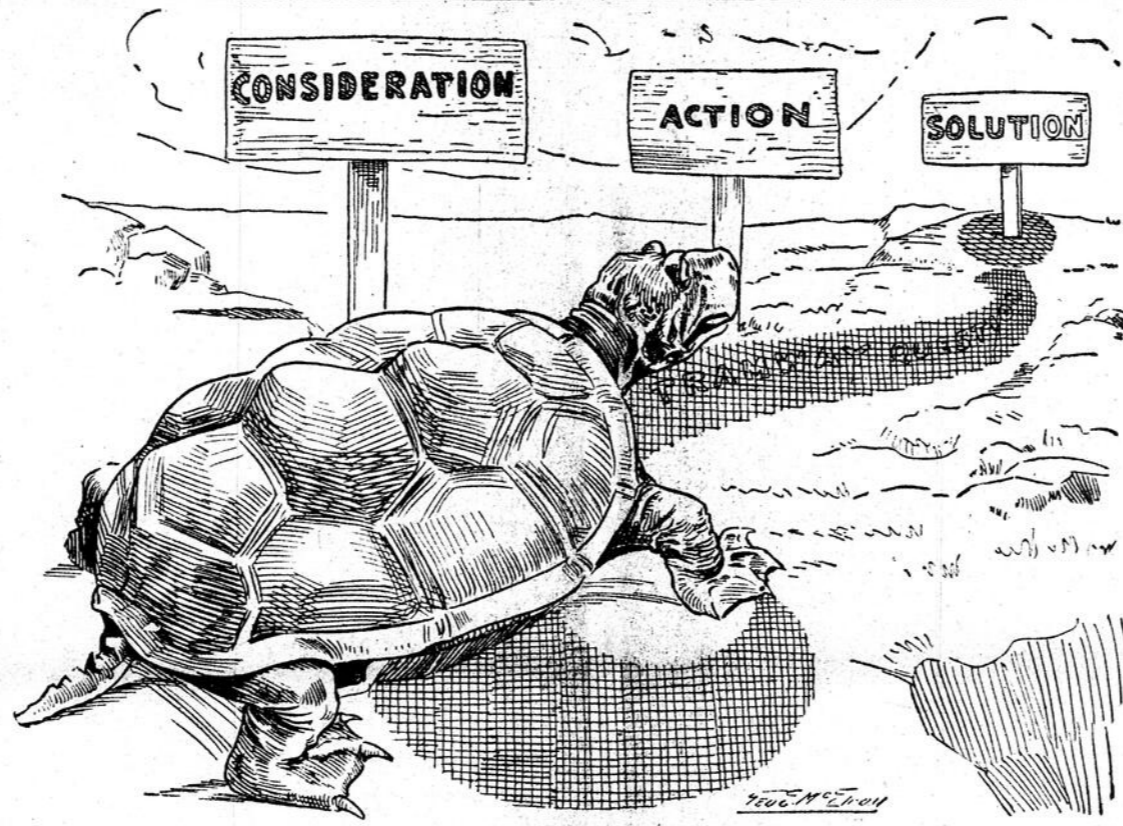


BURGLAR'S DARING MATCHED BY CONSTABLE'S CLEVERNESS

John Murphy Loaded Express Waggon With Merchandise From Storeroom, But Was Watched by Officer, Whose Suspicions That He Was Not an Employee Were Dramatically Justified.

Following the fire escape and leaning rods on the building occupied by the William Crevier Company, Limited, 423 Notre Dame street west, Montreal, the skylight and letting himself drop to the floor, John Murphy, 42 St. Alexander street, was able to work in the store for a time long enough to collect together over \$2,000 worth of merchandise, place it near the back door, go outside, steal a horse and express wagon and load it up with seventeen dress suit cases, over ten pairs of pants, besides furs, and other goods to the amount of \$1,000 before he was captured by Con-

stable Guigere at 5:30 this morning. When the constable first saw the wagon he passed on, thinking it was some of the employees of the firm. He stood in a doorway and watched the removal until satisfied the face was unfamiliar. Going over to Murphy he found the man was excited and nervous, making a pitiful attempt to account for his early morning labors. He was taken to police station number 4, and brought to court this morning, where he was charged with stealing \$1,000 of merchandise. He admitted his guilt, and was held for further investigation by the police, who are looking for confederates.

ENHANCING RITZ-CARLTON ATTRACTIONS

Ornamental Garden With Pavilions to be Designed in Time For Summer.

Mr. R. Biehoff, manager of the Ritz-Carlton Hotel, was busy to-day with plans for an extension to the new house on Sherbrooke street that will give Montrealers an opportunity of dining out in the open air in a manner that has not been previously accessible.

The scheme which has been formulated is to be placed before the directors to-morrow, and an early start will be made on the work in order that it may be carried out before the weather of the summer arrives. With an entrance from the west end of the oval dining room is a beautiful stone work loggia, and this leads on to a large garden. Trellis work twenty feet high is to be erected around this open space to block out the view of neighboring residences. The ground is to be graded over to a landscape gardener, and laid out in old Italian style. Five pavilions will be erected—a Canadian pavilion, a Swiss chalet, a Chinese pagoda, and a Japanese and a French pavilion. A fountain will play near the center of the garden, and nearby tables will be placed for afternoon tea and other meals. Special arrangements are being made to shade the garden from the direct rays of the sun, and at night it will be artistically illuminated.

MONTENEGRO WILL FIGHT ALONE

The Other Allies Accept Terms of the Powers For Armistice.

London, April 15.—The Balkan war is once more ended—this time for good and all. All the allies, with the exception of Montenegro, have accepted the terms of the latest note of the great Powers and it is practically certain that an armistice will be arranged within two or three days.

A Vienna despatch to the 'Chronicle' says that the relations between Serbia and Bulgaria are becoming increasingly strained. Serbia claims for herself Egri, Patanka, Kratova, Vales, Uskup and Okrida, in total disregard of the treaty concluded before the war between Serbia and Bulgaria, under which most of these towns being Bulgarian would go to Bulgaria. The disputed territory comprises 25,000 miles.

Cetinje, April 15.—The Government has notified its representatives abroad that Montenegro rejects pecuniary compensation for Scutari, and will only yield to overwhelming force.

LAKE PORT HUMMING WITH SHIPPING ACTIVITY

Sarnia, Ont., April 15.—Sarnia is humming with activity in preparation for the opening of navigation, which will be weather and ice permitting—on the 23rd. The Grand Trunk Railway, in conjunction with the Northern Navigation Company, is accepting freight for lake and rail to all points in Western Canada, as also for ports on the Georgian Bay. This information will be welcomed by eastern shippers as the inauguration for another season of this double track route to the West via Sarnia and to Georgian Bay ports via Collingwood means for them no little saving of time in the forwarding of consignments. The 'Huron' falls the honor of the season's sailing from Point Edward, Point Arthur, and Port William, with the 'Huron' and 'Sarnia' following in rotation till June 2nd, after which a weekly service will be maintained. Sarnia at the head of the St. Clair River, the entrance to Lake Huron, is a gateway through more tonnage passes than any other one point in the world; they being not only one of the busiest, either up or down every five days throughout the season of navigation.

COLD STORAGE PLANT.

Controller Ainey said to-day that the city is now having the new Reservoir plant installed at Notre-Dame Market. It will supply cold storage to the tenants at a charge of one cent a cubic foot a month.

IF THEY DO THEIR DUTY TO THE CITY

The view which the 'Witness' has been insisting upon in connection with the tramways question since the 'Get Together' policy has been endorsed is emphatically expressed to-day by the Controller. It says of the forthcoming reference between the Controllers and the Tramways Company:

If the men carrying advertising placards are kept out of the gathering and those who have the responsibility in the matter of their duty to the citizens, they will have occasion to congratulate themselves. The Controller's foresight and energy, which revolutionized the street car system and created a system that now serves the public better than any other in the world.

It is at this point of view that the wisdom of the present situation is apparent. In the past, ward politicians have been interested in any plans for improvements and have been ready to support them. It is more than a suspicion that the citizens will have reason to congratulate themselves.

CONTROLLER AINEY ON BENEFITS OF EXPROPRIATION OF POWER Co. by Wards.

The city is willing to buy out the Montreal Water and Power Company on a fair valuation. The reason we are proceeding on the expropriation of the plant ward by ward, is, first, the aldermen instructed us to do so a year ago; second, we were let by law only to get a physical valuation of the property; we first pleaded ourselves to buy it. This put us in an awkward position. The company wanted seven million dollars, and we paid that amount in gold and silver. The Board of Control was merely following out what was laid down by ex-Controller Wanklyn, in a comprehensive report presented two years ago.

MAYOR HURT IN AUTO MISHAP. Medicine Hat, Alta., April 15.—While returning from Whittla late last night, Mayor Spencer, Conservative candidate for Medicine Hat riding, was thrown from an automobile 25 feet and seriously injured. Taking a short cut, he was driving on a hole about seven feet deep, half full of water. He gripped the steering wheel and was not moving much, but Spencer was rendered unconscious and will be laid up for ten days or more.

WOMAN IN VERY NERVOUS CONDITION.

Mrs. Siefert had, it is declared, been in a highly nervous state for some days. Mrs. Pastaruk of 159 Clark street, a friend of the woman, who visited the Siefert's home yesterday, says she found Mrs. Siefert crying bitterly. 'What am I to do, what am I to do,' she wailed. 'I have my three little ones to feed, my husband has not been working for a long time, and now he has learned to gamble.'

PATHETIC SCENES AT FATAL HOUSE.

It presented a pathetic scene, that house of death. When the victim was taken to the hospital it was impossible for her husband to leave the three children alone, and he spent the time anxiously pacing the floor with the youngest child in his arms, while the front door was being guarded by the constable. The eldest child is three years old, and it is understood by the police that the couple came here from New York in the latter end of November, and that Siefert had been out of work for some three months. The revolver found by Captain Belanger and his men at the Siefert home is a .35-calibre weapon, chambered for five shells, but on examination it was found that only one chamber was loaded.

HUSBAND SAYS HE THOUGHT WIFE WAS DEMENTED

When She Greeted Him With Loaded Revolver at His Head.

DECLARES GUN WENT OFF IN THE STRUGGLE

Pathetic Scenes at the Siefert Home After Terrible Tragedy.

Now, what would you do if I threatened to shoot you? That, according to Morris Siefert, of 330 St. Dominique street, was the greeting with which his wife met him on his return from a Union meeting early this morning. At the same time she pointed a revolver belonging to her husband, at his head. To-day, the wife lies dead as the result of a struggle for the weapon. It had been loaded and went off, the bullet entering the woman's cheek under the left eye, and embedding itself in her brain. She was removed to the General Hospital, where she died without regaining consciousness.

The only person who can tell what happened on the fatal occasion is the husband, Morris Siefert, who is a garment worker. The story he told to Captain Belanger, of No. 4 station, who was called to the scene of the tragedy, was something as follows:— It was just about 12:30, said Siefert, when I came home after attending a night meeting, and my wife stood in front of the dressing table when I went in, getting ready for bed. After saying a few words, she suddenly picked up the revolver, which I always keep in the house, and turning to me, she pointed the gun at my head with the remark, 'Now, what would you do if I threatened to shoot you?'

WARNED HER IT WAS LOADED.

'I dodged away from the point of the weapon, and told her to put it down immediately, as it was loaded. She kept the gun pointed at my head, however, in spite of my warning, and thinking that she might have become suddenly demented I jumped and grabbed her wrist, and attempted to twist it from her grasp. 'As I jerked her hand around, she must have pulled the trigger, for I was deflected by a report, and my wife fell into my arms with blood streaming from a wound in her head. I saw that she was seriously hurt, so I ran immediately to the hospital for assistance, but the whole thing happened so quickly that I cannot realize that Fannie is dead.'

FIRST BOAT IS LOADING

WHO GETS MORGAN ART TREASURES?

Collection To-day is Valued at \$34,000,000—Disposition Known Next Week.

New York, April 15.—The will of the late J. Pierpont Morgan is expected to be filed in the Surrogate's Office here within a few days, according to an unofficial announcement here to-day. It is said that the general provisions of the will have been explained to members of the family, and some phases of it to the members of the Morgan firm, but no information has been given out as to its terms. The greatest interest centres in the disposition of the Morgan art treasures. Enormous policies of insurance are being placed on the Morgan art treasures. The value of the Morgan collection has been estimated at \$34,000,000, of which \$2,000,000 represents the great collections in the museum or in storage, and \$10,000,000 the books and works of art housed in Mr. Morgan's library.

ART EXHIBITION SOON TO CLOSE

Last Free Day To-morrow of Most Successful Display in the Association's History.

To-morrow is the last free day for the spring exhibition at the Art Gallery on Sherbrooke street. The exhibition closes on Saturday next. From an artist's point of view, alike from the point of view of attendees, the exhibition is the most successful ever held in the history of the association. It is possible that by the time it closes from 15,000 to 20,000 people will have visited it.

That the remarkable work of some Post-Impressionists who are exhibiting, and the controversy aroused over their methods, have had something to do with the great popular interest aroused there is no doubt, but other things have contributed. For instance, this is the first exhibition of local work in the new gallery, and the new gallery is such a magnificent building, and full of so much of interest, that a visit to it makes a highly enjoyable and profitable afternoon's outing. It is a distinct addition to the show places of Montreal.

Another point is that perhaps never before has there been such a good collection here of work by native artists in the interpretation of native scenes. We are fully alive to the commercial and industrial possibilities of our great heritage in this country. At last, as this exhibition shows, our artists are awakening us to the eternal loveliness of our heritage—the mystery and the wonder of it all. Here is where the great future of art in Canada lies; native art must find an ancestral sense of possession in the land. Many lovely pictures in this exhibition, essentially and gloriously Canadian pictures, testify that they are finding it.

Washington, April 15.—Mr. Charles H. Mann, for more than a quarter of a century superintendent of the Press Gallery of the House of Representatives, died early to-day, after an illness of several weeks. He was 74 years of age.

OFFERS STERN FIGHT AGAINST FREE WOOL

Opposition Forces at Washington Demand a Fifteen Percent Duty.

BUT MR. UNDERWOOD WON'T SURRENDER.

He Declares Tariff Bill Will Go Through Caucus With Little Change.

Washington, April 15.—'Fifteen percent ad valorem duty on raw wool,' was the slogan of the organized opposition to the administration free wool bill, when the Democratic caucus to-day resumed consideration of the new tariff bill.

With Southern and New England Democrats still fighting the cotton rates proposed in the new measure, the anti-free wool members were planning their attack on schedule K, which the caucus expected to reach before the close of the day.

At an early morning conference of Democrats from Ohio, Indiana, West Virginia and many of the western 'states, it was determined to stand by their decision to fight for a fifteen percent duty which they claim was the original judgment of the Ways and Means Committee before consultation with President Wilson.

Representative Ashbrook, of Ohio, who has presided over the anti-free wool conference, said he would lead the fight on the caucus floor. Though the opposition claims to have the sympathy of more than fifty Democrat members, the administration leaders insist that they cannot muster that many votes on an amendment to change the bill as presented to the caucus.

MR. UNDERWOOD IS CONFIDENT.

Mr. Underwood, after an early conference with President Wilson expressed confidence that the tariff bill would be approved by the House caucus without important amendment within the next three or four days.

The Democratic majority was sufficiently strong to put the measure through the House within a short time, they said. The measure would permit the minority to be fully heard. 'Of course, there will be many amendments from our Republican friends,' he said, 'but the bill will pass the House just as it is approved by the caucus and with only a few minor changes. You can't write a tariff bill of 4,000 items without forgetting to cross a 'y' and dot an 'i' here and there. In equalities always creep in and these have to be adjusted.'

BRINGS ENGLISH SONG BIRDS TO DETROIT.

Detroit, April 15.—Nearly 500 song birds, imported from England by Mr. Henry Ford, a local manufacturer, arrived in Detroit last night, and will be given their liberty on Mr. Ford's farm near this city. The ship was met in New York by game warden Daniel, of Detroit, and brought west in a special express car. Nearly one hundred birds died on shipboard. Included among the birds were larks, linnets, brilliant yellow linnets, thrushes, green finches, bull-finches, jays, chaffinches and red polls. It is expected that these birds will increase rapidly in numbers, and eventually spread over the State.

BELGIAN STRIKE WAKES SYMPATHY IN GREAT BRITAIN

Widespread Hope That Struggle for Manhood Suffrage Will be Successful.

SUFFRAGETTES PROHIBITED FROM OPEN-AIR SPEECHES

But They Have Put Home Secretary Into Most Awkward Situation on Record.

London, April 15.—Everybody here who is interested in democracy, and in the fuller realization of manhood and power, is following the Belgian strike for manhood suffrage with great interest.

The franchise in England is not what it ought to be, and the Government bill to abolish plural voting is not what it ought to be. This defect, however, will be remedied in the near future, and England, as always, will lead the way in the liberty of the subject and the cause of democracy.

The state of things in Belgium now affords proof of the danger of favoring one class more than another, especially in favoring the class usually opposed to the aspirations of the workers.

It is a matter of congratulation that the strike so far has been orderly, and the hope here is that it will be short-lived, and that the workers will carry it to a successful issue.

THE HOME SECRETARY AND MILITANT SUFFRAGETTES

The decision of the British Home Secretary to prohibit open air meetings of militant suffragettes, will, it is feared, only tend to create disorder instead of minimizing it.

Mr. McKenna is certainly faced with a difficult situation. He must either shut his eyes to the wanton policy of destruction and notorious disorder, or impose a ban on the free speech which the Liberals so strenuously fought for, and won for the people. The situation is declared to be one of the most difficult which ever confronted a British Home Secretary.

WESTMINSTER.

CARPENTERS AND CAULKERS STRIKE

Because Demand For Higher Wages Was Refused.

Fifteen carpenters and caulkers employed by the Montreal Dry Docks and Ship Repairing Company, limited, laid down their tools last night because their demand for thirty cents an hour had not been complied with by the firm. The other departments remained at work at the time of the walk-out.

It is said that there is little likelihood of any more men quitting work to join in the strike.

This morning a delegation from the Labor Temple and asked to be admitted into the United Brotherhood of Carpenters and Joiners. At the present time they are all non-union men, although there is one local, No. 178, for ship carpenters. It is likely that their request will be granted, and that three carpenters in the city are now out, 58 in an uptown shop and the rest in the dry dock.

The men who left their positions last night were receiving 30 cents an hour, having been raised from 25 and 27 cents about a year ago. On Monday they sent a letter to their foreman asking for 35 cents an hour. The reply of the company that conditions did not permit the increase. The result was last night's walk-out.

At the dry dock to-day officials denied that they were in any way inconvenienced by the action of the men, declaring that they had a full staff already. It was claimed that the carpenters and caulkers had been retained all winter, although there were times when work was very slack. Most of the repairs on the vessels were complete now, and there would be little activity around the dock for a month or more until the river and lake opened.

The strikers claim that 35 cents an hour is the recognized minimum wage for ship carpenters.

POPE WEAKER AND DEATHS HOURLY EXPECTED

Lawyer Patriarca Summoned to Vatican to Make the Pontiff's Will.

PATIENT'S COUGH IS MORE TROUBLESOME

Officials Reticent, Bulletins are Brief, General Impression One of Hope Abandoned.

Rome, April 15.—This morning's bulletin on the condition of the Pope was as follows:—

The Holy Father slept tranquilly for several hours during the night. This morning his temperature was under 97. The catarrhal affection is no worse and expectoration continues easy. The condition of the heart is good. (Signed), 'MARACHIAFAVA, 'AMICI.'

Rome, April 15.—1.10 p.m.—The Pope was disturbed more than usual by his cough this morning. It has become more troublesome to-day. The temperature of the Pope varied frequently during the forenoon. Dr. Amici visited him again just before noon, when he found an almost imperceptible rise had taken place since early morning.

Rome, April 15, 4.35 p.m.—The Pope had an alarming coughing spell this afternoon, almost causing suffocation. The attack was followed by such exhaustion that those attending the Pontiff feared the worst.

5.45 p.m.—Subsequent to the access of coughing the Pope had a period of distress, but after a rest he appeared relieved. At this hour the condition of His Holiness is considered to be stationary.

LAWYER CALLED TO MAKE WILL

The lawyer Patriarca, who represents the Holy See, was summoned to the Vatican this morning. The same lawyer drew up the last testament of Pope Leo XIII., and the inference is that he has been asked to do the same for Pope Pius X.

The lawyer Patriarca was summoned after Prof. Marchiafava had a long conference with Cardinal Merry del Val, the Papal Secretary of State.

Earlier in the morning the Pope's sisters expected the Vatican, and were received by Mgr. Parolin, the Pope's nephew, who held them waiting in an ante-chamber until the doctors had ended their visit. They then entered the Pope's chamber. Later they journeyed to an adjoining chapel, where they heard two masses celebrated, one by Mgr. Bressani, and the other by Mgr. Parolin.

Private, but reliable information as to the Pope's condition this morning, is to the effect that while he is again without fever to-day and better than last night, when his temperature was high, he is weaker than at this time yesterday.

If the same course continues he will be weaker each day. If bronchial affection does not develop into actual pneumonia, it is doubtful how long the constitution of the patient can hold out.

COMPLETE REST INSISTED ON.

The aggravation which occurred last evening in the condition of the Pope reached its height before midnight, and then gradually wore off in the early morning hours. When Professor Marchiafava entered the sick room this morning just before half-past seven, the fever had entirely disappeared.

The injections administered by Dr. Amici in the course of the night, had produced the desired effect of keeping up the strength of the patient's heart, although the weakness of the Pope had been increased by the restlessness caused by the slight feverishness in the earlier part of the night.

The Pontiff was this morning able to retain some nourishment. He greatly enjoyed some yolks of eggs beaten up alternately in Marsala wine and old brandy, which makes a kind of cream, both nutritious and light, and much liked by Italians.

Prof. Marchiafava gave a fresh prescription this morning, aiming at facilitating expectoration still further, as he feared the King Alfonso, who had taken so far might have affected his digestive organs.

The professor recommended complete rest and extreme care, saying 'Each patient must, above all, be his own physician.'

The arrival in Rome last night of Angelo Sarto, the Pope's brother, was interpreted in some quarters as a certain sign that all hope was abandoned. Angelo Sarto left his own village on his journey to the Holy City long before the present setback of the pontiff occurred—in fact, when the condition of the Pope had greatly improved.

Angelo was received with open arms by his sisters, who seem to think that the more the Pope is surrounded by the members of his family the easier it will be to save him.

The Spanish ambassador yesterday visited Cardinal Merry del Val, the papal secretary of state, and inquired regarding the progress of the Pope in the name of King Alfonso. At the same time he said he had been delegated to express the emotion of the Spanish Royal family for the kind thoughts of the Holy Father, who, while ill, and while the whole world was trembling for his health, had sent his congratulations to the King for his escape in the recent attempt against his life.

AT THE CITY HALL TO-DAY

At the City Hall to-day it was said that a beginning would probably be made in a few weeks on the relaying out of Phillips Square preliminary to the erection of the King Edward monument. The designs are the work of Mr. Todd, landscape artist.

LIBERALS WANT MR. MONK BACK IN HIS SEAT

Enhancing Meaning of City's Theological Degrees

The Rev. Dr. Jones, Chancellor of University of New Brunswick, Sees Great Potentialities in Co-operation of Theological Colleges—Tremendous and Most Hopeful Advance by the Churches, Says United States Principal.

Still the tide of congratulation over the success of the co-operation of the four theological colleges of the city continues to roll into Montreal. The Rev. Dr. C. J. Jones, the Chancellor of the University of New Brunswick, Fredericton, N.B., writes today:

"I am much interested in the current announcement of the Montreal Federated Theological College, and I am pleased to learn that the project is not only to be continued, but is to be very materially extended and enlarged. It is seldom that one finds a movement in educational circles of such unquestioned merit as the one under consideration. Religiously—it means a deepening of fellowship and a broadening of viewpoint among the students of the different denominations. Educationally it means the inspiration of larger and more enthusiastic classes, professors of thorough scholarship, and the highest academic standing, and eventually an institution from which a degree will have a much greater meaning than under former conditions. Financially it means a large saving effected by the combination of classes, better paid instructors and a general concentration of financial effort. It seems to me that the federation would be greatly strengthened by a common building such as a hall of instruction or library. Such improvements, however, will doubtless be accomplished as the movement becomes more permanent in character and receives the strong financial support which it undoubtedly deserves. I wish you every success."

FROM PRINCIPAL OF A U.S. THEOLOGICAL SEMINARY.

The principal of the Episcopal Theological Seminary near Washington, D.C.: "I am delighted with the happy result of your great movement. It is going to have a wonderful and far-reaching influence. It is evident that it must lead to the university idea of common theological study. A tremendous and most hopeful advance has been taken by the various churches of your city in bringing their students of theology into close contact with each other by studying together. It will make them at that impressionable age gradually realize that in the great essentials—the substance of our faith—we are one, with allowable and reasonable differences of opinion."

INCREASE LAW LORDS BY TWO

Will Give Added Facilities for Hearing Overseas Appeals to Privy Council.

(Canadian Associated Press.) London, April 16.—The question of affording greater facilities for the hearing of overseas appeals to the Privy Council, came up before the House of Lords yesterday, when the Lord Chancellor, Viscount Haldane, introduced the measure. Freshly shadowed and promised as a result of the Imperial Conference of 1911, His Lordship, in moving the second reading of the bill, explained that it was proposed to increase the number of Law Lords from four to six, all of whom would be qualified to sit in the Court of Appeals. Those judges of the courts of overseas dominions who would become members of the judicial committee by their appointment as new Lords would be on the same footing as the existing Lords. The justification for the bill rested on the resolutions which had been passed at the Imperial Conference of 1911, when, in view of the ever-increasing volume of business coming up before the Judicial Committee, various suggestions were made with a view to remedying existing conditions. One was to the effect that Dominion judges should sit on the Judicial Committee. It was made apparent that what was really wanted was that when occasion rendered it desirable, a judge of the Supreme Court, and the Lord Chancellor should be able to take part in hearing appeals. The Chief Justice of Canada had sat in appeals which did not come up before the Judicial Committee, but he was not permanently as a member of the committee.

The Imperial conference, Lord Haldane went on to say, had resolved that the Home Government should be requested to appoint two additional Law Lords to sit on the Judicial Committee, and the Government of Canada. Such a plan would strengthen the tribunal. It was recommended that the appointees be English judges of experience and of high judicial capacity. The object to be attained was that the Judicial Committee should not sit with less than four or five members in certain cases. The bill did not touch the question of a supreme tribunal for the Empire which might do away with appeals to the House of Lords, but arrangements would be made so that they would not cause any difficulty should that question become a practical one. The bill was supported by Lord Salisbury.

M. P.'S URGE NEED OF DIVORCE COURT.

Ottawa, April 16.—There has been much criticism in the Private Bills Committee of the House of Commons this morning of the divorce bills, which were recommended by the Senate Divorce Committee. On several occasions members of the Commons have registered their opposition to bills going on to the House without further evidence being heard to establish justification. There was a case of this kind before the committee yesterday, one of the numerous Toronto divorces, which was only passed on to the Commons after a vote had been taken and a concession of the committee registered its disapproval. That bill would never pass the divorce court in the Maritime Provinces, and the Government of New Brunswick member.

It is understood that there is another bill to be considered at an early date which is the subject of the committee's disapproval. The bill is a divorce bill and such action as has been proposed for the committee will, it is believed, help lead the way to a reform.

SOLD HIS WIFE FOR \$500 IN TORONTO.

Toronto, April 16.—A curious story was told in the Court yesterday when Anna Gysingh, an Austrian woman, faced a charge of having stolen a \$100 bill from Peter George, one of her countrymen. Mrs. Gysingh coolly informed Magistrate Denison that her husband had sold her to George for \$500, and that the \$100 bill in question had been paid to her on account. His Worship ordered the money to be returned to Peter and dismissed the case.

HYDRO-ELECTRIC CHIEFS THROW UP JOBS.

Toronto, April 16.—Ten officials in the employ of the Toronto Hydro-Electric Commission, the heads of every department in the service, have tendered their resignations. The dismissal of Mr. W. R. Sweaney, acting manager, by the Commission caused them to take such action last night. These men are: J. G. Jackson, chief engineer; J. C. Smith, general superintendent; A. G. Lamb, engineer of distribution; A. C. MacCullum, engineer of operation; I. M. R. Widdfield, superintendent of meter department; H. G. Oud, chief inspector; E. C. Clarke, manager of application department; H. G. Jacob, sales manager; F. R. Ewart, receipt agent; and H. C. Barber, assistant to acting general manager.

TO TEACH LITTLE CRIPPLES

It is Proposed to Erect a School in the Children's Memorial Hospital Grounds.

To give the crippled children in and around Montreal a chance in the world, a committee of those interested are working towards the building of a school in the grounds of the Children's Memorial Hospital. This hospital is non-sectarian, ready to receive children of any creed or nationality, and it is delightful to physicians, nurses, teachers, and friends to see how perfectly in harmony are all these different little patients. The resident patients are taught by the bed-side. Some are not able to raise their heads, and the copy books have to be held for them in a certain position, while they learn to write; others cannot use their hands, the teachers hold their books as the little ones learn to read. Yet, without these girls and boys study the same lessons that our public school boys and girls study, also learn to knit, sew, crochet, embroider, do typewriting and draw. The School for Cripples to be erected in the Children's Memorial Hospital grounds is to be a day school, where the helpless cripples in and around the city will be brought in ambulances daily, to receive a thorough public school education, and be taught light trades, which will help them to be self-supporting.

FIRE DESTROYS CLUBHOUSE.

Utica, N. Y., April 16.—Entailing a loss between \$50,000 and \$75,000, the clubhouse of the Adirondack League at Little Moose Lake was destroyed by fire last night. The clubhouse, containing about 150 canoes, was saved, as were several cottages nearby. The origin of the fire is unknown. The Adirondack League Club, of New York City, has headquarters on Broadway and includes some 1,000 men of the Metropolis. The clubhouse was erected about twenty years ago, and housed nearly all the members during the summer.

WIDENING THE AQUEDUCT.

Additional information was given out yesterday on the specifications for widening the aqueduct. The tenders will be opened on May 16; the work will cost \$2,000,000; it will have concrete retaining walls, and develop 10,000 horse-power. It will extend from Point St. Charles toachine, six miles. Two classes of tenders are asked for.

Who Owns 'News'? -- Players Belong to Club They Joined Last Year.

QUEEN CITY SCRIBE 'KNOCKS' THE N. L. U.

Mr. Charles Querrie, of Toronto, the astute chief of the Tecumseh Lacrosse Club, is authority for the following remarks: Having been in an effort to start a little trouble in regard to 'Kid' Donihue, of the Toronto, who, according to the now correspondent at Cornwall, was signed by Westminster, the gentleman at the head of the wire service in the Canal Town has turned his attention to 'News' and is making an effort to raise trouble in regard as to who has the first claim on the services of the Cornwall player, and even goes so far as to quote A. T. Caron, president of the Nationals, as follows: 'All we want is our rights,' said Mr. Caron. 'Don Jones stole Neway from the D.L.A. last year. He belonged rightly to Toronto last season upon our releasing him, but as Toronto did not take advantage of their property in him, and Con Jones kidnapped him, he now belongs to us. We think that we will certainly get him under the constitution of the D. L. A.'

It would be just as fair a proposition for the Tecumseh to make a claim for the services of Pickering, Ions, Griffiths and Adamson, as the Toronto to claim the services of 'Nick' Carter and West, as for the Nationals to have the services of Lalonde, who played on the coast last year. All the players who played with the respective teams last year become the property of that club, and the agreement will be carried out by Vancouver and the clubs in the 'Big Four' and Lalonde will play with Vancouver unless he is released or traded or sold to some club in the D.L.A.

According to an Ottawa despatch the statement is made there that now the N.L.U. as a professional lacrosse league is no more the question of what is to become of the accumulated fees in the treasury of the league is bothering at least one of the magnates. Mr. Alex. Bannerman thinks that the league should make an accounting of the money they have and turn it over to the four professional clubs, Capitals, Cornwall, Montreal and Shamrocks. 'We put the money in and should get it back. I see no reason why the amateurs should benefit by this fund when it has cost the professional backers good money to keep things going,' says Mr. Bannerman. While

MUCH INTEREST IS BEING SHOWN IN DRAUGHT HORSE COMPETITION.

Owners of heavy draught horses will compete this spring for the second time for the third cup offered for competition by Mr. Charles Cassils. The donor of this cup was among the first to offer a cup for the annual Montreal Horse Show, the first two given by him having been won outright. Last season saw the first contest for the new cup, it being won by the Shelden Forwarding Company, while the previous cup was won outright by the Dominion Transportation Company, in 1911. From year to year Mr. Cassils has chosen the same class with a view to encouraging the purchase and ownership of the better quality of such horses in Montreal. The competition in these events has always been of the keenest and will be none less keen this spring.

There is no city in this country where better horses suitable for this competition are to be found than in Montreal. The conditions for the cups offered by Mr. Cassils always remain the same, it being for the best pair of draught horses, any breed, to be shown in harness to a dray or heavy wagon, horses to be owned and in use by the exhibitor at the time of entry. The events at this have gone long way towards the improvement of the work horse, the larger firms as well as the individual exhibitors striving for honor in the show ring.

Mr. Cassils is one of the stewards of the show, and has always taken a great interest in the judging of the various classes. He is a member of the Montreal Jockey Club and the Montreal Hunt. One or two entries have already been received for this competition, and as there is still over a week between now and the closing date, the class will doubtless provide the usual keen competition. For the convenience of owners the Horse Show office will be open until 10 o'clock each evening until the closing date, which is Wednesday, April 23.

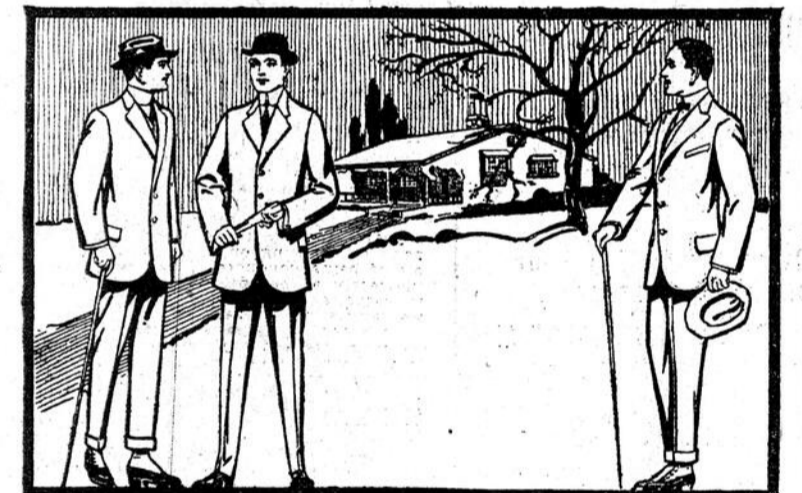

SOME GENTLE HINTS TO THE TRUSTS.

Should Consult Conscience,
Not Lawyer, Before Driving
Weak to Wall.

Washington, April 15.—Vice-Pres-
ident Marshall has given out a long
interview for publication to-day which
may be of some significance. In it, he
does not express any of his own
opinions, but voices the opinions of oth-
ers in order, as he says, "That the
men of power should know what the
rest of the people are saying." Putting
conscience into business as an antidote
for Socialism, may be described as the
keynote of Mr. Marshall's interview.
He says among other things: "From
men of all classes I have heard ex-

ed to pay off the war debt. Next it
was defended on the ground that it
was needed for the building of our
infant industries. Later it was de-

ference in the cost of production at
home and abroad with a reasonable

"Men are asking whether there is
any difference between the manufac-
turer who comes to the Government

from \$10,000 to \$20,000 waiting for
a capable man. It may be that a very
man might not want to earn \$20,000
working for the Steel Trust, however.
He might prefer to start a little rolling
mill of his own, so that he would be
independent and his own master, even
though he made but \$5,000 a year. It
is such opportunities as these that
many men are saying are denied to
them."

CALLS LABOR DEPARTMENT TO TASK IN HOUSE

Mr. W. F. Carroll Alleges Breach of Law in Relation to Labor Strike.

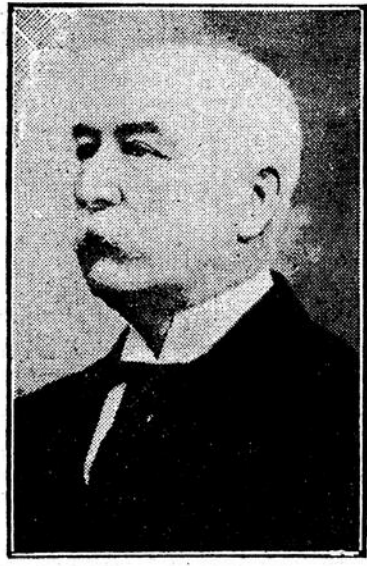
THE HON. MR. CROTHERS DENIES RESPONSIBILITY

Mr. Marcell Denounces Government's Closure Proposals and Debate Adjourns.

(Witness' Staff Correspondence.)

Ottawa, April 16.—The first break in the debate on the closure resolution since it was introduced by Mr. Borden on Wednesday last, occurred Tuesday, the entire afternoon being taken up with the consideration of a labor union.

Mr. Carroll, of Cape Breton, moved the adjournment of the House to discuss the action of the Departments of Labor and Immigration in connection

with the bringing into Canada of photo engravers to replace engravers on strike in Toronto and Montreal. He contended that they had been allowed to enter Canada in contravention of the law, and that the Hon. T. W. Crothers, who has charge of both the labor and immigration departments at the present time, had failed in his duty to the labor unions.

The Minister denied the truth of these allegations. He said that everything within reason had been done by the departments, whose action had been affected by a judgment given in the courts. He had administered to the best of his ability this law which had been passed by the late Government, and which was being enforced by officials appointed by that Government. He suggested the possibility that amendments to the law might be advisable.

Mr. Hugh Guthrie said that the present Government would never prosecute manufacturers for evasions of the law. A prosecution inaugurated by the late Government had been stopped, he stated.

Mr. Verville, the Labor-Liberal member for Maisonneuve, did not make a set speech, but simply entered a protest against the Government, as the inaction of the Government, and the matter was allowed to drop.

At the evening session the closure debate was resumed by the Hon. Chas. Marcell, the ex-Speaker of the House, whose chief criticism of the new rules was that they were more drastic than the British closure, because of the event of a decision to cut off a debate, such action could be taken on the second day, even if the debate had not been resumed. In the British House the matter would be left to the discretion of the Speaker.

The discussion was continued by Messrs. Michaud, Demers, Hughes, (P. E. L.) and Knowles, who spoke, and the adjournment was moved by Mr. McCraney, of Saskatchewan.

IN INTEREST OF RAILWAY MEN

When the House met, the Hon. George F. Graham introduced a bill to amend the Railway Act, it provides that the railways must secure the permission of the Railway Board before changing the location of terminal or divisional points; also that the railways shall pay all losses to employees on account of moving from one municipality to another. He remarked that the railway frequently find it necessary to change divisional points, and it was only fair that when they do so consideration should be given to the hardships such change entails upon employees. He instanced the case of the shifting of employees of the C.P.R. from a divisional point at Brockville, and the proposed change of the Grand Trunk divisional point at Brockville to Prescott. The latter proposal, if carried out, he said, would entail a heavy loss to the employees, who would be compelled to move to Prescott, and it was only reasonable that they should be reimbursed by the company.

Mr. Graham, in further explanation of his bill, said that it provides that when the loss to an employee cannot be agreed upon between the railway and the employee, the matter shall be referred to the Railway Board. He understood that the consolidation of the Railway Act undertaken by the present Minister was about complete, and asked that these proposals be included in the Act, or that the Government consent consideration of this bill being proceeded with.

The Hon. Frank Cochrane, Minister of Railways, rose to inform the House that a proposal on somewhat similar lines had been included in the Consolidated Railway Act to be introduced this session.

Mr. Webster, of Brockville, on behalf of the 200 employees of the Grand Trunk who will be compelled to move to Prescott if the company's plan is carried out, endorsed the proposal of the member for South Renfrew.

After brief speeches by Mr. Sixsmith, of East Peterborough, who protested against the proposal of the C. P. R. to change a divisional point from Havelock to Toronto, and the Hon. H. R. Emerson, the bill was given a first reading.

Mr. W. F. Carroll (Cape Breton), then moved the adjournment of the House in order to discuss an alleged breach of the Immigration law in connection with the strike of photo en-

gravers at Montreal, Toronto and other places, and the action of the government in regard to the matter. The strike, he said, commenced in Toronto some months ago, and it had been brought to the attention of the Hon. T. W. Crothers, Minister of Labor, and acting Minister of the Interior. The minister had been informed that the publishing firms affected by the strike had inserted advertisements in United States newspapers in order to induce strikers to come to Canada. The minister had also been notified that strike breakers were coming in from England contrary to the provisions of the law. The firms affected, after securing men in England, would put them in possession of a draft for \$50, the amount which the law stipulates that an immigrant must have in his possession on arrival in Canada during the winter months. These drafts would be turned in to the firms issuing them as soon as the strike breaker arrives.

ALLEGES LAW VIOLATION

Mr. Carroll said that this was a direct violation of the immigration law. Protests were held at the Photo Engravers Union of Toronto, but nothing was done until March 17th, when the Superintendent of Immigration, after laying the matter before the acting-minister wired the immigration agent at Halifax and St. John to watch out for photo engravers from England, and, if legally possible, to prevent them landing in Canada.

Mr. Carroll contended that this action was taken to circumvent the officers of the Photo Engravers Union because the acting-minister knew that no such action could be taken by his officials until a writ of habeas corpus was issued by the Governor-General-in-Council. Under the circumstances it is absurd to send photo engravers on strike, not over wages or hours, but touching the recognition of their union. When the facts of the case were presented to the Immigration Department, notice was given to the immigration officers at the incoming ports to see that no photo-engravers attempting to enter should be allowed to pass unless they complied in full with the immigration regulations. The department was warned that they might attempt to enter under the guise of some other trade or might come through the United States. The immigration officers were accordingly warned of this. Four men attempting to come in were arrested and held for deportation, but an application of habeas corpus brought before Judge Graham of the Superior Court at Halifax brought from him the judgment that they were entitled to their liberty. MR. CROTHERS JUSTIFIES HIS DEPARTMENT

Thomas Crothers, acting-Minister of Interior in replying to Mr. Carroll denied first of all that anybody should be allowed to enter Canada without the facts were that photo-engravers in Toronto numbering about ninety-eight, on strike, not over wages or hours, but touching the recognition of their union. When the facts of the case were presented to the Immigration Department, notice was given to the immigration officers at the incoming ports to see that no photo-engravers attempting to enter should be allowed to pass unless they complied in full with the immigration regulations. The department was warned that they might attempt to enter under the guise of some other trade or might come through the United States. The immigration officers were accordingly warned of this. Mr. Carroll had made much of the clause in the instruction to officers ordering action to be taken if that action could be legally taken. He said that there were no grounds for the charge of collusion which had been raised by Mr. Carroll. Mr. Carroll had asked why an order-in-council had not been passed dealing with the matter. Mr. Crothers said that such an order-in-council had never yet been passed and he doubted if it could be passed. Mr. Carroll had also suggested a board of inquiry, but the minister said that he had been appointed by the Governor-General, and that no such board had ever been appointed in the past. If there was fault anywhere it must be with the officers of the department appointed by the previous government and he doubted if the hon. gentlemen opposite wished to place a blame there. It was not the duty of the department at Ottawa, he said, on second-hand evidence and statements that were not legal evidence to the point of arresting men.

Mr. Crothers said that it might be that the immigration inspector at Halifax, had not carried out the order given. That might be a case whether the department was responsible, but theoretically it was not responsible. The Minister stated that it might be advisable perhaps to amend the law. The record showed, however, that reasonable efforts had been made to administer this act, which was passed by the late Government and was being enforced by officials appointed by that Government. He was not disposed, however, to criticize the officials and was perfectly sure that Mr. D. Scott, the superintendent of Immigration, had performed his full duty in regard to this matter.

Mr. Hugh Guthrie could not agree with the Minister that the Departments of Labor and the Interior were not to blame. Both departments, he said, but it was to be understood that the charge was not against the officials, but the Minister. This was another case he said where the rights of labor unions coming into contact with the manufacturers receive the correct kind of treatment and in many cases rank injustice by the present Government. This case, he said, was on all fours with that of J. E. Murphy, who deliberately broke the laws. A prosecution was commenced by the old Government, but it was stopped when the new administration came into power.

Mr. Guthrie said that there was a clause in the act giving the Minister specific power to keep out of Canada men of any particular class. The object of this clause was to prevent workmen from being imported to replace Canadian workmen on strike. Mr. Guthrie said he did not believe that the Government would permit the importation of men from the United States so long as he is Minister of Labor his first duty is to look after the interests of labor. The Minister had attended the Annual Meeting of the Labor Congress in Guelph, and had made many promises, but in so far as he knew personally he should remember that he had to carry out any of the promises made. There was he said a good deal of comment about this in labor circles.

SIXTEEN MINERS SUFFOCATED.
Hamborn, Germany, April 16.—Sixteen coal miners were suffocated by coal gas in a mine in a pit named the German Emperor, where fire broke out during the night.

Ottawa, Ont., April 16.—Miss Fern J. Willoughby, aged 21, eldest daughter of Mr. and Mrs. S. J. Willoughby, 291 James street, was instantly killed yesterday afternoon at four o'clock on the lawn in front of her home, when her motor car, which she was cranking, suddenly started, pinned her against a tree and broke her neck. Her mother was standing in the front window and saw her daughter killed. Dr. C. H. Brown, who happened to be passing, and other neighbors, ran to the assistance of the young woman, but before they reached her side she had succumbed.

GEN. BRAMWELL BOOTH.

Salvation Army Leader Expects to Rejoin Toronto November 1.

London, April 16.—Regarding the visit of General Bramwell Booth, of the Salvation Army, to Canada, the Canadian Associated Press states that he expects to reach Toronto by November 1. From there he will probably carry his campaign to other large centres for a fortnight, afterwards visiting Chicago and New York. This will be the General's first overseas campaign out of Europe since succeeding his father.

HOMOEOPATHIC HOSPITAL.

The annual report of the Homoeopathic Hospital of Montreal states that last year 895 patients were treated, including 183 children, a total increase of 12 patients. The public patients numbered 139, as against 141 the year before.

The outdoor department also treated 1,647 patients, as compared with 1,638 in 1911. The expenses for the year were \$20,843, and the fees from patients and dispensary totaled \$21,246, leaving a balance of \$396.
