GOVERNMENT WAS DEFEATED

Salisbury Ministry in Minority on Division—Its Stability Not Affected by Vote.

London, February 26.—Just before adjourning at midnight the Government was defeated in the House of Commons in a division on a question that does not involve the Government's stability, but tends to damage its prestige.

The subject under discussion was the hours of railway employees.

Major Cecil Norton, Liberal, complained that certain railway companies were not complying with the law and were overworking their servants, and he moved that the companies be compelled to make returns every six months with the view of checking the practice.

Mr. Gerald Balfour, president of the Board of Trade, on behalf of the Government, declared against the motion as it stood, although he was willing to accept it in a modified form.

The House divided on Major Norton's motion, which was adopted by a vote of 151 to 144, the Government being thus defeated by a majority of 7.

When the result was announced the Opposition burst into uproarious cheering, the Irish members being especially triumphant. An Irish wag awakened peals of laughter by shouting "A serious railway accident."

The defeat was due to the slackness of some of the ministerialists, and the absence of others from voting owing to their sympathy with Major Norton's motion.

Many members condemn Mr. Balfour's handling of the subject.

KING AT THE RACES.

Attended, To-day, the Kempton Park Steeple-chases.

HIS MAJESTY'S HORSE, AMHERST II, WAS THE WINNER.

London, February 26.—(Special)—For the first time since his accession, King Edward to-day appeared at the race course.

He went to Kempton Park steeple-chases to see his grand national "Amherst II." As was anticipated, the king's horse won.

BLONDIN'S CAPTURE.

HOW THE WIFE MURDERER WAS TAKEN INTO CUSTODY.

New York, February 26.—The manner of Blondin's capture was somewhat odd. Sometime Tuesday Blondin entered the office of the bureau of the Inspector of steam boilers, which is located in the same building as the police headquarters and applied for a license to run a steam engine. He stated that his name was Joseph Bernard, and that he lived at Eighty-Ninth street, and Madison avenue in this city.

BLONDIN'S STORY.

In Court the prisoner was remanded until to-day to await extradition papers. At headquarters he declared he had last seen his wife while he was seeing her off from the station at Boston. Hearing later of the discovery of her body, he feared, he said, that he would be accused of the murder and fled to New York. He said that he had lived in Brooklyn, Mount Vernon, and White Plains, and had made several trips as a coal passer on a North German Lloyd steamer. When arrested he said he was endeavoring to get the position of engineer in a hotel in which he worked.

PRINCE IN NEW YORK.

Entertained the President at Lunch Yesterday

THE EMPEROR'S GIFT TO MISS ALICE ROOSEVELT.

New York, February 26.—At the luncheon on the Hohenzollern yesterday, Prince Henry addressed the President as follows:

"Mr. Roosevelt, you are here on board as guest of His Majesty the German Emperor, and I really believe that it is the first time that a president of the United States of America has ever been on board one of His Majesty's ships. Please God, may it not be the last time. I wish to thank you heartily for the reception I have had from the first day I landed up to this moment, and it is my sincere and certain impression that there is a strong feeling of personal friendship arising between us. May it extend to the benefit of our two great nations. I propose three cheers for Mr. Roosevelt."

ROOSEVELT'S REMARKS.

The President arose directly to answer, saying: "I wish to express my hearty thanks for the kind words Your Royal Highness has expressed on my behalf and I wish you to understand that it is not an empty compliment that Your Royal Highness has won a genuine place in our affections and good will. I highly appreciate that His Majesty the German Emperor has sent you to the American people, and I thank you personally, and, what is of course, of much higher importance, that you have taken a step which naturally must knit closer together the two great nations, whose friendship means so much for the future welfare of the entire world. To express finally a personal wish of my own is to say that I look forward with great pleasure to the day on which I shall be your guest in your quality as admiral on board of one of your battleships."

PRINCE WAS GALLANT.

The Prince expressed his thanks to Miss Roosevelt, in the first place for the graceful way in which she performed the ceremony of christening the yacht. "We sailors are said to be superstitious," continued the Prince, and, turning to Admiral Evans, he said, "I believe, Evans, we are not, but however this may be, there will be a happy future to this craft from the fact alone that (turning to the builder of the yacht) she was built by hands of art, and was at her first appearance on the water linked with the name of a lady. We sailors are used to speak of our ship as 'her' and we keep and treat our ships like our wives. I drink to the health of Miss Alice Roosevelt."

THE KAISER'S GIFT.

Before the luncheon in honor of President Roosevelt a golden bracelet with a picture of Kaiser Wilhelm in diamonds was presented to Miss Alice Roosevelt. It was the Emperor's gift to the young lady as sponsor for the new yacht Meteor.

THE KAISER'S GIFT.

The presentation was made by Prince Henry on behalf of his brother, the Emperor. The Prince made a brief address and the young lady thanked him very much.

Freedom of New York.

Prince Henry was escorted to the City Hall in the afternoon. Thousands lined the route. At Wall Street the Prince had the hood of his carriage covered, and from the buildings came an avalanche of ticker tape and torn paper which almost covered him. "This he took in good kind saluting the showers. At the City Hall the Prince was received by Mayor Low and the members of the reception committee and escorted to the council chamber, where he was presented by Mayor Low with the freedom of the city. It is estimated 100,000 people attended to see the Prince leave the City Hall.

The Prince was dined last night by Mayor Low at the Metropolitan Club, and afterwards attended a gala performance in his honor at the Metropolitan Opera House.

THE ROSS MEASURE.

Rejected by the Ontario Prohibitionists.

CANNOT BE ACCEPTED AS FULFILLMENT OF THE GOVERNMENT'S PLEDGE.

Toronto, February 26.—The convention of the Ontario branch of the Dominion Alliance began yesterday at the pavilion with a large attendance. The members were eager to get at the prohibition issue, but a number of matters stood in the way. When at last the issue was reached there was a red hot time. Rev. Dr. Mackay, the president, made an impressive appeal for unity. A local paper had published a cartoon, showing the sun of prohibition on the horizon, with the query, "Is it rising or setting?" There was danger that in the tricks of politicians the money of the liquor interests and the unceasing divisions of temperance workers were to prevail that it would set, but must rise again.

After much discussion the convention adopted a resolution which read:

"That the bill introduced into the Ontario Legislature, making prohibition conditional upon difficult, unreasonable, and unjust requirements, cannot be accepted as a fulfillment of the Government's pledge and this convention expresses its deep regret that the Government is not carrying out the simple, definite promises of Sir Oliver Mowat, reiterated by Hon. A. S. Hardy, and the Hon. Geo. W. Ross, to introduce a bill to prohibit the liquor traffic to the limit of the declared power of the province."

KITCHENER REPORTS

Capture of Convoy Wagons by the Boers.

SEVERE FIGHTING IN WHICH A NUMBER OF BOERS WERE KILLED.

London, February 26.—(Special)—Kitchener reports that a convoy of wagons has been captured by the Boers near Klerkedorp.

The wagons were escorted by a company of British troops.

The fighting was severe, but there are no details.

Six hundred Boers driving cattle rushed the outpost line near Bothasberg.

Some got through, but the Boers left 15 dead and 6 wounded on the field.

MARCONI'S PLANS.

WILL SPEND SEVERAL WEEKS AT CAPE BRETON.

London, February 25.—Soon after Signor Marconi arrives in New York, whither he is now bound, he will spend several weeks in surveying the coasts of Cape Breton, where he proposes to construct a permanent wireless telegraph station, which will probably be the principal station in North America. Its establishment will entail prolonged labor but Signor Marconi hopes during the summer, to conduct tests preliminary to inaugurating a commercial service.

BRITAIN AND GERMANY.

Latter's Reply to Lord Lansdowne's Note.

Berlin, February 25.—The reply of Germany to the complaint of Lord Lansdowne, the British secretary of state for foreign affairs, concerning the publication by Germany of the despatch from Dr. Von Holleben (German ambassador to the United States) with regard to the meeting of ambassadors in Washington, held April 14, 1898, which asserts that Dr. Von Holleben misunderstood that action of Lord Pauncefote (British ambassador to the United States) at that meeting, maintained the correctness of Dr. Von Holleben's despatch.

The reply of the German Government suggests that the British publish Lord Pauncefote's report of this same conference.

EGGS.—There was a firmer feeling in the egg market. The demand was fairly good for small quantities and sales of fresh candled stock were made at 28c to 30c per dozen.

POTATOES.—Choice stock are in demand at 92c to 93c per bag, in car lots, and at 95c to \$1 in a jobbing way.

POULTRY.—Business in poultry was quiet, and the market was without any change. We quote: Good to choice fresh killed, dry-plucked turkeys sold at 12c to 13c; ordinary stock at 10 1/2c to 11c; choice dry-plucked chickens at 9c to 10c; good at 6c to 8 1/2c; ordinary at 6 1/2c to 7c; fowls, 4c to 5c; ducks, 8c to 9c; and geese, 5c to 6c per lb.

CATTLE MARKET.

London, February 24.—The easy feeling noted in this market for American cattle has since developed into weakness, the top price obtained to-day for choice being 12 3/4c, as against 14c a week ago. The strength in the market for sheep has been more than sustained, as prices show a further advance of 1-4c, with sales of choice at 12 3/4c.

MONTREAL.

Since our last report, nothing new of importance has developed in local export live stock circles, except that cable advices from both Liverpool and London, were of a very discouraging nature to shippers.

Receipts of live stock at the East End Abattoir market Monday morning were 600 cattle, 50 sheep and lambs, and 50 calves. A feature of the market was the demand from shippers for a few cattle to complete shipments with, and they bought good useful steers at 4 1/4c to 4 3/4c per lb. The supply was somewhat larger than usual, and in consequence an easier feeling prevailed, but prices do not show much change. The demand from butchers was good, and a fairly active trade was done. A few choice heaves were offered, which sold at 5c to 5 1/4c. Good stock sold at 4 3/4c, fair at 3 1/2c to 4c, and common at 2 1/2c to 3 1/4c per lb. The market for sheep was stronger and prices ruled higher with sales at 3 1/2c to 4c per lb. and lambs were firm at 4 1/4c to 4 3/4c per lb. The demand for calves was good at prices ranging from \$3 to \$13 each, as to quality. There was no change in live hogs. The supply was fair, for which the demand was good, and sales of selected lots were made at 6 1/2c, and the others at 6c to 6 1/4c per lb., weighed off cars.

THE TWENTIETH CENTURY SUNDAY.

Editor of the Record:

Sir:—At a lengthy legislative hearing on a question of legal restrictions of Sunday trade, a gentleman favored wider liberty because we are at the opening of a new century, implying that Sunday laws are a relic of the dark ages. Not at the darkest ages, he should reflect. They do not prevail now in "Darkest Africa," or in any dark and savage land nor ever did. Sunday observance is not a mark of rude uncivilized life. Only enlightened Christian nations observe Sunday rest, and protect the civil rest day by law, as a wise provision for the good of society. Not only savages, but bad men everywhere do without Sunday. Either they are not able to see that it is a necessity to live wisely, or they do not wish to live wisely. Just in proportion as men advance in enlightenment, and a desire to live according to the best light, they keep Sunday. There are exceptions, but on the large scale, and in the long run, exactly as men gain in spiritual insight, attain breadth of view, and a comprehension of the forces which govern human life, if they also are wise enough to conform their conduct to their increased knowledge, they will keep Sunday, and keep it with all their heart. This is absolutely sure. How do we know it? On the word of Him who cannot err, who is the TRUTH for He said "The Sabbath was made for man" for man as man, always and everywhere; not for Jews alone, not for certain centuries only, but for all the centuries, for the twentieth and the fortieth, for all those blessed and prosperous ages when human progress shall have lifted man to the high vantage ground of enjoying the blessings a kind Providence makes ready for his use. And of all these blessings, one of the richest in value in itself, and most prolific of other blessings is the day of Sunday rest and worship. And when God made the Sabbath for MAN He thereby declared that the Sabbath is something man needs in every age and land. It is indispensable to his property. Therefore a kind Heavenly Father will see to it that this precious gift shall not always be as pearls cast before swine. He will educate men and train them up to see what is good for them and will give them wisdom enough to take what is good for them. Men may spurn it now, for they are like young kittens—they have not got their eyes open yet. But the day of vision and of wisdom will come, if not for them, for "the coming man," the man who will not fly in the face of Providence, and trample its best gifts under his feet.

Through the voice not of written revelation alone, but through the cry of man's entire nature, body, soul, and spirit, by the examples of Christ, and by the Providential favor shown to Sabbath keeping and its good results. God has made known His will, man should take one day in seven, so far as the claims of necessity and mercy will allow, to rest the body and train the soul.
