The S.S. Quebec—The G. W. Wolf, arrived at Belfast, reports: "Disabled steamer sighted 9 p.m., 23rd, lat. 47 31, long. 25 57, under fore-topsail. Wind south-west. Straight stem, three masts, square rigged forward; distant two miles; ship hove to one and a half hours. Fired rockets; no reply. Oblige to bear away. Lost two sails next day. Gale north-west."—London Times, 31st January.

St. John's, N.B., February 13.—The owners of the tug Diego claim \$5,000 salvage for rescuing the barque Grace E. Canna from her perilous position in Minas Basin.

CHARLESTON, S. C., February 14.—Capt. Lea, commander of the pilot boat Atlanta, reports that on Monday, off the coast of Atlanta, it was struck by a tornado, torn in two and sunk. There were on board at the time besides Capt. Lea, his brother James, Joseph Myral, Andrew Gray, coloured; Wm. Green, coloured. The captain was picked up by his brother Capt. P. Lea, of the pilot boat Schaffer. The two negroes he knows were drowned, but he hopes that Lea and Myral are saved.

NEW ORLEANS, February 15.—The Austrian ship Imperatrice Elizabetha was burned near South Pass, valued at \$150,000. The crew escaped.

MONTREAL, February 15.—James J. A. Murphy, trader and tailor of Valleyfield, Quebec, has assigned. Liabilities light and divided among Montreal houses.

The adjourned meeting of the creditors of Louis Lewis & Brother will be held to-morrow afternoon, when the statement will be presented.

Lee & Newport, coal and wood merchants 154 William street, have assigned in trust for the benefit of their creditors to Mr. S. C. Pail. The liabilities are said to be very large.

Thos. Casey, carrying on business at Quebec, under the title of Casey & Co., as auctioneers and commission merchants, has assigned to Thos. Wells, Sr., of this city. The liabilities are large and divided for the most part among Montreal merchants.

Exercem & Monte, of the same place, general merchants and traders, have assigned to Messrs. Hugh Mackay and Jacques Grenier, representing the two firms in which they are principally interested. Liabilities do not exceed \$1,900, and everything is amply covered by the assets.

FINANCIAL.

There is nothing new to report in regard to the position of the money market. It was firm and unchanged, and brokers find more than ordinary difficulty in securing loans. There is a very good demand for accommodation from commercial borrowers, which speaks of an improvement in the trade circles. Prime mercantile paper can be readily negotiated at 7 1/2% to 8% and nature of the collateral, and 8% per cent. for less desirable. The dearth of money on call loans places the stock market in a dull and depressed state. Brokers have had scrapping to obtain what they require at 7 1/2%, and that with stiff margins. Sterling exchange was a shade firmer to-day in sympathy with the New York market. Bankers' 60-day bills are now quoted at 9, with 9 1/2 over the counter. Demand bills 9 1/2 to 10, and currency on New York about 1/2 premium.

The foreign exchange market in New York was firm. Commercial bills are still in demand. The posted rates were 4.83 1/2 and 4.87. The actual rates were as follows:—Sixty days, 4.83 1/2 @ 4.83; demand, 4.85 1/2 @ 4.86 1/2; cables, 4.86 1/2 @ 4.86 1/2. Commercial bills were 4.81 1/2 @ 4.82. Consols in London have advanced to 102 7/16 for money and 102 1/2 for account. United States bonds are weaker; 4 1/2% at 110 1/2; 5% 106 1/2; and American railway securities irregular; Erie, 37 1/2; Ill. Central, 148 1/2; Atlantic and Great Western first mortgage trustees' certificates, 55 1/2; New York Central, 129 1/2; Pennsylvania Central, 61 1/2; Mexican Railroad (limited), ordinary, 14 1/2.

At a meeting of the Directors of the Bank of England to-day the rate of discount was reduced to 3 1/2 per cent. As far as the money market is concerned this will bring the bank more into harmony with the general London market. The bank gained on balance yesterday £18,000.

India Council bills were allotted yesterday in London at a decline of 1-1/2 p. per rupee.

Paris advances quote 3 per cent. rates at 79 francs 15 centimes for account.

The New York money market is easy at 3 1/2 per cent. on call loans on stock collateral. The New York stock market is off again to-day. A continued feeding out of long stock and a steady tendency to lower prices, interrupted only by feverish rallies, due to the overselling by "bear" traders—these are the features of the stock market from day to day. Conservative houses understand the situation so well that they do not hesitate to express a belief in a much lower range of values, and outsiders are gradually dropping their holdings. The course of the market is unmistakable. The better classes of stocks are the weakest, and the support given by the cliques is gradually falling.

The Toronto market was quiet and slightly easier this morning. As a rule prices were higher than in Montreal, but the feeling seems to favour lower prices.

The local stock market was active though weak at the morning session, and in the afternoon a firmer tone was developed though transactions were very light. Bank of Montreal were buoyant and active opening at 207, declining on sales to 206 1/2 at the morning call but sharply rallied up in the afternoon to 207 1/2. Ontario were weaker falling from 112 1/2 to 112. Peoples were inquired for at 85 ex-dividend without sales being effected. Molsons were quiet at 130 bid, 132 asked. A round amount of Toronto changed hands at 184, closing weaker at 183 bid, 184 1/2 asked. Transactions in Jacques Cartier were affected at 113 1/2. Merchants were dull, a few lots sold at 125 1/2 @ 112 1/2, Eastern Townships were offering at 125, with bids at 120. A few shares of Union found a purchaser at 92, and trading in Commerce was done at 134 1/2, closing at 134 bid, 134 1/2 asked. Exchange were in offer at 170, with bids at 165 down to 160.

Federal were quiet and steady at 156 buyers; 155 sellers. Montreal Telegraph sold at 123 1/2, closing at 123 @ 124. A small lot of Richelieu changed hands at 63 1/2. City Passenger were inactive at 140 bid, 143 asked. There was a moderate business done in Gas at 185 1/2. Canadian Pacific sold up from 59 1/2 @ 60. St. Paul & Minneapolis were lower, offering at 139 1/2, with purchasers at 138 1/2. A few shares of CanAm Shipping found a sale at 95, and a small lot of Canada Cotton at 84. Dundas Cotton Co. were weaker, declining from 107 to 105. A round amount of Montreal Loan and Mortgage Co. was placed at 106 1/2, and North-West Land dropped from 59 1/2 to 58 1/2. RAILWAY NEWS.

—There is a rumour in Boston that Vanderbilt is seeking to purchase the Hoosac Tunnel.

—British Columbia advises as to the effect that there are now about 100 white men and 500 Chinamen employed on the railway works at Port Moody.

—The ties for the Erie and Huron have been contracted for, and a large number have been delivered along the line already.

—The Pullman Palace Car Company's earnings show an increase of \$4,000 per day, during January and \$1,500 per day so far during February.

—Railroad experts declare that over ninety per cent. of train delays are caused by hot journals. This could easily be remedied by the use of hollow axles.

—It is said that the Union Pacific surplus for the last calendar year, including

the proceeds of land sales, was \$700,000 less than for the year ending June 30.

—The Iowa commissioner's report gives the following figures for the North-West road project: Stock per mile, \$21,326; debt, per mile, \$24,396; stock and debt per mile, \$45,722.

—Denver earning for the first week in February show a decrease of \$4,000. The decrease ran as high as \$80,000 several weeks ago. There are now 1,160 miles in operation, against 1,062 miles a year ago.

—Notice has been given by the Lake Erie and Western R.R. connections that, owing to the floods along its line, it will until further notice, not be able to receive live-stock or perishable freight east of—

—We see it stated that an endeavour is being made by the Directors of the Nelson Valley Railway Company to secure a land grant from the Dominion Government along their proposed line running from Fort Churchill to the foot of Lake Winnipeg.

—The railbushers who are going to build the Ganoune branch of the Grand Trunk Railway, it is reported, are to receive \$10,000 in village bonds bearing six per cent. interest when the first engine reaches the river front.

—There are now about 115,000 miles of railway in the United States, which have cost, with the equipments, more than \$5,000,000,000. In 1881 1,000,000 persons were employed in operating and in constructing these roads, this number being almost equal to a seventh part of the male population of the United States. During the same year the roads paid out \$450,000,000 for wages and material.

—The Town Council of Niagara Falls, Ontario, have had a meeting about the new bridge, and have resolved that, considering the great benefit to be derived by this Town and County by the building of a bridge by the Canada Southern Railway across Niagara River at this point, they respectfully pray that the Dominion Government now in session do grant a charter for the same, and that a copy of the above resolution be forwarded to Dr. Ferguson, M. P. from this County, and Neil Kingsmill, Solicitor of the Canada Southern, both now at Ottawa.

—The purchases of private railways by the Prussian Government have caused a great revolution in Prussian stocks, the shares having been exchanged for Prussian consols. In the years 1851, and 1852 the Prussian Government purchased 128 million marks to have been provided with the Government's stamp; 313 were presented, 215 are still in arrears; 1,014 million marks worth of shares are intended to be exchanged for consols; 370 millions are already exchanged, 644 are still in arrears. Of this enormous amount not more than 32,800 marks worth of shares had to be paid for in cash.

—According to the figures compiled by the Commercial and Financial Chronicle, 191,000 railroads in January earned \$16,602,138 against \$18,225,763 for the same month in 1882. Increase for 1883, \$1,376,675; mileage in 1883, 47,430, in 1882, 43,277; increase, 4,153. Nineteen of the sixty-one roads show a decrease in earnings; the heaviest in North-West, \$262,230; Union Pacific, \$291,000. The roads that show the heaviest increase in earnings are Texas Pacific, \$210,542; Missouri Pacific, \$179,555; Grand Trunk, \$153,883; Northern Pacific, \$146,667; Iron Mountain, \$148,889.

—The reports that some of the roads running eastward from Peoria are and have for some time been carrying grain from that point to the seaboard at a cut rate of 5 cents below the schedule case, and a statement in railroad circles. Commissioner Fink treats the affair lightly, but adds that should the cutting assume such proportions as to materially affect the business of the trunk lines, the latter will at once take measures to stop it. He denies that any cuts have been made by the trunk lines on east-bound business, but this charge has been made so repeatedly that a good many people are beginning to doubt the truth of the matter, and dispatch from Chicago is far from reassuring: "It is asserted that on account of the Peoria lines cutting rates to the seaboard from 33 to 28 cents, they are gradually getting business from the Chicago lines, and that the latter are quietly introducing a cut from here to New York of 5 cents; but the officials still deny that they are shading rates."

—A report comes from Boston that the efforts of the Grand Trunk Railway to secure additional facilities on the seaboard has given rise to many rumours of consolidations, which have, on investigation, proved to be groundless. To-day, however, it is semi-officially announced that the contract between the Boston and Lowell and the Concord railroads will be terminated March 1 and that General Manager Sherburne will retire. It is also said that the Concord Railroad will lay a second track on the Nashua and Acton Railroad and build a road to some point on the Nashua and Acton road to Boston. General Manager Sherburne does not deny the report that he is to retire, but says the Grand Trunk will seek an eastern terminus at Portsmouth, and that the Boston, Concord and other central New Hampshire railroads will petition the next Legislature for leave to consolidate, as it is impossible for any Massachusetts corporation to get a charter to build a competing line to Concord.

PRODUCE AND PROVISIONS.

MONTREAL, February 15.

—The resistance brought to bear by buyers against further additions to cost has not prevented sellers from asking more, and our quotations are somewhat below the views of the latter. At the same time there is no chance of concessions being made, still the amount of flour offering is moderate, and this adds more firmness to the market. Superior extra is held by some dealers at \$5.20, with a small business progressing at \$5.15. A round lot of extra was placed at \$5, and

nothing can be bought under that. Spring extra commands \$4.55 @ \$4.90 in a small way. Low grades are firm but inactive at the prices given, while Ontario bags are scarce and very firm at quotations. On "Change to-day buyers were not prepared to acquire in the higher values of holdovers and little was done. Reported sales were 125 barrels extra at \$5; 250 Ontario strong bakers at \$5.25; and 250 Ontario bags at \$2.45 with bags. The following are our quotations:—

GRAIN.—With the exception of the firmness exhibited by sellers there is simply nothing to note in the wheat market, as buyers persistently refuse to buy any wheat near the prices asked; consequently business is within narrow limits. We quote prices firm as follows:—

Canada red winter wheat, \$1.16 @ \$1.17;
Canada white, \$1.11 @ \$1.12; and Canada spring, \$1.10 @ \$1.11. Other grains remain quiet, but prices are firm. We quote peas 90c @ 91c; oats 35c @ 36c; rye 75c asked for May; barley 30c @ 30c, and corn 75c.

—Yesterday there was heavy speculative buying of wheat in Chicago on the reports of crop damage and the marked stability of foreign markets which sent prices up so rapidly. At the opening this morning a continuation of speculative buying forced up prices, but the market proved to be more sensitive than was expected, as the upward movement was sharply arrested, and then fell back considerably. In corn the general feeling of confidence, prompted by prospects of lighter crops, was partially neutralized by the decline in wheat, though a noticeable advance over yesterday was established as the net result. The estimated receipts for to-morrow were 27 cars spring wheat, 26 winter, 424 corn, 114 oats, 57 barley, and 18 rye.

DOMINION PARLIAMENT.

First Session—Fifth Parliament.

HOUSE OF COMMONS.

OTTAWA, Feb. 15.

The SPEAKER took the chair at 3.20 p.m.

Several petitions were presented.

Sir JOHN MACDONALD laid on the table the report of the Committee appointed to strike the Standing Committees.

NEW BILLS.

Mr. BEATTY introduced a bill entitled, An Act for the discharge of past insolventcies.

The bill was read a first time.

He also introduced a bill for the equitable distribution of insolvent estates. He explained that it was similar to the bill he had introduced on the same subject last session.

It provided that when a man was unable to discharge his liabilities he might go into insolvency, and that the estate should be equitably divided among his creditors. It did not permit of any preferential claims.

THE NORTH SHORE AND INTERCOLONIAL RAILWAY.

Mr. LANDRY asked whether the Government have come to any understanding with the present proprietors of that part of the Quebec, Montreal, Ottawa & Occidental Railway, now more particularly known under the name of the North Shore Railway, in relation to the construction of ferry boats to ply between the terminus of that railway and that of the Intercolonial Railway, and what that understanding is?

Sir CHARLES TUPPER replied that no understanding had yet been arrived at on that subject.

PUBLIC RETURNS.

Sir S. L. TILLEY laid on the table the Public Accounts for 1882 and the Auditor-General's report.

Mr. BOWELL laid on the table the Trade and Navigation returns for 1882.

The House adjourned at 3.35 p.m.

PROVINCIAL LEGISLATURE.

Second Session—Fifth Parliament.

LEGISLATIVE ASSEMBLY.

QUEBEC, February 15.

The Speaker took the chair at 3.15 this afternoon.

Several petitions were presented, amongst others one by Mr. Shelyin from the Municipality of St. Sauveur, praying for incorporation as a town.

NEW BILLS.

Mr. Robertson introduced a bill to change the name of the Oxford Nickel and Copper Co. Mr. Poirer introduced a bill to enable the Rector and Churchwardens of St. James' Church, Hull, to sell certain immovable property and invest the proceeds thereof.

Mr. Wats introduced a bill to divide the electoral district of Drummond and Arthabaska in two electoral districts.

THE C. P. R. TRAIN SERVICE.

Mr. Marion moved for copies of all correspondence respecting the fulfilment of the condition contained in the deed of sale passed between the Government and the Pacific Railway Company.

He called attention to the irregularity of the train service on the Laurentides Branch, quoting from the contract made with the Government to show that the Pacific Railway Company was bound to run a train each way daily. This had not been so far the case, but he hoped the Government would see to the due execution of the contract.

Mr. Joly said the complaint was carrying out the predictions made by the Opposition last session when they had said that the Pacific did not require the branches of the western section of the Q., M., O. & O., which were, however, forced upon them by the Government.

Mr. Mousseau said the matter had been considered by the Government, who had called the attention of the Pacific Railway to the question, and had received assurances that the contract would, in future, be faithfully adhered to.

Mr. Mercier wondered why these instructions had only just been given, instead of some months ago.

Mr. Mousseau said the matter had only lately been brought under the attention of the Government.

Mr. Mercier said the Government must have been aware that the local press had been complaining of the matter for five months past.

Mr. Mousseau said the Government was not supposed to take any action on complaints of the press so long as the people interested appeared satisfied and made no representations to the Government. So long as they made such representations the Government took immediate action.

SETTLERS' GRIEVANCES.

Mr. Richard moved for copies of the correspondence, documents, &c., respecting the promise of a grant of certain land lots made to Mr. Conter, of St. Donat, County of Montcalm. He explained that the Government, by one of its ministers, had promised to the party named in his motion some 12 or 15 lots of land if he succeeded in opening up a certain settlement in the county. Mr. Conter had settled some families on the land in question, but the Government had not complied with the conditions to which he assented. He argued at length that the duty of the Government was to exercise a paternal care over colonization, especially in new districts of the country.

Mr. Flynn said that the pretended claims of Mr. Conter had received the attention of the Government of which he had been a member and reports on the matter were ordered by his Department.

Mr. Blanchet said that only a few days since this matter had occupied the serious attention of the Government. The mover of the resolution and the House might rest assured that the Government would never be found wanting in its duty towards colonists.

THE REPLY TO THE ADDRESS.

Before proceeding to the Orders of the Day, Mr. Mercier said he wished to raise a question of privilege. On the 22nd of January last the address in reply to the Speech from the Throne was adopted by the House, the usual committee being struck to present it to the Lieutenant-Governor. From that day to this the Government, who, upon their own showing, were only a Committee of the House, and, as such, bound to execute its orders, had not reported in any way whether the address had been presented or not. This was altogether unusual and unconstitutional. He, therefore, offered a motion censuring the committee for not reporting His Honour's reply or the grave reason for which he had refused to reply to the House's address.

Mr. Mousseau said that he admitted the dignified and serious air with which the Opposition leader lectured the House and usurped the function of the government. Ministers thoroughly understood and had in no way failed in their constitutional or parliamentary duty. As soon as the address was presented they had communicated with the Lieutenant-Governor and had appointed a day with him for its presentation. But unfortunately on that day through sickness or

some other cause His Honor was absent and since then he had gone to Ottawa and had not yet returned.

Mr. Flynn said that he would vote against the motion in consequence of the explanation of the Premier, showing that ministers could not be held responsible for the delay, owing to the physical impossibility of obtaining an answer from the Lieutenant-Governor.

Mr. Joly said the Premier could not take any responsibility upon the Lieutenant-Governor. He must take it all upon his own shoulders and he was surprised at the ground taken in the matter by the member for Gaspé.

Mr. Irvine said it was perhaps very unimportant in some respect whether an answer was received upon the Lieutenant-Governor but the matter was different when the principle involved was taken into consideration. He protested against Mr. Flynn's assertion that the Premier was not responsible for whatever omission had occurred, even for the absence of the Lieutenant-Governor. If that absence affects us the Premier must be held responsible. The Lieutenant-Governor, as fully exemplified in the unjust dismissal of Mr. Letellier, which was so fully explained by Mr. Flynn himself some years ago. He would like to be informed how the Lieutenant-Governor could possibly be absent from Quebec, while the Legislature was sitting, when the Constitution laid it down in strict terms, that he was an integral portion of it. Even the estimates which they hoped to be able to consider at some distant date could not be taken up without a message from his Honor. This message might be sent from some place in England or the United States as from Ottawa, which was equally beyond our limits. It may be the Address and reply are mere empty forms and should be done away with, but while they remain a part of our system they must be correctly observed. Mr. Stephens said there must be some mistake about this affair. The document must surely have been a very heavy one. It was placed on the table of the House and, yet several members of the House had been invited to dine with his Honor since the Address had been voted. It might be said that this business was all a matter of form and he hoped that it would lead to a reform in the office of the Lieutenant-Governor, which now cost us \$20,000 to \$30,000 a year. He believed all the work of the office could be done for \$2,000 a year. If they could get along so well without the Lieutenant-Governor for such a length of time he submitted to the House whether his services could not be entirely dispensed with and an annual saving effected of \$31,000, which meant the interest on \$500,000.

In reply to Mr. Blanchet, who defended the conduct of the Government, Mr. Marchand asserted that it was not the Opposition but the Government who had introduced the name of the Lieutenant-Governor into the debate to take shelter behind it. Mr. Desjardins, seconded by Mr. Flynn, moved an amendment that the House is satisfied with the explanations of Ministers and passes to the order of the day.

Mr. Cameron said it was notorious that for days after the passage of the address the Lieutenant-Governor had been at Spencer Wood, and that the responsibility for its non-presentation, therefore, did not lie with him, but with the Government.

Mr. Robertson remarked that the Government had no doubt been careless in the matter, but if they were guilty of nothing worse this session, he, for one, was willing to pass this matter over.

Mr. Gagnon argued that the Lieutenant-Governor did not yet constitutionally know whether his Ministers had the confidence of the House, and that the House could not vote the supplies to the Government under the circumstance.

Mr. Irvine thought if the Government told the House the real reason why the address had not been presented, instead of getting one of their friends to move an amendment to ask the question, it would be much more satisfactory. The truth was that the minds of men were so much troubled with other matters that they had altogether forgotten about the address.

Mr. Wurtels said it was nonsense to pretend that the Lieutenant-Governor was constitutionally not aware that the Ministry possessed the confidence of the majority of the House when its proceedings from day to day were regularly transmitted to His Honor whether he was in Quebec or not. The only loss the country had suffered in the whole of this matter had been the loss of a whole afternoon to the House in discussing the rival question raised by the Opposition leader.

After remarks from Mr. Asselin, Mr. Mercier said the tone of the discussion had taken reminded him of the verdict of the jury who declared the prisoner "not guilty, but that he should not do it again." That was really the position in which the Government were placed in this matter by their own followers. He went on to argue that the excuse offered by the Government for the failure to do their duty was lame and unsatisfactory. Ministers could find the Lieutenant-Governor when they wanted to let a message from him to the House, as he had done on the 11th and 12th inst. It was very strange that they could not find him under other circumstances. He also complained generally of the unreadiness of the Government to go on with the business of the country.

Mr. Desjardins spoke in support of his amendment until six o'clock, when the House closed.

AFTER RECESS.

Mr. Desjardins, continued in support of his amendment and was followed by Mr. Marchand, who referred to the records of the Legislative Council to show that the Lieutenant-Governor replied to the address of that House on 2nd February, and could have equally replied to the address of the Assembly if Ministers had done their duty. He moved in amendment to the amendment "that the explanations of Ministers cannot be accepted, by those explanations it is admitted that the order of this House was executed, and that the address has not yet been presented to the Lieutenant-Governor, owing to his illness; that it appears nevertheless by the journals of the House that on 3rd January last, the day after the address was presented to the House, the Lieutenant-Governor transmitted messages to the House, proving that in those days his Honor was not absent from Quebec nor incapacitated by sickness from signing messages; that it appears moreover by the votes and proceedings of the Legislative Council that his Honor transmitted a message signed with his own hand, to that House on the 2nd of February, thanking it for its address in reply to the Speech."

The debate was continued by Messrs. Irvine, Wats, Blanchet and Mercier until after nine o'clock, when the House adjourned until next and lost on division.

Mr. Desjardins' amendment to the main motion, proposed by Mr. Mercier, being carried on the same division.

The bill to amend the charter of the City of Hull then passed its third reading, and the bill to incorporate the Rimouski and Gaspé Railway its second reading.

Mr. Mousseau moved that after Thursday next all Government measures take precedence.

The motion was passed.

On the order for the third reading of the bill to aid the maintenance of common goals, Mr. Gagnon objected that this bill was irregular, as it involved new taxation and should have been introduced by a message from the Lieutenant-Governor.

After some discussion a correction was made to meet Mr. Gagnon's objection and the bill was read a third time and passed.

The House then adjourned at 10.15 p.m.

THE ASYLUM CONTRACT.
On Monday evening Mr. Laberge brought up in the Local Legislature a subject of considerable importance—that of the disposition of our lunatics—a topic the most important, considering that the existing contract with the Beauport Asylum expires in the course of a few weeks, and some action has at once to be taken for the requirements of the immediate future.

that of having these poor people treated as well and as economically as possible. So far we have not heard that the Longue Pointe Asylum (the St. Jean de Dieu) is not as efficient and well managed an institution as the other; nevertheless, for the satisfaction of having the lunatics at Beauport, near Quebec, the seat of Government, the Province pays for 650 of them \$43 per head more than there is any occasion to do, a nice little item of \$27,950 per annum uselessly taken out of the Treasury. Besides, there are a number of others for whom \$52 too much is paid. Here then is a chance for economy, other conditions being equal, and here is a sum of money saved that would materially help the Treasurer in maintaining the equilibrium between receipts and expenditures. Mr. Mousseau has declared that the administration is not a committee of the House. In this admission we find a still further reason why any arrangement for the future should be submitted to the members before being resolved upon. The Government of which the present is the lineal descendant, and the legitimate heir to everything, bad as well as good for which its predecessors were responsible, will not, it is to be hoped, particularly since Mr. Mousseau has before time been the policy, to ignore its duty to the House and without consulting it, ratify a fresh contract, no matter how advantageous it may appear to be. The Province has to determine upon the course which it will adopt for a few years to come. If the Government proposals are such as shall commend themselves, we are certain that the members will not factiously oppose them. The House was, however, elected to direct and supervise matters of this kind and it will be an usurpation of its functions if Mr. Wurtele or Mr. Mousseau should undertake to arrogate to themselves their powers and prerogatives. An honest and businesslike proposal will be dealt with in a proper spirit, and we hope ere long to hear what the Government is going to do about it.

ASSIMILATION OF THE FRANCHISE.
In the Speech from the Throne at the opening of Parliament, a measure respecting the assimilation of the franchise throughout the Dominion was foreshadowed. As this is a reform in the right direction, we must give the Government credit for what our American cousins call "smartness" in stealing the thunder of their opponents. If they provide the country with a good, simple, and workable law, we shall not complain; though they and their supporters will, as usual, claim all the credit for passing a measure forced upon them by public opinion and the arguments of their opponents. In questions relating to the qualification of voters, as in all other questions, the Reformers have ever been in advance of the honorable gentlemen who at present occupy the Treasury benches, and if the latter now see fit to adopt views long ago advocated by others, we can only congratulate them on their conversion, and express the hope that they may not disappoint the people by bringing down a half-and-half measure. At the Quebec conference the franchise was one of the details talked over, but as it was not a matter of vital importance it was allowed to remain in abeyance, with the understanding that the system of voting then in force in each Province should remain undisturbed until the introduction of a new system applicable to the whole Dominion. Though changes have since been made in the manner of voting, and even in the qualification of voters in some of the Provinces, the arrangement is still the same; and the result is anything but satisfactory. What the country wants is a uniform law, a uniform system. The franchise should be the same in every part of Canada, so far as voting for members of the House of Commons is concerned, no matter what the local qualifications may be. Under the present system a young man in Ontario who, as a farmer's son, has the right to vote, would be left out in the cold, were he to move into Quebec and occupy a corresponding social position. This is absurd, and the sooner a change is made the better. In making this change the Government cannot move backward; they must approach the position of the Province that is farthest advanced in this respect, otherwise they would disenfranchise, without good cause, a large number of persons who are now on the voters' list. We have no means of knowing what the programme of the Government is; but no doubt it will not vary greatly from the Ontario law, though we hope it will go even a step farther. A few years ago when farmers' sons, residing on the homestead, and not yet holding property in their own right, were enfranchised, the sons of mechanics, merchants and professional men, living in the towns and cities, contended, certainly not without reason, that they had been slighted or overlooked. If a young man in the country could give an intelligent vote, they held that surely his cousin in the city was quite as capable of doing so, and might with equal safety be trusted with the ballot. Mr. Mowat admits this now, and there is every reason to believe, from what has been said on the platform during the present campaign, that at the next session of the Ontario Legislature a bill will be passed extending the franchise to those who now demand it in the centres of population. While we do not advocate universal suffrage, we believe that a measure somewhat similar to that now in force in Ontario, with amendments in the direction indicated, would prove acceptable to the people. Confer the right to vote on the sons of farmers by all means, but at the same time grant the same privilege to young men in our towns and cities. In these days of schools and colleges there are few men who have not received a good education, whereby they are enabled to form an intelligent

opinion for themselves on the questions that come up from time to time for public discussion. Surely their voice should be as loudly heard as that of the illiterate man who, knowing perhaps little or nothing of one party or the other, has the right to cast his ballot, simply because he pays a few dollars a year in the way of rental, or is the freeholder of a small piece of land. We would not go so far as to insist on an educational qualification (it is a farce where it is in force in some portions of the United States) but we do hold that young men of education, who are earning their own living, and have an interest in the welfare and prosperity of the country, should no longer be kept away from the ballot box. We have got beyond the days of property qualification for Parliamentary purposes. So far as Municipal elections are concerned, that is another matter. The taxation of our houses and lands is the question then directly involved, and those who own the property should be the persons to say who shall have the management of civic affairs. But when we come to select those who are to represent us in Parliament, the people of all classes, degrees and creeds, should have their say. The governments of all constitutionally ruled countries are finding out this fact. Before the session of British Parliament which was opened yesterday, comes to the end of its work, it is almost certain that the agricultural laborers, who have been kept down for centuries, will have been kept down on them the same right at the polling booth as the lord of the manor. This is one of Mr. Gladstone's promised measures of reform, and he is certain to carry it out. The Ottawa Government have before them a clear field. They have an opportunity of doing the country a great service in sweeping away the present incongruous system, and establishing in its place a sound, common sense law that will have force in every part of the Dominion. A semi-official announcement is made to the effect that it is their intention to bring down a bill exceedingly liberal in character. Let us hope that this may prove to be the case, and that hereafter our young men of all classes shall have a voice in deciding the affairs of the nation.

LIVING IN MANITOBA.
A great deal of gross misrepresentation is made, presumably by interested parties, about the cost of living in Manitoba and the North-West. We dare say, luxuries are more expensive, but what we are more concerned in is the cost of living to the farming and travelling communities. Almost every conceivable article of food is raised in the country now, and of the finest too. Two years ago of course there was an immense difference, we admit, when large imports of food had to be made, but it is entirely different now, the immigration to these vast regions having changed the whole situation. We extract from the Times of Winnipeg the prices of a few articles to elaborate our case, convincing enough, we have no doubt, to change the notions of those who exaggerate the precise state of things in that new country. The supply of wheat is about 100 lbs. per bushel, and is quoted at 9¢. @ 11¢. per lb. Lake Superior Trout 12¢. Choice dairy butter 30¢. @ 35¢, and the lower grades at 21¢ @ 24¢. per lb. Eggs 35¢. @ 38¢. Roast beef 12¢. @ 20¢, and corn beef 10¢. @ 12¢. Potatoes are the only dry article on the list, which are readily saleable at \$1.50 per bushel, but that price cannot affect the farmer, except formally, because there was an enormous crop last season. For beef, mutton, butter, eggs and fish, we pay about as much here, and if we understand the quotation for flour, there is little or no difference at all; if any, we fancy it must be in favour of Manitoba, because the price of Patents is \$3.10 @ \$3.20, and Baker's strong, \$2.25 @ \$2.50; these rates, we presume, representing bags of 100 lbs. each. It would not be worth while exposing the absurdity of these malicious stories, were it not that they might reach the eyes or ears of intending settlers in the new Territories. The evidence is overwhelming that the country abounds in everything which is required for the maintenance of man and beast.

MUNICIPAL ELECTIONS.
We publish this morning our report of the municipal nominations, from which it will be seen that a battle royal has been commenced between Mr. Beaudry and Mr. Bulmer. Our sympathies are with Mr. Bulmer, the representative of the English Protestants; we hope he will be returned. He has our heartiest good-will. We had hoped that there would have been no such controversy, but having been entered upon, we advise all our friends to leave no effort untried to secure the election of Mr. Bulmer. The proceedings in the different Wards will be found in another column.

A HEARTLESS case of fraud has just been unearthed in Edinburgh, the sufferers being the widows and the orphans of dissenting clergymen, who are dependent almost solely on the Dissenting Ministers' Friendly Society of Scotland, whose capital amounted to about \$150,000, to represent which there is only about \$25,000 left. The defaulter is an Edinburgh accountant named Donald Smith Peddie, who suddenly disappeared. The chief peculiarity in the case is that Peddie did not hold any recognized office in connection with the society. His brother, the Rev. Dr. William Peddie, of Edinburgh, has been nominally treasurer of the Society for the last 37 years, has been re-elected annually, and has drawn the salary of that office; but the whole of the business of the Society has been managed during these years by Donald Peddie for his brother, who seems to have given him half of his salary. The directors exonerate the Doctor from any connection with the fraud—rather sympathize with him, but do not propose to

live him of his legal responsibility. Donald, it was reported, had gone to Spain, but he was lately reported to have been buried in the Potter's Field at Philadelphia. He was 74 years of age.
The London Times, in a five column article on the diplomatic correspondence of Prince Bismarck says that of "all ambassadors, Americans are probably the best. With them diplomacy is a profession, but not one that requires any preliminary training and outfit beyond the possession of an educated, open mind (with manners, if possible, in accordance) and a seeing eye. Their idea of the representative or honorable-spy function is the true one, as any one may convince himself by turning up a volume of their 'Foreign Relations.' Nothing is too small for them to make note of. Nothing escapes their observation, and whatever they observe they report." This may be true or it may not; but one thing is certain, and that is that the American diplomats generally get the best of it when they measure swords with Europeans.
ONE may well imagine the excitement in the vicinity of Trafalgar Square, and the British House of Commons, when Mr. Bradlaugh drove to Westminster followed by 5,000 people. That there was no disturbance is most remarkable, considering the class that the Member for Sheffield was leading. On the reading of Mr. Bradlaugh's letter by the Speaker, it must have been most gratifying to the expelled Member, to know that the Premier proposed offering the affirmation bill, the vote on which will be looked for with great public interest. The crowd appeared well satisfied and dispersed without any demonstration. So far Mr. Bradlaugh will be gratified. Last night's proceedings will no doubt be accepted by the political outcasts friends as a triumph.
A DESPATCH from Ottawa, states that it is the intention of the corporation of that city to re-impose the income tax on all members of the profession, and they are perfectly right. It will be remembered that this tax was declared to be illegal by the courts some time ago, though on what grounds the lawyers alone know. The civil servants enjoy all the rights and benefits that arise from improvements made by the city, and they should pay their taxes the same as other people.
OBITUARY.—Our obituary column this morning contains a notice of the death of Mrs. Reginald Force at Axeter, Devonshire, England, at the ripe old age of 82. Mrs. Force was the mother of Mr. Anthony Force of this city, whose friends, we are sure, sympathize with him in his bereavement.
It may not be dispointing to the house, but it is very much so to the public that for a week back we have been promised the Treasurer's statement, certainly on Wednesday, and now we are only to have it to-night, if we can rely upon the last announcement.
An important dispatch via the Canada Mutual Telegraph Company, respecting the Phoenix Park murders, will be found under our telegraphic head. The evidence appears now to be complete and probably eight or ten will be involved in the crime.
The Ministerial ranks at Quebec appear to be somewhat disturbed just now. The Premier has several times lost control of the house and is not very successful in leading the Government.
THE RIGHT HON. W. E. GLADSTONE, the British Premier, entertained H. R. H. the Prince of Wales, on the 30th ult., at Cannes, where they had been on a short visit.
The English Cricketers at Sydney, Australia, under the captaincy of the Hon. Mr. Bligh, defeated the Australian team by 69 runs, at the match recently played.
THE MERCHANTS' Association, of Belfast, report the linen trade of 1882 as having closed satisfactory. The present year has opened with moderate prospects.

QUEBEC CORRESPONDENCE.

The Budget—Mr. Garneau Retains His Seat—The Game Laws—Railway Committee—Private Bills—The Hochelaga Mills—Mr. Senecal's New Company.

From Our Special Correspondent. QUEBEC, February 14. The Treasurer will positively make his Budget speech to-morrow morning.

Mr. Garneau will retain his seat in the House. There is no doubt that he offered his resignation, but present appearances are that he has been induced to reconsider his decision.

Messrs. Nelson, Parker and Boyer were here to-day as a deputation from the Fish and Game Club of Montreal, to ask that no amendments be made to the game laws.

Hon. Mr. Lynch has given them a satisfactory assurance to that effect, and they left for home to-night, perfectly satisfied with their mission.

The Railway Committee met to-day, and reported in favour of extension of time for receiving petitions to private bills to 28th inst. They also took into consideration, but without deciding, upon the merits of the following bills:—Those respecting the Chicoutimi and Saguenay Railway Company; the St. John, Naperville and Huntington Railway Company, and the Lake St. John Railway Company.

In the Private Bills Committee this morning there was a strong fight on the bills respecting the municipality of Hochelaga presented by Messrs. Beaubien and Marion respectively, that by Mr. Beaubien to incorporate the town of Hochelaga being promoted by himself and Mr. Prefontaine, the Mayor, and that of Mr. Marion, by Messrs. Barand and Beauchamp.

Mr. Marion's bill proposes to extend the territory of the municipality of Hochelaga into a separate municipality, the position referred to being that comprised between the south-west line of lots numbers twenty-eight and twenty-nine of the official cadastre of the village of Hochelaga, the river St. Lawrence, and the north-eastern and north-western limits of the said municipality.

The reason urged for the division is that the separation is compulsory principally of country lots and does not require the use of the fire brigade and other town appliances towards which it would be compelled to contribute if regularly united with the proposed town.

Messrs. Beaubien and Prefontaine, on the other hand, held that this district would participate in the benefits arising from the town's incorporation, and should be made to contribute its proportion of revenue.

The preamble of Mr. Beaubien's bill was proven and the other defeated. Mr. Senecal's bill for the incorporation of his new joint stock company, with a capital of \$10,000,000, was printed in French to-day. The English copies are not yet printed. The only foreigners amongst the promoters are R. J. Kimball and Louis J. Belloni, New York, Rene Manzaize and Emile Bonnemont, of the Legion of Honor, Paris, France, and Senator Bradley Barlow, of St. Albans, Vermont.

THE ESTIMATES. The estimates of the Provincial expenditure for the fiscal year ending 30th June, 1884, were distributed this evening. The chief items are the following:—

DISASTROUS RAILROAD COLLISION.

Two Trains Collide on the G. T. R. near Hamilton.

THE LIST OF KILLED AND INJURED

HAMILTON, Ont., February 15.—A fearful accident occurred this evening on the G. T. R., three miles west of here. The passenger train from the Suspension Bridge which should arrive at 2.45, arrived at about five. The passenger train from the west was eight minutes late.

The conductor of the west-bound train got his clearance order, and his train started out with two engines and sixteen coaches. When about three miles from the city, on an up grade rounded a curve, the train from the West was seen rapidly approaching, and though the engineer whistled and put on the brakes, a disastrous collision occurred.

The three locomotives were piled in a heap on the track. Halford, the engineer of the train from the West, with his fireman, jumped, and were saved. The driver of the pilot on the train from the East was scalded to death.

Fred Williams, his fireman, jumped and escaped injury. Temple, the regular engineer of the train from the East, with his fireman, escaped. Rogers, baggage-man on the Pacific express, the train going west, had his arm broken.

Chas. Douglas, commercial traveller for Burr & Singer, furniture manufacturer of Guelph, was returning home from the east when the collision occurred. The smoking car was telescoped and his head was jammed and he died instantly.

The dead are Edward Mann, engineer, Hamilton; Chas. Douglas, commercial traveller, Guelph. The injured are Geo. Leveque, from Rochester to Chicago; John Misanan and Wm. Misanan, father and son, from Rochester to Chicago; Wm. Kalpen and Mina Kalpen, husband and wife, from Rochester to Nilesville; Wm.
