## RUSSIA WILL CONTINUE WAR.

### Czar Said to Have Reached This Decision—While Possibility of Victory Remains Would be Cowardly to Talk of Peace.

Berlin, Germany, Feb. 23.—(Special.)—The Emperor of Russia has elected to continue the war.

The Emperor's position is absolutely firm and the German Court has been advised in this sense.

The war will be pushed with the utmost energy, the domestic situation being now within the control of the authorities.

In the judgment of the chief of army, Gen. Oyama cannot defeat Gen. Kuropatkin, but stands in great danger of defeat himself.

The Emperor, therefore, thinks it would be cowardly for Russia to ask for mercy with all the men and money essential to a successful war.

### WAR RUMOR.

St. Petersburg, February 23.—Rumors were current in this city last night that General Kuropatkin had been outfanked by a strong force of Japanese in the vicinity of Simintin, and compelled to retire from the Shkhalo river; but official despatches so far as made public, and the Associated Press' Mukden advices give no intimation that such a contingency is even remotely possible.

Military circles report the report entirely and say no body of Japanese of sufficient strength has been operating on the right Russian flank to force General Kuropatkin to abandon his exceedingly strong position on the Shkhalo without a hard fight lasting several days.

### RUSSIAN MOVES.

Mukden, February 23.—A company of Cossacks which has returned from a long and perilous reconnaissance toward Corea, penetrated by mountain paths as far as Hagomin, eighteen miles northwest of the Yalu river, where they burned a large depot of Japanese provisions. Turning south, the Russians captured a transport of supplies, of which the small command was in great need. During the course of the night Japanese surrounded the

command on three sides. The position of the Russians was desperate, but a Chinese guide discovered a mountain pass, by which they escaped into Kwaizhen Mountain, one hundred miles due north of the mouth of the Yalu river, from which they rejoined the army by way of little known trails.

The news of General Gripenberg's attack on General Kuropatkin has caused great indignation at Russian headquarters here and in army circles.

General Gripenberg's departure was a surprise, as he had received no orders from General Kuropatkin to quit his position. He left Manchuria unceremoniously, without taking leave of the commander-in-chief.

Even General Gripenberg's friends say that the present is not a fit time for venting personal feelings, when the army must bend all its energies in the effort to secure victory.

### KEY TO THE POSITION.

Tokio, February 23.—In addition to the Russians' usual desultory bombardment of the Japanese centre and left, Marshal Oyama reports the fact that they recently placed heavy artillery near Tashan, while the Tokio newspapers learn from Chinese sources that large projectiles are falling in the Russian centre, which indicates that Japanese siege guns, brought from Port Arthur are in position. Thus the centre of both armies approximates more each day to the character of a great fortress. The Chinese state the Russians still regard Lone Tree (Putiloff) hill, between the Japanese left and Russian right wings, as the key to the position in that part of the line. It was there they surrounded and cut off Major-General Yamada's brigade in the battle of the Shkhalo river. It is expected that this important position will again be hotly contested in the coming battle.

## ADDRESS BY REV. DR. CHOWN.

### Tells of Progress of Temperance Movement.

#### THE LOCAL SITUATION—PETITION AGAINST GRANTING OF NEW LICENSES.

The lecture hall of the Methodist church last evening was well filled, when Rev. S. D. Chown, D.D., general secretary of the department of Temperance and Moral Reform of the Methodist church, Toronto, gave an address on the work carried on by his department.

The Rev. P. L. Richardson presided, and the Royal Templars of Temperance attended in a body and the representation from other congregations was good.

Dealing with the temperance question Dr. Chown said that every effort was being made to suppress the liquor traffic and that everything was pointing towards the curtailment of the liquor interests.

He was very optimistic as to the future results of the work. They were receiving great encouragement from the railroads and other great commercial concerns in this direction.

As an instance of this Dr. Chown cited one of the C.P.R. officials who said that before he engaged any young man he always put two questions. One was: "Do you use intoxicating liquor?" and the other, "Do you smoke cigarettes?"

This official said he found no young man who used both could give efficient service to the C.P.R.

The speaker dwelt at some length on the labor problem. He first referred to labor and capital, and said that while he favored labor unions, the laboring man made a mistake when he held that wealth was the product of labor of his own hands alone.

These labor leaders should recognize that labor is really an expression of the brain through the hand, so that brain work might be classed as labor just as much as manual work.

Referring to the gambling evil, Dr. Chown dwelt on the evil in its different forms, betting, ordinary gambling and paid-a good deal of attention to what is known as stock gambling, and marginal speculation. He showed how such gambling struck a blow at and undermined the whole commercial world.

At the close of Dr. Chown's address Rev. Mr. Richardson spoke of the present condition of things in Sherbrooke. The W.C.T.U. of the city having heard that requisitions were being made to the City Council to grant additional licenses, started in circulation a petition among the citizens, respectfully requesting the Council to refuse all such requests, on the ground that they are not needed and more places of that kind would

tend to lower the tone of the community. The petition makes special mention of shop licenses, as being especially baneful. The ladies have already interviewed many prominent citizens, besides the clergy, both Catholic and Protestant and they expect to have a great many more names added to the petition in addition to those who signed last evening.

On the suggestion of Mr. R. Armistage it was decided to make a house to house canvass with the petition.

### WAR OPENS ON BEEF TRUST.

#### WARRANTS OUT IN CHICAGO FOR 25 WITNESSES.

Chicago, Ill., Feb. 23.—A special Federal Grand Jury venire was ordered yesterday and ten deputy United States marshals were sent out with subpoenas summoning more than twenty-five witnesses against members of the so-called "beef trust." The men summoned will be taken before the grand jury and an attempt will be made to indict persons restrained by Judge Grosscup's beef trust decision, which recently was sustained by the United States Supreme Court. Much servey was maintained concerning the affair and the deputy marshals were despatched under orders to serve the subpoenas immediately and to make public no facts concerning the affair.

For more than eight months investigation has been carried on secretly in Chicago. Orders came from Attorney General Moody to United States District Attorney Betha to take up the work on the case. Attorney Betha was ordered to spare no expense to secure evidence against violators of the injunction of Judge Grosscup. It is believed the investigation of the special grand jury will cover several weeks. In all 135 subpoenas were issued, for subordinates, clerks and other employees of the packers. None of the packers was summoned. The employees are expected to corroborate in their testimony evidence secured by Government secret agents.

### KILLED DEER OUT OF SEASON.

#### AS RESULT TWO MIDPOLIS MEN ARE NOW IN JAIL.

Pierre Roy and Joseph Roy, of Piopolis, were conveyed to Sherbrooke jail on Tuesday afternoon, having been sentenced by Count d'Orsonnen, J. P., Lake Megantic, to pay a fine of \$10 and costs, or fifteen days in jail, for having killed deer out of season.

As they had not the money they went to jail.

## FUNERAL OF DUKE SERGIUS.

### Took Place This Morning in Moscow.

#### GRAND DUKES LEAVE ST. PETERSBURG TO ATTEND.

Moscow, Feb. 23.—All the schools and colleges have been given two days' holiday during the lying in state and funeral of the late Grand Duke Sergius. Last night the students placed floral tributes around the cross erected on the scene of the assassination; and later reviewed the remains of the Grand Duke.

There were manifestations of public sorrow yesterday at the funeral of the coachman of Grand Duke Sergius.

Grand Duchess Elizabeth followed the hearse on foot three kilometers from the hospital to the railway station, walking by the side of the coachman's widow and children.

Numerous distinguished personages have arrived here to attend the funeral of the Grand Duke.

#### TO ATTEND FUNERAL.

St. Petersburg, February 23.—Several of the Grand Dukes left for Moscow yesterday to attend the funeral to-day of the late Grand Duke Sergius. Grand Duke Vladimir will not attend the funeral owing to indisposition, caused by a chill.

Emperor Nicholas has issued orders specifying that members of the court, naval and military officers, heads of judicial and administration institutions, presidents of the nobility, the Zemstvos of the province, the mayor and foreign representatives may attend the funeral. Ladies must wear black cloth dresses and black bonnets. Civilians must wear mourning. All must arrive at the monastery by 10.30 a.m.

## JUDGMENT IN HEREFORD CASE.

### DEFENDANTS WIN IN CASE OF BELOIN VS. HOVEY AND BALDWIN.

Mr. Justice Hutchinson, in the Superior Court yesterday rendered judgment in the case of N. Beloin, jr., of the Township of Hereford, against Leslie E. Hovey, of Canaan, Vt., and P. L. Baldwin, of Coaticook, as executors of the estate of the late Edwin Bean, of Hereford, for damages for cutting down a large number of spruce trees and other timber on property belonging to the plaintiff.

The plaintiff contended that the defendants had entered upon his property in the township of Hereford, and without cause cut down spruce trees and other timber for pulpwood, making in all about 250 cords, without the consent of the plaintiff; that the value of the wood cut is damaged at \$500; and that this amount of damage had been suffered by the plaintiff on account of the said trespass.

The plaintiff asked that the Court declare him the owner of the property, and that defendants be enjoined and ordered not to molest plaintiff in his peaceable possession of the same, and that in default of the same defendant be condemned to pay \$500—damages with interest and costs.

The defendants deny the allegation of the plaintiff and produced a deed bearing date 31st March, 1888, signed by the late Edwin Bean, whereby the latter acquired all the soft wood timber now claimed by plaintiff, and the right to cut down the same for a period of twenty years, and that the plaintiff when he acquired the property from Mr. I. Van Dyke did not get possession of the soft wood timber as the deed reserved all the soft wood timber standing on the said property.

The Court held that the defendants had the right to cut the soft wood timber under the aforementioned deed, and dismissed plaintiff's action with costs.

## COMPOSITE TELEGRAPH AND TELEPHONE.

### SYSTEM ESTABLISHED BY C. P. R. BETWEEN SHERBROOKE AND FARNHAM.

The C.P.R. has just installed a composite telephone system between Sherbrooke and Farnham. Only the one wire is used, and telephone and telegraph messages pass between Sherbrooke and Farnham at the same time without interfering with each other.

The telephone instruments used are most expensive, and have 11 cells of batteries.

The C.P.R., G.T.R. and other roads are fast installing this composite system which is working very satisfactorily.

## INQUEST HELD AT LENNOXVILLE.

### Jury Finds Level Crossing Fatality Accidental.

#### REMARKS, HOWEVER, THAT CROSSING IS "MOST DANGEROUS IN THE PROVINCE."

Dr. F. Gadbois, deputy coroner, and a jury held an inquest, last evening, at Bishop's College, into the death of Mr. Cyril N. Montgomery, a student, who was killed yesterday forenoon, at the level crossing, on College street, Lennoxville, by being struck by the engine of the Megantic local.

The verdict of the jury was: "That the deceased, Cyril Norris Montgomery, came to his death, on the 22nd day of February, 1905, by being struck by a Canadian Pacific Railway train, on a crossing of College street, in the Village of Lennoxville; that his death was due to his own carelessness, or, perhaps, to his natural deformity of deafness, and no blame can be attached to any person, whosoever."

"The jury would recommend that in view of the many accidents lately taking place at this and other railway crossings, that the Government should take some steps to place a flagman or gates there, and thereby protect the public life, as this is the most dangerous crossing in the Province."

The jurors were: W. E. Smith (foreman), C. F. Wiggett, J. M. Shuter, John McCulloch, C. S. White, W. J. H. McKindsey, L. A. Simonneau, A. L. Brown, R. McMurray, M. L. Tindall, J. B. Orr, A. McFadden, Robert Burge, Jas. Pearson.

Only three witnesses were examined and two doctors.

Alfred Cael, engineer on the C. P. R. engine, which struck the deceased, testified that he whistled for the station outside the semaphore, about eighty rods from the crossing, and gave the usual signals by whistle, and the fireman rang the bell. Witness saw the deceased walking on the track, and gave a succession of short whistles. The deceased acted as if he heard them, for he appeared to hurry.

He was then about twenty-five feet from the track. He had just reached the edge of the track when the buffer beam struck him on the side, and threw him away from the track on to a bank of snow, but witness thought that when the engine passed he must have rolled on to the track, as he was caught in the wheels and dragged about twenty feet. Witness stopped his train as soon as possible, and went back and notified the station people. When he first noticed the deceased he was about 30 rods away, and before he whistled for the crossing. When he saw that the deceased did not notice whistle as he ought to, he applied the brakes. The train was running about six miles an hour. The train ran about twelve car lengths before it came to a standstill. The engine was past the station when the train stopped. The train was under air brakes. Deceased was on the right side of the track. There was nothing to impede his view at this side of the crossing.

Pierre Mercier, fireman on the Megantic local, testified that he did not know anything about the accident until they stopped, when his engineer told him they had struck a man. Witness was ringing the bell. The air brakes were applied, but he did not think this unusual as they often did that when coming into a station. He could not see the deceased from the side he was sitting. He heard the engineer give a succession of short whistles.

Andrew Parker, switchman on the C. P. R., stated that he was in the freight shed when the engine whistled at the crossing. He then went towards the station, and raised semaphore behind the train. Witness saw some object on the track and remarked that the train must have struck somebody.

Drs. Russell Thomas and Alvin Foss both testified to the injuries which the deceased received, and which were chiefly on the chest, which was badly crushed, and were sufficient to cause death.

## SENATOR WARK.

### SPEAKER DANDURAND AND MR. EMMERSON RECEIVE TELEGRAMS CONVEYING GRATITUDE FOR GOOD WILL.

Ottawa, Feb. 23.—In reply to the message of congratulation of the senate, Hon. David Wark, the aged legislator, wires Speaker Dandurand: "Thank the honorable the Senate for their kind remembrance of me and their hearty congratulations on the return of the 101st anniversary of my birthday."

The senator wires Hon. Mr. Emmerson, who tendered him a private car to come to Ottawa: "Please convey to the Liberal members of the commons my sincere thanks for the message of congratulation just received, and for their kind offer."

## ANOTHER DIVISION IN BRITISH HOUSE.

### Government Majority Only Forty Two.

#### IRISH PARTY SPRANG SURPRISE IN HOUSE.

London, Feb. 23.—Encouraged by the reduced Government majority in the division in the House of Commons, Tuesday night, the Irish party unexpectedly returned to the attack, yesterday, more fiercely than ever. Immediately after the session opened, John Redmond gave notice of a motion to adjourn in order to discuss the conditions under which Sir Antony Macdonnell holds the post of under-secretary to the Lord-Lieutenant of Ireland. This move came as a surprise and caught the Government off its guard. The Speaker set the debate on the motion for the commencement of the night session.

The debate lasted till midnight when a motion to adjourn was defeated, 265 to 223; but Mr. Redmond scored a point by compelling Mr. Wyndham, (chief secretary for Ireland), to read the correspondence between himself and Sir Antony Macdonnell, by which it was shown that the under-secretary was given extraordinary powers, and authorized to arrange for co-ordination in the control and direction of boards and administrative agencies. It was also shown that Premier Balfour had concurred in this arrangement.

## THE TROUBLE AT WARSAW.

### Strike Extends and Situation is Serious.

#### AT LODZ, ALL RAILWAY EMPLOYEES HAVE STRUCK.

Warsaw, Feb. 23.—(Special.)—Workmen have struck in all the factories of Czerinakowska district, the chief manufacturing suburb of Warsaw.

There have been serious disturbances and a strong force of police and troops were summoned.

Soldiers fired but no casualties are reported.

The police arrested many persons, but threats of the mob compelled them to release their prisoners.

Employees of Lodz Kozuska Railway have struck.

Lodz is entirely cut off from railway communication.

## NOTES OF THE NEWS.

The House of Representatives at Washington passed the naval appropriation bill, carrying a total of \$99,914,359. The provision for two battleships, as reported by the Committee on Naval Affairs, was retained.

A man who was believed to be the oldest person in New York city, died of old age there at the age of 107. He was Jos. McGrath, a stone cutter, and a native of Ireland. He left four generations of descendants, numbering two hundred.

The New York Independent Telephone Company was incorporated at Albany with a capital of \$50,000 to operate a telephone system in New York city and thence to Albany and Boston connecting intermediate cities in New York, Massachusetts, Rhode Island, Connecticut and also through New Jersey and Pennsylvania to Jersey City, Philadelphia and other places.

Denis Donohue, financial editor of the New York Commercial, who has been running a series of articles in a magazine entitled "The Truth About Frenzied Finance," which are in reply to the statements of Thomas W. Lawson about financial conditions, was arrested on a warrant issued upon complaint of Herbert Gray, of Haverhill, Mass., who alleges that Donohue made statements reflecting upon him amounting to criminal libel.

## RESIGNS FROM PASTORATE.

### REV. MR. McLAUGHLIN OBLIGED TO TAKE THIS STEP OWING TO ILL HEALTH.

Huntingville, Feb. 23.—(Special.)—Rev. I. W. McLaughlin has sent in his resignation as pastor of the Universalist Church here, which position he has held for the past three years and a half, but on account of ill health is forced to seek a milder climate. He will be missed by a large circle of friends.

Rev. I. W. McLaughlin will preach his farewell sermon here next Sunday afternoon, Feb. 26th, at 2.30.

## DECISION WILL FAVOR RUSSIA.

### Unofficial Announcement Regarding North Sea Affair.

#### MUCH INDIGNATION IS EXPRESSED IN ENGLAND.

Paris, Feb. 23.—Admirals von Spaun and Davis, who have been delegated to draw up the findings of the North Sea Commission, held a session Sunday, and met twice Tuesday. Their main work is to fulfill the requirements of the protocol that the commission report all the circumstances of the incident. While this detailed recital involves the main issues, namely, whether torpedo boats were present, and whether Admiral Rojestvensky was justified in firing, yet the full board of admirals reserves final determination to the main questions until after the presentation of Admirals von Spaun and Davis's recital of the circumstances. Therefore, no positive decision has yet been reached upon the main points, but their number and circumstances seem to indicate a definite inclination of the majority of the commission toward partially justifying or excusing Admiral Rojestvensky's action. It is generally believed in well-informed quarters that Vice-Admiral Doubasoff (Russia), Admiral Fournier (France), president of the commission, and Admiral von Spaun, incline to the foregoing view, while Rear Admiral Sir Lewis Beaumont (Great Britain) and Admiral Davis are considered favorable to the British view that no torpedo boats were present, and that therefore there was no justification for firing. But it is impossible positively to verify this alignment of the admirals owing to the lack of finality of the conclusions until the von Spaun-Davis report is discussed. Moreover, the board apparently is seeking to reconcile differences, so that the decision may not be a pronounced victory for either side, but measurably acceptable to both.

### DECISION UNOFFICIALLY ANNOUNCED.

London, Feb. 23.—A Paris despatch says, unofficially: "The commission gives no opinion on the question of the presence or absence of Japanese torpedo boats in the North Sea, declaring merely that the Russian Admiral quite legitimately believed that his squadron was endangered, and that he had the right under the circumstances to act as he did."

### ENGLISH PRESS COMMENT.

London, Feb. 23.—A strong chord of indignation is sounded by the London daily newspapers this morning over the semi-official statement relative to the decision of the North Sea Commission, giving to Russia the victory, but it still is hoped that the publication of the full text of the commission's report may modify the impression produced by the preliminary version, which is one of intense disappointment.

The Daily Mail goes so far as to declare that the decision has dealt a death blow to arbitration.

The Morning Post says: "A new dogma of international law is thus established, under which the commander of a belligerent fleet may attack and destroy neutral, unarmed vessels, without any other plea than that he conceived his ships might be in danger. This doctrine is so monstrous and inconceivable that we can only yet hope the official report will give a different reading."

### ANOTHER CABLE ACROSS THE ATLANTIC.

New York, Feb. 23.—Although the bids received by the Commercial Cable Company for the new Atlantic cable have not been formally accepted, it is probable that the cable contract will be awarded to one or both of two English corporations, the Silvertown Company and the Telegraph Construction Company, both of London. In order to hasten the work of making and laying the cable, Clarence H. Mackay and his associates may give the contract for the shore end sections to one company, and the contract for the mid-Atlantic section to the other company.

No American company was requested to bid for the contract. When asked for information as to the reason for inviting only English companies to bid for such an important work, Geo. Gray Ward, vice-president of the Commercial Cable Company, said Monday evening:

"It was not because our company is falling in patriotism, but because there is no American Cable Company so well equipped for the task that it could make and lay a cable of the standard of excellence we require in the time we want it ready for use. The English companies have complete facilities for the manufacture of the cable, and, in addition, they have steamships specially designed and manned for the work of laying the cables. Probably it will take two such steamships to lay the new Atlantic cable."

SUNDAY SCHOOL CONFERENCE.

Addresses by Mr. Leet and Mr. Pearce.

DISCUSSIONS OF INTEREST TO SUNDAY SCHOOL WORKERS.

A conference of Sunday school workers was held Tuesday in the lecture hall of the Methodist church. The Rev. Mr. Capel, secretary of the S. S. Union, had been expected to address the meeting, but owing to the very recent death of his father, was unable to attend.

Mr. Seth P. Leet, K.C. of Montreal, Treasurer of the S. S. Union, took Mr. Capel's place and Mr. W. C. Pearce, of Chicago, also addressed the meeting at both sessions. Rev. Mr. Richardson was in the chair and introduced the speakers.

At the afternoon session Mr. Leet spoke of the organization of the Sunday School Union and its objects and of the international convention to be held in Toronto July 20th, to 27th next. Delegates are desired from every Union, from every Sunday school, if it can be accomplished. Reduced fares, etc., will be provided.

The topic of Mr. Pearce's address was "The teacher preparing and the teacher teaching." The first step was preparation, and there are two kinds, personal, i.e., the heart or character; professional, i.e., the head or knowledge. A good teacher must be a Christian, able to say with truth "The Lord is my shepherd." He should also avoid questionable things, not only things he thinks are not quite right, but places and things which appear questionable to other people. He must respect himself if others cannot respect him. Mr. Pearce then went very fully into the preparation of the lesson, giving illustrations and describing his own methods. He laid special stress upon familiarity with the Bible and upon reading about the land where the Bible was written. If a teacher's meeting or training class could not be held, then each teacher should study alone, but time should be given to the lesson, and books on teaching and child-training should also be studied.

At the evening session Mr. Leet spoke of the importance of visiting the members of a Sunday school. He also spoke particularly of the Home Department, for those who cannot attend Sunday school, but who wish to be members, keeping them supplied with literature, lessons for each Sunday, etc., etc.

Mr. Pearce went very fully into each department of a Sunday school and what it should be. Executive, of which the superintendent should be the head; statistical, under the charge of the secretary; finance, the treasurer; instruction, the teacher. There should be a leader for the singing; a piano or organ of course, and if possible an orchestra. The librarian should have full charge of the library, and choose his own assistants. In regard to training of teachers, it would be well to have a class for normal training, even if it had to be held during the Sunday school session. There should be a Sunday school committee to visit the parents of the children and report to the superintendent who could then keep a record of each child. Mr. Pearce made many other helpful suggestions as to Sunday school work generally.

DEATH STRUGGLE IN THE ICE. DROWNED IN THE ST. CLAIR, OPPOSITE SAENIA. He finally became exhausted, threw up his hands and disappeared. Every effort is being made to ascertain the identity of the victim, but so far without avail. The ice is not in a condition to permit crossing, and it is not known how the man got to the spot where he disappeared, as there was a large stretch of open water between him and the Samia shore. Several persons saw the occurrence, but could render no assistance. The body will probably not be recovered until spring, as the current is swift.

RUSH OF IMMIGRATION. Montreal, Feb. 23.—Twelve hundred immigrants, mostly from West Ham, westward bound, are expected to pass through Montreal between Monday evening and Tuesday morning. They are being transported from Halifax by the C.P.R. Most of them are skilled craftsmen, but it seems that they are willing to try farming. The steamship companies have arranged the matter differently and rates have gone back to the original figure, but this will not, it is thought, act as a deterrent to immigrants, because this year in Europe the reasons why many should seek greater freedom have increased.

### ST. JOHNSBURY MAN'S PREDICAMENT.

His story is that he left St. Johnsbury to travel the Townships with a patent article that paid him well, writing his wife every Saturday, and getting her answer. The last letter he sent her money to come and meet him in Sherbrooke on Saturday, the 18th, and she came on Saturday, the 11th, and when Jaquet arrived in Sherbrooke on the 18th he went to the hotel where he was to meet his wife, and judge his astonishment when the proprietor told him she had arrived the Saturday previous with her

child, and expected him all that day and the Sunday following, and on Monday she telephoned everywhere about the surrounding towns, but in vain, that she became very despondent and wept most of the time, and would eat nothing. She stayed at the hotel till Thursday, when she disappeared with her child, nobody knew where. Jaquet set about making enquiries and telephoning and wiring all his and her relatives, but none had seen her. He went to East, Angus where she often went to visit her aunt, a Miss Bernard, but no trace of her there. The young man is quite beside himself. He cannot imagine what has happened to her and his child," with blond hair and pretty, but of an exceedingly nervous disposition. Mr. Jaquet will remain one week to pursue his enquiries and would be very thankful for any information.

### NEW JEW POPULATION IS REVOLUTIONARY.

THE BUND OPENED A SERIES OF NIHILISTIC MEETINGS WITH SUCCESS.

Montreal, Feb. 23.—There is evidently a strongly revolutionary tendency among the latest acquisitions to Montreal from Russian Hebrew society. The Montreal Brotherhood of the Russian Revolutionary Bund, which has been lying low since the days of its inception a year or two ago, blossomed forth into a tremendous popular demonstration Sunday night, and numbers of enthusiastic advocates of the policy of the red hand were turned away from Empire Hall, where Mr. Vineberg, an organizer and high official of the Bund, whose office is in New York, and who is persona non grata to the St. Petersburg police, held forth on recent events.

The meeting contributed \$102 towards the funds of the Bund. It is not likely that any of this will go for the actual purchase of dynamite, although Mr. Vineberg was vague as to the exact destination of the money. He explained that the Bund's objects were of an educational character. It would hardly be accurate to say that he defended the assassination of the Grand Duke Sergius; he rather gloried in it, and the meeting thundered approval, when he expressed the conviction that many other assassinations would follow.

The Bund is starting on very active propaganda work in Montreal, and a series of similar meetings is to be held. The second, a week from next Sunday, will be addressed by Mr. Abe Cohen, editor of the Jewish Daily Forward, of New York, and is likely to be even more strenuous.

### HIRSCH AUTHORITIES NOT PLEASED.

The Baron de Hirsch authorities, it is understood, are not particularly delighted at the development of revolutionary doctrines among their proteges, and will take what steps they can to counteract the work of the Bund. The theatre is proving the most popular form of the Bund's propaganda, and certain recent performances at the Monument National and other works hostile to the existing order of society have been received with tremendous acclamation.

"It was a great meeting," said one expatriated Russian Hebrew, who was waiting at the institute the other morning for some kind of a job to turn up. "The day is coming when God will avenge his people upon those who have persecuted them and driven them out of Russia. What right have Sergius and Treppoff and their like to be treated as human beings? They treated us like dogs, and we will do the same to them."

### CANADIAN MAGAZINE.

The first number of the Canadian Magazine was published in March, 1893. It is, therefore, now entering upon its thirteenth year. Gordon Mow was editor for the first two years, and his successor, John A. Cooper, is still in the editorial chair.

### THE UNIVERSITY EXTENSION LECTURES.

LAST OF SERIES GIVEN BY PRINCIPAL WHITNEY.

Rev. Principal Whitney, of Bishop's College, Lennoxville, gave Tuesday evening the last of a notable series of University Extension Lectures, which have dealt with "Modern Novels." The lecturer said: "The authors we have taken up thus far—the Brontes and George Eliot—gave us their impressions of quiet village life in England, but for a writer who specially describes English village life and country society, we would inevitably go to Jane Austen. For several causes her novels are not as popular now as they have been and should be. Undoubtedly, the style in which she wrote was very characteristic and suitable then, but is perhaps a little old-fashioned now.

"Her works had a great literary effect and on the whole a higher place must be ascribed to her, than, for instance, to any of the Brontes.

Other writers, who show the influence of Miss Austen's style are Mrs. Gaskell and Mrs. Oliphant, who spent a whole long life in the service of literature and who had a great deal of literary skill.

These three give us perhaps as good a picture of English country life as we could possibly have.

"A few words must be said about an entirely different kind of novel.

"There has been a reaction from the quiet school which studied character and in the last ten or twelve years we find a large number of novels of rather romantic incident, full of adventures, overdrawn possibly, but distinctly popular.

"When we come to consider the literary place of these writers, it is rather difficult. For really good literature there must, of course, be one condition of permanent value.

"Every writer is more or less the product of his age, and many writers are certainly out of harmony with their day.

"Even in the novel if we only read for amusement we should have a high standard. To sum up, novels familiarize us with life in different countries, and help us to understand motives and characters, not only in others, but what is still more difficult, in ourselves.

At the close of the lecture Mr. H. D. Lawrence made a few brief remarks, thanking Dr. Whitney and Mr. H. V. Routh in the name of the audience for the interesting and instructive no less than entertaining series of lectures, and expressing the deep regret of the community at the approaching departure of Dr. Whitney, who had been largely instrumental in bringing about closer relations between Sherbrooke and Lennoxville.

Dr. Whitney replied pleasantly and suitably, alluding to his own regret at leaving Canada, and the University of Bishop's College and of the interest which he would always take in the welfare of both.

Victoria, B.C., Feb. 23.—Aboard the steamer Tartar, which arrived Sunday, were Lieuts. Below and C. Bondy, officers of the Russian battleship Sevastopol, captured at the fall of Port Arthur. They were released by the Japanese after giving their parole. The captain of the Sevastopol and a number of other prisoners recently released are expected to reach San Francisco shortly.

Lieut. Below characterizes General Stoessel as a coward. "The world will know Stoessel as he is," said Below. "He is a coward. Gen. Stoessel was burrowed a great deal of the time in a cave."

"The real heroine was Madame Zouhoni, who when her husband was killed, took command of a battery of three 13-inch guns at a point commanding the water supply and held them until she was killed.

"The garrison was deceived by false reports of the approach of Kuropatkin's army and the Baltic fleet."

A number of outbreaks have been started recently by Russian prisoners at Matsuyama.

SHERIFF HAGAR CAST DECIDING VOTE ELECTING HIM.

Prescott, Feb. 23.—L. Joseph Labrosse, of St. Eugene, was Monday elected member of the Ontario Legislature for the County of Prescott. The vote on the 25th of January resulted, after a recount of ballots, in a tie between Mr. Labrosse and Hon. F. E. A. Evanturel and this week Sheriff Hagar, the returning officer, gave the casting vote for Labrosse and declared him elected. The new member was the choice of the Liberal convention held just previous to dissolution.

### WOULD HAVE GUARANTEES.

THAT CANADA WILL MAINTAIN STANDARD OF DEFENCE.

London, Feb. 23.—The Morning Post commenting on the taking over the charge of Esquimaux and Halifax by the Canadian Government, says it is a commendable product of the realization of her growing strength and her wish to take a proper footing in the commonwealth of the empire. Referring to the importance of Halifax in the contingency of war with the United States, the Post says: "It is vital to ask what guarantees the Imperial Government are taking that the present standard of defence both in personnel and material will be fully maintained on the transfer of the fortress to the Canadian authorities."

CANADIAN FORCES DEFICIENT? Though expressing no desire to belittle the fighting qualities displayed by the Canadians in South Africa, the Post says the Dominion Government, with commendable frankness, has shown by its yearly productions that the Canadian forces are lamentably deficient in training, organization and equipment, and that their system of administration has far more regard to political considerations than to preparation for war. The Post thinks it is to be regretted

that the Imperial tie should be severed by the removal of Imperial troops from Canadian soil. It is our aim should be not to encourage the colonies to build up separate armies and navies, but rather to encourage the blending of the British and colonial troops into one great Imperial force for the protection of the empire as a whole.

### Japan's Strength Sur Half Million Men

London, Feb. 24.—St. Petersburg through Berlin, answers Russian negotiations with a statement that the Czar has decided to withdraw. This course is said to be dictated by the internal situation which would be made worse by a war; and the Czar's advisers are said to have told him that the Russian army is quite unable to defend itself, but is himself in the hands of the Russian army. The Czar's apparently intended to be a peace negotiations with the Czar, and that the German court of honor had decided to accept the decision of the decision may be a foundation for reports that the Kaiser had urged on St. Petersburg the ending of the war. ## S. S. LINE BETWEEN CANADA AND FRANCE

Contract Made by Government and Allan Line

EIGHTEEN TRIPS EACH SUBSIDY \$100,000.

Montreal, Feb. 24.—(Special) Contract has been entered into between the Dominion Government and Allan Line S. S. Co., calling weekly S. S. service between Montreal and France.

The contract, calls for eight trips, yearly, between either Quebec in summer, or St. Halifax in winter, to either Cherbourg, France, with leave at English ports.

The contract provides for carriage of mails, and ships must be fitted with cold storage. The contract is for three years, carries a subsidy of \$100,000 per voyage, or \$133,333.33 per annum.

## EARNINGS OF BELL TELEPHONE

THE NET REVENUE FOR PAST YEAR AMOUNTED TO \$701,905.

Montreal, Feb. 24.—The statement submitted at the meeting of the Bell Telephone Company shows receipts of \$2,933,933, expenses \$2,231,748, leaving revenue of \$701,905. This revenue is divided into operating, maintenance, reserve, accident and other, amounting to one hundred and eighty-eight subscribers with a total of 100,000 sets of instruments installed.
