## INTRODUCTION

---

Since the late 1960s, the Québec health and social services network has been screening newborns for certain treatable inherited metabolic disorders. Identifying these disorders only a few days after birth makes it possible to begin treatment quickly and thus avoid significant physical and intellectual damage to children. For a majority of these diseases, treatment consists of a diet restricted in protein, fat, or carbohydrates that individuals must follow throughout their life. Inherited metabolic disorders can also be diagnosed at later ages by specialized medical services. Those diagnosed may be prescribed a diet restricted in protein, fat, or carbohydrates.

The Québec food program for the treatment of inherited metabolic disorders (Programme alimentaire québécois pour le traitement de maladies métaboliques héréditaires or PAQTMMH) meets the following objectives:

- Ensure that people with inherited metabolic disorders requiring a diet restricted in protein, fat, or carbohydrates have access to the therapeutic nutritional products prescribed to them, regardless of the health region they live in
- Promote adherence to treatment, given the very serious consequences if treatment is interrupted (e.g., intellectual disability, neurological complications, death) and the significant social, family, and individual costs that can result
- Prevent these individuals and their families from having to bear a significant financial burden

Only products on the “List of Therapeutic Nutritional Products” are covered by the program. The prices indicated include shipping costs. Any changes to this version of the list (including new products) are highlighted in **bold**.

### **NOTICE**

- **Access to therapeutic nutritional products listed in this document is limited to those eligible for the PAQTMMH and requires a medical prescription.**
- **This document is intended primarily for healthcare professionals (e.g., doctors, dietitians, nurses, etc.) specializing in the treatment of hereditary metabolic diseases and for people registered in the PAQTMMH.**

# DESCRIPTION OF THE LIST OF THERAPEUTIC NUTRITIONAL PRODUCTS

---

The List of Therapeutic Nutritional Products consists of products covered by the PAQTMMH. The cost of products not included cannot be covered by the program. The list is updated twice a year.

It has two categories:

- 1) “Basic” therapeutic nutritional products, also known as “formulas”
- 2) Therapeutic nutritional products that are “capped and uncapped foods”

Access to products with a code preceded by the “◆” symbol is conditional on consultation between the attending physician and the nutritionist. In order for these products to be delivered to the patient, a prescription from the physician or nutritionist must be sent to the trustee.

## 1 “BASIC” THERAPEUTIC NUTRITIONAL PRODUCTS (FORMULAS, MODULES)

Therapeutic nutritional products considered “basic” are formulas or modular products used to develop special formulations.

## 2 THERAPEUTIC NUTRITIONAL PRODUCTS (FOODS)

### 2.1 Non-capped foods

Non-capped foods are:

- Products that form the basis of a diet restricted in protein, fat, or carbohydrates
- Basic ingredients used in the preparation of recipes or dishes that are restricted in protein, fat, or carbohydrates
- Products that provide variety in a diet restricted in protein, fat, or carbohydrates

### 2.2 Capped foods

Capped foods meet the same criteria as non-capped foods.

These products are subject to an overall annual limit of \$1,500 per patient. Their codes are preceded by the “⊕” symbol.

**For greater convenience, “basic” therapeutic products of the special preparation type are classified by metabolic disease.**
