## TWO SOUTH HAM MEN ARE CHARGED WITH MURDER OF SAUL GREGOIRE

Conrad Audy and His Father-in-Law, Louis Audy, Held Criminally Responsible for Gregoire's Death at Coroner's Inquest in South Ham Last Night—Police Claim Gregoire Was Murdered Five Miles from Spot Where His Body Was Found—Two Accused Removed to Sherbrooke Jail Under Heavy Police Guard.

The frail meshes of a web of circumstantial evidence, woven as the result of two weeks of pains-taking investigation by provincial police officers, today hold two men charged with the murder of Saul Gregoire, fifty-year-old South Ham farmer, who was shot through the back on the night of August 19th last.

Conrad Audy, thirty-two years old, and his father-in-law, Louis Audy, fifty-seven years of age, both illiterate sons of the soil who have lived for many years in the vicinity of South Ham and St. Camille, were held criminally responsible by a coroner's jury last night for the death of Saul Gregoire.

Warrants charging the two men with murder were issued immediately after the inquest by Coroner Bachand, and the prisoners were then conveyed to the Sherbrooke jail under police guard. They were arraigned before a local magistrate this morning and remanded for preliminary hearing.

The lifeless body of Saul Gregoire was discovered by the side of the lonely road leading through the 10th range of the Township of Dudswell on Wednesday morning, August 22nd. Gregoire was lying on his back, his arms folded, his legs crossed. The greater part of his body was covered with a black oil-cloth he was known to customarily carry in his rig. He had been shot through the back. The bullet, perforating the left lung, had emerged through the chest.

Gregoire lay by the side of the road, practically hidden from view in the tall grass, half way up a steep hill. His wagon, with stones placed underneath the rear wheels to prevent its running down hill, was found a hundred and fifty feet further up.

His horse, a gray mare, had been unhitched from the wagon and permitted to roam at will.

The inquest into Gregoire's death was held yesterday afternoon and last evening at South Ham in the hall of the registrar's building. The final stages of the police investigation had been shrouded in dark secrecy, and the enquete, held unexpectedly, contained a number of surprising revelations.

Yesterday was a memorable day in the annals of the usually peaceful village of South Ham. Gregoire's brutal murder had excited much commotion throughout the district, and when it was learned that the coroner's inquest was to be held at South Ham, a large number of people, coming from the four corners of Wolfe County, travelling by car, by wagon and many a-foot, wended their way to the scene of the investigation.

The registrar's hall was crowded. Aged farmers who had heard and read of drama but had never seen it enacted; awed boys and girls impressed by the grim machinery of Canadian law in operation, and women, mothers, some of them carrying their babies in their arms, pushed and crowded their way into the stuffy, ill-ventilated hall to catch a glimpse of the proceedings.

Leonidas Bachand, coroner for St. Francis District, presided over the inquest. Wilfrid Lazure, K.C., Crown prosecutor, represented the Attorney-General, while Louis Jargalle, Chief of Quebec Provincial Detectives, was present in behalf of the police. Miss Marguerite Gauthier, of Sherbrooke, was official stenographer.

The most dramatic moment during the entire proceedings was when the coroner's jury announced that Louis Audy was also criminally responsible for the death of Saul Gregoire.

The room was very still then. People seemed to have stopped breathing. A woman sighed, "Mon Dieu."

Conrad Audy had been detained the previous day as a material witness under an order issued by Coroner Bachand. The jurymen were advised that the benefit of any doubt had to be given to the Crown. Audy was not on trial; then, the benefit of any doubt had to be given in his favor.

Shadows of darkness were creeping into the hall when the jurymen returned with their verdict after close to forty-five minutes' deliberation. The coroner wrote out the murder warrants which place Audy as a gasoline thief, and a deserter from a blue flame at every gust of wind coming in through the open windows.

According to the police theory Saul Gregoire was not murdered on the Dudswell road where his body was found, but five miles from there on a deserted short-cut route linking the Marbleton and St. Camille highways, about a mile from the residence of Louis Audy.

It was logical to presume, the police said, that Gregoire was shot through the back while travelling in his rig. It was evident that he had been shot while ascending a steep hill, judging by the manner in which the bullet had penetrated his body.

The inquest was opened shortly after three o'clock, the first witness to be called being Conrad Audy.

Audy said that he and his family had resided on Saul Gregoire's farm since July 10th last. Gregoire, he said, had entrusted himself into his Audy's care. They had made an agreement, the witness stated, by which he cared for the fifty-year-old farmer, who was a sickly sort of man, until his death; whereupon all of Gregoire's property came into his possession.

"Have you a copy of that agreement?" asked Wilfrid Lazure. "I had," replied the witness. "But it was taken away from me."

The coroner leaned forward and produced the agreement in question. It was filed as an exhibit. It had been drawn up by Notary Bourget, of South Ham.

"It was understood, according to this document," stated Mr. Lazure, "that Gregoire gave you his farm, upon the condition that you cared

## IRISH HOSPITAL FAILS TO ATTRACT CUSTOMERS

Hospital Built Near Londonderry Has Been Unoccupied for Whole Thirteen Years Since Division of Ireland.

Londonderry, Sept. 7.—Without a single patient in the whole thirteen years of its existence is the unique record of a fully-equipped hospital in the Londonderry area.

The hospital was built by the Londonderry Fort Sanitary Board at Moville, on the Donegal side of Lough Foyle.

Then came the Free State treaty and the drawing of the border line. Northern Ireland, containing Londonderry, became one state, and Southern Ireland, with Moville within its boundaries, became another.

The Sanitary Board was left on one side of the border and its hospital on the other.

## CHACO WAR CONTROVERSY TO BE SUBMITTED TO LEAGUE ASSEMBLY

Chaco War Was First Question Considered as Session of League of Nations Council Met Today—Bolivian Representative Vigorously Protested Against Embargo on Arms Shipment to the Belligerents.

Geneva, Sept. 7.—The League of Nations Council voted today to refer a consideration of the Chaco war between Paraguay and Bolivia to the League Assembly.

The Council resolution stated that Bolivia had requested an examination of the dispute by the Assembly, and that it had decided by all the conditions prescribed by article 15 of the covenant, under which League intervention was sought.

The Chaco war was the first question considered as the session of the Council was called to order by Edouard Benes, Foreign Minister of Czechoslovakia.

Dr. A. Costa du Reis, representative of Bolivia, sprang to his feet immediately and protested against the embargo on arms shipments to the belligerents. He said he doubted the legitimacy of the embargo as it was arranged under the League covenant. Cabellero Bedoya, representative of Paraguay, also sat with the Council.

The famous glass room of the League of Nations buildings was packed as the Council started its deliberations. The session attracted extraordinary interest because of the expectation that Russia will be taken into the League.

France probably will open the campaign for Russian admission by asking the Council to extend an invitation to the Soviets.

Louis Barthou, French Foreign Minister, showing no evidence of weariness from his constant travels, was hopeful about the admission of Russia.

Extra police guarded Barthou because of rumor Fascists might attempt an anti-French demonstration.

EXPLAINS WHY IT IS HARD TO SECURE LOAN AT BANKS

President of Dominion Association of Chartered Accountants Says Public Should Be Made to Realize Extent to which Their Savings Are Being Used to Finance Government Over-Expenditure.

Montreal, Sept. 7.—George C. MacDonald, president of the Dominion Association of Chartered Accountants, in his presidential address at the opening of their thirty-second annual convention gave one reason why it had been so difficult in recent years to raise a loan at the bank.

Mr. MacDonald pointed out that "of every dollar deposited in the bank, fifty cents is lent to governments; and worst of all, that fifty cents is not backed up with assets, but has been advanced largely to cover deficits. The situation is alarming and the public should be made to realize the extent to which their savings are being used to finance government over-expenditure."

THEFT BRINGS DEATH PENALTY Archangel, U.S.S.R., September 7.—D. J. Daniloff, head of the supply department for the Peninga logging district, and M. M. Cogan, teamster, who co-operated with him in the theft of \$100,000 worth of Government property, were sentenced to death. Twenty-one others involved were given prison sentences of from one to ten years.

## GOVERNMENT OF CUBA TO FIGHT DEMONSTRATORS

United Front Against Student and Leftist Demonstrators Planned as Disorders Appeared Today to Be Spreading Throughout Havana.

Havana, Cuba, Sept. 7.—Cuba's Government emphasized its united front against student and Leftist demonstrators today as disorders appeared to be spreading throughout the island.

Reports that President Carlos Mendia had resigned, or was about to step out of office, were denied vigorously. It was rumored that Mendia and Fulgencio Batista, head of the army, had disagreed on matters of policy.

Bombs damaged the homes of Pedro Aruz, an army captain, and Manuel Arnaz, former chief of police, in Santiago last night. No one was injured.

Comparative quiet was restored to Camaguey after soldiers and students fired at each other for an hour yesterday. Two persons were injured.

## FIVE KILLED, MANY INJURED IN EARTHQUAKE

Violent Tremor Rocked Town of Orleansville, Algeria, Early Today—Relief Expeditions Enter Earthquake Zone.

Algiers, Algeria, Sept. 7.—Five persons were killed and twenty injured when a violent earthquake rocked the town of Orleansville at 4:15 a.m. today.

The tremor shook the houses and sent the French colonists and natives fleeing into the streets.

Many more persons were believed to be injured in the small towns between here and Orleansville and authorities started relief expeditions into the territory.

Orleansville itself is a village of 900 inhabitants, 300 of whom are French.

Several minor quakes preceded the big tremor, shaking the two hundred-mile long Chelif valley and an area 180 miles across.

Three towns, Carnot, Les Attafs, and Watignies, were heavily hit in addition to Orleansville.

Communications were disrupted by the quakes and it was impossible to determine immediately how badly the homes of natives and Europeans in outlying districts were damaged.

The region is one of the most densely colonized in Algeria.

## FORMER EDITOR FATALLY SHOT BY GANGSTERS

Howard Guilford, Former Newspaper Editor and Leader in a Fight for Freedom of the Press, Slain in Fashion Typical of Underworld.

Minneapolis, Minn., Sept. 7.—Howard Guilford, former newspaper editor and leader of a fight for freedom of the press, came into the spotlight again today—slain.

He was shot down by a gunman last night in fashion typical of the underworld his publications often attacked.

Guilford, forty years old, was driving his automobile along a south side street, going home, when the killer and his companion drove their car alongside Guilford's, pointed the muzzle of a shotgun through an open window and pulled the trigger.

The charge struck the former editor of the "Saturday Press" and the "Pink Sheet" in the head. His death apparently was instantaneous.

Then, after taking one quick look to make sure the charge had killed their victim, the gunmen sped away. There was but one witness and he told police the killers' machine bore yellow license plates.

Seven years ago Guilford was attacked by gunmen. He was wounded seriously, but recovered. Guilford's publications often were devoted to attacks on gambling and other forms of vice. He said he had been threatened.

## TRINIDAD PORT SCENE OF BIG OPIUM SEIZURE

Chinese Ship Steward Apprehended with Six Pounds of Opium Concentrate, Four Times as Powerful as Raw Drug, Upon His Person.

Port of Spain, Trinidad, Sept. 7.—A Chinese ship's steward was on the way to jail for a year today following the greatest dope seizure in Trinidad's history—\$24,000 worth of concentrated opium.

Colonial police uncovered the first known attempt to smuggle this form of the drug into the island when they seized the steward as he came ashore yesterday from the motorship Cape Horn, in port from Cardiff, Wales.

His waistcoat, said by police to be specially made for transporting narcotics, contained six pounds of the opium concentrate, four times as powerful as the raw drug. In his cabin the officers found more opium.

Arraigned immediately in court, the Oriental was convicted and fined \$1,250 besides being sentenced to a year in prison. Owners of the Cape Horn were ordered to post a deposit of \$1,250 pending further investigation.

## LOCAL LEADERS OF NAZI PARTY TO BE HONORED

Officials and Members of Local Groups, Numbering 180,000 Gather at Nurnberg for Ceremony.

Nurnberg, Germany, Sept. 7.—The Nazi little men who served Adolf Hitler obscurely but well, are having their day at the spectacular National Socialist party convention.

Nurnberg is crowded almost to suffocation with thousands of the so-called "goon" men, political organization leaders, officials and members of Germany's local Nazi groups. Preparations have been made for 180,000 of them.

Under the leadership of Robert Ley, they will stand at attention before Chancellor Hitler tonight and sing the Nazi hymn.

Before the unfolding of this pageant several big guns of the party, including William Darré, Alfred Rosenberg and Gottfried Feder, made addresses to the convention.

As the party convalesced moved from one emotional climax to another, it appeared that the Nazis who were expecting that Hitler would make it an occasion for announcing the name of his "political heir" are doomed to disappointment.

In an address to the convention yesterday Dr. Paul Joseph Goebbels, Minister of Propaganda, asserted that Germany lost the World War because of her inadequate propaganda service. That fault has been corrected, he asserted proudly.

Goebbels defined propaganda as "everything that will serve to convince a people that the right thing is right." No nation, he boasted, enjoys so sufficient a propaganda organization as does modern Germany.

"Is this a definite decision on the part of Ottawa, or is the offer subject to discussion?"

"We are informed that it is definite."

The \$600,000 per month arrangement applies as from August 1st last to April 1st next, he said.

The Premier added that the cost of distributing the money will fall upon the province, as well as all other costs involved in the matter, by which it was taken to mean that Ottawa will have no inspectors to check municipal expenditures, or anything else but hand over the monthly sum to Quebec.

"It means," said the Premier, "relieving Ottawa of a considerable charge, and adding considerable additional burdens to the province and municipalities. We are told Ottawa will not go beyond this amount."

Mr. Taschereau was asked as to the amount which the provincial Government had asked for, following upon the estimates submitted to Quebec by the principal municipalities, but he had no recollection of the figures. The \$600,000 decided upon is far below what was hoped for from Ottawa. By way of illustration, it may be stated that the City of Montreal estimated its needs for direct relief at \$1,200,000 per month. Under the old arrangement, which retroactively ends August 1st last, Ottawa paid \$400,000 of this and Quebec another \$400,000. It would mean consequently that if Montreal is to fare as well as in the past from federal funds it would have to get \$400,000 a month of the \$600,000 being allotted for the whole province, obviously an impossible division.

RACINE ON AERIAL SURVEY. Haileybury, Ont., September 7.—Armand Racine, commissioner investigating affairs of the Temiskaming and Northern Ontario Railway, left North Bay by aeroplane and will make an aerial survey of the country north of Cochrane. The trip will take at least two days.

## MURDER AND SUICIDE OVER FIFTY-CENT BOARD BILL

Boarder Kills Landlady of Winnipeg Rooming House and then Slays Self After Argument.

Winnipeg, Sept. 7.—Persistence in attempting to collect fifty cents unpaid room rent was recorded today as the motive for murder of Mrs. Jennie Hryhorko, aged thirty-six, and the suicide of Milk Ponik, former roomer at the Hryhorko home.

The cause was advanced by Andrew, husband of the dead woman and cousin of Ponik, at the inquest into the deaths here last night. The jury found Ponik shot and killed Mrs. Hryhorko in the Hryhorko home on August 29, and then shot himself.

Hryhorko said Ponik had roomed at his home but was asked to leave when his wife complained he would not pay his rent. Before leaving he paid \$12 but fifty cents was still outstanding.

A witness at the inquest was Elsie, five year old daughter of the slain woman, who witnessed the murder of her mother and suicide of Ponik.

TRAIN WRECK IN SCOTLAND TAKES HEAVY TOLL Glasgow, Scotland, Sept. 7.—A mounting toll brought the list of casualties in yesterday's train crash to five dead and thirty-three injured today.

Two passenger trains collided at the entrance to the central railway, some of the wooden coaches being smashed to splinters in the head-on collision.

## CENTRAL BANK WILL BE HEADED BY YOUNG CANADIAN FINANCIER

Appointment of Graham Ford Towers, Assistant General Manager of the Royal Bank of Canada, as Governor of Central Bank Announced by Acting Prime Minister—Deputy Governor Likely to Be Selected from United Kingdom.

Ottawa, Sept. 7.—A speeding up of organization will, it is expected, follow the appointment of a governor for Canada's new Central Bank. Yesterday the Dominion Government set all doubts at rest as to whether or not a Canadian would be selected for this high post with the announcement that Graham Ford Towers, assistant general manager of the Royal Bank of Canada, had been appointed. He will shortly celebrate his thirty-seventh birthday.

Swift advancement has characterized the career of Mr. Towers. A graduate with honors from McGill University, he entered the service of the Royal Bank fourteen years ago in the capacity of an economist. Subsequently he became inspector of branches in Cuba, and gathered considerable experience in the field of foreign finance. He was lately shortly for Europe there to study central banks in operation and gain knowledge to assist him in the important work awaiting here.

The anticipation now is in operation early in the new year.

Having selected a Canadian for the highest post, the government now intends to secure a deputy governor from one of the other central banks in the Empire so that his practical experience may be available in the initial stages. Mr. Towers, in accordance with the legislation passed at the last session of Parliament, is appointed for seven years. He will, however, be eligible for re-appointment at the conclusion of that period.

Launching of the new institution is in the hands of Hon. E. N. Rhodes, Minister of Finance. The share capital of the bank was fixed at \$5,000,000, and it is anticipated that the stock will be offered to the public within two months. The question of whether or not the bank should be publicly or privately owned constituted the chief issue when legislation was before Parliament. Liberals and Progressives lined up in favor of a government-owned and controlled institution, with the government forces favoring private ownership but with an appreciable measure of government control.

The functions of the new bank were clearly indicated during the stormy passage of the bill through the Commons. It will be a bank for commercial banks and governments but not for the public. It will take over all gold held by the commercial banks retaining it as a reserve against the note issue which it will control.

It will act as banker for the Dominion Government and may also perform similar functions for the provinces. It will advise the government on financial matters. For the gold which it takes over it will pay the normal rate of \$20.67 an ounce and the government will benefit from the difference between that and the market value. This provision was the subject of strong objection by the commercial banks.

Under the legislation the bank will have a head office in Ottawa but it may open branches in other parts of the Dominion.

## SITUATION IN TEXTILE WALK-OUT TAKES ON MORE OMINOUS ASPECT

Further Outbreaks of Violence Feared as Strike Executives Announce Intention of Forcibly Closing All Mills—Reject Arbitration Proposals Until All Mills in All Branches of Industry Have Been Closed—Martial Law Threatened in Many Districts.

Washington, September 7.—The United States textile strike assumed a more ominous aspect today, with the growing seriousness of the walk-out apparent in at least one sector of the strike front.

The death of seven persons in South Carolina yesterday led Governor Blackwood to announce he was "seriously considering declaring certain areas in a state of insurrection."

As the strike continued to spread, along with indications several allied industries would join in the movement, the board of inquiry named by President Roosevelt gathered in the Capital today to begin consideration of the controversy. Governor John G. Winant, of New Hampshire, chairman of the Board, declined comment as he arrived to meet his colleagues, Raymond Ingeroll, Borough President of Brooklyn, and Marion Smith, Atlanta attorney.

The Board was confronted by a strike toll of ten, injuries exceeding two score and several score of arrests. Apprehension was expressed in some quarters that fresh outbreaks of bloodshed would occur. Bitterness of the strike has been most evident in the southern areas where all ten deaths have occurred.

Additional thousands joined the strike yesterday to swell private estimates of the total number of strikers to 360,000, more than half the operatives normally employed.

Francis J. Gorman, strike chief, said other international unions might call out their members in support of the textile walk-out. Strike calls appeared imminent in the hosiery, draper and silk dyeing industries. Cotton garment workers were under orders to strike on October 1st, although this walk-out was not directly connected with the textile stoppage. The garment strike was ordered to force compliance with President Roosevelt's order reducing hours and raising the wage scale. Leaders said the strike would affect from 125,000 to 175,000 workers.

After the garment strike had been authorized, the executive board of the International Ladies Garment Workers Union took action to provide financial assistance to the textile strikers, officials said approximately \$25,000 would be spent. In addition the Board authorized appeals among affiliated organizations to raise \$75,000 for aid to the textile strikers.

National Guardsmen continued on duty in North and South Carolina today as fresh picketing attempts were planned. Every unit was on duty in South Carolina and eleven companies were mobilized in North Carolina.

The New England area, which yesterday saw picketing expeditions resulting in the closing of more mills, was comparatively quiet, although the ranks of the strikers had been swelled in Rhode Island, Massachusetts and Connecticut.

Conflicting views of the situation from the employers' viewpoint were expressed yesterday. The strike was "more serious" than the previous day and said the number of mills closing had been "tremendous."

Any hope that President Roosevelt's inquiry board would be able to start arbitration proceedings was dashed by the government's proposal that if an arbitration proposal is made "we shall agree to it only after we have closed all mills in all divisions of the industry."

Gorman said additional strike calls would be issued today, possibly including draper workers. He added that synthetic yarn workers would join next week and that the Silk Dyers' Union from Paterson, N.J., was sending representative here for a conference to decide on whether to strike.

The executive council of the American Federation of Hosiery Workers will meet here Saturday to consider whether to call out its members, except those operating under contract with employers.

Emil Rieve, the Federation president, said some hosiery mills in North Carolina probably would be closed today.

John J. Edgerton, president of the Southern States Industrial Council, sent President Roosevelt a telegram saying the action of the textile employers "clearly a strike more against the government than the National Industrial Recovery Act, the code system and constituted authority than against the affected employers of labor."

## THE WEATHER

CHEAPER RATES TO CANADA ARE EXPECTED SOON

British Government Has Before It a Recommendation for Cheaper Passage to Canada "if and when Conditions Appear to Justify Such a Scheme"

London, Sept. 7.—For a time in the future when economic conditions have improved and Empire migration again is feasible, the British Government has before it a recommendation for cheaper passage to Canada.

Cheaper rates to Canada should be restored "if and when conditions appear to justify such a scheme," the committee suggested. The £10 rate for British emigrants to Canada, which was in force from 1929 to 1931, was mentioned with favor in the report.

The committee, which conducted a lengthy investigation into migration matters, recognized that any large-scale land settlement in Canada or any other dominion is out of the question at the present time.

Not only the ocean, but the rail rate, was taken into consideration by the committee which suggested settlers be given a rate of \$10 to Montreal and east of Montreal \$12 to Winnipeg or east of the Manitoba capital to Montreal; \$14 to west of Winnipeg.

Present day encouragement of any migration scheme, however, asserted, might take the form of action to assist in giving primary producers a greater return. Britain should make every effort to enlarge and create markets in this country.

Thereby breaking the vicious circle whereby low returns to the producer and the low purchasing power of this country result from and are caused by one another.

SEEK INCREASE OF PENALTIES ON KIDNAPPING

Canadian Bar Association Debates Best Method of Combating Growing Abduction Habits.

Montreal, Sept. 7.—Prominent jurists from five countries prepared to discuss and return to their homes today as the three-day session of the Canadian Bar Association's nineteenth annual meeting drew to a close.

The international scope of the potential influence of lawyers and jurists was called to the attention of delegates last night by the Earl of Bessborough, Governor-General of Canada, who mentioned the presence at the conference of prominent legal men from Italy, Great Britain, the United States and France.

During the day Hon. A. W. Roebuck, K.C., Attorney-General for Ontario, occupied the chair at a session which discussed the question of kidnapping and its proper punishment. The convention recommended the adoption of more severe sentences in kidnapping cases.

Mr. Roebuck said he favored the lash for kidnapers if the sentence was not longer than five years and also sequestration of the property of victims and their relatives so as to prevent payment of ransom money.

The question was discussed freely by R. L. Calder, K.C., Montreal, former Crown Prosecutor, J. C. Meeker, K.C., Toronto, and Mr. Justice K. B. MacRae, New Brunswick, among others. Judge R. H. Murray, Halifax, was opposed to legislation increasing penalties in kidnapping crimes because he thought the remedy for criminals was not punishment but the improvement of conditions.

Alabama—Many workers armed in determination to keep jobs. Police and citizens on watch to turn back "flying squadrons."

Georgia—Police guard against further trouble. Shutdown of hosiery mills adds to general walkout. Two women arrested as Communists.

Massachusetts—Strike groups reported ready to picket mills in Lawrence where 20,000 at work, untouched by strike. Roads to Mount Hope mills in Dighton guarded against picket invasion.

PRESIDENT NOW AWAITS REPORT OF COMMISSION

Hyde Park, Sept. 7.—President Roosevelt watched efforts of his special United States textile strike board closely today for a solution of the aggravating labor dispute.

He kept informed of developments throughout the day, asking for all reports, but he was leaving full responsibility for Federal negotiations with the board headed by Governor Winant of New Hampshire. Until this board makes its report which is expected to be issued October 1, there is little likelihood of direct action by the President.

ONE-TIME STORM CENTRE REFUSES TO ANSWER CALL

Boston, Sept. 7.—Attention in the textile strike in New England turned today to Lawrence, where approximately 20,000 textile workers have been plying their trade, untouched by the general strike.

Dighton, in southeastern Massachusetts, also drew attention as the first private armed guards reported in New England paced before the gates of the Mount Hope Finishing Company's plant.

Apparently, United Textile Workers of America groups were intent on picketing the mills at Lawrence, once a storm centre in any textile unrest, but at present the most peaceful and content of any large New England mill community.

There were reports that Horace Riviere, New England strike director, was planning to throw his "flying squadron" picketers into the peaceful city at an early hour.

Police in Lawrence appeared to be making no elaborate plans for coping with the picketers. Officers on the late night shift were ordered to remain at their stations, but otherwise life went on pretty much as usual.

Workers in Lawrence seemed contented as they went to their duties in the mills on the night shift last night. Mill owners had no ideas of closing down.

GOVERNORS WARN AGAINST VIOLENCE IN CAROLINAS Charlotte, N.C., Sept. 7.—Bristling bayonets and machine guns in the hands of nearly fifty National Guard units were posted along the textile front today to preserve order in the wake of clashes which cost seven lives in the preceding twenty-four hours.

FURTHER CLUES ARE FOLLOWED IN KIDNAPPING

Reward of \$5,000 for Information Leading to Arrest of Men Who Abducted John S. Labatt Expected to Be Announced Today.

Toronto, Sept. 7.—Offices of the Attorney-General of Ontario today found officials active in sorting threads that might lead to the capture of the kidnapers of John S. Labatt, wealthy London, Ont., brewer. A \$5,000 reward for information leading to arrest of the men who abducted the brewer on August 14th, and released him early on August 17th, was expected to be announced by Attorney-General Arthur W. Roebuck after conferences with other officials in the case.

A little summer cottage in the Wildewood district of picturesque Muskoka has been revealed as the place where Labatt spent sixty-six hours with his kidnapers. The cottage is near Bracebridge, about one hundred miles north of Toronto, and it was to this place the gangsters sped with their captive after waylaying him on a lonely road between his Saranica beach summer home and London.

Twenty-four hours after Labatt was released, still blindfolded, in Toronto by the men who had demanded \$150,000 ransom in a note left in the brewer's abandoned car in London, police arrived at the cottage but their quarry had flown. Police, reticent regarding progress made on the kidnapers' trail, admitted they had known of the hideaway a day after Labatt was freed, but remained silent on ransom payment questions, even in the face of reports \$50,000 had been turned over by the Labatt family.

Chained to his bed by the wrists, Labatt was not allowed outdoors of the cottage, guarded by three gangsters, believed from the United States. They shaved him and fed him well if the empty cans of honey and two oil-cans. Mr. Lazure asked if he had noticed a carpet in the wagon. Revelation of the hide-away strengthened the belief officers were nearing the end of the trail. Continued From Page One. for him and paid up the taxes?" Guy shrugged. He has narrow shoulders. His shrug conveyed intended meaning. He did not know. "I am not educated," he said. "But without being educated," pressed Mr. Lazure, "surely you know the terms of the agreement?" The lawyer added: "You were present when the deed was drawn up. You understood that you were to take care of Saul Gregoire?" "Of course, I had to take care of him."

"You understood everything, then—before his death?" "Yes," another replied. He said that Gregoire had appeared very satisfied with the arrangement. "He was happy," he declared. A payment on the farm had to be met in the month of July. This payment was to be made to Saul's brother, who resides in St. Camille, a town of Halifax. "Gregoire asked me if I could meet this payment," said Guy. "I told him that I could pay part of it. It amounted to seventy-five dollars. I gave Saul forty dollars, and he was to furnish the balance and remit it to his brother."

"You gave him that forty dollars in money?" "Yes." "Have you a receipt?" "I told him that he had not. He had thought it necessary to ask Saul for a receipt. "It would have been different had I paid the money for a receipt. But Saul was asked for a receipt. But Saul was to make the payment."

Witness said that Gregoire must have had the forty dollars upon his person when he left for St. Camille on the night of August 19th. He was going to St. Camille to fix up a fire insurance matter, and also to collect some money on a note from a man named Lapointe. On Sunday evening at about 6:30 o'clock Saul Gregoire left for the

home of Louis Audy. He was accompanied by Conrad Audy, the latter's wife and their child. Gregoire had his own rig. Louis Audy resided about a mile from Gregoire's farm. "When we got there," Conrad Audy stated, "Louis and his family were away. We went into the house, and then Louis arrived. Saul wanted to continue to St. Camille. He left shortly after Louis arrived at the farm. I spent about eight minutes alone with Saul before he went away."

Audy said that Saul's rig contained an umbrella, a piece of rope and two oil-cans. Mr. Lazure asked if he had noticed a carpet in the wagon. "Yes, that's it." "I have not used it this year," Audy continued to state that he left Louis Audy's farm at about nine o'clock, together with his wife and daughter, and returned home. He had not seen Gregoire again. During the night he got up several times. Once it was because of the baby. His wife did not get up, but he lighted a lamp and noticed the time. It was about five after ten. Later during the night he had to get up twice because the dog was barking.

"Are you a huntsman, Audy?" asked the Crown prosecutor. "Yes," Audy smiled slightly. "Well..." He sounded modest. "You own a rifle?" "Yes, I do." "Is this it?" — And Mr. Lazure proffered a heavy gun. Audy examined it quite closely. He said: "Yes, that's it." "The gun was a .303 calibre. Audy said that he had left it at Louis Audy's farm. "You see, I did not need it. The hunting season was not open."

"When Gregoire left for St. Camille," another channel, "drifting into," another channel, "was wearing a sweater?" "Yes, and his knees were covered with an oil-cloth." Conrad was then questioned closely upon his activities at Louis Audy's farm after Saul's departure. Witness said that when Saul left he entered the barn. found traces of blood. Mr. Bachand asked the doctor how long Gregoire might have lived after being shot. Dr. Roussel could not be positive. "It could have been only a 'matter of minutes,' he said. "Death was not instantaneous, but it was rapid. Say, about five minutes after the shot was fired."

Oscar Paquin, fourteen years old, was confronted with the carpet. He said that he had seen one "similar to that" in Gregoire's wagon only a short while before the murder. John Gregoire, a brother of the dead man, also stated that he had seen a carpet in Saul's wagon. "He used it to cover his feet."

Sinal Croteau, fifty-three years old, said that he had seen Saul about four or five days before his disappearance. Mr. Lazure, exhibiting the now-famous carpet, "Ever see this carpet in his wagon?" "Sinal Croteau said that he had seen one similar to that. "About eight days before Saul's death."

"That was while Saul Gregoire lived with Audy?" "Yes." "Between twelve o'clock and one o'clock Monday morning, August 20th, Dorilla Manseau drove along the road where Gregoire's body was found, he told the Court. "Was Gregoire's wagon there or any wagon?" "I did not see any." The witness said that he would have noticed a wagon parked on the road or by the side of the road.

Arthur Fileau, of South Ham, said that at about 12:30 o'clock on the Sunday night that Gregoire disappeared he passed by the corner of the 10th Range of Dudswell road and the Marlboro road. He met a horse-drawn rig. The horse was gray. "There was somebody in the beam," he said. "I heard a man say 'Giddup.' "You knew Saul Gregoire?" "Yes, I did." "You had spoken to him before?" "Yes, in his opinion, he said, it had not been Saul Gregoire's voice that had said, "Giddup."

Xavier Audy, white-bearded seventy-year-old farmer of the 10th Range of Dudswell, said that he had found Gregoire's gray mare on the morning of Monday, August 20th. The horse still carried its harness. When Saul Gregoire left Louis Audy's home he dropped out of sight completely. He was not seen returning along the Marlboro road in the section of the 10th Range highway; neither was he seen emerging from the short cut leading from the Marlboro road to the St. Camille route.

Detective Auguste Guyon, of the Provincial Police, stated that he had found the carpet near a wooded sector along the short-cut road, some distance up a steep hill. That was about five miles from the place where the body was found. The .303 calibre rifle which Conrad Audy had identified was found at Louis Audy's home on August 29th, the detective said. "I had given to me by Mrs. Audy. I had asked Louis Audy himself on August 23rd, if he had any rifles. He had replied in the affirmative, informing me that one of the rifles belonged to Conrad. I asked him if I might have Conrad's rifle, and he sent his boy to get it. This is the rifle they gave me," and Guyon exhibited an old .32 calibre gun. "The rifle was so dusty, indicating that it had not been used for a long time, that I did not bother to take it with me."

"I asked Louis Audy: 'Is that the only rifle belonging to Conrad?' and he said, yes, and that it had not been used for about two years." Detective A. W. Morrow corroborated Detective Guyon's testimony. He added that Louis had told him that Conrad had been absent about twenty-five minutes or half an hour following Saul's departure on Sunday night.

The distance between Louis Audy's farm and the short-cut road where the blood-stained carpet was found could be covered on foot in about five minutes if a person used the footpath leading from Audy's to the Marlboro highway, in the opinion of Gerard Audy, twenty-year-old son of Louis Audy. Louis Audy was then called to testify.

He gave his age as fifty-seven or fifty-eight, he was not positive. "On Sunday night," he told the Court, "I arrived home and found Gregoire

SABRE-RATTLING BY MERCENARY WRETCHES.

What has long been hinted at is now being proved by testimony. The makers of war munitions have been desperately fomenting strife between nations by means of the bribery of officials in high places. The war party, or militant party, so often referred to as "in military circles," are proven agents of munition makers who, with avarice and greed, promote the sales of arms, of cannon, of warships and fighting airplanes by playing on prejudice and racial characteristics. They find plastic public men to do their bidding, and to so provoke nations that they can make large sales of killing instruments.

With this knowledge in mind the politicians who play the war game can no longer plead ignorance when they make damaging statements.

Labour strife is being manufactured in the United States by men of the same type. Low brows seek a place in the public eye, and glow over their pictures appearing in the newspapers.

There can be no evasion of the guilt which lies with them by such men. That they would rather call on a president or premier than upon a policeman has long been the preference of paid agitators, particularly those who fear to lose well-paid jobs unless they can make a fuss and attract attention as does Little Orvie who shouts "Look at me! I'm Orvie!"

SUBSIDIZING INEFFICIENCY.

With many, unemployment becomes chronic, and relief costs grow higher per capita and by millions in dollar volume.

Thirty cities, with a population of 2,805,487, recorded \$34,612 as out of work, or one in every five, 19.41 per cent. to be exact.

This does not include relief camps, like the one at Bishop's.

Cost of relief administered by these thirty municipalities in 1933 was over \$38,500,000, or about \$13.72 per person, or over \$60 per family.

That some municipalities are more philanthropic, more charitable than others, where public welfare societies are conducted, and the efforts are shared by the citizens, is indicated by the variation from \$3.42 per person to \$19.41.

Quebec City's per capita cost was \$3.42; Toronto's was \$19.41, and Montreal's \$17.34.

Of the \$38,500,000, the thirty municipalities had to pay \$12,460,000, of which \$9,900,000 was raised by the sale of debentures or mortgages on the municipal properties, which will have to be returned by the taxpayers with interest, and will for years be a burden upon industry.

Some of the cities used the Open Voucher, others the Closed Vouchers, whilst others used the "depot," as did Sherbrooke, whilst yet others used the "cash system." There is no approach to uniformity.

Suburban areas were invariably less costly, no doubt because the neighbours knew the deserving and the undeserving, whilst in the crowded cities people seldom know their next door neighbours.

Toronto, taking the most of the government relief funds and the highest per capita cost, used the depot system and the closed voucher. Quebec used only the closed voucher system.

There should be a nation-wide policy where so much public money is being paid for relief which is likely to become chronic. There are signs of a union organization among the thrifless and the unemployed, the shiftless and the dissatisfied. There has been no expression of gratitude for relief accorded.

THE SPEECHLESS WONDER.

"Ike" Hoover, as interpreted by Wesley Stout in the Saturday Evening Post, who was resident genius in the White House under a line of Presidents—both Republican and Democratic—intimates in his memoirs that President Coolidge was intensely disappointed when the Republican party took him at his word.

"I do not choose to run," said Mr. Coolidge. But he never said "I will not run." His first term was as a successor from the Vice-Presidency, just as Theodore Roosevelt's. Technically his candidacy would not have been for a third term.

The ex-President had a reputation to keep up—as an oyster. He would not amplify his cryptic utterance.

His friends took him at his word. He was too coy.

"Ike," the man within, the close observer of Presidents and their characteristics, believed that the gentleman from Vermont was but a keen horse-trader who waited for a universal demand that

Coolidge succeed himself. But though there were those who voiced the cry to "Draft Coolidge!" That is, to nominate him as the Republican candidate in the surety that he would no longer be coy, but would at once accept.

Mr Coolidge was visibly mortified, was even peevish. Thus passed the united experiment with a "speechless wonder" as President.

But the Man in the White House was of the firm opinion, gained from close observation of Coolidge, that he had hoped up to the last minute that his brief indulgence in the double entendre was meant to intimate that he feared the "third term" objection and chose this way of having the nomination brought to him on a silver salver. He forgot the hunger of other aspirants, who had both the gift and the ambition, men who did not bite their sentences in two.

SOMETHING FOR NOTHING.

Patting myself on the back for the success of a conceived and carried out effort to restore to the County Fair the interest which it deserved, I was wounded in my self-esteem at the Brome Fair.

How many bones are there in a turkey leg? Well one good friend of mine picked that many bones with me because I had written only a few lines about one of the finest County Fairs in Quebec.

Politely and smilingly I refuted the ascribed fault, and we broke bread and ate salt together, yet part of that leg of bones was between us.

Nobody knows how generous I would be with free readers and copious draughts of adulation if I could pay my competent staff of editors, reporters, printers, pressmen and office staff—fifty of them in all—with the revenue from free readers.

May I repeat my oft-quoted definition of the difference between news and advertising:

A writer in "Post and Providence," published in Halifax, recites the story of "The Place of Welcome," the town of South Brookfield, N.S., brought to new and broader life by the advent of the family and the industry founded in Disraeli, Que., by Charles Bienvenu, and now carried on in Nova Scotia by the sons of the founder, now a resident of Sherbrooke. The two sons, Wilfrid and Lionel, are residing in South Brookfield, together with their brother-in-law, A. E. Rheault. Charles Bienvenu began his career in Bolton Centre, with a pair and tub factory, when he was a boy of thirteen years, and it was a similar business which he launched in Disraeli and carried on for fifteen years. OXFORD GROUP ACHIEVEMENTS UNDER REVIEW

Speakers Demonstrated at Open Meeting at North Hatley Last Night How Oxford Group Offered Solution to Their Own Personal Problems and Was the Answer to the Needs of the World.

North Hatley, Sept. 7.—At an open meeting held in the North Hatley Town Hall last night, four hundred people heard a team from the Oxford Group House Party witness to the change that had taken place in their lives and their minds since they had identified themselves with the Group. People of every walk in life, clergymen, a professor, businessmen, bankers, mothers, wives, students, a former Communist, and a Superintendent of the Royal Canadian Mounted Police, demonstrated how, through the life of the Oxford Group, they had found the solution not only to their own personal problems but had discovered the answer to the needs of the world.

The crowd of people, who filled every available chair in the hall and stood along the sides and at the back, were told the principles on which the 'quality of life' in the group is based and were given a vision of the tremendous importance of the message which the speaker brought. Although the most of the audience were registered at the Pleasant View House, where the House Party is being held, a number of the summer residents of North Hatley, as well as a number of the townsfolk attended. Interest was keen, the attitude throughout was sympathetic, and the program for future meetings and the whole House Party was bright.

The meeting was led by Rev. Frederic C. Lawrence, of St. Peter's Episcopal Church, Cambridge, Mass., who admitted that he had accomplished a spiritual re-orientation of his life when he met the International Team of the Group and saw their work at a businessmen's lunch in Toronto last spring, and later at Banff, where the Group held an international conference in May, and at last all at Oxford during the House Party held in July. Mr. Lawrence stressed the international aspect of the Group's outlook and pointed out that North Hatley was an international centre in that people from every part of the United States and Canada came there for the summer. What a possibility this fact presented for a more complete understanding and greater harmony between Canada and the United States was emphasized by Mr. Lawrence. The Group had realized this possibility and made a special effort to produce such a result by holding the Eastern House party in such pleasant and ideal surroundings.

Major Mark H. Vernon, of Ottawa, Superintendent of the Royal Canadian Mounted Police, pointed out that as in his own life, so in the world, an old superstition could not be rebuilt without new underpinnings. The props were individuals, and they had to be changed and renewed. Mrs. F. C. Lawrence, of Cambridge, Mass., long a summer visitor to North Hatley, told of her trip to the west with the International Team in the spring and how she had seen the need and the answer to the need in the work of the Group in Portland, Ore., Vancouver and Banff. She saw Canada as wholly Christian, leading the world out of the chaos and confusion which perplexed and threatened to engulf it now.

Other speakers, Bob Walton, of Toronto, and Loring Swain, Jr., of Boston, told of how the Group had changed their lives. Following them, Dr. Philip Marshall Brown, former professor of International Law at Princeton University, told of the need he saw for the Christianity of the Group. The internationalism of the present relations of the United States and Canada could be made into a super-nationalism which would transform the present phenomenon of Canada being directly influenced by the United States into a super-nationalism to the United States being influenced by the spiritual superiority of Canada. To do this, however, Dr. Marshall Brown admitted, Canada would have to accept her responsibilities and become a completely Christian country. In the field of his own work, a university professor could even be used if he were willing to accept the task.

Dr. C. J. Edgar, of Sherbrooke, followed Mr. Lawrence and he told of how the Group, and the practical Christianity it preached and practiced had completely revitalized his life and had given him, a non-believer in a religion he could follow at a time when he was in dire need of religion, any religion.

Mrs. Eric Bentley, of Toronto, told of the purpose in life she had found through the Group. It had come, Mrs. Bentley admitted, when she was obsessed with fear, divorce, death and financial difficulty. It had brought her, a young woman, five years married, a realization of the obligations resting on the youth of the country to work things out and to give our children a greater and better heritage than had been handed down to her generation.

Eric Bentley spoke next. He told of how the four standards of absolute love, unselfishness, purity, and honesty had challenged him and through facing up to them he had seen and found the solution to his family and business problems. It was a matter for the individual personally; for in the individual, in pride, in lust, and greed, and dishonesty, the sins of the world were present. In the world they were merely veiled large.

James Watts, of Aberdeen, in rolling Scottish accents, and with rare humour, declared how he had seen the feverish attempts to find an answer to the world's problems, just as Roosevelt and Hitler with

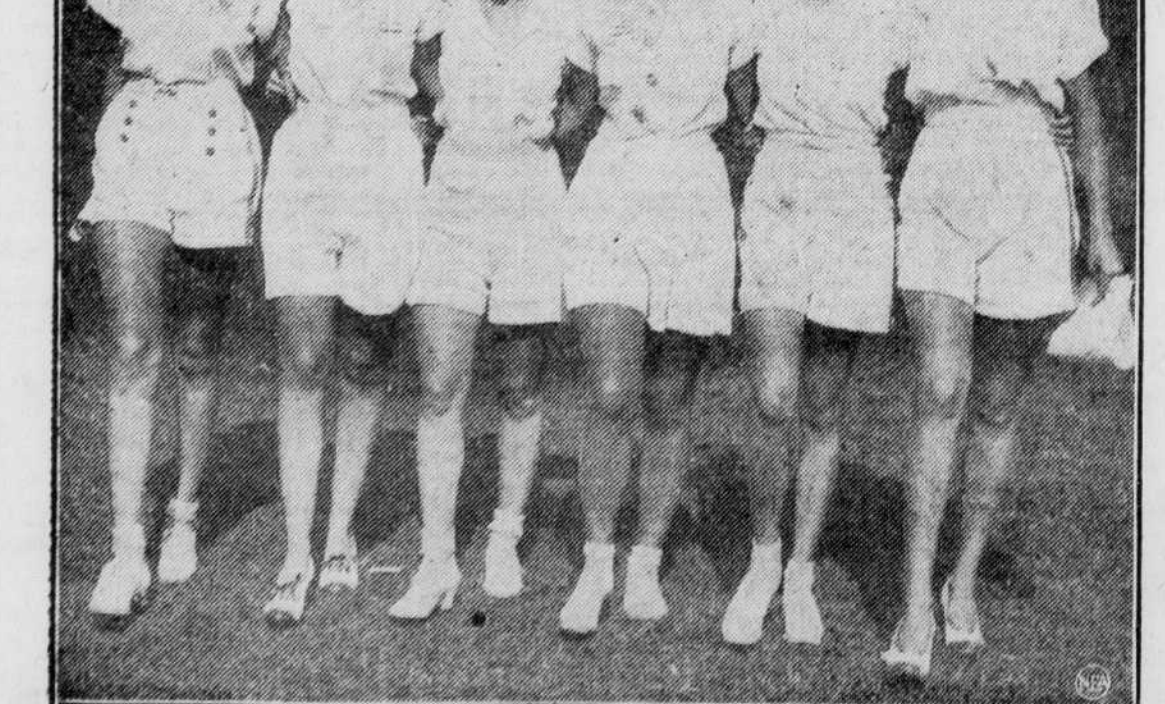
