London, July 22.

The compromise on the Irish Church Bill was the result of fear on the part of the Peers of the consequences threatened by a collision of the two Houses of Parliament.

Last night the Tory Lords held a large meeting at a private residence and resolved to repudiate the Marquis of Salisbury and put themselves under the lead of Lord Cairns. The latter was authorized to make peace with the Ministry and express the willingness of the Peers to yield.

To-day Lord Cairns sought an interview with Earl Granville and gave in the submission of the Peers, whereupon the Cabinet agreed to the compromise announced to-night.

The prompt and loud expression of popular indignation terrified the Lords and thus postponed for a while the threatened agitation.

St. Domingo, July 22.

The town of Azua is besieged by the insurgents. President Baz has sent troops to aid the garrison and is confident of success in suppressing the rebellion.

Washington, July 22.

Secretaries Cox and Creswell gave an audience to-day to Colonel Warren, who waited on them in reference to General Halpine, at present confined in England. Both Mr. Cox and Mr. Creswell promised all the assistance in their power to effect his release.

New York, July 23.

The Herald's Washington special says: The Secretary of the Treasury on being questioned on the subject replied that he had no intention at present of selling gold, and that he did not expect to sell any while the premium was at the present figure. The impression at the Treasury is that it will go lower. This seems to be founded on the fact that United States bonds have advanced in Europe in consequence of the favorable exhibit of Secy. Boutwell's financial management, and that by the time there is a demand for the shipment of gold the crops will be ready to bring into the market. A letter received here to-day from an American traveller in Europe alludes in warm language to the beneficial effect of Mr. Boutwell's policy in strengthening the credit of our Government abroad.

FROM OTTAWA TO-DAY.

Ottawa, July 23.

Mr. George E. Cartier leaves town to-day to see the Governor-General at Quebec, and proceed with him and Lady Young on an extended tour through the Maritime Provinces.

Montreal, July 23.

At the next meeting of the City Council Alderman Devlin will make a motion for the appointment of commissioners for Mount Royal Park, under the act passed at the last session of the Quebec Legislature.

Prince Arthur will sail for Canada on the 14th August accompanied by Lieut. Col. Elphinstone, V. C., and Lieut. Poirer, V. C. Sir Francis Hincks, left town this afternoon for Ottawa and the west.

Much speculation has been indulged in as to the nature of the important intelligence referred to in our last. The Journal de Quebec gives currency to two rumors, neither of which has the slightest foundation. It says there has been a conflict between the British and American fishermen in the Gulf, which may lead to war with the United States; and what is still more unlikely, than an immense Fenian organization has been discovered in the Province of Ontario! The real cause of our statement yesterday was a report, now more general, but discredited, that Minister Motley had received instructions to return to Washington, having failed to come to terms concerning the Alabama claims.

The message sent to us by our Ottawa correspondent to the effect that Mr. Rose will not only leave the Ministry, but leave this country to take up his residence in England, to accept a position in one of the largest banking establishments in the mother country, proves to be correct. The Montreal Gazette says: "It is probable, however, that he may retain his seat in the House of Commons." The banking house into which Mr. Rose is about to enter is said to be that of Messrs. Norton, Bliss & Co., of New York, who have a branch house in London, where Mr. Rose is to reside. The Montreal Herald takes it for granted that "it will be utterly impossible for him, as the Gazette asserts, to hold his seat in our legislature, while living at so great a distance, and occupied in duties which will, no doubt, be of an engrossing kind." If the qualities of assiduous and careful attention to duty, and a large experience of all kinds of business, can be expected to fit any one for the post which he is about to assume, we may expect that in his new career he will not be less fortunate than in that which is passed.

The position of the Irish Church question is now more serious than ever. Will, or perhaps rather can, a conference of the two Houses terminate the deadlock of the Government? What will the new bill be like which Gladstone proposes to introduce after the contemplated prorogation of Parliament? One thing is certain, it will not be identical with, and probably will be infinitely more unfavorable to the Irish Establishment, more revolutionary in the sense of organic change, and to restore the old phrase of England's great revolution in the middle of the seventeenth century, more "root-and-branch" in its workmanship and execution than that measure which the bitter sectarianism of Lord Cairns, more than any other man, has contributed to defeat. Are the old tactics of Lord Brougham on the Reform Bill to be repeated by Mr. Gladstone; are the spiritual peers of England to be told to "set their House in order, for the people are coming down upon them;" are the lay peers again to be told "if the bill does not pass through your House it will pass over your House." Will Gladstone really carry out the threat of new creations in such numbers as necessary to secure the success of the bill? Time was when such threats were dangerous. James II. threatened to call up a troop of life guards to the Lords and make a peer of every man of them. Six months afterwards he was an exile in France. The days since then are doubtless changed. Once, indeed, under the house of Hanover, the peers were increased in order to pass a bill which otherwise could not have been carried; and in later days William IV. expressed himself ready to create as many peers as might be necessary to carry the Reform Bill. There is little doubt that, despite the desire of the Crown to support the purity and dignity of the Upper House, the Queen, sooner than permit a measure so essential to the peace of the realm and the pacification of Ireland to be defeated, would accede to the advice of her Ministers even to the extent of swamping the House of Lords. It is, however, possible that her Majesty will previously insist on a dissolution of Parliament, in order to take the sense of the nation on the conduct of the peers. The lords would never have the tenacity, or rather the insanity, to resist a fresh condemnation by the popular will. A folly at once so unconstitutional and so suicidal as that would show that the Upper House indeed wanted an infusion of fresh blood, and might be benefited, but not injured, by any number of new creations. In any case the period of prorogation will be one in England of such excitement as has not been known since the Reform Bill, and in Ireland of such agitation as has not been surpassed since 1829. England and the whole British empire are in the throes of a mighty revolution. May it please Provi-

THE MARQUIS OF HARTINGTON ON THE PURCHASE OF TELEGRAPHS.

In Committee of the Whole in the House of Commons on Monday, the 5th inst., the Marquis of Hartington brought in his Money Bill for completing the purchase of the telegraphs. Premising that the basis of the arrangement of last year was twenty years' purchase of the net profits up to June last, he explained the steps taken by the Post Office authorities to ascertain those profits and the value of the stocks to be taken over. The chief results of these inquiries are summarized in a table, and are as follows:—The telegraph companies in 1868, 1869, and 1870, had a net profit of £1,235,377, £1,715,047, and a statement of £1,230,030, and of £1,252,109 would be for the purchase of £220, and £494,938 for other items. The purchase of the rights of the railway companies he put at £700,000, the expenses of extensions at £300,000, and including compensations to small companies, necessitated by the monopoly clause which the Bill would contain, he calculated the whole cost of the transfer at £9,750,000. The inquiries of the Post Office show that the business of the telegraph companies was rapidly increasing in one case at 18 per cent, and in another, at 32 per cent, per annum; but calculating the average increase at 10 per cent, the sum of £9,750,000 would represent not 20 but only 17 1/2 years' purchase of the profits at 1869. The annual revenue he put at £673,838, and the expenditure £358,454, giving a net profit of £315,384; and the interest on £9,750,000 at 4 per cent, being £270,000, and at 3 1/2 per cent, £236,350, in the one case there would be a surplus of £44,000 and in the other of £77,000. The Bill would give power to raise the purchase money by 10 per cent, on the basis of the year 1869, and he anticipated that it would be raised at the rate of 3 1/2 per cent, so that the surplus would be £77,000. He went with some minuteness into the details of the estimates of revenue and expenditure, and under the first head he alluded to the revision of tariffs and additional facilities the number of messages would be raised from 6,250,000 annually to 8,815,000, which at an average rate of 1s. 2d. would give an annual revenue of £514,234. The revenue of the consolidated stock of telegraphs he estimated at £109,604, from private wires at £25,000, and from transmission of news £25,000. After allowing the House that the estimates had all been framed on the most moderate basis, he concluded by a justification of the monopoly clause, mentioning among other arguments, that the number of offices would be increased from one in 13,000 to one in 6,000 of the population.

The Corporation of Three Rivers very wisely imposes a special tax of three dollars upon each and every editor who distracts the councils of that usually quiet town. It threatens to raise it to four shortly if the two now there do not stop quarrelling, and the effect has already become apparent.

THE LATE STORMS.—The effects of the late heavy gales and storms have been keenly felt in many of the country parishes. We learn that at Portneuf the roof was blown off a farmer's house, and two barns on Mr. Dodd's farm were carried away, and the timbers are said to have blown twenty yards. A fence on St. John's Road was blown down on Wednesday night, and coming in contact with one of the strong and handsome iron lamp-posts, bent it half way to the ground.

ST. HILAIRE TO CACOUNA.—Two young gentlemen, Messrs. Jarvis and Paddon, of Lennoxville, have arrived in town, having accomplished the somewhat novel feat of navigating the St. Lawrence in a skiff, from St. Hilaire, by the Richelieu river, through Lake St. Peter and thence to Quebec; time six days. They are provided with materials for camping out and intend proceeding as far as Cacouna.

THE BALL.—The guard of honor at the Citizens' Ball to the Governor General and Lady Young, was formed of a company from the 9th Battalion (Volunteers) Quebec Volunteer Rifles, under command of Capt. Arthur Evanslett, Lieut. Elzear Gauvreau and Esquis Lapointe, and saluted their Excellencies the Governor and Lieutenant Governor on their entrance, the Band playing "God save the Queen."

H. M. TROOPSHIP SIMOON returned from Halifax this morning and will leave for England on Thursday, the 29th inst., with Artillery and Hussars.

MIDNIGHT DESPATCHES.

London, July 21.

The Times this morning in an editorial says:—"The Ministry has resolved to propose the Irish Church bill in spite of the majority against it in the House of Lords. The bare conclusion, the Times continues, is the difference between the House in respect to the preamble and 68th clause, and do not offer insuperable obstacles to the passage of the bill. The Harvard Court at Putney. They have declined the challenge of the London Club. The Times, alluding to the recent aggravated outrages in Ireland says:—"Centuries of misrule have planted perverse views in Irish peasants, which must disappear under beneficent and enlightened legislation. For this reason we trust in such measures of justice as the Irish Church bill, which should not be left unexecuted a moment longer than can be avoided. Until it is settled there is little hope for tranquility in Ireland and the temporary postponement. Heavy indeed is the responsibility of those who have the power to rescue the measure from delay. In the House of Lords, to-night, there was a full attendance of Peers and spectators, and many members of the House of Commons were present. The consideration of the amendments to the Irish Church Bill was resumed. Earl Granville opened the debate by stating that Her Majesty's ministers regarded the vote as one of a very grave character, but they were unwilling to prevent the consideration of the other amendments to the bill and were anxious to conduct the discussion in a spirit of peace and conciliation. He proposed the re-insertion of the original clause, the disestablishment, namely, January 1st 1871, but should insist on a division of the House; if the motion was contrary to the feeling of the House he would withdraw it. Lord Cairns said since the adjournment he had had a conference with Earl Granville. He was glad to find that Earl Granville was actuated by a similar spirit; nothing could be more culpable on either side than to encourage or protest controversy on a measure of the kind, where the materials for solution were at hand, and with that view and that sentiment, everything which took place at the conference was accorded. He agreed that the question was of second order importance, and he declared that he was ready to accept the original date. He advised the Lords not to insist on their amendments. In regard to the Curates' ecclesiastical residences and the distribution of annuities, if three-fourths of a diocese were willing to commute, they would have 8 instead of 7 per cent. added. The question with respect to the disposition of the surplus might be left over, but power should be given to Parliament to apply a portion of the fund to the alleviation of unavoidable calamities. Lord Cairns concluded by admitting that he still has strong objections to the bill, but if it was to pass at all it was not for the interest of the country or the Church to prolong the struggle on minor details.
