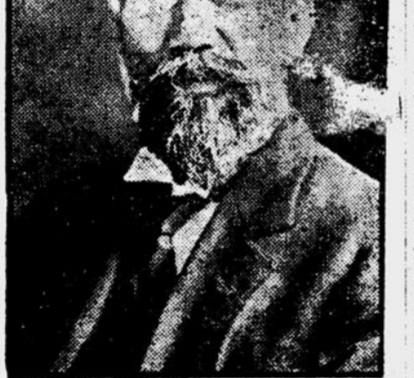

DRUGGIST WHO CONTRAVENED PHARMACY ACT GETS OFF EASILY.

Joseph Pigeon, a druggist, who, with several other parties, was summoned before the court on a charge of selling cocaine in contravention of the Pharmacy Act, was found guilty by Judge Leet in the Police Court this morning, but was allowed to go on suspended sentence. The other cases were postponed.

OUTREMONT COUNCIL.

The Town Council of Outremont held a meeting last night at which Mayor Gorman presided, and the following councillors were present: Messrs. Nadeau, Desjardins, Dunlop, Ainsley, Beau-bien and Robinson.

The special assessment roll for local improvements for the year 1908, was homologated. Councillor Beaubien submitted, seconded by Councillor Nadeau, the following motion: 'That a new audit of the books be made and the annual statement be prepared. It was explained that as the financial year ends on Oct. 31, the citizens' committee would have the new financial statement before them as soon as it could be prepared.

This would place before them the necessary information to enable them to do their work of revision and investigation. The motion was adopted and the Council adjourned after the usual routine.

STREET CARS COLLIDED

DANGEROUS INCIDENT ON PARK AVENUE IN THE FOG.

The fog prevailing this morning was responsible for a collision between a street car, and a sand car on the slope on Park avenue between Pine and Duluth avenues. The passenger car was following the sand one down the hill when the motorman suddenly noticed it. However, it was too late and a collision consequently occurred. Both cars were damaged but they were able to proceed on their way. None of the passengers were injured.

DYNAMITE IN TIPPERARY

Dublin, Oct. 27.—The agrarian agitation in County Tipperary culminated last night in a dynamite bomb outrage. The residence of two well known landowners, brothers named O'Mullane, at Templemore, was the scene of it. The bomb was placed on a window sill and exploded, demolishing the window. Two old servant women had a miraculous escape from death.

FIRE RECORD

Rome, N.Y., Oct. 29.—Fire which originated in an electric car standing in the barn of the Rome City Street Railway Company last night, destroyed the building, with its contents. The property was owned by the Utica and Mohawk Valley Railway Company. The loss will approximate \$40,000.

Charlottetown, P.E.I., Oct. 29.—Five buildings on Frank Heartz's large farm, together with the season's crop and farming implements, were destroyed by fire to-day. Loss about \$15,000. Insurance, \$12,000.

FORTY REASONS FOR RELEASE.

His Lordship Sir Henri Taschereau, Chief Justice of the Court of King's Bench, heard argument in the case of Walter H. Geiger, committed for extradition on a charge of obtaining money at Tampa, Fla., by false pretences, and whose lawyers are applying for habeas corpus. Mr. N. K. Laflamme, K.C., who is associated with Mr. J. H. Dubreuil in the interests of the prisoner, presented forty reasons why Geiger should be released the main one being that the false pretence had not been proved. The Chief Justice fixed judgment for Saturday.

BAPTIST CONVENTION

THE REV. P. C. CAMERON DELIVERS SERMON—REPORT OF SUNDAY SCHOOL BOARD.

Ottawa, Oct. 29.—The first business session of the Baptist convention of Ontario and Quebec was held to-day. The convention sermon was delivered by the Rev. P. C. Cameron, of Owen Sound, and the report of the Sunday School Board was presented and discussed at some length. The latter showed that there are 464 Sunday Schools in the Baptist Church in these two provinces, with 4,962 teachers and 41,741 scholars. This is an increase of 16 schools, 130 teachers, and 2,160 scholars over last year, but the report, as well as the ensuing discussion, all emphasized the need of greater attention being devoted to this important feature of the church's work.

Ex-Mayor Thos. Urquhart, of Toronto, presided over the sessions as president elect of the convention. The report of the Home Mission Board will be presented this afternoon.

KILLED BY STREET CAR

UNKNOWN MAN KNOCKED DOWN AT THE CORNER OF RACHEL STREET AND PARK AVENUE.

A man was knocked down and fatally injured by a street car at the corner of Park avenue and Rachel street, this afternoon. When picked up he was in an unconscious condition and was immediately conveyed to the Royal Victoria Hospital, where he died shortly after admission. The hospital authorities have failed as yet to ascertain the victim's name or address.

REVOLTING CONDUCT

FOUR PRISONERS CONVICTED IN EAST END SCANDAL CASE.

Three men were convicted of revolting conduct in what is known as the St. Catherine street scandal, by Judge Choquet, this afternoon. They were Dr. J. N. Geoffroy, Joseph Berton and Arthur Thibodeau. A fourth accused was discharged. Joseph St. Pierre, another member of the gang, was convicted yesterday. Sentences will be pronounced to-morrow.

CHEESE FACTORY BURNED.

Cornwall, Oct. 28.—The 'Royal' cheese factory at Summerstown was destroyed by fire this morning about 10.30 o'clock. Just how the fire started is a mystery. It is thought, however, that a coal dropped from the furnace and set fire to the floor. The building and the entire contents, including cheese, were destroyed. The building, which was owned by H. A. McLaren, was insured in the Metropolitan. The stock of cheese, some 18 or 20 boxes, was insured in the Royal.

SUPPOSED FUR THIEVES.

Horace Quimet and Romeo Ouellette were arraigned before Judge Bazin this morning by Detectives Laberge and Giguere, charged with breaking and entering a store on Rachel street, and stealing therefrom a quantity of furs. They pleaded not guilty and were remanded for enquete.

NEW INSPECTOR OF JAILS.

At a meeting of the Provincial Cabinet, held in Quebec, yesterday, Dr. Choquette, of St. Hilaire, was appointed inspector of prisons, in the place of the late Dr. Chevrefils.

LONGBOAT'S POSITION.

Will Become a Professional and Meet Hayes and Dorando in New York.

Toronto, Oct. 28.—It has at last been definitely decided that Tom Longboat will enter the professional ranks, and he will do so this fall, probably next month. For some time past P. T. Powers has been at work trying to arrange a race or series of races in Madison Square Garden, New York, with Hayes, of New York, the Olympic Marathon winner; Dorando, the game little Italian who finished first in that great race, but was disqualified; Tom Longboat, and Alfred Shrubbs.

The deal has all but been completed, with a proviso laid down by the Indian's manager, that Hayes, Dorando and Longboat race first, and then a series of races will be arranged with Shrubbs. They figure that the three Olympian Marathon runners will fill Madison Square, and that another crowd would be attracted by the match between Longboat and Shrubbs, thus ensuring larger gate receipts.

Negotiations to this effect are practically completed. Tom Flanagan, of the I.C.A.C., will continue to act as the Indian's manager. Matches will also be run in Montreal, Toronto, and other Canadian centers.

Longboat will, however, wind up his amateur career in the Hamilton 'Herald' race, which he is confidently expected to win.

According to the Buffalo 'Express,' the majority of the spectators of Shrubbs' last race are inclined to the opinion that he shows better form than Longboat, but a staunch admirer of the Indian runner, who believes thoroughly in his ability to win from the Briton, is Davis, also an Indian, who raced against Shrubbs. Davis is the man who brought Longboat out several years ago.

In those days Longboat was a tame Indian compared to what he is now, said Davis, in his dressing room, 'but, all the same, I think he is good enough to give Shrubbs all he wants at fifteen miles, and I have little doubt at ten also.'

(Canadian Associated Press.) Manchester, Oct. 28.—Five thousand spectators to-day witnessed a fine game between the Canadian lacrosse team and the North of England twelve. The Canadians winning by 6 goals to 5. It looked like a loss for Canada, with the team apparently all in, the score a tie, and less than two minutes to play. In a final effort, the Canadians notched the goal that won the game.

The Canadians apparently thought they had an easy thing, and were still more of that opinion when Gorman scored the first goal of the match in a minute and a half. Instead of following up their advantage and turning to good account the bewildering of their opponents the Canadians took it easy, and at the end of the first quarter led by only 2 goals to 1.

GOLFING GOSSIP.

The close of the golfing season at Dixie, as far as competitions are concerned, takes place on Saturday, when the Royal Montreal Club will play Outremont in a home and home match. The exact number of players has not been decided, but about sixteen pairs will play at Dixie, and ten at Outremont.

Although there will be no more competition at Dixie this year the links will remain open just as long as play is possible, that is, until the snow comes.

One very noticeable feature of important golf matches in recent years is the large crowd which turns out to see the play. It is not many years ago when the finals in the amateur and open championships drew the only crowds worth speaking of during the year, although when two professionals were matched, there was always a following, but only from the locality. But in the recent professional tournament at Mid-Surrey there were between 3,000 and 4,000 spectators watching the final between Taylor and Robson, an immense number of people to wander over a golf links.

When a crowd follows any particular match, one is accustomed to the use of a rope to keep the players from being pressed, and it is distinctly interesting to note that in the match above mentioned the time-honored custom was disregarded, and with excellent results.

The authorities of the club had abandoned the idea of using ropes to keep the crowd back from treading too closely on the heels of the players. In adopting this policy of trusting to the instincts of fair play and of what is due from spectators to players, a wise decision has been come to. The crowd moved about in unfettered freedom, and though now and then there was some scrambling and pressure at the tees, on the whole it may be said that the crowd behaved excellently under the circumstances.

As between the use of ropes to keep the crowd back, and of leaving the spectators untrammelled, experience seems to show that the last named expedient is the better one.

Discussing the behavior of those who follow an important match the 'Field' has some interesting and pertinent remarks which an American journal says are very applicable to a crowd in the United States. The remarks are as follows:

'One is impelled, indeed, to ask why there should be these demonstrations of inappropriate applause at golf matches, which is quite a recent development in the history of the game, especially among the large crowds of spectators which habitually assemble to see these matches in the neighborhood of London. Observation of those at Mid-Surrey who were prone on the slightest provocation to clap their hands at any particular stroke carried conviction to the mind that they were for the most part either only golfers in name, or that they had but recently become recruits to the game. In this awkward, disconcerting amusement for the players, the ladies join with prodigal effectiveness, but the spectators, who were "real golfers," and knew something of the etiquette of the game, were certainly conspicuous among the crowd in remaining silent and unobtrusive, however the shots on either side were played.'

To remain silent in such circumstances of stress is the only way in which the game can either be fairly or satisfactorily played, and it is certainly to be much regretted that the crowds now flocking to witness good golf matches do not see the unfairness and lack of civility of their behavior. It also seems to be quite useless to appeal to a crowd's sense of what ought to constitute fair play. One of the officials of the Mid-Surrey Club made an admirable little speech on the first green in the second round of the Taylor and Robson match. He appealed to the large crowd to observe four points of behavior, the most important being that there should be no applause until both players had played their strokes. It is needless to say that the very proper request was almost immediately ignored.

A remarkably interesting golf case was recently decided at the Woolwich County Court. A gentleman who was sitting in the ground on Blackheath was struck on the finger by a ball driven by a member of the Blackheath Club. The finger was broken, and he was unable to work for some time. He claimed £32 damages and costs against the player. For the defense it was stated that the player had obeyed all the regulations of the London County Council, and had not been guilty of any negligence. He had a caddy to go in front and warn anybody who was in the way. The caddy, it was stated, warned the gentleman, but he refused to move. A health keeper also warned him, but he still refused to move. After hearing evidence the judge remarked that if persons played golf in places where other people were present, they must take reasonable care. He directed the jury that in this case there had been no negligence, and the jury found for the player with costs.

SERIOUS FOOTBALL ACCIDENT.

OTTAWA YOUTH HAD LEG BROKEN IN GAME AT LANSDOWNE PARK LAST EVENING.

Ottawa, Oct. 28.—In a junior football game at Lansdowne Park this evening, between the two city teams, Walter, a member of ex-Ath. Stroud, a lad about 16 years of age, had his leg broken. Young Stroud was tackled by another boy, and sent to the ground rather heavily. When he attempted to rise it was seen that he was disabled, and examination by a physician revealed the fact that the leg was broken. This is the first serious accident of the season in Ottawa.

PRESIDENT DIAZ.

Mexico City, Oct. 28.—President Diaz says in an open letter to-day regarding his rumored retirement at the close of his present term, in 1910, that the rumors are premature and unfounded. President Diaz says the statement attributed to him was merely an expression of a personal desire. He intimates that he will again be a candidate.

RUSSIAN PARLIAMENT.

Deputies Plunge Immediately Into the Balkan Situation.

INDIGNATION AT POLICE CLOSING MEETING OF SYMPATHY FOR SOUTHERN SLAVS.

St. Petersburg, Oct. 28.—The autumn session of the third Russian Douma was opened this morning and the sitting of the Council of the Empire began this afternoon.

This is the first time a Russian parliament has come to its second session. The first and second Doumas did not survive after one session. This fact has brought out much satisfaction, as well as the hope that the present Douma will be of great service to the country.

In the Tauride Palace the deputies plunged immediately into the Balkan situation.

St. Petersburg, Oct. 28.—At the opening of the fall session of the Douma today great indignation was expressed in the lobbies at the action of the police last night in closing a meeting that was being held to express sympathy with the Southern Slavs. An urgent interpellation on the subject was subscribed to by deputies of all parties and was discussed in the Douma. M. Malakoff, one of the leaders of the Constitutional Democratic party, attacked the government for endeavoring to stifle the voice of Bohemia and Herzegovina by Austria was a national question. The motion for urgency was unanimously adopted.

EMMA GOLDMAN

NOT ALLOWED TO SPEAK IN INDIANAPOLIS.

Indianapolis, Oct. 28.—Emma Goldman was led from the Propylaeum here to-night when she was about to address a large audience that had assem-

bled at the fashionable clubhouse out of curiosity to hear her. Twenty policemen were on hand when she arrived, and as she stepped into the hall she was told that she would not be permitted to speak in this city. She demurred at first, but the officers gathered around, and she was told that she would have to go to the police station if she persisted. She did not make any further resistance, but was led out of the hall without having uttered a word.

A NEW AEROPLANE

HEINFELT'S MACHINE DIFFERS FROM THAT OF THE WRIGHT BROTHERS.

Dayton, O., Oct. 28.—Frank J. Heinfelt has made the successful flight of 500 feet with an aeroplane materially different from that of the Wright Brothers, in that in this machine the single plane principle is used, the Wright machine having double planes. Although hitherto unknown in the aeronautic world, he, in fact, has built three previous machines, paying his expenses out of his slender salary as a stenographer. His motor was given him by a friend who took it out of an old automobile. The flight was terminated by a lack of skill on the part of the manipulator, who brought the machine to the ground too suddenly, breaking one of the wings.

APPRENTICES OF WRIGHT.

LeMans, Oct. 28.—Wilbur Wright began to-day the education of his apprentice pilots. The first was the Count de Lambert, who made three flights of 12, 8 and 15 minutes respectively. The Count manipulated a supplementary lever on these trips, but two other flights he himself conducted in proper fashion. In an interview the Count declared that it was easy to manoeuvre the aeroplane and that he thought he soon would be able to direct it and make voyages in it on his own account.

THE MORSE-CURTIS TRIAL

CURTIS TRIES TO EXONERATE HIMSELF OF ALL BLAME.

New York, Oct. 28.—The apparent determination of Alfred H. Curtis to exonerate himself of all blame in connection with the banking transactions for which he and Charles W. Morse are now undergoing trial in the United States District Court, became more defined to-day, when, under the prompting of his attorney, Curtis produced a letter written by him under date of June 12, 1907, and addressed to Morse, in which he made vigorous protest against the continuance of practices inaugurated by the latter, and which, in Curtis's opinion, constituted a grave menace to the stability of the National Bank of North America.

The incident of the overdraft of \$210,000 by Morse, previously testified to, was made the subject of searching questioning by the witness's own attorney, Mr. Curtis related the coming of F. Augustus Heinze to him with a request for a loan of \$128,000, and his refusal to grant the accommodation. Morse had remonstrated with him, saying, "Unless we let them have the money they must go to the wall." Curtis had stood firm, however, he said, and retorted: "They cannot have a cent of the bank's money; if they must sell, they must fall."

To his amazement, however, he testified, a personal cheque of Chas. W. Morse for \$128,000, drawn to the order of Heinze, came through the next day. The cheque had been paid, although Morse, at the time, the witness said, had a balance to his credit of only \$3,100.

"I at once went to Mr. Morse," the witness said, "and told him that he must protect the bank and at once wipe out this overdraft." Mr. Morse sent out and got two boxes of securities, and turned over their contents to me. I told him that the securities he offered were insufficient, and he offered to give me an order on \$1,000,000 of steamship bonds, which he had on deposit in London. I accepted the offer, and upon being given the order at once cabled to London to have the securities held, subject to the Bank of North America's order."

The witness was then turned over to the attorneys for Morse, for what virtually proved a cross-examination. Despite the efforts of the Morse attorneys to present Curtis in the light of a free agent, the witness persisted in maintaining his contention that he had been but the instrument of another's will and purpose.

"I never made a dollar through any speculation in any of the enterprises upon which the bank was loaning money," said he. "I earned my salary, and that was all. The bank was my life's business, and I worked for it conscientiously and faithfully."

An adjournment was taken, when Mr. Curtis will be further questioned.

PRESENTATION TO THE REV. A. T. LOVE

Quebec, Oct. 28.—On Friday afternoon a meeting of the Ladies' Aid Society of St. Andrew's Church was one of special interest and was largely attended. The meeting was made the occasion for the presentation of new pulpit robes consisting of a Geneva gown and cassock, imported from Edinburgh, and the pastor, the Rev. A. T. Love, B.A.

The president of the Ladies' Aid, Miss Scott, in making the presentation on behalf of the Aid, made the following remarks: "I have much pleasure in offering you, on behalf of the Ladies' Aid, this pulpit gown and cassock. It is a deed which we have long had in contemplation, but, while it occupied our hearts, the Sunday-school building occupied our minds to the exclusion of all else. Now we feel freer to do those things which please us. Since I have had the honor of being president of the Aid, I have had many pleasant tasks to perform, but this, personally, affords me more pleasure than any other. It is fitting that, when cordial relations exist between pastor and people, some proof of it should be given as well as an acknowledgement of our appreciation of the kindly interest you have always taken in our work. We sincerely hope that you will be very many more years at old St. Andrew's paying us, as in the past, friendly visits at our meetings, and that you will always feel that the Ladies' Aid keeps a loving watch on your welfare and will be ever ready to lend a helping hand to any of your projects."

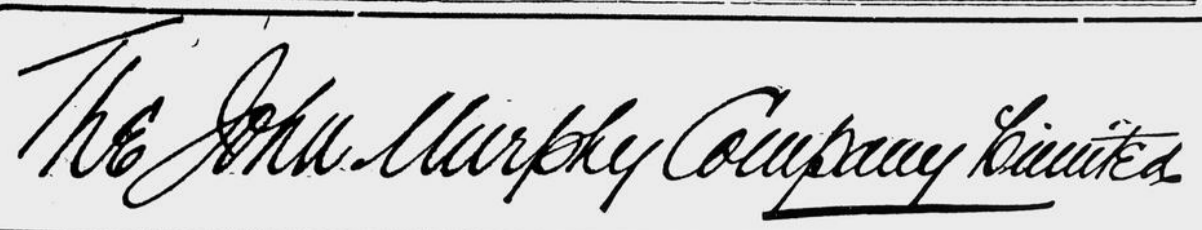

Did the German Emperor draw up the plan of campaign by which the Briton finally conquered the Boer? Hitherto we have given the credit to Lords Roberts and Kitchener, chiefly to Lord Roberts, but now, according to a 'reputable Englishman,' as reported in the London Daily Telegraph, and said to be confirmed by the British Foreign Office, it was the Emperor William who took England under his wing in her most trying hour and saved her from destruction from her enemies in Africa and Europe.

never been of those who considered the German Emperor as lying in wait to take the first opportunity to invade England and despoil the empire.

A curious illustration of borrowed meanings is found in the English comment on the Canadian election. The Manchester Guardian says 'the main trend of Canadian sentiment is along the lines of nationalism.' This is, as we have said, the direction in which Sir Wilfrid Laurier is a leader. If Canada has at all found itself nationally it is chiefly owing to him. But the writer of the sentence quoted little thought that in Sir Wilfrid Laurier's own country his phrase would imply the very reverse of what he meant to say.

Two distinguished Englishmen have been in Canada during the recent general election observing our country, our people and their way of conducting themselves in politics. Lord Northcliffe and Lord Milner are of different types. Both are Imperialists, but while the one may be said to take the business view, the other, so far as his public utterances inform us, takes the political view.

Both are right in regarding Canadians as a people bent on working out their national destiny on lines of practical material endeavor, assuming that their institutions are permanent and that they have every reason to look forward to a happy, peaceful and prosperous future. Lord Northcliffe found that we take our politics quietly compared with the method of conducting elections in England. That public quietness, unruffled by the furious personalities of the partisan press and the circus methods of some Opposition stump orators, should have impressed upon him the underlying fact that there were no burning issues before the country, that the Opposition really had no convincing 'cry' with which to arouse popular enthusiasm.

As regards Lord Milner's views on imperial and colonial relations, they are listened to with the respect which the opinions of so eminent a man deserve. While it is believed that we should look forward to, and prepare for, future contingencies, it is felt that the question of readjusting our relations with the Mother Country and other parts of the Empire, is not yet ripe and that, when it is, we will be ready to perform our part with becoming gravity and rise responsive to the larger patriotism of a united British Empire.

THE AFTERMATH.

We are now having the usual aftermath of an election in the form of strong assertions that this and that election is going to be contested. It is in most cases nothing but a brutum fulmen, a noise and no more. This is unfortunately not always because there is no reason for contesting the election, nor because the evidence is not forthcoming. It is practically nothing but a saw-off. Robinson's election is going to be contested, says a party authority on one side; whiskey flowed like water. Oh, no, it isn't, says an equal authority on the other. Jones stood addressing the crowd on Slipshod square, in front of a very open bar-room, where there was nothing to pay. And respectable, busy, earnest-minded citizens are besought to go to any necessary trouble to record their votes against the votes of people who can be thus influenced. The most essential part of an election law, as far as purity of elections is concerned, the part we have pleaded for most earnestly, is not even yet in the law, namely, some prosecuting authority who will be responsible for electoral purity, and who will act on his own initiative. But even sup-

posing there to be such a public officer appointed by government, it is hard to imagine him acting with absolute impartiality. So degraded have our electoral methods become that we do not believe they will be reformed until good citizens set themselves apart to the work, as was done years ago in Montreal by the Young Men's Electoral League, and make it their one object impartially to bring to justice those in either party who commit the crime which should rank as the highest treason, that of corrupting or cheating the electorate. It seems the worst of pities that this league has ceased effectively to exist, as there would appear, if rumor speaks truly, to be as much need of it as ever.

Meantime it is for the government, well entrenched in power, to put a stop to the iniquities which its members have too much belittled, and which they are accused of having winked at. Let it not be said, as has been more than hinted at in New York and London, that their return is to be accounted as a renewal of their license to wink at graft. For some reason the government did not, during the last parliament, see its way clear to bring in more than half-measures for electoral and civil service reform. The election law did not require full publicity of both sides of the expenses account. The civil service law clearly confined its reforms to the indoor service at Ottawa. Let Laurier finish his work. It remains to him to bequeath to history a clean country. Let the party, once called the Reform party, do real reform. The country has not realized that any important change has yet been accomplished, and looks for whole-hearted measures, and for a ruthless cleansing of the departments of the old heaven wherever it can be found. If this is not done, it will not be because the country does not demand it. It will not be because the government is not strong enough to carry it out. At least a government that fears that its continuance depends on being over gentle with hoodlums had better commit hari-kari than continue to live under such a consciousness and such a black imputation. A party made up of hangers-on, who count themselves as having a right to the positions at its disposal, is a subject for contempt, and the support it retains in this way is precarious and false. The construction of the civil service commission of last session was such as showed a fearless determination to know the worst, and when that commission proved unaccountably abortive, another was appointed, that has not seemed to fail in zeal or impartiality. Very different were the committees of parliament before which irregularities came. The acquittal of any one by a committee in which the majority fights and votes against frank efforts at discovery is entirely unconvincing to the public, and leaves an ill odor of disinfectants in everybody's nostrils. What the country wants, and sadly needs, is a zealous cleansing of its public life. As an English paper tells us, we shall find that national greatness does not depend alone or chiefly on material prosperity.

A CURIOSITY.

A cable from London informs us that the Bradford Chamber of Commerce is the latest to endorse the resolution of the Leeds Chamber of Commerce which protested against the false statements contained in an article published in 'Industrial Canada,' the organ of the Canadian Manufacturers' Association, which averred that there was 'death' in much of the textile manufactures of Yorkshire received in this country. The only dissentient to the Bradford resolution was a member who contended that 'by keeping the matter before the public the chamber would only be assisting the cause of those Canadians who are seeking that higher duties be put on 'British goods.' Mr. Frank Whiteley, who was, by the way, Mayor of Mafeking during the famous siege of 1899-1900, and was formerly in the ivory and ostrich feather trade, was the gentleman who took exception to the resolution on the above ground. His concern, was wasted. The Canadians who are seeking for higher duties will seek for them still whatever the Yorkshire and other British chambers of commerce may do or say. For instance, in the September number of 'Industrial Canada,' the journal which first published the silly statement about there being 'Death in Shoddy,' and which had grudgingly to retract it, there is a letter insisting that some shoddy really is dangerous to health, and practically returned to the attack, in spite of the rebuke it has received from, among others, the Canadian 'Journal of Textiles,' the organ of the trade in Canada. In another part of 'Industrial Canada,' we find the statement that the 'government at Ottawa has sacrificed Canadian industries on 'the altar of its imperialism,' meaning the preference the government has given to British goods, and Mr. Whiteley may depend upon it that if the Conservatives had been returned to power, with Mr.

Foster or another as Minister of Finance, it would not have been long before the duties against British goods would have been raised and the preference at any rate destroyed. That would have been done by those who call themselves imperial preferentialists, or some such title, and whose idols are Mr. Chamberlain and men of similar imperial and economic faith. It would be interesting to hear what Lord Milner has to say about these curious things.

OUR COMING EXHIBITION.

The tuberculosis exhibition which is to be held in Montreal early next month, is one of many which have been held all over the North American continent. These exhibitions were designed by the National Association for the Study and Prevention of Tuberculosis of the United States, which numbers among its directors some of the best-known men in that country—famous for scholarship, science, industry, and philanthropy. It is well known that the ravages of tuberculosis are most widespread among the poorer and more ignorant classes of the population. In order to reach these people, in addition to printed information especially prepared for the purpose, the association initiated a series of exhibitions which show in a graphic and simple way by charts, photographs, models and apparatus of all sorts the great prevalence of tuberculosis, the causes and conditions which bring it about, and the approved methods of prevention and treatment. That is what the Montreal exhibition is designed to do, and it is hoped in this way to impress upon all classes of the people the fact that the deaths from this disease—one hundred and fifty thousand every year in the United States, and perhaps between eleven and twelve thousand in Canada—are needless, that the misery and loss resulting can be avoided, and that with organized action and the observance of proper hygiene, consumption can be practically stamped out. In the United States the attendance at these exhibitions has already been a half million or so, and everybody in Montreal should be induced to attend the exhibition here. There is no more fitting mission for the Church than to join in such a crusade as this. The Church's Master ever coupled physical and mental with spiritual healing, and the holding of the exhibition is a good occasion for advice that will promote the enlightenment of the many.

In this connection we are glad to state that the government of Sir Lomer Gouin is about to join in the work of education, by publishing in a popular way the vital things our medical representatives saw at the tuberculosis exhibition at Washington. These should be widely distributed in both languages, and will doubtless be but the beginning of the provincial government's participation in this work. One thing may be said in advance about what the people will be taught at the exhibition. It is the wholesale danger of spitting in public places. At Saranac Lake leaflets are printed and distributed as follows:

SPITTING FORBIDDEN.

Section 130 of the Sanitary Code provides that: 'Spitting upon the sidewalk or crosswalk of any public street, avenue, park, public square or place, in the village of Saranac Lake, or upon the floor of any hall in any tenement house which is used in common by the tenants thereof, or upon the floor of any hall or office in any hotel or lodging house which is used in common by the guests thereof, or upon the floor of any theatre, schoolhouse, church, store, factory, or of any building which is used in common by the public, or upon the floor of any railroad car or other public conveyance, or upon the floor of any depot or station, or upon the station platform of any railroad or other common carrier, is hereby forbidden.'

PENALTY.

Section three ninety-seven of the penal code, as amended by the laws of 1905, provides that: 'A person who wilfully violates or refuses or omits to comply with any lawful order or regulation prescribed by any local board of health or any local health officer is guilty of a misdemeanor.' Note.—The offending party may be arrested and fined or imprisoned or both at the discretion of the Court.

A similar by-law and penalty are urgent necessary in this city where the public ways are often vile with spitting as well as menacing to health. In the street cars it is true there is the absurd notice staring everybody in the face: 'Passengers are forbidden to spit on the floor of the car,' or some such instruction, nothing being said about spitting upon any other part of the car. But if the legend were worded differently, it would make no difference, for the uncleanly would not regard it any more than they do now, and the conductors would be less than indifferent about enforcing it. Yet it is an unquestionable fact that death lurks in this practice, as tuberculosis may be communicated to others by means of dry sputum.

DROWNED AT KENORA.

Winnipeg, Oct. 29.—The body of W. R. Colgate, a former leading insurance and financial agent here, has been found in the lake at Kenora. He was returning to the West from England.

A BURGLARY CHARGE.

Alexandre Dufresne, accused of breaking into the carpentering shop of Cleophas Dubrule, 27 St. Alexander street, last night, was arraigned before Judge Bazin this morning. He pleaded not guilty and was remanded until Nov. 4.

EMIL SAUER

The lace-maker; the weaver of tapestries of Little Trianon gardens where lovers walk and talk amid delicious silences and rivals fight without fury; the artificer of sweet confections which melt in the imagination and leave no sense of satiety; a keen lean face with kindly searching eyes; fingers tipped with pearl and quicksilver—Emil Sauer. He came and he conquered. Sauer, if we pronounce his name 'sour' in our English tongue—which has curious consonant and vowel qualities all its own—is quite different in himself and in his playing to the associations that word calls up of a wry mouth and a protesting palette. He is an airy, deft and delicate player, whose playing has a serenity and composure most agreeable to nerves racked in a world of noise. Even a stockbroker on the wrong side of the market could find comfort in his playing.

Emil Sauer is what in a most respectful and affectionate way may be called an 'old boy' on the concert platform. He has indeed been a concert pianist since 1882, or for twenty-six years. In all that time, however, he has only had one previous visit to this continent, and the audience at the Lyric Hall last evening was indeed in fortunate case in having the opportunity to see and hear a man who is one of the supreme artists of the piano to-day. Advance agents and many writers have a way, of course, of describing every new arrival as the greatest ever seen and heard—as a circus (on the bill boards) is always the biggest and best—and the judicious have learned to take all this with a large admixture of salt. But in all earnestness and impartiality, while recognizing the high and varied qualities of Paderewski, De Pachmann, Hoffmann, Rosenthal and others, there is an artistry about the playing and personality of Sauer over and above the necessary technique, which gives him a place in the world of art by himself alone.

Sauer was a protege of Anton Rubenstein and studied with Rubenstein's brother Nicholas, in Moscow. Afterwards, in 1881, he took lessons from Liszt. But Liszt at that time was seventy-four, and very erratic, and the pupil gained little from the master. Their temperaments at any time would have been opposing, for Liszt was all power and passion, while Sauer's chief charms are sweetness and light. The programme, already published, was by no means an amazing one, we have enjoyed the numbers and otherwise before, with the exception, perhaps, of Sauer's own compositions, more than once or twice; but it was a very respectable programme, and it was not so much what Sauer did as how he did it that mattered to the audience. And the doing, as we have said, was unique and supreme. The audience was a fair-sized one, and would have been larger but for the disagreeable weather. Mr. J. W. Shaw deserves much credit for bringing the master here, as to do so he had to guarantee a very large fee. But it was worth the money from every point of view.

TYPHOID ON THE TRANSCONTINENTAL.

A HUNDRED PATIENTS IN KENORA HOSPITAL.

Toronto, Oct. 29.—Dr. R. W. Bell, inspector of the Provincial Board of Health, who has returned from inspecting camps of transcontinental railway, confirms the report of prevalence of typhoid fever among the workmen. Many deaths have resulted from the outbreak, and there are 100 patients in the Kenora Hospital. About nine camp hospitals are filled with sufferers, and many men have been taken to Winnipeg for treatment. The season, however, is improving, and with colder weather the number of cases is diminishing.

A 'BLACK HAND' LETTER?

MONEY DEMANDED FROM ITALIAN BANKER IN MONTREAL.

Alberti Dini, the St. Catherine street banker and labor agent, believes he has come under the notice of the 'Black Hand.' Yesterday he received a letter, written in red ink, and bearing the imprint of the black cross. In it he was instructed to be at the corner of Windsor and St. Antoine streets with \$200 at eight o'clock in the evening. He was on hand according to instructions, but did not take the amount demanded. Instead he took a detective with him. The latter remained in the background as Dini approached the corner indicated in the letter, but only at a distance sufficient to be quickly on the spot in case of anything happening. Mr. Dini remained on the corner several minutes, but as no one accosted him he returned to his home. He has an idea that he knows where the letter came from.

MAY BE MURDER.

RAILWAY TRACK TRAGEDY ROUSED SUSPICIONS AT INQUEST.

The inquest in the case of Joseph Ouimet, a nephew of Mr. Rodias Ouimet, of the Night Refuge, who was found dead beside the railway track at Nominique, nine days ago, with his head battered and pockets rifled, was held at that place yesterday. Dr. Boucher's evidence showed that death had been caused by blows on the head, and the jury returned a verdict in accordance with the facts, adding a rider that three suspicious characters be followed up. Mr. Ouimet has written to the Attorney-General's Department, asking that the case be placed in the hands of the provincial detectives.

LAYMEN'S MISSIONARY CONFERENCE

OPENED IN LONDON.

London, Oct. 26.—The Laymen's Missionary Conference, National and International, opened in the Royal Albert Hall this afternoon. The members already present, 150 in all, are expected to reach the session, and 1500 more to-morrow. Mr. O. J. G. Dent, introduced Mr. J. H. White's address on the subject of the conference. The conference will close on Oct. 31.

**SOCIALIST SUSPENDED.
 Mr. Grayson Creates Another
 Scene in British House of
 Commons.**

**DEFIES THE CHAIRMAN AND
 CALLS PARLIAMENT 'A HOUSE
 OF MURDERERS.'**

Two scenes on two successive days were created by Mr. Victor Grayson, Socialist, M.P., for Colne Valley, in the British House of Commons. The first, in which he described the Labor members as traitors to their class, has already been reported in the Canadian press. This is how the Glasgow 'Evening News' records the second, which occurred on Friday, October 16:

During the discussion on the Licensing Bill in Committee of the House of Commons to-day, Mr. Grayson entered the Chamber about one o'clock and took his usual seat at the end of the back Labor bench, and in close proximity to the sergeant-at-arms. Immediately after the announcement of the figures in a division on the Licensing Bill, Mr. Grayson rose and said he wished to call attention to the fact that there were thousands of people starving in the streets while the House was trifling with the bill. (Cries of 'Order'.)

Mr. Grayson—Personally, I refuse to give order. I am only one in this House, but I defy it to silence me.
 The Chairman of Committees (Mr. Emmott)—Order, order.
 Mr. Grayson—I will not give order. I have a large mandate behind me, sir, and I positively refuse to allow this House to proceed a moment longer while I am in it. (Loud cries of 'Order, order'.)

Mr. Grayson, bawling at the top of his voice, went on to accuse the House of callous indifference to the sufferings of the unemployed, whereupon there was some laughter.
 Mr. Grayson—I feel it is not a laughing matter. (Renewed cries of 'Order'.) I absolutely refuse to give order. I refuse to wait another moment.

Mr. Emmott, at last succeeding in making himself heard, explained that under the rules of the House the committee could only deal with what the House instructed it to deal. He should raise the matter in the House and not in committee.
 Mr. Grayson again essayed to speak, whereupon Mr. Emmott asked, 'Does the honorable member refuse to obey the chair?'

Mr. Grayson (emphatically)—No, sir, I feel this matter so deeply that I must refuse to obey the rules of the House. (Loud uproar.)
 Mr. Emmott—I must ask the honorable member to resume his seat.
 Mr. Grayson—I know there's force enough in the machinery of this House to remove me, but I refuse to give order, feeling that every section of the House is pledged to the Licensing Bill. (Renewed uproar.)

Mr. Emmott—The honorable member has refused to obey my instructions to sit down, and I now order him to withdraw from the House. (Loud cheers.)
 Mr. Grayson—I refuse to withdraw from the House voluntarily until the House has shown some inclination to attend to this urgent question.
 Mr. Emmott—If the honorable member refuses to obey my order, I must name him.

Mr. Grayson—I cannot help that, sir; I refuse to allow the business of the House to go on while people are starving in the streets.
 Mr. Emmott—Then, Mr. Victor Grayson, I name you for disobeying the order of the Chair.
 Mr. Grayson—Sir, you cannot shame me. (Loud laughter.) It is all very well for members to laugh. I will obstruct the procedure of this House as long as it refuses to attend to this question. (Considerable uproar.)

The sitting was then suspended, and the speaker sent for.
 In the meantime Mr. Grayson made repeated attempts to address the members, but was shouted down. Above the din he was heard to bawl—'I wish the unemployed were here to see you.' (Cries of 'Order, order'.) 'Yes, you will get disorder.' (Cries of 'Sit down'.) 'I refuse to sit down.'

On the arrival of the Speaker, Mr. Emmott reported what had occurred, and the Prime Minister, rising, amid dead silence, said:—'I beg to move that Mr. Grayson be suspended from the service of this House.'

The motion was immediately carried, only one or two Socialist members opposing, whereupon Mr. Grayson cried—'What does the Labor party say?'
 The Speaker—I must inform the honorable member that he has been suspended from the service of the House, and must ask him to leave the House.
 Mr. Grayson—Well, sir, I leave the House, as I said yesterday, with pleasure. I feel that no man—(loud cries of 'Order')—can sit in this House another moment. (Renewed cries of 'Order'.)

The Speaker—The honorable member is not entitled to address the House after he has been suspended.
 Mr. Grayson thereupon picked up his hat and made his way to the door, remarking—'I leave the House feeling that I gain dignity by doing so, and I hope other honorable members will leave it too.' (Loud laughter.) It is a house of murderers.' (Uproar.)

The honorable member then left the Chamber, and the committee resumed.

THE FAMINE IN INDIA
 St. John, N.B., Oct. 28.—At a meeting of the Baptist Foreign Mission board of the Maritime Provinces to-day, reports from India showed that famine is still pressing heavily, and unless plentiful rain comes soon the outlook will be desperate.

**SENTIMENT IN POLITICS
 OF INTEREST TO WOMEN.**

The charge that woman, if given the privilege of voting, would be governed by feeling and sentiment instead of by reason, is accepted without question by a writer in the 'Westminster Review,' who, however, takes the ground that this need be no barrier to her enfranchisement, as, in the last analysis, the same holds good in regard to men. He says, 'Even the doughtiest opponent of votes for women hesitates to deny that a vote must come when women shall be admitted to a share in political rights, but in his opinion the time has not yet come. He frequently draws a gloomy picture of woman's lack of civic qualities, her limited mental vision. The implication seems to be that the great majority of men furnish a worthy contrast. We think of a nation of thoughtful and earnest men, who wrestle in a philosophical spirit with political principles, store their minds with statistics and facts (if they can get them), and lay aside all private interests and prejudices; . . . above all, we think of their opinions as being their own, and not inherited from their fathers or borrowed from their favorite newspaper. Were this so, the case against the political enfranchisement of women would be conclusive.' (would it?) . . . but if it can be shown that in general a man's education has little effect on his opinions, and that his qualities as a citizen depend much more on his heart than on his head, we shall have less confidence in excluding women from all share in public life.'

'If feminism means the introduction into politics of wholly new forces, that would substitute feeling for conviction, enthusiasm for argument, we need not even this revolution, no other state of affairs has ever existed. We may make show of logic, entrench ourselves deep in statistics and jurisprudence, like Mr. Grainger, we may do the hard and glittering panoply of "facts," but reason plays a small part in shaping our conduct, either as individuals or as members of a State.'

This seems an exaggerated statement, but certainly if the 'male voter' would candidly analyze his own motives, he would often find that sentiment, feeling, plays a larger part in his action as an elector than he fancies, and, 'by the same token,' women who take any interest in politics at all are given to reason more than they get credit for. Besides, as the writer of the 'Westminster Review' article would agree, sentiment of the right kind is not a bad element in politics, and as a great show of reason can be advanced to support either side of almost any position, it seems that sentiment must have a good deal to do in the decision, after all. Whether they are recognized or not, there exist certain, subtle, sympathies or antipathies which account for the particular form a public question assumes to a particular person.

Will not even the 'doughtiest opponent' agree that woman's antipathies, at least, may always be trusted to be on the side opposed to what is against social welfare and the good of humanity?

KEEP OUT IN THE AIR

One cannot bottle up air and sunshine for future use, but one can store up vigor and strength that will help one to face the long winter with cheerfulness. The woman is wise who in these latest fine days of autumn gets out of the house to spend all the time she can in the open air. What though the breeze is to be re-arranged and set in order for winter, the pickles and jellies to be made, and the children's winter clothing to be got ready! The 'melancholy days' are surely coming when Nature without offers few attractions and one can make up on arrears within. So, while the weather tempts out of doors, consider it no dereliction of duty to let some things go, and yield to the temptation to be out in the air.

One of the best forms of exercise is fortunately the most open to everybody. Many have not time to 'go in for' golf or tennis enough to become sufficiently expert to derive pleasure from the game, and we haven't all got automobiles or saddle horses, but we can all walk and learn to take a great deal of pleasure in it. It is an excellent accomplishment to be a good walker, not merely to be able to cover so many miles, but to do so in a way to obtain most benefit from it. Nobody ever hears a really good walker complain of aches and pains.

The first details to be considered by the walker relate to her clothing. It should be comfortable, not too tight nor too loose, too long nor too short, just 'comfortable' from hat to shoes. The walking-suit should be plain, but with a touch of 'smartness' about it. Dowdy clothes take lots of the pleasure out of a walk. Do not make radical changes in dress under the impression that low-heeled or flat shoes and no corset are 'the thing' when walking. If you are in the habits of wearing corsets and shoes with medium heels you will find it more tiring to change than to wear what your muscles have become accustomed to, but the corset should be perfectly easy at the waist line. Leave your Directorate corset—if you have adopted that 'instrument'—and your high Gibson collar off, when you go walking for exercise. There is nothing that can spoil a walker quicker than an 'uneasy' collar, unless it be uncomfortable shoes. Hold your chin well up—you can accustom the muscles of the neck to do this without the aid of a high collar or military stock. Your chin is at about the right angle when your gaze is on a level with your eyes, and you are looking neither up nor down. Train yourself to breathe with your whole lungs, not only with the tops of them, as you walk. The ten-

tenity of the novice in deep breathing is to work too hard at it, and this over-takes the heart and is exhausting. Accustom yourself to it gradually, and, provided the clothing gives the necessary freedom, breathing from the bottom of the lungs will become a habit, and a very beneficial one.

Banish all thoughts of work to be done, engagements to be met, and everything that suggests worry or anxiety. It is a good plan to choose a new route frequently, and cultivate one's powers of observation. Taking an interest in things helps to keep one from getting into a constrained, flurried manner of walking, until one comes to love walking for its own sake. The rate of speed matters less than freedom of carriage and cheerfulness of mind. Some accomplished walkers carry a tightly-rolled umbrella, on the same principle that a man carries a walking-stick. Acquire the habit of a daily walk now, while the weather is neither too warm nor too cold, and you will not find it difficult to keep it up later, when a brisk walk taking you out of doors for an hour each day will keep you from losing vitality in the heated house.

A CRIMEAN NURSE

An Irish nun who died a few days ago, had been one of the nurses assisting Florence Nightingale in the Crimea. Miss Nightingale had considerable difficulty in persuading her generation that women must be trained before they could be competent nurses. It used to be thought, before she taught the contrary, that nursing came to women by nature. Miss Nightingale insisted upon the necessity of training—a foundation of scientific theory and a super-structure of practice overlooked by a teacher—before the womanly instincts of compassion and unselfish helpfulness could be sure of accomplishing any useful service. It was because she was so clear on this point that she objected to having sent out to her at the Crimea any nurses not chosen by herself. The firm and fearless will that made Miss Nightingale able to be of use in a great national crisis was called into action when the first party of volunteer nurses arrived. Her stimulation that she should choose her own helpers was broken by the government in despatching to her this party of untrained helpers recruited from various sources, and Miss Nightingale instantly resigned her position in the War Office. The whole story appears in the 'Life' of Mr. Sidney Herbert (Lord Herbert of Lea), and is instructive in showing the strong and determined qualities that really characterized that great woman. She was 'given in to' completely by the government, and only employed such of the volunteers as she thought fitted for nursing, or as she could make useful in other ways. Mother Mary Aloysius, who has died in an Irish convent at the age of ninety-four, was employed at first as store-keeper, but later was promoted to tend the sick.

**THE CLINGING GOWN
 AND GRACEFULNESS**

How a woman wears her clothes has almost as much to do with her appearance as being well dressed or the reverse, as the quality of the clothes themselves. This is particularly true of the long clinging skirt, which adds to the grace and dignity of the woman who wears it well, but which accentuates the self-consciousness of others. Some women are naturally graceful. Whatever they put on, from the walking costume with its short skirt, to the clinging Directorate gown, seems to suit them exactly, because they wear it with grace and ease, and with an absence of self-consciousness. They know instinctively how to manage the long skirt that is, they leave it to hang as it was built to do, its trailing length resting on the floor, except when it is necessary to lift it a little in front when going up or down stairs, or for some such reason. It goes without saying that the trailing gown should only be worn where it can be allowed to hang in the long lines on which it is constructed, never on the street or any place where it must be held up to avoid being soiled.

The woman who is not so gifted by nature can acquire a certain grace by training. Let her observe her own defects closely and mercilessly in a long mirror, especially at the present time in connection with the wearing of the long skirt. And, which is even more helpful, observe the graceful woman's way of letting the skirt arrange itself as she moves about or stands, how she raises it a trifle when a case of movement demands it, catching a fold in front between her fingers mid-way between her waist and knee so that there is little bending of the elbow, using one hand or both, as required; and, when it is necessary to lift the back, gathering it in the right hand with enough slack to prevent drawing across the back, bringing it round at arm's length to the right, and catching up a fold of the front with the left hand to ease the pulling on the plain side.

By all means let all practicing with the long skirt be done in the privacy of one's own room. Have we not all seen women furtively eyeing their own trains and folds, and giving them experimental little jerks and thrusts? It suggests that the wearer is possessed by her clothes, instead of possessing them. Absence of self-consciousness is one of the first elements of gracefulness.

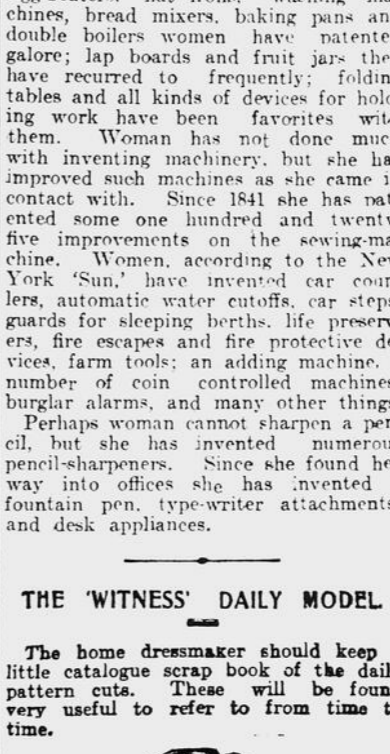
WOMEN AS INVENTORS

A novel and interesting exhibition is being arranged for a bazaar in New York. This is an exhibition of women's inventions in domestic labor saving devices and other departments. Among the domestic inventions are a carpet-sweeper, pressing and ironing boards for waist and sleeves, a dish-washing machine used in hotels, a safety delivery box for bread, vegetables, fruit, etc., which locks automatically, and keeps the food clean as well as safe, etc. A blind woman has invented a broom holder, merely a little iron ring which screws into the wall and clasps securely around the broom handle, but useful and soothing, since a broom standing against the wall is always falling down and getting under foot, and destroys its own shape by standing on its end. A sanitary garbage receptacle for use in apartment houses is another woman's invention.

The inventions are classified generally as domestic labor-saving appliances, domestic furnishings, dress, medical, for children, educational and miscellaneous, including machinery, utensils, etc. The total number runs into the thousands. Egg-beaters, flat irons, washing machines, bread mixers, baking pans and double boilers women have patented galore; lap boards and fruit jars they have recurred to frequently; folding tables and all kinds of devices for holding work have been favorites with them. Woman has not done much with inventing machinery, but she has improved such machines as she came in contact with. Since 1841 she has patented some one hundred and twenty-five improvements on the sewing-machine. Women, according to the New York 'Sun,' have invented car compasses, automatic water cutoffs, car steps, guards for sleeping berths, life preservers, fire escapes and fire protective devices, farm tools; an adding machine, a number of coin controlled machines, burglar alarms, and many other things. Perhaps woman cannot sharpen a pencil, but she has invented numerous pencil-sharpeners. Since she found her way into offices she has invented a fountain pen, type-writer attachments, and desk appliances.

FROM THE CAPITAL.

Major-Gen. Lake to Shortly Return to the Imperial Service—Mining Development in British Columbia

THE HON. SYDNEY FISHER TO ATTEND AGRICULTURAL CONVENTION AT ROME.

Ottawa, Oct. 29.—It is expected that Major-General Lake, inspector-general of the Canadian Militia, will very shortly return to the Imperial Service. As chief of the general staff and as inspector-general, he has performed a very valuable part in working out the new system of military administration which is now in force in this country and his removal will be a great loss to Canada.

Until Sir Frederick Borden's return to the Capital it is uncertain as to who his successor will be in the inspector-generalship at Ottawa, or, indeed, whether the office will be filled at all.

In the few months in which General Lake has held the appointment he has visited every part of the Dominion, and before leaving will put the results of his observations into the form of a report to the Militia Council.

Mr. Brock, acting director of the Geological Survey of Canada, returned last night from a three-month visit to the province of British Columbia. During the late summer he visited the various mining camps of the province in company with the Hon. Wm. Templeman, Minister of Mines, and afterwards accompanied a party of British mining engineers in their inspection of the mineral resources and development of the Pacific Coast Province.

There has been good progress in the various branches of the mining industry despite the low prices which now prevail for silver, lead, and other metals. One of the pleasant things of all is the large number of new finds which have been made of rich mineral deposits in the Slokan and other camps.

The Hon. Sydney Fisher, Minister of Agriculture, leaves in a few days for Rome, where he is to represent Canada at the convention which has been called by the King of Italy for the promotion of scientific agriculture and of agricultural research.

NEW LIFE INSURANCE FOUNDED IN THE EAST, Two Canadian Companies Doing Business in that Far Away Land—Those Interested

There has until lately been but one life insurance company doing business in the Far East and that is the China Mutual Life in Shanghai. Recently, however, a new company has been founded with headquarters at Singapore.

The interesting feature to Canadians in this connection is that these companies have been founded and managed by Canadians and they are in a sense offshoots of Canadian life insurance.

The China Mutual Life was founded by Mr. J. A. Wattle, of Valleyfield, P.Q., who went to China about ten years ago in the capacity of cashier at Shanghai of the Sun Life Insurance Company of Canada.

The English press is serious, worthy, instructive, aiming at completeness in its articles as in its news. Americans make their newspapers hasty, self-centred, highly condensed in their articles, but with all possible display in their news.

The complaint is almost universal that American Sunday newspapers are too bulky. When they seriously set about reducing their drooping proportions, they cannot make a better beginning than by cutting away the so-called comic supplements, which are really more tragic than comic, and more barbaric than either.

THE SUNDAY COMIC

(New York Evening Post.)

Clownish, vulgar, idiotic the colored 'comics' of American Sunday newspapers undeniably are. It is a reproach to our civilization that they should have been allowed to swarm over the land. They are a glory all our own. No other journalism has anything like them. They leave visiting foreigners absolutely astounded and aghast. For the reproach inevitably runs beyond the individual editor or journal, and is an impeachment of the taste and even common sense of the whole country.

But is there any moral quality in the unutterably silly? Synopsis of Canadian Northwest Land Reguatio.

ANY person who is the sole head of a family, or any male over 18 years old, may homestead a quarter-section (160 acres, more or less) of available Dominion land in Manitoba, Saskatchewan or Alberta. The applicant must appear in person at the Dominion Lands Agency or Sub-Agency for the district. Entry by proxy may be made at any agency, on certain conditions, by father, mother, son, daughter, brother or sister or interceding homesteader.

DUTIES—Six months' residence upon and cultivation of the land in each of three years. A homesteader may live within nine miles of his homestead on a farm of at least 80 acres solely owned and occupied by him, or by his father, mother, son, daughter, brother or sister.

In certain districts a homesteader in good standing may pre-empt a quarter section alongside his homestead. Price \$5.00 per acre. Duties.—Must reside six months in each of six years from date of homesteaded entry (including the time required to earn homesteaded patent), and cultivate fifty acres extra.

A homesteader who has exhausted his homestead right and cannot obtain a pre-emption may take a purchased homestead in certain districts. Price \$1.00 per acre. Purchased homesteads may be acquired on any available lands on either odd or even numbered Sections South of township 45, East of the Calgary and Edmonton Railway and West line of range 28, and West of the third Meridian and the Sault Railway line. Duties.—Must reside six months in each of three years, cultivate fifty acres and erect a house worth \$500.

SYNOPSIS OF CANADIAN NORTH-WEST MINING REGULATIONS.
COAL.—Coal mining rights may be leased for twenty-one years at an annual rental of \$1.00 an acre. Not more than 2,500 acres can be leased to one applicant. Royalty, five cents per ton.

QUARTZ—A person eighteen years of age and over having made a discovery may locate a claim 1,500 feet by 1,500 feet. Fee, \$5.00. At least \$100 must be expended on the claim each year, or paid to the Mining Recorder. When \$500 has been expended or paid, and other requirements complied with, the claim may be purchased at \$1.00 an acre.

PLACER MINING CLAIMS generally, 100 feet square. Entry fee, \$5.00.
DREDGING—Two leases of five miles each of a river may be issued to one applicant for a term of 20 years. Rental, \$10 a mile per annum. Royalty, 2% percent after the output exceeds \$10,000.

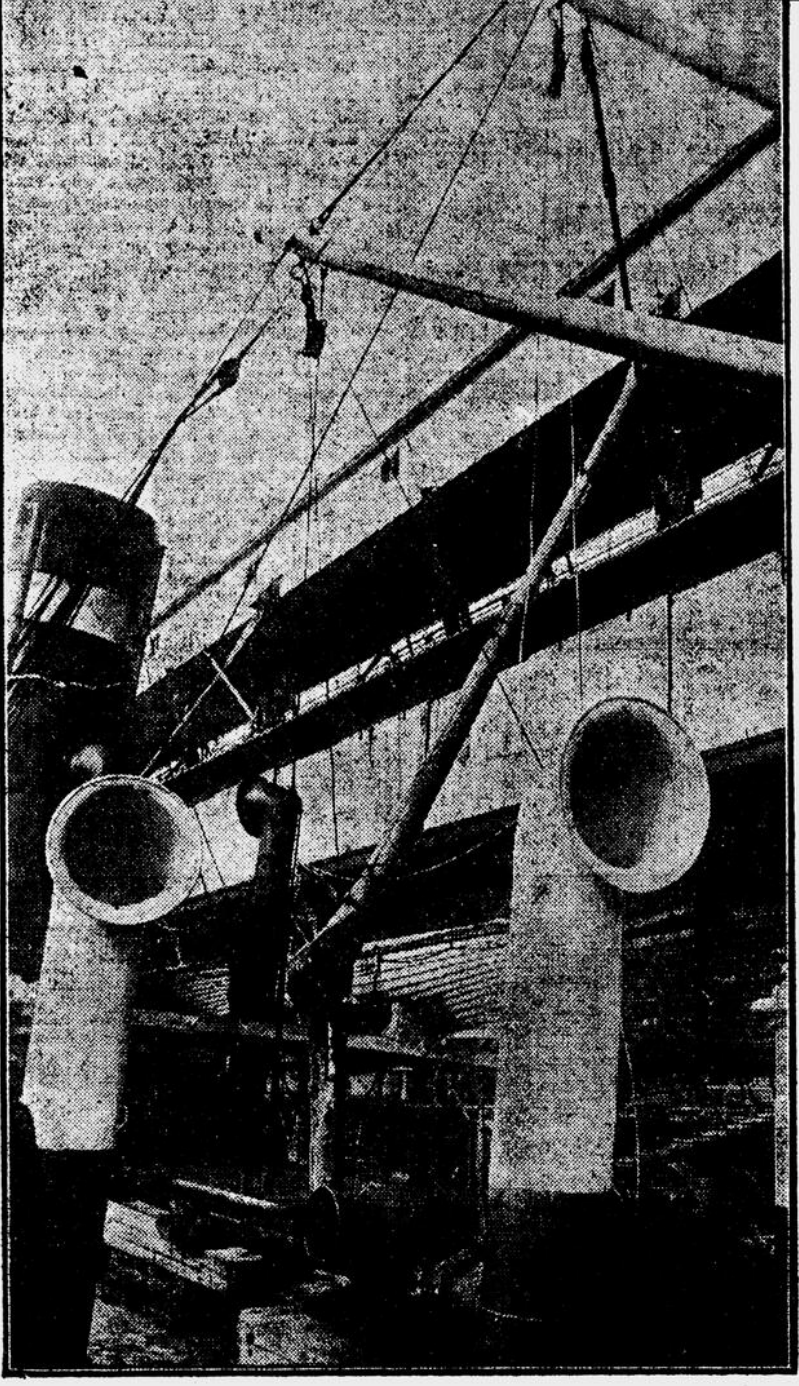

McMenamin, president, stated that out of 115 members 27 had purchased nothing, and the average purchase per week was only \$1.50. This and the general depression in trade, besides a burglary that took place at the society's store last August, was given as the principal cause of the deficit of \$238.87 for the last quarter. In the secretary's report it was shown that since June 30 the membership had increased from 84 members to 115, the sales from \$1,800.46 to \$3,700.13, and the amount of goods purchased from \$2,279 to \$4,375. After the secretary had read the minutes of the last meeting the president said that the auditors had not yet signed the sheet for the last quarter. Mr. J. H. Malone, a member of the society, one of the auditors, said that the reason why he did not sign the sheet was that the city's tax had been entered, when it was not due until next May, as it was payable yearly. A quarter of last year's bill had been entered up in the books. He thought that this should be left over until the bill came in in May next. After much discussion on the part of the members, the auditor's suggestion was agreed to. The president complained of the backsliding of some of the old members, who were making their purchases elsewhere instead of patronizing their own store. 'We have enough members in the society,' he said, 'and we could declare a dividend every quarter, but the only way to do this is for the members to buy more goods.' The members of the committee also gave their views on the question, and it was decided that every one should work together and try and place the society on a good footing. The balloting for a vice-president and a committee for this quarter was then taken up and the lot finally fell on Mr. J. A. Newton for vice-president, and Messrs. A. Poole, J. W. Exley and R. Fields as committee-men. It was decided at last night's meeting to form a Women's Guild, to work in the interests of the society, to try and create more enthusiasm among the members.

ENTIRE CREW PERISHED.
Foundering of the Great Eastern Railway Steamer 'Yarmouth' in the North Sea Confirmed.

London, Oct. 29.—Wreckage picked up in the North Sea confirms the fears that the steamer 'Yarmouth' foundered two days ago while crossing from the Hook of Holland to Harwich. The 'Yarmouth' was a Channel freighter belonging to the Great Eastern Railway Company. She carried a crew of 23 men, and it is believed that they all perished.

NATIONAL COUNCIL OF WOMEN.
ANNUAL MEETING DISCUSSES MATTERS OF PUBLIC HEALTH.

His Excellency the Governor-General presided at last evening's session of the meeting of the National Council of Women of Canada, being held this week in Ottawa. The discussions centred around public health, with especial reference to the prevention of tuberculosis. Among the speakers on the subject were Dr. Brice, Mrs. Adam Shortt, of Kingston, and Mrs. John Cox, of Montreal. In his address His Excellency paid a particular tribute to Mrs. Cox. With enough women like her, the Council, he thought, would succeed in securing the Government's assistance in its work of fighting tuberculosis, and of establishing supervised playgrounds. Miss Mabel Peters, of St. John, N.B., gave a paper on the playground movement. Greeting from Lady Aberdeen was received by cable. Lady Aberdeen will come to Canada next summer to preside at the Quinquennial meeting of the Council in Toronto. The treasurer's statement showed that receipts for the year had been \$1,404, and expenditure \$1,379. The special fund is \$1,651, and the quinquennial fund amounts to \$445. At a meeting of the citizenship committee, presided over by Dr. Stowe-Gullen, considerable enthusiasm was evoked by discussions on the efforts being made by women in England to secure the franchise.

LECTURE ON CANADA IN PARIS.
Mr. Marcel Dubois, the Sarbonne professor who passed several weeks in Montreal, giving lectures and visiting the schools, left for Paris on Tuesday last. Before leaving, he announced that the subject of his geographical lectures at the Sarbonne, during the present academic year, would be 'Canada.'

Mr. William Sloan Chosen by Acclamation for Comox-Atlin.

RECOUNT WILL BE ASKED IN QUEBEC WEST, WHERE MR. PRICE'S MAJORITY IS 2.

Mr. William Sloan, Liberal, who represented the constituency in the late parliament, was yesterday re-elected by acclamation for Comox-Atlin, British Columbia. This makes the Liberals elected 131. The Conservatives remain at 80, and there are 4 Independents.

A MAJORITY OF TWO.

An official statement gives Mr. Price's official majority in Quebec West as 2. A recount will be asked for. Mr. Martineau, who ran as a straight Liberal in Quebec county against Mr. Jos. Turcotte, the successful government candidate, and Mr. Lorenzo Robitaille, polled 12 votes in that county.

MR. DYMENT DEFEATED.

The full returns of the election in East Algoma show that Mr. W. R. Smyth, the Conservative candidate, has a majority of 41. His opponent was Mr. Dymont, ex-M.P.

MR. MURPHY'S SUCCESS.

The Hon. Charles Murphy's majority in Russell constituency is 1,193. He carried all the townships except Osgoode and Cumberland.

STRUCK ATTORNEY-GENERAL.
LAWYER ARRESTED IN WINNIPEG FOR ASSAULTING THE HON. COLIN CAMPBELL.

Winnipeg, Oct. 29.—Edmund Howell, son of the Hon. H. M. Howell, Chief Justice of Appeals, and a member of the law firm of Hudson, Howell & Co., was yesterday arrested on a warrant, charging him with assaulting the Attorney-General, the Hon. Colin H. Campbell, K.C. Howell was released on a \$3,000 bail.

On Sunday night a man named William Carson was arrested on a charge of bribery, and was taken to the prison. He engaged Howell to conduct his case for him. Howell called up the Attorney-General at his residence late on Sunday night, and asked that the officer of the Crown personally attend at the provincial jail and order his client's release. This the Attorney-General refused to do, whereupon it is said that Mr. Howell threatened to publish the conversation between them. To this the Attorney-General is said to have replied in terms of indifference, and also to have called Howell a 'blatherskite.'

Howell met the Attorney-General yesterday on the Main street, and, in the presence of a crowd of people, is said to have both struck and kicked the Attorney-General, who is no longer a young man. The arrest of Howell was the result. The affair has caused quite a sensation in the city.

AN ELECTION WAGER.

On Tuesday evening the residents of St. Catherine street east witnessed the results of a wager between two electors of St. Mary division. It had been stipulated that the one whose candidate would lose should draw the other in a buggy, on St. Catherine street, from Visitation street to Papineau avenue and return. The consequence was that at 9 p.m. on Tuesday, Mr. St. Jean, the Liberal voter, enjoyed the triumphal drive given him by his Conservative friend, Mr. Godon, amidst the good-humored remarks of a large crowd present.

MR. BRODEUR WILL NOT RETIRE.

The rumor of the Hon. Mr. Brodeur's intention to abandon the political arena and accept a seat on the bench, is declared by the 'Canada' to be without any foundation whatever. The 'Canada' says: 'We are authorized to deny most categorically the information published by the "Gazette." The Hon. L. P. Brodeur intends to remain at his post, and he is the more justified in doing so from the fact that in the recent campaign he received a striking testimony of public confidence.'

THE OPENING OF PARLIAMENT.

A special Ottawa despatch to the 'Canada' mentions January 6 as the probable date of the opening of Parliament. The same despatch gives Mr. Charles Marcell as the probable coming Speaker of the House of Commons, with Mr. G. H. McIntyre as deputy-speaker, and it adds that the two Nova Scotia vacant seats in the Senate are expected to be given to Mr. Howe J. Logan, ex-M.P. for Cumberland, and Mr. Alexander Johnstone, ex-M.P. for Cape Breton. The Hon. R. W. Scott is mentioned as Speaker of the Senate.

THE HON. W. A. WEIR'S DISAPPOINTMENT.

In the course of an interview, yesterday, the Hon. W. A. Weir stated that he had been much disappointed with the vote given by a large number of the English-speaking electors of Westmount, on Monday last. He felt convinced that those electors did not

REAL ESTATE TRANSFERS.

PREVOST ESTATE BROUGHT \$326,625.

The licitation sale of the Prevost Estate realty holdings, at the Court House yesterday, brought \$326,625 for nine parcels of property, the biggest figure, as reported in the 'Witness' yesterday, being obtained for two lots at the corner of Mountain and St. Catherine streets, knocked down to Mr. J. Stevenson Brown, real estate agent, for \$27,500. Fifty years ago the property was purchased by the Prevost family for \$14,000, on the basis of which the investment has increased in value by no less than 1,500 percent. Five years ago the estate was willing to part with it for \$135,000, and within the last year it was understood that it could have been had for about \$200,000. There was one offer for \$196,000 made for it this fall, and it was said at the time that the signature of only one member of the family was required to complete the sale. This deal, however, fell through.

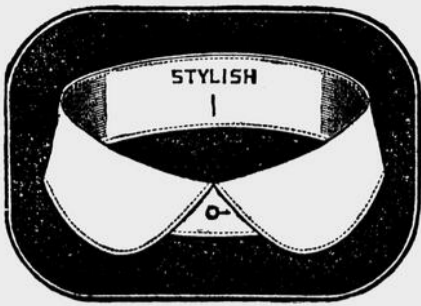

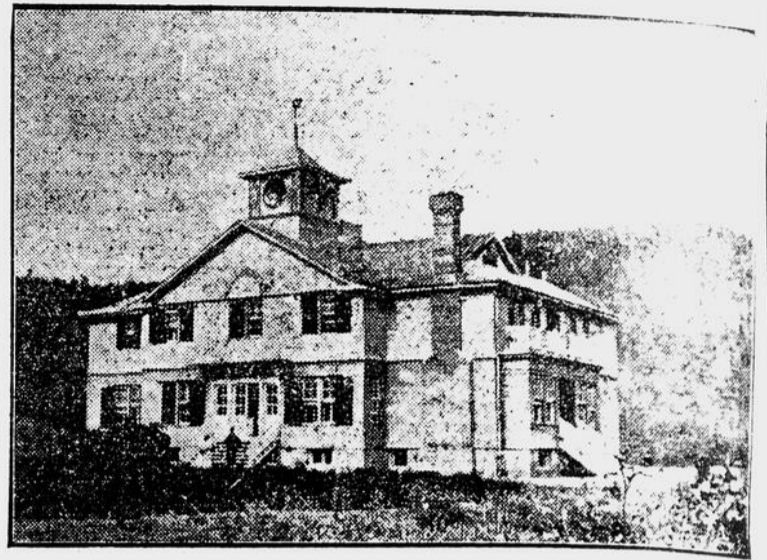

AT THE BOYS' FARM

SHAWBRIDGE INSTITUTION WILL PROVIDE TECHNICAL TRAINING FOR NEGLECTED BOYS.

Working on the theory, propounded by experts in child training, that 'Direction is better than correction,' the managers of the Boys' Farm and Training School at Shawbridge, in planning an institution that is designed to supplant the reformatory in dealing with 'difficult' and neglected boys in this province, have decided to provide plenty of scope for the energies of the boys who will come under their care. Not only will farming and gardening be taught in all their branches, but a technical school will provide instruction and practice in many lines of trade from the boys' manual training stage to the experts' grade. The accompanying cut shows the building that is in the future to be devoted to technical training. It is the first of the group to be erected, and at present is the whole institution. It contains single beds and dormitories for thirty boys and living quarters for the superintendent. The first batch of inmates, it is expected, will be transferred from the Sherbrooke reformatory, after which delinquent or 'difficult' boys will be sent there by the courts instead of to Sherbrooke.

It was announced at the opening of the building on Saturday last that \$10,000 out of the \$25,000 asked for had already come in, but the rest of it had to be financed for.
