To ascertain in this System which Company is really the cheapest, requires a careful examination of the Profits which have been returned by each Company, and the prospect there may be for a continuance or increase of the same. THE CANADA, at its Second Annual Meeting, declared a return of *twenty-five per cent.* or *one-fourth* of the *Premium received*—the corresponding Bonus added to the Policy, being from £22 8s. 3d. to £34 7s. 8d. per £1000 Assured, and decidedly more than the Bonus declared by ANY British Company, even in the seventh year of its existence.

This proportion of the Profits the Directors feel sure will be increased; but in itself, it reduces the above Rates at 20 years of age, to £1 8s.; at 30, £1 17s.; at 40, £2, 9s. 8d.; and at 50, £3 9s. 10d.
