Local postal workers join nation in strike action

SHERBROOKE (BP) — Area residents can expect mail delivery today but the amount will likely be small as about 60 inside workers at the Sherbrooke Post Office joined counterparts today in Western Canada, Ontario, Montreal and Nova Scotia around 6 a.m. by setting up picket lines.

In Cowansville, postal clerks and mail sorters refused to report to work this morning, and there was no immediate indication if mail would be delivered there or not. The only sign of activity was the vehicle of a rural mail carrier in the post office parking lot.

A spokesman at the Sherbrooke Post Office said smaller communities with post offices would not be immediately affected by the strike, but mail moving from there to the larger areas or out of the province would get snarled down before it reached its destination.

The union action came shortly after Postmaster-General Bryce Mackasey said a postal strike could not be avoided if the Canadian Union of Postal Workers (CUPW) did not accept the government's final offer of a \$1.70 increase an hour over

30 months.

Mr. Mackasey also repeated his threat to shut down the post office if the threat of a nationwide strike was realized.

"They've been stalling all along until they could force sporadic walkouts across the country," Mr. Mackasey told reporters in an early morning press conference.

The walkouts came only hours after contract talks in Ottawa ended for the day with Mr. Mackasey stating he would not go back to the bargaining table until the union made up its mind to

accept or reject the government's final wage offer.

ONUS ON UNION

"We told them we'd be glad to resume negotiations when they were prepared to accept the principle basically, the monetary package recommended by Judge Moisan which we accepted as well," Mr. Mackasey said.

"We told them we'd wait until they call us whether it's today, next week or next month."

The wage offer, contained in a conciliation report prepared by Quebec Superior Court Judge Jean Moisan, amounts to a 37-per-cent wage increase over 30 months. The union entered negotiations Friday morning with a demand for a 71-per-cent increase over one year.

Mr. Mackasey restated Monday night the CUPW had reduced their demand to a 51-per-cent increase over one year but Jean-Claude Parrot, the union's chief negotiator, refused all weekend to comment on the wage question.

Mr. Mackasey said once the wage offer was accepted he would be prepared to be "as flexible as possible on other issues."

The monetary plight of the part-time workers which Judge Moisan was ambiguous about, shift differentials, weekend premiums and the hiring of casual labor.

QAPSB reports on funding of its fight against Bill 22

ST. ADELE, Que. (CP) — The Quebec Association of Protestant School Boards (QAPSB) has spent nearly \$100,000 to date fighting Quebec's Official Language Act, says the association's retiring president.

Douglas Sheldrick said at the QAPSB annual meeting here during the weekend he expects the legal challenge to the act by the association would go as far as the Supreme Court of Canada.

Legal proceedings against the Act, known as Bill 22, were launched by the QAPSB in Quebec Superior Court in July.

Legal fees alone have amounted to \$45,626 until now.

About \$60,000 of the funding was provided by the Pan-Canada Foundation, an organization which says its aims are to "promote national unity and patriotic sentiments," preserve minority rights, and promote the cultural development of minorities. It was founded in 1971.

The other \$40,000 was taken from the association's contingency fund.

Public donations to the fund amounted to \$15,600.

Mr. Sheldrick also told 150 delegates representing 31 school boards that the QAPSB has refused to join negotiations with a common front of teachers from the Provincial Association of Protestant Teachers (PAPT) and the Centrale d'enseignement du Québec (CEQ) because any ensuing contract would cut student-teacher contact and adversely affect the quality of education in Quebec's Protestant schools.

members of the CEQ, under their collective agreement, are required to work only 22 such periods.

The CEQ teachers are negotiating for 20 work periods a week.

A PAPT-CEQ delegation was heard at the end of the meeting but was boycotted by the QAPSB executive.

Jack Johnson, president of the PAPT, said the Protestant teachers would "no longer be prepared to accept a contract which in any major aspect will be inferior to that of their colleagues in other sectors."

Olympic workers off the job

MONTREAL (CP) — Workers at the 1976 Olympic site remained off the job today in a dispute over a controversial blacklist barring "troublesome" workers from the site.

A union spokesman said more than 3,000 workers

would not return unless negotiations which began Monday produce a satisfactory agreement.

Several hundred workers were reported milling around the entrance to the east-end Olympic site today,

but security guards were not letting any workers enter.

"Work isn't likely to resume until the police and the construction firms scrap the blacklist," Fernand Daoust, secretary-general of the Quebec Federation of Labor (QFL), said Monday night.

Construction at the east-end Games site stopped Monday when about 3,000 workers walked out to protest existence of the list believed to contain about 300 names.

"QFL workers are getting tired of seeing their buddies suddenly barred from the worksite because the police simply decided to put their names on the 'no-hire' list," Mr. Daoust said.

MADRID (AP) — Sources say Gen. Francisco Franco has developed a heart problem in addition to influenza, and specialists were called to the Pardo Palace today to treat him.

Bomb in Beirut

BEIRUT (Reuter) — Three people were killed and 10 wounded early today when a mortar bomb hit a building in the Christian district of Ashrafieh, police said.

Sporadic shooting and explosions continued in many areas of Beirut until well after dawn, but police could not give precise casualty figures.

At least 23 people were killed in fighting Monday. Armored cars rumbled through the city during the night moving from one trouble spot to another.

Radio Beirut said the roads in the eastern parts of the city were unsafe and issued a warning about a roadblock on the northern side of the capital.

Syrian and Israeli forces clashed Monday on the Golan Heights, said a military spokesman in Damascus, and local residents said Israeli artillery bombarded a Lebanese village near the heights.

Assassination foiled

LOS ANGELES (AP) — Federal officials say the theft of a television set from a motel room foiled a carefully-laid plan by two men to assassinate President Ford.

The two were indicted Monday by a federal grand jury for conspiring to assassinate Ford in Sacramento Sept. 5—the same day Manson follower Lynette (Squeaky) Fromme allegedly pointed a gun at Ford.

A justice department spokesman said, however, that Miss Fromme has no known connection with the alleged plot.

The indictment says the assassination attempt was to include the bombing of a sewer as a diversion while shots were fired at Ford.

The indictments charge Gary Steven DeSure, 32, and Preston Michael Mayo, 24, of Warren County, Va. They are tentatively scheduled for arraignment Oct. 28.

Federal officials say DeSure walked away from the state mental hospital in Warm Springs, Mont., where he had been committed for threatening former president Richard Nixon.

Both men are in custody at Santa Barbara, Calif., where they were arrested Aug. 26—10 days before the Fromme incident—in connection with the theft of the television set. They pleaded guilty to that charge and were sentenced to 90 days in the county jail.

They were also arraigned there last month by a U.S. magistrate on charges of threatening the president and are being held in lieu of \$100,000 bail each.

Injunction against nurses extended

MONTREAL (CP) — Quebec Superior Court Monday extended until Oct. 30 injunctions against the United Nurses Federation taken out by five hospitals a week ago ordering striking nurses back to work.

The hospitals—among 42 affected by strikes and slowdowns by nurses protesting lagging contract talks—are the Royal Victoria, the Lakeshore General, the Reddy Memorial, the Queen Elizabeth and the Montreal Neurological.

A decision is to be made today on an injunction covering nurses at the

Maisonneuve-Rosemont Hospital.

The Royal Victoria Hospital announced its services "remain severely curtailed" because of the uncertain availability of its nurses, who started calling in sick last week.

"Only patients with life-threatening problems who cannot be directed to another hospital are being admitted," a spokesman said.

Meanwhile, the emergency department of Sacre Coeur hospital in nearby Cartierville remained closed Monday as nurses, belonging to the Montreal Nurses' Alliance, continued a work-to-rule campaign to protest overcrowded facilities.

About 250 of the hospital's 450 patients have been transferred since the protest

began Friday. Negotiators for the government and the United Nurses are to meet Wednesday.

Premier Robert Bourassa has said Quebec nurses may be in line for salary "catch-up" clauses in their new contract, despite the recently-announced federal government's wage-and-price controls.

Wagner calls for election

OTTAWA (CP) — Claude Wagner, (St. Hyacinthe) a Progressive Conservative leadership prospect, accused the Liberal government Monday of lying about its plans for the economy and called for an election on the wage-and-price control issue.

Mr. Wagner, a former provincial Liberal cabinet minister, said much of the effectiveness of the government program depends on the willingness of the public to make it work. Public willingness in turn would depend upon the credibility of the government.

Mr. Wagner, referring to Liberal opposition to wage-and-price controls in the 1974 election, said he expected the government would "continue to mislead the public and make false representations."

Liberal statements during the 1974 election campaign were the "most hypocritical statements ever made in Canada."

URGES VOTE
Mr. Wagner, speaking in both French and English, said the Liberals should have

the courage to ask for a mandate for controls in another election.

He noted that one advertisement used by the Liberals in 1974 ended with the words: "The working men and women of Canada don't want their wages frozen Vote Liberal."

The \$600 limit for increases at the lower end of the income scale was "absolutely heartless," he said.

It was the insincerity of the government which led to the defeat of Communications Minister Pierre Juneau by a Conservative in a byelection in Montreal-Hochelaga last week, Mr. Wagner said.

Mr. Wagner said the Conservatives would support the principles and purposes of the legislation but would seek amendments to "make it more just."

US farmers to sell grain to Soviets

WASHINGTON (AP) — United States farmers now are free to sell grain to the Soviet Union following the announcement of a long-term U.S.-Soviet agreement Monday covering the sale of U.S. grain and the purchase of Soviet oil.

As the embargo was being lifted, Agriculture Secretary Earl Butz said as much as seven million more metric tons of U.S. grain might be sold to the Soviets this year.

There are 2,205 pounds in a metric ton.

The two-month-old embargo was imposed by President Ford last summer after the Soviets purchased 9.8 million metric tons of grain from U.S. exporters. The embargo was the result of concern over the impact on U.S. prices that exports could have and some nervousness that predictions of bumper U.S. crops this year might not prove true.

Kidnappers surrounded by police

DUBLIN (Reuter) — Police tracked down kidnapped Dutch industrialist Tiede Herrema today and opened negotiations with his captors, who are holding him at gunpoint, Dublin radio reported.

Dr. Herrema, managing-director of the Ferenka Steel Cord Co., was kidnapped 19 days ago near his Limerick home by Irish guerrillas who demanded the release of three of their comrades. The government refused to make

any concessions.

The radio said police located Herrema in the town of Monasterevin in County Kildare.

Police and troops immediately surrounded the house. Herrema was understood to be held at gunpoint on the upper floor by two men.

The police took over the ground floor of the house and opened negotiations with the kidnappers.

LEADS POLICE
The head of the Irish special branch, Chief Superintendent John Fleming, went to the scene to take charge of the attempt to rescue Herrema.

Police and troops threw a security net around the town,

which is about 35 miles southwest of here.

Police picked up the trail early today after finding a car which was thought to have been used in the abduction of Herrema Oct. 3. At the same time, they arrested two brothers who were driving the car at Tullamore, not far from Monasterevin.

The car was thought to have been used by Eddie Gallagher, an Irish guerrilla believed to have engineered the abduction. Gallagher is a close friend of Dr. Rose Dugdale, the English heiress-turned revolutionary who was one of three persons whose release was demanded by the kidnappers.

Former Bruck manager going to Iran with CESO

Retirement from business has not meant total withdrawal from the textile industry for Maurice A. Hauser, Pointe Claire, Quebec. Quality control manager for Bruck Mills Limited, Cowansville, Quebec, from 1948-72 and plant manager at Associated Textiles of Canada Limited, Louiseville, Quebec, 1934-48, Mr. Hauser has embarked upon a distant volunteer mission to Kashan, Iran, for a six-month term on a consultant basis at the request of Canadian Executive Service Overseas.

His assignment is a dual project for a new textile firm in Kashan where he will act as industrial engineer to advise them on production. At the same firm, Arya Textile Company, he is also answering the need for a volunteer consultant on quality control and work methods.

Mr. Hauser, who is fluent in English and French and has some knowledge of German, Portuguese and Spanish, has had earlier identification with foreign countries in the textile field, initially in the United States, and recently in Brazil, Mexico and the Philippines. A non-profit organization, Canadian Executive Service Overseas was established in 1967 by a group of business leaders to assist business enterprises in developing countries by recruiting senior Canadian executives and technical experts who volunteer their expertise when assistance is requested. It has over 1,500 volunteers on its roster and has completed 1,040 projects. Most of the volunteers are retired and the normal assignment lasts two to six months. Volunteers receive no salary nor fees for their work, but transportation for the volunteer and spouse is provided by CESO and living expenses underwritten by the host organization with whom the volunteer works.

SWEETSBURG WARD (JM) — Judge Guy Genest reserved judgment in the case of Robert St. Jean to Nov. 24. St. Jean, 19, formerly of Sutton, is accused of attempted armed robbery and complicity after the fact. The case dates back to April 3, 1974, at the Marina Restaurant, Bondville.

Jacques Gagne, Bondville, and Yvan Bellegarde, Sutton, entered pleas of guilty to charges of attempted armed robbery while disguised, and were each sentenced to the equivalent of 23 months, considering time spent in preventative detention.

St. Jean's lawyer Daniel Bedard, produced four witnesses in defence. Yvan Dagenais, Foster, said the accused was in his employ April 3, 1974, and the road between Bondville and Foster was torn up due to construction of a sewer system. He said the road could be travelled, however, at low speeds.

Jocelyne Gagne, 20, Bondville, said she was at the restaurant-grocery store when the robbery was committed and she saw St. Jean there shortly after the crime. She said she couldn't remember the precise time, and she heard about the robbery although she had not heard any gun shots. Miss Gagne is the sister of Jacques Gagne. She said she asked St. Jean to drive her home which he did, and they had not discussed the robbery at any great length.

St. Jean, RR 2 Knowlton, said he met Gagne and Bellegarde in Sutton. "I told them I was going to Foster to pick up my cheque and they asked me to give them a lift to Bondville. I had another friend with me and we left towards Bondville. Bellegarde asked me to stop at his home and he came out with a .12 gauge shotgun. He said he was going to make a 'pass'. We then drove to Bondville and I dropped them off at the corner of the highway and the street Jacques lived on.

"My friend and I continued towards Foster and my rattling truck began developing new noises some two to three miles beyond Bondville. We stopped and I got under the truck trying to find the cause of the new noise. I then decided to go back to Sutton when we stopped at the Marina to have a soft drink. That's when we met Jocelyne and her sister and they told us of the robbery. They asked us to drive them home which we did. We then left Bondville for Sutton when we saw Gagne and Bellegarde beside the road. We stopped and picked them up and drove them back to Sutton. I then went to bed for a while then went to work at 11 p.m."

Under questioning by crown prosecutor Guy Prenovost St. Jean said the only mention of the robbery after they picked Gagne and Bellegarde up in Bondville was they went into paroxysms of laughter. St. Jean said he thought Bellegarde might have brought the firearm to do some hunting.

Mr. Bedard told the bench he had only received his mandate to act for M.R. St. Jean six days prior to their appearance in court, and he had attempted to have a hearing specialist subpoenaed to appear for the defence to attest to his client's hearing deficiency. Mr. Bedard alleged the hearing defect coupled with the noises in the 10-year-old truck could have prevented his client from un-

derstanding any conversations relating to the crime during the period he was driving from Sutton to Bondville. He then cited jurisprudence on charges of complicity and suggested his client be given the benefit of any reasonable doubt. Judge Genest ordered copies of all depositions prepared prior to rendering his judgment.

+++ Germain Gagnon, Beauport, and Florent Gagnon, Charlesbourg, consented to having their bail and preliminary hearings continued to October 22. The men are charged with qualified robbery, wearing disguises, possession of restricted firearms, car theft, and theft of \$5976 from the Caisse Populaire, in Eastman, October 9, 1975.

Gilles Poussard, Legal Aid Office, told the court he had been contacted by their lawyer, Narcisse Proulx, of Quebec, who had asked him to represent his clients. Mr. Poussard then asked the men, who are not related, if they consented to being remanded in custody pending their hearings. They assented and will be held in preventative detention pending their hearing Wednesday.

+++ A bench warrant was issued for Simon Cabana, of Granby, who failed to appear for arraignment on four counts of fraud.

+++ Bertrand Gauvin, Farnham, pleaded not guilty to a count of having obstructed a peace officer in the performance of his duties. His trial will be heard Nov. 3.

+++ Earl Wilson, Waterloo, pleaded guilty to a charge of hit and run in the Township of Shefford, July 15. He explained someone had tampered with his brakes and he left to go to a garage to have them repaired. He was fined \$50 and costs, in default 30 days.

Canadians turn to US mail service

DERBY LINE-NEWPORT, Vt. (GA) — Firmly believing in the old adage, "The mail must go through", a growing number of Canadians and Canadian business firms made arrangements to send and receive mail to and from points outside Canada in the Derby Line and Newport, Vermont post offices, U.S. postal officials disclosed yesterday.

Their foresight will obviously pay off with a national postal strike being announced today.

Since last year's Canadian postal strike, Canadians as far as 30 miles from the US-Canadian border have found it necessary to resort to the US post offices to assure a regular flow of mail to and from points outside the Dominion. As a direct, or indirect result of this unusual measure, all post office boxes in both towns have been rented. Newport, the larger of the two facilities, has reportedly rented all 700 boxes. Both, however, continue to make free general delivery service available to all applicants, an increasing number of which are Canadian, American postal officials claim.

Lawrence Gallant, Derby Line postmaster says that due to the limited facilities of his post office he will not be in a position to accept any more Canadian business firms as

regular mailing customers. The Newport office, on the other hand, having newer and larger facilities, is preparing itself for bonus-business from across the border and is setting up temporary sorting-cases for Canada-bound general delivery mail.

"It is going to be difficult for us to determine how much postage to keep on hand unless Canadians planning large mailings tell us in advance," Newport assistant postmaster, Joseph Coutu, said. "We cannot accept foreign postage-meter stamped mail, so therefore each piece of mail must be individually stamped with postage purchased here. So based on this, you can appreciate the problem we would have if someone walked in off the street with a thousand or more pieces of mail for us. Just last week for example, the CPR bought \$600 worth of postage," Coutu added.

Officials from both Vermont post offices concluded that they welcome the extra business but were a little uncertain as to what sort of problem will arise with the declared Canadian postal strike, especially should it continue over a prolonged period of time.

However, it seems they will soon find out.

Two Sherbrooke men sentenced for theft

SWEETSBURG WARD (JM) — Two Sherbrooke men were sentenced to seven years and three and a half years.

Albert Langlois, 33, and Alain Picard, 28, both of Sherbrooke, who had opted for trial before a magistrate alone pleaded guilty to charges of armed robbery while disguised, in the theft of approximately \$26,000 in cash, jewelry and other valuables from Lionel Belanger's Jewelry Store in Cowansville August 9, 1975.

Crown Prosecutor Guy Prenovost told the court the men were armed with a .22 revolver, wore masks and bound both the owner and a young lady customer. Mr. Prenovost said the two men threatened the victims with death and a death threat was again stated against Mr. Belanger while the two men were under arrest in the Brome-Missisquoi-Perkins Hospital.

Mr. Prenovost cited Picard's record which dates back to 1965 and said that he had been granted a ticket of leave from the Laval Minimum Security Institution July 18, some three weeks prior to the commission of the crime.

He then said Langlois had served time for various charges between 1960 and 1965.

"In view of their records and the violence attached to the crime the minimum sentence I can request is 15 years," Mr. Prenovost said. Gilles Poussard, head of the Granby Legal Aid office, said there had to be a distinction between the two men. He produced medical reports stating Langlois had been shot three times once in each leg and in one wrist while Picard's ankle was shattered by a bullet fired by the owner of the store.

Mr. Poussard admitted his clients were charged with a very serious crime and said they went into the shop armed with a revolver when they tied up the young customer. They then asked the owner to open the showcases to enable them to

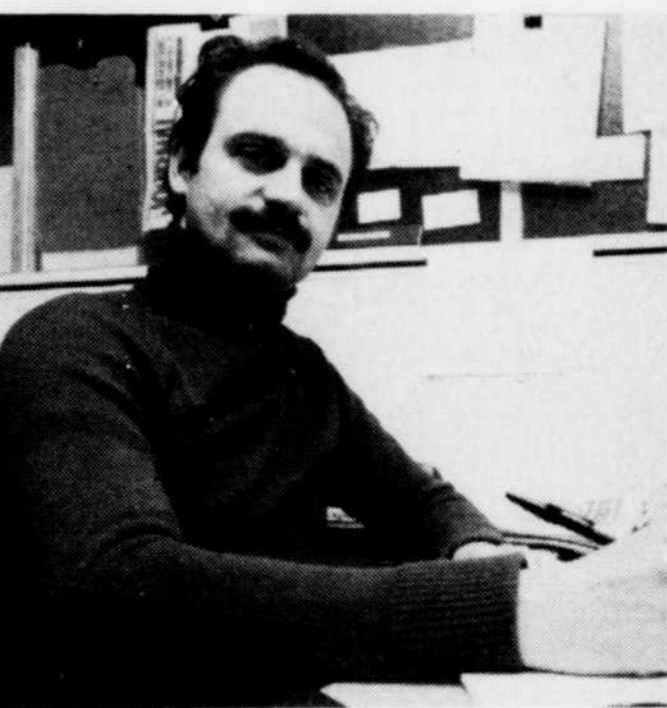
remove the valuables. "They never physically molested the persons although they threatened them. They saw a policeman in front of the door and noting they were surrounded decided they were ready to surrender. That's when Belanger shot them. Two shots went through the window, close to their heads and they thought the police were firing. They went to the rear of the store where they saw Mr. Belanger and slid their weapon to him. They could easily have killed him as he was out of ammunition while they had eight shots left in the magazine.

"Both men are crippled for life and considering their injuries. I feel two years in the case of Langlois who has had no dealings with the law since 1965 would amply serve the interests of justice. "In the case of Picard it is not true that he was on a ticket of leave. However, he had completed two-thirds of the sentence he was serving and was mandatorily released under conditions imposed by the national parole board. Picard obviously had more responsibility in the commission of the crime. However, as there was no physical violence to their victims I feel a sentence of four years would be ample," Mr. Poussard concluded.

Judge Gerard Normandin said, "You know my opinion of armed robbers. I have little pity for them, especially when they are carrying an actual fire arm. I have sentenced 18-year-olds to 23 months for armed robbery when they were armed with a cap gun and they had no records. "This is an excessively serious crime. However, considering Langlois' wounds and the fact he has been out of trouble for 10 years he is sentenced to 42 months.

"In the case of Picard I am also considering his wound, although he has obviously lived off the avails of crime since he became an adult. He is sentenced to seven years."

SHERBROOKE — Got a complaint? Maybe a local merchant isn't living up to his advertising?

If you should find yourself in the position of needing consumer information or you have a complaint, the man to call in Sherbrooke is Guy Desrosiers, of the federal department of Consumer and Corporate Affairs.

Guy Desrosiers was appointed Assistant Consumer Consultant for Sherbrooke last week by Lucie Dion, acting Quebec Regional Director, Canada's Department of Consumer and Corporate Affairs.

Mr. Desrosiers will act as a liaison between the department, consumers, professional and commercial groups in the Sherbrooke area. He will also be responsible for informing and advising consumers and various organizations as to their rights as well as to organize consumer information programs. These new services are in addition to those already being offered in the area by the department, namely the inspection of products, weights and measures, as well as bankruptcy administration.

Mr. Desrosiers, a graduate of the University of Ottawa, also has a BA in History from the University of Sherbrooke. He worked with CUSO (Canadian University Service Overseas) for four years, three of which were spent in Ghana, Africa.

Mr. Desrosiers entered the federal public service in 1972, working for CIDA (Canadian International Development Agency) in Ottawa in the field of overseas staffing. He then worked in the field of bilingualism for the Public Service Commission in Ottawa.

In an interview Friday, Mr. Desrosiers stated that public relations for the department, for which he is responsible, entails (1) informing the consumer as to his or her rights, and of the 24 consumer laws and the 5 statutes administered by the department, (2) initiating a prevention program to inform the consumer of the

number of potentially hazardous items on the market. As part of its information program, the department will conduct full day courses on consumer security this fall and winter for the public on preventative buying of toys and to explain the new symbols on hazardous products.

The most frequent complaints of Sherbrooke residents, stated Mr. Desrosiers, deal mostly with new car warranties, housing conditions and false advertising. The department has a staff of inspectors, who gather information, and if necessary, merchandise to be presented in court. However, the only times the department will go to the court directly is in the case of Monopolies and False Advertising.

Another facet of the Department is the computerization of complaints to compile and mark trends and complaints of areas in Canada. Any consumer with a complaint should call Mr. Desrosiers at 565-4723, or register the complaint at 25 Wellington St., 4th floor, Sherbrooke. The complaint will be verified and if necessary an inspector will be assigned to work on the complaint.

We had free time with them for the whole weekend. During this time, we went shopping at the town's only department store, the Hudson Bay and on Saturday night there was a dance for everybody in the gymnasium of Peacock Academy from 8:00 to 11:30," she continues.

The three teachers who accompanied the group, Harry Brown, Ron Ewing, and Pat Glashan, stayed at the Goose Hilton, and ate their meals in the homes of several teachers.

On Monday, September 29, the group attended the hosts' classes at Peacock Academy. Tuesday morning we visited the weather station in Goose Bay. In the afternoon we climbed Snow Goose Mountain, on which we got lost while looking for a lake. Tuesday evening fifteen students and the three

teachers took a cruise on a fishing boat on Lake Melville," Miss Brown reports. "We got our first taste of five-pin bowling on Wednesday morning. Trumpets of war

The recent signing of the Sinai agreement has failed to bring about the desired relaxation of Middle East tensions. After a hurried trip to Moscow by the Syrian President Assad last Friday, Damascus has announced it is no longer interested in any negotiations with Israel. The accusations voiced by Damascus on Wednesday (and by the Arabic service of the Moscow Radio on Monday) that Israel was massing troops on the Syrian border in preparation for a new assault on Syria have been unpleasantly reminiscent of similar Soviet charges that preceded the 1967 war. At that time the Israeli government asked the Soviet ambassador in Tel Aviv — Soviet-Israeli diplomatic relations were broken only after the Six-Day War — to make a tour of the area and convince himself personally that there was no truth in those allegations. The ambassador refused and President Nasser, using the Soviet allegations as a pretext, expelled the UN peace-keeping force from the Sinai and mobilized Egyptian forces.

The history-conscious Israelis are, therefore, worried lest history repeat itself, especially since the UN force's mandate on the Golan Heights expires next month. Two Tel-Aviv newspapers quoting authoritative Israeli sources yesterday claimed that Syria has chosen "the military option". This gloomy assessment finds further confirmation in the outcome of the recent meeting between Israeli Foreign Minister Yigal Allon and the Soviet Foreign Minister Andrei Gromyko. The meeting, arranged by State Secretary Henry Kissinger, was to open the way to the resumption of diplomatic ties between Israel and the Soviet Union. Instead, Mr. Allon was lectured in harsh terms and told that Israel must give up the American-sponsored step-by-step negotiations and return to the Geneva Middle East peace conference, where the Soviet Union is the co-chairman; that Israel must withdraw behind the 1967 borders and evacuate all occupied territory including the Golan Heights and Jerusalem; and must open discussions with the Palestinians. Only then would the Soviet Union be prepared to resume diplomatic relations with Israel. That much then for hopes of a Soviet-American collaboration in the Middle East.

It was a foolish hope anyhow, since the Soviet Union now regards General Assad of Syria as the leader of all Arabs and is probably strongly involved in the events in Lebanon, where the Palestinians, with Syria's assistance, have been trying to overthrow in a civil war the only democratic government in the Arab world. The fall of Lebanon to Syria would drastically alter the strategic situation in the Middle East and the Israelis fear that the turmoil in Lebanon could be exploited by Syria to open the fifth round of the Arab-Israeli war. Nor can Israel rest assured that the Egyptian front would remain unaffected by Syria's action.

Alberta led in anti-inflation planning

EDMONTON (CP)—The September announcement from the Alberta treasurer's office had unusual impact coming from a government awash in resource revenues and with every sign there was more where that came from. Alberta, said Provincial Treasurer Merv Leitch, "disappointed" that the federal government had failed to take bold new initiatives to counter inflation, had decided to set a good example. Growth of the 1976 budget due to be handed down in February would be limited to 11 per cent — half the average increase of the last four years.

"We believe governments must provide leadership in assisting in the reduction of the alarming inflationary rates in the nation," said Mr. Leitch.

"It is well recognized that the causes of inflation are primarily international and national, and that a provincial government is only capable of taking very limited action."

TOLD TO CINCH BELTS That Alberta was willing to lead the way in taking such action was affirmed a week later as Premier Peter Lougheed called on all Canadians to cinch in their belts a notch and be ready to make personal sacrifices to fight inflation.

Speaking to a joint meeting of the Vancouver Board of Trade and Men's Canadian Club in Vancouver, the premier said the problem had reached the stage where "muse and talk" had to be replaced by concerted action. Business, labor, and professional groups should be prepared to defer their expectations, he said, and every individual recognize the part he must play.

"The answer lies in a combined effort—governments must take the lead, but governments cannot do it alone," said Premier Lougheed. "They must dampen expectations and tell it like it is."

The administration's sentiments, like the move to limit spending, was greeted with polite applause from the business community and the editorial writers. Back home, meanwhile, the call for self-sacrifice rallied little enthusiasm among the groups the budget ceiling would fall on hardest.

LIMIT ON GRANTS As well as direct provincial spending, the limit would also apply to the almost 50 per cent of the budget reserved for grants to schools, hospitals and municipalities.

Aside from municipalities, which have recourse to property taxation, these sectors depend heavily on provincial largesse as a source of operating funds. As well, each was rounding out a year of exhaustive penny-pinching to make salary demands, inflation and growth of programs fit under a 15-per-cent limit on provincial grants im-

posed for the current budget year.

Provincial contributions to the school foundation program, which shores up Alberta's Grade 1 to 12 school system, increased to \$402 million this year from \$338 million in 1974. Under a straight 11-per-cent guideline, grants would come to \$446 million in 1976.

The reaction from school boards and teacher association representatives alike was one of dismay, accompanied by warnings the quality of education is almost sure to suffer.

SAYS IT'S SACRIFICE "It isn't reasonable to expect education to be the sacrificial lamb to inflation," complained Jim Weaver, president of the Red Deer local of the Alberta Teachers' Association.

Ed Paszek, a teacher representative in Edmonton, said the profession has a right to salaries in perspective with

those of society in general and would be unlikely to moderate its wage demands despite the ceiling.

The grant restriction comes at a time when local school boards are under great pressure to provide new facilities for growing populations and maintain a high standard of education, said Jim Falconer, chairman of the Edmonton public school board.

"We hesitate in view of this to cut back essential programs, particularly successful ones recently established, or to increase class loads," he said.

"Restrictive financing of this kind could make the supplementary requirements on local taxpayers intolerable."

COLLEGES COMPLAIN Similar responses came from the heads of the province's colleges, which would receive a \$3-million increase in grants next year compared with \$4 million the year before, and universities, which would receive \$150 million in the next budget year compared with \$108 million in 1974.

Some of the most understated cries of dismay came from the province's hospitals, which this year experienced a staggering 32-per-cent increase in costs, to \$432 million, and which look forward to the start shortly of a new round of labor negotiations. Bargaining last year resulted in wage increases often exceeding the 30-per-cent mark and salaries may account for up as much as 75 per cent of an institution's budget.

Noting the effects of inflation and that union wage settlements have been running at increases of 15 and 16 per cent, the city needed a 12-per-cent budget increase this year just to maintain the same level of services as 1974, said Ald. Decore.

The situation underlines the need for a more rational cost-sharing arrangement between municipalities and the province, said Ald. Decore, pointing to Manitoba's decision to cut cities in for a share of provincial income tax and British Columbia's plan to split some of its oil revenues.

Mr. Notley, the NDP's lone member in the legislature, condemned the plan because the social services would be the first to feel the pinch, while the government continued to provide handsome incentives to business and corporate taxation loopholes remained unplugged.

"The 11-per-cent guideline is a superficial solution to a complicated problem," said the NDP leader. He added that the government move will actually put local authorities in a position of having to take the rap for program cuts.

Ironically, the members of the government that proposed the guideline may be among the first to regret it.

This fall, an independent commission headed by Mr. Justice Clifton Prowse of Calgary is expected to hand down its report on the first pay increase members of the legislature have had since 1972.

Excess Profits of Defense Contractors

WASHINGTON — All but a handful of the nation's largest defense contractors have been successfully covering up billions of dollars in excess profits.

This is the finding of a confidential study by a House Banking subcommittee which is determined to close the legislative loopholes which make these excess profits possible.

Hordes of lobbyists, meanwhile, are struggling to keep them open.

The billion dollar battle centers on the obscure federal Renegotiation Board, the only independent office in the Executive branch specifically charged with rooting out excess defense profits.

But the beleaguered board is so undermined that each of its accountants must evaluate a staggering \$15 million in defense spending every hour, the study asserts.

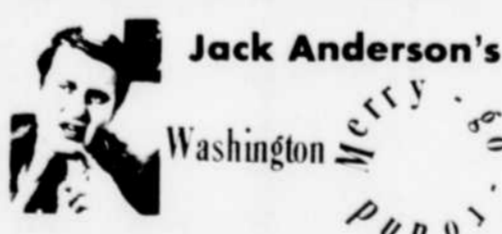
The banking subcommittee chairman, Rep. Joseph Minish, D-N.J., backed by such veteran friends of austerity as Adm. Hyman Rickover, has tried for years to bolster the board.

Now, the Minish bill is being readied for House action. His subcommittee study details the excess profit cover-up.

"In 1966, of the 100 largest defense contractors, none were subject to the renegotiation determination. In 1967, there was only one; in 1968, four; 1969, two; 1970, two; 1971, three; 1972, two; 1973, seven; 1974, four."

"It seems clear that either 95 per cent of the large contractors do not make excess profits or else they are able to cover up their excessive profits. Undoubtedly, the latter is the real reason."

The large corporations are able to avoid examination, the memo states, because of a "profit-averaging" loophole which allows them to offset profits in one corporate division with losses from



another.

"The present system discriminates against the smaller corporation which primarily operates a one-line product. It is unable to offset its excessive profits."

Minish has also targeted three other technical loopholes. One allowed the big defense producers to escape renegotiation on "1.5 billion of sales" in 1970 alone, according to the memo.

Another loophole was designed to aid the oil, timber, mineral and other big resource industries by exempting certain of their raw material sales from scrutiny by the board.

The most outrageous loophole, however, is one which permits defense contractors to pocket \$80,000 in excess profits even if they are caught by the board. The profit-taking ceiling was \$40,000 until after 1972, and the General Accounting Office has estimated that \$16 million would have been lost to the taxpayers had the \$80,000 regulation been in effect that year.

Republicans in the House have tried to retain the \$80,000 loophole. Indeed, the Ford Administration has been strangely silent on the bill, despite the fact it would save the government billions.

One Board member estimated that merely adding 95 new staffers would mean a retrieval of \$8 million for the government in 1977 alone. But the President's budget office has refused to assign any more auditors to the Board.

Footnote: One of the busiest lobbyists

against a stronger Renegotiation Board has been former Rep. Charles Gubser, R-Calif., whose main distinction as a congressman was his incessant junketeering at taxpayers' expense.

Sexist Security: Sexual discrimination is so ingrained in the U.S. that 23 million or 18.3 percent of all women over 65 are living their "golden years" in poverty.

According to an internal report prepared for the Senate Aging Committee, the average retired woman worker must subsist on Social Security payments of \$180 a month. Men average \$225.

As a result, almost twice as many women as men live in poverty after retirement. Says the Senate study:

"The differential reflects an economy in which women workers are disproportionately found in low-pay and part-time occupations, even when they are the mainstay of family support."

To improve the Social Security system for women, the committee report urges a dozen changes, including one to allow disabled widows and surviving divorced wives to collect payments regardless of age.

Another change would give higher benefits to families in which both the husband and wife worked. In some cases, now, a family with a non-working wife gets larger payments than the working couple, even though both had identical earnings.

The study also recommends extending payments to close dependent relatives living in the house of a worker who dies, retires or is disabled.

The Aging Committee, chaired by Sen. Frank Church, D-Idaho, will hold hearings on the proposals later this year.

New union formula to receive workout

MONTREAL (CP)—A new formula aimed at curbing violence and improving union freedoms in Quebec's construction field is about to receive its first big workout.

Three Quebec labor federations are empowered to begin rival recruiting campaigns today among the province's 147,000 construction workers employed on a host of projects, including the vast James Bay power development and the 1976 Montreal Olympics site.

Under the legislation, imposed by the Quebec government following a sensational inquiry exposing violence and corruption in the industry, the four-week membership drives will be followed by a secret ballot Nov. 9-11.

A spokesman for the newly-formed Quebec Construction Office (QCO)—which will supervise the balloting—stressed Monday that the law forbids on-the-job campaigning.

The new law aims at eliminating the intimidation, baseball-bat diplomacy and bribery by which union membership rolls were expanded during designated raiding periods in past years.

Workers will vote for the union of their choice at 550 polling stations established across the province by the QCO, headed by Real

Mireault, former deputy minister of labor.

QFL IS BIGGEST It will be the first such vote in an industry in which the internationally-affiliated Quebec Federation of Labor (QFL) now represents about 70 per cent of the workers.

The rival Quebec-based Confederation of National Trade Unions (CNTU) represents 25 per cent. The Centrale des Syndicats Democratiques (CSD), a newer federation, stands a distant third in present membership.

The unions say they plan to woo membership by leaflets and booklets as well as advertisements in newspapers and other media. But officials of the QFL, CNTU and the CSD, wary of government interference, have been critical of the new law for various reasons.

CNTU president Marcel Pepin told reporters Monday the forthcoming vote could not be considered secret because each member would eventually receive a union card and "then everyone will know how he cast his ballot."

Observers say the QFL seems confident of maintaining its dominant role in the forthcoming vote despite a recent commission's findings of extortion, loan-sharking and fraud involving the big federation.

Record Yesteryears. 45 Years Ago

QUEBEC, Que. — A non-political commission, which will likely represent various interests concerned, directly or indirectly, with the expenditures of funds available for the relief of unemployment, will be appointed on Wednesday at the meeting of the Cabinet, it was announced by Premier Taschereau.

"The Commission, which it has been thought advisable to name to deal with relief measures coming from Ottawa in co-operation with the Provincial and Municipal funds, will be named at the next meeting of the Cabinet," stated the Prime Minister.

"This commission will be a non-partisan one," he added. "In view of the importance of carefully dealing with the moneys which will be supplied by the Federal and also by our Provincial and Municipal administrations."

No names have yet been mentioned, but it is understood that experts, capital and labor representatives, will form part of the Commission, which will likely be of five or six members. The Commission will have to start its work without delay, in view of the fact that requests for help are coming in from all parts of the province, and each case will have to be very seriously investigated.

Attic is colorful sewing area

Manufacturers of sewing cabinets lately have been criticized for their unrealistic approach to the very real problem of sewing storage.

Most sewing cabinets are made without drawers — or, at best, shallow drawers that don't begin to hold the working equipment of a serious home sewer.

Sewing boxes are worse, with their pretty little padded interiors and strawberry-basket storage space.

A man wouldn't dream of putting up with inadequate arrangements in his workshop. Why, then, should a woman be expected to sew without a place to put the many tools of her craft, plus the raw materials of fabric, patterns, buttons and trims? If she is workmanlike in her approach to sewing, she should have a workmanlike sewing space.

A separate sewing room is ideal, such as a converted attic. A false plywood wall was built around a lowered window and fitted out with shelves which hold corrugated boxes color-coded for easy classification.

In addition to adequate — even generous — storage, a good sewing area demands a big work surface, to lay out and cut patterns and to accommodate the huge amounts of

fabric required for such home furnishings projects as slipcovers and curtains.

APPLE DESSERT FRITTERS

4 apples
1/2 cup lemon juice
1/2 cup granulated sugar
1 cup cake and pastry flour
1/4 cup granulated sugar
1 1/2 teaspoons baking powder

1/2 teaspoon salt
2 egg yolks
one-third cup milk
1 1/2 teaspoons vanilla
1 tablespoon vegetable oil
2 egg whites

Preheat deep fat to 375 degrees F. Peel, core and slice apples into 1/2-inch thick rings. Marinate them for 30 minutes in a mixture of lemon juice and 1/2 cup sugar. Sift together flour, 1/4 cup sugar, baking powder and salt. Combine egg yolks, milk, vanilla and oil. Beat in flour mixture. Beat egg whites to form stiff but moist peaks and fold into batter.

Drain apple rings, 3 or 4 at a time, on absorbent paper. Dust lightly with flour then dip in batter, draining off excess.

Fry in deep fat which has been preheated to 375 degrees until golden brown. Drain on absorbent paper and dust lightly with icing sugar. Serve hot. Makes 16 fritters.

PUMPKIN NUT WAFFLES

2 and one-third cups cake and pastry flour
3/2 teaspoons baking powder
1 teaspoon salt
1 1/2 teaspoons cinnamon
1/4 teaspoon nutmeg
3 egg yolks
2 cups milk
one-third cup vegetable oil
3/4 cup canned pumpkin
3 egg whites

Chopped pecans or walnuts
Preheat waffle iron. If necessary grease with unsalted fat. Sift together flour, baking powder, salt and spices. Beat yolks, milk and

oil together. Blend in pumpkin. Stir in dry ingredients, beating until almost smooth. Beat egg whites until stiff and fold into batter.

Pour batter onto preheated waffle iron using 1 1/2 cups batter for each 16-inch square waffle. Sprinkle with nuts. Bake until waffle iron stops steaming. Serve hot, with butter and maple syrup. Makes 16 four-inch square waffles.

PUMPKIN NUT PANCAKES

Preheat griddle or heavy frypan. Prepare batter as for waffles. Pour batter onto preheated griddle, using 1/4 cup batter for each pancake. Sprinkle with nuts. Turn when bubbles break on surface. Serve hot with butter and maple syrup. Makes 20 five-inch pancakes.

SPICY PUMPKIN PUDDING

1 and one-third cups cake and pastry flour
1 teaspoon baking powder
1 teaspoon salt
1 teaspoon cinnamon
1/2 teaspoon nutmeg
1/2 cup shortening
1 cup lightly packed brown sugar
2 eggs
two-thirds cup milk
1 cup canned pumpkin
3 tablespoons table molasses

3/4 cup chopped walnuts
Thoroughly grease a 1 1/2 quart mould. Sift together flour, baking powder, salt

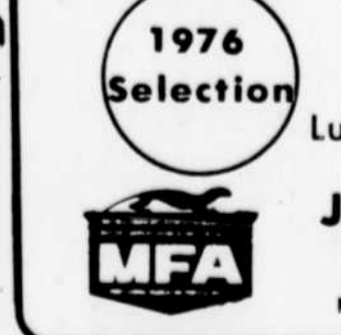

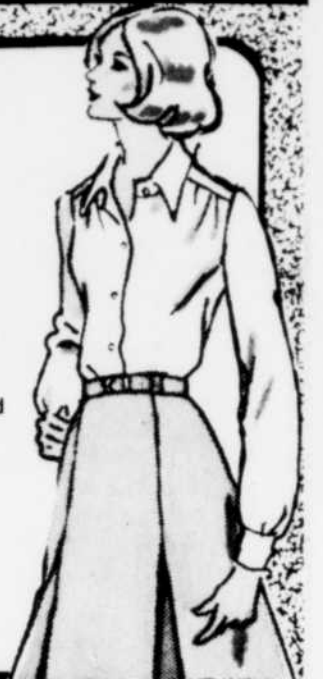

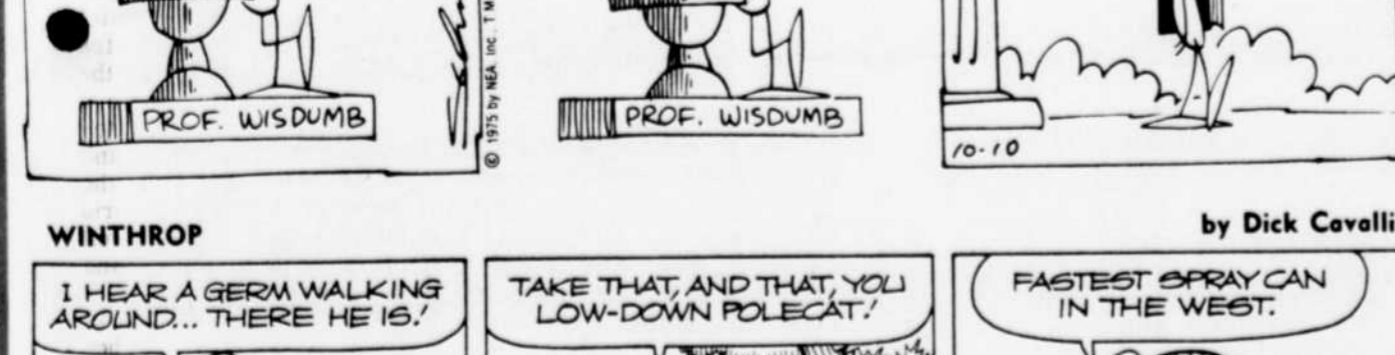

Here is a really tough hand for an expert game. South has a low spade from dummy. If East fails to overtake his partner's queen and shift to a diamond, declarer will romp home. At least declarer will work out a winning line of play.

If the spade is ducked he wins the next spade, ruffs out the last two spades, runs off all his trumps and works the proper end play against West.

If East hops up with the king as he should, bid shifts to a club. South rises with the ace, ruffs out spades, draws two

rounds of trumps, leads his queen of clubs and West is caught in an early end play.

In the actual play East did put up his king of spades, did shift to a diamond and was rewarded by scoring 100 well-earned points.

Why did he lead the diamond? He explained at length that it was the presence of the four clubs to the 10 in the dummy.

He pointed out that there were so many combinations where that 10 of clubs could develop into a trick that he just had to lead the diamond.

Canadians break some of the American domination during Pan-Am competition

MEXICO CITY (AP) — Marie Gurr of Vancouver, U.S. PULLS AWAY

For the third consecutive day, U.S. athletes dominated the Games, winning 12 of the 19 gold medals available and settling for no less than a bronze in the other seven events.

They took six of the eight on the final day of the track and field program and six of seven in swimming and diving, plus silver medals in the water polo tournament, dressage, the women's backstroke and 1,600 relay and the marathon.

The Canadian foil team of Donna Henney of Toronto, Susan Stewart of Vancouver and Fleurette Campeau and Chantal Gilbert-Payer of Montreal won Canada's first fencing medal, a silver, as Cuba continued its string of successes in the sport.

The only other Cuban gold medal came in the marathon, as Rigoberto Mendoza outlasted Charles Smead of the U.S. and Tom Howard of Vancouver in what the 27-year-old Canadian described as the toughest race of his career.

That left the Americans with 59 gold medals to 34 for Cuba and 14 for Canada.

SIMPSON WINS SILVER
 The Canadian pair of Laura Wilkin and Carol Stuart of Calgary won a silver medal in synchronized swimming. Ottawa pole-

vaulter Bruce Simpson finished second behind Earl Bell of the U.S. and the Canadians chased the Americans home in the 400-metre freestyle relay.

Both silver and bronze went to Canada in the women's 200-metre freestyle as Gail Amundrud of Vancouver and Anne Jardin of Pointe Claire, Que., both broke the Games record as they finished behind Kim Peyton of the U.S.

Marion Stuart of Montreal won a battle for a bronze over Joann Baker of Thunder Bay, Ont., who finished fourth, in the women's 100-metre breast-stroke.

There were also three Canadian bronzes in track relays. Mrs. Hakubowich, pressed into double duty along with Joanne McTaggart of Saskatoon, ran another strong anchor leg in the women's 400 and Don Domansky of Thunder Bay, a 28-year-old veteran of nine years of international competition, ran the closing leg of the men's 1,600.

The U.S. and Cuba were first and second in all three races.

SET CANADIAN MARKS
 All four relay teams broke Canadian records. Mrs. Yakubowich, coughing constantly after her second race of the day,

said she did not dare take medication for fear of being ruled ineligible to compete, as was Joan Wenzel of Waterloo, Ont., who had to bow out of the 1,600 relay after dosing a severe cold. She was replaced by Miss McTaggart.

"The cough didn't affect my running," said Mrs. Yakubowich.

Canada's best chance for a medal in team sports was in field hockey as the Canadians played to a 2-2 draw with Argentina Monday in what experts described as a great exhibition of the sport.

Both teams are unbeaten with one round remaining in

the seven-country tournament with the top four teams playing for the medals when the preliminary schedule ends. The Canadians have two draws to the Argentines' one.

The Canadian team scored its first victory in the final game of the water polo competition, defeating Puerto Rico 10-4 to finish

fourth among the five contestants. The baseball team was beaten 7-2 by Mexico and both basketball teams lost, the men being beaten 84-73 by the United States and the women 78-74 by Mexico.
