THE DEVELOPMENT OF QUEBEC.

Time and again well-merited criticisms have been made against the apathetic manner in which matters appertaining to the best interests of the city have been and are being dealt with by the Provincial Government, our civic authorities, and many of our prominent business men.

These criticisms are founded on glaring cases of gross negligence in almost every instance. Take, for example, the proposed development of our great resources in the northern part of the province, where the necessity of the construction of a line of railway is so vital for the opening up of that country.

We note all around outside the city of Quebec, industries springing up, factories being built, large numbers of individuals employed, but here in Quebec, nothing at all seems to be attempted. We are told that the Transcontinental shops will employ a large number of men, and that the Terminals and Bridge will also give considerable employment, but these are not the industries that are most desirable.

We also recollect that some months ago, certain propositions were made by the Directorate of the Q. R., L. & P. Co., that a meeting should be arranged at the earliest possible opportunity between a committee represented by the Mayor and the Chairmen of the Finance, Road and Light Committees with the City Engineer, and a committee representing the Q. R., L. & P. Co., with a view to obtaining from the city, all causes of complaint such as the removal of poles, extension of lines, and reduction of gas prices, &c., but we are sorry to state that the suggestions of the Q. R., L. & P. Co. seem to have been treated with the greatest indifference, and no action or meeting has been held to ameliorate these matters, which could easily have been adjusted if these suggestions had been accepted and the matter discussed in a business-like, practical way.

THE FATAL FIRE AT ST. JOSEPH'S COLLEGE

Two Lives Were Lost — The Superior and Assistant the Victims.

(By Canadian Press.) Granby, Que., Jan. 5.—Two deaths are recorded as a result of the fire which destroyed St. Joseph's College here last night. Brothers Louciere, assistant Superior, and Daniels, the Superior, are the victims. The fire broke out at 11.30. The teachers awakened the students and got them out of the building. It was while doing this that Brother Louciere lost his life, as he was not seen after directing the last of the students downstairs. His body is still in the ruins.

The building was a fine structure, erected about 12 years ago at a cost of \$75,000. A new wing in course of construction was almost completed. There was insurance for \$30,000. Plumbers were at work in the basement last night until 10 o'clock, but they say they left everything all right. The fire started in the basement, and it was the smoke ascending to the top floor of the college, where the dormitories and private sleeping rooms were located, that gave the inmates of the building the intimation that the place was on fire.

The boys, who were all strangers in the town, and who were remaining at college during the Christmas and New Year's vacation, were quickly aroused. Some of them were overcome or frightened by the smoke, and the brothers had to carry and drag many of them down the three flights of stairs to the street. At the time of the outbreak 29 brothers were asleep on the third floor of the college, and they had no time to dress, the blaze spread so rapidly, and they had to run into the street in their night clothes and bare feet, with the thermometer about 25 degrees below zero. The brothers and pupils lost all their clothing and belongings and suffered terribly from the bitter cold before they could reach various houses and hotels in the vicinity.

Brother Daniels, who remained behind to ascertain if all the boys were out of the building, had his escape by the stairway cut off by the flames. There was no way for him to escape being burned to death but to jump. He struck the ground in a heap and when picked up was unconscious. He was carried to the home of a physician and early this morning it was said he would not recover, as his spine had been fractured.

The firemen of the town made a quick response after the alarm had been turned in, but the blaze had made considerable headway before it was discovered, and when they arrived with their apparatus the building was a mass of flames from the basement to the top story. The fire-fighters had to work hard to prevent the flames from spreading to the church and other buildings in the vicinity. But, fortunately for them, the college was set back somewhat from the street and squared from the other buildings. Inside of two hours from the time the outbreak was discovered nothing remained of the building but a heap of smoking bricks and timbers.

STRANGE VERDICT OF A CORONER'S JURY.

(By Canadian Press.) New York, Jan. 5.—A coroner's jury to the contrary notwithstanding, seven prisoners arrested in connection with the murder of John C. Warner, a young civil engineer of Highwood, Conn., were to-day charged with felonious assault. Warner was killed during the recent express strike, on October 31 last, by a band of ruffians who, it is thought, mistook him for a strikebreaker. A coroner's jury found to-day that he had come to his death at the hands of some persons unknown. Coroner Hellenstein was indignant. "There is ample evidence, corroborated by the prisoners themselves," he said, "to show that they conspired with one another to commit a felonious assault on some one. I shall sit as a magistrate in this case and hold all the prisoners."

The prisoners are: James F. Mulligan, Peter J. O'Connor, Alfred Langlois, Chas. J. Hansen, Andrew Martin, Edward Hirschfeld and Charles Klienmann. The first three were held in \$8,000, charged with being the principals. All went to jail in default of bail except Klienmann, who was paid until to-morrow, when he must furnish bonds.

MINISTERS LEFT FOR WASHINGTON LAST NIGHT.

(By Canadian Press.) Ottawa, Jan. 5.—The Canadian ministerial party which left this afternoon for Washington included Hon. W. S. Fielding, Mrs. Fielding and Miss Edith Fielding, Sir Allen and Lady Aylesworth, Hon. W. Wm. Paterson and Hon. L. P. Brodeur. Accompanying the ministers in the capacity of expert advisers were Dr. Wakeham, officer commanding the Gulf Division of the Fisheries Service; Mr. H. V. Rorke, Supervisor of Customs, and Mr. Wm. Russell, of the Finance Department. Hon. Geo. P. Graham, Minister of Railways, will meet the party in New York, where he intends to spend a couple of days.

CONSERVATION COMMISSION

Is Opposed to Any Reciprocity Which Would Give Away Forests of Canada.

(By Canadian Press.) London, Ont., Jan. 5.—Speaking tonight at the Canadian Club banquet, Hon. Clifford Sifton said that the Conservation Commission was opposed to any reciprocity which would give away Canada's forests. "They would lose the United States, but seven years," he said. "We must not forget that our natural resources are the means of livelihood for a great majority of a country's people. Therefore it is no fad, this process of conservation and saving, for the nations that have fallen have been those which exhausted their natural resources. Egypt is an example of that. It was once the granary of the world, then it became a desert, but British energy will again restore it." The speaker proceeded to outline the growth of the Conservation movement and then described the steps that have been taken along this line in Canada.

The question of water powers was first dealt with. The old view of private rights in water powers was disappearing as a result of recent discussion and agitation. Ontario had led the way in this respect by "legislation containing the organic principle of limited franchises and power to control," and finally the government of Ontario had assumed the duty of giving its people power. "I may go so far as to say," said Mr. Sifton, speaking of their mission, "that the presence of a body whose duty it is to watch legislation of this kind, has had a healthy effect, for the promoter of any bill contrary to the great public principle knows that he will have to run the gauntlet."

Bishop Fallon, on "International Peace," said that he feared that Germany's plans were to oust Britain as the dominant power. "That would be a bad day for the world," he said. Mr. Mackenzie King also spoke.

TO SUPPRESS OPIUM TRAFFIC. (By Canadian Press.) London, Jan. 5.—The international congress for the suppression of the opium traffic will assemble at The Hague May 30. It is stated that the United States will support the British proposal to include morphine and cocaine with opium.

SENSATION IN A MONTREAL COURT

The Recorder Calls the Clerk of the Court of King's Bench to Task.

(By Canadian Press.) Montreal, Jan. 5.—A mild sensation has been caused by some remarks made by Recorder Dupuis in sentencing a prisoner in his court this morning. The woman was accused of keeping a disorderly house. "This woman apparently defies the court and is laughing at it," said the Recorder, "but I do not blame her. I will see the Attorney-General and endeavor to have an enquete to get to the bottom of this matter, because I cannot make up my mind that there is not something wrong. I do not believe that a man like Mr. Sciotte would do the work he is doing just for the pleasure of doing it. It is perfectly useless for me to sentence this woman to jail because in five minutes from now Mr. Sciotte would give her her liberty. The administration of justice by this court is nothing more or less than a joke since Mr. Sciotte has taken upon himself to do away with the judgments of this court." Mr. Sciotte was amazed when told of the Recorder's remarks. As clerk of the Court of King's Bench he explained, he received notices of appeals entered by these women in accordance with the law, and exacted security from them as the law demands. It was true that some of these women after being convicted in the Recorder's Court and entering an appeal, had left the city, but the city was rid of them and this was a good thing. He declared that he intended seeing what Recorder Dupuis meant by his remarks.

REFORMS IN PORTUGAL. (By Canadian Press.) Lisbon, Jan. 5.—The Minister of the Interior has decided to put into operation a comprehensive social reform scheme. The measures include a weekly rest day, old age pensions, public aid and the protection of maternity and childhood, the creation of a large number of primary schools, with the free distribution of food, clothing and books to needy children, the development of higher education, especially medicine, with the establishment of a faculty of medicine at Lisbon, and adequate lunacy regulations.

BANKER ROBIN'S ALLEGED PARENTS

He Refuses to Recognize an Old Couple Who Claim to be His Father and Mother.

(By Canadian Press.) New York, Jan. 5.—"What's the matter with you anyway? What do you think you're trying to do?" asked Joseph G. Robin, the fallen banker, this afternoon, of the gray-headed couple who say they are his parents. He absolutely refused to have anything to do with them or even to admit that his parents were in this country. In his denials his sister, Dr. Louise Robinovitch, who had been constantly behind him, took the same firm stand. It was necessary to lead Robin to the District Attorney's office with assurances that he need answer only a few questions. Once there Mr. and Mrs. Herman Robinovitch were brought into the room. "My son! my son!" cried the woman, half in yiddish, half in English. "This is my son," and made as if to embrace him. Robin smiled and turned his shoulder. "Ask him if he is not my son!" she protested to the District Attorney. It was then that Robin startled the room with his abrupt question. The woman shrank as if she had been struck, and broke out into lamentation. Her husband, whose sight is not of the best and who understands no English, had been peering anxiously at Robin during this dialogue. He affirmed positively, "This is my son. I know him." Again Robin denied that his parents were in this country, and at this fresh denial the husband joined with the wife in upraised hands and moans of grief. The sister met similar affirmations with similar denials. "I probably have seen these old people in Brooklyn," she said, "but I do not know them. My brother's parents and mine are in Russia."

INVITED TO JOIN AMATEUR ATHLETIC UNION. (By Canadian Press.) Ottawa, Jan. 5.—The Inter-Provincial Amateur Football Union has been invited to affiliate with the Ontario branch of the Amateur Athletic Union of Canada. The matter will be considered at the annual meeting, which takes place here on Saturday afternoon. Charges against "Kid" Smith may also be investigated.

**ANY OLD THING FOR QUEBEC.**

Last year representatives of the C.P.R. promised that they would busy themselves with the improvement of the service between here and Montreal.

At that time there was a train covering the distance in four and a half hours. To-day the train is scheduled to do it in five hours, and is seldom on time, even with the extra half-hour.

The sleeping car accommodation is another instance of the doctrine that any old thing will do for Quebec.

Last week, for instance, we had occasion to note a car called the Rideau. We are not aware who named it thus or why he did so. On the principle of lucus a non lucendo he should have gone further and called it Rideau Hall.

There was no vestibule. It was lighted by oil lamps, which reminded one of the "infinitely lugubrious crepuscule" spoken of by Rudyard Kipling or the "struggling moonbeam's misty light" which lent its feeble aid at the obsequies of Sir John More. Had the late lamented Edgar Allan Poe been still living and had taken a trip on the Rideau the other night, he would probably have fabricated a more weird and fearsome story than any that have yet passed the publisher.

The Rideau is evidently one of the oldest cars in the service, and if it were put on some other route there would be an uproar immediately.

As, however, it is only Quebec, any old thing will do.

**QUESTIONS OF MOMENT.**

Now that the Federal Premier is in town, it is to be hoped that a little headway will be made with some of the more important questions relating to the city.

On the occasion of Sir Wilfrid's visit in May we enumerated the following questions as calling for consideration:—(1) The location and construction of the terminals. (2) The commencement of a dry dock. (3) The erection of a new Customs House. (4) The reorganization of the Harbor Commission. (5) The building of an elevator. (6) The all-round improvement of our harbor facilities.

Since that time the only progress made has been in the matter of the terminals. The dry dock is still in abeyance, and it is this necessity that should be emphasized above everything at the present moment. The interests of the country require a large dock at this port, and this fact is generally admitted. We understand that Sir Wilfrid has promised that, if no company will undertake the construction of a dock at Levis, his government will undertake the work itself. This statement, however, has not been confirmed publicly.

There is a considerable amount of antagonism to the erection of a Customs House on the old site, in view of the increased railway traffic which is expected in the future in the lower town. This is likely to make for congestion, and a more convenient site to all sections of the community would be at the juncture of St. Roch and Lower Town.

Whether the removal of the workshops of the Marine Department to the mouth of the St. Charles is assured or not, we are not in a position to know. But, in view of the much-heralded improvements to the St. Charles, it is a moot question whether the location of the shops in that quarter will not interfere with the local and coasting traffic to facilitate which these improvements are intended. If the shops were removed to Wolfe's Cove or elsewhere, it might be better. We make a mistake if we think that congestion is expansion, and it would be just as well to look ahead and consider what will be the effect if the St. Charles site be chosen.

Another question which cannot fail to be of the most vital importance to the future of our port is the reorganization of our Harbor Commission. If we intend to make any showing in the "Battle of the Ports," which is a feature of transportation activities in these days, we must map out for our city a far more aggressive policy than has been followed in the past. To insure the carrying out of such a policy, we need a Harbor Commission reorganized on the same lines as that of Montreal—composed of three men who will be able to devote all their time and energy to the work of improving the harbor to cope with the demands of the future.

**A TIMELY MESSAGE.**

At the dawn of the New Year Archbishop Bruchesi, of Montreal, expressed the following wish:—

"If I record my thought for the last month, or, rather, for the year which has just passed away, when I take count of many things which it has been given me to hear or to read of in the daily press, it seems to me that the best message which I can address to my compatriots is to wish that during the year which is now opening they may know how to exercise their charity in the broadest and truest interpretation of the word."

These words of Archbishop Bruchesi are indeed timely when we consider the tendencies of the past year on the part of a few to inflame race against race and creed against creed by ill-considered appeals which were addressed particularly to the young and ignorant.

"We should recognize," continues Mgr. Bruchesi, "that there are, and always will be, differences of opinion between men. If we can realize this and know how to accord to those who differ from us, whether in politics, religion or other questions, the credit of being sincere in their convictions as we ourselves are, then we shall be better citizens and better neighbors."

"Because a man differs from us on religious or political questions, that is no reason why we should denounce him as our enemy, and he is none the less our neighbor."

Mgr. Bruchesi's words breathe a spirit of moderation, and his message may be called truly "Catholic."

**MONTCALMVILLE.**

It is generally recognized that the annexation of Montcalmville is now a matter of no very distant future, and it is equally certain that many of those who formerly regarded this project with disfavor are now inclined to regard it with approval. They have seen how Limouliou fared and consider the case of Limouliou as a good augury for themselves.

The advantages of such annexation would redound to the benefit both of Montcalmville and the city. In addition to other things the former would gain in the matter of light and fire and police protection, while the city would thus have a better water supply.

Perhaps it is the ambition of certain residents of Montcalmville that their municipality should be in the same relation to Quebec as Westmount is to Montreal. With all due deference to their ideas, we would suggest that the case is hardly a parallel. And it is hardly in accordance with the views of those who desire to see the expansion of Quebec.

It would undoubtedly be a good thing if the annexation of Montcalmville were fait accompli before the next census, and in all probability would give a considerable impetus to the rebuilding of Quebec. We know that some of the most prominent residents of the municipality would heartily welcome its inclusion within the city limits. All that is needed is a spirit of co-operation rather than of parochialism, and we would suggest that representatives of Montcalmville and the city should hold a meeting—public if possible—where the pros and cons of the subject might be duly weighed and met with reasonable consideration.

**AN EXCELLENT CHOICE.**

The nomination of Mr. George R. Smith, ex-member for Megantic in the Provincial Legislature, to replace the late Hon. Ward in the Legislative Council is likely to be as popular as it is well-deserved.

Mr. Smith is a practical, energetic and far-sighted man and has done much to further the mining development of the Province. He has played a prominent part in connection with various other enterprises and has been a member of the Boards of Trade both at Montreal and Quebec.

His personal character, his large experience, both in business and in the Legislature, will make him a most useful acquisition to the Council.

**PANAMA CANAL.**

It is said that the annual revenue from the Panama Canal will be \$4,000,000 or thereabouts, and that the annual cost of maintenance will be at least \$17,000,000. These figures are among the arguments that are being used by the opponents of the proposal to provide fortifications for the canal, at a cost of some \$20,000,000, which is to be dealt with by the United States Congress this month. A vigorous opposition to the proposal has developed. Both Admiral Dewey and Rear Admiral Evans are strongly opposed to the idea of fortifying the canal. The latter says: "Fortifications can be of no use against a blockading fleet. If a fleet should blockade the canal our fleet must come to meet it, and the canal is rendered inoperative until then." In other words, he considers that moving forts on the water will be worth more than stationary forts on land.

**DEDICATION SERVICE**

**Press Opinions**

**THE LONDON ANARCHISTS.**

It is difficult to sympathize with the British people in connection with the trouble they are having with the anarchists. As a deliberate matter of policy they have allowed these social hyenas to find a sanctuary in the heart of the metropolis of the most civilized nation in Europe, somewhat selfishly trading on the principle that, as the anarchists were driven out of every continental country, they were bound to subdue their natural instincts for assassination and crime when on English soil, because they had nowhere else to make their headquarters. For years past London has been the centre of the anarchistic propaganda. There the plots were hatched that resulted in the assassination of rulers and public men in various parts of Europe. Thither the assassins and their confederates fled for safety after committing crimes, if they succeeded in making their escape.

In some respects there is no greater social hypocrite than the average Britisher. With a fine Pockeniffian air of furnishing a sanctuary for political offenders, the British authorities have harbored these anarchists and protected them from proper retribution, because it saved trouble and had a tendency to safeguard the lives of British public men, owing to the fact that the anarchists maintained a tacit but criminal truce, on the understanding that they would not kill on British soil, whatever they might do in other countries. It has proved an effective if immoral insurance, because the anarchist knew that if they allowed their mad dog instinct to get the better of them they would be hunted out of their last refuge in civilization.

It must be said that the anarchists have kept their pact with the authorities. They might shoot down a French president or stab to death the innocent and beautiful Empress of Austria, or commit equally brutal and unjustifiable crimes abroad, but they kept the pact to the letter so far as Britain was concerned. But the anarchist business has been getting rather poor lately. Perhaps the funds contributed for "political" purposes have been running low, and one thing that drives people of the anarchistic persuasion to positive desperation is the prospect of having to do an honest day's work. So while they kept their tacit pact with the authorities on the higher order of crime, they no doubt felt at liberty to indulge in ordinary burglary, on the assumption that society owned them a living. It was equally natural that these social wild beasts, when interfered with by policemen, should shoot them down with as little compunction as they murder innocent people elsewhere. And it really could not be regarded as a breach of contract, because a poor bobby could not be regarded as a public man, in the sense of that contract. But the British hobby naturally objected. When he attempted to enforce the law against them he was met by the natural ferocity that has caused these people to be regarded as little better than mad dogs.

If the extraordinary scene which was enacted yesterday in the heart of London had taken place in St. Petersburg, the average Britisher would probably have held up his hands in horror at the authorities of a government that surrounded a building with troops and police, riddled it with rifle fire and machine guns, and ended by burning half a dozen gentlemanly anarchists alive. Of course there are any number of extenuating circumstances, but when these little affairs occur in poor, old, dumb Russia, the bare facts are made known to the world, and the anarchists are not infrequently regarded as heroes and political martyrs.

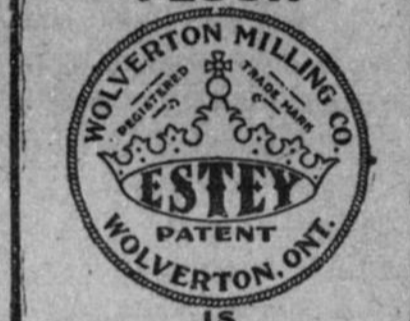
Canada has been inclined to accept stories of Russian cruelty and intolerance with a considerable dilution of saline matter ever since our own experience with the Doukhobors. Of course

these people are not to be regarded as in the same class with anarchists, but it is still vividly recalled that they were foisted upon the credulous Canadian government by certain British philanthropists, who, by the way, received a liberal per capita bonus, by working upon the sympathies of our public men by stories of their maltreatment by the Russian authorities, because these simple, pastoral people objected to being conscripted for military service, for conscience sake. Canada has had its own troubles with the more obnoxious elements of these people since then, and has had to have them herded by mounted policemen and treated more like cattle than human beings. Perhaps if the photographs which were suppressed in Canada had been circulated by agitators in some other country as illustrative of the treatment of the Doukhobors by Canadian Cossacks, this country might have got as bad a reputation over the affair as poor old Russia did in dealing with those people—Ottawa Citizen.

**MR. HYDE'S SHARP TRICK.**

New York, Jan. 4.—The Legislative investigating committee which has long desired to examine City Chamberlain Chas. H. Hyde as to his possible knowledge of methods used in the attempt to defeat the anti-race-track gambling bills passed by the Legislature in 1909, learned to-day that Mr. Hyde might be expected to return to the committee's jurisdiction about midnight on January 14. The life of the committee expires on January 15.

It is hereby ordered and enacted by the Municipal Council of the City of Quebec as follows:—

1. The following article is hereby added after article 32 of By-law No. 192, passed by this Council on the 22nd of December, 1895, to wit:—

No. 32 A—"It is forbidden under the same penalty as above to any boy, of less than ten years of age, and to any woman, or girl, to sell or offer for sale newspapers or any other articles in the streets of the said city."

### THE FIRST ENCYCLOPAEDIST.

Encyclopedias are an English invention, I hasten to add that they owe a great deal of their early and later development to Scottish brains. The earliest work was published in the second year of Queen Anne, John Harris, the "omnibeggetter" of this remarkable work, was born in the year of the great fire of London, and Shropshire proudly claims that he was a Shropshire lad. He passed through Oxford to the vicarage of Ickleham, Sussex, to which he added the care of Winesales parish, London preferences followed, and a Fellowship of the Royal Society, and a good deal of London religious controversy. For the rest, we know that Harris lived in a house in Amen Corner, and that he there received and boarded pupils. We know also that he gave free lectures in mathematics at the Marine Coffee House in Birch Lane. The Marine Coffee House has not been much noticed by London typographers. Mr. H. B. Wheatley has unearthed a curious advertisement proclaiming that water gruel was to be had there every morning from 6 to 11 o'clock. The announcement proceeds: "This is not yet generally known; but there comes such company as drinks usually four or five gallons in a morning."—John o' London, in T. P.'s Weekly, London.

### NO OLD FOLKS NOWADAYS.

Festivals were devised for youth. After twenty nobody enjoys Christmas, except in making other people enjoy it. This I have known for twelve years, and now I find myself upon a further discovery; that after 30, New Year's Day is not so much a promise of good things to come as it is a reminder that a man must hurry if he is to get the best of the good things that preceding New Year's day's promised him.

Is this a symptom of the disease that we call modern life? I think it is. I think that our great-grandfathers did not feel as we do. I think time was more kindly to them. And I think that I have found the reason why.

When we were all boys and girls together there used occasionally to be caught a word that declared that men and women had lost the art of growing old gracefully, and we younger people were given vaguely to understand that it was a sad deprivation.

Now all that is over. Our generation has lost even the sense of loss. Not only do we not grow old gracefully; we do not grow old. We live among deeds so intensely that we forget facts, among actions so rapaciously that we escape thought. We do not grow old; we commit only the bourgeois banality of growing middle-aged.

It used to be the easiest thing in the world to grow old. All that you had to do was to fold your hands and wait. But now it is a curiously conscious and painfully intellectual process of which most of us are wholly incapable. Where are the old lavender ladies in lace caps, the old ladies with delicate folded hands and faces calmly sweet of whom our fathers told us? Where the white-haired gentlemen who quoted Horace over their morning bacon and greens and read their school Virgils in the sunset of their peaceful lives? The snows of Villon's yesteryear are not more utterly vanished.

### OTHER COUNTRIES ABROAD.

Many striking events occurred in the other countries of the world sufficient to impress 1910 upon the memory of their inhabitants. In France floods in the valley of the Seine which flooded Paris, turned Paris into a second Venice, and caused untold damage would have been sufficient but there was also the great railway strike which threatened to cripple the whole country until it was taken in hand by the government in such masterly fashion as to bring it to an immediate end. Minister Ducey was accused of misappropriating \$1,000,000 government funds.

In Berlin there was the great bricklayers' strike and the suffrage riots during which a number of journalists were brutally attacked by the police, who were afterwards forced to apologize. The emperor also gave two outbreaks, which Punch described as flights in which he reassessed his "divine" rights. The first at Konigsburg led to considerable trouble, the second in November merely to amusement. The German naval estimate showed an increase of \$5,000,000 over any previous year.

Japan calmly annexed Korea and not a word was said by the other powers.

Spain and Portugal changed and changed about with threats of revolution until in October Portugal revolted against the crown and the monarch was forced to flee to England where he found refuge at Wood Norton. The revolution was of short duration, and comparatively free from bloodshed.

In October two other monarchs, the King and Queen of Italy, were once more engaged in going to the succor of their subjects. Naples was suffering from a cloudburst by which many people were rendered homeless and massive buildings destroyed. Mount Aetna erupted and also caused widespread damage.

The throne of China acceded to the request of the people and granted a constitutional parliament.

The floods on the continent of Europe spread very generally, and at various times portions of Italy, Switzerland, Germany and Hungary were reported as being under water. This was one of the things charged by many to the comet.

The Brussels exhibition which had been opened by the King of the Belgians was practically destroyed by the fire in August and over \$10,000,000 damage was done mostly to the British section.

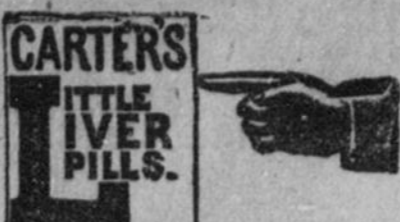
Riots and revolutions commenced in Mexico in June and are still proceeding, and an opera bouffe revolution was carried out by the Brazil sailors at Rio de Janeiro in November, when they captured their officers and turning the guns of the vessels on the city threatened to bombard it, and to destroy the battleships if their terms were not granted. Their terms were promptly acceded to.

The "Mad Mullah" had his usual forays against the British and was successfully reported as "killed" the customary number of times.

In Russia harrowing scenes were witnessed throughout the year owing to a decree expelling the Jews.

Families were broken up and homes destroyed, and Jews were badly treated in all parts of the country.

Worthily also of comment was the fact that Emperor Menelik took his first ride in an automobile during the year 1910 now departed to the days of history.

### STRANGE STORY OF A FRENCH ATTORNEY.

(By Canadian Press.)  
New York, Jan. 4.—Louis de Beauval, a French attorney serving sentence in the Auburn State Prison, believes himself to be the victim of an official conspiracy, and so strangely has he presented his case in a letter to Justice McCall of the Supreme Court, that he will be given a chance to tell his story in court. Justice McCall to-day signed a writ of habeas corpus returnable before Judge Benon in Auburn. In his appeal de Beauval describes with many adjectives how he was "skimming along the St. Lawrence in his motorboat" when two men appeared in another launch and after deceiving him to one of the Thousand Islands in "nature's bower" robbed him of \$1,000 in Canadian money. The men turned out to be constables, he writes, and after subjecting him to many indignities arrested him for the theft of the launch, a charge on which he was convicted through an alleged conspiracy on the part of "the sheriff, magistrate, a fire commissioner, a district attorney and a county judge."

### BANKER ROBIN COMMITTED TO JAIL WITHOUT BAIL.

(By Canadian Press.)  
New York, Jan. 4.—Jos. G. Robin, banker, promoter and financial operator of large undertakings, was lodged in the Tombs to-day on an indictment charging him with stealing \$80,000 from the Washington Savings Bank, of which he was president. On his plea of not guilty bail was fixed at \$40,000. Robin's counsel, former District Attorney Jerome, told the court that his client was without a dollar in the world. Jerome made no effort to delay arraignment on the indictment and offered no defense, but strenuously resisted the raising of bail. Hearing on the petition of Robin's sister to have him declared insane is set for to-morrow. The banker was subjected to-day to a trying mental examination by alienists employed by the Prosecutor.

Friends of the prisoner appeared after the commitment with offers of bonds for his release. The District Attorney announced that he would take the full 48 hours allowed by law to examine the security offered. In the meantime the man whose operations are alleged to have caused the suspension of the Northern Bank will remain in prison awaiting action on his sister's petition to have him adjudged insane.

THE CASE AGAINST OCEAN STEAMERS

Brought by U. S. Government Is a Serious One, Says District Attorney Wise.

(By Canadian Press.)

New York, Jan. 5.—In a reply to the complaint filed yesterday by the Federal Government against thirteen of the principal transatlantic steamship lines and twelve of their officers, Vice president P. A. S. Franklin, of the International Mercantile Marine Company, one of the defendants, intimated that the suit was a friendly one, in the nature of an act in equity, and brought to determine what rights the companies had in co-operating to regulate their business.

Mr. Franklin's statement, in part, follows: "Last spring the Government began an investigation. The lines informed the United States attorney that if any of the practices were illegal they were perfectly willing to discuss the same. The matter, we believe, was referred to the Attorney General and, it being thought that there was doubt as to the legality of certain ways in which the steamship lines were doing business, it was determined to bring an equity action which would raise the whole question of the legality of the practices, and we understand, this suit is the result."

"Of course, as to the legal and technical points involved, we are not sufficiently familiar with the law to pass upon these. But looking at the matter as practical business men, it seems to us that ocean carriers can never have a monopoly of their business because the ocean is free, and any person with capital can enter into the business with ease. The railroad has a comparative monopoly of the territory it serves, while in the case of ocean carriers all the territory is competitive. The steamer business is a very peculiar one and must be handled by the united action of all the lines in order that serious abuses may not enter into it and in order to properly protect the interests of the immigrant. Passengers for ocean steamers come from parts of the country far removed from the port of embarkation and the steamship lines must have thousands of agents all over the various countries. These agents, accordingly, cannot be paid salaries, but have to be remunerated by the means of commissions. In this competition for business, many of the agents were splitting their commissions and so some of the passengers were getting a rebate, or, in other words, there was the same discrimination in the steamship business as there was in the railroad business before the Interstate Commerce law was passed. The lines have felt and still feel that all they have been doing and that is being done is entirely legal and is in reality for the best interests of the steamer passengers, but if it is determined in this suit that any of the practices are in violation of the law any way they shall be only too glad to cease such practices."

CANADA AND NEWFOUNDLAND

The Countries Not Likely to Unite, Says the Premier of the Latter.

(By Canadian Press.)

Boston, Jan. 5.—Sir Edward Morris, Premier of Newfoundland, who was entertained at the Chamber of Commerce to-day, said that he anticipated no trouble with the Gloucester fishermen. Regarding trade relations between Newfoundland and the United States, the Premier said: "If reciprocity between the United States and Newfoundland comes within the realm of reasonable diplomacy, my country will participate. Newfoundland has 3 or 4 items to offer the United States, the value of which is not to be disregarded. The first is an enormous catch of codfish, the distribution of which through the inland states of this Union would help materially, in my opinion, to solve the question of the high cost of living. At the present time the United States stands first in the list of countries from which Newfoundland obtains her imports."

Sir Edward smiled when asked if Newfoundland was likely to unite with Canada, and remarked that this is less likely than ever. "The question," he said, "has not been a plank in the platform of any party in the island for forty years. In Newfoundland the idea is not at all an agreeable one to the people, and the fishermen think that confederation would be disastrous to them. Canada would have little to offer them by way of inducement that would prove of any lasting advantage to the country or to the people, and as Newfoundland's prosperity increases there is a correspondingly equal reduction in the possibilities of any such political departure."

BRITISH VS. AMERICAN TOURISTS.

The talk arose as to the difference between the American and the English tourists, and the solemn Englishman averred that he saved up his money and went abroad on his interest. COINAGE OF GOLD IN UNITED STATES

System to Be Adopted Similar to That in Vogue in England.

(By Canadian Press.)

Washington, Jan. 5.—Secretary MacVeagh's plan to practically stop the coinage of gold and permit the Treasury to issue gold certificates against gold bullion and foreign gold coin, promises to become law at this session of Congress. Under the present law the mints spend \$300,000 to \$400,000 a year stamping gold bullion into coin which is then stacked away in vaults, while gold certificates representing it are circulated. At present, of the \$980,000,000 of gold coin in existence in the United States, \$932,000,000 is stored in the Treasury vaults and probably never will be called for in that form. The present law also requires the millions of gold coin which come to this country in payment of foreign trade balances, to be received in our money, before they can be put into circulation by the medium of certificates. In twenty years it has cost \$800,000 to recoin foreign gold in that way. Secretary MacVeagh's idea is to issue certificates against the gold bullion and against the foreign coin itself, as is now done by England, Germany and France. He points out that the enormous cost of coinage practically will be abolished and the gold for export will be held in convenient form.

CANDIDATES FOR THE PRESIDENCY OF CUBA. (By Canadian Press.)

Havana, Jan. 4.—Alfredo Siaz, Vice-President of the republic, announces his candidacy for the Presidency, with the support of Major Gen. Pino Guerra and his brother, Col. Ramon Guerra. General Loynaz del Castillo, now Minister to Mexico, announces the candidacy of General Eusebio Hernandez for President and his own for Vice-President. Hernandez is the leader of the Miguelites and former head of the Cuban Democratic party. General Loynaz del Castillo declares that any attempt on the part of President Gomez to secure a renomination would be the instant signal for a civil war. Senor Ferrara, Speaker of the House of Representatives, reiterates in behalf of General Gomez the President's firm resolution to accept a renomination.

In military matters, the late Mr. Higgins was well versed. For many years he had been a member of the 8th Royal Rifles. Always a faithful member of the corps, he watched, after his retirement, the regiment with an esteem and interest that will never be forgotten. Not alone in military circles will Mr. Higgins be missed. He also took a keen interest in fraternal and other societies, among them the Masonic order, which conferred upon him many high honors, and among the whole fraternity of the Quebec district and Province there will be universal sorrow at the news of his death. With the family of the deceased all will unite in sympathy at their great loss, for as a man and a brother there were few who had these principles so much at heart and who at all times endeavored to live up to them. Mr. Higgins was an old and well-known resident of Quebec, and universally esteemed by all who knew him.

Canadiens are coming to Quebec with "Newsy" Lalonde under the full impression that they can reverse the Renfrews' fate, and the result of the Renfrews' fate, and the contest between the fast French-Canadian team from Montreal and the locals will be one that is sure to be interesting.

RESERVED SEATS FOR CANADIEN-QUEBEC MATCH.

The plan will open at the rink this (Friday) afternoon at 4 o'clock for the great senior championship hockey match, Canadien vs. Quebec. The 50c and 75c tickets will also be on sale.

RENFREW PUTS IN PROTEST AGAINST SMAILL

Montreal, Jan. 5.—The Renfrew protest, which was filed with President Quinn before the team left the rink, is based on section 4 of the rules. The rule states that players may be changed at any time in the first two periods but that substitutes must be placed on the ice and the game proceed without any interruption as a result of the change. As Gardner had 30 seconds of a penalty to serve when the second period ended, Renfrew officials last night claimed that the rule was being violated when Smail was not eligible to go on the ice before the second period ended. The point will offer a ticklish argument for the league.

OTTAWA WILL MEET WANDERERS SATURDAY.

The Ottawa-Wanderer match at the arena at Ottawa to-morrow night will be the main feature of this week's sport programme. It is estimated that between five and six thousand people will take in the tit-bit attraction of the puck-chasing campaign. Ottawa tickets will sell this week like hot cakes, and the club intends to take the usual precautions to guard against speculators.

It is probable that Russell Bowie and Duncan Campbell will be the officials.

President Emmett Quinn of the National Association expressed the opinion that Ottawa would not go into the game without Bruce Stuart. Hundreds of Ottawa fans are also praying for the return of the "championship kid," but as Bruce has not handled a stick since last winter it is not at all probable that he will be in uniform, although it is doubtful if the present Ottawa team can down the Red Hands.

HANS HOLMER'S NEW LAURELS

Great Race by Former Quebecer, Who Set New Marathon Record.

In connection with the great race of Hans Holmer, at one time a member of the R.C.R. in Quebec, who set a new record for the Marathon distance on the Powder Hill grounds in Edinburgh, it may be stated that the Powder Hill handicap is one of the big athletic features of the world and is eagerly sought after. The distance is the full Marathon of 26 miles 385 yards.

It is the first time a Canadian ever ran in this event. Holmer turned professional a couple of years ago. He was a candidate for the Marathon race for Canada in England in the Olympic games, but did not catch a place. Recently he has been paired with Quail, of Alexandria Bay, Ont., in relay races at New York. He has won the Hamilton Herald race and has run at the Island a couple of times. He is a strong, powerful runner.

The race divides £500 three ways and is well worth winning. The amateur Marathon record is 2.36.26 1/2, by Maloney, of New York, and the best over the London Olympic course 2.43.31. The best professional record is 2.32.39 1-5 by St. Yves at Seattle.

THE ALMANAC WAS GUILTY.

Compilers of almanacs in France are legally responsible for the accuracy of their predictions. This point was determined by a case tried in the days of Louis Philippe. Ouvard, a well-known army contractor, fell into difficulties and was severely pressed by his creditors. According to French law, debtors cannot be arrested between sunset and sunrise. One evening Ouvard sallied forth in quest of fresh aid and was seized by a bailiff as he stepped out of his house. He protested, and produced an almanac showing that it was three minutes past sunset. The bailiff produced another almanac, showing that the sun did not set for another nine minutes. On his release from prison, Ouvard sued the publisher of the almanac, which had misled, and obtained damages.—London Chronicle.

A PRAYER FOR 1911.

The Bishop of Nova Scotia prepared for the Halifax Herald the following prayer for 1911—

"O God, who providest for thy people by Thy power and rulest over them in love, we bless Thee because Thou hast brought us safely to the end of another year. We bless Thee for the continuance of our life and for the many undeserved mercies which daily supply our wants and gladden our hearts.

"We yield Thee unfeigned thanks that Thou wast pleased to set Thy servant, our Sovereign Lord King George to reign over us. Let Thy wisdom be his guide, and let Thine arm strengthen him. Let truth and justice, holiness and righteousness, peace and charity abound in his days. Direct all his counsels, and those of his representatives throughout the empire, and more especially those in this land in which we live, that they may tend to Thy glory and the welfare of the people.

"Pardon all our misuse of Thy mercies, our misspent time and manifold sins. Give us grace to begin the New Year with renewed desires to serve Thee and more earnestly to fulfil Thy Holy Will, that every one may realize his responsibility and do his part in strengthening the empire by building firmly upon the foundation which Thou hast given us in our Lord and Saviour Jesus Christ. Amen."

The point will be made that although Gallagher may have shot "with intent to kill," he did not intend to kill Commissioner Edwards, as is specifically charged in the indictment. Gallagher has never been indicted for his attempt on the life of Mayor Gaynor. The prosecutor's office decided to wait for a year and a day to make sure that Mayor Gaynor was out of danger.

AIRSHIP STILL LACKING.

New York Tribune.—"Air men are devoting themselves exclusively to their vessels, almost neglecting the element in which they move. The record of the last year should be a sufficient warning. Aeronauts have developed their technical skill without attaining a corresponding degree of atmosphere airship. Until that is gained the conditions of flying contests ought, if possible, to be regulated by restrictions which would at least diminish the risks which reckless men are willing to run for the sake of gratifying crowds of sensation lovers and earning huge fees."

PETER, THE PAINTER, STILL AT LARGE

Was Not in the House Which Was Burned in London Fight.

(By Canadian Press.) London, Jan. 5.—According to the latest report the burglar killed in the Houndsditch affray and the two men killed in the Stepney battle were members of a gang of a least 29 aliens of the same type and character, some of them being women. Owing to the bewildering number of aliases they have adopted the police are finding an almost insuperable difficulty in tracing them. "Peter the Painter" is still at large, it having been established that the second victim of the Stepney siege was a Russian terrorist who fled to England eleven months ago under the name of Jacob Fogel. He was 22 years of age and a native of Kolvno, Lithuania. With the exception of these particulars the police have not yet unravelled the crimes or discovered the actual connection existing between the Houndsditch affair and the Beron murder.

Topics of the Day

The Hundred Years of Peace.

Highly commendable is the proposition of Mr. Wurtelle that the United States should celebrate the century of peace by withdrawing the warships of that country from the lakes. There are other proposed means of observing the centenary. All have their good features. But none interfere with the carrying out of Mr. Wurtelle's idea. The removal of the ships, in fact, might be made a part of whatever ceremony may be determined upon. It is of interest to note how diplomatically the process of creating a lake navy has been carried through. At the outset our neighbors were met by the Rush-Bagot agreement which prohibited the presence of warships of either country on the lakes. To nullify this bargain it was at first proposed so to widen the Erie Canal that war vessels might be brought into the lakes at any time. This was an expensive process. Another manoeuvre was therefore devised. Unarmed vessels for training purposes were to be brought through our canals. These ships were sent west, one every year, with the consent of our Government, until now there is a fleet of eight fully armed vessels in the area which the Rush-Bagot agreement dedicated to commerce and to peace. That the understanding has been violated there can be no question. That our Government

weakly consented to the violation is also certain. That there should be a return, and that without delay, to the old conditions everybody must admit. The centenary of peace cannot, therefore, be better observed than in the enforcement of the terms of the Rush-Bagot agreement. That agreement might well be turned into a treaty as Mr. Wurtelle proposes, and contemporaneous with the signing of the convention the warships, which ought never to have entered the lakes, might pass in procession to the sea, amidst the cheers of the citizens of both countries. If we are really glad that we have peace, and are anxious to continue the happy conditions under which we live, what is the use of retaining on the lakes these engines of war.—Toronto Mail.

CARRIED ALOFT BY KITE.

A large box kite which he received for a Christmas gift carried 9-year-old George Harpell, of Minerva street, Roxborough, on an unexpected trip toward the clouds, and he might have been flying yet had it not been for the friendly branches of a tall and spreading chestnut tree, which the boy embraced as he was flying skyward. For several hours the boy clung to the tree while the kite pulled and wedged him tightly between the branches. The Roxborough hills are said to be on a level with the City Hall tower, and the wind and cold were in accordance with the elevation. It was not until the thick rope attached to the kite cut his benumbed hands that he let the little aircraft go. Shortly after it was released he was rescued. The boy did not have an opportunity to test the kite on Sunday, so immediately after his breakfast Monday morning he went out on the hills near the porch-house and started to raise it. A stiff wind was blowing and the kite readily took all the rope "fed out." In fact, it took the rope so quickly that before Harpell could unwind some of it from his wrist it took him, too. When his feet left the ground he was dazed, but when he recovered himself he was about 20 feet above the earth. He intended to let go then, but a quick glance showed him that he was directly over a stretch of hard and jagged ice. He went fully ten feet higher before he started to struggle, and his jerks brought the swiftly moving kite over toward the friendly tree. When he was within arm's length of it Harpell grasped wildly at a friendly limb and held fast. Then he worked his legs over. Despite the unexpected raise, the youngster held on to the tree with one hand and clutched the rope of the struggling kite with the other. The tree was an especially tall one, higher than the nearby house tops, in fact, and as the branches were not obligingly situated the boy concluded to wait until he was discovered. While he spent the afternoon hours in the cold, all kinds of rumors were reaching his home. One was to the effect that George was seen flying over the Schuykill in tow of the kite, while others were that he was going in the direction of Chestnut Hill. His relatives and boy companions scoured the hills and woods until near nightfall, and finally James Brogan, a neighbor, who was making a short cut over the hills, heard his cry for help and rescued

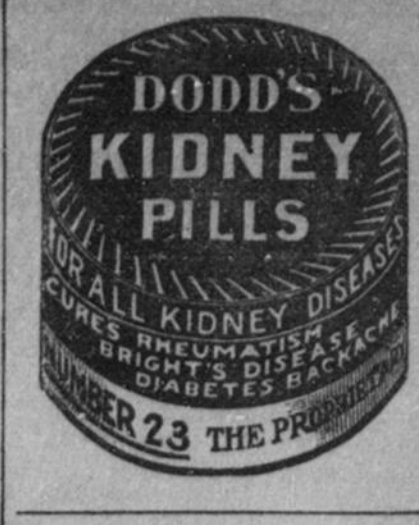

THE SITUATION IN HONDURAS

Movements of the Revolutionists — Government Will Negotiate a Loan.

(By Canadian Press.)
Puerto Cortez, Honduras, Jan. 4, via wireless to New Orleans, Jan. 5.—The Honduran revolutionary expedition headed by Manuel Bonilla to-day arrived at Bay Island and established a base of operations off Ruatan Island, one of the small group lying about 100 miles from this port and about 40 miles from La Ceiba. The actions of the expedition are keeping every one puzzled, as it is not apparent just what move is to be made.

RECOVERING HIS MEMORY. (By Canadian Press.)
Yonkers, N. Y., Jan. 5.—The victim of aphasia in St. Joseph's Hospital here, who was found yesterday in the Y.M.C.A. Building without memory of his identity, now recalls that his name is Stanley Walbridge, of Cobalt, Ont. This agrees with the papers found in his pockets last night. He believes that he is a graduate of McGill University, of the class of 1883, but is not sure. Much of his past is still vague to him.

WOODSTOCK BOARD OF TRADE OPOSED TO RECIPROCIITY.

(By Canadian Press.)
Woodstock, Ont., Jan. 5.—Reciprocity with the United States and the tariff generally were under lively discussion at a well attended meeting of the Board of Trade to-night. Addresses were delivered by prominent business men after which the following resolution was unanimously passed: "Resolved, That this Board of Trade stands for the maintenance of the present tariff on manufactured goods and is unhesitatingly and unalterably against any reciprocity treaty with the United States in manufactured products, and urges the Government not, at this time, to lower the tariff duties or enter into a reciprocity treaty with the United States respecting manufactured products." It will be forwarded to the Minister of Finance.

THE SUPERIOR DIVISION OF THE TRANSCONTINENTAL.

Ottawa, Jan. 5.—J. D. McArthur, contractor for the Winnipeg Superior Junction Division of the Transcontinental Railway, is in the city. The line is being operated, but has not been finally taken over. It is said that the deductions in respect to their contract on account of over classification will be near \$275,000, which is more than previously estimated. The connection of Ottawa with the G.T.P. is not finally decided, but President Hays has suggestions to build a line from a point in northern Ontario across the country to Arnprior or Carp, on the existing Western Division of the G.T.P., for which the company holds a charter, or a branch in a straight line from Arnprior to Ottawa. The Canadian Pacific Railway also has authority to build an extension of the Gatineau Railway through to James Bay intersecting the transcontinental railway.

ALBERTA'S DISPUTE WITH THREE BANKS

The Fight for \$7,400,000 Great Waterways Money—Union Bank's Action in Case.

(By Canadian Press.)
Edmonton, Alb., Jan. 5.—The fight for the \$7,400,000 of Alberta and Great Waterways moneys deposited in the Royal, Union and Dominion banks is now on. This morning an appearance to the action brought by the Alberta government by the above banks to compel payment of these moneys was entered by Dawson, Hyndman & Hyndman, on behalf of the Royal Bank, and by J. E. Wallbridge, acting for the Dominion Bank. The Union Bank people are pursuing a different course. They apparently intend to pay \$1,000,000 of these moneys on deposit with them into court, withdraw from the dispute and let the different claimants of the money fight it out among themselves. This morning, through their solicitors, Short, Cross & Biggar, they applied for and were granted a Chamber summons calling upon the parties interested to appear before Mr. Justice Beck in Chambers on January 27 and put forward their claim in support of the application. The affidavit of John J. Anderson, manager of the Union Bank, was filed. The affidavit states that the applicants do not collude with the Alberta and Great Waterways Railway, the Canadian West Construction Company or the Standard Trust Company, who are trustees for the bondholders of the railway. This inter-pleader will give the Alberta and Great Waterways Ry. and the construction company an opportunity to make a fight. The opportunity will no doubt not be overlooked. According to Montreal despatches J. Pierpont Morgan may be drawn into the dispute.

MINOR NOTES OF THE DOMINION.

(By Canadian Press.)
St. John, N.B., Jan. 5.—Word was received here to-night that the body of Charles Collins, of Erin street, this city, was found in a brook near Hampton, about 20 miles from here to-night. Collins, who was about 25 years of age, left his home here early this morning and his brothers were much startled when they heard of his tragic end. The Hampton authorities think it is a case of suicide and an inquest will be held. St. John, N.B., Jan. 5.—Thirteen young men, arrested here as a result of New Year's riot, were committed for trial to-day in the Supreme Court, which opens here Tuesday. They were released on \$2,000 bail each. Montreal, Jan. 5.—McGill hockey team will leave here to-morrow for Boston and New York to play exhibition games with Harvard and the Crescents. The first game will take place Saturday, the second Monday. Eleven men, including all of last year's septette, will make the trip, but the lineup has not yet been chosen. The student team will be the strongest that McGill has been able to put on the ice for many seasons.

Brockville, Ont., Jan. 5.—A number of Grand Trunk conductors, some of whom have been laid off since the strike, were called to Belleville to-day to report for duty. Of those convicted in the police court for misconduct during the strike, not more than half a dozen conductors and trainmen at this divisional point are still out of employment.

Winnipeg, Jan. 5.—Canon Jeffrey leaves Saturday for England via Montreal and Halifax in the interest of the Church of England in the West in connection with the colonial and continental missionary society and to induce suitable young men to enter the mission field of the church in the West.

Winnipeg, Jan. 5.—The City Street Commissioner, who has been investigating the car service, condemns overcrowding of cars and bunching of cars which he says can be remedied by improvements at all junctions and terminals. He further recommends three new lines, two of which would parallel Main street and Portage avenue where concentration of all lines reached the limit of convenience.

Port Arthur, Jan. 5.—Severe weather has played havoc with the passenger service on the C.P.R. The Toronto train due at 12:42 was one and a half hours late. No. 95 due at 12:27 midnight did not get in till 5:25 a.m. while No. 96 due last night at 11:30 did not come in until 2:15 this morning. Rigorous weather is reported from all points on the C.P.R.

Halifax, N.S., Jan. 5.—Wreckers are bringing up iron that they are salvaging from the steamer Hungarian, of the Allan line, lost in the year 1860, on the coast of Nova Scotia. A cargo of this iron was brought to Halifax to-day. Years ago a large quantity of iron was saved from the Hungarian, but it did not pay in the long run and work ceased. The price of scrap iron now makes the operation profitable.

Brighton, Ont., Jan. 5.—Galt Granite Rink, skipped by Skip Taylor, won the New Hamburg cup to-day from the Brighton Rink, skipped by Kerr, 18 to 14. Bright has held the trophy for two years.

Woodstock, Ont., Jan. 5.—Before Judge Snyder left Woodstock to-day he stated to D. O. Cameron, barrister, who worked up the case for the county in the initial stages of the graft investigation, that he would likely have his report practically completed by the time the last witness is examined in Hamilton on January 16. This means that the report of the commission will be in the Attorney-General's hands in about 10 days. If the findings do not result on action by the County Crown Attorney it is likely that civil actions will be commenced against those alleged to have received graft.

HE STILL FORGETS.

MANY MINERS ARE RETURNING TO WORK.

Halifax, N. S., Jan. 5.—The situation at the Port Morien mine of the Atlantic collieries, where the men ceased work because of a cut in wages, has considerably improved during the past few days and little trouble is now anticipated. A number of the men have returned to work and accepted the reduction, though there are still many of the miners idle. A number of officials of the U. S. W. are in Cape Breton, among them President Walkin, of Springfield, and it is said the U. M. W. through its solicitor, have notified the Atlantic collieries of their alleged acceptance of the Lemoine act, but it is probable that all the men will be back at work within the next few days.

INTERESTING ADDRESS BY SIR WILFRID

The Premier Gave History of "Fur Trade in Canada" at Chateau Yesterday.

The members of the Women's Canadian Club of Quebec turned out in full force at the Chateau yesterday afternoon to hear Sir Wilfrid Laurier lecture on the "Fur Trade in Canada."

In the absence of Mme. Grondin, Mrs. Benyon presided over the meeting. Sir Laurier Gouin, Sir Louis Jette, Bishop Hunter Dunn, Dean Williams, Senator Choquette, Hon. L. A. Taschereau, Judge Carroll, Captain Benyon, Rev. F. G. Scott, Messrs. J. P. Burstall, J. B. Hants, Frank Carrel, P. J. Paradis and others. Mrs. Benyon, in introducing the Prime Minister in French and English, said that the introduction was a sincere and spoke of the good fortune of the club in being able to prevail on such distinguished authors to lecture before them.

Sir Wilfrid, in his opening remarks, regretted the absence of Mme. Grondin, but expressed his pleasure in being received by so good a substitute as Mrs. Benyon, whom he had known from childhood, and whose father, the late Mr. Thibaudau, had been one of his personal friends.

Beginning his lecture, Sir Wilfrid discussed the early days of exploration in Canada, and gave a graphic description of pioneer life and the gradual spread of commerce with the Indians. From the first history of the fur trade had been a history of monopoly, and this condition of affairs had given rise to the reckless, swaggering and picturesque coureurs des bois, who lived a life of practical outlawry but had yet done much for the early discovery and commerce of the country.

Sir Wilfrid paid a tribute to the contributions made by Francis Parkman to the literature of the coureurs de bois, and read from his "Oregon Trail" the description of Parkman's two French-Canadian guides on his memorable trip over the prairies in 1846 to the Rock Mountains. These descriptions might stand for those of typical coureurs de bois. Of Henry Chailion it was said "He was a fine athletic figure, mounted on a hardy gray Wyandot pony. He wore a white blanket coat, a broad hat of felt, moccasins and trousers of deer-skin, ornamented along the seams with rows of long fringes. His knife was stuck in his belt; his bullet-pouch and powder-horn hung at his side, and his rifle lay before him, resting against the highommel of his saddle, which, like all his equipments, had seen hard service, and was much the worse for wear."

"Deslauriers," the other guide, "brought up the rear with his cart, wading ankle-deep in the mud, alternately puffing at his pipe and ejaculating in his prairie patois, 'Sacre enfant de —,' as one of the mules would seem to recall before some abyss of unusual profundity. The cart was of the kind that one may see by scores around the market place at Quebec, and had a white covering to protect the article within." When he took leave of the "bourgeois," Parkman thus related the incident: "Deslauriers was on the rock at the landing place, waiting to take leave of us. 'Adieu, mes bourgeois, adieu, adieu,' he cried as the boat put off; 'when you go another time to the Rocky Mountains, I will go with you; yes, I will go.' Chailion accompanied Parkman and his friend as far back as St. Louis. 'No one who met him in the streets of St. Louis,' he said, 'would have taken him for a hunter fresh from the Rocky Mountains. He was very neatly and simply dressed in a suit of dark cloth; for although since his 16th year he had scarcely been for a month together among the abodes of men, he had a native good taste which always led him to pay great attention to his personal appearance. His tall athletic figure with its easy flexible motions appeared to advantage in his present dress; and his fine face, though roughened by a thousand storms, was not at all out of keeping with it. He had served us with a fidelity and zeal beyond all praise. We took leave of him with regret; and unless his changing features, as he shook us by the hand, belied him, the feeling on his part was no less than on ours."

Passing to the history of the Hudson Bay Company, the Premier described the remarkable charter granted by King Charles II., in 1670, to Prince Rupert and his associates, known as "The Company of Adventurers Trading Into Hudson Bay," and compared it with that granted to the East India Company. The series of conflicts between the Hudson Bay Company and its rivals were hurriedly described, with the final fusion in 1821 of the company with its most serious rival, the North-West Company. In 1869 the Hudson Bay Company made a formal cession to the Government of its remaining territorial claims, receiving therefor from the Dominion Government an indemnity of a million and a half of dollars. The company moreover retained all its forts and a certain portion of land sur-

rounding each, besides one-twentieth of all the land in the territory ceded to the Government. By the shrewd selection in alternating blocks of the lands in question, the company now found itself in possession of very valuable property.

Sir Wilfrid mentioned in succession the names of many of the pioneers in the Old North-West Company, and described the course followed by some of them in their passage from Montreal to the great Northwest, by way of Lachine, Ste. Anne, the Ottawa, Matawa, the Georgian Bay, Lake Superior, etc.

Roderick McKenzie, who arrived in Canada in 1784, embarked five years later at Ste. Anne's, and in speaking of his departure from the place wrote "St. Anne's Church was the last church on our route, and the voyageurs, in consequence, generally drop a piece of money into a box there, as an offering, to secure the protection of La Bonne Ste. Anne during their absence, and I, with a view to do as the people of Rome do, joined my mite to that of the rest of the crew." The speaker quoted in English the words of the Canadian boat song as written by Thomas Moore, and in connection with Roderick McKenzie's references to the place, subsequently reading the late L. H. Frechette's translation of the lines into French, with which he had been favored by Mgr. Mathieu, expressing the hope that they would appear in any future edition of the poet's works, as they richly deserved to do.

A charming description of the different ranks in the North-West Company was given, namely the bourgeois, the clerks and the voyageurs.

Of the bourgeois, Washington Irving was quoted as referring to the great solemnity of their meetings at Fort William and elsewhere.

In connection with the clerks, references were made to the severe discipline maintained in their regard.

Among the many big fur traders connected with the city of Montreal, special reference was made to Mr. Chaboulier, whose name was perpetuated among the place names of the metropolis.

The old Beaver Club, of Montreal, with its strict exclusiveness and generous hospitality, which had left its name to Beaver Hall and the hill which led to it was also noticed. The club was founded in 1785, and originally composed of only 19 members. It remained until 1824, and its joyous fortnightly reunions have been described by various participants therein. Distinguished strangers were always cordially welcomed within its hospitable portals, but none were eligible for membership, but those who had experienced the vicissitudes of the Northwestern fur trade.

Before closing, the speaker gave a summary of the more important bibliography of the fur trade. In the first and earliest place he mentioned those in valuable sources of the beginnings of Canadian history, the Relations des Jesuites. These came the works of Champlain, Les-carbot and Charlevoix. In English, first place was accorded to the Journal of Alexander Henry, giving an account of his travels and adventures in Canada and the Indian territories between the year 1760 and 1776.

Henry was born in New Jersey and took part in Amherst's expedition, having been present at the capitulation of Montreal. He traversed the Northwest in all directions in the prosecution of the fur trade and died at Montreal in 1824 at the age of 84 years. An admirable history of the fur trade in Canada up to the commencement of the nineteenth century was to be found in Alexander Mackenzie's "Voyages from Montreal on the River St. Lawrence," through the continent of North America, to the frozen and Pacific Oceans, in the years 1789 and 1793, with a preliminary account of the rise, progress and present state of the fur trade of that country. Sir Alexander Mackenzie was born in Inverness about 1755. In 1779 he entered the counting house of one of the partners of the North-West Fur Company. After two years' experience among the Indians of Fort Chippewyan he was sent to explore the unknown Northwest region, and after a canoe journey of 102 days attended with infinite danger, he reached Great Slave Lake, discovered the great river which bears his name and descended it to the Arctic Ocean, subsequently retracing his steps in safety. He died in 1820. Very valuable material is contained in the two volumes of the late Lieutenant Governor L. R. Masson, entitled "Les Bourgeois de la Compagnie du Nord-Ouest." Mr. Masson's first wife was a daughter of Roderick Mackenzie, of the old North-West Company, of whose archives, consisting of important diaries and correspondence, he thus became possessed. Sir Wilfrid also made pleasant reference to the exceedingly important historical work of the Abbe Dugas on L'Quest Canadien, and on the history of the "Hudson Bay Company," by Professor Bryce, a Presbyterian minister.

Sir Wilfrid declared, in conclusion, that he had been led to select the subject of his address from his constant desire to extend the fame and the glory of the Canadian people and nation, for the history of the Canadian fur trade was one of the most thrilling and most romantic chapters in Canadian history.

Men from the Province of Quebec had played an important part in the fur trade and the explorations and development of the Northwest, and also in the remarkable history of those stirring events.

This province had been itself the scene of great commercial industries, and he

expressed the hope that historians would be found to do justice to the thrilling stories of the great fish companies of Gaspe and Labrador. He concluded with a quotation from Dr. J. C. Tache.

The vote of thanks was proposed in suitable terms by Benyon, and seconded by Mme. Antoine Taschereau.

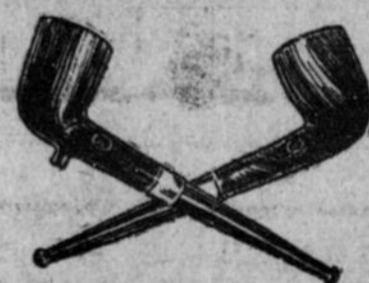
