EAST ANGUS WOMAN LOST SECOND ATTEMPT TO ESCAPE THE GALLOWS

Beatrice Bernard Chapdelaine, Twice Convicted of Murdering Her Husband, Will Be Executed Here on September 21—Appeal Court This Morning Denied Her Right to a Third Trial—Unless Commutation of Sentence Granted, Mrs. Chapdelaine Will Be First Woman Executed in Sherbrooke.

Montreal, June 29.—Mrs. Beatrice Chapdelaine, of East Angus, today lost her appeal from a conviction on a charge of murdering her husband and the Quebec Court of Appeals confirmed the sentence by which she is to be hanged on September 21st.

In reading the judgment, Mr. Justice Walsh made special reference to the evidence of Gedeon Bernard, convicted accomplice of his sister in the crime and now serving a term for it in St. Vincent de Paul penitentiary.

It was ruled that this witness certainly implicated his sister, the accused. The trial judge, however, made a serious statement when he instructed the jury that since the defence wanted Bernard declared an accomplice, it must be known that a person cannot be accomplice unless there is a principal culprit, the one who actually committed the crime.

He limited his remarks to an accomplice, however, and did not align Mrs. Gedeon Bernard in her husband's class as such. Mrs. Bernard proved that the accused had inferentially admitted the giving of the first dose of poison and also stated that when the victim's condition improved a letter called Gedeon Bernard to her.

Bernard's own evidence consisted, in the main, of a statement by the accused woman to the effect that the first dose of poison had proved insufficient and that she required a second. If his evidence were acceptable, therefore, it would establish a serious presumption that she had admitted the first dose; the words of the accused could imply nothing else.

Thus the same facts were proved by two separate alleged confessions. Mrs. Bernard's evidence strengthened the Crown's case, but not the testimony of her husband.

The ruled that the trial judge's instructions to the jury were correct, coupled with the medical testimony in the case, were such as to allow them to form their own opinions. He also instructed adequately on reasonable doubt.

Beatrice Bernard Chapdelaine was twice convicted as the murderer of her husband, Ludger Chapdelaine, an East Angus taxi-cab driver, who died under mysterious circumstances in the St. Vincent de Paul Hospital.

It was alleged that the woman had given her husband a dose of arsenic poison, and Dr. Rosario Fontaine, medico-legal expert, and doctors at the St. Vincent de Paul Hospital declared that the symptoms of Chapdelaine's illness preceding his death denoted arsenic poisoning.

Following her first trial in Sherbrooke, at which she was sentenced to hang by Mr. Justice Charles D. White, the woman appealed the verdict and was granted a second trial when it was proved that an alleged confession obtained from her by provincial detectives had been elicited under duress.

The first trial was terminated under extraordinary circumstances. Just before it ended a juror became ill and the final stage was conducted in a Sherbrooke hospital about the bedside of the juror. It was the same hospital in which the husband had died.

With the confession and certain parts of the evidence presented at the first trial excluded as proof, Mrs. Chapdelaine went on trial for the second time last autumn before Mr. Justice Louis Cousineau, of Montreal, and was again convicted and sentenced to hang.

In the defence of the defense that Gedeon Bernard, convict-brother of the accused, rendered false testimony at his sister's second trial formed one of the strong grounds for the second appeal. The appeal was also based on Justice Cousineau's charge to the jury, the defense claiming that the charge was biased and strongly against the accused.

Should the further efforts which her counsel will make to save Mrs. Chapdelaine from the gallows meet with failure, or should a commutation of sentence be refused by the federal Minister of Justice, the East Angus woman will be the first woman to be hanged in this district; the third in the Province of Quebec to expiate her crime on the scaffold, and the seventh woman to be executed in the Dominion since Confederation.

Four of the six women on whom the sentence of death have been carried out were convicted for murdering their husbands. They were Phoebe Campbell, hanged in London, Ont., on June 30, 1872; Elizabeth Workman, executed in Sarnia, Ont., on June 13, 1873; Cordelia Viau, who ascended the gallows in Ste. Schastique, Que., on March 10, 1899; and Marie Beaulieu Viau, hanged in Hull, Que., on August 23, 1929. The other two women were Emily Hilda Blake, who died on the scaffold in Brandon, Man., on December 27, 1899, and Florence Lassandra, found guilty of killing a police constable and hanged at Fort Saskatchewan, Alta., on May 2, 1923.

Since Sherbrooke became the seat of the District of St. Francis six persons have been hanged in the Sherbrooke jail yard. Prior to 1890, three were executed, while of late years Antonio Poliquin, of Sherbrooke, Albert Vincent, of Flodden, and Albert, alias Pierre, St. Pierre, of Hereford, have been convicted and executed for homicides.

INCREASE IN PERJURY IS DEPLORED BY MR. BENNETT

Prime Minister Tells House of Commons He Knew of "Most Terrific Cases" where Even Human Life Was Sacrificed for Greed and Gain.

Ottawa, June 29.—Perjury has increased tremendously in Canadian courts in recent years, Premier R. B. Bennett told the House of Commons. He said he knew of "most terrific cases" even where human life was sacrificed for greed and gain.

Perjury, said the Prime Minister, who has been a leading lawyer of western Canada for years, often appeared a trivial offence to a man held on a more serious one. To escape one offence he committed another and the practice was becoming too prevalent.

DEATH REMOVES PIONEER CHIEF OF VICE TRAFFIC

Chicago, June 29.—Clifford Griffith Roe, an assistant state's attorney from 1906 to 1909 who was credited with originating the term "white slavery" and starting a nationwide drive against it, died in a hospital yesterday. He was fifty-eight years old.

Roe drafted the Illinois Pandering Act, first adopted by any state, making severe penalties in the traffic in women and aided in formation of the national law, the Mann Act.

HEAT WAVE CAUSES HEAVY DEATH TOLL IN CENTRAL UNITED STATES

More than Score Perish as Sizzling Temperatures Scorch Country from Rocky Mountains to Atlantic Seaboard—Drownings Responsible for Large Proportion of Fatalities—Great Damage in Drought-Stricken Areas.

Chicago, June 29.—More than a score of deaths were attributed today to sizzling temperatures that scorched much of the United States from the Rockies to the Atlantic seaboard. Generally speaking, no immediate relief was in sight.

Off the mid-western states, Iowa apparently was the hardest hit, with six deaths, three due to prostrations and three to drownings. A maximum of 107 degrees was reached at Waterloo.

Many of the victims in other states died when they took to the water to escape the baking heat. Nebraska counted three dead, Illinois one, Maryland three, Michigan four, Ohio four, western Pennsylvania three and Indiana two.

An all time heat record of 112 was registered at Mattoon, Ill., while in Chicago, where one person died from the heat and scores were prostrated, the mercury hit ninety-nine—a new high for the date.

In the Pittsburgh district records of forty years' standing went tumbling, and Franklin Pa., saw a reading of 101, the hottest in its history.

A heavy loss of livestock was reported from some of the drought-stricken areas of the mid west, and crops were withered and burned.

TWO SHERBROOKE MILITARY UNITS PREPARED FOR ANNUAL INSPECTION

Sherbrooke Regiment and Les Fusiliers, Encamped at Wright's Beach, Hold Stiff Morning Drill in Preparation for Inspection to Be Held Tomorrow—Efficiency of Personnel Competition Held This Afternoon—Tugs-of-War Feature Sporting Activities.

From Our War Correspondent on the Lake Memphremagog Front.

Wright's Beach, June 29.—The Sherbrooke Regiment and Les Fusiliers de Sherbrooke will this afternoon compete in one of the most interesting events on their annual camp programme—the efficiency of personnel competition to decide which unit is the most efficient in tactical scheme work.

At seven o'clock this morning the soldiers of both regiments marched onto the field once more, on parade for another stiff morning of drill in preparation for the annual inspection, which is to be held tomorrow.

Brigadier W. W. P. Gibson, C.M.G., D.S.O., O.B.E., Officer Commanding Military District No. 4, accompanied by Major J. Trudeau and Lt.-Col. Armand Hay, Officer Commanding the C.O.T.C. of the University of Montreal, arrived in camp this morning at ten o'clock.

Major Trudeau and Lt.-Col. Hay, together with Col. Valmore Olivier, V.D., Officer Commanding 10th Infantry Brigade, will act as judges for the efficiency of personnel competition this afternoon. Major Trudeau is representing staff headquarters of M.D. No. 4, and Lt.-Col. Hay M.D. No. 4 branch of the Canadian Infantry Association, under whose auspices the competition is held.

General Rioux, who was a guest of Col. Emile Gibeau, former O.C. of the 10th Infantry Brigade, for lunch at Col. Rioux's summer residence this noon, will inspect the regiments tomorrow morning. The Sherbrooke Regiment will be inspected at ten o'clock and the French Canadian unit at eleven o'clock.

An active sporting programme is being planned by both regiments for the week-end. It was expected that the Sherbrooke Regiment and Les Fusiliers will compete in various athletic events tomorrow afternoon.

Today and Saturday, especially because of the sporting activities which are scheduled to be held, lady visitors, who have been forbidden from entering the camp site, will be allowed on the premises.

Tugs-of-war competitions in the English and French regiments last evening proved the outstanding features of the day's sporting events. The officers and sergeants of the Sherbrooke Regiment had a "grand pull," which resulted in a close victory for the officers. Two Empire service men, Instructor Wallis and "Bill" Dowd, sergeant, took for the English unit, coached the officers and sergeants, respectively.

Lt.-Col. Sam Echenberg, O.C. of the Sherbrooke Regiment, was an anchor man for the officers, while Sgt. Cecil Tarte, soldiers' cook, led the sergeants. Apart from the anchor men the teams included Major Bill Baker, Major Lee Watson, Capt. Jim Houlden, Capt. Lloyd Bowen, Lt. George Logie, Lt. J. Echenberg, Lt. Gordon Sangster, 2nd Lt. Frank Hindmarch, and 2nd Lt. Jim Reid for the officers, and Sergeants Howard "Giggs" Symons, Donald "Duke" Henry, Ted Wigzell, Pat Corbett, Jack Shand, Bob Matthews, John Parker and Sgt.-Major Self for the sergeants.

After much difficulty the officers won the first pull—and then reorganized to take the second tussle. Col. Echenberg led his "army" to victory in a gallant manner. During the pull the officers were climbing away a slight ridge in the field, and when the tug was reached, and the colonel felt himself on the down-ward trend

he shouted bravely to his men "Come on boys, we've got 'em"—and "got 'em" the officers did.

The soldiers of Les Fusiliers also held a tug-of-war competition, which proved the cause of much amusement and fun.

Among the guests of the Sherbrooke Regiment last evening was Col. Echenberg's father, M. Echenberg, and also Capt. Cecil H. Bowen, Capt. Bowen is the son of the late Lt.-Col. G. F. Bowen, the organizer and the first O.C. of the 53rd Regiment, which is now the Sherbrooke Regiment. Exactly half a century ago Capt. Bowen commanded "B" Company, which is now under the command of his son, Capt. Lloyd Bowen.

Activities at the camp are following much along routine lines, as the soldiers are preparing for their inspection and the personnel competition.

The "green" men are still the subject of considerable amusement and a couple are roaming around the camps during their leisure hours searching for a "left-handed" monkeywrench and the "Last Post."

After four days of assiduous enquiring, Pte. Trepanier, of the Sherbrooke Regiment, quite in despair over the matter, fervently declared yesterday afternoon that he was unable to locate a left-handed monkeywrench. "Frankly," he said, "I think they're mistaken. There isn't any around here."

Pte. "Tony" Arlano, of Les Fusiliers, was sent out to find Sgt. Arnold Mercier, who was "painting" the Last Post. He returned with his Sgt. Mercier—but he failed in his efforts to locate "Last Post." Quite worried about the matter, he explained his predicament to some of his friends who have been in military camps before. They advised him to see Sgt.-Major Burboing, who knew all about these things.

So Arlano went to Sgt. Bourboing.

It happened at that time that the English regiment was out on the field for special coaching under Instructor Wallis.

"You see that man," said Sgt.-Major pointing to Sgt.-Major Burboing, "you walk over there and ask him about the 'Last Post' and he'll tell you all about it."

VIEW OF IRISH PEOPLE STILL SHROUDED IN DOUBT

Irish Free State Political Circles Discuss Possibility of De Valera Holding General Election to Determine what People Think of His Way of Doing Things.

Dublin, June 29.—What the country thinks of President Eamon de Valera's agricultural policy and his continued economic war with Great Britain, arising out of refusal to pay Britain land annuities, remained in doubt today. Political circles discussed the possibility of the President holding a general election to find out.

Local elections throughout the Irish Free State this week, into which were injected the cardinal issues of the federal political field, have failed to decide the people's views one way or the other, it was revealed today as returns from county, urban and borough elections rolled in slowly.

Unofficial tabulation today gives the Fianna Fail, President Eamon de Valera's party, a plurality of one hundred seats in county councils.

Thus far, it appears that members of the Fianna Fail have won 481 seats; members of the Fine Gael, headed by General Eoin O'Duffy, have gained 381; Labor candidates 146; and others 298.

PREMIER DOUMERGUE GIVEN VOTE OF CONFIDENCE

Paris, June 29.—The chamber of deputies today voted confidence in the government of Premier Gaston Doumergue. The vote was 324 to 226.

EXCISE ACT AMENDMENTS CREATE DEADLOCK BETWEEN TWO HOUSES

Conference Between Commons and Senate Called as Government Refuses to Accept Change Demanded by Upper House—Prorogation Expected Tomorrow—Opposition Attacks on Central Bank Measure and Public Works Programme Continued to the Finale.

Ottawa, June 29.—Driving on towards prorogation with over-time sittings, the House of Commons and the Senate assembled today for what may be their second last sittings of the year. The plan is to wind up the affairs of Parliament for this year tomorrow, and with this in view rapid progress was made yesterday.

Last minute differences of opinion between the Commons and the Senate on important bills provided an interesting situation at the end, and in one case a conference of representatives of the two Houses was called to attempt to iron out the difficulties. This was in connection with the new Excise Act and the provision for confiscation of automobiles, other vehicles and boats in which contraband goods are found.

The new act is a consolidation of the various excise acts and merely re-enacts the law as it stands now, but the Senate, under the determined leadership of Rt. Hon. Arthur Meighen, set out to modify it and provide an avenue by which an innocent person might recover his property in the event of a seizure. The Department of National Revenue and the Government firmly opposed the change, claiming it was difficult enough as it is now to prevent smuggling and that any relaxation of the law would be a handicap to officers.

Yesterday the House rejected the Senate amendments, and when Senator Meighen announced the Senate would insist on them the arrangement for a conference was made. If no agreement is reached the bill will not get through this session.

The other Senate amendment which had to meet the approval of the Commons was the one eliminating wheat from the scope of the Natural Products Marketing Act. It was insisted on this one.

After a last-minute flurry of opposition from the left of the Speaker the Bank of Canada bill, setting up a central bank, received third reading in the Lower House and went to the Senate, where it was given second reading.

The public works bill caused a long discussion with member after member complaining that this or that district had been ignored. Not a vote was cast against it as it received second reading. It provided for the expenditure of some forty million dollars on a building programme to provide employment and stimulate industry.

The Senate received the report of the agriculture committee and also received a visit from Mr. Justice Rinfret, deputy Governor-General, who gave Royal assent to a number of bills.

The House of Commons gave second reading to a bill respecting small loan companies, and second reading to a bill amending the Customs Act.

ROYAL COMMISSION TO CONTINUE MASS BUYING INQUIRY PROPOSED

Creation of Present Commons Committee into Commission Would Preclude Payment of Salaries to Commissioners, Who Would All Be Members of Parliament—Radio Committee Advises Reorganization of Dominion Broadcasting Facilities.

Ottawa, June 29.—A Royal Commission to continue the inquiry started by the mass buying and price spreads committee of the House of Commons was recommended in the committee's report submitted to the House today by Hon. H. H. Stevens, chairman.

The Commission would be composed of the present members of the committee.

The members of the committee are: Hon. H. H. Stevens, W. W. Kennedy, Conservative, Winnipeg, S.C.; Mark Senn, Conservative, Haldimand; Alex Edwards, Conservative, Waterloo South; Thomas Bell, Conservative, Saint John; J. L. Baribeau, Conservative, Champlain; J. L. Hsley, Liberal, Hants-Kings; E. J. Young, Liberal, Weyburn; Samuel Factor, Liberal, Toronto; O. L. Boulanger, Liberal, Bellechasse; and D. M. Kennedy, U.F.A., Peace River.

As they are all members of Parliament, the Commissioners would have to give their services free with the exception of living and travelling expenses, it was explained.

The report follows:
Pursuant to the resolution of the House of Commons of February 2nd, 1934, your committee has been in session on sixty separate witnesses, and under the powers conferred upon it, appointed auditors and investigators to examine into matters pertinent to the said order of reference and coming within its purview.

Due to the voluminous character of the evidence and the limited time at the committee's disposal it has not been possible for the committee to complete the investigations and inquiry contemplated by the terms of the resolution and to report thereon before prorogation.

Under the rules of Parliament the powers of your committee cease on prorogation, and, being fully seized of the necessity of completing the subject matter of the said resolution, your committee begs to recommend:

That the inquiry be continued; That members of this committee be appointed Commissioners under the provision of part one of the Inquiries Act, chapter ninety-nine of the revised statutes of Canada, 1927, to continue and complete their investigations and inquiry;

That the Commissioners be authorized to engage the services of counsel, secretary, accountants, technical advisers, reporters, clerks, stenographers and investigators to aid and assist the said Commissioners in the inquiry, and to print the evidence, proceedings and documents received by the Commission;

That the Government be advised in evidence received and taken by the said special committee be made available to the Commission;

That the Commissioners may hold meetings at such places and at such times as they may consider expedient for the purpose of the inquiry; and

That the Commissioners report their findings to the Minister of Trade and Commerce.

A copy of the evidence and proceedings taken is submitted with this report.

A RADIO GENERAL MANAGER SUGGESTED BY COMMITTEE

Ottawa, June 29.—While recommending the continuance of the act under which the Radio Commission operates for another year, the Commons radio committee expressed the conviction that radio broadcasting could best be conducted by a general manager. The report was tabled in the House today by Hon. Raymond Morand, chairman.

The Government was advised in the report to consider during the recess the question of amending the act with a view to improving the broadcasting facilities throughout the Dominion.

"It has been made apparent," the report observed, "after reviewing the evidence that the establishment of national broadcasting in Canada presents many difficulties for the correction of which time, experience and large expenditure of public money will be necessary."

The committee submitted the following recommendations:
1.—That in view of evidence given before this committee, the Government should, during the recess, consider the advisability of amending the act, with a view to securing better broadcasting facilities throughout the Dominion. In the opinion of your committee, radio broadcasting could best be conducted by a general manager.

2.—That the collection of the fees for radio licenses should be simplified and that one license fee should cover only one receiving set.

3.—That the provision of the act dealing with advertising should be more liberally interpreted.

4.—That a greater use of electrical transcription be permitted.

5.—That, pending nationalization of all stations, greater co-operation should be established between privately-owned stations and the Commission.

6.—That chapter 35 of the statutes of Canada for 1933, which expired on April 3, 1934, be renewed until March 31, 1935.

MAGOG YOUTH IS VICTIM OF STREET MISHAP

J. Boutin, Eighteen Years of Age, Narrowly Escaped Death when Bicycle on which He was Riding Was Struck by Automobile.

Magog, June 29.—J. Boutin, an eighteen-year-old youth of this place, was the victim of a serious accident yesterday afternoon when he was struck by an automobile driven by a Sherbrooke resident giving the name of Viau. A PILGRIMAGE TO PALESTINE. When winter still held this land in its icy grip, Joseph R. Rosenbloom and a few others left for a vacation journey to the East.

They sailed on the "Stardam" from New York to Madeira, where they had the first of many thrilling experiences on the mountain slide, a steep decline which is negotiated by a vehicle resembling a sleigh.

The mere enumeration of names of places visited give the party the status of travellers. Gibraltar, with its impregnable rock, Tangiers and Cadiz; Seville with its magnificent royal palace, where King Alfonso lived before his country chose to be a republic, and Algiers in North Africa, were his first visits.

After climbing the height Mr. Rosenbloom felt his overcoat heavy. His Mohammedan guide offered to carry it, but the cautious traveller hesitated to give it to him. The guide noted his fear and said, "You may trust me, I am a Mohammedan."

Among other places visited were Monaco, with its Monte Carlo, Nice, Malta with its ancient buildings, Beyrou, old but of little interest otherwise, and then to Haifa, the port of the Holy Land.

Palestine is visited every traveller. They all go to Jerusalem, Bethlehem, Jericho and the Dead Sea. A Hebrew cannot pass the Walling Wall. Our citizen spent a half hour with his brethren in the appointed prayers.

Aviv is a modern miracle. It is now a large city. Twenty years ago, when the movement of Jews to their ancient home began, it was a barren landscape. Its site is seventy miles from Jerusalem. It had no tradition to help its growth. Today it is one hundred and ten miles built of white stone, splendid streets, big hotels, and magnificent residences. It shows that the Jew is not buried in his past, he is modern, and is lavish in his gifts to make the land of Abraham attractive.

Other places visited were Port Said, Cairo, with its famous museum displaying garments in perfect preservation which were made four thousand years B.C., and among other things the chariot of the great Tut-Am-Kamen.

In the western return journey the party saw the sights of Greece, Italy and France, including Rome with its gorgeous cathedrals, and Pompeii, now half-excavated, with its numerous life-like petrifications of those who perished in the boiling lava of Vesuvius. Travel costs money but it gives returns which never fade.

UPHOLDS FIRM FOR REFUSAL TO PAY INSURANCE

Judgment Declares Sufficient Evidence Offered to Prove that Waterville Blaze Was of Incendiary Origin.

"Considering that the evidence given by the plaintiff shows that it is not to be believed that the fire is shown fraud to such an extent that the conclusion is inevitable that he intentionally caused the said fire in order to collect the insurance;

"Considering that he claims in his pleadings that he has articles of value which are very much over-valued, in fact the said articles were ever destroyed;

"Considering that a few months afterwards he had another fire for which he claims damage for the time destroyed and the fire in fact, the said articles were ever destroyed;

"Considering that the defendant has established that the said fire is of incendiary origin;

"Doth dismiss plaintiff's actions with costs." Such was the judgment handed down this morning by Mr. Justice C. D. White in the case of William C. Keefe, of Waterville, against the Cornhill Insurance Company Limited, of Montreal. The plaintiff alleged that on November 2nd, 1931, he signed a contract with the defendant for a fire insurance policy against any loss that he might suffer by fire. The contract was for a period of three years and the policy at its face value was \$500. On June 22nd, 1932, Fisk contended, he suffered a loss by fire, his property being destroyed. He asked judgment against the insurance company for \$400. The defendant company pleaded in defence that the fire was of incendiary origin.

WILL NOT A FORGERY.

The attempt of two sons and a daughter to obtain shares of their father's estate failed this morning when Mr. Justice White dismissed the Superior Court action taken by John H. Keefe and Frank J. Keefe, of Southbury, B. G., and Desha D. Keefe, of Maguire, of Cour d'Alene, Idaho, against Dame Helen Keefe Hurley, of St. Jacques le Major, Wolfe County. The plaintiffs allege that they and the defendant are the legal heirs of the late Andrew Keefe who died on February 7th, 1932. They contended that their father died intestate, and accordingly the assets belonged in equal share to the three plaintiffs and the defendant. A month after the death of their father the plaintiffs claimed that the defendant had procured a pretended will of their father. The will was admitted to probate. This last testament, the plaintiff claimed, was a forgery. By its terms the defendant was named universal legatee and took exclusive possession of the assets of the estate. To substantiate their contention that the will was a forgery the plaintiffs asserted that at the time the pretended will bears date, long prior thereto and subsequently up to the date of his death, Andrew Keefe was not in a mental condition to make a will. They asked that the will and probate be set aside and that the plaintiffs and defendant be declared entitled to their share of the estate.

Mrs. Hurley pleaded that her father did not die intestate and that the will of sound mind when the will was made.

In judgment Mr. Justice White pointed out that the important question in the case was to decide whether the plaintiffs were obliged to prove that the will was a forgery or that the defendant was required to prove that the last testament was genuine. The comparison of the will with admitted handwriting specimens showed that there were many grounds of similarity, although there were a few points which seemed somewhat dissimilar. The appearance of the will itself would lead to the conclusion, His Lordship continued, that it was genuine. Commenting on the question of the mental condition of the father, the court maintained that while the deceased had been treated for mental trouble sometime before, neighbors and others who saw him frequently stated that his mental condition at the time the will was made was satisfactory.

BROMPTON GORE LAND CASE SETTLED. Antonio Noel, of Brompton Gore, was declared owner of a property in the tenth range of the Township of Brompton, and the defendant, Delphis Noel, of the Township of Brompton, was ordered to quit the premises within fifteen days in the judgment which settled this case. The plaintiff alleged that since June 2, 1930, the defendant had occupied the farm by tolerance and still lives there against the will of the owner. The plaintiff claimed that he had a right to claim the sum of \$114 as the balance due on rent. Antonio Noel asked that he be awarded \$714, the balance of rent due and six hundred dollars for deterioration of property.

The defendant pleaded that he had made improvements to the property to the extent of \$600 and that he should not be expelled until he was reimbursed that amount.

The Court considered that the title to the property was in the name of Antonio Noel and it seemed that Delphis Noel wished to purchase the land and wanted the plaintiff to be surety for him. The plaintiff had refused to act as surety, but took the title in his own name and was to give title to Delphis Noel when the notes were paid. The notes had not been paid. The judgment read, and Delphis Noel had not paid anything for more than two years. The damages done to the property were equal to any improvements made by the defendant, whereas if the defendant was compelled to pay the amount demanded he would be entitled to the

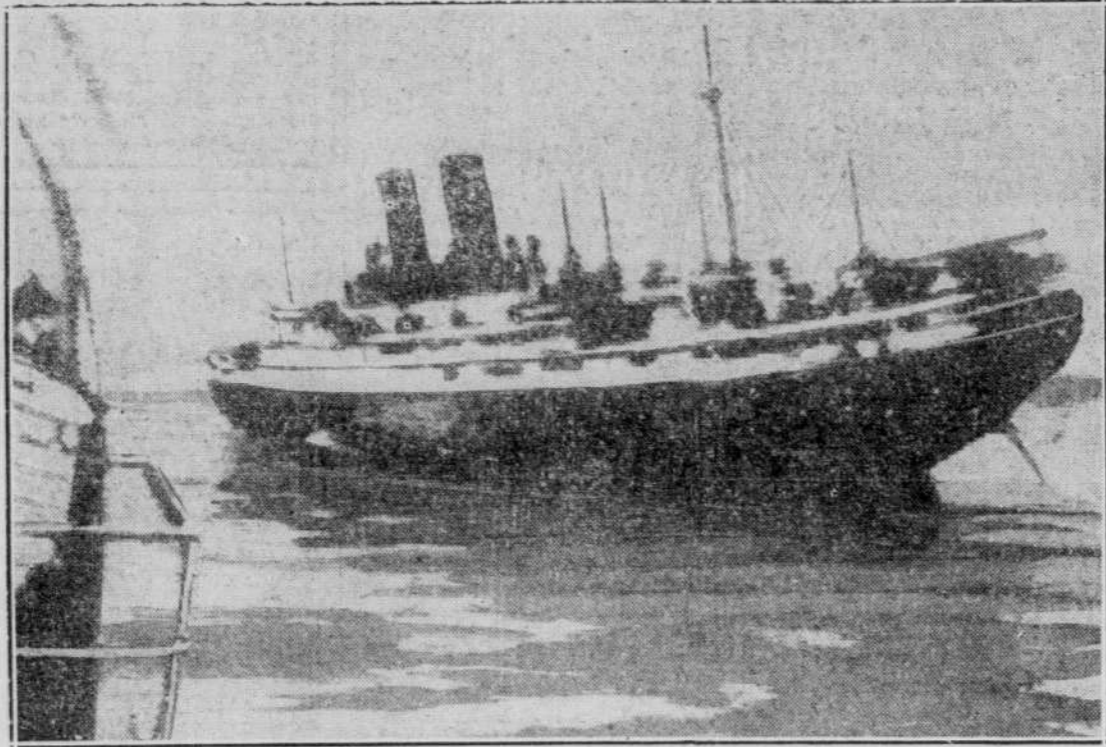

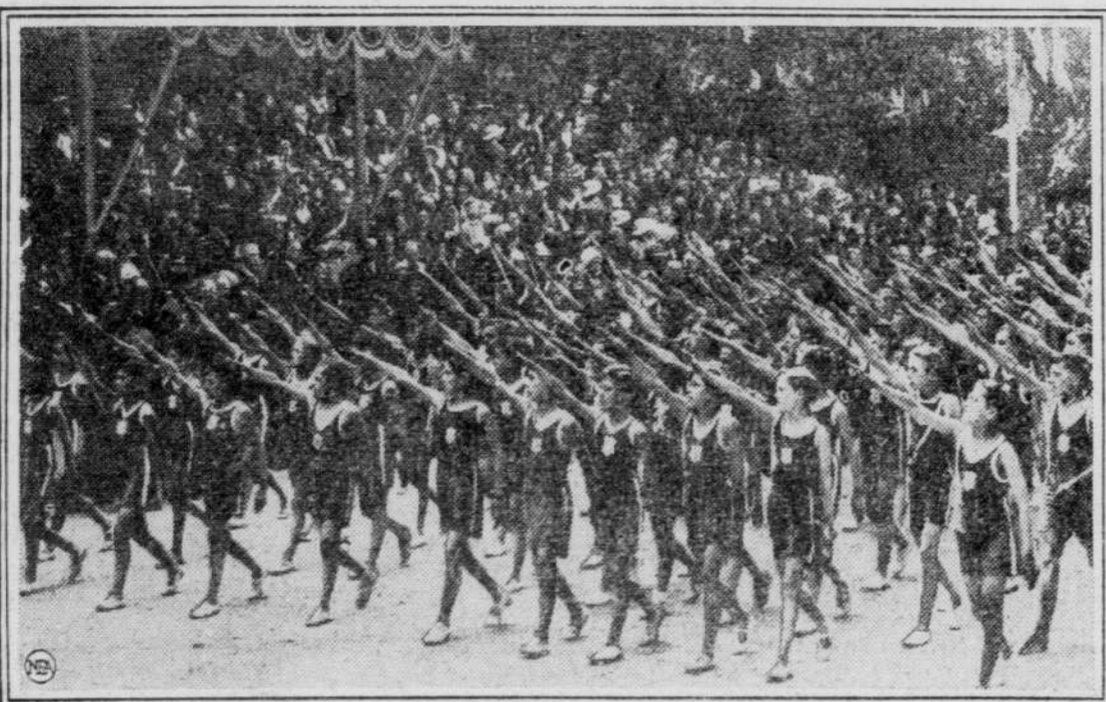

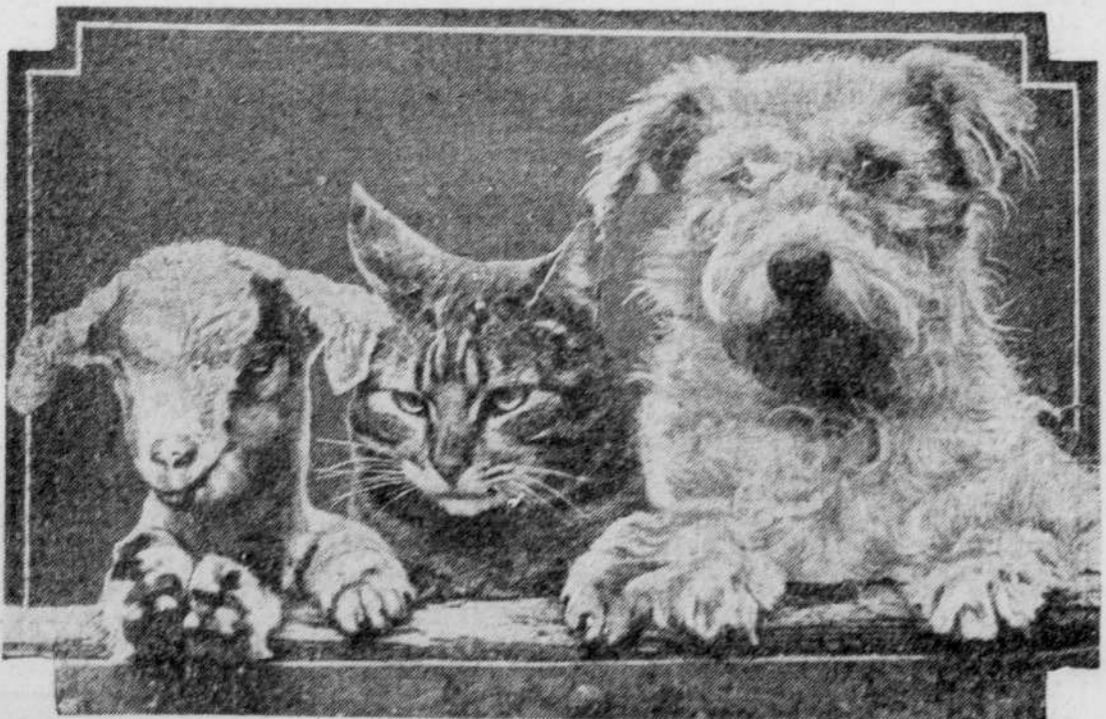

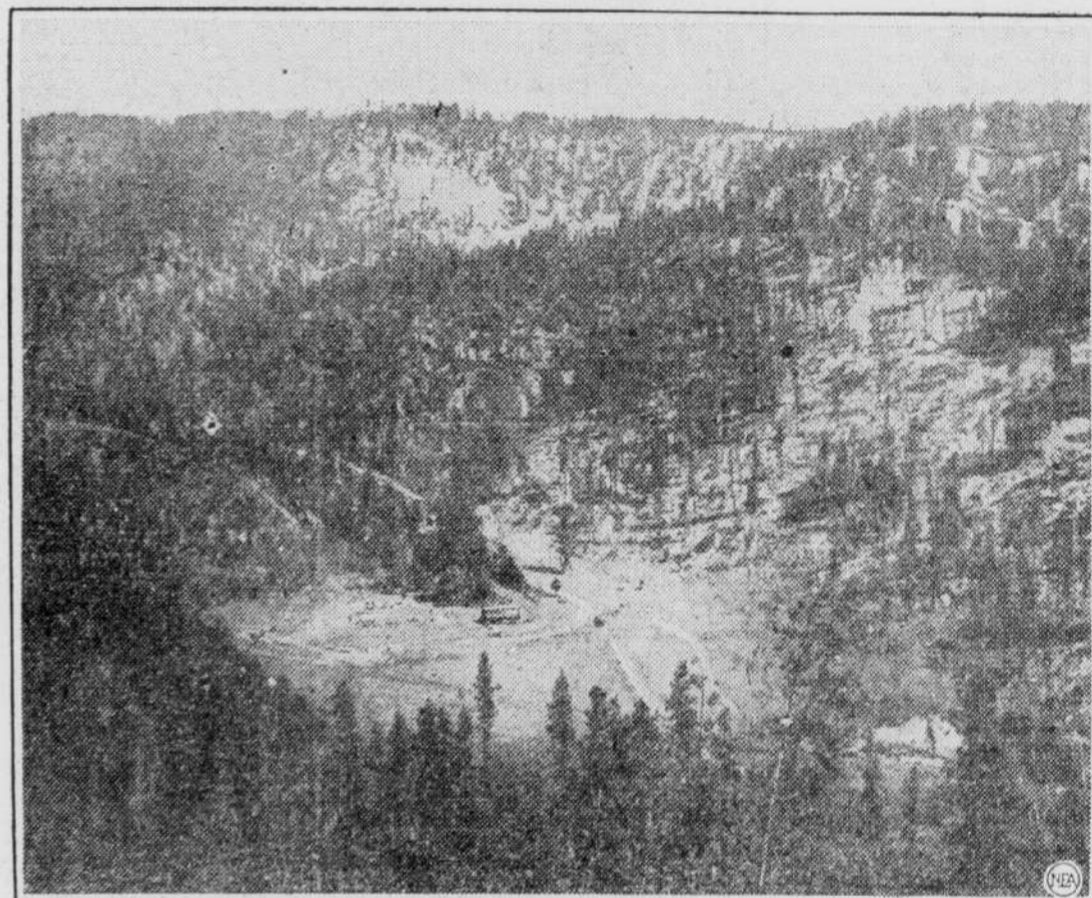

Playing a one-day stand at home before leaving for another but shorter road trip in the west, Detroit squeezed out an eight to seven victory over the Chicago White Sox yesterday in ten innings, and remained only a half game away from the Yankees, who won a four to nothing shutout over the Washington Senators.

"Red" Ruffing scored his third successive shutout, his fourth victory in a row and stretched his scoreless innings to twenty-nine as the Yankees downed Washington. The big red-head allowed only three hits and was in trouble only in the sixth inning. Yesterday's triumph was his ninth against three reverses.

Bob Johnson's twenty-third homer and Jimmie Fox's twenty-first circuit clout helped the Philadelphia Athletics whip Boston's Red Sox by seven to one in the only other game played in the major leagues.

BRITISH GOLF TITLE RETURNS TO NATIVE LAND

Despite Poor Seventy-Nine on Final Round, Henry Cotton, British Pro Turned in 282 for 72 Holes to Lead British Open Field by Comfortable Margin.

Sandwich, Eng., June 29.—Henry Cotton brought the British open golf title back into native hands today for the first time in eleven years by carding 282 for the seventy-two hole chase.

In a wild final round when his nerves cracked under the terrific strain of the twenty-seven-year-old English professional blew up, but was still good enough to card a seventy-nine and win by a comfortable margin.

After setting a record-breaking pace for his first two rounds, with a sixty-seven and a sixty-five, Cotton stuck his third round this morning in par seventy-two and faltered on the final round, taking a shaky seventy-nine. He missed a three foot putt on the final green.

In his third round earlier today Cotton shot a par seventy-two to widen his lead over the field to ten strokes at the fifty-four hole mark. Cotton, playing in a stiff breeze in his third round, covered the first nine holes in thirty-five, one under par, and came home in thirty-seven for a seventy-two and a three round aggregate of 204—twelve strokes under par.

Joe Kirkwood, the trick shot Australian, was in second place with 214. By shooting a one under par seventy-one, Kirkwood picked up a shot on Cotton, who led the Australian holder of the Canadian open championship by eleven strokes at the thirty-six hole play.

Alf Padgham, of Great Britain, who trailed the pace setting Cotton by nine strokes at the halfway stage, slipped to a seventy-five this morning for a total of 216, losing three strokes to Cotton.

Denny Shute, the American defender of the championship, took a disastrous eighty for a fifty-four hole total of 223, putting him hopelessly out of the running.

Percy Alliss, veteran British star, posted the third round seventy-one, which gave him a total of 219. As the game figure were Bert Hodson and William Nolan, also of Great Britain.

It is the first time a native son has won the trophy since Arthur Havers nosed out Walter Hagen in 1923.

Wimbledon, England, June 29.—Jack Crawford, Australian defending champion, easily won his way to the fifth, or "round of eight" of men's singles in the all-England tennis championships today. The Aussie ace scored 4-6, 6-4, 6-2, 6-2 victory over the young Japanese Davis Cup player, Jiro Yamigishi.

Crawford will meet the winner of the match between Lester Stofen, of the United States, and H. G. N. Lee, of England.

Sydney B. Wood, Jr., United States Davis Cup player and title holder here in 1931, advanced with Crawford for a straight-set victory over Dave Jones, American student at Oxford. The scores were 6-3, 6-3, 6-3.

After dropping the first set, Helen Jacobs, United States champion, rallied to eliminate Joan Ingram, of England, in the third round women singles. The scores were 4-6, 6-1, 6-3.

Margaret "Peggy" Scriven, top-ranked English girl, defeated Mrs. E. S. Law, also of England, in another third round match, 6-3, 6-2, to keep pace with her American rival.

A scheduled fourth round engagement between Baron Gottfried Cramm, German ace, and Vernon G. Kirby, of South Africa, was postponed until tomorrow at von Cramm's request. He is suffering from a slight cold.

They were singing praises to Fred Perry's fighting heart last night for the courage that alone carried England's Davis Cup ace over the difficult hurdle Roderick Menzel, of Czechoslovakia.

Perry and the crack invader fought a long, thrilling duel seldom equalled in Wimbledon's dusty annals, but in the end the home-bred pulled out a popular victory by scores of 6-6, 6-3, 5-7, 6-4, 6-2.

Menzel, trounced the British Davis Cup ace when Perry sprained an ankle. As yesterday's duel got under way, the native favorite stayed close by the baseline, apparently favoring the weak ankle, while the Czech giant raced all over the grass as nimbly as a sparrow.

When Menzel swept the first set 6-0 the gallery groaned. The fans came quickly out of despair, however, as the indomitable Briton rallied with placements and chop strokes to finally edge out the victory.

The triumph put Perry into the fourth round along with a seditionally international field. Jack Crawford, the defending champion from Australia, and Henry "Bunbury" Austin, of England, did not play yesterday, but most of the United States survivors did, with success in every case.

Showers continually interfered with the tourney and finally caused a postponement of late afternoon matches after Frank Shields, Sidener B. Wood, Jr., Lester Stofen, George M. Lott, Jr., Dave Jones, Helen Hull Jacobs and Carolin Babcock continued the American advance.

Only Jones and Lott had any trouble. The former, now a Cambridge student, rallied superbly to beat J. Siba, of Czechoslovakia, by 4-6, 4-6, 6-4, 6-1, 6-3. Lott, playing carelessly against Nigel Sharpe, unranked Englishman, won by 7-5, 2-6, 6-3, 1-6, 6-4, only after the stiffest kind of a struggle in the last set.

Stofen defeated the fifth ranking Frenchman, Marcel Bernard, 6-4, 6-4, 6-3; Wood won from the former Oxford captain and internationalist, H. G. N. Cooper, and Shields had a walkover when H. C. Fisher, of Switzerland, defaulted.

Miss Jacobs met a fellow American, Dorothy Andrus, in a postponed second round match and won by 6-2, 6-1, while Miss Babcock defeated Mrs. A. H. Mellows, of England, by 6-1, 6-3 in the third round.

Dorothy Round, carrying the burden of British hopes of keeping the women's title at home, advanced through the third round with a 6-3, 6-0 win over her fellow countrywoman, Mary Healey, Mrs. Kitty McKane Godfree, British internationalist, also won, scoring an easy 6-1, 6-0 victory over Mrs. F. MARIE DRESSLER MAKING A VALIANT FIGHT FOR LIFE

"Grand Old Trouper" from Cobourg, Ontario, Passed Major Crisis in Her Illness Today After Doctors Had Given Up All Hope.

Santa Barbara, Calif., June 29.—Marie Dressler passed a major crisis in her illness early today after doctors at her bedside had abandoned hope she would live to see the dawn.

Five hours after Dr. F. R. Nuzum, head of the medical staff attending her, expressed belief she would not live through the night, the "grand old trouper" from Cobourg, Ont., sixty-two years old, rallied so strong that physicians announced the threat of death had passed at least until noon today.

Her amazing vitality held out against a complication of heart and kidney ailments. At seven o'clock last night Dr. Nuzum said: "We don't expect her to live through the night."

At eight o'clock she sank so low that her features turned blue. Her heart faltered—almost stopped. Then slowly the pale pallor drained from her face. By midnight her heart action was normal. There was no fever. Respiration was 80 to 100.

DOCTOR DISBARRED OWING TO MONEY BACK GUARANTEE Ontario College of Physicians Take Action Against Toronto Doctor Because of Alleged Unethical Conduct in Advertising Goitre Cure.

Toronto, June 29.—Dr. Gordon Webb, of Toronto, stood disbarred today from the rolls of the medical profession in Ontario after the Ontario College of Physicians took action yesterday regarding his alleged unethical conduct in advertising a "money back" guarantee if he failed to cure goitre, adenoid and tonsil ailments without operation.

Dr. Webb said many unnecessary operations were being performed by unskilled surgeons and the medical profession was "riddled with rackets."

"Every thinking practitioner knows perfectly well that this operation has become a racket," Dr. Webb told the Council, adding, "it is almost impossible for a patient to visit a doctor without an operation being recommended as the only treatment."

His advertisements were genuine, Dr. Webb said. He filed notice of appeal to the courts with Dr. H. W. Atkins, registrar of the College.

COURT RULES BRIDE-TO-BE "TOO OLD" TO BE MARRIED Indignation Expressed by Eighty-One-Year-Old Woman and Sixty-Two-Year-Old Man when Officials Upset Their Matrimonial Plans.

Modesto, Calif., June 29.—Because the bride-to-be was "too old" to marry, the law today halted the matrimonial plans of Mrs. Lydia A. Wright, aged eighty-one, and Charles S. Patterson, sixty-two years of age.

Superior Judge J. C. Needham issued a restraining order against the marriage, at the request of Attorney R. V. Wilcox, guardian of Mrs. Wright, and C. H. Ramont, county welfare officer, because they said she was too old to marry.

Indignation was expressed by Mrs. Wright and Patterson, who had filed a notice of their intention to wed.

POLISH FLYERS GUIDING PLANE OVER ATLANTIC

Clear Weather and Light Tailwind Favor Pair on Second Lap of Flight from New York to Warsaw.

Harbor Grace, Nfld., June 29.—Flying into the sunrise, two adventurous brothers and partners in business roared over the Atlantic today in a big tri-colored monoplane with Poland as their goal.

Yesterday the two airmen completed the trip from Brooklyn, N.Y., to Harbor Grace in nine hours and thirty-five minutes.

APPEALS COURT MAINTAINS SENTENCE ON RUM-RUNNERS

Unanimous Verdict Given by Quebec Court Against Appeal of Two Convicted Leaders of Smuggling Ring.

Quebec, June 29.—Dismissing the appeal both on fact and in law, the Court of Appeals yesterday unanimously confirmed the verdict and sentence in the case of Alfred Levesque, of Notre Dame du Lac, and Antonio Graveline, of Quebec, convicted leaders of the million-dollar liquor smuggling ring, who were sentenced to four years in St. Vincent de Paul Penitentiary by Mr. Justice Wilfred Laliberte at the Circuit Court of King of the Bench last January.

The judgment of the court was read by Mr. Justice Dorion, while on the bench were Justices Hall, St. Jacques, Galipeault and Letourneau.

Counsel for Levesque and Graveline stated they would immediately prepare a petition for permission to go before the Supreme Court. When a judgment of the Court of Appeals is unanimous the only grounds on which the appellant may go to the Supreme Court is when the judgment conflicts with findings of the higher courts of other provinces in similar cases; and this will be the grounds invoked in the petition on behalf of Levesque and Graveline.
