Integration of PRTs

In late January 2002, M^{re} Samson informed us of the decision of the *Office des professions du Québec* to submit the draft decree respecting the integration of physical rehabilitation therapists into the *Ordre* to Minister of Justice.

Under subsection 27.2 of the *Professional Code*, the government may decree that a group of persons be integrated into an existing professional order with a view to protecting the public.

The draft decree will be examined by the Minister and published for a 60-day period in the *Gazette officielle du Québec*. At the end of this period, it will be considered by the government. Once the decree has been passed, it will be published in the *Gazette officielle du Québec* and come into effect the fifteenth day after this publication or at a later date indicated in the decree.

The third integration, ours...

After the integration of educational psychologists into the *Ordre professionnel des conseillers et conseillères d'orientation du Québec* on September 20, 2000 and that of marriage and family therapists into the *Ordre professionnel des travailleurs sociaux du Québec* on November 30, 2001, the year 2002 will mark the integration of physical rehabilitation therapists (PRT) into the *Ordre professionnel des physiothérapeutes du Québec* (OPPQ).

As you know, the integration of PRTs into the OPPQ has been on the agenda for a number of years. The integration of two groups of professionals is nothing new for the government. We are, in fact, the third case since June 1998. All three cases have proceeded along the same lines in terms of timeframe, initiatives taken, and the various stakeholders' applications to the *Office*. For example, the *Conseil interprofessionnel du Québec* (CIQ), which represents 272,000 professionals, was involved in each case, and in each instance, an ad hoc committee made up of representatives from the different orders examined the professional issues at stake. The CIQ's approach to each group was also consistent. In our case, its recommendations to the *ministère de la Justice* via the *Office des professions du Québec* were in favour of the integration of PRTs into the OPPQ.

Important dates

On the eve of this integration, a review of the long yet natural development of this issue would be useful for all our members, particularly for our new graduates. Discussions between the two groups have been ongoing since the early 1970s, following the introduction of the first college program in 1969. In 1973, the *Code des professions* recognized physiotherapists, and in the late 1980s, PRTs made an application to form a professional order. In light of the latest developments, that is where our review will begin

1987

In December 1987, the *Société québécoise des thérapeutes en réadaptation physique* (SQTRP) applied to the *Office des professions du Québec* to form a professional order. At that time, the *Office* did not consider it advisable to create a new professional order for PRTs.

1989-1992

From 1989 to 1992, the OPPQ and the SQTRP primarily focused on assessing an integration model based on additional continuing education that would enable PRTs to become regular physiotherapist members of the *Ordre*.

In 1990, the *ministère de la Santé et des Services sociaux* (MSSS) proposed working with the *ministère de l'Enseignement supérieur et de la Science* (MESS) to update information on the professional duties and responsibilities of PRTs and physiotherapists.

In 1991, the SQTRP and OPPQ made joint recommendations to the Council of Colleges respecting the college curriculum, its revision and the introduction of new programs. They also noted the lack of a clear definition of the duties and responsibilities of each group.

1993-1994

In a brief to the *Office des professions du Québec*, the MESS and the MSSS, the SQTRP proposed that integration into the OPPQ be based on a two-level responsibility model. The *Office* approved this proposal and began consultations on a model respecting the levels of responsibility for PRTs.

That same year, the *ministère de l'Éducation* began revising the physical rehabilitation techniques program, which had not been reviewed since 1977.

1995-1996

In 1995, the *Office des professions du Québec* developed a levels of responsibility model subsequent to consultations with a group of experts representing the *Collège des médecins*, the *ministère de l'Éducation*, the SQTRP and the OPPQ. Representing over 272,000 members, the CIQ approved the description of the levels of responsibility and recognized the importance of integrating the two groups into the same order to limit potential confusion in this practice area.

In December 1995, the *Office* recommended to the government that PRTs be recognized by the *Code des professions du Québec* through their integration into the OPPQ, based on levels of responsibility. At this time, the OPPQ agreed with their integration in compliance with this model.

It should not be forgotten that the government accepted the levels of responsibility model to the extent that it was approved by the *ministère de l'Éducation du Québec*, which drew on it extensively in establishing standards applicable to the competencies set out in college rehabilitation techniques program.

Since 1997, PRT college training has been based on this model. It should also be noted that the five colleges offering this program participated in the revision initiated by the *ministère de l'Éducation* in 1994.

1997-2000

In 1997, the issue was examined by the various stakeholders.

In 1998, the passage of Bill 406 led to a new option for physical rehabilitation therapists and physiotherapists. The integration of a group of persons (PRTs) into a professional order whose members practice a reserved title profession (OPPQ) became legally possible.

2001

In 2001, all these discussions culminated in a draft decree respecting the integration of physical rehabilitation therapists into the *Ordre professionnel des physiothérapeutes du Québec*, based on a levels of responsibility model that had been established for a number of years and corresponding to the current college curriculum.

It should be recalled that PRTs had never asked to be granted the exclusive right to practice their profession but instead had asked to have their practice granted a reserved title by being recognized through a professional order.

The OPPQ position

The *Ordre* continues to be proactive in this regard since we believe that the draft decree respecting integration will result in major gains, not only for both groups concerned, but also for the professional system as a whole and its ultimate aim to protect the public.

The following are a number of points in favour of this integration.

- First, let's not forget that the proposed integration provides for six PRT directors on the Bureau. The new Bureau will also include four directors appointed by the *Office des professions du Québec*. PRTs and physiotherapists will participate equally in orienting physiotherapy in Quebec.
- At a time of budget cuts and labour shortages, the goals of the *Office* and the OPPQ are to provide first-quality physiotherapy treatments to Quebecers and to ensure that the right professional is used in the right place. There is no question of reducing the accessibility to quality care implicit in our

health system or of using the integration of PRTs into the *Ordre* to subjectively replace physiotherapists with PRTs or vice versa.

- PRTs' clinical practice will be enhanced by an equivalent frame of reference for each group. Physiotherapists will have no trouble adapting to this new situation since it is already common practice in a number of public and private environments.
- From the *Ordre's* perspective, we believe that the integration of PRTs and a clear understanding of the levels of responsibility will promote the hiring of more PRTs in clinical circles.
- Integrating PRTs into the *Ordre* will give them official recognition within the Quebec professional system. This in turn will eventually give them the mobility to work in any of the other Canadian provinces. They will also be able to play a role in promoting Quebec physiotherapy on the national and international scene.

After integration...

In the months following integration, there will be a certain amount of adaptation required on the part of all professionals. The physiotherapist and PRT directors will be on hand to ensure the decree is properly applied.

Épilogue

This review of the road travelled since 1987 reflects the enduring interest of both groups in integrating PRTs into the OPPQ. With Bill 406, the government has given us the means of achieving this integration.

Ongoing collaboration will be essential for us all to carry out the mission that is central to each and every professional order – the protection of the public.

Conclusion

This historical review of the issue clearly mirrors the interest of all professionals in this integration. Its successful conclusion will significantly reinforce the important role played by physiotherapy and physiotherapy professionals in the Quebec health system. It will enable us to pool our efforts to protect the public, which remains the first priority of this new order

The year of Back Pain

Physiotherapy month, which will be held from April 20 to May 20, 2002, will increase public awareness of back pain by focusing on the kinds of evaluations and treatments that only the scientific knowledge of physiotherapists can provide.
