SHERBROOKE CONSERVATIVES MEET SATURDAY

Great Throngs In Jam For Last View Of Valentino

A. M. Sangster, Likely Candidate, It Is Now Said

Revision of Voters' Lists Now Under Way—Office Opened Last Evening—Will Continue Several Days for Hearing of Complaints and Recording Further Names—Persons Whose Names Have Been Omitted Have Chance Now to Have Them Recorded.

SHERBROOKE Conservatives are calling their convention for Saturday night when a standard-bearer will be chosen. The name most prominently mentioned in this connection today is that of Mr. Andrew M. Sangster, former President of the Sherbrooke Board of Trade, and long associated with the Canadian Ingersoll Rand Company of this city. Mr. Sangster's name is said to be meeting with general favor in party circles and, if his consent to stand is forthcoming, it is believed his nomination at Saturday's convention is most probable.

REVISION OFFICE OPENED

Sittings for the revision of the voters' lists for Sherbrooke opened last evening at the Court House, continuing from 7.30 till 9.30 o'clock. Chas. E. Buchand, acting-revising officer, presiding. These evening sittings will be continued every evening until August 30th, inclusive.

Those whose names do not appear on the voters' lists as posted at the polling booths may apply at these sittings to have names added.

On application or complaint names, already recorded, may be struck off the lists on evidence that they are not entitled to vote.

Between August 31st and September 2nd, following these sittings, the lists as revised will be formally certified.

MR. MEIGHEN AT RALLY IN REGINA, SASK.

Speaks of War Time Election Act—Replies to Query Re Dr. Paquet.

REGINA, Sask., Aug. 25.—(By Canadian Press)—Premier Meighen addressed a meeting here last night following speeches at Melville, at Balcarres, at Lebret and at Fort Qu'Appelle. It was a strenuous day, the effort of which was apparent in the hoarseness of his voice.

Mr. Meighen spoke in passing of the war times election act. He turned particularly to statements made in this connection by Hon. Charles Dunning.

"I was a member of the government which passed the act," Mr. Meighen said. "I always took my full share of responsibility, have done so before audiences in this city and do so again."

"At the time of the great war, it came to be a question of deciding upon what principle our men should be enlisted, whether we would continue a system of compulsory enlistment or whether we would desist."

"A large section of our population, not large comparatively, lately arrived from the lands of the then enemies, from Australia, from Germany, petitioned the government, that, as they had lately come from those countries and felt a natural bond of affection for the land they had recently left, they ought not to be called upon in any way to enlist to fight their brothers from whom they had lately departed and they said: 'If we are to be saved from that obligation, we quite recognize that we ought not to claim the right to vote in an election which decides whether others enlist or not.'"

"That seemed a reasonable appeal. It seemed common sense. It was natural. They were not in a position to assure me all the obligations of British citizenship and it was unnatural to ask them to do it. We did not ask them to do it and we took the other suggestion, perfectly right and logical, that, as they could not assume all the obligations, they would not have the right in our country to determine what the obligations of the rest of us were."

"This was on the petition of those people themselves organized for that purpose. And on the basis of that, Liberal speakers by the dozen, but especially Mr. Motherwell and Mr. Dunning have sought persistently to arouse prejudice among our foreign-born citizens in order to 'net political capital.'"

Net Running Fire of Comment. As Mr. Meighen rose, he received an enthusiastic greeting, but there was a running fire of comment from the crowd. The meeting at one point was halted for several minutes while one interrupter wanted to put questions.

At another, Mr. Meighen replied to a cat-calling asking if anybody has anything to say, whether of the civil service under salary, or whoever he is."

(The crowd laughed.) "There is one up here," shouted some one.

FASCISTI GUARD FOR VALENTINO BODY IN N. Y.

Many Injured in Great Jam—Uncontrollable Mobs — 50,000, Mostly Women and Girls, Blocked Upper Broadway—Pola Negri Leaves California for New York to Attend Funeral.

(Associated Press Despatch) NEW YORK, Aug. 25.—The body of Rudolph Valentino, great lover of the screen, today was guarded by police and black shirted Fascisti because of the unprecedented and uncontrollable mobs that have thronged to view it, resulting in scores of injuries.

Ten men wearing the black shirts of the Italian Fascisti arrived, and two of them went on guard, the others arranging to relieve them at intervals. A huge wreath also arrived, labelled "from Benito Mussolini."

Valentino is receiving more newspaper space than Charles W. Eliot, president emeritus of Harvard University, and often referred to as "the first citizen" of the United States, who is being buried at Cambridge, Mass., today. Financial returns from their works also offer a basis of comparison of popular appeal. In eighteen years sales of Dr. Eliot's five foot shelf of books have totalled \$20,827,188. Presumably his box office has been paid at much offices by Valentino fans. In ten years he earned \$2,500,000 representing salary and part of the profits of producers.

Some 125,000,000 people viewed one picture alone.

Police estimated that 50,000 persons, mostly women and girls, blocked Upper Broadway before the undertaking establishment where Valentino lies in state, and that more than 100 were injured in yesterday's crush. One hundred and forty-five policemen, ten of them mounted, were required to keep order until the establishment closed at midnight last night. The body will be on view again today and tomorrow.

"The crowd had the true mob spirit," said Police Captain Hammill. "I never saw anything like it in twenty years on the force. So many of them were morbidly curious they would not go home."

The casket containing the body has been placed on the second floor to force spectators to pass single file by climbing a stairway. All portable objects have been removed from the reach of souvenir hunters. The line passed the coffin at the rate of 75 a minute.

Funeral service will be held Monday, but the place of burial will not be decided until the arrival of Valentino's brother, Alberto Guglielmi, who sailed from France today. Pola Negri, who announced some time ago that she expected to marry Valentino, and George Ullman, Valentino's manager, will urge that he be buried in Hollywood "where he spent his happiest hours."

Miss Negri will leave Hollywood today in the hope of reaching New York in time for the funeral services. Among the honorary pall bearers Monday will be Mayor Walker, Will Hayes, Adolph Zukor, Marcus Loew and Hiram Abrams. Services will be at St. Michael's Catholic Church.

EVANGELIST IS KILLED IN MISSOURI

Indian Club in Hands of His Brother-in-Law Causes Death of Gillum.

(Associated Press Despatch) SPRINGFIELD, Mo., Aug. 25.—Rev. Edward Gillum, 50, who has been conducting evangelistic services at Sheridan, Missouri, was killed last night by his brother-in-law, W. R. Leffler, local contractor. The first took place at Leffler's home here.

Leffler used an Indian club to kill Rev. Mr. Gillum. The unwritten law will be Leffler's defence.

According to Leffler's statement to the police, he returned home and found Rev. Gillum in the front room. According to his version, Rev. Mr. Gillum had been trying to "wreck" his home during recent weeks. As he entered the room, he said, Rev. Mr. Gillum reached for his pocket. As he did, Leffler seized an Indian club and crushed his skull. Rev. Mr. Gillum did not regain consciousness.

Leffler called the police and an ambulance and went to the central police station.

Mrs. Leffler corroborated her husband's story.

SHEFFORD CO. FAIR OPENED AT WATERLOO

Month Earlier Than Former Years—Grounds in Good Condition—Stock Entry Higher—Horticulture Department Small—Judging Proceeding Today—Much Activity in Placing Exhibits Today.

WATERLOO, Aug. 25. (Special)—Shefford fair opened here this morning, nearly one month earlier than in former years. The change of dates was occasioned by heavy and continuous rains having fallen during fair week for the past three years, and the president and directors were anxious to avoid, if possible, the annual storms, therefore setting the dates for August 25, 26 and 27, instead of the middle or latter part of September.

A heavy rain falling on Monday night was most encouraging, as the dust has been done away with and everyone is now anticipating three or more days of fine weather.

For the past two weeks, carpenters have been making all necessary repairs to the buildings on the exhibition grounds, and the race track has been put into shape.

The secretary, Mr. N. O. Rockwell, reports more live stock entries than in former years, and all other entries are numerous as usual. The horticulture department may suffer somewhat from the early dates fixed this year, as fruits and vegetables will not have matured, but on the other hand no flowers or vegetables have been injured by frost as is sometimes the case when the fall fairs are held in September.

The dining hall will be under the management of the V.I.S.S. of Warden, which for the past few years has won for itself an enviable reputation for the splendid meals furnished and quick and competent service.

The usual attractions are provided for those having seats on the grand stand and a splendid band will furnish music all three days of the fair.

This morning there was great activity as the different departments are receiving their exhibits.

All tickets will be put on articles winning prizes in the main building this afternoon, so that visitors may know the result of the competition in the various departments when they arrive on Thursday morning.

STANSTEAD CO. FAIR HAS BIG CROWD TODAY

Fine Weather Brings Out the People—Show of Excellent Quality—Agricultural Prominence of the County Demonstrated—Crop Prize List Concluded.

AYER'S CLIFF, August, 25. (Special to the Record)—Under auspicious circumstances, except for wet weather early yesterday, the eighty-first annual exhibition of the Stanstead County Agricultural and Horticultural Societies is scoring another success. A big crowd is gathering today and directors expect a record attendance.

The opening day, as is usual, was not one essentially for the public, although several hundred visitors did enter the grounds during the day, but rather one of preparation for the succeeding two busy days, when everything will be going in full force. Yesterday exhibitors were coming in with their horses, cattle, swine, sheep, poultry, vegetables, fruit, fanciwork, or whatever line they chose to contest in, and the buildings were being put into order. The 1926 fair is, in the opinion of the directors, especially notable for the entries of horses being made, these being far greater in number and considerably better in breed than ever before shown in Stanstead county.

The extensive fair grounds are in good condition, and some six hundred dollars have been expended during the past year in repairs to buildings, especially on new roofing to grand stand and cattle and horse sheds. The midway commenced to operate on a small scale during the morning.

The ground floor of the main building is occupied by exhibitors of industrial and retail concerns of the district, including those of the Dominion Experimental Farm, Lennoxville, H. C. Wilson and Sons, Sherbrooke, and Magog, Dominion Textile Company, Magog, J. A. C. Ferland, Magog, W. W. Levesque, Magog, and D. E. Pepin, Magog. This section is in charge of Mr. F. W. Wallace, Magog, last year's president.

Programme for Today and Thursday.

Judging of all entries commenced, and in some cases was finished, during the afternoon. Parades or programme took place, but will be held today and Thursday. Three three-beat races are scheduled for today, with purses of \$150 and \$200, and on Thursday a free-for-all with a \$200 purse and two other races.

Special arrangements have been made to entertain the public today and Thursday in the way of amusements on the grand stand apart from the usual races and horse and cattle parades. The vaudeville attractions are to be carried out by the Roscoe-Armstrong troupe, while the Ayer's Cliff band and an orchestra will be in attendance. Judging of special classes of horses—drafts, saddles, foals, drivers, etc., will be carried out on both days as part of the afternoon's programme.

This part of the fair has been organized by John Peters, Magog, and F. W. Pope, Hatley.

FINE CATTLE EXHIBIT AT THE BEDFORD FAIR

Good Weather Brings Crowds to Grounds Today—Many Improvements Made—Fair Continues Till Tomorrow Evening—Outlook Bright for General Success.

BEDFORD, Aug. 25. (Special)—The Missisquoi County Fair enters upon its second day under fine weather conditions. People began to arrive early from all parts of the county and a big attendance is assured.

The grounds have been much improved since last year, repairs and alterations to the extent of over two thousand dollars have been carried out. One great improvement made is the doing away of the three old entrances and the building of an entirely new entrance at the foot of Pine street with a new office building. The midway is one of the best that the exhibition has yet obtained, as arrangements were completed with the Maple Leaf Shows to provide a series of rides and an excellent class of shows for the entertainment of the public.

In addition to the above mentioned company, there are several independent places of recreation and amusement, which all contribute to the attractiveness and interest of the aggregate.

In regard to the chief interest of the exhibition, namely the entries of live stock, especially cattle are larger than usual and the majority arrived and were placed by Monday. The cattle exhibits include such herds as those of Messrs. Montgomery, Col. Ramsay, Wilkins Bros., McCullough Bros., and Symington. The entries in the sheep and swine class, while not so large still are very excellent. Horses also are showing up well and the exhibit in this class promises to equal any of the previous years.

The purses have been greatly increased in the speed contests and this increase has induced the attendance of a larger number of race horses than usual and good races are assured for the entire three days of the exhibition.

The attendance on the opening day was very fair taking into consideration the weather conditions, which were anything but promising after the heavy rain of Monday night.

The exhibition will continue until tomorrow evening and with good weather a financial as well as an exhibition success will be scored.

LABRADOR BOUNDARY DISPUTE CASE

Lord Advocate for Scotland Will Plead for Canada Before Privy Council.

(Associated Press Despatch) MONTREAL, Aug. 25.—Consultations leading to the preparation of Canada's case before the Privy Council in connection with the Labrador boundary dispute are going forward in Montreal between the Right Hon. Hugh Patterson MacMillan, P.C., K.C., Lord Advocate for Scotland, who is to act as counsel for Canada when the case is called before the privy council on October 21.

Mr. MacMillan is in daily consultation with a number of those who will argue Canada's case when it comes up. Before coming to Montreal he visited Quebec, where he was received by Premier Taschereau, with whom he discussed the case, as well as with Charles Lantot, K.C., assistant attorney-general of the province. While in Canada he will also confer with the Right Hon. Charles J. Doherty, former Minister of Justice, who will also act for Canada.

Right Hon. Mr. MacMillan is an advocate of the Scottish Bar and has held a number of important appointments under various British governments, including that of assistant director of intelligence in the ministry of information during the war. He is a former editor of the Judicial Review, and was for four years senior legal assessor to the city of Edinburgh.

R. H. BERTRAND ALLOWED BAIL IN BEAUDRY CASE

Held as Witness in Montreal's Murder Mystery—Coroner Again Adjourns.

(Associated Press Despatch) MONTREAL, Aug. 25.—R. H. Bertrand, manager of the Merchant's Printing Company, who was detained Saturday at a witness for the inquest into the death of J. A. Beaudry, proprietor of Le Prix Courant, who was shot to death in his office last Monday, was released yesterday afternoon on \$3,000 bail, after the crown had asked Coroner McMahon further to adjourn the murder probe until Monday afternoon because essential witnesses were absent. No evidence was taken.

ATTEMPT TO STOP ENTRY INTO STATES

Charge of Moral Turpitude Fyled Against Young Hindu Theosophist Preacher.

(Associated Press Despatch) NEW YORK, Aug. 25.—Enemie of J. Krishnamurti, the youthful theosophist Messiah, have protested his entry into this country, alleging moral turpitude, the New York Herald-Tribune says today.

Complaints against him were reviewed yesterday by immigration commissioner Day, the paper says, but were rejected on the grounds of insufficient evidence. The names of those opposing the landing today of the young Hindu from the liner Majestic were not disclosed, nor were the specific charges against him.

Meantime Krishnamurti's friends made plans for a special boat-load of reporters and photographers to meet him on the Majestic before it docked. Two theosophist leaders and a representative of a lecture agency were included in this reception party.

The Herald-Tribune quotes commissioner Day as saying that he expected further evidence and that "if it is more than presumptive proof of guilt we will hold him for inquiry."

Krishnamurti and Mrs. Annie Besant, 80 year old international president of the Theosophical Society, who is sponsor and guardian, plan to spend the night in New York, according to an announcement by their representatives and then go to Chicago to attend a theosophical convention. Afterwards, Krishnamurti's plan will be for seclusion on his ranch in California.

Mrs. Besant became acquainted with Krishnamurti when his father, G. Narayan Iyer, a magistrate's clerk in Madras took him to a theosophical meeting at Adyar, in 1908. The boy was twelve years of age at the time. When he was thirteen he wrote a book "At the Feet of the Master", which has been translated in thirty languages. On December 28, 1911, Mrs. Besant introduced Krishnamurti at a theosophical gathering at Benares, India, as the vehicle of the first coming of the great teacher since Christ.

Since that time the youth has been preparing for this mission, part of the time studying with a brother under Bishop Leadbeater, liberal Catholic who was expelled by the Theosophical Society in 1906 and restored to membership in 1908.

In 1902 Krishnamurti's father sued Mrs. Besant to have his sons returned to him, denouncing Leadbeater's alleged immoralities. The highest courts of India held that the boys should be restored to their parent, but the case was taken to the Privy Council, which ruled that they should continue in Mrs. Besant's custody, but not under the tutorage of Leadbeater.

The police of Sydney, Australia, where Leadbeater surrounded himself with novices of mystical orders, investigated in 1923, at which time two sons of the Madras Magistrate's clerk testified in his behalf. Krishnamurti's brother died in California a year ago.

"I find," the Herald-Tribune quotes Commissioner Day, "from an examination of the complaints no evidence that Krishnamurti himself has been guilty of moral crimes. His examination on the ship may reveal it, but the charges do not." Krishnamurti has been in this country twice before.

BURY SCHOOL BOARD HELD BUSY MEETING

Application of Frank R. Groat, B.A., as Principal Accepted—Bury to Teach Grades Ten and Eleven—Conveyance Contracts Let—Resolution of Thanks Passed to William Ellis, Who Resigned Position of Caretaker—Personals.

BURY, Que., Aug. 25.—On Saturday evening, August 21st, a meeting of the Protestant School Board was held at the town hall. The members present were A. Pelemann, A. Dougherty and D. MacLean with the chairman, James F. Groom.

The secretary read the references given by the applicants for the position of principal of the Canterbury School, and the action of the chairman and secretary in accepting the application of Frank R. Groat, B.A., was confirmed.

A circular letter from the Provincial Board of Health in regard to the vaccination of all pupils was read and the secretary was instructed to notify all teachers to require the production by all pupils of the necessary certificate.

A letter from the Department of Education was received, granting permission to teach grades ten and eleven in the Bury Intermediate School and grade ten in the Brookbury Consolidated School. A communication, relative to raising the status of the village school to that of a high school, was also received.

The three contracts for the conveyance of pupils held over from the last meeting were awarded at this meeting, as follows: Brookbury No. 2 route, to Charles W. Berwick, at \$3 per trip; Canterbury No. 1 route, to Angus Smith, at \$2.50 per trip, and Canterbury No. 2 route to Curtis Bennett, at \$3 per trip.

A long discussion ensued on the question of the conveyance of pupils living off the main routes, and a resolution was moved that on one route the contractor should be approached with a view of making the extra trip into a side road, amounting to five miles of extra travel per day, but later on a motion was passed to reopen the subject and after a further consideration and consultation of the code, the former resolution was rescinded.

Mr. William Ellis for several years janitor at the Bury Intermediate School, being present, tendered his resignation on account of leaving Bury to reside with his daughter in Manitoba. On receipt of this resignation the following resolution was passed: "That this board do accept Mr. Ellis' resignation with regret; that they appreciate the faithful services he has rendered the board whilst holding the position, and that he takes with him to his new home the good wishes of the board for continued health and happiness. That a copy of this resolution be given to Mr. Ellis." This was carried unanimously.

Two applications were before the board for the vacant position, which was awarded to Arthur G. Atkins on trial.

W. Mulvena, for many years District Magistrate for the District of St. Francis.

The late Judge Henry Walter Mulvena, who was in his seventieth year, was born in Sherbrooke, of Irish parents, on November 22nd, 1856. He was educated at St. Hyacinthe College and graduated in Arts in 1875. Following his graduation he entered the law office of the late William L. Felton, and completed his studies under the late Hon. W. B. Ives. In 1880, he was admitted to the Bar of this province and was in partnership, first, with the late J. W. Merry, and upon his death, with W. L. E. Panneton, K.C., now His Lordship Hon. Mr. Panneton.



Judge H. W. Mulvena, who died suddenly at his late residence, Melbourne street, this morning at eight o'clock.

Since his admission to the Bar, the deceased has held many different positions. He was first appointed secretary of the local Bar, afterwards treasurer and in 1895 was appointed Batonnier.

During the years 1880 and 1881 the late Judge Mulvena was engaged in newspaper work, and controlled the Sherbrooke "Gazette."

In politics the deceased was a Liberal-Conservative and was secretary of the Liberal-Conservative Association of the Eastern Townships.

In 1892 he was appointed Crown Prosecutor, and Bishop's College, having established a law course, in 1892 he was appointed professor of civil procedure and received from that university the degree of LL.B.

Appointed Magistrate in 1896.

In 1896, with the approbation of all sections of the community, he was appointed District Magistrate for Bedford and St. Francis and in 1901 his jurisdiction was extended to the District of Arthabaska. He continued as District Magistrate from 1893 until about five years ago when he resigned, and was replaced by Judge J. H. Lemay.

Apart from the numerous positions which he held in the legal profession, the late judge also took a keen interest in educational matters, and was a former chairman of the Board of Catholic Commissioners.

In religion the late Judge Mulvena was a faithful member of the Roman Catholic Church.

In 1895 Judge Mulvena was married to Elizabeth Mary Doherty, youngest daughter of the late Hon. Mr. Justice Marcus Doherty, and a sister of the Hon. C. J. Doherty, of Montreal. Mrs. Mulvena predeceased her husband in October last.

The late judge is survived by two sons, Messrs. Marcus and Desmond Mulvena, and one sister, Mrs. L. Mooney, of this city, as well as by several nieces and nephews.

The bomber, a man of foreign appearance dressed in working clothes, entered the bank yesterday and presented a demand for \$2,000, "or I'll blow up the bank."

Bank officials, after an investigation, fixed the damage to the 24-storey building at upwards of one hundred and fifty thousand dollars.

"O Lord, give us a guide opinion of ourselves" was the very sincere prayer of a penetrating old Scotsman whom nature had endowed with a knowledge that self-confidence is the first law of success.

Nationally speaking we are badly in need in taking this advice to heart. We have inherited a good deal of that British spirit of self-restraint that keeps the rest of the world making bad guesses about the state of the foundations of the British Commonwealth of Nations. It has permeated into our natures so that we are reluctant to stand on street corners and scream out our attainments. We live next door to a neighbor much of whose success is due to advertising and perhaps that proximity has produced in us a reaction against that sort of broadcasting and consequently we have failed to announce our own achievements with sufficient force.

Canada has had much the same struggle that Scotland has had against nature, for it has taken generations of grit to convert an unknown land into the land that is Canada today.

A Distinct Canadianism

We have nurtured, fostered, developed and achieved a distinct Canadianism. We have estab-

lished a system of representative government founded on the most enlightened of democratic principles. We have a system of justice unsurpassed anywhere. We have founded it upon two opposing sets of laws, the French laws of old Royalist France as they survived the British conquest, pre-dating the laws of Republican France, and the ancient British laws which were founded upon the ethics of Saxon days. Upon this foundation we have built the superstructure of our law courts.

We have fought nature and we have fought circumstances. When we seemed to be getting a good grip on affairs, along came the war and never did a nation at Canada's stage of development enter a harsher finishing school than the four years of struggle which left us with a war debt that consumes forty-three per cent of our national expenditures every year, and sixty thousand little white crosses in France and Flanders of over sixty thousand Canadians who would be spending brain and brawn in our fields and factories today, but for the ambitions of the exile at Doorn. But who can calculate the value of the priceless certificate of nationhood which we get in return for our share in the great war? Twelve years ago, could you have found as many passionately proud Canadians in your own circle of friends as you can find today?

Canada has the greatest undeveloped mineral resources in the world, and lies one-half within the pre-Cambrian mineral belt, the wealth of which is inexhaustible.

Canada has the world's greatest transportation systems, both the Canadian Pacific and the Canadian National having unique records. The Canadian Pacific is the greatest the world has ever seen, for in addition to its Canadian railways it has vessels sailing to all parts of the world. The Canadian National is the greatest publicly-owned railway in the world comprising more than 22,000 miles of road.

Canada has the best all-round educational system in the world, and one in every five of the population is registered in educational institutions.

Canada is the playground of the world. Tourists who entered Canada by means of motor cars only, in 1925, equalled the total population of the country.

Canada has provided the world with its greatest known variety of wheat, Marquis, which added an empire to the world's productive area and now is adding another empire by means of another Canadian wheat, the Garnet, exhibition in the world in the Canadian National Exhibition.

Canada has 423,000 miles of open roadway and is spending thirty millions a year on development and repair. There is one motor for every fifteen people in the country.

In point of population we stand twenty-fifth among the nations of the world, but we stand sixth in the ranks of exporting nations, and only one country surpasses us in the value of exports per capita.

The twentieth century is ours. We have claimed it and Fortune seems to be smiling upon our claims. The further we push back the curtain from the north the richer our reward. The farther north we fix our farms the greater we find is the fertility of the soil where winter frosts provide moisture for the brief but brilliant summers. When we get past our farming belt we drop into a mineral belt which makes Croesus look like a pauper. When we leave it behind we are in a fur belt from which the Hudson's Bay Company has been drawing fabulous wealth for two hundred and fifty years without making an impression on its resources and which can never be depleted of its furry crops.

It's a great country to pin your faith to. Pray the Scotsman's prayer and let us get a good opinion of ourselves. Make this your creed of country:

"I believe in Canada. I have confidence in her institutions, faith in her future. I honour her as my home, cherish her ideals of justice and a second chance. I believe Canada has a destiny to fulfill among the nations of the world and that it is my birthright to help in creating an intelligent, happy, prosperous and law-respecting people. I believe that though I treasure the traditions of other lands from which our people have originated, that my whole allegiance should be pledged to Canada which is my home."

Socialist Countess Declined Royal Rank

Seeks to Abolish Private Ownership of Land and Has Given Home to Labor Cause

Countess of Warwick Had Charm and Wealth But Championed Rural Poor---Radical Warwicks of Another Day Saved Castle

KENILWORTH SUFFERED WITH OLD ORDER

An intriguing personality is the "Socialist Countess," the charming Lady Warwick, who has recently demonstrated her sincere attachment to the British Labor Party by presenting to it Easton Lodge, a lovely Essex estate, as a home for Ruskin College, now at Oxford. She is one of those curious examples, not rare in English life, of one of wealth and aristocratic standing joining the ranks of the workers. Lady Warwick is genuinely sincere about the tenets she preaches and is regarded as a socialist writer and exponent of authority.

Might Have Been a Princess

Curiously enough, this same gifted and charming woman who is now so picturesque a figure in Labor circles, was once destined to be a daughter-in-law of Queen Victoria. Frances Evelyn Maynard became an heiress of a great estate in Essex, including Easton Lodge, when she was an infant, and with her wit, culture, charm, and great wealth she was a rare matrimonial prize in the middle Victorian era.

Prince Leopold, the delicate son of Queen Victoria, became attached to her, and even the austere royal mother regarded the match with pleasure. Lord Beaconsfield relaxed his attentions from his political office in order to assume the role of matchmaker, so interested was he in the royal romance. However, it takes two to make a marriage, and the winsome Victorian girl preferred Prince Leopold's friend, the young Lord Brooke, later to become Earl of Warwick.

The friendship of the Earl and Prince Leopold continued to be one of those rare and beautiful episodes that ended only with the death of the prince. When the great wedding took place in Westminster Abbey the prince attended the Earl of Warwick. It was a big event in

English society, and the great church was filled with those anxious to see the young pair safely launched on the sea of matrimony. The earl himself tells of the dismay the bridal pair felt when, upon emerging from the Abbey and entering their carriage, the ancient traces of the Warwick state carriage, unused and untested for years past, suddenly gave way as the horses started forward, to drive them to the wedding reception! The party was held up until someone found rope with which to make good the breach in the harness, and the journey could be commenced.

Forgot Her New Name

The honeymoon was spent in the country near Windsor, and in a few days a note arrived from the Queen asking the young pair to attend a party at Windsor, and the bride was specially asked to wear her wedding dress. It was a trying evening for the young girl and her youthful husband, "exhibited" in the royal circle, and subject to some good-natured teasing from the young people of the family. It is easy to understand how the bride, in her nervousness, forgot her new name, and upon being asked to sign the Queen's birthday book, wrote herself Frances Evelyn Maynard!

She is not the first of the family of Warwick to entertain radical sympathies, for the magnificent castle of Warwick as it stands today, one of the "stately homes of England," is a monument to the sentiment of the members of the Greville family who supported the anti-royalist Cromwell in his fateful campaign.

It is interesting to imagine the attitude of the royalists of the seventeenth century toward this man who had apparently no regard for tradition or for the places and things

which spelled English historical associations. Mutilated monuments, ruins of castles and churches stand today as testimonials to the fierce spirit that prompted the radicals of that day, under Cromwell, to burn and destroy. However, Warwickshire was the cradle of the parliamentary movement and Warwick Castle was a stronghold of the Cromwellian forces. Within the castle today are preserved relics of that fierce conflict and its great chief. After one brief siege the great castle was spared any further

conflict and so escaped the fate of so many English castles which fell prey to the hands of the Cromwellians.

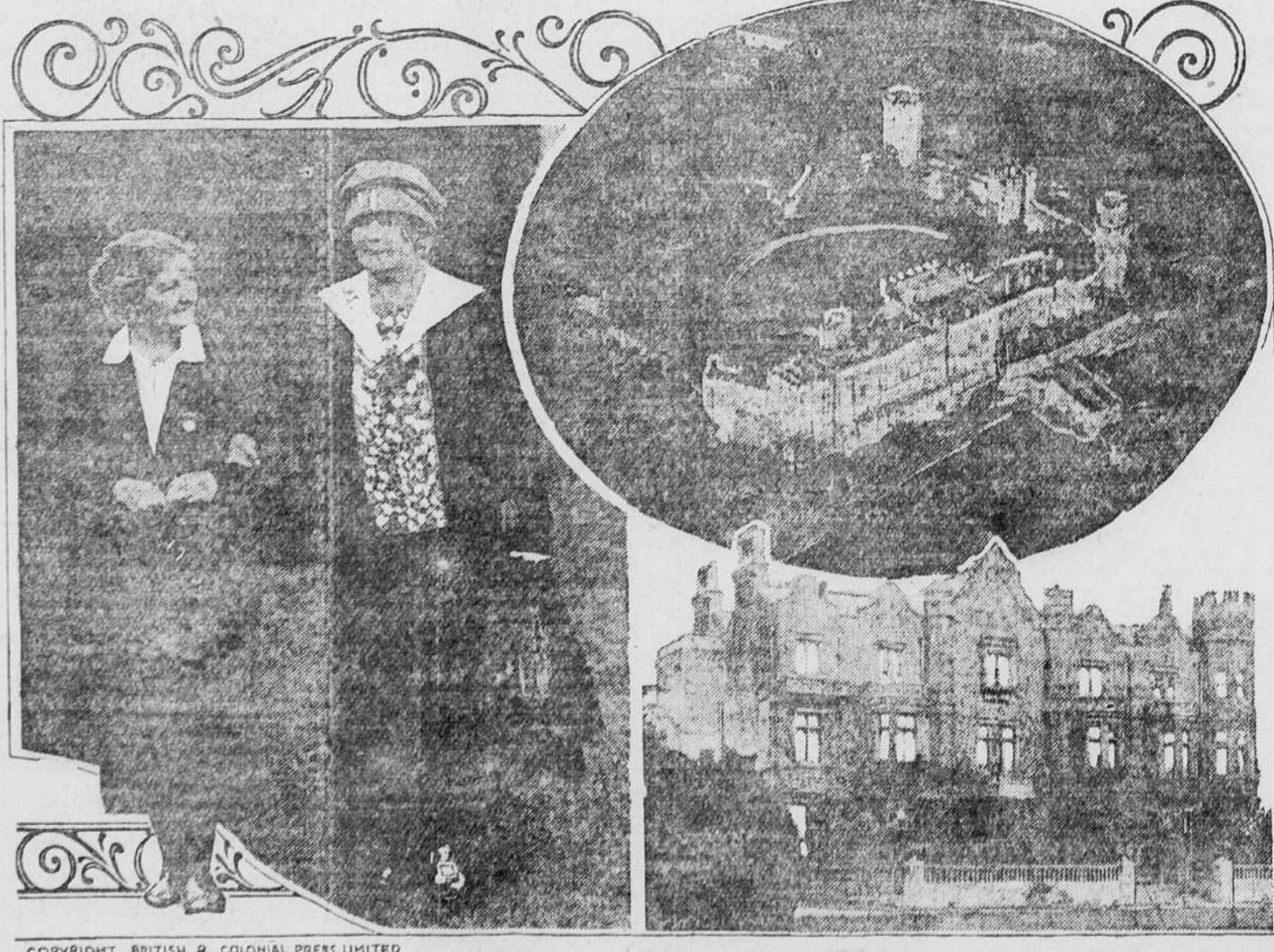

graceful arches, re-clothe its naked walls with tapestries and burs again within its mighty fireplaces the great logs that warmed and cheered the great Virgin Queen and her Earl of Leicester who, in spite of all his failings, roused within her the only womanly emotions she ever displayed.

But for the privilege of strolling

through the rich rooms of Warwick, Kenilworth's successful rival, the visitor parts with half a crown and smiles to think of the disgust of the great king-maker, Richard Neville, Earl of Warwick, could he picture these groups of "trippers" daily ushered through the historic rooms of his castle to gaze with mingled emotions upon the relics of centuries.

Countess Wants State Ownership.

Yet, steeped as she is in the traditions of her race, and more especially in the associations of her husband's family and ancient possessions, Lady Warwick holds some extremely advanced ideas. She advocates the abolition of private ownership of lands and would have every man have as much land as he can farm, and no more, while those whom he engages to aid him in his labor (if he sought for more than his own hands alone could produce) should profit by a share in the earnings. She has always been an advocate of free state education of children and adult suffrage. The abolition of the House of Lords and the disestablishment of the Church of England and the disendowment of the churches are also included in her creed.

Founds a School

One of her first efforts in removing social barriers was to found a school where the daughters of professional men could be trained in horticulture, dairying and bee and poultry keeping. She believes education is the means of social revolution.

She also established scientific and technical schools for rural Essex, and a home for crippled children in Warwick.

THE JOYS OF THE POLITICAL CHIEFTAINS.

Few persons probably realize just what a political leader undertakes when he enters upon an election campaign. A little reflection, however, will convince one that it is not a job to be envied.

Premier Meighen, after his keynote speech in Ottawa, left for the Maritime Provinces, making many speeches there, and then went West where he has been speech making ever since, and has two weeks of strenuous work ahead.

Hon. Mackenzie King began at Ottawa, went West speaking from Prince Rupert to Winnipeg, and is now away to the Maritime Provinces.

Mr. King's day in Quebec probably affords a fair example of what the leaders of both parties are undertaking in their campaign. Travelling and speaking and little rest constitute a daily programme which must tax the physical endurance to the limit.

The cheers of the crowds and the unflinching interest of the public in the political hustings are the sustaining force of the day and the faith which each holds in the justice of his cause coupled with the belief in victory, is the incentive which carries them through to election day.

SHOULD MAYORS BE PAID?

There have been discussions in Sherbrooke in days gone by as to whether mayors should be paid. At one time the answer was "Yes" and for a few years the mayors of this city received a small salary. Then the other opinion prevailed and the answer was "No" and still there was no shortage of mayors.

In Ontario, it appears that most of the cities pay their mayors. Up in London, the mayor of that town has advanced the idea that this remuneration ought to be done away with. The honor he thinks, is ample remuneration.

Over in Hamilton this view is challenged by the Spectator which observes:

The mayor of London, Ont., has come to bat with a suggestion that chief magistrates of cities should serve without salary, but there have been no loud and ringing cheers and there doesn't seem to be any particular reason why there should be. The mayor of a city is general manager, installed by fellow shareholders, to administer what in most municipalities is pretty big business. Almost without exception, elected mayors are men of other interests and, while the honor that goes with the office is not deemed unimportant, it is out of the question to expect business and professional men to neglect their private affairs without compensating remuneration. As Mayor Treleaven has pointed out, the suggestion of the mayor of London, if acted upon, would narrow the field of mayoring down to a group of men of independent means. In his own case, it is doubtful if the stipend he receives compensates Mayor Treleaven for the hours the chief magistrate's job keeps him out of his law office. There is another angle to the job with which the public is not familiar. Scarcely a day passes that the mayor is not called upon to subscribe to one or another of the local charities, or to dip down in his jeans for a book of tickets for bazaars or benefit. The public would doubtless be surprised if it knew the extent of these "teaches" each year.

There is of course something to be said on both sides. A point in favor of the non-salaried mayor is that the office is taken out of the realm of things to be striven for because of their monetary value. If a salary of \$2,000 was attached to the mayoralty in Sherbrooke, for instance, there would be no end of chaps, with a pull with the public, who would consider themselves fitted for the job. As it is, the office is purely a way to public service and as such it commands the interest only of men interested in public affairs and disposed to make sacrifices in the public interest.

Until the volunteer mayoralty timber, of good quality, fails, the system of remunerating mayors with honor rather than cash is not unsatisfactory to the ratepayers.

THE DEMON FLOWER.

(By Dr. Frank Crane)

Sara Carham-Mulhall, formerly director of New York's state narcotic drug control, calls the opium poppy the "demon flower." She is engaged in the movement to educate the country respecting drug addiction.

This plant may well be called by this name. It is one of the most deadly menaces to humanity in existence, and like all deadly menaces it may be of use.

Opium is like fire. When it is properly controlled it is a valuable servant for the people. Fire in stoves and in furnaces supplies the motive power and comfort of the people. Fire uncontrolled devastates woodlands and cities.

So it is with opium. When it was discovered it was thought to be one of the greatest boons to humanity. It could render a person insensible to pain in certain crises.

It was found, however, that its real value was offset by its danger. Opium strikes at the thing most necessary in the human being. It saps the will and blunts the moral sense.

A person who has come under the influence of this drug is no longer responsible. Often you cannot restrain him, for the law will not permit it. He really is a dangerous man and needs looking after.

A recent writer in public service says that he remembers "a boyhood principal who was an addict, a physician addict, two reporter addicts, a mother addict, and a pastor addict whose tragic descent was the kind of thing it is easy to prove impossible."

The approaches to this subservency are very subtle and a man's power over himself is gone before he knows it. His downfall is very difficult to stop.

Some plan ought to be adopted to control the supply of opium in the world and limit it to

strictly medical purposes. It probably is the outstanding menace to the human race.—Cpt. 1926.

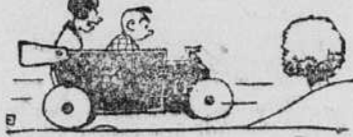

PRESS COMMENT

I. ZANGWILL.

Israel Zangwill is dead. He was not quite the English Heine, though he wrote in appreciation and understanding of that brilliant cosmopolitan in a way which has not been surpassed. Zangwill proved anew the gift of the European Jew for the possession and expression of a truly European character and genius. He was a good Englishman for that matter, but every drop of his blood, every gleam of his keen intellect, was opposed to insularity. He knew America as well as any Englishman, any European, of his time, but that meant, with his disposition, that he knew American weaknesses and dangers, and was not afraid to expose them. What he said and did never quite suited any nation; it did not even please the Jewish race to which he belonged and which he loved, and which he sought to make a nation. And that did not mean that he was unkind either in thought or words. He was honest in heart, searching in his thought. He has left a body of work which is full of sentiments and beauty.

Zangwill, like Heine, has left, in good truth, no matter what opposition his frank utterances may have provoked, a world full of lovers. He was witty, he was wise; his heart bled for the miseries not only of the people of his race but for all who were poor and hard-pressed. As a critic and an essayist he was readable not merely for the point, the charm of his words, but for the coolness and the far reach of his thoughts. His death, at sixty-two, is a loss not only to English literature but to the good will and onward-faring sentiment of the world.

TRADE UNION TYRANNY.

One of the admitted blunders of the general strike in England was the shutting up of the newspapers. It was an ominous indication of what the Trades Union Congress might do if it gained complete power. People did not fail to point out the strange likeness between the attitude of the Italian dictator and the English proletariat. But the lesson does not appear to have been learned. At the recent meeting of the National Union of Railwaymen at Weymouth, a resolution was promptly adopted to the effect that "only representatives of trade union papers should be eligible to report the public proceedings of this conference." What was meant, of course, was newspapers having the closed shop. But to the credit of the reporters present, not even those who might have qualified under the terms of the resolution remained in the hall. They all left in a body as a protest against such an interference with the freedom of the press. The Daily Herald itself, the Labor newspaper, was for a time at least left without a representative.

Such an action as this of the Railwaymen's Union has rightly been described as exemplifying "the mind of tyranny." A tyrant, a dictator, cannot bear discussion, and feels that he must control every medium of communicating information to the general public. Uncolored truth he considers inimical to himself. The free reporting and printing of what he says or does or proposes, he cannot tolerate. That trades unions should be ready, on slight occasion, to set up this form of censorship or suppression of the press, does not argue well for the quality of their leadership. Yet Labor censors have long been known in England. When Mr. Hamilton Fyfe was editor of The British Worker, he wrote: "I have four censors sitting at my table—a large one, fortunately—who go through every line of type." This gives an unpleasant hint of what sort of rules for newspapers Labor would lay down if it got into a position to do freely with the English press what Mussolini has done with the Italian. Happily, labor leaders in the United States are too clear-sighted, saying nothing of any question of principle, to commit such a mistake as that which the English trade unionists have repeatedly fallen into of seeking to deprive the public of legitimate information.

IMMIGRATION PROBLEMS

Sir—The story of a little boy who, hearing that rabbits multiply rapidly, found that his couldn't even add, is told by Mr. Lawrence Dale, writing on "Australasia" in an American magazine. Might not Canadians profitably think of high fecundity like Mr. Dale's rabbit's in connection with the birth rate of the Mediterraneans today commencing a peaceful penetration of your Dominion?

You have, for example, the beginnings of Italian immigration. Excess of births over deaths equals a yearly increase of Italy's population pressure about equaling the combined population of Alberta, Saskatchewan and British Columbia. Such pressure formerly forced Italian immigration into the United States. These, once admitted multiplied like Mr. Dale's rabbits. Mention America's Nordic, overwhelmingly British-Nordic, family averaged about three kiddies! Three times three repeated four times, gives, in the fifth generation, an original family represented by 243 Nordic children. The Italian family everaging seven children, shows, in the same time, 16,807.

With a quarter-million new immigration annually, and with each yearly increment thus displacing, by its fifth generation our old Nordics at a rate of 69 to 1, we had to call a halt. The Johnson Act cut the 250,000 annual Italian inflow to 40,000. The 1924 Johnson Act further reduced this to 8,845, simultaneously slashing Greece's quota to 100.

Italians in your area today are about as scarce as they were in the United States in 1850. Our newcomers of 1850 were, however, the very thin edge of a wedge. Behind it in the Fetherland was such forceful population pressure that, in 1910, we were admitting the above quarter-million annually. Only in 1921 we could muster sufficient strength to halt that wedge. It threatened, meantime, to destroy our Anglo-Saxon Nordic civilization, our and your common heritage from Britain.

Your Dominion being Nordic-founded and Nordic-managed is blessed with a high living standard like ours. Denied admission here the Mediterranean travels a little farther to knock at your door. If you accept what the States reject, you will sink as we had commenced to sink, to the level of Latin-America. This ought not to occur. Notices must save Canada, as well as the two Australasian Dominions, as we are trying to save what is left racially of the United States, for the descendants of those Nordics who alone could claim from nature these once open spaces.

He was not enough to speak with the tongue of a man and not with the accents of our ancestors of five thousand years ago.

Again there was a laugh. Mr. Meighen emphatically classes as fabrications reports that he intended to amalgamate the Canadian National with the C.P.R. He declared his intention to introduce a new soldier settlers' revaluation bill if returned.

Urged His Views on Protection. "Mr. Dunning said, 'Mr. Meighen pursued, 'that when I came to western Canada I would not talk protection. Why, I never stood on a platform in Regina or in western Canada where I did not declare definitely, formally and without reservation for the principle of protection.'

Mr. Meighen asked why Mr. Dunning had not moved at Ottawa the tariff resolutions he had supported in the Saskatchewan legislature.

"He's not had the experience yet," shouted one heckler.

"He's not been there seven years," shouted another.

"And he won't move if he's given seventy years," Mr. Meighen retorted. Conservatives had never asked for a high and high tariff, he went on. But they did believe in the principle of protection definitely, permanently and universally applied.

Interspersed through Mr. Meighen's speech was some swift retort.

Mr. Meighen spoke of a Liberal candidate in Nova Scotia running on a secession ticket.

"He is 87 years old," came a sharp interruption.

"Then one would think he had reached the age of wisdom," was Mr. Meighen's retort.

Mr. Meighen spoke of the sale, under the King government, of denatured alcohol, a month before the general elections.

"That's how they got into power," a voice called out.

"That's how they pretty nearly got into power," Mr. Meighen shot back.

Once more a laugh went around the hall.

Mr. Meighen turned to his conversation with the Governor-General, when, on the resignation of the King government, Bar a Byng invited him to form a new administration.

"What should I have told the Governor-General?" Mr. Meighen questioned, pausing for a reply.

"Told him you couldn't do it," a voice called from the crowd.

"That would have been a falsehood because I could," Mr. Meighen returned.

When the King government resigned, Mr. Meighen added, there was no government. Was it not then the duty of the leader of the opposition—the leader of the largest party in the House—to endeavor to form an administration? Especially so, Mr. Meighen proceeded, when he knew that if the King government were called back, the parliament of Canada would ensure it for malfeasance of office.

Regarding Dr. Paquet. When Mr. Meighen closed his speech a returned man asked if it was true that Dr. Paquet, the new minister of health, had thrown mud at the Union Jack in 1911.

"No," Mr. Meighen replied, "it is just another Liberal falsehood."

Mr. Meighen added that Dr. Paquet's family had served in the war and that Dr. Paquet had served in Canada as best he could.

SMUGGLING OF LIQUOR IS FIRST INQUIRY

Sir Francois Lemieux Presiding at Customs Inquiry, Opened at Halifax This Morning.

(Associated Press Despatch) HALIFAX, N.S., Aug. 25.—(By Canadian Press) — In the historic legislative council chamber of Nova Scotia with paintings of Long dead monarchs of Great Britain, adorning the walls, Sir Francois Lemieux, this morning opened the investigation into the department of customs and excise. Proceedings were brief, but one witness being examined this morning, R. L. Calder, K.C., associate counsel with W. F. O'Connor, K. C., for the commission intimated however, that tomorrow there would be plenty for the commission to do. One witness A. J. Doucet, former Conservative member of parliament for Kent, N. B., will be examined when the commission resumes this afternoon.

"I hope this commission will be held as a national commission to serve the interests of the people and the interests of the country at large," said Sir Francois in opening the investigation. Proceedings were formal in their nature, Commissioner, counsel and registrar being attired in black gowns.

Concerning Liquor Smuggling. W. C. Acker, collector of customs for Halifax was the first witness, when the Customs Inquiry opened today. He was appointed collector in January 1920 after being in the service since 1889. Mr. Acker said that the personnel under him was about 108 men with 28 special men. His inside staff numbered 91. There were no preventive officers under his direction. These came under the control of W. F. Wilson, chief preventive officer at Ottawa.

"Who is in charge of taking bonds from vessels clearing with liquor?" asked Mr. Calder.

Mr. Acker replied that he was. He had always carried out instructions to the effect that clearance for a foreign port should not be granted to such vessels as were not in fit condition for the voyage.

"What is the chief form smuggling takes in this province?" "I would say liquor," was the reply.

"What difficulties do you encounter dealing with this problem?" Mr. Acker said that prevention of liquor smuggling in Nova Scotia was not easy. The long and much indented coastline and foggy weather made landing of liquor a simple matter. He suggested distribution of detachments of mounted police along the coast to watch landing places and also a material reduction in duties on liquor. This would make the smuggling business much less profitable.

He informed the commissioner that the customs department at Ottawa had ruled that Canadian vessels must be seized or searched outside the three mile limit.

"A most extraordinary decision," interjected W. F. O'Connor, K. C., counsel. Mr. Calder referred to this ruling as a "staggering conclusion to those of us who are familiar with constitutional law."

Mr. Acker suggested that the right of search and seizure outside the three-mile limit would be a material help in suppressing liquor smuggling. Other steps included the stationing of detachments of mounted police at strategic points along the coast line, and reductions in the liquor duties. He stated that a smuggler had been arrested inside the three-mile limit in Cape Breton but the bench of judges had non-suited the case on the ground that smuggling meant actual landing of goods in Canada. In the majority of cases smugglers were arrested at the time seizures were made.

Mr. Acker told of a seizure made in Cape Breton some time ago within the three mile limit. The smuggler was arrested, but a bench of judges had non-suited the case on the ground that smuggling must mean the actual landing of goods in Canada. Mr. Calder drew the attention of the commission to the case.

Mr. Calder asked if smugglers caught in the dock were arrested at the time of the offence.

Mr. Acker replied that this was done in nearly every case.

Mr. Calder suggested that adjournment be made until three o'clock in the afternoon as there was but one more witness to come before the commission today.

INSCRIPTION ON MONUMENT TO CAN. NURSES

(Associated Press Despatch) OTTAWA, Ont., Aug. 25.—The monument unveiled yesterday in Canada's Hall of Fame in the Parliament Buildings and dedicated to the memory of Canada's nurses who were killed in the Great War will bear the following inscription incised in its base in dull gold letters:

"Erected by the Nurses of Canada, in remembrance of their sisters who gave their lives in the Great War, 1914-1918, and to perpetuate a noble tradition in the relations of the Old World and the New.

"Led by the spirit of humanity across the seas, woman by her tender ministrations to those in need has given to the world the example of a heroic service, embracing three centuries of Canadian history."

The words were composed for the memorial by Right Hon. W. L. Mackenzie King when, as Premier of Canada, he made arrangements for the erection of the monument.

BAIL HEARING IN STEVENS-HALL MURDER

SOMERVILLE, N.J., Aug. 25.—Supreme Court Justice Charles W. Parker, home from the Maine woods, announced that he will hear application to admit Henry De La Carpentier and Willie Stevens to bail on Thursday.

Justice Parker's return from his vacation followed the refusal on Monday of Chief Justice Gannero to entertain the plea on the grounds that he was interfering with Justice Parker's jurisdiction.

Carpenter and Stevens are in the county jail charged with the murders in 1922 of the Rev. Edward W. Hall and Mrs. Eleanor R. Mills. Mrs. Hall, also accused of the murders, is free on \$15,000 bail.

LONDON POLICE MAY GO TO THE COAL AREAS

(Associated Press Despatch) LONDON, Aug. 25.—Reports of intimidation of miners seeking to return to work in the coal fields, while believed to be exaggerated in many cases, are understood to have caused the British Home Office to make preparations to move considerable bodies of police from London and other areas to the affected districts.

STOCK MARKET SHOWED MUCH ACTIVITY TODAY

Selling Pressure Noted in New York—Wide Range of Issues Figure in Montreal Trading.

(Associated Press Despatch) NEW YORK, Aug. 25.—Selling pressure was renewed at the opening of today's stock market, which displayed a distinctly reactionary tone. Popular industrials were again thrown on the market in large blocks, initial declines of a point or so being recorded by Allied Chemical, General Asphalt and Montgomery Ward. United States Steel common and General Motors each opened 1/2 lower, the former touching the lowest price since the establishment of the new record high of 159 1/2 last week.

Wide Range in Montreal Trading. (Associated Press Despatch) MONTREAL, Aug. 25.—Trading on the local stock exchange at the opening this morning was fairly active and well distributed in a wide range of issues. Values displayed an irregular trend. Brazilian, the leader, was soft, opening with a loss of half a point at 117 1/2, and in later trading touched 117 for a net loss 1/2 point. The Power (new) issues were in good demand and revealed a strong tone, the common advancing to 65 for a gain of one point, while the preferred was unchanged at 49 1/2. Laurentide was the weak spot of the early trading. This issue began the day at 103, off 1/4, and in subsequent trading moved downward to 101 1/2. Other features included Smelters, unchanged at 238, Wayagmack, also unchanged at 95, and Spanish River, off 1/4 at 108.
