THE OUTLOOK DOOMS GOUIN GOVERNMENT TO DEFEAT

Opposition Candidates Throughout the Entire Province Meeting with Magnificent Success

BIG PROVINCIAL CHANGE OF SENTIMENT

The Opposition Central Committee for the District of Quebec were in receipt of excellent reports from almost every constituency throughout the Province, which are filled with a ring of certain victory at the polls May 15th.

Consternation is reported to prevail in the Liberal centres of Quebec and Montreal, and every effort is being made to stop if possible the assured landslide in favor of Mr. J. M. Teller and his Opposition supporters. The change in political sentiment is more apparent in the rural than the city constituencies where the farmers especially openly manifest their desire for a change of administration. The extravagance of the Gouin Government in its pet scheme to build monuments at the people's expense to perpetuate the vanity of Sir Lomer Gouin has so incensed the electors of the rural parliamentary seats that they have declared themselves solidly against the Government.

The most astute politicians in provincial politics do no longer hesitate to express the opinion that a landslide is inevitable. In the meantime the Opposition candidates have no intention to be relaxed in their efforts. On the contrary, they are fighting solidly together, with the great majority of the electors ranged en masse behind them to route the Gouin Government, lag and baggage, from office. It is conceded by the Liberals that the Montreal District will go to swell the Opposition majority, that will transform it into the coming government of the Province.

The result is no longer in doubt; it is now only a question of majority, with the certainty of Mr. Teller coming to power with at least from 35 to 40 seats majority in the next meeting of the Legislative Assembly. In the victorious Opposition column will be found at least 17 out of the 23 seats, including the defeat of three ministers—Hon. Messrs. Taschereau, in Montmorency; J. E. Caron, L'Islet, and J. C. Kaine, Quebec West. If there are any skeptics living who doubt the handwriting on the wall which conclusively spells out the Gouin Government's defeat, all they have to do is read the daily reports in the Opposition papers, especially the Soleil, and they will be convinced of the positive change of political sentiment from one end of the Province to the other.

The exaggerated falsification of facts to gull and mislead the electors are sufficient to demonstrate the dying despair of the doomed Gouin Government is plainly manifest. The Soleil on Monday last, in its report of Mr. Huard's meeting at the Jacques Cartier Market Square, showed its chargin by deliberately lying about the meeting. This chief Quebec organ of the Gouin Government went out of its way to tell its readers that the most orderly and respectable assemblage of 6,000 or more Quebec East electors was characterized by interruptions, notwithstanding the contrary.

This style of reporting may suit the management of the Soleil, but it has a different effect on the intelligent public, especially upon the immense number of St. Roch's electors, who attended the Opposition meeting on Sunday last. However, Wednesday next, May 15th, will tell the tale, and tend to squelch the lying exuberance of the Gouin press.

Mr. Armand Laverge, who is contesting both the Counties of Montmo-

rency of Montmagny, left for the latter last evening to consult with his organization committees and address the electors. There is no need of Mr. Laverge going to Montmagny, or, in fact, Montmorency, as the electors of both these counties have assured him of certain victory. Nevertheless, the young and popular politician feels it his duty to go among the electors of both counties as much as possible, though his presence and services are in great demand in almost every county in the Province.

Before leaving for Montmorency, Mr. Laverge held a conference with several leaders of the Quebec District and appeared jubilant over the sanguine reports he had received, and does not hesitate to say that the Gouin Government will be swept from office by a landslide of public sentiment whom desire a change of Provincial administration.

City Divisions.

Considerable activity was displayed by the candidate upholding the Opposition standard in the city divisions yesterday and last night.

Mr. Charles Smith put in a busy day making a personal canvass in the Lower Town and Montcalm Ward, and last night he visited his committee room at 62 Scott street, Montcalm Ward, in the interest of organization. Supporters who, hearing of his presence, flocked to the committee rooms to assure him of their support and victory. Among these were old-time Liberals, who said they wanted a change of administration, besides were most anxious to have a representative in sympathy with the Ottawa Government, especially in view of the impending terminals and harbor improvements in prospect to upbuild the city and port of Quebec to come from the Borden Government. Another reason given was their entire dissatisfaction with their present representative, Mr. Kaine, who lacked every requirement that was necessary in a man to represent an important division like Quebec West. He had been tried for eight long years and his record did not in the least entitle the electors to renew his mandate.

Quebec Centre.

Mr. Romeo Langlais, the Opposition candidate in Quebec Centre, devoted his time last night to organization and personally canvassing a number of electors. Mr. Langlais is meeting with unqualified success and expects to gain a large majority over the Government candidate, Mr. Leduc. In the meantime he regrets sincerely that want of time alone will not permit him to call on and personally canvass the votes of every electors in his division, and expresses the wish that those electors he is unable to see under the circumstances will take the will for the deed and rally to his support May 15. Mr. Langlais' friends who are working like Trojans in his behalf, not only feel sure of his election, but estimate his majority will be up into the hundreds.

The electors of Quebec Centre, one of the most intelligent and important constituencies in the Province, feel the same about parliamentary representation as the electors in Quebec West, and openly express their chagrin at their interests and the interests of Quebec in general should be entrusted to a man of ability, a good spokesman of energy, enterprise and ambition, and not in the keeping of a nonentity whose only qualification is a willing tool at the behest of his mas-

ters and silent voting machine in the House, on question of legislation that he neither understands or takes the trouble to learn.

Quebec East.

The meeting in Quebec East on Sunday last, in favor of Mr. Alp. Huard, the Opposition standard bearer, has had a good effect. It has been the means of awakening a strong determined change of sentiment in favor of Mr. Huard and points to his triumphant return by at least 300 majority. He is, however, taking no chances and is working very hard day and night. An independent canvass of the division clearly demonstrates that the division is extremely anxious to be rid of the Government candidate, Mr. Louis Letourneau, another incompetent that should not be tolerated by such a rich and important business and manufacturing centre as Quebec East. Added to his incapacity, the Letourneau-Leduc scandal is still fresh in the memory of the people of St. Roch's and they are determined to try and wipe out the disgrace by Mr. Letourneau's defeat.

Levis County.

Mayor A. Bernier, the Opposition candidate in the County of Levis, is meeting with great success. His organization is good and his supporters enthusiastic over his certain victory. The public meetings held in his favor are largely attended and everything in connection with his campaign points to his election by a large majority. The electors of Levis County have not been as interested in an election for years as they have in the present contest, and the knowing ones estimate that Mr. Bernier's majority will be nothing short of 700, especially as the shackles have been stricken from over a thousand voters who were gagged and bound in the chains of Lib-

SEVENTEEN LIVES HAVE BEEN LOST

Dreadful Destruction Has Been Done by the Floods of the Mississippi River.

Baton Rouge, La., May 7.—Seventeen lives are known to have been lost in the Torras crevasse in the Mississippi levee. Three white persons were drowned today on Bayou Latnache when a raft on which a farmer, his wife and two daughters were endeavoring to reach high ground was broken to pieces by the swift current from the break. The farmer was the only one rescued. Fourteen negroes lost their lives in the Letsworth neighborhood.

BEATTIE NESBITT WILL MAKE APPLICATION

Toronto, May 7.—Dr. Beattie Nesbitt, through his Chicago counsel, W. K. Pattison, will probably make application for release under a writ of habeas corpus before Justice Judge Carpenter, of the United States Federal Court at Chicago.

In a letter received to-day by H. H. Dewart, K. C., Canadian counsel in the case, Dr. Nesbitt's Chicago attorney state that the preparation of the necessary papers has been completed.

WILL OF A VICTIM OF TITANIC

Large Sum Voted for the Pro- vision of a Higher Form of Amusement.

Halifax, N. S., May 7.—The will of George Wright, of Halifax, who perished in the Titanic disaster, is published. The figures provide for payments of \$275,000, irrespective of any surplus. Of the total \$66,000 goes to charity. Mr. Wright's residence on Young avenue, valued at \$25,000, is left to the local council of women, of which Mrs. William Dennis, proprietor of the Halifax Herald, is president, to be used as expressed in the will, as a headquarters in carrying on their work and assisting in suppressing evils such as he had been writing about and trying to put down.

Another bequest is provided for in the following words: "In order to provide for a higher form of amusement than is at present placed before the public, and for a building to be erected for the purpose of bringing the people together to uplift them and train them to higher ideas, such building to be also used for meetings, lectures, and to provide clean amusement in order to check the lure and bad influence of the streets, I give the sum of \$20,000 towards the erection of such a building and if necessary this sum can be supplemented by public subscription."

TITANIC WAS GOING FULL SPEED

One of Main Points Brought Out in the Board of Trade Enquiry.

London, May 7.—Shipwreck experiences consumed the time of the Board of Trade inquiry into the Titanic disaster today. Only three witnesses were disposed of. No new light was shed on the sinking of the steamer beyond the facts elicited by the American senatorial committee.

The examination was significant, because it showed the government's determination to discover what steps were taken to get off the third class passengers. The main points brought out in the general inquiry were that the ship was going at full speed; that no boat drills had been held; that some of the sailors did not know their stations, and that the boats were inadequately manned and directed and were not provided with lights, compasses, water or rations.

Whatever comparisons may be drawn between this "stately and well ordered tribunal," as one of the weekly reviews predicted it would be, and the proceedings before Senator Smith, the British court certainly is anything but expeditious. Sir Rufus Isaacs, the attorney-general, who is conducting the government's case personally, is not sufficiently acquainted with the details to manage with any economy of time. This is not to be wondered, when the burden of the work the attorney-general is attempting to carry on is considered. Besides the role of chief counsel of this court, he is attending to the regular routine of his office and participating in the Home Rule debate from his seat in the House of Commons. The result is that he has to stop frequently to consult with his assistants, while the inquiry halts.

The number of counsel representing the various unions who take a hand in cross-examination also tends to draw out the testimony. The first reference made to the American inquiry was when Sir Rufus Isaacs compared the statements of Quartermaster Hichens with those he made at Washington, but no material discrepancies were discovered.

SPRING WHEAT SEEDING IN MANITOBA

Minnipeg, Man., May 7.—Seventy per cent of the spring wheat seeding is finished in Manitoba and 85 per cent in Saskatchewan and Alberta, according to W. A. Matheson, head of the Lake of the Woods Milling Company. Acreage seeded to the prime cereal will show an increase of 35 per cent in Saskatchewan and 15 per cent in Alberta, but there will be no increase in Manitoba, though more coarse grain will be sown. Recent heavy rains have done a lot of good throughout the country, though they have checked seeding operations. Mr. Matheson considers the season very early and looks to the conclusion of wheat seeding by May 20. Farmers last year seeded up to the middle of June.

TWO BOYS BADLY INJURED BY EXPLOSION

Plaster Rock, N. B., May 7.—Stanley Turnbull, aged 16, and Clarence Turnbull, aged 18, sons of Walter Turnbull, of Wapascote, were terribly injured as a result of an explosion of a 25-pound can of blasting powder with which they were playing. The lads found a tin of powder and were amusing themselves by dumping small portions on the ground and setting it on fire. It was while they were in the act of shaking out some of the powder that a spark ignited the tin and with a roar it exploded, throwing the lads 20 feet apart. They were fearfully burned about the face and neck and the flesh was torn from their hands. Their eyebrows and eyelashes were burned off and their eyelids frightfully burned so that for a time it was feared that the boys would lose their sight. It is said they found the powder on the right of way of the Transcontinental, where it had been left by one of the contractors.

FLOOD IS ON ITS LAST LAP

Mississippi Has About Done Its Worst, and Relief Is Now in Sight.

New Orleans, La., May 7.—When the official river gauge at the head of Canal street registered 21.3 feet at 3 o'clock this afternoon, a rise of four-tenths since 7 a.m., United States weather officials were of the opinion that the Mississippi had started on its final lap toward the predicted crest of 21.5 feet, which would mark the passing of the greatest flood recorded in the Mississippi valley.

Clear weather and sunshine was reported to-day at all points from the Torras crevasse south to the mouth of the river. The work of rescuing marooned persons in isolated districts progressed more rapidly to-day, and boats coming into concentration camps are usually loaded with women and children.

There is a scarcity of every kind of navigable craft, and everything that can be steered and carry passengers and supplies for even a short distance has been pressed into service. Hundreds of primitive flat boats that can be towed by motor boats are being constructed.

Work on the levees has practically been abandoned here in the vicinity of the American Sugar Refinery. The hot sun to-day baked the repair work done during the past three days and the engineers are once more cheerful, many of them believing the worst has passed. The levees have been inspected and pronounced in good condition. The work of strengthening the levees on the Atchafalaya side has about been completed and experts believe more than a 22 foot stage can be held back.

Mayor Martin Behrman issued an appeal to-day for funds and supplies for flood victims of the northern and east central portions of the state. The newspapers have taken up the task of raising funds in connection with the relief committees and several thousand dollars and many carloads of supplies have been sent out from this city.

TROUBLE AHEAD ON OTTAWA STREET CARS

Ottawa, May 7.—This afternoon the Ottawa Electric Railway Company handed a reply to the President and Secretary of the Street Railway Men's Union saying they would not enter into an agreement with a union on matters relating to the conduct or management of its business. They were willing to discuss the question of wages and hours alone with a committee of conductors and motormen, Magnus Sinclair, representing the International executive of the Street Railway Men's Union, considers there is no further use trying to settle the men's demands peacefully. The company have rejected the union's requests almost entirely. Further action is awaited somewhat anxiously and a strike seems most probable.

COLORED PEOPLE WILL SETTLE IN CANADA

St. John, N. B., May 7.—The Parrishboro schooner Yolando, 72 tons register, Captain Hassel, arrived to-day from Sable Island, Dutch West Indies, with 38 passengers. They are all colored persons, and with the exception of one woman, all are young men. The master states they are a good class of people. It is their intention to settle in Canada. Several of them, it is thought, will go to Sydney. The Yolando, which has a crew of ten men, sailed from Barbadoes to Hassel for the purpose of getting ballast. The passage up was a tedious one, owing to the light head winds. She was detained in the bay for about ten days.

Winnipeg, May 7.—Violent earthquake shocks were recorded this afternoon by the seismograph of St. Boniface College. Father Blain says they began at 1.07 p.m., were very violent at 1.24, and ceased at 2.51. He puts the disturbance at 2,000 miles south-east.

"WILL REND THE BRITISH EMPIRE"

So Declares Ulster Member in British Commons Discussing Home Rule Bill.

London, May 7.—The Rt. Hon. Herbert L. Samuel, postmaster-general, defending the provisions of the Home Rule bill granting financial aid to Ireland, said it was impossible to establish an Irish Parliament under circumstances which would compel an increase of taxation in Ireland by from 15 to 20 per cent. Under the bill there was a prospect that the annual grant would be reduced to the vanishing point, but the Unionist policy would increase the amount given by the United Kingdom to Ireland.

The fact that Irish Nationalists in times past had made violent speeches

against the government, he contended, was no proof that they would not be loyal under Home Rule. In Canada and Australia similar speeches in large numbers were made before those countries got self-government. The attitude of the Nationalist members in earlier years was the invariable attitude of the representatives of a people who were steadily denied the right of self-government. That position the Unionists sought to perpetuate.

Andrew L. Horner, one of the Ulster members, declared that the attitude of Ulster still was: "Ulster will fight, and Ulster will be right."
"We are taking steps," he added, "to perfect the machinery so that when the bill passes our provisional government will begin to carry out its trust. In two years passive resistance can be transferred into active resistance. The first shots fired in this conflict will not only rend the British empire, but the British army."

Halifax, May 7.—The Cunard liner Utonia will sail for Montreal to-morrow morning at 5 o'clock. The shaft tube was plugged up to-day. The passengers were forwarded by two special trains leaving at 5 and 8 o'clock.

ANOTHER BIG STRIKE MAY BE DECLARED

London, May 7.—The strike of 100,000 transport workers may be declared should the Peninsular and Oriental Steamship Company persist in their refusal to meet the demands. The Transport Workers' Federation to-night decided to support the strikers, but appointed a deputation to approach the company again to-morrow before declaring a strike.

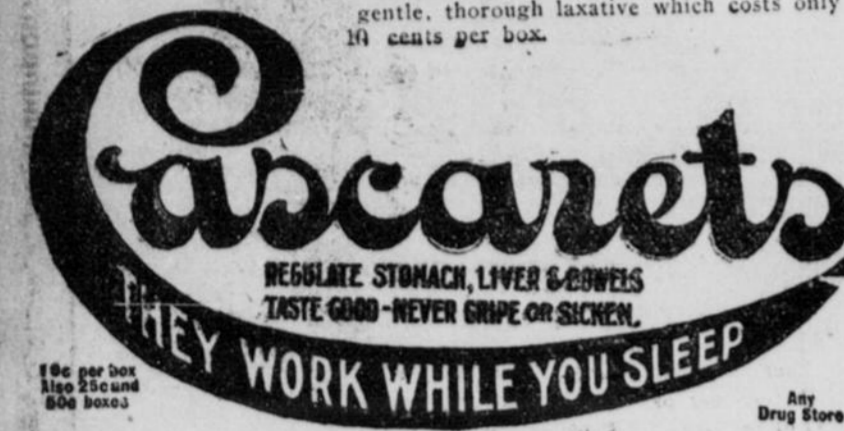

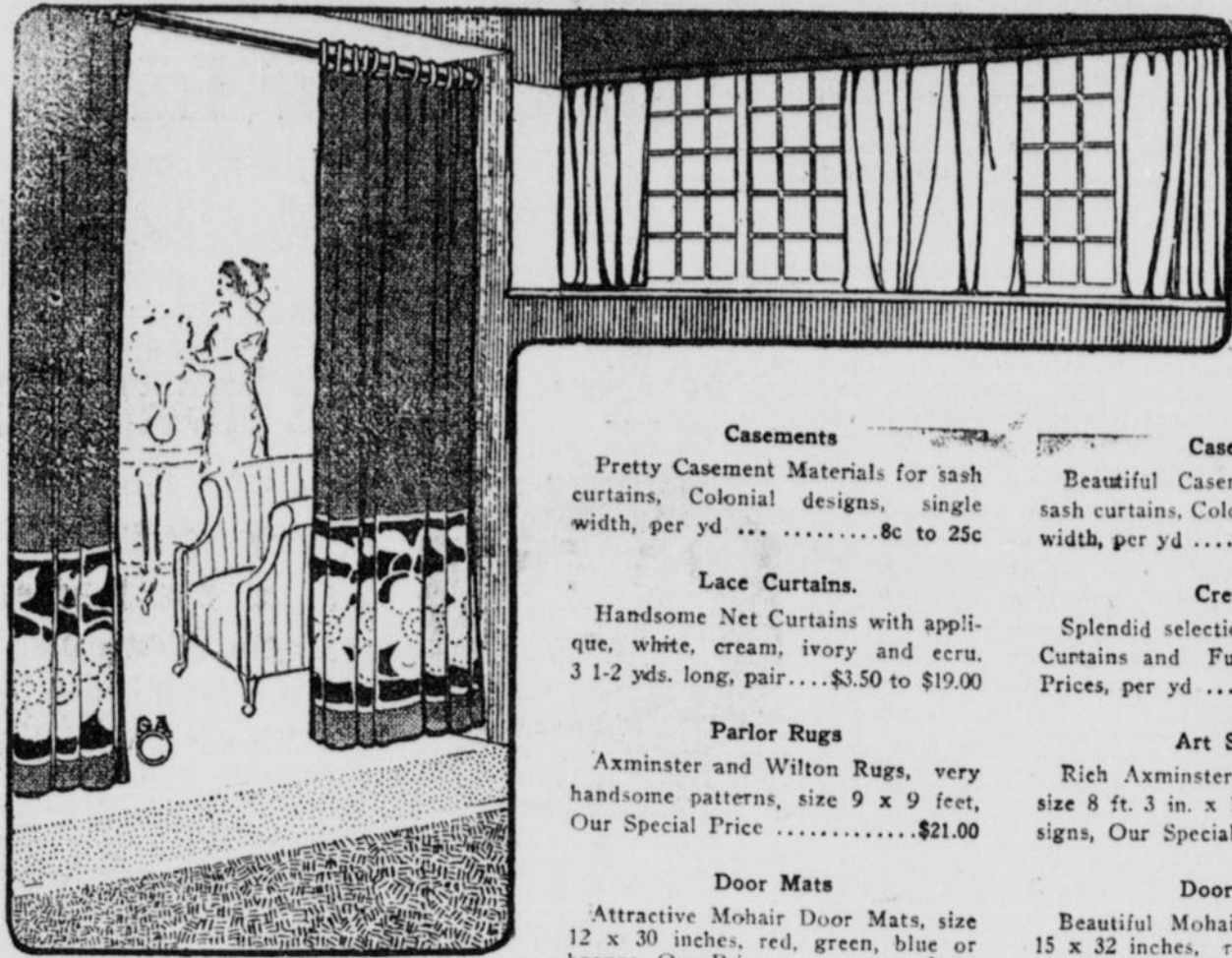

QUEBEC ELECTION APPEALS HEARD

Supreme Court Occupied With Three Rivers, Maskinonge and Nicolet Cases.

Ottawa, May 7—In the Supreme Court to-day several practice motions were postponed till the hearing of the appeals on the merits and the Three Rivers election case, Bureau vs. Normand, was heard. The appeal was from the judgment on preliminary objections to the petitions by which they were over-ruled. The appellants relied on two objections: 1. That the petition was premature having been presented and served before the appellant had been gazetted as member elected and that the status of the petitioner was not proved; 2. That the Clerk of the Crown in Chancery, having been summoned to produce the list of voters used at the election, sent a member of his official staff in his stead who presented sealed envelopes which he swore were supposed to contain the list and the record had a list with the imprimatur of the King's Printer. The petitioner swore that he was on the list and identified his name opposite a number thereon. The appeal was dismissed with costs. Lemieux, K.C., for the appellant and Bisailon, K.C., for respondent.

The Court then heard a cross appeal from a judgment in the same case by which preliminary objections to a cross petition were over-ruled. This cross appeal charged all the usual acts of corruption against the defeated candidate and his agents. Counsel argued that as the seat was not claimed on behalf of the defeated candidate the petition should be limited to charges which would disqualify the candidate. The same counsel appeared. Judgment was reserved.

In the Maskinonge election case, Bellemare vs. Hatle, preliminary objections were taken as to the status of the petitioner, that service was irregular and that the affidavit was defective. Vincent was heard for appellant and Lemieux, K.C., for the respondent. Judgment was reserved.

The appeals in the Nicolet election case and the Champlain election case were postponed and placed for hearing at the foot of the list of Quebec appeals as the appellants, who appeal from judgments on preliminary objections, desire to move in each case for the dismissal of the petition for want of prosecution. The Western Provinces appeals were then taken up.

LAST TRIBUTE TO JUDGE MABEE

Remains of Chairman of Dominion Railway Commission Laid at Rest.

Toronto, Ont., May 7—In the little town of Port Rowan, where he was born and lived as a boy, the remains of James Fitt Mabee, chairman of the Dominion railway commission, will be laid to rest tomorrow afternoon. The obsequies will be attended by an unusually representative gathering.

The special funeral train leaves the Union station at 9:15 tomorrow morning. The remains of the dead chairman will travel in the Dominion railway commission's special car. The train will carry other private representatives from Ottawa and one of the fellow members of the commission and their friends. The Canadian Northern will also have a special car, carrying Sir William MacKenzie, third vice-president, D. B. Hanna, and Hon. F. S. Phippen, chief counsel. Many judges will represent the bench, a staff deputation will represent Osgood Hall, and the Bar will be represented by several of its most distinguished members. The Ontario railway and municipal board also plan to attend in a body.

On arrival of the special train at Port Rowan, the cortege will be held prior to proceeding to the cemetery. The services, both at the church and at the grave, will be conducted by Rev. Mr. Williams, rector of the Port Rowan church.

Mayor Geary, Controller Church, and Corporation Counsel Drayton will attend as representatives of the city of Toronto, and there will also be delegations from the Toronto Board of Trade and the Canadian Manufacturers' Association.

ROOSEVELT LEADS IN TEXAS CONVENTIONS.

Dallas, Texas, May 7—Returns from 59 counties where Republican county conventions were held to-day show the following result:—Roosevelt, 22; Taft, 17; uninstructed, 10; split delegations or contests, 6. Four of the 59 counties reported no conventions held.

Seventy-six counties where Democratic conventions were held show the following results:—Wilson, 107; Harmon, 72; Clark, 9; uninstructed, 4. Four of the 76 counties did not hold conventions. There are 244 counties in Texas.

FOUND WITH HEAD CRUSHED

Foul Play Expected With the Death of a Man Near Montreal.

Ste Anne de Bellevue, Que., May 7—A suspicion of foul play is attached to the death of D. Horan, foreman of the Standard Construction Company, who was this morning found lying near the railroad tracks with his head battered in and an uncorked and half-emptied bottle of gin at his side.

In charge of a gang composed of Poles and Italians, it is alleged that the deceased had been the object of their enmity and that vicious threats had been made from time to time. When Dr. Guenette set forth to inform Horan's family of the tragedy, he was met by the dead man's son, who said, before the doctor had fairly begun his story, "I know what you have come to tell us. My father has been killed by some of the foreigners."

Whether Horan was murdered, or whether his death was accidental, and caused by his having been struck by a train, are matters which have aroused the curiosity of the village to the boiling point.

In addition to the terrible blows by which his head was crushed in, Horan's face bore evidences of severe cuts and there was also an injury to one shoulder. Horan was 60 years of age.

CHIEF INSPECTOR OF INDIAN AFFAIRS RESIGNS

Ottawa, May 7—Mr. J. G. Ramsden, for the last six years chief inspector of the Department of Indian Affairs of the Dominion of Canada, has resigned his position with that department to accept a position with a large corporation. He is an ex-alderman of the city of Toronto and lives in that city. Mr. Ramsden has travelled in connection with his work from below the Island of Anticosti to Northern British Columbia. He has settled many of the most intricate of the Indian problems in such a manner that he enjoyed the full confidence of the Indians themselves and was always a welcome visitor on the reserves.

WASHINGTON DELEGATES ENDORSE CHAMP CLARK.

Walla Walla, Wn., May 7—The State Democratic convention voted this afternoon to endorse Champ Clark as candidate for President. The vote stood: Clark 455; Wilson, 106; Bryan, 135 1-2; Harmon, 1 1-2. An attempt was made to stampede the convention for Bryan, but it was unsuccessful.

WAS CONVERT TO MORMONISM

Latest Story in Connection With Rev. Richeson, Sentenced to Death

Boston, May 7.—Clarence V. T. Richeson, under sentence of death for the murder of Miss Avie Linnell, has been a Mormon elder and secretly connected with the Mormon organization for several years, although preaching from a Baptist pulpit, according to a sworn statement just made before William A. Thibodeau, an attorney and justice of the peace. The author of the affidavit, Mrs. Louie E. Brittain, claims to have been formerly connected with the Mormon Church and to have been a celestial wife of a New York man, who is the head of the Mormon organization of the state. In the statement, Mrs. Brittain asserts that she has known Richeson for several years past, first meeting him three years ago at a Mormon conference held on Staten Island, where she says the Baptist clergyman was recognized as one of the Mormon elders and was particularly active in the affairs of the conference. She has since seen him many times in and about Boston and has given him the Mormon signs which were always answered, she claims. She says she attended a Mormon conference at Providence, R. I., a little over a year ago, at which Richeson was present, and that she received commands from him as a Mormon elder at a Boston gathering of the leaders of the church.

A short time ago Mrs. Brittain became converted from Mormonism, she says, although for eight years previous she had been aiding in the propaganda of the Mormon church in Boston and New England. According to Attorney Thibodeau, of the firm of Thibodeau and Ellsworth, who gave out the affidavit to-night, Mrs. Brittain recently divulged to some of her close friends her knowledge of Richeson's alleged connection with the Mormon church, and she was prevailed upon to make the facts known previous to the time set for the execution of Richeson, as it was felt that the information, if withheld until after his death, would seem unfair.

In an interview to-night during which she was accompanied by Duncan A. McPhee, Secretary of the Evangelical Alliance, Mrs. Brittain said that to the best of her belief Richeson was converted to Mormonism while still a student at William Jewell College in Liberty, Mo., from which he was expelled in 1889. At that time Richeson became attached to a young woman who now makes her home in Salt Lake City. To this young woman is due Richeson's trend toward Mormonism, Mrs. Brittain believes.

The affidavit, which was given out prior to the interview, described some of the meetings at which she said she had seen Richeson, and concluded as follows: "I have always considered Elder Clarence V. T. Richeson a member of the Mormon organization in good and perfect standing and do to the present day, and believe he is considered so by the Mormon organization. "While it is not common, it is not unusual to find the more educated of the Mormon elders preaching in the pulpits of evangelical churches which baptize by immersion."

JACK GOODMAN BETTER THAN AHEARN.

New York, May 7.—Jack Goodman, the West Side lightweight, had the better of Young Ahearn, of Brooklyn, in a ten round bout here to-night. Ahearn had the advantage up to the fourth when Goodman scored two knockdowns. The Brooklyn man came back in later rounds, but in the final session Goodman put Ahearn to the floor. The bout ended in a fast mixup, but the general opinion was that the West Sider was entitled to the decision by a fair margin.

Halifax, May 7.—Parsons won from Sutton by the knockout route at the Arena to-night in the fourth round of their scheduled twelve round bout. It was a case of science over strength. Sutton had some six pounds on the North Sydney boy. A hard left to the stomach and a terrific right to the jaw did the work. The men fought a clean bout and agreed to go to a decision. A fairly large crowd witnessed the fight. Sutton declined to fight with regulation four ounce gloves and eight ounce gloves were used.

In the county of Bellechasse, Mr. Galpeault, K. C., is in danger, as Mr. Levalée, the federal member, has taken a prominent part in favor of Mr. Gelly, and has considerable influence in the upper part of the county.

Hon. A. Robitaille, returning officer for Quebec Centre, received the nomination papers of both candidates yesterday. Mr. Romeo Langlais, advocate, has appointed Mr. W. R. LaRue, N. P., as his agent, and Mr. Leclerc, government candidate, has appointed Mr. P. J. Cote, merchant, as his agent.

Mayor Bernier, the Conservative candidate in Lévis, is meeting with much success in that county and is putting up a good fight against the government candidate, Mr. L. Roy, and another Liberal candidate, Mr. Evans Guay. It is rumored that Mayor Nolin of St. Ronald, a well-known Liberal organizer, will be put in nomination today.

Mr. Armand Lavergne will be present today in Montmagny, when he will be nominated as opposition candidate, but will return to town this evening and will address the electors of St. Famille, and St. Jean, Island of Orleans, tomorrow. These meetings will be contradictory meetings and the government candidate, Hon. L. A. Taschereau, will be present.

During Mr. Letourneau's speech, there was very little enthusiasm displayed, and his principal criticism was against the local papers, which, he claimed, did not treat him properly and wanted to completely knock him out of politics. As may be expected, he touched slightly on the Leduc question and informed his electors that he had won his cases against two Conservative papers in the superior court.

Sir Lomer Gouin followed and was well received. He advised his friends to vote for Mr. Letourneau, who was the friend of the workmen.

Other speakers were Hon. L. A. Laschereau, Hon. A. Turgeon, Messrs. Lucien Cannoh and L. A. Pouliot.

POLITICAL LEADERS AT OTTAWA.

Results in the faculty of medicine will not be known for at least three weeks, the medical students having only just commenced their examinations.

IN AND ABOUT TOWN

FEDERATION OF BROTHERHOOD

Will Arrive From England This Morning and Will Be Given Welcome.

His Worship Mayor Drouin and the city council invite the presence of English-speaking citizens particularly at the City Hall this morning at 11 o'clock, to attend the civic reception to be tendered the large deputation of 130 delegates from the Brotherhood Federation of Great Britain, who will arrive by the Royal Edward between 10 and 11 o'clock.

The visitors will be met at the boat by the mayor, Alderman Cannon, the chief of police, as well as by the ministers and representatives of the Brotherhoods and other men's organizations of the Protestant churches of the city, who will conduct them to the City Hall, where an address will be read and a civic reception tendered, after which they will be given a ride around the city before their departure by the boat for Montreal.

From Montreal they go to Ottawa, Toronto, Hamilton and Niagara Falls. Each of the cities is preparing a welcome and a civic banquet is being tendered by the mayor and city council of Toronto; but the honor of the first welcome to Canadian soil falls to the ancient capital and it is hoped the citizens will help make it a worthy one.

The purpose of the visit of this large number of gentlemen of standing to Canada is to attend the first convention of the Brotherhoods of the Protestant Churches of Canada, which assemblies in Toronto from the 10th to the 13th inst. The object of the convention is to organize a Brotherhood Federation for Canada similar to that of Great Britain, which now numbers nearly 1,000,000 members. The formation of such a federation in this country, it is expected, will have the effect of bringing the men of the different churches into closer harmony and more effective cooperation for the strengthening of virile Christianity in our Canadian life.

The first paragraph of the commission's report which the conference eliminated today consisted in the main of the sentence: "There shall be a final court of appeals."

It is understood that as a result of the two meetings recently held negotiations with regard to the inland lines are considerably advanced and a definite announcement of some sort may be made after tomorrow's meeting. Information is scarce as to the exact position of the negotiations, but it is stated that the old Richelieu board and the representatives of the inland interests are getting back to the basis of understanding on which the deal was taken up last summer. Misunderstandings on both sides, it is reported, have been adjusted as a result of the talks around the board. Richelieu stock continues sluggish, the price being off a half point to-day, to 123. For one thing the public is perplexed over the long drawn-out negotiations. For another stock appears to be freely supplied on every upward movement.

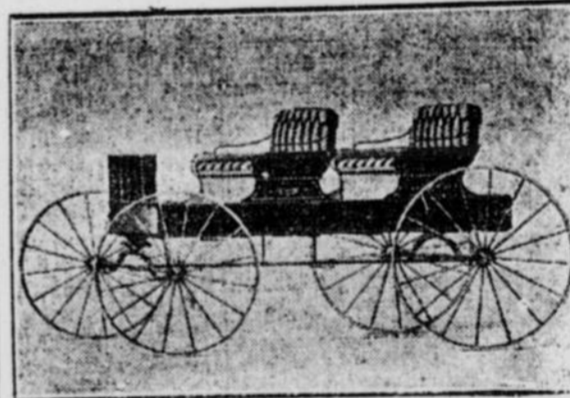

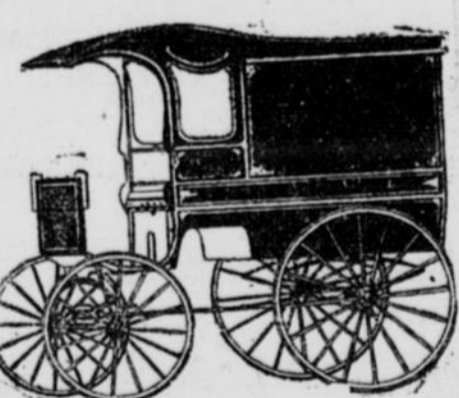

SYNOPSIS OF CANADIAN NORTHWEST LAND REGULATIONS

Any person who is the sole head of a family, or any male over 18 years old, may homestead a quarter section of available Dominion land in Manitoba, Saskatchewan or Alberta. The applicant must appear in person at the Dominion Lands Agency or Sub-agency for the district. Entry by proxy may be made to any agency, on certain conditions by father, mother, son, daughter, brother or sister of intending homesteader.
Duties—Six months' residence upon and cultivation of the land in each of three years. A homesteader may live within nine miles of his homestead on a farm of at least 80 acres solely owned and occupied by him or by his father, mother, son, daughter, brother or sister.
In certain districts a homesteader in good standing may pre-empt a quarter section alongside his homestead. Price \$3.00 per acre.
Duties—Must reside upon the homestead or pre-emption six months in each of six years from date of homestead entry including the time required to earn homestead patent and cultivate fifty acres extra.
A homesteader who has exhausted his homestead right and cannot obtain a pre-emption may enter for purchase homestead in certain districts. Price \$3.00 per acre.
Duties—Must reside six months in each of three years, cultivate fifty acres and erect a house worth \$300.00.

HORSE-SHOE NAILS PART OF COMBINE

One of the Seven Pools in Connection, With the U. S. Steel Corporation.

New York, May 7.—The American Steel and Wire Corporation was a partner to pool agreements with other manufacturers whereby prices on U.S. Government bids were fixed and the business divided among the pool members, according to testimony given to-day at the hearings of the Government suit to dissolve the corporation under the Sherman anti-trust law.

The testimony was given by Samuel J. Bailey, of the office of E. E. Jackson, "supervisor" of the famous wire pools, whose members were indicted and fined a year ago. Bailey acted as secretary of the Horseshoe Manufacturers Association, one of the seven pools, and explained in detail to-day how the horseshoe business of the country was managed. The evidence was introduced by the Government in support of its contention that the American Steel and Wire Company was itself an illegal combination. In brief the rules fixed the price per keg at which all members of the association should sell horseshoes, prices being changed when necessary, the witness explained, at monthly meetings. Each member was allotted a certain percentage of the business, and in case his sales at the end of the month exceeded his allotment he was to pay cash into the association equivalent to the amount of the excess. If they were less, the association was to make up the deficiency by cash payments to him. A deposited penalty of \$1,000 was provided for violation of the rules.

Cross-examined by David A. Reid, Bailey said that the pool was broken up in March, 1909 by the withdrawal of the American Steel and Wire Company. "How long did the pool last after that?" asked Mr. Reid. "About one minute," replied the witness.

To his knowledge none of the members of the executive of the Steel Corporation had ever knowledge of the pool, he said, and none ever attended its meetings.

BREAK UP OF THE ICE.

Campbellton, N. B., May 6.—Everybody here has joyfully witnessed the breaking up of the ice here last night. The river is now clear down to the bay.

Two steamers which were waiting outside came in port; the Marken, Rotterdam, which will take a cargo of lumber, and the Canada, of the Campbellton and Gaspe Steamship Company, which having recently left Quebec and stopped on her way down at several ports, will now resume her regular service from here to Bay des Chaleurs and Gaspe coast points, leaving Campbellton every Wednesday and Saturday at 6 a.m.

Gaspe Basin was still covered with ice when the Canada passed there, but it is expected it will be clear this week.

John Graney, a Well-Known Coach, Dead—Kindergarten Stakes at Montreal.

Boston, May 7—John Graney, well known as a coach among the oarsmen of the country, died last night after a long illness. Graney developed many varsity eights for Harvard, Yale and other colleges, and for eight years was a coach for the Boston Athletic Association. He was a sweep oarsman of ability. He was born in Ireland 42 years ago.

Montreal, Que., May 7—The running of the Kindergarten Stakes, which is an event for two-year-olds, and been run since the inception of the Montreal Jockey Club in the spring of 1907, finds the majority of the original nominators returning this spring with even better entries than formerly. This stake is one of the most valuable of the Montreal Club and will be run during the spring meeting from Saturday, June 1, to Saturday, June 8, inclusive. This year it has attracted as large an entry as it has ever done, there being 40 odd named in it.

New York, May 7—The American Olympic committee is receiving entries for the try-outs so slowly that it was found necessary today to send out an urgent request to athletes to hasten to send in their entry blanks. The Swedish blanks have been forwarded to all athletes who led in performances last year, but comparatively few of the blanks have been returned. The blanks must be returned before May 30, and candidates appearing after that date positively stand no chance of being considered eligible.

New York, May 7—The Brooklyn National League Baseball Club today released Jerry Downs to the Chicago Nationals under the waiver rule. Chicago refused to waive claim on the second baseman. Brooklyn has also waived claim on Catcher Billy Bergen, released by Newark, and that player is now a free agent.

DEATH OF WELL-KNOWN AMERICAN HORSEMAN.

Lexington, Ky., May 7—Horace W. Wilson, for 13 years secretary of the Kentucky Trotting Horse Breeders' Association and one of the best known horsemen in America, died here to-day. He was for many years secretary of the Empire Trotting Association in New York and at one time was associate editor of a Chicago paper devoted to horse racing. He was 52 years old.

SIXTY-ONE ENTRIES FOR TORONTO CUP

Toronto, May 6—The splendid total of 61 entries in the Toronto Cup heads the list of entries to the stakes to be run at the approaching spring meeting of the Ontario Jockey Club. Though the Toronto Cup, with \$5,000 added money takes rank next to the King's Plate, as the most valuable race to be run on the North American continent in 1912, it was never anticipated that the record of this race in point of numbers reached last year would be surpassed, particularly as the entry of 1911 had the very substantial support of the powerful Hildreth stable.

IMMUNITY FROM TYPHOID FEVER

Paris, May 6—It is stated that experiments on human beings at the Pasteur Institute with an anti-typoid serum has met with excellent results. Forty persons were inoculated with the serum. The reaction following the inoculation is said to have been very slight and the specialists in charge of the experiment say that complete immunity from typhoid apparently was insured by the operation. One of the chief experimenters is of the belief that the serum will prove valuable in the army when operations are being carried forward in contaminated districts.

FUNERAL OF A VICTIM OF TITANIC

Montreal, May 6—The remains of the late Leopold Weisz, of Montreal, who was a victim of the Titanic disaster, reached the city on the Maritime Express from Halifax Saturday evening. The funeral was held this afternoon at 2 o'clock, Rabbi Herman Abramowitz conducting the service. Interment was made in the Jewish Cemetery. His wife, whom he was bringing to Canada, will go back to her occupation of dressmaker. Before marriage she had a prosperous establishment in Birmingham, which she sold for several thousand dollars. This sum, along with several thousand dollars of Mr. Weisz's saving, was lost with the Titanic, leaving the widow practically penniless.

CONFERENCE OF RED CROSS SOCIETIES

Washington, May 6—With delegates representing the Red Cross societies of 28 countries in attendance, the ninth international Red Cross conference, and the first ever held in the United States, convenes here tomorrow for a 16 days' session. In the absence of President Taft, as honorary president of the American Red Cross, Senator Elihu Root of New York is scheduled to formally open the congress and deliver the address of welcome. Following this address and the response of the foreign delegates in the Pan-American Union building, where the sessions are to be held, the delegates will proceed to the exhibition building nearby and formally open it. A reception tomorrow night at the Pan-American building will close the first day of the conference.

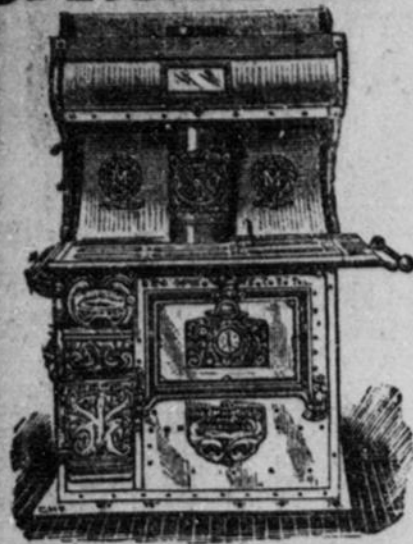

Sir Lomer made a wonderful success at St. Catherine's on Sunday, and he completely crushed his young opponent. But the young opponent was not present, much to Sir Lomer's relief.

DAMAGE AMOUNTED TO OVER HALF MILLION

Providence, R. I., May 7—More than half a million dollars' loss was caused by a fire which destroyed the storehouse of the Revere Rubber Company in Atwells avenue, in the western section of this city today, and for a time threatened to wipe out the extensive lumber plant of William H. Harris, Jr., which adjoined. The loss is practically covered by insurance.

Thousands of automobile tires stored in the building were destroyed, with a loss estimated at \$550,000. The loss on the storehouse, which was a four-story brick structure, and from damage to nearby property was about \$25,000. Flames communicated to several buildings in the lumber yards, but in each case were quickly extinguished. The greatest damage to the Harris property was caused by water.

Three firemen suffered slight injuries. Two were hurled from a ladder by a hot-air explosion, while another was burned. The cause of the fire has not been determined. Two workers who were on the top floor of the storehouse when the flames were discovered, jumped to the roof of another building, two stories below. They were not hurt.

WILL PORTNEUF COUNTY REJECT

Premier Gouin? Is Question Politicians Are Asking Each Other These Days.

The political contest in the County of Portneuf, where the Provincial Premier, Sir Lomer Gouin, is opposed by the young Opposition candidate, Mr. Edmond Chasse, is becoming so close and interesting that leading politicians, not only of Quebec city, but in Montreal and various other sections of the Province, are now asking each other if the County will reject Sir Lomer. No other contest in the present election is causing more interest than the fight going on in Portneuf, where it was thought Mr. Chasse would have no conceivable chance of election. The contrary is the case, however, which is a strong indication of the change of sentiment in the minds of the electors in general all over the Province, that signifies defeat of the present Liberal administration.

Three weeks ago when it was given out that a young newspaper man named Edmond Chasse would oppose Sir Lomer Gouin in Portneuf, politicians within both the Liberal and Opposition parties seemed to be amused, and did not seriously entertain the announcement, let alone the possibility of Mr. Chasse being able to save his deposit. The inevitable, however, has come to pass. Mr. Chasse is not only opposing the Prime Minister and putting up a good fight, but the young candidate is now surer of victory. Sir Lomer Gouin does not contradict Mr. Chasse's prediction, by his conduct in seeking another constituency, St. Johns, Quebec, where he is sanguine of election, but judging by appearances, he may lose both counties, and this is the opinion of many astute politicians.

Mr. Chasse arrived in the city yesterday from Portneuf to consult with the Opposition leaders and returned to his battle ground last night to be present for nomination. While in the city Mr. Chasse in a talk with a member of the Chronicle staff on the subject of his fight said: "In my opinion, founded on facts, I feel that La Vigie and Le Soleil are destined to receive the greatest surprise of their respective lives. Both these papers at first ridiculed my opposition candidature to Sir Lomer Gouin, and predicted that I would be defeated by 2,500 votes. Since then they have been less sanguine and placed the Premier's majority at 900. Sir Lomer Gouin, not quite so sure, said at the St. Roch meeting last night that his majority in Portneuf would be 800. Now I will tell the Soleil, the Vigie and Sir Lomer Gouin that I will have the proud honor to defeat the Prime Minister of Quebec on May 15th by 300 majority, and not one vote less, and when I enter the Legislative Assembly to take my seat, I will find a place at the right of the prospective Speaker, and if Sir Lomer is elected for St. Johns he will find his place reserved for him on the left of the Speaker, which was heretofore occupied by Mr. Tellier. In your newspaper experience you have come to learn that there are many ups and downs in life. Sir Lomer Gouin has had his ups, and is now destined to his down, while Mr. Tellier will have his share of the ups as the people's champion, and not their master and dictator.

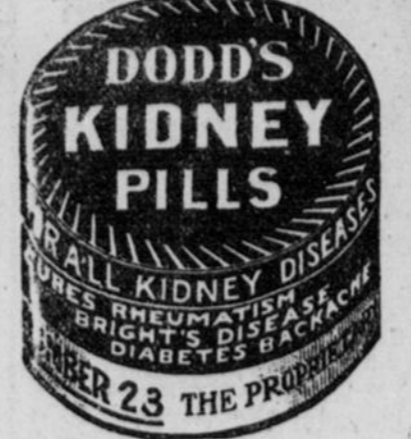
"The Vigie and Soleil were kind enough to go out of their way to state in their respective columns that I was given a very poor reception at the joint meetings held on Sunday last at St. Basile and Pont Rouge. I will tell them that they disturbed the truth, and their lying misrepresentation of facts will do me more good than harm in the County of Portneuf. I will also say for the benefit of the public and in justification of my candidature, that I received an enthusiastic reception from the electors of Portneuf at these meetings as Sir Lomer, if not a trifle better. I have no desire to belittle the strength of my esteemed and august political antagonist, who besides his ability and oratorical powers, is a gentleman of prestige, but notwithstanding his gifts and his prestige, I mean to defeat him and I will, with the aid of my majority which the electors of Portneuf will give me on May 15th.

"Since I entered into the contest, I have addressed twenty public meetings, and still have ten others to address, and you may depend that I do not intend to stop until the election is over, as I have made up my mind to work without intermission from now on until the close of the polls.

"On Monday last I addressed a large meeting at Pointe aux Trembles and another at St. Agathe, and yesterday morning again appeared before the electors of Les Ecureuils, and at all three meetings received a most flattering reception.

"To-day I will meet Sir Lomer Gouin at Cap Sante, where we will discuss the issue in controversy, and expect another such reception as was accorded me at the previous meetings. After nomination I will spend the balance of the time addressing the electors and other work to ensure my election, which I now feel is certain, and when I return to Quebec on Wednesday night of Thursday of next week, I will come as the elected candidate, with the honor of having defeated the Prime Minister, as I have already said, by a majority of 300 votes."

It was rumored last night in political circles that Sir Lomer Gouin in dread of defeat in Portneuf had telegraphed to Montreal for speakers and other assistance to come immediately to his aid.
