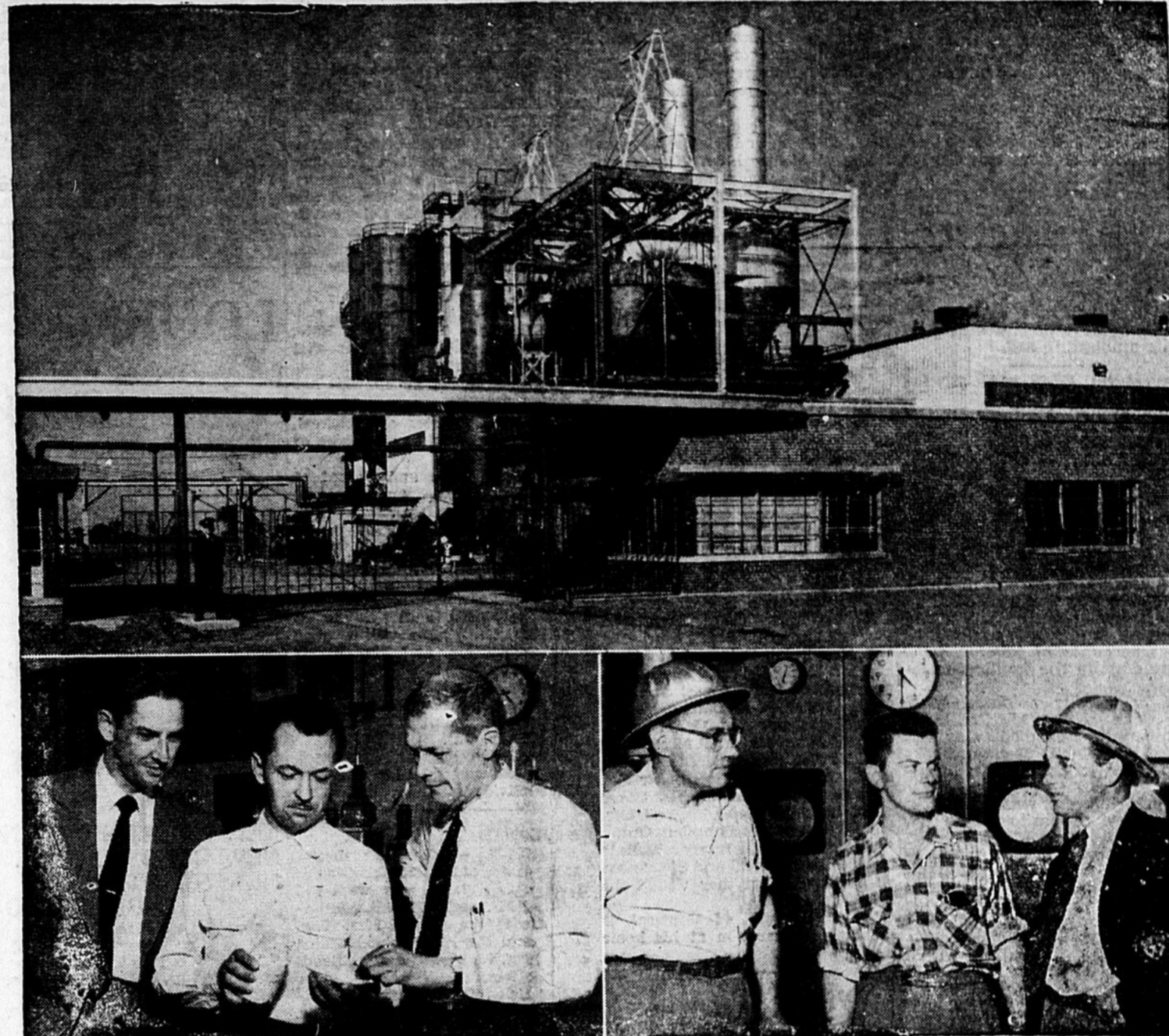

DAVISON CHEMICAL OPENS \$6,000,000 PLANT AT VALLEYFIELD



The Canadian petroleum industry need no longer import the catalysts required to increase its yield of high octane gasoline, thanks to the initiative of Davison Chemical Co. Ltd. Until the recent construction of the ultra-modern plant shown above, the synthetic catalyst used in

the petroleum cracking process had to be brought in from the United States. In locating in Canada, the company which is affiliated with the Davison Chemical Company Division of W. R. Grace & Co., chose Valleyfield because it not only has an abundance of skilled labor and

water supply but also because it is near Canada's great refinery centre in Montreal East.

A. L. McMurphy, Immigration Officer, Dies

Allen L. McMurphy, 60 of Trout River, an officer in the U.S. Immigration Service stationed at Trout River, died suddenly at his home Wednesday morning, July 17th, after suffering a heart attack. The Malone Rescue Co., was called, but he failed to respond to treatment.

He was born at Randolph, Vt., Feb. 24, 1897 a son of the late Ellisworth and Mary Patrick McMurphy. He had been at the Trout River border office for the past 14 years and before that was a member of the Immigration Service on a temporary basis in Vermont.

250 Employees Of Merck On Strike

The employees of the Valleyfield plant of Merck and Company, manufacturing chemists, were called out on strike at 12:01 a.m. on Tuesday and the plant is being picketed.

About 250 employees are involved in the dispute, which hinges on the elimination of a cost-of-living bonus clause from an existing labor contract. Its elimination was recommended by an arbitration board. The employees, members of the International Chemical Workers' Union (I.C.W.U.), met on Thursday evening and decided on the strike action by means of a vote.

Andre Courchesne, organizer for the Union, described the cost-of-living bonus as being worth three per cent of earnings.

The board recommended an hourly increase of 13 cents for the first year and 11 cents for the second year and a gradual reduction in working hours to 40 from 44 without any loss in pay.

There was some prospect up until the last minute that the company would accept a counter proposal by the Union, in which case the strike order would have been countermanded.

No one is presently being admitted to the plant.

"Dear John"

A decade or more ago, during World War II, as we recall, the "Dear John" letter was a feature of the life of GI Joe. An American soldier serving overseas might get a letter from the young wife he had left Stateside informing him that their hasty marriage had been a mistake and that she was instituting divorce proceedings in order that she might be free to marry some smart cookie who had dodged the draft.

Such a kick in the serviceman's solar plexus came to be known as a "Dear John" letter. Seems to us someone even wrote a song with that title.

Now we are borrowing it to write an open letter to our new Prime Minister, John Diefenbaker. The connection is that we, too, have received a missive that hits us in a soft spot. For the second time in less than a year we have been charged with the same offence: to wit, we have failed to file the monthly returns for the month of April, 1957, pursuant to The Excise Tax Act. In less legal verbiage we had neglected to remit to the Receiver General by May 31st, 10 percent of all job printing we had done during the month of April.

Dear John, we are guilty as sin. We failed to send in our cheque on time, as has happened before, and well may happen again. Not because we have criminal tendencies, John. It's just a matter of time; of not enough time to do all the things one must do if one is to stay in business, in a modest way, in this hectic age.

But we plead extenuating circumstances, dear John. That form had to be filled out, that cheque mailed, by May 31. Remember how busy you were about that time, John? Would you have found time from your campaigning to tote up the number of miles you had travelled during April, for forwarding, perhaps, to the Bureau of Statistics?

We in the small printing shops were busy about that time, too. Our thoughts were centred on clearing the last election jobs, on getting out that important pre-election issue on schedule. We had more to worry about than the fact the Receiver General must be served, no matter how big his surplus. Our desk was a mess, and somewhere beneath the pile were those forms the Sales Tax people say must be filed every month.

Dear John, we aren't asking you to get us off the hook. We will pay whatever penalty the court demands. But we must admit it hurts. It hits us way down deep where our pride of citizenship lies buried, yet a living thing. We feel unjustly treated, trod upon.

In your housecleaning of the federal government, dear John, could you remove the cobwebs that seem to have enveloped our tax-

gathering agencies? There are bugs in the system, you probably realize. We have a notion that there are also buggars guys with an authoritarian complex who delight in throwing the letter of the law at their less fortunate fellow countrymen who have not the weight of government behind them.

Dear John, please take a second look at this Sales Tax legislation. Is it just that one's government should force any citizen into the role of a tax collector; an unpaid tax gatherer, in fact; one who must pay a yearly \$2.00 fee for the questionable privilege of adding 10 percent to the cost of every printing job he accepts? To add insult to injury, that 10 percent must be remitted in the following month, whether or not the printer has been paid, no matter if he has not found time to send out his bills; regardless of the fact he is paying 10 percent on an account that may turn out to be a total loss, utterly uncollectible.

John, it just isn't right. Collection agencies charge as much as 40 percent to bring in doubtful accounts. Why should our government expect us to do it for free, to pay a collector's license and pay again through the nose in penalties if we prove not too efficient in this business of collecting for the treasury?

And if you look at our taxing laws from the worms-eye viewpoint, dear John, don't overlook The Income Tax Act. Here again the small businessman is serving as an unpaid collector for National Revenue. He must remit payroll deductions by the 15th of the following month, or else. He is not only a collector of Income Tax; he pays through the nose, too, and he may be paying another \$400 or more to an outside accountant because the Revenue boys are not satisfied with his system of book-keeping.

Dear John, it sometimes seems to this one owner of a small business that his government keeps a corps of slap-happy heavyweights hovering impatiently just beyond the floodlights, ready to pounce on any upstart who dares enter the business ring despite the odds against him. If one carries enough weight, the Treasury referees use the slow count (or the fast write-off). If one fails to connect (or have the proper connections), he's down for the count. And how those federal tax-collectors seem to revel in pushing our noses into the canvas.

Dear John, if you find time to measure the competency of those tax-gatherers in the Revenue branch, please use the Golden Rule. Throw out of their soft seats all those who have yet to hear the age-old dictum "do unto others as you would have others do unto you."

We are not only being taxed to death, we are being harried, too. And we don't like it.

Round Byre A N D Ring

Unique Occasion

It was a unique, in fact, one might say, historic occasion. The occasion being the annual Field Day of Franklin-Clinton Counties Beef Cattle Association, of New York State, which was held across the International Border at Braemanor Farm, Island Road, Dewittville, Que., on Saturday, July 20.

Why unique? Because first of all it was undoubtedly the first time that any similar body of the United States had staged its Field Day in this part of Quebec, in the area usually known by Braemenor as the Howick-Orms-town-Huntingdon area. Secondly, because it was doubtless the first time that any similar beef cattle rally was staged in that area. An area which is predominantly a dairy cattle area. Thirdly, it was staged at the Braemanor Farm of Ellen and Bruce McKellar, on which is kept the first sizeable purebred Aberdeen-Angus cattle herd to be established in either the county of Chateauguay or the county of Huntingdon. Moreover, that herd is now one of the top Aberdeen-Angus cattle herds in the Province of Quebec. Incidentally the other top herds are located in St. Andrews East, Vaudreuil and the Eastern Townships. Also, insofar as we are aware the Braemanor herd is the first purely purebred beef cattle herd to be ever established in this area.

"A-A" Predominates
The Franklin-Clinton Counties Association is comprised of owners of all purebred beef cattle breeds, but it would appear that Aberdeen-Angus men constitute the largest section of the said Association's membership. Anyway, insofar as we are aware most of the cattle men from over there, who were at Braemanor Saturday, are the owners of Aberdeen-Angus cattle.

The New York State party was led and stage-managed by Robert A. Ingersoll, Jr., Assistant County Agricultural Agent, Franklin County Extension Service, Association, Malone, N.Y. At Braemanor they were met and welcomed by Bruce and Ellen McKellar; were joined by several other Aberdeen-Angus breeders from other parts of Quebec, and by a few local people.

Prior to the Basket Picnic there was a demonstration on the trimming of animals feet and the dressing of cattle for the showing.

After the luncheon period Professor Myron Lacy, of Cornell University (Ithaca N.Y.) Beef Cattle Extension Service, gave a brief, but most interesting address, on the topic: "Should we heavily feed our young stock?" Following same there was a discussion period during the course of which Prof. Lacy gave most interesting, practical replies, suggestions and advice.

Leon A. Beaudin, Agronomer for Huntingdon County and part of Chateauguay County, gave an interesting outline of his Pasture-Improvement Plan and then conducted the party over, first the pasture plots on the McIntosh farm at Dewittville, and then those at Braemanor Farm.

Finally, the Braemanor Farm Aberdeen-Angus herd of around 100 head, was inspected, admired and discussed, after which a hearty vote of thanks was accorded the McKellars.

Incidentally, the Braemanor Farm herd is comprised of members of the best known, most popular families and strains of the Aberdeen-Angus breed. And, insofar as that breed is concerned the ancestors of same were the "Buchan Hummles" (from their native district in Aberdeenshire), and the "Angus Doddies" (here again from their native district, the county of Angus, which county, by the way, was named Forfar for several generations until the name was changed back to Angus.)

The "Hummles" and "Doddies" were of course black in colour and naturally hornless. Subsequently they were known as the Polled Aberdeen or Angus cattle, but their present name dates a long way back, to the days of their great improvers Hugh Watson of Kellor, William MacCombe of Tillifour, and others. However, by and by the county of Banff (Banffshire) became the greatest centre of Aberdeen-Angus cattle breeding, and still maintains that title.

Families
As already indicated the Aberdeen-Angus men, like their Shorthorn competitors, have always favoured cow-families or strains, and so it now is that one of the first questions to be asked is: "What family?"

Therefore at Braemanor there are naturally of the following famous strains: Barbara, Blackbird, Blackcap, Erica, Miss Burgess, Pride, Queen Mother, and others. All tracing back to famous cows and subsequent ancestors bred in famous herds. For instance the Queen Mothers trace to Queen Mother 348 sold

as a yearling to Tillifour in 1844, and subsequently a great prize winner. In turn the Queen Mother tribe is now divided up into some nine families, including Pride of Aberdeen.

Braemanor Sale
Another unique occasion will be the Braemanor Production sale which has been advertised in The Gleaner, which will be held next Saturday, July 27. Another first — the first Aberdeen-Angus or Beef Cattle sale in this area. It is apparently not a culling or weeding out sale, just a reduction sale necessitated by the increased size of the herd — through natural increases. Also because Bruce McKellar has to slow down for a time as a result of a rather bad accident last spring. However, even if the last head scheduled to be sold are disposed of, it will still be quite a large herd.

The Gore
Gore W.M.S. Holds Afternoon Tea and Sale
The Gore W.M.S. held a successful afternoon tea and food sale on Thursday afternoon, July 18th, at the Herdman Hall with Mrs. Carl Anderson, President, in charge. A beautiful duet, "Open Mine Eyes That I May See" was sung by Mrs. Nickerson and Mrs. Willard Anderson.

The guest speaker for the afternoon was Miss Churchill from the Church of All Nations. The topic of her talk was "The Church on the City Street". Miss Churchill spoke of the difficulties and hardships that the new Canadians had to face, but how they in unity turned to the Church.

Mrs. Sterling, from the Literature Section of the W.M.S. displayed some books. Mrs. Nelson Anderson thanked Miss Churchill and Mrs. Sterling.

Tea was then served and the Food Sale and Sale of Work took place. Proceeds amounted to \$57.

economist, and it is a very real deterrent to stability. It is not the amount of money in circulation that makes for prosperity, but rather its value as a medium of purchase and exchange. That value is determined by price levels. Mr. Jacoby points out that with ever a slow rise in the price level, "more and more people will discover that they are losing real purchasing power by holding insurance policies, bank deposits, savings bonds, and other dollar assets. What began as a 'creeping' inflation will become a running, then a galloping inflation."

In his conclusion, Mr. Jacoby says: "The basic requisite for sustained prosperity is policies to create a high-incentive economy: the fields of personal security, public assets, money regulation, taxation, business investment, competition and foreign economic relations. The requisite policies call only for moderate reforms of present laws, institutions and practices—not radical innovations."

Mr. Jacoby's repeated emphasis on "high incentive" is important to his whole thesis. It means that incentive is the mainspring of individual and corporate progress and is essential to sustaining prosperity in a free society. Where there is no freedom, as in communist Russia, there is no place for private interest or enterprise. Compulsion is the only driving power in Soviet industry, and the individual is dehumanized into a robot. Incentive is a voluntary impulse to thought and action, and without that creative impulse neither prosperity nor human progress can be sustained.

Auto Insurance Report

OTHER states are now looking at New York's compulsory liability insurance law with envy, since reports of the first four months under this law showed such phenomenal results. Four months' experience is not enough to nail down the value of this law, of course, but the report is heartening to those who, like this newspaper, urged its passage.

Only seven cars involved in accidents during the February through May period were uninsured. In the same four months last year about 25,000 uninsured cars got into accidents. The enormous difference to victims of such accidents seems reason enough to have made auto insurance compulsory.

The Baltimore Sun has called the attention of Maryland legislators to this New York

four-month report, comparing the New York law favorably to a Maryland statute which merely provides, for prosecution of uninsured drivers after they get into accidents.

Insurance firms are still not certain that the New York law will prove a good thing in the end. They claim that experience elsewhere has been that juries get entirely too generous in their awards when the jurymen know that it is "insurance money" they are awarding. Such reaction would lead to skyrocketing insurance rates, hurting all drivers.

Therefore it may be well to wait a year or even more before declaring the compulsory auto insurance law an unqualified success. We cannot refrain from cheering loudly however, at the results thus far.

The Disappearing Farmer

BETWEEN the census years 1941 and 1951 the number of Canadian workers classified by the Dominion Bureau of Statistics as employed in agricultural occupations fell from 1,083,000 to 826,000. The number of workers in manufacturing increased by 284,000 to 973,982 during the same decade and substantial gains were recorded in the numbers engaged in all other classes of employment. The net gain in employment for the period was about one million jobs, but the jobs were not provided by agriculture, Printed Word states. There has been no significant change recorded in the acreage of occupied farm lands and the unsold surpluses that continue to exist in many products of the farm are proof that Canada is still a long way from starvation. The growth of cities, it is true, is transferring some good farm land to residential or industrial use, but this trend, while it should be watched, is probably not yet alarming.

What the statistics of farm workers may indicate is the attraction of an easier life in cities over the toll of the farm. The attraction of cities has always existed, but at one time there were some powerful counter-attractions in rural life. The farmer was independent, largely self-sufficient, almost untaxed. Now his independence is qualified by the marketing schemes to which he is forced to belong and for which he is taxed. Mechanizing farm operations has increased his efficiency, but has destroyed his self-sufficiency, for gasoline,

oil and tires are not products of the farm. He still must work longer hours than his urban neighbor, for cows and crops have not been unloved.

Like other citizens, farmers are fond of talking about their hardships and politicians seeking votes are more likely to agree that the complaints are just than to examine them critically. Thus grievances that are imaginary, but well publicized, may act as an additional deterrent to young men making a choice between city and rural life. The politician can support the farmer's argument that there is too great a spread between the price of farm products at the farm and the price the city consumer pays. But the politician usually backs away from looking for the cause of the discrepancy, for he knows that his search would lead to the mounting costs of labor between farm and retail store and might make him say something displeasing to unionized employees of the transportation, packing and other industries.

Few farmers, despite their grouching, would be willing to change from rural to urban life, and it may be suspected that, in moments of candor, they might admit that they are getting their share of the country's prosperity and that farming still offers opportunities to young men comparable, when all factors are taken into account, to the opportunities offered in urban vocations. But in election years, moments of candor are rare.

Sustaining Prosperity
By LEWIS MILLIGAN

"Can Prosperity Be Sustained?" is the title of a recent book by Neil H. Jacoby, an American economist and a member of the President's Council of Economic Advisers, in which capacity he has helped to formulate policies that promote the stability of the national economy. Mr. Jacoby's book is not as enthralling as a romantic novel, but its style is intimate and direct. At the outset the author goes to the heart of his subject: "Can the United States have a lasting prosperity? Few Americans have definite opinions on this subject. Some, deeply impressed by the memory of the massive unemployment of the 1930's which disappeared only with the coming of war and national defence programs, believe that our present good times will end when the economy has 'caught up' with deferred demands and when peace comes to the world."

Mr. Jacoby's answer to his question is summed up in the last sentence of his book: "Prosperity can be sustained in the United States without serious lapses, so long as government manages the fiscal affairs wisely and the American people continue to build a high-incentive economy." The author deals with the problem from various points of view; from those of government, the individual, management, labor, banker and investor. He insists that the role of government is of vital importance in "regulating the supply of money."

"Money and credit," he says, "are truly the lifeblood of our economy. Nearly everyone works for money or pays with money for the things he buys. From this simple reality the reader is made to realize how much his share of the currency depends upon a 'high-incentive economy, wherein government actively supports the expansion of private enterprise, and the regulation of money supply."

Industrial exhibits will exceed those of former years and everyone likes to browse around among such exhibits. There is always something new and something can be learned from these exhibits.

Some changes will be noted in the arrangement at the grounds, due to the Memorial Skating Arena being located on this spot. It is possible that much of the steel construction for the new arena will be in position by this time. The Flower building has been moved to a new site beside the grandstand. It will be necessary to drive around the site of the new arena, as it extends across the old road. Last year, it was unfortunate that a debt was incurred which still remains to be entirely wiped out. Thus it is hoped that everybody will get behind the Fair this year and give it a boost by a bumper attendance and gate receipts. The way is opening up for even bigger Fairs and under better conditions and if the public will lend support the goal being strived for can be accomplished. The slogan might well be—"Let's Make 1957 Huntingdon Fair the Most Successful to Date".

Everyone remembers the crazy days just after the war when people were standing around with fistfuls of money, willing to pay more for a used car than for a new one (since they couldn't buy a new one anyway).

Sure, there were used car dealers in those days who cleaned up. But then as now the basic rules of the new car dealer remain.

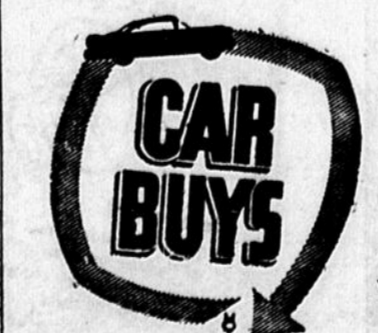
