The Italian Cabinet crisis continues. Navigation is open at St. John, N. B. Earthquake shocks at Scio have ceased.

The SS. "Newton" has been wrecked at Funchal, Madeira.

The revenue of Nova Scotia for the present year is estimated at \$536,987, and the expenditure, \$608,988.

Ex-Marshal Bazaine has challenged Admiral Jaurès, the French Ambassador at Madrid, for an alleged insult.

A new railway bridge, 1,100 feet long, has been constructed at Woodstock, N. B., although only commenced three months ago.

The SS. "Mantohan," arrived at Halifax, brought fifty-five children from Scotland for the Marchioness Hotel, Belleville, Ont.

Great distress and alarm prevail throughout Hungary on account of floods. A vast amount of property has been already destroyed, and the worst is not yet.

Floods on the Missouri continue. Tons of mail, baggage and express matter are piled up on both sides of the river at Omaha, awaiting the re-opening of transport.

Mrs. Blaine, Miss Brewster, and a number of prominent ladies have issued an appeal to the people of the United States on behalf of the sufferers from the earthquake in Scio.

Operations towards the stripping of the wrecked SS. "Ottawa" were to have been commenced on the 11th, all hopes having seemingly been abandoned of being able to save the hull.

The Parliamentary election at St. Ives, England, led to the vacancy caused by the death of Sir Charles Wood (Conservative), 517; Pendergast (Liberal), 395.

Extraordinary precautions were taken on the occasion of the Queen's recent journey to the city of White, on account of the rumors concerning her personal safety, emanating from Fenian sources.

THE HUDSON BAY ROUTE.—WINNIPEG, April 10.—During the past summer the engineers of the Hudson Bay Railway Company surveyed the route between Norway House and the outlet of Lake Winnipeg and Fort Churchill on the Hudson Bay, a distance of three hundred and fifty miles.

The surveyors report that the route first follows the course of the Nelson River, a distance of nearly one hundred miles over a level country. The next part of the road is over a broken, rocky country, where the Nelson River has a descent of nearly seven hundred feet to the plateau, where the country again becomes level, and continues so to Hudson Bay.

Upon entering the rocky range, the surveyed route leaves the Nelson River, taking a northerly course toward the valley of the Churchill river, which is reached at the entrance on the lower plateau, and continues to follow the course of the river to its outlet at Hudson Bay.

The route is a distance of 100 miles on the plateau, and \$17,000 per mile through the rocky portion, or an average of \$12,000 per mile along the whole route.

It is said that transportation to Liverpool by this route will be cheaper than the freight charges by rail to Montreal, and the service is practicable over the Hudson Bay route from May to December.

THE SOUTH AFRICAN TROUBLES.—President Brand's Opinion of the Peace Conference. London, April 11.—President Brand, of the Orange Free State, on returning from Natal, has received by great demonstrations along the route. He expressed the conviction that the terms of peace between Great Britain and the Transvaal now being arranged by Roy's Commission would unite all the nations of South Africa, and pave the way possibly to a union under one Government of the white peoples of the continent.

STARRVED TO DEATH.—Death of the Iowa City Pasting Girl. IOWA CITY, Ia., April 11.—Miss Hattie Dwell has succeeded in committing suicide by starvation. She died at her home in Iowa City on Saturday, and from that time she had not strength to write her father. By signs she indicated that she did not wish to see any more strangers, and that she was only anxious to die. Her death was high fever, but by morning it had abated, and she lay quietly until the hour of dissolution at noon. She completed the 47th day of the fast. It is said that her last square meal was eaten on Washington's birthday.
