U.S. SEEKING UNDERSTANDING WITH BRITAIN ON LATEST GOLD POLICY

Washington, Oct. 31.—The United States government today expectedly awaited British assurances that its approaching operations in European markets would not arouse retaliatory measures and fire the starting gun for a ruinous race to depreciate currencies.

The London government was told in friendly spirit that President Roosevelt's plan for raising prices at home and steadying the dollar abroad was purely a matter of domestic policy dictated by conditions within the United States.

It could hardly be construed, the British Government was informed, as a malicious move designed to weaken the position of Great Britain in the world of trade, nor as an unfriendly gesture aimed at any other nation. There were intimations that Britain's first reaction was sympathetic.

Awaiting more definite word from London, Mr. Roosevelt's advisors proceeded busily with preparations for making the first purchase of foreign gold, hoping the transactions could begin tomorrow. Busiest of these, perhaps, were Federal Reserve system officials. Although the Reconstruction Corporation will be the purchaser, the New York Federal Reserve Bank will be its agent.

Chairman Jesse H. Jones, of the R.F.C., and Henry Morgenthau, Jr., representing the President, had their usual exchange with acting Secretary Dean Acheson of the Treasury, to inspect foreign quotations and fix a price for the day's purchases of newly-mined domestic gold.

This price, arbitrarily set at a point higher than the London bullion market, had gone constantly upward. The price announced today was \$32.12. This was another new high, an advance of sixteen cents over yesterday's figure and \$1.07 higher than the day's world quotation. The price was advanced in spite of a drop of 7 1/2 pence on the London exchange.

Today's dollar equivalent of the London price was \$31.05 as compared with \$31.49 yesterday, today's differential being based on the opening of the pound-dollar rate in London at \$4.76 1/2.

The purchases of gold abroad will accompany this move, also designed to raise commodity prices, on the theory that the one adjusts itself to the latter. But with the purchases abroad new complications enter the situation.

The gold must be paid for in sterling, if bought in London, in francs if bought in Paris, and in guilders if bought in Amsterdam.

To acquire these foreign currencies, the R.F.C. must buy foreign exchange, must sell dollars for pounds, francs or guilders. By constantly offering dollars and consequently increasing their supply on the foreign exchange market, many economists agree that, lacking resistance from European capitals, the administration could force the dollar value of the pound constantly upward, thereby depreciating the dollar in its relation to the pound.

Mr. Roosevelt apparently has assured the British Government that he contemplates no such extremes, that his prime purpose is to increase the price of gold abroad as well as here for its buoying effect upon commodity prices and to avoid such wide fluctuations as have characterized the dollar-pound relationship in the last few months.

The London Government has a ready weapon for retaliation, which already has been in extensive operation. It is the British equalization account, which has sought to keep the pound stable, in some instances by buying abroad, much as Mr. Roosevelt proposes to do.

If London should regard the United States' program as endangering its own position, it could put the equalization fund to work. The result of such an international struggle, finding its basis in an effort by the British Government to depreciate the pound as compared with the dollar, and an American attempt to depreciate the dollar in relation to the pound, might prove disastrous to both countries.

CANADA'S 1933 MINED GOLD ESTIMATED AT \$90,000,000

Toronto, Oct. 31.—At no time in Canadian mining history, have the fortunes of our mineral industry been followed with greater interest than at present," declares Dr. Charles Cammell, Deputy Minister of Mines for Canada, in a review of conditions in the mineral industry.

Dr. Cammell says that ordinarily a revival of activities in other industries, with the consequent rise in the price level of commodities, tends to depress the relative position of the gold industry in respect to these industries, but international action has so enhanced the value of gold that the industry is this year surpassing all previous records, both in the intensity and in the extent of its activities.

Production is not keeping pace with that of last year, continues the Deputy Minister, but the value of output will be much higher when allowance is made for exchange compensation, and will likely reach \$90,000,000.

NEW MONETARY PROGRAMME BOOMING MINING INDUSTRY

BRITISH CURRENCIES ADVANCED TODAY

New York, Oct. 31.—British and gold standard currencies continued to advance in the foreign exchange markets today. Sterling opened two and one half cents higher, at \$4.77, while the French franc moved up .06 of a cent at 5.91 1/2 cents.

The Canadian dollar started one-eighth of a cent higher at 98 7-16 cents, which is equal to a premium on United States funds of 1 5-8 per cent.

ORDER MOTHER TO TRIAL FOR ABUSING GIRL

Tragic Story of Beating and Starving of Fifteen-Year-Old Girl by Jealous Mother, Related Before St. Jerome Court.

St. Jerome, Que., Oct. 31.—An emaciated little fifteen-year-old girl having told a packed court room of being chained to a bed and beaten with sticks, Mrs. Eugene Lavigne Paquette today awaited trial before the criminal assizes on a charge of inflicting bodily harm upon her daughter Rolande.

At the preliminary hearing here yesterday, Mrs. Paquette was committed for trial by Judge Donat Lalonde, while her husband, Leon Paquette, of Terrebonne, Que., was acquitted on a charge of complicity. Seized with trembling every time she looked at her mother, Rolande, whose cheeks bore scars, told the court she was chained to her cot by her mother when she returned home from school every day. "She forced me to lie in bed and then struck me across the body with a stick while the rings of the chain cut my body, making it bleed," the girl testified.

Rolande stated she was not given breakfast by her mother and did not receive any food at the school, and as she was not given any supper she went without eating most of the time.

Leon Paquette and his two sons also testified and corroborated Rolande's evidence. A statement allegedly made by the father and read in court by a police officer stated he had protested against his wife's treatment of Rolande but his wife struck him when he interfered. Rolande and the two boys testified that their father was not to blame.

Mrs. Paquette admitted chaining her daughter to the bed, but denied she had struck Rolande with a stick. Both her sons were "out of her mind," she claimed in defending herself. "It's all my husband's fault," Mrs. Paquette declared.

DECISIVE TURN IN DEBT TALKS EXPECTED SOON

President Roosevelt's Latest Currency Programme Disturbing Factor in War Debt Negotiations Now Under Way.

London, Oct. 31.—Official circles expect a decisive turn this week in negotiations of the British war debts mission at Washington.

With the Treasury and the Bank of England maintaining their usual official silence, most other financial authorities are busy explaining how puzzled they are by President Roosevelt's programme.

Some newspapers jumped today to the conclusion—without any authoritative reason—that debt negotiations might be abandoned soon.

Exactly the opposite may prove true should Sir Frederick Leith-Ross' conferences at Washington prove to have furthered Anglo-American collaboration.

Financial authorities here set no reason why the debt negotiations should not be continued under such circumstances.

DISMISS CASE AGAINST BEEBE TOWN OFFICIAL

Jurymen Decide Noel Rodrigue Has No Grounds for \$5,000 Action Against Councillor Boulais, of Beebe, for Defamation of Character.

Noel Rodrigue, Beebe stone cutter, has no doubt decided that this is a pretty tough old world. Things have not been going his way at all lately. First of all Rodrigue discovered what he considered a plot to injure his good name and character. Next thing he knew he was ousted from the church choir. Then he discovered his membership in the A.C.J.C. and the Sacred Heart Society doubtful and everyone seemed to be turning their backs on him.

Like Shylock, he decided that his only recourse was in the courts of justice. So, after a conference with his lawyer, he decided to sue, and sue he did. He sued everyone he thought had done anything to harm him, but his efforts brought him little consolation.

Yesterday in the Superior Court here twelve jurymen heard his claim for \$5,000 damages for defamation of character against Beebe Councillor Joseph-Adelard Boulais, but the law decided that his charges were unfounded and the action was quickly dismissed.

Boulais, accompanied by two other councillors, Mayor Woodard, Beebe and a police officer paid an unexpected visit on Rodrigue on the night of March 29th, last, a visit which Rodrigue considered none too friendly.

Rodrigue declared that Boulais, as well as others, had accused him of keeping a disorderly house and selling liquor, which charges he claimed were false.

Rodrigue declared he had enjoyed an excellent reputation in Beebe up to the time the alleged charges were made against him by the Mayor, councillors and the policeman.

Rodrigue thought it over, nursed his indignation and then began to sue. He sued right and left, for an aggregate amount of \$25,000—insulting actions against Councillors Boulais, Mayor Woodard, Councillor Charles Berry, Councillor Irvin Corey and Eugene Sheppard, Beebe policeman and officer for the Quebec Liquor Commission. Each action was for \$5,000.

With the dismissal of the Boulais case, Mayor Woodard, it is considered very improbable that the other four actions will be pressed before the Superior Court tribunal.

Mr. Justice Hector Verret, who confirmed the verdict, presided over the Superior Court and the jurymen were, Honour Blais, J. B. Morin, George Gagnon, Henri Veilleux, O. Chamberland, Hippolyte

TAKE DRASTIC STEPS TO HALT FURTHER RIOTS

Administration of Holy Land Given Power to Deport Offenders in Racial Riots—No Further Casualties Despite Continued Sniping.

Jerusalem, Oct. 31.—Dawn revealed the streets of the Holy City strewn with nails today, presumably by Arabs to hinder the transporting of government forces ordered out to halt anti-Jewish demonstrations.

Snipers blazed away at the government offices intermittently throughout the night and police returned the fire, but there were no casualties to add to the thirty dead and hundreds wounded in previous bloody rioting.

An emergency law was called into effect today in an effort to prevent further outbreaks. It vests the administration with wide powers including authority to arrest, court-martial and deport offenders. It was hoped this move would forestall recurrences of the defiant demonstrations.

BRITAIN WILL DISCHARGE DUTY "WITHOUT FEAR OR FAVOR"

London, Oct. 31.—Great Britain will discharge its mandatory duties in Palestine "without fear or favor," but law and order must be preserved, Sir Philip Cunliffe-Lister, Colonial Secretary, said today.

The Colonial Secretary spoke "very plainly" to the people of Palestine in an exchange of messages with Sir Arthur Grenfell Wauchope, Palestine High Commissioner, on the occasion of the opening of the harbor at Haifa.

Sir Philip's message said: "This country is overpowered by the deplorable disturbances which have taken place.

"I would speak very plainly to the people of Palestine. Thirteen years ago Great Britain accepted the Palestine mandate. The mandate carried with it clear duty to the Arabs and to the Jews. That duty will be discharged fully and fairly without fear or favor.

"There is under the mandate an obligation to facilitate the establishment of a Palestine national government, but at the same time there is a paramount duty to preserve law and order. That duty, too, will most thoroughly be discharged."

Sir Philip concluded: "I appeal to all men of good will to give the High Commissioner loyal support and co-operation in his work for the common good of all."

RECOVERY MACHINERY FAILING TO SUSTAIN HOPES OF ITS SPONSORS

Despite Slowness of National Recovery Act in Producing Results, President Roosevelt Believes Country Heading in Right Direction—Opposition of Leading Manufacturing Interests Greatest Menace to Scheme—Decision to Purchase Gold Seen as Sign of Dissatisfaction.

New York, Oct. 31.—Clouds of doubt cast their shadow today over the hopes that the National Recovery Act could quickly pull the United States out of the depression "by the bootstraps."

From Washington and elsewhere surveys have come in recent weeks to indicate the vast machinery President Franklin Roosevelt set up to reverse hard times is running behind schedule with few, if any, of its major parts clicking in the manner foreseen by its more rabid engineers.

Mr. Roosevelt definitely is not in the rabid class. He has said more than once that economic pictures cannot be re-cast in a day, a month or a year.

The President's turn to gold purchases on the world market in the hope of hoisting commodity prices is seen in some quarters as based on the realization that all is not thoroughly well elsewhere in his programme.

On the credit side of the N.R.A. ledger, a major item for consideration is that something like 3,500,000 have found re-employment.

By the vigorous Hugh Johnson, the predicted exactly twice that number would be returned to work "before the snow flies."

Also, a new psychology is abroad among the working masses. The Federal government's "buy now" campaign has had favorable results, as attested by wholesale and retail figures for most lines. But Henry Ford, a few powerful figures in the steel and oil industries, large slices of the country's financial and farming communities either have said outright or let it be known they disapprove of certain phases of the government's ambitious plans.

CALLS FOR STATEMENT ON CONDITION OF ALL U. S. BANKS

Washington, Oct. 31.—The Comptroller of the Currency issued a call today for the condition of all National Banks in the United States at the close of business on Wednesday, October 25th.

The text read: "J. F. T. O'Connor, Comptroller of the Currency, has this day called upon all National Banks in continental United States Alaska and Hawaii and all savings banks, trust companies and credit unions in the district of Columbia for reports of conditions as of the close of business on Wednesday, October 25, 1933."

TOLMIE SEEKS SUPPORT FROM OTHER GROUPS

British Columbia Premier Declares Any Cabinet Re-organization Plans Must Await Outcome of Elections.

Vancouver, Oct. 31.—Premier S. F. Tolmie has again given notice he is not depending alone upon candidates named as his supporters to govern his action after the British Columbia elections.

In a public address here last night he remarked, "no new government will be formed during the election, but after the election."

This is in line with his stand that after the voting he will consult with all members who favor a union form of government. Only a dozen candidates in the forty-seventh seats have been named as Tolmie Unionist Government supporters, but many are running as independents with freedom to decide affiliation later.

"I have no doubt," said the premier, "the next government will be made up of the best men procurable, regardless of previous affiliations, a group ready to place the province ahead of private or party interests."

He said he had in no way hampered any of his supporters in the selection of how they should run but had given them perfect freedom to do what suited them best having regard to the peculiar conditions existing in their respective ridings.

The premier reviewed his invitation to T. D. Pattullo, Liberal leader, to join him in a union government, with leadership to be left open after an election, and declared the previous Liberal administration, of which Mr. Pattullo was a member, had failed to balance their budget and had run tremendously into debt.

The present administration group, he said, was the only one offering with experience of running the country in troublesome times.

Meantime, today, the campaign proceeded with only a few days left before the voters will decide the fate of 175 candidates in forty-one seats. Six seats will be decided November 27th.

REMOVE FIXED VALUATION ON EMPIRE GOODS

Refunds Against Dominion or Law-suits Against Government May Be Outcome of Tariff Board's Ruling.

Ottawa, Oct. 31.—Far-reaching in importance, arbitrary valuations fixed against British Empire goods since November 25, 1932, by the Department of National Revenue under section forty-three of the Customs Act stand invalidated today under a decision of the Tariff Board.

Refunds by the Dominion or lawsuits against the government for such imports and dumping duties collected under section forty-three since it was amended in November, 1932, may be the outcome of yesterday's ruling of the Board.

Enacted in 1931, the section in question gave power to the Minister of National Revenue to fix arbitrary valuations for goods of origin, irrespective of the country of origin, the importation of which was believed to be prejudicial or injurious to manufacturers or producers in this country. In November, 1932, however, this authority was amended by limiting the power to fix arbitrary valuations to goods imported under the intermediate and general tariffs and excluded British Empire products. The Board's ruling of invalidity is based on this amendment.

MAY RESTORE THOUSANDS OF DOLLARS TO IMPORTERS

Ottawa, Oct. 31.—The ruling made yesterday by the Tariff Board that section forty-three of the Customs Act could not be invoked to increase duties against British goods may restore many thousands of dollars in rebates to importers.

ASCAH GIRL ALIVE WHEN THROWN INTO ICY WATERS OF GASPE BAY

Autopsy Proves Young Victim's Skull Was Fractured by Blunt Instrument Before She Was Tossed into Watery Grave—Police Convinced Elder Ascah Girl Met Same Fate as Her Cousin—Thousand-Dollar Reward Offered by Attorney-General's Department for Information Leading to Arrest of Murderers.

Peninsula, Que., October 31.—A flotilla of fishing vessels and police boats dragged Gaspé Bay today, with searchers convinced that Marguerite Ascah, seventeen years old, had shared the fate of her fifteen-year-old cousin, Maud Ascah, and was to be found somewhere in the depths of the Bay.

Meanwhile, Dr. Guy Pouliot, of L'Anse du Cap, had decided to open an inquest some time today on the body of Maud, recovered from the Bay last Saturday. From Quebec came word that the Attorney-General had offered a reward of \$1,000 to any person who could supply information leading to the arrest of persons connected with the death of Maud Ascah, and police are redoubling their efforts to solve the mystery of the disappearance of the two girls from their homes here on August 30th.

A preliminary autopsy performed on the legless body of Maud revealed that the young girl was still living when she was hurled into the water, according to Dr. Rosario Fontaine, provincial medico-legal expert. Dr. Fontaine said the girl's skull had been fractured with a crushing blow from some heavy, blunt instrument, and that she had been tossed alive into the Bay.

Previous reports that there was a knife wound in Maud's body were denied by Dr. Fontaine, but he confirmed the news that the girl had been roughly gagged with a piece of material ripped from her own dress. Examination of the contents of her stomach revealed that the girl had died about three hours after her last meal, the doctor said.

On August 30th the two girls left their adjacent homes here to attend a meeting. Returning from the meeting they visited their aunt in her cottage and then started for home. They never reached their destination.

Frantic parents and neighbors searched through the night and Royal Canadian Mounted Police and provincial detectives took up the search the next day.

Many clues were run down. Reports that the girls had been seen as far away as southern New Brunswick in company with young men were investigated and found false.

The first tangible fact connected with the disappearance of the cousins was the discovery of a naked human foot, which Dr. Fontaine said was the right foot of a fifteen-year-old girl. Later a shoe was found, and then another shoe and a girl's coat. Relatives said the shoes and coat belonged to Maud Ascah.

Last night it was established that the same shoe found was worn by Marguerite and not Maud, leading to the belief that she also was lying somewhere in the bay.

Gaspé folk believe the girls were killed and thrown into the bay by rival runners out of revenge for the activities of members of the Ascah family connected with the Quebec Liquor Commission police and the Customs Preventive Service.

RAIDERS DESTROY TRUCKS DURING DRIVERS' STRIKE

Massachusetts State Police Unable to Save Convoy of Twenty Trucks from Groups of Strike Sympathizers.

Charlton, Mass., Oct. 31.—A band of raiders who rode the Springfield, Boston highway through the night, burned one truck and damaged six others as violence flared in the strike of western Massachusetts truck drivers.

The most serious outbreak occurred on Charlton Hill, where auto-riding raiders ambushed a fleet of twenty trucks en route east with freight. Gasoline was poured on one of the freight-laden vehicles as state police, who were escorting the fleet, sought to question some of the raiders.

The gasoline-saturated truck was set afire, and as troopers rushed to extinguish the blaze the raiders stoned and damaged five others in the convoy. Additional troopers were called and the disorder quieted. The disturbers made their getaway.

AGED PRISONER SUCCUMBED TO HEART ATTACK

WHERE THE POLICE MUST GET THEIR MAN.

There is more than Justice at stake in the Ascal tragedy on the Gaspe Coast. The arm of the law should reach out with an army of the law to bring to justice the perpetrators of the crime which has no comparative annals in Canada. If the crime be traced to smugglers; if it is an act of revenge, with two innocent children as the victims, then should every smuggler on the Gaspe Coast be treated as they would do unto others. Not a more inhuman case is there on the records.

All along the Gaspe Coast there has been a steady stream of tourists, growing in number each year since the Perron highway was finished. Conceive the injury which will be done to this popular vacation ground if the guilty are allowed to escape their deserts. Travellers far from home are proverbially timid, particularly the ladies.

This is a crime which must be cleared up. No thought of expense should enter into the chase and capture.

COMMENT OF AN ENGLISH PAPER LOOKING THROUGH A KNOTHOLE.

We in Canada must take the utterances of the Manchester Guardian with more than the proverbial discount of a grain of salt. The Guardian for thirty years opposed the Imperial preference, which is working to the mutual advantage of Canada and the United Kingdom. Hon. Joseph Chamberlain, the founder of the movement, left behind him many men who carried it to a conclusion. Mr. Chamberlain launched the idea long before Sir Wilfrid Laurier gave to Britain the British preference without any quid pro quo.

So that when the Manchester Guardian, through its Canadian advisory staff, would envisage the C.C.F. as being vigorous because of a bye-election result in the West, and would accord them a balance of power after the next election, we not only discount the weaving-center newspaper, but we claim its interpretation is all wrong. To most of us in Canada the C.C.F. is a political joke, even when we reflect that many half-wits are often elected to office.

The Communists, or converts to Sovietism, are a new and vigorous party, but they would not number ten thousand, and Russia has staggered a bit in its financial support of filibusters in foreign lands, just as were the Jacobins of the French Revolution routed in all their proselytizing efforts when Napoleon proclaimed himself Emperor and suppressed mob rule.

Canadians in the mass are sane and cool-headed. They are loyal to King and Country, and they abhor any party which refuses to join with them in the singing of the National anthem.

We may answer the fool according to his folly, but we are unperturbed by the underworld advocates of Sovietism in Canada. Fear of the agrarians in an agrarian country makes the C.C.F. except farm lands when they advocate the conscription of everything but farms. Yet once in power the farmers would be crucified by those who know not what they do so long as they can be lions among the lambs.

The Record Man on the Wing

Sixteen years ago today, the men from the "Land of the Maple" were, slowly but surely, pressing back the flower of the German army at Passchendaele. Stubbornly the Germans fought, contesting fiercely every foot of ground. Shells and bombs of every size and description rained on the ground until the fields became a sea of mud, but, regardless of all, the Canadian army moved on to their objective, leaving the ground behind them thickly strewn with dead, dying and wounded companions.

After days of fighting, the news flashed around the world that the Canadians had taken Passchendaele. A few days of rejoicing, then like the stab of a knife, came the price.

From the Atlantic to the Pacific; from our Southern border to the Arctic circle, flashed the fatal messages, telling of the brave young soldiers who would never return.

Perhaps nowhere in the annals of the British army can be found anything more pathetic than the case of Mr. and Mrs. Edward Larive, of Ascot Corner. To their farm house, overlooking the St. Francis River, came a message one November day telling them that their two soldier boys were amongst the fallen. Their girls were, perhaps, types of young Canadians, just budding into manhood. Patrick aged 20 and Daniel only 19. Both killed in action as Passchendaele; one in the morning, the other in the evening of October 31st, 1917.

My father has become frantic; many a mother has died broken hearted under a lighter blow, but this couple, bravely and calmly, accepted their fate, as only those can, who truly love their God, their country and their King.

Patrick Larive was born in Richville, Megantic County, on July 10th, 1897 and Daniel on the same place on August 11th, 1898. The Larive family are of Irish descent, and have been prominent in Megantic County since the earliest settlement. When his children were yet small, Edward Larive sold his farm in Richville and bought one at Ascot Corner. In the Ascot School and St. Patrick's Academy, Sherbrooke, his family was educated. After leaving school, Daniel stayed on the farm with his parents, while Patrick went to work for the Bromponton Paper Company.

Daniel enlisted in the 117th Battalion in February and Patrick one month later, and it was on the Empress of Britain that they left for overseas on August 12th. Shortly after getting to Branshott Camp, they both transferred to the 5th Canadian Mounted Rifles and went immediately to France. Today they sleep together in soldier's graves.

Many letters of sympathy came to the bereaved parents, from the bloody fields of France and Belgium, expressing the high regard in which the two young soldiers were held by their comrades. One from the major commanding their company, tells of their bravery and devotion to duty on many a hard fought field; and later a memorial from the war office, with the notification that the name of Pte. Daniel Larive is now engraved on a Menin Gate Memorial at Ypres, Belgium, for being mentioned in dispatches for bravery.

Briefly this is the history of two young soldiers, the anniversary of whose death is today. Two young Canadian lads, who, unflinchingly crossed the seas and in a foreign land, fought till death for the flag of their fathers. They gave their young lives for a scrap of paper, old and musty, but on that paper was a pledge and the seal of their country.

God grant that the men and women of this young Dominion will ever remember those long lines of white crosses and honor and respect the parents, the wives and children of those heroes who sleep beneath the poppies.

God grant that the rising generations will reverence the memory of the men who fought their country's battles, to the extent that they will closely guard our borders against all who do not hold the high ideas of christianity, loyalty and honor as did those lads.

Weep not that their toils are over, Weep not that their race is run, God grant that we may rest as calmly,

When our work, like theirs is done, No call nor clamor can wake them, From slumbers so pure and deep, For only his voice can reach them, Who giveth his beloved ones sleep.

COUNCIL HELD BUSY MEETING AT COATICOOK

Question of Changing System of Electing Councillors, Request for Additional Grant for Coaticook Band and Adoption of By-Law Granting Commutation of Taxes Included on Busy Agenda.

ALD. LANGIS IS NOT CATERING TO WEST WARD

Finance Chairman Would Delay Work on Fabre Street, in Spite of Proprietors' Desire to Have Project Proceeded with.

Ald. Langis once again last evening made it quite apparent that he is none too kindly disposed towards the West Ward. Aldermen Blais and Jobin, who represent that particular section of the city, are not on specially good terms with the finance chairman, and he apparently does not intend to let them get away with much.

For a time, at the beginning of last evening's brief special meeting of the City Council, it appeared as though Alderman Langis and Jobin would work up a good discussion. This did not materialize, but a second round in the verbal bout might be forthcoming next Monday evening.

The discussion centered about proposed work on Fabre street in the West Ward. In the report of the finance committee it was stated that the proposed levelling of Fabre street be left in abeyance until all the proprietors on this street had signed that they would not hold the city responsible for any damage which might be caused to the properties.

Ald. Jobin said that any delay in the work was quite unnecessary as he had with him a petition signed by every proprietor but one, and they were all willing that the work should be proceeded with and that they would claim no damages. The reason that the petition was not unanimous, Ald. Jobin said, was because one proprietor was absent in Quebec City at the time the petition was signed.

Ald. Langis showed that he was vindictive when he said that several weeks ago the two West Ward representatives objected to a by-law providing for the transfer of funds and had expressed themselves as being opposed to any further expenditure on works. Now they came forward and asked that the work on Fabre street be undertaken. Ald. Blais was absent from the meeting, so the whole defence of the West Ward fell upon Ald. Jobin.

Ald. Fortier, however, did not hold the same views as did Ald. Langis. If the residents of Fabre street desired to have the work done, he saw no reason why there should be any delay.

After a brief discussion it was agreed to leave the matter over until the regular meeting on Monday evening next.

Last evening's session had been specially called for two purposes. First, to give second reading to the by-law and discussion was left over until next Monday evening. He did not even read the proposed by-law, but simply made a motion that it be considered as read the second time.

There was nothing of special interest in the committee reports. The Road Department report recommended that a retaining wall be built along the east side of Magog street at an approximate cost of \$11,000, and the finance committee favored the proposal that sewers be laid along the length of the east side of the St. Francis River, from the Wilfrid Bourque property to Blouin Lane. This undertaking, according to the city engineer's plans, will cost \$8,800. Both this and the Magog street project will be done by the unemployed.

The Parks and Real Estate Committee recommended that the land in front of the Civic Hospital be levelled, preparatory to the planting of trees and shrubs to be supplied by the Provincial Department of Agriculture, at an approximate cost of \$200.

The request of N. N. Walley and Son for use of the old dump ground on the Brompton Road for piling pulpwood was granted, the cost

CONSIDERABLE FURORE CAUSED BY RUMOR OF HITLER'S DEATH Mingled expressions of relief and disappointment, of joy and regret were heard by the Record editorial staff this morning at the conclusion of the hundreds of telephone calls which sought confirmation or denial of the rumor that Chancellor Adolf Hitler, of Germany, had been assassinated. Seven of every ten calls brought the same query, "Is Hitler dead?"

The rumor was officially spiked by press associations which chased the canard to its source. The rumor circulated on brokers' wires throughout Canada and the United States and it apparently found its way to the radio.

During the day the Canadian Press had a number of cables from Berlin reporting the situation there normal, with Hitler's forces continuing an intense election campaign.

Perhaps it was just another election rumor.
