RAILWAY NEWS.

—The earnings of the Burlington, Cedar Rapids and Northern Railway Company for the week ending May 14 were 1882, \$33,957.49; 1881, \$36,669.12; increase, \$2,711.63.

—A despatch from Trenton, N. J., reports that the Chancellor has ordered an election by the New Jersey Central Railroad. The Chancellor's opinion is very long.

—The gross receipts of the Philadelphia and Reading Railroad during April were \$1,709,712.18; expenses, excluding rentals, \$1,029,638.34, leaving a profit for the month of \$680,073.84.

—Advices from Chicago state that the east-bound freight on the trunk lines continue to decrease because of the low lake rates which give vessels the preference to all points reached by water; and there is not sufficient business going to inland points to make a respectable showing.

—Mr. McHenry, of London, has written to the New York World regarding the Erie litigation. He remarks that the Erie Company, to silence a troublesome, perhaps dangerous inquisition threatened by the mission to New York of Sir E. Watkin and Mr. Morris, successfully "discovered" them, and as a brilliant counter stroke commenced action to recover from me money paid by me in London and by Mr. Jewett in New York, for acquiring Cleveland, Columbus, Cincinnati and Indianapolis shares, in support of plans laid down by Mr. S. L. M. Barlow as counsel, and Mr. P. I. Wainwright as President of the Erie Company.

Boston, May 22. The leather market has remained quiet, partly owing to the most severe weather, and prices are unchanged. The new export inquiry has been light. From New York the exports have been 22,613 sides, against 51,578 last week and 22,608 the week before. The receipts at New York have been 80,420 sides, against 80,460 last week and 83,547 for the week preceding this.

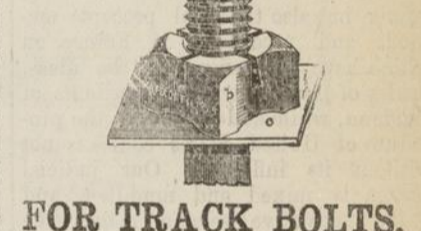

Irish Opposition to the Representation Bill.

MR. GLADSTONE'S VIGOROUS DEFENCE.

Parnell Abandoned by a large number of his Supporters.

CONTINUED JEWISH PERSECUTIONS.

The Egyptian Malcontents Preparing for Fight.

LONDON, May 24.—In the House of Commons, Mr. Forster denied that the Government had negotiated with the suspects clandestinely.

Dillon resumed the debate on the Representation Bill intimating that evictions were more common than outrages.

Mr. Gladstone severely denounced Dillon for endorsing outrages by refusing to assist the Government carrying the Bill.

Dillon declared that he always denounced outrages.

Mr. Gladstone replied that inciters to illegalities were responsible for the consequences.

Dillon affirmed that Mr. Gladstone had declared that boycotting was legal.

Mr. Gladstone spoke with great passion. He said the Irish must confine themselves to agitating for changes in the law and laws or whatever they may desire by proper means, respecting private judgment and the liberty of the subject.

Mr. Gladstone said that the object of the Irish judges to the suppression of juries he declared that if Parliament allowed judges to interfere in the framing of the bill they would abandon one of the most important functions of the Government.

He thought the institution of a special tribunal necessary. No good could come of a prolonged discussion unless it was the intention of some members to exasperate the animosity between England and Ireland. He beseeched the House not to obstruct the bill.

Mr. Ritchie, Conservative, stated that he would not vote for the bill.

Sir S. Northcote regretted this intention. Whatever fault might be found with the Government's Irish policy, the Conservatives ought to give a solid vote for the bill in the interest of peace and order.

There should be no uncertain sound in the matter.

Mr. O'Donnell denounced the bill. The Irish ought never to rest until the administration of Ireland was free from British interference.

The debate was adjourned on motion of Mr. Parnell.

HOME RULE DISSENSIONS.

LONDON, May 24.—The action of Healy Dillon, Callan and O'Donnell, forcing divisions in the House of Commons yesterday, contrary to the wishes of the Government, Parnell, is regarded as a defiance to Parnell and throwing over his authority as leader of the Irish party.

There was intense excitement on the Irish benches during O'Donnell's speech, and frequent applause from half a dozen members.

During the progress of the scene, Parnell sat pale and weary looking. When the final challenge to a division was made by O'Donnell and supporters, Parnell left the House, followed by a number of his party.

Among English members the incident is regarded as a forerunner to the disappearance of Parnell and the disruption of the Irish party.

There is, however, reason to believe that a reconciliation may be effected, as many of the fifteen members who took part in the demonstration have already expressed their regret.

Justin McCarthy and Sexton who voted with the fifteen disdain any intention of affronting Parnell or attacking his authority.

All the papers comment upon the significant divergence among the Irish members, in the division last evening in the House of Commons on Mr. Gladstone's motion that the Representation and Arrears Bills have precedence over other business.

Besides O'Donnell and Arthur O'Connor, those refusing to follow Mr. Parnell, include Thomas Power O'Connor, Redmond, Finnigan, Richard Power, Sexton, McCarthy, Biggar, O'Sullivan, Moore, Healy, Sullivan, Leamy, Callan and Shiel.

The following abstained with Parnell from voting on the division: O'Kelly, Cummins, Synan, Molloy and Marum.

New York, May 24.—The Tribune's London special says there is a complete split among the Irish members, consequent upon the Kilmainham compact.

The disposition shown by Parnell and his immediate followers to assist the Government, represented by the more advanced sections of the party.

It is reported that Parnell contemplates retiring to private life, but the best authorities state that he has no such intention at present.

A POLICY OF OBSTRUCTION.

LONDON, May 24.—The Parnellite members of Parliament state that the Representation Bill cannot pass before July. Nearly 200 amendments are prepared against it.

The Times, discussing the correspondence between Lowell and Frelinghuysen in regard to the suspects, says: "We hear a great deal of the protests of the Washington Cabinet with the fear of the Irish vote before their eyes, against our finding it necessary to imprison American suspects, but we hear very little of steps taken by them against the assassination press."

LEGISLATIVE RESTRICTIONS ON JEWS.

St. Petersburg, May 24.—The regulations agreed upon by the Committee of Ministers and approved by the Emperor prohibit Jews from settling outside of towns and villages, except where Jewish settlements already exist, and from trading on Sundays and Christian holidays.

The regulations only apply to Governments where Jews are permanently settled. All contracts or tenancy with Jews are provisionally suspended. The Government is firmly resolved to punish inexorably all outrages against the person and property of Jews.

CONSTANTINOPLE, May 24.—In reply to the protest of Turkey, England and France have informed the Porte that the vessels at Alexandria will be withdrawn as soon as a durable state of normal things is re-established.

CABLE NOTES.

Sir John Holker, who resigned the Lord Justiceship of the High Court of Appeal on Monday, is dead.

The rumour of the engagement between Princess Beatrice and the eldest son of the Landgrave of Hesse is denied.

The Governor of Tripoli, in consequence of the approach of French advance parties, has ordered it necessary to send a strong force to the frontier.

A Vienna despatch says that a small-pox epidemic prevails at Sera Jevu. Twenty deaths occur daily and several Government officials have died.

Russia and Austria have decided to act in complete accord on the Turkish question. This decision has been arrived at spontaneously and reciprocally, almost without an exchange of engagements, both being convinced that Germany would be happy to see them mutually exhaust themselves in war expenses. Therefore all causes of discord or dissension between Russia and Austria are forgotten or set aside for the moment.

DOMINION DESPATCHES.

TOUTFUL CRIMINALS.

OTTAWA, May 24.—A gang of about fifteen boys, who for months past have been causing annoyance to the community, has been broken up by the police. They have been continually committing petty thefts, and occasionally venturing upon crimes, the execution of which required an amount of dexterity and hardihood astonishing in children.

Many of them are of respectable parentage, and the great trouble has been how to punish them. Six of the juvenile criminals are now in goal in connection with the Smith burglary, committed here on Sunday night last.

MANY KILLED AND WOUNDED. Fiendish Attempt to Wreck a Passenger Train.

At Portland, Oregon, Captain Thompson, of the British steamer "Bothwell Castle," has been fined \$8,000 for bringing 160 more Chinese than the tonnage of the ship allowed. He was also fined \$1,000 for not reporting the correct number of passengers at the Custom House.

A HEROIC STATION AGENT.

DALLAS, Texas, May 24.—There is much alarm at Garritz's Pass, 113 miles east of El Paso, on account of the proximity of large parties of hostile Apaches going northwest in full light of the camp of hunters, miners and prospectors. The Indians have been driven by Mexicans across the borders. Three hundred dollars are offered by the Mexican Government for the scalp of each hostile Indian.

CONTENTS OF INDIAN MOUNDS.

St. Paul, May 24.—A skull of heroic size and singular formation has been discovered in a mound in the Red River Valley. The mound, which is sixty feet in diameter and twelve feet in height, contained the bones of a dozen males and females, the property of the various animals. The skull evidently belonged to a giant.

PRIGHTFUL COLLIERIES DISASTER.

SHENANDOAH, Penn., May 24.—A frightful explosion occurred in one of the collieries here to-day, a number of miners being killed. Among the dead taken out are John Lee, fire boss; James Mulhall and named Stroub and McDonald. Twenty men are still in the mine, and cannot be reached on account of after-damp. The explosion killed two mules, blew down all the doors in the mines and caused the property to be scattered in various directions. Four men who were taken home badly burned are still living. It is believed the number killed will be about 140. The excitement is intense. When the men went down this morning the fire-boss warned them that the mine was full of gas. The men, however, became negligent, discarded the safety lamps and carried their own lights. Thus the gas was fired.

LATER.

It is now believed that only six men were killed and two fatally hurt. The names of the killed are Martin and James Mulhall, father and son, Owen Gallagher, James McDonald, John Strat and Samuel Hugo. The fatally injured are John Lee, fire-boss, and Matty Matenyowiz. The men were working at the bottom of a new level, 1,700 feet from the top shaft, when all of rock caved, forcing the sulphur down and it quickly ignited, and the naked light. The force of the explosion was terrific. The men were hurled along the gangway and dashed against timbers, mutilating their bodies so terribly as to be almost unrecognizable. A number of men received serious but not fatal injuries. The news of the accident was brought out by men who escaped a shock of hundreds of feet to the shaft, and as the mutilated bodies were brought up many women fainted, while others had been taken away by force. It is believed the dead and injured are all out of the mine. Between three and four hundred persons are employed in it.

TRAIN WRECKERS AT WORK.

MADISON, Conn., May 24.—A young man named Way, going home at midnight on the track of the Shore Line Railway, heard the pounding of hammers, etc., and found a large number of men placed along the track and nailed down. He began to remove them, as the mail train from New York for Boston was soon due, but was fired on by parties in ambush, a bullet wounding him in the leg another breaking his arm. Way then proceeded down the road and stopped the train by waving a lantern he had with him. Train hands removed the men and Way was taken to a hospital, where he is now recovering. He was dressed by a physician on the train. Way remained on the track after the train proceeded. The wreckers again replaced the obstructions to throw off the train from Boston, but Way signalled the train in time.

WAY'S HEROISM.

The obstruction consisted of two large ties put between the ties on a pile bridge, and which projected over the level of the track three feet. The bridge was two hundred feet long and spans the Salt Meadow. There is a large number of ties set on either side of the track. But for Way's discovery there would have been a terrible disaster. Way is only twenty years old, and is station agent at East River. He says five men are concerned in the affair. The railroad authorities are making great efforts to capture the wreckers. It is suspected that three trains who were detected trying to steal a ride and spoiled from two trains were concerned in the attempt. It appears that Way ran to the station after they fired and displayed red lights. There were eight passenger cars in the train, well loaded. Three men have been arrested on suspicion at East Lynn and one man at Middletown.

CUSTOMS OFFICERS ARRESTED.

LONG BRANCH, May 24.—Warrants for the arrest of Colonel Houghton, Collector of Customs at Perth, Ambroy, Joseph Smith, Deputy Collector, and William Hopper, Inspector of Customs, Long Branch, have been issued upon the oath of a special agent of the Treasury, charging them with conspiracy to defraud the United States with forged and embezzled money. A civil suit for \$12,000 has been commenced against Houghton.

ANOTHER SERIOUS OVERFLOW.

LITTLE ROCK, May 24.—General Mangum informs the Governor that there is another disastrous overflow of the Mississippi river in Arkansas. Over three-fourths of the bottom lands in Phillips County are under water, with no prospect of being out before the last of June. Desha is in about the same condition, as are also portions of Lee, Monroe and Crittenden Counties. The suffering of the labourers in these counties will be greater than ever known. They are nearly all negroes, with no means of obtaining the necessities of life. All hopes of crops are gone. Mangum says if the Government rebuilds the levees at once the negroes can get work, otherwise he fears many will starve. The condition of the people is alarming.

BRITISH HOUSE OF COMMONS, May 8. Mr. Gladstone, with manifest emotion, said:—I rise for a purpose which I think the House will anticipate, it is to move the immediate adjournment of the House. It is a course I believe, Sir, that will be found in conformity with what has been done on previous occasions when sad events have come home to the mind of Parliament and the public. I believe, Sir, that this event must be known on Saturday night, and yesterday morning is unparalleled in our history, and unparalleled for the blackness of the crime which has been committed, unparalleled as I fully believe, for the horror it has excited in the entire people of the United Kingdom. (Hear, hear.) Having said that I shall make this motion, I will say—and I promise the House to be as brief as I can, since I must in a very few words advert to the character of the event—that in the death of Mr. Burke we are robbed of one of the best, the most upright, the most experienced, the most eminent members of that civil service to which in the hands of its permanent officers we owe so much in the government of the country. (Hear, hear.) But, Sir, the hand of the assassin has come near the heart of the assassin, and I think it is not in a state at the moment to grapple with the serious course of parliamentary business. I will, therefore, limit myself, Sir, to giving notice that I shall think it our duty to ask the attention of the House at once to what is felt to be most deeply pressing, and what I believe in the present emergency to be perfectly practicable. We intend to ask the House on Thursday next to permit us to introduce a measure relating to the repression of crime in Ireland (hear, hear); and we have the fullest confidence in its spirit that what it ought to be done by the House will be done by the House. (Hear, hear.) That on Thursday next, next to that, and I hope upon an early day, we shall introduce a measure to amend the law relating to the repression of crime in Ireland (hear, hear); but it will be felt that I cannot name a day for that purpose, inasmuch as it must necessarily depend upon the progress we may make in the stages of the earlier measure. It will not be delayed one day beyond what necessarily requires, and I trust that the House will be satisfied by very short. I think I ought to add nothing to the words I have said. I thank the House for having assisted in the performance of the most painful task that ever devolved upon me when standing at this table. I have no doubts as to the support which the House has so kindly and so generously given to me. (Hear, hear.)

members present who I knew Mr. Burke so well as I did, and I feel it to be my duty to say a word or two about him. (Hear, hear.) I had the most intimate relations with him, under difficult circumstances, now for two years. It was a very short time before I heard of what manner of man he was, and I can truly say I believe the Queen and the country never had a more faithful, a more upright, a more truly honourable and unselfish servant. (Hear, hear.) His industry—his devotion to his duty—was something more than we are accustomed to. During the last two days he never had a fortnight's holiday. Day after day, from morning to night, he plodded on with work which was most distasteful, uncomplainingly, quietly, with a silent, dignified reticence that belonged to him, without much praise—he never expected it. But we all thought he was safe from such a visitation. (Hear, hear.) To give the House an idea of what the man was, his silent, dignified endurance and power of doing his duty without looking for any reward, I will mention one fact. Some months ago I saw many men in the Civil Service dignified, and I thought Mr. Burke was one who should have an honour conferred upon him. I wrote and told him I thought I ought to press it. I wish I had more words at my disposal. He was satisfied with the respect of those who worked under him and with the confidence of those above him, and he entirely forbade me asking for it. (Cheers.) I must say one other word. I think I never met with a man so without prejudice, so completely and absolutely determined to do justice to all classes, and that in a country where it is sometimes difficult. I must say—and I should like them to know it—that the tenant-farmer and the poor tenant-farmer, never lost a truer or more faithful friend. He was ready to mention the name of any tenant well, and he stood up for their interests. Over and over again he has decided a question for the tenants, and if there was a case of hardship on the part of the landlord towards the tenant, Mr. Burke, of all the men I met in Ireland, was most ready to denounce it. (Hear, hear.) I am sure the House will forgive my saying this, because I knew him so well.
