PRESIDENT ARTHUR'S CANAL SCHEME.

Many leading United States journals are coming up to the support of President Arthur's Nicaragua canal scheme. The Baltimore Day says the sentiment of the country is rising rapidly in favor of it. "Even if the treaty is to give us trouble," says this journal, "it will be far better to have the matter settled at once than in time of some future war, when the existence of the treaty would seriously embarrass us." The New Orleans Picayune stands by the treaty, regardless of consequences. The Philadelphia Call "believes that it is the interest and duty of our Government to ratify this treaty, unless arrangements can be made to secure the annexation of Nicaragua, either by purchase or as a State of our Union. But in any event, as the issue is upon us, we should arouse to the fact that if the Monroe doctrine is to be maintained it requires positive measures. We can no longer sit still and warn off the rest of the world." The Buffalo Courier holds that "England could not fairly dispute the claim of the United States to a controlling position on the Isthmus while she has control over the Suez Canal. In time of war such a position would become simply a question of power." The Philadelphia North American says:—"The autonomy of the Western World should be maintained at all costs, and it cannot be maintained under a surrender of the natural gateway to the Pacific. It is only a question of time when the Isthmus will be pierced and the path of commerce around Cape Horn abandoned. This commercial revolution should be wrought by the Western nations, and its fruits should be by those nations largely shared." The Cleveland (Ohio) Leader says:—"The undertaking to defend Nicaragua from the attacks of hostile Powers involves the assumption, it is true, of responsibilities heretofore unknown to this country, yet as far as European Powers are concerned at least, it is a logical result of the application of the Monroe doctrine. By the time the canal is finished we will have a population of about 80,000,000 people, and all foreign Powers, whether American or European, will be very anxious about attacking Nicaragua, if it is under the protection of such a powerful nation."

The New York Herald warmly urges the ratification of the treaty, the New York Commercial Journal and some purely Opposition papers being decidedly opposed to it. The chances just now are favorable to its passage, and the discussion it will provoke will, no doubt, favor a large appropriation for naval purposes.

The London Telegraph, whether speaking for the English Ministry, the Clubs or the People, takes a very sensible view of the Nicaragua scheme. It says, as reported by cable yesterday:—"The Nicaraguan Canal will be of untold advantage to mankind. There cannot be too opinions as to the advisability of England seeking peace and harmony with America in preference to any other power. It can hardly be Granville's desire to quarrel with America over the long-forgotten Clayton-Bulwer Treaty, to which few Englishmen attach very great importance. England has no interest in forcibly opposing a canal across the Isthmus of Panama by whomsoever constructed, with proper provisions. A wise English Government will perceive that its interests lie in just the opposite direction."

These are statesmanlike views and will commend themselves to all Canadians, since we are all interested in seeing the utmost harmony existing between the Empire and the United States.

MANITOBIANS are boasting that they are now producing all the beef and mutton they consume. They say that for the first time the fine Christmas meat display at the country market in Winnipeg included Manitoba's produce exclusively—"not one pound has been imported." One exhibit, Kobold & Co.'s, included "six cattle fed by Pat Carey, five by the firm and eighteen were brought in from Southern Manitoba." They also exhibit two elk, which have just arrived from Manitou. This firm, whose members have spent a life time in Canada, say:—"For the first time in the history of Winnipeg her market is fitted up with Manitoba meat—meat that would do credit to any country in the world. I have been thirty years in this Canada of ours, and I can say without fear of contradiction that Manitoba is the best place in the universe for fattening cattle. I have been all through the Southern States and have had cattle fattening there, but they couldn't begin to compare to this beef here." Mixed husbandry is what the farmers of Manitoba must follow. They can raise both grain and cattle at the same time, and all of the finest quality in the world.

NEWFOUNDLAND.

The Rev. Moses Harvey, of Newfoundland, speaking of the prospect of that colony uniting her fortunes with Canada, says:—

"It does not at present come within the range of practical politics. No party mentions it, and no prominent politician would venture to declare himself in favor of it. The recent prosperity of the colony has created the impression that Newfoundland can succeed better by working out her own destiny apart from the Dominion. The impression is that our people in confederation would be heavily taxed. We would have to help pay for Canada's public works without sharing their advantages, while Newfoundland itself would get few if any advantages—seeing that we have built our own dry dock and railway. The Dominion could do but little towards developing our mines, selling our lands or opening our forests."

This is a change of base for Mr. Harvey, that gentleman (who is connected with the Newfoundland press, and wields considerable influence in the colony) having formerly been the strongest advocate of Confederation. The principal objections to the union which Mr. Harvey now raises were equally potential when he urged the colonists to accept Confederation.

There is no doubt, however, about Newfoundland doing very well. She is getting into debt almost as rapidly as if she formed a part of the Canadian Dominion. With her railway and her dry dock and the expenditures which will be needed to open up the interior of the island, Newfoundland is not likely to want for a substantial debt. Her railway at present starts from St. John's and ends nowhere. It will soon be discovered that extensions or branches are needed, and then the debt will keep pace with the improvements. At present she has the satisfaction of knowing that if she incurs a debt it is for public works and improvements on her own account. Still, as the guardian of the Gulf of St. Lawrence Newfoundland should form a part of the Dominion; and we do not suppose there is any party in Canada that would object to her incorporation into the Union on reasonable terms.

RAILWAYS IN INDIA.

The Parliamentary Committee appointed to inquire into the state of railway communication in India, and as to the advisability of building more lines, have reported favoring, 1, the extension of the present system; 2, their construction by the Indian Government; and 3, the floating of railway loans in India itself when practicable. It is stated that the entire railway system of India pays 53 per cent. on the investment. It is advised that the ultimate construction of railways by private enterprise be kept in view. Of the advantages which have already accrued to India from her railways the report says:—

"These grounds are set forth under thirteen heads. In the first place there is the necessity for increasing the works likely to protect the country against famine. General Strachey and Sir James Caird having given it as their opinion that there is no other means of saving life in time of famine so efficient and economical as railways. Next may be placed the development of the internal trade of India, with the result, among others, of reducing the price of salt and other necessary articles of consumption. Another point on which stress was laid was the rapid development of the export trade in recent years, especially wheat. Of this fact the tables of export show striking proof, the average annual value of the exports having risen from £57,700,000 in the period from 1864 to 1868, to £89,980,000 in that from 1879 to 1883; while in 1883-84 the exports amounted to £88,076,000. In regard to the exportation of wheat in particular the development of the trade has been even more remarkable, the quantity having risen from an average of 4,544,000 cwt. valued at £1,951,000, in the five years from 1876-77 to 1880-81, to 19,901,000 cwt. valued at £8,870,000 in 1881-82, and to 20,961,000 cwt. valued at £8,880,000, in 1883-84. Again, the improvement which has taken place in the credit of the government of India in the London money market would enable it now to borrow the requisite capital at a much cheaper rate than was formerly the case, and if guarantees have to be given to companies it is no longer necessary to offer the high rate of 5 per cent. formerly given."

Mr. CLEVELAND'S REMARKS on what he proposes to do for Civil Service reform when he gets to the White House do not appear to have been altogether called for. There was no emergency on him or on the country requiring him, in advance of his inauguration, to unbosom himself to the world as to how he proposes to deal with office-holders and office-seekers. Mr. Cleveland will not be President of the United States until the 4th of March next. So far as the duties of the Presidential office are concerned, he has as yet no more power or authority than any private citizen. What he has to say to the people of the United States in respect to his future programme will keep until after his inauguration, and can then be said with better taste than while Mr. Arthur is President. As for the policy of his remarks in their bearing on political parties, a majority of the Democrats who elected him will receive them with no good feeling, while the Republicans will regard them as showing signs of weakness and will not thank Mr. Cleveland. The principle laid down by the coming President is excellent, judged from a Canadian point of view, but it has been given forth at the wrong time and is entirely out of harmony with the system of party politics in vogue in the United States. It may be the duty of Mr. Cleveland to bring about a great change in the selection of United States officials, and when he gets fully installed in the Presidential office and can speak with the authority of President, the people of the United States will, no doubt, be willing to hear from him in this connexion. At present his non-official utterances seem somewhat premature.

DEATH OF SENATOR MUIRHEAD.

Hon. William Muirhead, Dominion Senator, who was known to many of our merchants and all of the public men of Montreal, died at Chatham, N.B., on Monday night, in his 67th year, after a long illness which he bore with mainly fortitude. Mr. Muirhead was called to the Senate in January, 1873, having previously been a member of the Legislative Council of New Brunswick for a number of years. In New Brunswick politics Mr. Muirhead had been an active supporter of Confederation; and after the Union he was a consistent adherent of the Macdonald Government and the Conservative party. He was during a long life one of the most advanced and enterprising of the business men of his Province. He was a self-made man in all respects, of remarkable industry and natural shrewdness and sagacity. He had been a successful shipbuilder and shipowner and lumber merchant, having at his death extensive saw mills and one of the largest lumbering establishments in the Miramichi country. The town of Chatham and the county of Northumberland will miss the energy and the enterprise which Mr. Muirhead imparted to all his undertakings, and these were invariably identified with the prosperity of the people. Personally, Mr. Muirhead was popular, a generous friend of the poor, and strong, in his personal attachments, and his death will be regarded in New Brunswick as a provincial loss.

IT WILL SOON BE TIME for Colonel Denison to put his British Empire army in motion. The Canadian National Association having established its headquarters in Ontario's Capitol—Mr. T. C. Milligan, barrister, president, Mr. Alan C. Thompson, secretary, 23 Adelaide street, E. Toronto—has just issued an address setting forth the aims of the Association. "The Canadian National Association advocates the independence of Canada" is the brief, but important, opening statement of the circular, and the reasons for taking this course are then stated. We presume these reasons have been widely circulated, and they will, no doubt, call forth a considerable amount of discussion. The appearance of this paper so quickly after the Premier's denunciation of independence sentiments would seem to argue that ultra loyal speeches by public men, instead of suppressing independent criticism of our political status, is calculated to provoke discussion and arouse to action those who might otherwise have remained quiescent. "Let sleeping dogs lie" is a sensible saying under most circumstances.

IF THE MUDIR OF DONGOLA is practicing treachery on Wolesey and the British expedition up the Nile, he is certainly in a position to operate successfully. The interview between Wolesey and the Mudir, which we publish in another column, shows that a little over a fortnight ago the Mudir assured Wolesey that from Dongola to Khartoum he would find the people glad to see him; that he would have no fighting to do; that the rebels were "all gone"; that he would find plenty of supplies en route; that the Mudir had ordered grain to be collected at various points, and that there were cattle and sheep in abundance. In fact, if the Mudir was then meditating treachery he must be regarded as a master of dissimulation. He had just been made a Knight of St. Michael and St. George.

THE ECCLESIASTICAL TROUBLES In the Faithful Province of Quebec.

An Interesting Story; but is it
True?

The following is telegraphed to the
Associated Press from Quebec:—

QUEBEC, Dec. 30.

No little agitation has been caused in religious circles by it coming to public knowledge that when Mgr. Smeulders arrived here as Apostolic Delegate from Rome he was determined to oppose to Ultramontanes, and that when he went on to Montreal certain parties, perceiving this, had approached him on the question, but finding at the time that he was unchangeable in his opinion, made up their minds to devise some means whereby to change his opinion. One of the devices is said to have been the bringing on of Bishop Tache, of Winnipeg, who came on under the pretext of visiting the Government and in connection with certain land subsidies in connection with the half-breeds of Manitoba. It is stated that, instead of going to Ottawa on this mission, he came straight to Montreal and put up with the Oblat Fathers in that city, where he met Mgr. Smeulders, who, in conversation with the former, laid open his mind upon the subject. Bishop Tache is said to have merely shrugged his shoulders at this in a suggestive manner, whereupon Mgr. Smeulders enquired of him, "What is your opinion, to which Bishop Tache said he did not know much about it, as he did not live in this country, and in course of conversation referred the Apostolic Delegate to other parties, these parties, it is said, were being well-drilled and knew exactly what to say when called upon to speak. They came on, one after another, for nearly two weeks, and each story seems to have corroborated the other to the extent that when one left he always had another witness who was acquainted with some facts which he (the present witness) could not assert. This sort of work finally came to a climax when a Mr. Pagnuolo, of St. Hyacinthe, a rabid Ultramontane, was summoned by Mgr. Smeulders to Montreal to give evidence. Pagnuolo, it appears, feeling great uneasiness, being called by so high a commissioner, spread the news among his friends boasting, and by this means the plot came to the ears of Cure Gravel, of St. Hyacinthe, now in Rome. From the moment of Pagnuolo's visit Mgr. Smeulders seemed to change his opinion exactly in accordance with the plans laid. After this some even more important documents have come to light, which show that the plot was entirely aimed at getting rid of Archbishop Taschereau, of Quebec, when the Archbishop arrived in Rome a letter had been received there from the Apostolic Delegate, stating that Canada was a little Belgium, entirely in the hands of the Freemasons; also stating that the Archbishop, he believed, was a very honest man, but completely in the hands of the Masons. In this letter he had arranged that Archbishop Taschereau was to be appointed a Cardinal and remain in Rome, and that Bishop Lafite was to be made Archbishop of Quebec. In proof of the above, it is stated that Archbishop Taschereau was really offered a cardinalate but refused, and after giving his explanation, and corroborating by Grand Vicar Gravel, it was decided to recall the Apostolic Delegate who was here completely in the hands of the Jesuits and Ultramontanes.

The explanation offered has a history. A few years ago a priest named L'Abbe Villeneuve, author of the "Comedie Infernale," was in the habit of writing letters to Cure Gravel, which came into the hands of the Grand Vicar, who gave them to Bishop Fabre of Montreal, and the latter sent them to Bishop Taschereau while in Rome. In these letters Villeneuve used very strong and inexplicable language against the Roman Congregations and Cardinals, to Rev. Gravel, cure of Laprairie, brother to Grand Vicar Gravel. The next day he showed the death of Cure Gravel, only last year, at which time he appointed his brother, the Grand Vicar, executor of his will. Then all these letters that L'Abbe Villeneuve [There is here an omission of some words or lines in the telegram, which immediately follows being apparently quotations from the objectional letters of L'Abbe Villeneuve.—ED. HERALD] "whom I said could be bought, and have been bought by Laval University," and also that "they were very cowardly," and that "Cure Gravel not to submit to the decree from Rome, and to keep up a hot agitation and they dare not come to any conclusion. In this he applied language not necessary to be repeated. In each of his letters he had a prescription in which he stated, "(Apotept)" "That is my Delenda est Carthago."

After such proof it is said the Pope dismissed any thoughts he may have entertained about removing Archbishop Taschereau, as it was clearly proven that enemies were at work trying to undermine the Archbishop, and that the accusations received by Mgr. Smeulders had originated from the same source, as was explained by both the Archbishop and Grand Vicar Gravel. It is said that Mgr. Smeulders is so compromised that he cannot remain in Rome, but will have to join some foreign mission of the order to which he belongs.

When the Archbishop arrived here he knew very well that Mgr. Smeulders had been re-called, but that he had not received his letters; and this is stated as the reason why the Archbishop spoke to the Delegate with so little diplomacy. When the latter paid his official visit on the Archbishop's return, he even going so far as to ask him when "he left here to return to Rome?" When the Archbishop left Rome he was on terms of great intimacy with Cardinal Czakvi, who is said to be the right hand Cardinal with the Pope. Cardinal Czakvi was Nuncio Apostolic in Paris at the time of the Gambetta Ministry.

It is generally claimed that Archbishop Taschereau has won his point and conquered his enemies.

THE LARGEST DRY DOCK IN THE WORLD.—Mr. James E. Simpson, of the firm of Simpson & Sons, contractors of the dry dock at St. John's, registered at the Royal Hotel on Friday, and took the Western train in the morning en route for Brooklyn, N.Y. Mr. Simpson says that St. John's has the largest dry dock in the world; in all England and Scotland there is not one to equal it in size. The dock is 600 feet on top, and 558 feet on line of keel blocking. Its breadth is 132 feet at widest part, and 85 feet at the abutment or entrance. It is built of wood, and the cost has been \$550,000. The Messrs. Simpson have rented it from the Government for ten years at \$5,000 per annum. The work commenced in June, 1883, and was, according to terms of contract, to have been finished on 1st June, 1885, but instead was completed on December 10th—about six months within the specified time.—St. John, N.B., Globe.

WOLSELEY AND THE MUDIR OF DONGOLA. An Interesting Interview Described.

DONGOLA, Dec. 14 (5.55 p.m.).

The Mudir's troops and a guard of honor of the Royal Sussex paraded in front of the Mudir on Saturday morning upon the occasion of Lord Wolseley's and his staff's departure for Korti. All the officers' heavy baggage was stored here for shipment to Cairo. Everybody went forward in the lightest marching order. Mustapha Pasha, wearing neither sword nor decorations, and dressed in a civilian loose overcoat and trousers, a fez and a kaftan, received the general with his Excellency exchanging salutations with his Excellency, Lord Wolseley and his staff, all wearing scarlet tunics, led by the Mudir, entered the official residence, where shepherds were served. The following conversation ensued:—

Zorah Bey, interpreting for Lord Wolseley, after saying that he had come to the Mudir, added that he had hoped the Mudir would soon be able to follow when things should quiet down. If he should need him he would send for him. The Mudir said: "You will find people glad to see you. The rebels are now scattering, and the Berberes are returning home and won't fight. This is because Sheikh Suleiman of Mohamed has been made Governor of Berber by Mohamed Ahmed—the same Suleiman who killed Stewart. Mohamed El Kheir, the former governor, was deposed because he did not stop Stewart's general at Berber, and prevent its going north. The people are attached to El Kheir. Whether he be governor or not, they will obey him."

Lord Wolseley: Where do you think the rebels will fight?

The Mudir, smiling: They know the English are coming, and from here to Khartoum you will find nothing, and have no fighting. They are all gone.

Lord Wolseley: Why don't we get messengers backwards and forwards, then?

The Mudir: Because of the country people. But it will be different when the soldiers shall be there.

Mustapha Pasha further observed that some of his troops were at Ambukol and Merawi, and that he would issue orders at once that messengers from Khartoum or elsewhere with news who came in should be sent to Lord Wolseley; to which the Archbishop replied that he would telegraph to Excellency all news of importance, wherever I may be.

The Mudir: Can I do anything to help you?

Lord Wolseley: What I want most is to get supplies all the way.

The Mudir: You will find plenty. Orders have been sent to collect grain at Debbeh and other places, and you have only to ask for what you require. There are also lots of supplies at Merawi. If you want them I can send them.

Lord Wolseley: No; do not trouble. I am going to collect the country at Abdon, near Merawi. Supplies are the chief thing.

The Mudir: I have told them so, and my people are now sowing wheat, barley, and other grain, which will be ready in three months. They are cutting durra now.

Lord Wolseley: How about meat—cattle, sheep, and goats?

The Mudir: There is any amount.

Lord Wolseley: I am most grateful.

Thereafter the party walked to the Dahabieh, the Mudir escorting them. The steamer, with the Dahabieh, started precisely at nine. The troops saluted the Governor's cannon boomed. Lord Wolseley and his staff were in excellent health and spirits. The Mudir's people manned both boats. The Dahabieh had been renovated, and oranges and baskets stood in the saloon with grapes, oranges, and other fruit rarely seen south of Assuan.

Gossip from London "World."

Lady Millyar, herself the widow of an Admiral, and the mother of two full Admirals of Her Majesty's Navy, died last week at Tor Point, near Plymouth, at the advanced age of nearly sixty. The deceased lady was widely known, and the Prince of Wales and the Duke of Edinburgh had promised to dine with her on her hundredth birthday.

Typical fever is scourging Dublin and its environs just now. Among its earliest victims was Mr. J. J. O'Connell, of such promise in his profession and so dear to many members of the Meath and Ward Union Hunts. The meet of the Meath Hounds at Dunshaughlin on the 25th ult., was smaller than usual, from the numbers of "pursuers" who went to his funeral, which took place the same day.

Mrs. Langtry has been in Paris, staying at the Hotel d'Albe, in the Champs Elysees, busy buying costumes for her coming campaign. Worth and Felix have been vying with each other, and we shall be able to sit in judgment on the result in about a month's time. Mrs. Langtry returns to London this week, and will commence her dramatic season at the Prince's Theatre early in January. The opening piece will be the Princess Georges.

Mrs. Bolton, Lady Colin Campbell's sister, has been "pursuing" for some weeks with the Meat and Ward Union Stag-hounds, and as the sailors say, has made a very good track, considering that the country was quite new to her, and that her mounts were not always pieces of prize. Mrs. Bolton has been staying with her cousins, Sir Thomas and Lady Hesketh, at Somerville Park.

The question now is, will the Duke of Edinburgh obtain the Mediterranean command next year? Besides the most coveted command in the British Naval Service, and, as such, hoped for by many flag-officers of high standing, there are several political considerations to be carefully weighed before placing a Royal Prince in this position. On the other hand, the presence of the Duke of Edinburgh at the head of the Mediterranean Squadron would enhance enormously the *ceat* which would attend the squadron wherever they went, for pluck and for tact the traditions of the Royal Family are sufficient guarantee, and as a practical seaman and commanding officer his Royal Highness is second to none.

The Crocodile arrived in Portsmouth Harbor on Friday last, having on board the 1st battalion of the Essex Regiment, whose commanding officer so recently received the Victoria Cross for gallantry at the hands of a junior subaltern. No reports of the court-martial have been made public; but they are eagerly looked forward to, as it is impossible to imagine that fault could lie on the side of the subaltern only. The offending officer has been left behind at Aden, as it was not thought probable that he should travel home in the same ship with the Colonel; and he awaits the promulgation of the sentence passed upon him.

A week of gaieties had been mapped out for the second stay of the Channel Squadron at Gibraltar, but the incessant rain greatly spoiled it. The second day of the autumn race meeting had to be postponed, and with it the running for the Naval Cup, and also the performance of the H.M.S. Pinafore, which was to take place alongside the Mole. A trip to Tangiers, which the Duke of Edinburgh and a number of officers had planned in the Seahorse, was also interfered with. There was a large attendance of officers present on the ball given by the Duke and Governor Lady Alice to the Duke at the Convent. On the Saturday night

before starting everybody who could possibly do so was on board the Minotaur, on the invitation of H.R.H. the Vice-Admiral, to a farewell social concert. The string band, formed largely of officers of the squadron, performed, the Duke of Edinburgh playing first violin. In Romberg's Toy Symphony his Royal Highness conducted. At the close a special arrangement of the National Anthem by the Duke was played.

ANOTHER "CLAIMANT." An Alleged Elderly Daughter of the Queen of England.

In these days claimants of some kind or another seem to be very plentiful, but we have at present the case of a lady who appears to have taken quite a new departure in this—often very profitable—line of business.
