

## GERMAN INFANTRY AGAIN HURLED BACK AFTER FUTILE ATTACK ON FRENCH POSITIONS

### Powerful Infantry Assault On French Line Between River Meuse And Douaumont Meets Stern Resis- tance — German Losses Heavy — British And German Artillery Activity Is Marked — Russians Capture Surmeneh — Trezibond Is Their Objective

Again the Germans have launched a powerful infantry attack against the French positions extending from the river Meuse to Douaumont and again they have been swept back, except where they obtained a footing in a small portion of the Chaufour wood, by the guns of the French. Heavy casualties were inflicted on the attacking forces along the two and a half mile battle front.

The Germans have kept up their heavy shelling of Hill 304, north-west of Verdun, and the second lines of the French in this region, probably with the intention of again throwing their infantry forward in an endeavor to capture these important points—keys to the Verdun position on the west.

Elsewhere along the lines held by the French there have been only bombardments and mining operations. Numerous German positions have been bombed by French aircraft.

On the British front in Belgium and France the heavy bombardments by the British and Germans continue unabated. The artillery activity in the sector between St. Eloi and the Ypres-Comines canal has been especially marked.

The Germans have poured shells on the Russian positions along the Dvina river at the Ikskull bridgehead and about Dvinsk, and vigorous artillery duels have been in progress in the lake region south of Dvinsk.

In Galicia, along the Stripa river, the Teutons have made several attempts against Russian trenches, but all of them were repulsed, according to Petrograd.

The big guns on both sides are in action along most of the Austro-Italian front. In the Sugana valley the Austrians delivered attacks against the Italians from the Larganza torrent to Mont Collo, but they were everywhere repulsed.

In Asiatic Turkey the Russians on the Black Sea coast have captured the town of Surmeneh and pushed farther westward against the retreating Turks to Arsene Kelessi, less than twelve miles from the important fortified town of Trezibond.

The Russians are anticipating no easy conquest of Trezibond, according to unofficial advice from Petrograd, the town having been heavily fortified and reinforced with three complete divisions of troops. The Turks are declared to be resisting furiously the onward press of the Russians against Baiburt, north-west of Erzerum, in the attainment of which the Russians hope to join hands with their men fighting in the Black Sea littoral.

The British government hereafter will regulate the shipments of American packing houses to all neutral European countries for the period of the war, according to an agreement reached between the government and the packers in the settlement of the cases arising from the seizure by Great Britain of cargoes of packers products.

#### INQUIRY AGAINST GERMAN CONSUL.

Amsterdam, via London, April 17.—The public prosecutor has opened an inquiry against German Consul Von Humboldt, who is alleged to have spread the recent report that Great Britain had issued an ultimatum to Holland, says the Telegraaf.

#### UN-AMERICAN TO FIGHT.

Washington, April 17.—America will have forgotten her traditions, said the President today, if she fights merely for herself, and added that the United States must not fight under such conditions as would show it had forgotten traditions. "When America ceases to be unselfish, he said, it will cease to be America.

The President declared the nation was formed for the purpose of serving the rest of mankind as much as itself and to afford asylum to all men. Those traditions, he added, must be continued.

#### CONSTANTINOPLE RAID RESULTS.

London, April 18, 12:04 a.m.—In the British air attack on Constantinople Friday evening two bombs dropped by the raiders burst in the War Ministry, according to a report from Saloniki forwarded by the Athens correspondent of the Exchange Telegraph Company.

The despatch adds that another bomb burst in the powder factory of Makreki, which blew up. There were numerous casualties.

## VON PAPEN IS INDICTED BY U.S. GRAND JURY

### ORGANIZED AND FINANCED CONSPIRACY TO BLOW UP WELLAND CANAL.

New York, April 17.—Captain Franz Von Papen, recalled military attache to the German Embassy at Washington, was indicted by the Federal grand jury here today as the organizer and financier of the alleged conspiracy to blow up the Welland canal in Canada. With him also were indicted Captain Hans Tauscher, alleged agent of the Krupp in the United States and husband of Mme. Johanna Galski, the prima donna; Constantine Govani, Alfred J. Fritzen, and another whose name has not been revealed. It was learned from a reliable source that the latter is a prominent German whose name has been mentioned fre-

quently in connection with German propaganda. His arrest is expected tomorrow.

The indictment, it is understood, was returned with the sanction of the Department of Justice, and is believed to establish a precedent. No effort will be made to have Von Papen brought here, but the indictment will be held in abeyance in case he should return to the United States.

The indictment charges, in addition to the Welland canal plot, that it was "the purpose and intent of the defendant to blow up and destroy other property in Canada."

Von Papen was designated by Federal officials as the "brains" of the alleged conspiracy. It is alleged in the indictment that he, with the others "began, set on foot, provided and prepared the means for a certain military enterprise to be carried on from within the territory and jurisdiction of the United States against the territory and Dominions of the King of Great Britain, with whom the United States at all times mentioned was and is at peace."

The other three men whose names were made public were, according to the indictment, merely agents and employees of Von Papen, who planned the conspiracy and furnished the money and high explosives. The five men alleged to have carried dynamite and other explosives is

suitcases to Niagara Falls, where the plot was abandoned, were Host Von Der Goltz, alias Franz Hobart Wachendorf, alias Bridgman Taylor; Fritzen, Govani, Carl Tushendler and Joachim Busse. Von Der Goltz, who was later arrested in England, returned to the United States, accompanied by a detective from Scotland Yard, and gave important testimony to the government here.

John T. Ryan, an attorney and prominent in politics in Buffalo, N.Y., was named in the indictment as the man who acted as intermediary in the payment of money by Von Papen to Von Der Goltz. On two occasions in September, 1914, it is alleged, Von Papen paid \$200 to Von Der Goltz through a Buffalo bank and Ryan. A previous payment of \$200 also is said to have been made to Von Der Goltz. Checks and check book stubs of these transactions are in the possession of the United States District-Attorney.

Captain Tauscher, head of the Tauscher Arms Company here, supplied the explosives to Von Der Goltz, the indictment charges, while Von Papen furnished "electric generators, fuses and wires."

In August, 1914, according to the indictment, five sailors from the interned German liner Bavaria, at Baltimore, were brought to New York by the alleged conspirators to aid in the plot, but they were subsequently returned to their ship. Arrangements then were made, it is charged, for the five men named in the indictment to undertake the expedition.

## THIRTY LIVES ARE LOST IN COLLISION OF TRAINS

ACCIDENT TOOK PLACE AT BRADFORD, R.I., AND  
VICTIMS WERE EITHER CRUSHED IN CAR OR  
BURNED TO DEATH.

Bradford, R.I., Apl. 17.—Thirty or more persons were reported to have been crushed or burned to death in a collision of trains on the New York, New Haven and Hartford Railroad here tonight. The accident occurred at 7:30 o'clock, and four hours later wrecking and hospital crews were said to have recovered thirty bodies.

The dead were in the rear car of a four coach local train, bound from Boston to New London and which had stopped at the local station when it was run down by the Gilt Edge Express, bound from Boston for New York.

This coach was telescoped, set afire and burned. The car ahead also took fire and the flames communicating to the passenger station and freight house destroyed both buildings. A hospital train came here from New London and medical examiner M. H. Scanlon, of Westerly, took charge of the search for the dead and care for the injured.

It was stated that there were known to have been 37 persons in the destroyed car and that only six of these had been accounted for several hours later.

Westerly, R.I., Apl. 17.—Great confusion followed the collision and it was long before a definite idea of the extent of the disaster could be had. As the flames of the burning cars and buildings died out the train yard was left in darkness and those who went to the aid of the injured worked under great difficulties.

The only telegraph lines in the town went out of commission with the burning of the station and the only communication with the outside was by a single telephone wire. Over this wire help was summoned from Providence and New London, the former sending a wrecking train and physicians and the latter city despatching a hospital train.

Estimates of the dead varied widely and in the absence of a positive official statement the number could not be determined at midnight.

At that hour the ruins of the burned cars were still so hot that they could not be thoroughly searched. Four bodies were early removed and a count of those who received emergency medical treatment showed that 35 who escaped death were injured. Several of these would die, it was thought.

A brakeman of the local train said that there were 37 passengers in the rear car and that he had been able to locate only seven of these. This gave rise to the report that thirty persons had been killed, but later investigation threw doubt on this estimate. A report that thirty bodies had been recovered was later disproved.

The belief that thirty persons had been burned or crushed to death, was expressed by a member of the wrecking crew, but his opinion was not generally shared by others on the scene. It was agreed that the list of dead probably would not be completed before daylight.

## GENERAL HUGHES WILL SPEAK IN THE HOUSE TODAY

ANNOUNCEMENT TO THIS EFFECT IS MADE BY SIR ROBERT BORDEN.

(Special to The Chronicle)

Ottawa, April 17.—That Sir Sam Hughes would make a statement in the House Tomorrow was announced by Sir Robert early in the day sitting. The Premier also said upon the table an order-in-council approved by the Governor General on April 15 and arising out of a promise made by the Prime Minister during the debate upon Sir Wilfrid Laurier's motion calling for the appointment of a parliamentary committee to investigate the operations of the Shell Committee. In his speech in that debate Sir Robert said that the government would be prepared to direct the attention of the British government to allegations made by members of the opposition in regard to the Shell Committee and would inform the British authorities of its readiness to co-operate in any investigation which might be thought desirable. The order in council provides for the transmission to the Secretary of State for the Colonies of the Hansard report of the debate on the Laurier resolution and of a copy of the order-in-council authorizing the issue of a Royal Commission to Sir William Meredith, Chief Justice of Ontario and Mr. Justice L. P. Duff of the Supreme Court.

The order approved on Saturday last also conveys to the Secretary of State for the Colonies that the government of Canada is prepared to assist in any enquiry into the transactions to which reference was made in Sir Wilfrid Laurier's motion and that "so far as the government of Canada is concerned there is no obligation whatever to the fullest investigation that may be thought desirable at any time."

#### A CURIOUS DEATH.

Wingham, Ont., April 17.—Death by suffocation with no one to blame, was the verdict returned today by Coroner Kennedy's jury which inquired into the death of Dr. R. H. Waikley of Mount Forest, who died here recently at the office of his brother-in-law, Dr. J. A. Fox, a chiropractor.

It was shown in the evidence that death was due to an abscess which had lodged in the throat and caused suffocation.

SENATOR CHOQUETTE

REPLIES TO CRITICS

Quebec, April 17, 1916.

To the Editor, "Morning Chronicle," Quebec.

Dear Sir.—Many thanks for announcing the publication of my speech which, being so awfully misreported, caused somewhat of a sensation among the soldiers, and with reason too, if I had said what I am wrongly accused of. I regret that some correspondents do not even read what is said in both Houses of Parliament before sending reports to their papers. It is most unfortunate, because, as in my case, these reports are absolutely unfair, unjust, and the cause of abuse being thrown to the heads of public men. So I am glad of your publishing my speech, though it is from the unrevised edition of the Hansard, without even correcting the few errors which are in it. I am ready and willing to abide by the judgment of all fair and honest men of Toronto and elsewhere, and of our soldiers, to say if I uttered a single word offensive to them. Moreover, I am sure that Hon. Mr. Kemp, Acting Minister of Militia, speaking in the House of Commons on Friday last, when I was away from Ottawa, took as granted what the papers have said, in also accusing me, instead of reading my speech, and this morning I sent the following telegram:

Quebec, 17th April, 1916.

Hon. A. Sevigny, Speaker, House of Commons, Ottawa:

Dear Sir.—Senate being adjourned, I will ask you to please read to your Honorable House my answer to the Honorable Mr. Kemp.

I most strongly deny having directly or indirectly, said anything offensive of our soldiers here or abroad. On the contrary, I praised and congratulated them; as it is easy to verify by reading my speech.

As for the recruits rejected in so great a number in forming two battalions in Toronto, I just cited a report from the Mail and Empire of Toronto and read a letter from one Mr. Hazelton who also wrote me that he is a good English Tory and a lieutenant in the army, as Hon. Senator Mason told me.

On these matters of recruits rejected and Rev. Mr. Hinks, the Hon. Acting Minister might have an argument with the Mail and Hazelton; but I hope he will apologize to me. The more so because Hon. Senator Mason's resolution of Friday last, practically confirms what I said. With thanks.

May I also ask why you put in big headlines that Mr. Hazelton is my friend? I ask you if this is fair! I never saw that gentleman; he wrote to me without being asked for. I found his letter so strong that I wrote him back asking if it was intended for publication, and if so to give me references on his standing. He answered that I could publish his letter and referred me to Mr. McLean, M.P. for York, to Col. Currie, and to General Hon. Senator Mason, as being a good Englishman, a good Tory, etc. I inquired from Messrs. McLean and Mason, and they told me he was a first class man. As you will see in my speech, when speaking, not about the soldiers, but about the recruits who have been rejected in so great a number in Toronto, I cited from the Mail and Empire of the 18th of March, the organ of the Borden Government, a report giving out this great number of men refused, and then, I read, on this point alone, the letter from Mr. Hazelton. Well, how can the soldiers, whom I praised and congratulated, take objection to that? They have not been rejected, and this does not apply to them, and why do the English papers abuse me? The whole trouble lies in distorted reports of what I said, and it must have been done maliciously. I had the pleasure of speaking to Messrs. Dobell, Pentland, Major Gibsone, & al., about that speech, which they read, and I am willing to abide by their decision if there is anything offensive to any of our soldiers. The insinuation in your

paper that Hazelton is my friend, is in the same line, and may cause trouble. Now, I ask if this is the way to help recruiting in this country and especially in this province? Do you think that it is by bullying men who have a right to express their views in a fair and honest way that recruiting will be helped? The English press are publishing every day that the Allies are fighting for fair play, rights, liberty, and for the respect of treaties which the Germans call scraps of paper. These are all good reasons to fight for; but why not in this country respect fair play, right, liberties, treaties, and Pact of Confederation? Why not respect the rights of the French minority in Ontario and Manitoba? Why trample upon the rights of the French-Canadians to speak and teach their language in these two provinces? Do you not give them the right to say that the majority in those provinces are considering the Pact of Confederation as a scrap of paper? and that they are acting like Germans???

It is not by accusing right and left of disloyalty, without reason, and against the truth, this man, that man, or a great portion of the best citizens of this country, that you will help the Allies in this great war. The very contrary will happen.

Let the press, and especially the English press of Ontario, be fair to public men, be fair to Sir Wilfrid Laurier, be fair to the minority, and everything will, in this country, go better than they are going now.

## LEGAL INTELLIGENCE.

Judgments Rendered and Writs Issued.

Judgments by the Hon. Chief Justice Lemieux:

Metropolitan Insurance Co. vs. The Quebec Bank. Considering that the checks mentioned in this cause have been paid in good faith by the defendant; considering that the bank honestly thought that Dube, assistant superintendent of the plaintiff, had the power and authorization to endorse such checks considering that plaintiff had expressly authorized said Dube to endorse said checks and had ratified such endorsements; considering that plaintiff had no right to claim the amount of the checks paid by the said bank; the Court dismissed the plaintiff's action with costs.

Merchants' Bank vs. Lesage. Considering that plaintiff is the bearer of the note, forming the basis of the action, which said note had been transferred to plaintiff by Vezina, as an additional guarantee of a loan made to him by said bank; the Court condemned defendant to pay plaintiff \$135, with interest, but without costs.

Drolet vs. National Ry. Association Co. Plaintiff has proven that by a lease dated the 28th of April, 1914, he had leased to the company defendant the premises described in his declaration, defendant being bound to heat those premises during the winter season; plaintiff has also proven that the company defendant had not fulfilled this last obligation, since the 1st of January up to the 2nd of April, 1915, and that plaintiff, during this space of time, had suffered damages to the amount of \$136 by loss in profits on account of the cold which rendered the premises uninhabitable; judgment against defendant for \$136, with interest and costs.

Judgment by Hon. Justice Beliveau:

Carignan vs. Turcotte. # ATTACKS UPON THE BRITISH GOVERNMENT REACH CLIMAX

TODAY IS THE DATE FIXED FOR CABINET COUNCIL TO MAKE A FINAL DECISION ON CONSCRIPTION OF MARRIED MEN.

London, April 17.—Today, the date fixed for the cabinet council to make a final decision as to whether married men should be conscripted, the attack on the government by newspapers devoted to the cause of conscription reached the climax of vehemence.

All the government's alleged blunders—at Antwerp and in the Dardanelles and Mesopotamia—its alleged mistakes and delays in connection with munitions and the air service were reviewed and contrasted with the perfect organization reigning in enemy countries. The Times' military correspondent printed an article with an elaborate map, purporting to show the exact dispositions of enormous forces of German troops massed along the British front in Flanders and France, and drawing the conclusion that Great Britain is still lacking the necessary reserves to meet a big attack.

These newspapers are openly advocating the overthrow of the "inefficient" ministry and exhort the members of parliament not to lose the opportunity in the approaching debates to compel the government either to conscript married men or resign.

Throughout the afternoon in the lobbies of parliament there were rumors of grave cabinet dissensions and of possible resignation of minority ministers who favor universal service.

The council of ministers met late this afternoon and sat for little over half an hour. Immediately afterward the leading ministers attended the war council, which it is understood was held as the result of the decisions arrived at by the cabinet council. What these decisions were has not yet transpired. They will be given to parliament by Premier Asquith tomorrow.

According to the best information, however, there will be no resort to compulsion for married men and the measures adopted will be along the lines already indicated in the despatches of The Associated Press—that there will be no general conscription on the lines of "equal sacrifice for all."

The Press Association says it understands that while difference of opinion have manifested themselves among the ministers, a serious crisis in the ministry has thus far been avoided. Up to the present there is no news of any resignations from the cabinet.

## STEAMER MONGOLIA SAILS FOR LONDON.

New York, April 17.—The American steamship Mongolia, which had been delayed in this port since Saturday on account of a strike of her crew for higher wages, sailed for London today, the strike having been settled. The demands of the seamen were granted by the Atlantic Transport Line, owners of the vessel.

# BELIEF IS THAT PABLO LOPEZ, NOT VILLA, IS DEAD

BUT MEXICAN OFFICIALS AT EL PASO AND JUAREZ SAY OTHERWISE.

El Paso, Tex., April 17.—General Gabriel Gavira, Carranza commander at Juarez, announced tonight that the Mexican telegraph wires between Juarez and Chihuahua had been blown down near Pearson about noon and that for that reason he was unable to learn and further details of the reported discovery of the body of Francisco Villa. At the same time a telegram filed at Chihuahua City presumably before the interruption of the wire service, was received by The Associated Press from Consul Letcher saying that nothing was known in the state capital regarding the finding of the bandits remains.

The two circumstances combined to reinforce the growing scepticism here as to the truth of the story that death has ended the career of the fugitive brigand. The story that the man who is really dead in Pablo Lopez, the notorious butcher of Santa Isabel, and that Villa has used his death as the basis of a false report of his own decease, was revived. This story was re-told today by an American owner of a large ranch in the Guereiro district, who said he had received it from his ranch foreman and believed it to be true.

The confidence of Mexican officials here and in Juarez that Villa is dead has not diminished however, outwardly at least. It was pointed out today that if the body had been brought to Cusihuiriachic it might take the better part of a day to transport it from there to Chihuahua City.

## AMERICAN LEGION TO RECRUIT IN THE EAST.

The American Legion, which has met with such spontaneous success in the West, will very shortly start recruiting in Quebec and the Maritime Provinces.

The idea of the American Legion Brigade was conceived by Major C. Seymour Bullock. Authority was secured by him to recruit the 97th Battalion, calling it "The American Legion," and this battalion was recruited in record time. It is now at more than full strength, with headquarters in Toronto. The surplus being carried for the benefit of another battalion now forming.

Major General Sir Sam Hughes has since authorized the organization of three additional American battalions—the 211th, 212th and 213th, which with the 97th, are to be formed into The American Legion Brigade.

The 211th Battalion has headquarters in Vancouver, with Lieut.-Col. Wm. Sgan, commanding. The 212th, with headquarters in Winnipeg, is recruited by Major B. C. Pittman. The 213th will be raised in Ontario, Quebec and the Maritime Provinces, with headquarters in Toronto. Americans who realize that there is an opportunity for every real man to fight under Canada's flag for the high principles of humanity and civilization which Great Britain represents, make up this unique brigade.

We heard our Mother calling from afar:  
"Come over, O my Children, to the war!"  
Now, home again, wear proudly every scar.  
For we were there!  
Yes, we were there!  
Battling the Huns by land and sea and air.

It was a fight of fury, West and East.  
The Kaiser clawed brave Belgium like a beast.  
We choked him off. We tore him from his feast.  
For we were there!  
Yes, we were there!  
Did you not help us drive him to his lair?

Sea-dragons, too, we hunted, night and day.  
We kept the murderers of babes at bay.  
All Hell we fought in that long, madd'ning fray.  
Were you not there?  
Were you not there?  
In that great struggle—speak!—had you no share?

Don't you remember those who fought and fell

The War is over. Battle-flags are furled.  
The Great Betrayer from his throne is hurled.

"The man who would not fight for Canada as she is today would not defend a Garden of Eden," declared Rev. Father John J. O'Gorman, pastor of the Blessed Sacrament Church, in the course of a powerful recruiting sermon, preached in Ottawa.

"It is not patriotism our 'slackers' lack, it is imagination," he said. "If Canada's first line of defence in Flanders were definitely broken, her second defence on the shores of the St. Lawrence would be very insecure. I am not a pessimist, but I do not want to salute the spiked helmet in my own country."

"No apology is required for one more sermon on the duty of enlisting in the Canadian Overseas Force. Canada's relation to the great war is so fundamental, so many-sided, so far-reaching, that there is no one man who has an adequate comprehension of everything it means."

Continuing, Father O'Gorman said:—

"The question as to along what lines the relations of Canada and Britain should develop is indeed one which is not for the pulpit. On the other hand, however, as Canada is officially and effectively participating in this war, it is within the province of a bishop or priest to urge the members of his flock to fulfil their war-duties. For one cannot be a good Christian if one is a bad citizen. HE WHO IS DISLOYAL TO HIS COUNTRY IS DISLOYAL TO THE CHURCH. He who is only partially patriotic is only partially religious; for patriotism is a virtue.

"At all times and in all places the Catholic Church has loyally and enthusiastically supported the legitimate authority of the state, and neither sneers nor slanders will cause her to change her conduct. She practices herself what she teaches to her children.

"That is Canada's duty in the present crisis to fight with the Empire in defence of her national rights and liberties as a British self-governing Dominion is the teaching of every Catholic Canadian Bishop. Thus, for example, the Archbishop of Montreal, in his Laval University address, defended and defined Canada's relation to the war as follows (I summarize somewhat his remarks):

"England did not wish for war. Her reason for entering it was to avenge Belgium and to safeguard justice, liberty, right and honor. Canada is not an independent state, nor is she neutral. She is an autonomous Dominion in the British Empire, and since Britain is at war, there result for us sacred obligations. While Canada is not attacked directly, she is attacked indirectly. She is menaced, and therefore must be defended. WERE ENGLAND DEFEATED, GERMANY'S FIRST PREY WOULD BE CANADA. Hence we must do our utmost, for the fate of Canada is dependent upon the success of the British arms. The Bishop of Quebec, at the very beginning of the war in a joint pastoral letter, taught that it was the duty of Canada to aid England."

"In this Laval recruiting speech of Mgr. Bruchesi," said Father O'Gorman, "there is no politics, but there is patriotism. Canada's duty to participate in this war is no longer debatable. It was decided a year and a half ago by the Canadian merchant.

"I have maintained and do maintain, not as a defined article of faith, but as a reasoned and reasonable moral opinion, that by virtue of the natural law which imposes upon citizens, who are in a position to do so, the obligation of defending their country when the latter is fighting for her liberty and existence, and by virtue of the just action of our government in calling for half a million men, which is practically the whole available manhood that our country can spare, THE ABLE-BODIED CANADIAN CITIZEN WHO IS NOT DETAINED BY A MORE URGENT DUTY IS IN CONSCIENCE BOUND TO ENLIST."

# MEAT PACKERS' CASE SETTLED

SETTLEMENT DISPOSES OF COMPANIES' CLAIMS REGARDING GOODS SEIZED.

London, Apr. 17.—The Foreign Office tonight issued a statement for publication in the British press announcing a settlement of the cases of the Chicago meat packers arising from the seizure of a number of their cargoes. In addition to the Armour, Swift, Hammond, Morris and Schwarzschild and Sulzburger companies, the case of the Cudahy Company, which was represented by British solicitors, is included in the settlement. The Foreign Office statement says:—

"The settlement finally disposes of the claims of the companies in respect of all goods seized and detained as prizes. The settlement, however, does not in any way prejudice the decision of Sir Samuel Evans (president of the prize court) given in September, by which the bulk of the cargoes of the steamships Kim, Fridland, Alfred Nobel and Bjornstjerne-Bjornson were condemned as prizes, and the appeals of the packers to the Privy Council in these cases against the above decision are now withdrawn.

"The whole proceeds from these goods will therefore remain to the credit of the prize fund, which is further augmented by a substantial part of the proceeds of other packers' goods which were the subject of proceedings pending in the prize court. The settlement further provides that His Majesty's government, in consideration of a sum of money paid to the packers, shall regulate the entire shipment by the packers of all packing houses products to neutral European countries.

# LAST FIGHT FOR POSSESSION OF TREBIZOND IS BEGINNING

RUSSIAN FORCES HAVE PASSED LAST OF SERIES OF NATURAL OBSTACLES ALONG THE COAST OF THE BLACK SEA.

Petrograd, April 17, via London.—Having occupied the strongly fortified Turkish position on the left bank of the Karadere on the Turkish Black Sea coast, the Russian forces have passed the last of a series of natural obstacles along the coast, the defensive advantage of which had been made the most of by the Turks. Thus they have entered the immediate area of the Trebizond fortifications.

The Russians are now separated from the city of Trebizond by only sixteen miles of roadway, no part of which is considered capable of sustained defense, although since the fall of Erzerum, the Turks have undertaken everything possible to perfect the defensive power of the Trebizond fortifications and greatly increase the garrison, which is now said to be contain three complete divisions.

Therefore, the word "imminent" no longer is used here in predicting the occupation of Trebizond, and it is realized that the city will be taken only after the hardest kind of struggle, which is likely to outlast in stubbornness and duration the one which resulted in the fall of Erzerum.

The capture of the Kardere position, which necessitated the crossing of the swift stream, which is particularly swollen and turbulent at this time of the year, was made possible by fine assistance rendered by the Russian fleet. The Turks, apparently believing the recent appearance in the Black Sea of their cruiser Breslau had caused the Russian fleet to abandon the operation which it so successfully executed in connection with the bombardment from the sea, set up no shore batteries and limited their construction of defenses to an elaborate system of wire entanglements. A vigorous bombardment from the sea, which demolished a great part of the Turkish fortifications, was followed by an infantry attack which met with little resistance.

The Turks are still fiercely opposing the Russian forces operating against Bahari, sixty miles northwest of Erzerum—fighting in which the Russians if successful, are expected to unite their two groups of forces operating along the coast and to the west of Erzerum in such a way that further Turkish efforts to prevent a solid advance of the Russian armies over the whole of the front would be useless.

## QUEENSLAND PREMIER LANDS IN CALIFORNIA.

San Francisco, Cal., April 17.—Premier T. J. Ryan, of Queensland, Australia, arrived here today on his way to London on a mission "arising indirectly out of the war." He would not explain further. He left here tonight for New York.

## GENERAL SIR SAM HUGHES

The prompt return to Ottawa of General Sir Sam Hughes, to face the charges made against him by his political opponents just as soon as he had arrived on the other side of the ocean, is only just what was to have been expected from a man of his pluck, reputation and standing in the public estimation. except, perhaps, from some of those who waited until he was well out of the way before arranging for the launching of the accusations in question. His political foes, jealous of the splendid work he has done and was still doing when he was, so to say, stabbed in the back, as far as it was possible to do so, and green with envy because of the magnificent reputation which his grand work for Canada and for the Empire has gained him, knew thoroughly well that by timing the levelling of the charges against him as they did, it would be impossible for the accused to give the lie to the charges as promptly from the other side of the Atlantic as he would have from his seat in the House of Commons, and that therefore his denial of them and his protestations of innocence could not possibly go out to the public, as they otherwise would have done simultaneously with the accusations themselves. That no fair-minded man who knows anything of Sir Sam will believe for a single minute that there is a word of truth in any of the charges so far as the General himself is concerned, goes without saying. If irregularities of any kind are to be proved in connection with the awarding of any of the war contracts, it is safe to assume that there has never been the least reason for suspicion to be attached to the Minister in the connection. If the same regularity has not been able to be observed in the hurried handling of contracts involving hundreds of millions of dollars, as obtains in the ordinary everyday routine of government business, surely nobody will express any surprise.

The Germanic hordes that have been threatening the very existence of the Empire for the last year and a half were too near to Paris and to Calais, and the Allied troops at the front were too badly in need of the munitions of war that they were awaiting from Canada and the United States, to render it possible to hesitate about procuring the necessary goods wherever they could be had from apparently responsible parties. It is barely possible that some of these parties may turn out not to be everything that they appeared to be, but even if this should prove to be the case, surely nobody will be astonished. Some of the greatest praise which has been bestowed upon Sir Sam in connection with his magnificent work in raising, equipping and forwarding the Canadian army to the front has been based upon the promptness of his work and decisions. He will understand, as it was his duty to have understood, that there was no time to be lost. Promptitude of action was what Canada and the Empire demanded of him, and what was required of him that he gave. Hesitancy at such a time would have been fatal. Surely if ever a Minister of State was justified in believing that small errors of administration would be gladly pardoned if committed in good faith, and in the hurry of that precipitate action which the exigencies of the time demanded of him, it must decidedly have been the Honorable Sir Sam Hughes in the first months of the war. All who know Sir Sam and his prominent characteristics will give him credit for general sound judgment as well as for prompt and decisive action in cases of emergency, and it will indeed be matter for considerable surprise if any errors of judgment of considerable moment will be found traceable to him.

What mistakes, if any, may be found attributable to any of the many officials and others, by whom the Minister was surrounded, or with whom he was called upon to have relations of any kind, it is impossible as yet to say, but none of the Honorable gentleman's friends can be found to believe that under any circumstances whatever, any evidence of wilful wrong-doing will be able to be brought home to himself, after the most minute investigation possible, which it is gratifying to observe that Sir Sam himself demands and insists upon having.

The most melancholy feature of the whole affair is to be found in the time selected for this attack upon the Minister. Nothing could have been better devised than this by the bitterest enemy of Canada and the Empire to give encouragement to the enemy in the field, to discourage and dampen the ardor of the Canadian at the front, whose idol the accused is, or to injure the credit of the Dominion and interfere with the execution of contracts already made for the supply of munitions. If there is really anything wrong on the part of any of those concerned with Sir Sam in his work there could surely have been selected a more appropriate time for an investigation than the present, when nothing in the world should have been allowed to occur that could in any way appear like seeking to stay in the smallest degree the hand of anybody having serious and responsible work to do for maintaining the equipment and efficiency of the men at the front. Never, in any time of war, do we remember to have heard of a more ill-timed attack, from other than the enemy's side, upon one of those most responsible for such maintenance.

### A NEW WAR SONG.

With nothing like the same bluster and fireworks a newer war ballad has almost entirely superseded Tipperary in the affections of the people, not only at home but in the field, says the Calgary Herald. It isn't the same sort of music at all, but it seems to fit the mood of the public just as effectively as did the earlier melody when the war started. Which shows that the mood of the public has changed.

Tipperary was a composition of the catchy march sort, with a lilt to it that set the feet moving, willy-nilly. Its words were without meaning of any depth and at best it was merely an appeal to the physical rather than the mental; certainly it was a great aid to route marching. But times have changed since Tipperary came and the mood of soldiers and citizens has changed with them.

There has been much blood-letting since we first sang Tipperary and many thousands of our loved ones have passed into the unknown Beyond. Many more thousands of them are lying crippled in hospitals and many thousands more are standing in their places ready to offer themselves as the next sacrifices, if necessary, to the ruthless god of war. No wonder we seek something more religious in tone than Tipperary now for our battle hymn, and no wonder that "Keep the Home Fires Burning" is our choice, with its better musical setting and its more thoughtful verse.

Ivor Novello, the composer of "Keep the Home Fires Burning," is 22 years old and has been writing music since his 15th year. His mother suggested that he write a patriotic song and in ten minutes he wrote the

haunting melody of "Keep the Home Fires Burning." Lena Guilbert Ford wrote the words in another ten minutes and in less than half an hour the song was ready for the publisher. Today it is published in six languages and is sung in every camp of the war zone.

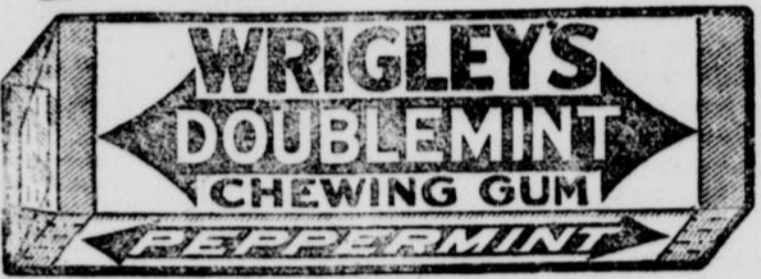
The Herald concludes:—"Some day before the war ends there will have to be another inspirational war song written. It will be a march, triumphant and with a religious stateliness befitting the solemnity of a victory so magnificent yet so dearly bought."

### PRESS COMMENT.

In The Sun of Monday morning there appeared two news items dealing with the treatment of prisoners. One of these was from London, describing the frightful conditions of the Wittemberg camp, where many British and Canadian prisoners are lodged. Statements by doctors who have visited the camp, prove that prisoners are treated in the most brutal and infamous manner, suffering unnecessary hardships through the cruelty of their jailers. Dogs are encouraged to bite and worry them, while the slightest attempt at self-defense is followed by chastisement at the hands of the Germans. The other report dealt with a Canadian government proposal to employ several thousand Germans in the harvest fields at the rate of \$2 per day. This was not very clearly explained in the press despatch, but one can only infer that the alien enemies will receive the

money they earned. If this is the case, and we hope that we are grievously mistaken, it should be opposed bitterly by every Canadian. If German prisoners are to receive two dollars a day for their work, unwillingly given, it is a national scandal. Allied prisoners in Germany receive some two and a half cents a day if employed by the German government. They are put to work in the harvest fields, road mending and other forms of hard manual labor, receiving practically nothing for their work. Should we in Canada pay more than that to enemy laborers? Perhaps we should pay more. We might even stretch a point and pay twice as much, but that would be only five cents a day, a sum very different from two dollars a day. By all means let Germans and Austrians work in our fields. Let them work hard and receive double the money paid to British and Canadian prisoners in Germany. This is eminently fair. There is another point of view, that of the prairie farmer who needs assistance this summer. There can be no question but that he will be glad to avail himself of enemy labor, yet the supply is not sufficient for all the farmers of the prairie. It would be grossly unfair if one farmer paid only five or ten cents a day for workmen, while his neighbor paid two dollars. This can best be solved by having the farmer make payment to the government at the rate of \$2 a day, while the government can pay the German or Austrian the rate decided upon. The balance would go to the Red Cross fund, War Fund or other worth cause. Whether or not the government intends to do this was not explained in the news despatches. The inference was rather that the enemy laborers would receive the high rate of wages usually paid at harvest time. A great deal of curiosity has been aroused on this point and an explanation would be received with the greatest interest.—Vancouver Sun.

Synopsis of Canadian North-west Land Regulations.

The sole head of a family, or any male over 18 years old, may homestead a quarter section of available Dominion land in Manitoba, Saskatchewan or Alberta. Applicant must appear in person at the Dominion Lands Agency or Sub-Agency, for the district. Entry by proxy may be made at any Dominion Land Agency (but not Sub-Agency), or certain conditions.

Duties: Six months residence upon and cultivation of the land in each of three years. A homesteader may live within nine miles of his homestead, on a farm of at least 80 acres, on certain conditions. A habitable house is required, except where residence is performed in the vicinity.

In certain districts a homesteader in good standing, may pre-empt a quarter section alongside his homestead. Price, \$3.00 per acre.

Duties: Six months residence in each of three years after earning homestead patent; also 50 acres extra cultivation. Pre-emption patent may be obtained as soon as homestead patent, on certain conditions.

A settler who has exhausted his homestead right, may take a purchased homestead in certain districts. Price, \$3.00 per acre.

Duties: Must reside six months in each of three years, cultivate 50 acres and erect a house worth \$300.00.

The area of cultivation is subject to reduction in case of rough, scrubby or stony land. Live stock may be substituted for cultivation under certain conditions.

**MISTOOK TRESTLE FOR LOCAL HILL**

**TRANSFERS FOR SILLERY CAR LINE**  
**RESIDENTS OF BELVEDERE WANT THEM GRANTED ON TICKETS AS WELL AS 5c. FARE.**  
 Mr. Jos. Ahern, Secretary of the Quebec Public Utilities Commission, has received from a number of proprietors and residents of Belvedere avenue, Murray avenue and Belvedere Road, a petition requesting the Utilities Commission to oblige the Q. R. L. & P. Co., to give transfers for the cars on the Sillery line on city street car tickets.  
 Up to the present a passenger on a city tram is not granted a transfer on the Sillery Line unless he pays the cash fare of 5c. The complainants want this transfer privilege to points within the city limits by the payment of the ticket. Although the respective railways are operated under different charters it is possible that the Public Utilities Commission will bring about a satisfactory settlement of the dispute. The complaint will be heard at the next sitting of the Commission in Quebec, which will be held on the 25th inst.

Both parties are busy preparing for the Provincial Election Campaign, which will be formally opened next week. Owing to the fact that this is Holy Week, little will be done except the drawing up of the plans of campaign for the big pitched battle of words which will be waged until the voice of the people is heard on the 22nd of May.  
 In the district of Montreal as well as here, the activities have not yet begun, although Hon. Jeremie Decarie the Provincial Secretary, has broken the ice, and is the first Minister of the Gouin Government to enter the campaign, having promised a Liberal delegation yesterday to enter as their candidate.  
**Afraid of Mousseau.**  
 It is said that despite the opposition of his former colleagues in the Gouin Government, Mr. J. O. Mousseau, who was forced to resign in 1914, will insist upon being a candidate at the next elections. Truth is lent to this story by the anxiety of local Liberal sheets yesterday to throw discredit upon the Burns' Detective Agency, by publishing a despatch of doubtful origin stating that Guy Biddinger, who conducted the case here and in Montreal against Mousseau, was to be tried in Chicago on fifty-one counts of bribe-taking.  
 Even strong Liberals, who are not afraid to admit the truth, state that Mousseau will be returned in Soulanges in spite of all that the Government can do to prevent it.

**NO DAMAGES FOR S. MINGUY ESTATE**  
**JUDGE BELLEAU DISMISSED A \$12,000 ACTION AGAINST THE CAN. PAC. RAILWAY.**  
 The \$12,000 damage action which had been instituted against the Canadian Pacific Railway Company by the widow of the late Samuel Minguy, of St. Foy, and prosecuted since her death by the estate, was dismissed with costs in the Superior Court yesterday morning, by Mr. Justice Belleau.  
 It will be recalled that the late Mr. Minguy was killed by a C.P.R. train at Bell's Road crossing last spring, while driving in a buggy.  
 In giving judgment the Court decided that the accident was due entirely to the victim, who had been lacking in prudence, and had evidently not taken the precaution to see whether a train was approaching or not before advancing on the crossings.

**MEETING OF THE CITY COUNCIL**

Friday, April 14th, 1916.

Present: His Worship the Mayor; Aldermen Bedard, Bertrand, Bois, Bourret, Collier, Dinan, Dussault (St. Louis), Dussault (Belvedere), Fiset, Galibois, Gauvin, Glode, Lantier, Lockwell, Madden, Martin, Mercier, Paquet (St-Sauveur), Paquet (Jacques Cartier), Pettigrew, Plamondon, Theriault, Verret—(23).

The minutes of the last meeting are read and confirmed.

Read a letter from the Central Board of Trades and Labor, and also another letter from the National Fraternity of day laborers, praying the Council to order that the day laborers and of the City, be paid 25 cents an hour.—Referred to the Road Committee.

Read a letter from Col. Readman, of the 167th Battalion, asking a financial aid from the City to help the officers in their organization.—Referred to the Finance Committee.

Read a letter from "L'Union Lamblotte," offering to give twelve open air concerts on Thursdays, in Victoria Park, for the sum of \$250. Referred to the Finance Committee.

Read a petition of taxpayer of Belvedere Ward, asking that Fraser street be opened and extended to Moncton street, and another petition also asking the extension of Fraser street. Referred to the Road Committee.

**Reports of Committees.**

Presented the following reports of Committee

Finance.—2207th. (The budget of the City for the year 1916-17); 2208th (Recommending the appointment of Mr. George Goulet in the Accountant's department).

Moved by Alderman Verret, seconded by Alderman Bois, and resolved: That the said report be taken up as the 4th order of the day.

2009th. (Recommending the appointment of Mr. Villebon Garant, as joint guardian of the City Hall, with a salary of \$1,000. Moved by Alderman Verret, seconded by Alderman Theriault, and resolved: That the said report be taken up as the 5th order of the day.

Fire.—831st. (To award contract for copper wire to the Mechanic Supply Company, Limited). Moved by Alderman Lockwell, seconded by Alderman Theriault, and resolved: That the said report be taken up as the 6th order of the day.

832nd. (Contract for fire hose). Moved by Alderman Lockwell, seconded by Alderman Bertrand, and resolved: That the said report be taken up as the 7th order of the day.

**Report of Officers.**

Read the report of Doctor Paquin, on the seizures and confiscations of meats and other food stuffs during the last three months.

**Order of the Day.**

First Order of the Day: Pursuant to notice, the Council proceeds to the second reading, for adoption, of by-law No. 8, imposing the tax of one cent on each person admitted in a place of amusement, for which second reading and adoption the presence of two-third of the members of the Council is required, the following members of the Council being present: His Worship the Mayor; Ald. Bedard, Bertrand, Bois, Bourret, Collier, Dinan, Dussault (St. Louis), Dussault (Belvedere), Fiset, Galibois, Gauvin, Glode, Lantier, Lockwell, Madden, Martin, Mercier, Paquet (St. Sauveur), Paquet (Jacques Cartier), Pettigrew, Plamondon, Theriault, Verret. (23).

His Worship the Mayor reads the preamble and the thirteen clauses of the said by-law, each clause being submitted to the vote and adopted, without any amendment.

It is moved by Alderman Verret, seconded by Alderman Fiset, and resolved: That an additional clause, being clause 14, be inserted at the end of the said by-law, to the following effect: "The said by-law shall come into force on the first of May next, 1916."

His Worship the Mayor then submits the said by-law thus amended in toto, and the said by-law, thus amended, is unanimously adopted and His Worship the Mayor declares the said by-law read a second time, and passed and to be put in force on the first of May next, 1916.

Second Order of the Day: Consideration of the 724th report of the Market Committee, re Berthelot Hall, which being read and put to the vote,

It is moved by Alderman Bois, seconded by Alderman Dussault (St. Louis); That the report No. 724 of the Market Committee, re closing of the Berthelot Market Hall, be withdrawn, and that the said Berthelot Market Hall shall remain open for occupancy by butchers as in the past until 1st of May, 1917. And the said motion being put to the vote, is unanimously adopted, and the said 724th report of the Market Committee is struck off from the order of the day.

Third Order of the Day: Consideration of the 152nd report of the Police and By-law Committee, to amend by-law No. 3, concerning markets. And the said report and by-law being annexed with the preceding order of the day, it is unanimously resolved: That the said 152nd report of the Police and By-law Committee and proposed amendment to by-law No. 3, concerning markets, be struck off from the order of the day.

Fourth Order of the Day: Read the 2008th report of the Finance Committee, which being read and put to the vote, is adopted, and it is resolved: That this Council hereby approves the appointment of Mr. George Goulet, presently one of the bailiffs of the Recorder's Court, to be a clerk in the department of the City Accountant, with a salary of \$1,000 a year, to be computed from the first of May next, 1916—the amount of said salary to be charged to the credits to be voted for salaries of permanent officers of the City.

Fifth Order of the Day: Read the 2009th report of the Finance Committee, which being put to the vote, is adopted, and it is resolved: That this Council hereby appoints Mr. V. Garant, presently employed in the Accountant's department, to be joint guardian of the City Hall, with a salary of one thousand dollars a year, to be computed from the first of May, 1916—the amount of the said salary to be charged to the credits voted for salaries of permanent officers of the City.

Sixth Order of the Day: Read the 831st report of the Fire Committee, which being put to the vote, is adopted, and it is resolved: That this Council hereby awards to the Mechanic Supply Company, Limited, of Quebec, for the sum of \$119.50, a contract for the supply of 5 miles in length of copper wire as stipulated in the call for tenders, subject to the conditions mentioned in their tender, and in the call for tenders,—the amount to be charged to the appropriations of the Fire Committee for the year 1916-17, and His Worship the Mayor is authorized to sign a contract to that effect and to accept such securities as he shall deem satisfactory.

Seventh Order of the Day: Read the 832nd report of the Fire Committee, which being put to the vote, is adopted, and it is resolved: That this Council hereby awards contracts for the supply of 3,500 feet of fire hose of the Keystone brand, at \$1.10 a running foot, as tendered for by the Canadian Consolidated Rubber Company, Limited, and 500 feet of the Proctor brand, at \$1.00 a running foot as tendered by Mr. Rene Talbot,—the amount of said contract to be charged to the credits of the Fire Committee for the year 1916-17, and His Worship the Mayor is authorized to sign contracts to that effect and to accept such securities as he shall deem sufficient.

A notarial lease containing the conditions will then and there be signed by the lessees and paid by them, with a copy for the Corporation.

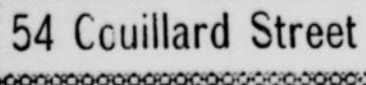

By-Law No. 8.

By-Law Imposing a One Cent Tax on Every Person Admitted in a Place of Amusement.

(Drawn up in the French Language).

At a meeting of the Municipal Council of the City of Quebec, held at the City Hall, in the said City of Quebec, on the fourteenth day of April, one thousand nine hundred and sixteen (1916), in conformity to law, and in virtue of a by-law passed by this Council, pursuant thereto, and after the due observance of all the formalities prescribed by the statute in such case made and provided, at that meeting were present two-thirds of the members composing the Council of the City of Quebec, that is to say: His Worship the Mayor, Aldermen Bedard, Bertrand, Bois, Bourret, Collier, Dinan, Dussault, St. Sauveur; Dussault, Belvedere; Fiset, Galibois, Gauvin, Glode, Lantier, Lockwell, Madden Martin, Paquet (J.C.); Paquet (St. S.); Pettigrew, Theriault, Verret, Plamondon.

It is ordained and enacted by the Municipal Council of the City of Quebec, and the said Council doth hereby ordain and enact as follows, to wit:

Section 1.—The words "place for amusement" employed in the present by-law signify and comprise a theatre, moving picture halls, an amusement hall, concert hall, a circus, play grounds, trotting course, a skating rink of any other place where are given representations or shows of any nature or kind it may be, in the City of Quebec, where an entrance fee is charged.

Section 2.—The words "proprietor of a place for amusement" used in the present by-law, signify the person, partnership, company or corporation who carries on a business in a place of amusement in the City of Quebec.

Section 3.—A one cent tax is imposed on every person admitted in a place for amusement, even if said person is admitted with a free ticket or a pass. Said tax shall be due and payable by such person every time he shall be admitted in a place for amusement.

Section 4.—Said tax shall be payable with a ticket issued by the City.

Section 5.—The product of such tax, deduction made of the expenses incurred by the City for said imposition and perception of it, shall be employed only for the ends and in the manner mentioned in the Act 6 George the Fifth, chapter 43, and section 10.

Section 6.—So as to facilitate the payment of said tax, the City shall have printed and shall sell in such a way it shall be found advisable, the tickets at a price of one cent each.

Section 7.—Every proprietor of a place for amusement shall, under the hereinafter edited penalty, collect said tax and account for it to the City the following day of the collection of such tax, and furthermore, he shall supply the City, at the end of every week, or oftener, if he is requested to do so by the City, a written report of the number of persons that have attended the shows in said places of amusement.

Section 8.—The municipal officers shall have the right to enter in every place of amusement to ascertain if the dispositions of the present by-law are observed and to collect themselves said tax, in case the proprietor of said place of amusement should refuse or neglect to do so.

Section 9.—It is forbidden to interfere with or molest or annoy said municipal officers.

Section 10.—It is forbidden to enter as a spectator in a place for amusement without having previously paid said tax.

Section 11.—It is forbidden for any proprietor of a place for amusement, also for any of his employees or representatives to admit in a place for amusement a person subject to the payment of said tax, unless said person has previously paid said tax.

Section 12.—Whosoever shall infringe any of the dispositions of the present by-law or shall refuse or neglect to fulfil any of the obligations that shall be imposed upon him by the present by-law, shall be, upon conviction of said offence before the Recorder's Court of the City of Quebec, liable to a fine with or without costs, and in default of the immediate payment of said fine, or of said fine and costs, as the case may be, of an imprisonment; the amount of the said fine and the term of said imprisonment shall be fixed by the said Recorder's Court, at its discretion, but said fine shall not exceed forty dollars, and the imprisonment shall not be for a longer period than two calendar months, said imprisonment, however, may cease at any time before the expiration of the term fixed by the said Recorder's Court, upon payment of said fine, or of said fine and costs, as the case may be, and if the infringement continues, the offending party shall be liable to the fine and to the penalty edited by the present article for every day during which said infringement shall continue.

Section 13.—The annulment of the license awarded by the City to a proprietor of a place for amusement is imposed as an additional penalty to said proprietor who shall have been found guilty for the third time by the Recorder's Court of having infringed some of the dispositions of the present by-law.

Section 14.—Said by-law shall be enforced on the first of May next, (1916).

Shipping News

S.S. DRUID LEAVES WITH LIGHT SHIPS

ALSO BRINGS BUOYS FOR BELOW—DOINGS ALONG THE WATER FRONT.

The Canadian Government steamer Druid left port yesterday morning with the light-ships for Red Island and White Island. These ships will be anchored for the season of navigation at the customary points.

On board the Druid were a number of buoys which will be laid in the lower St. Lawrence.

The Traverse lightship formerly the Arctic will leave this morning for below where she will remain during the season of navigation.

All vessels that have moored in the graving dock during the winter have left their winter quarters.

The Gaspeian is in the outer basin and will proceed to Montreal just as soon as the channel is clear, which will be in a few days, it is expected. She will take on a cargo at Montreal for Gaspe and other points.

Captain Joseph Bernier has just sold his schooner "Minnie Maud" to the Eastern Fisheries Co. of Montreal. The schooner will go to Halifax in charge of Captain Aug. Bernier and from this latter port will leave for England with a cargo of wood.

The Maritime & Industrial Co. of Levis has sold their vessel, the Orleans to an American company. The steamer will leave shortly for Buffalo.

The schooner, Marie-Reine, Captain Bouchard, of Gaspe, has left for Montreal to take on a cargo for Gaspe. The schooner "J. Heppel", Captain Heppel, which wintered in the Louis Basin has left for Matane. The schooner Sea Star, Captain Achille Gagnon is in port from Murray Bay and is taking on a cargo at the Renaud Wharf.

INTERNATIONAL MERCANTILE MARINE COMPANY.

Combined Earnings for 1915 Reached Sum of \$41,416,768.

New York, April 17.—The combined earnings during 1915 of the International Mercantile Marine Company, its subsidiaries and the Leyland Line, which it controls, were \$41,416,768, according to the report of Philip A. S. Franklin, receiver of the company, filed in the Federal District Court today. The Leyland Line contributed \$14,194,922 of the total earnings.

From the earnings must be deducted bond interest, depreciation, Broitish war and income taxes, and other items. The annual accounts for 1915, the receiver says, have not yet been prepared and the net earnings cannot be stated finally.

Earnings of the International Mercantile Marine Company for Jan. 1916, were \$2,510,636, and of the Leyland Line, \$2,014,836. No dividends from the stock of subsidiary companies have been received. The amount of the company's 4-1/2 per cent bonds, cash in the receivers hands Dec. 31, 1915, was \$3,875,000, and the trustees the New York Trust Company, have on hand \$5,000,000.

A statement from a stockholders committee April 9 said that the earnings of the International Mercantile Marine for 1915, over and above all charges were estimated at \$6,000,000. The Leyland Line, it was said, had earned \$13,500,000 subject to the war tax.

**NEW YORK MARKET.**  
(Canadian Press)

New York, April 17.—New war  
rumors were made to serve old pur-  
poses in today's sagging market, the  
result proving temporarily disastrous to  
war contract shares and affiliated  
issues. The more disquieting reports  
were to the effect that foreigners had  
been ordered out of Mexico and that  
Germany had definitely declined to  
recede from her submarine policy. As  
for rumors of the death of Mexico's  
bandit chief, Wall street inclined a  
willing ear, but maintained an attitude  
of doubt.

Chief features of weakness included  
Crucible Steel, American and Baldwin  
Locomotives, New York Air Brake,  
the Motors, United States Industrial  
Alcohol and Cuban-American Sugar,  
which registered extreme losses of 2  
to 11 points, while Bethlehem Steel  
fell 4 1/2 to 4 3/4, but closing at  
45 1/2-1/2. These reversals were the  
more noteworthy from the fact that  
opening prices were better by 1 to 4  
points, Mexican's deriving the greatest  
benefit.

United States Steel also declined re-  
current heaviness on its decried of 1  
1/2 from the high quotation of the  
opening. Selling of Steel was natural-  
ly associated with the publication of a  
table showing a decided decrease  
in the number of shareholders, but  
this was offset later by the tenor of  
Chairman Garry's annual address.

Coppers, zinc and other metals also  
suffered from the general depression  
of the day, even though additional  
orders from foreign sources for the  
base metals were reported with higher  
prices for spelter and a new recovery  
quotation since the war for silver.

Rails occupied their inconspicuous  
place of recent months, but the light  
dealings in these stocks were invariably  
at impaired prices. Irregular, but  
in some instances sharp recoveries,  
due mainly to short covering,  
marked the final trading, a few issues  
more than retrieving their losses. Total  
sales amounted to \$10,000 shares.

Conflicting rumors regarding the  
progress of negotiations for the new  
French loan accounted for the erratic  
course of change on Paris, which  
moved between 5.92 1/2 and 5.98. At its  
worst, however, the Paris check was  
well above its depreciation of last  
week.

Home developments of a construc-  
tive character included enormous ton-  
nage at leading railway centers and  
active buying in all the western mar-  
kets.

The bond market was broad, with  
an easier trend. Total sales, amounted  
to (par value), \$2,050,000.

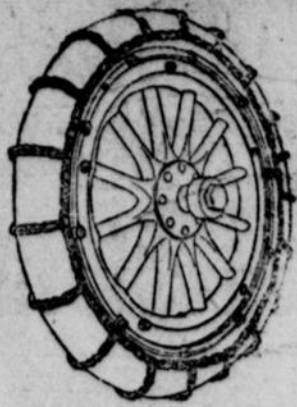

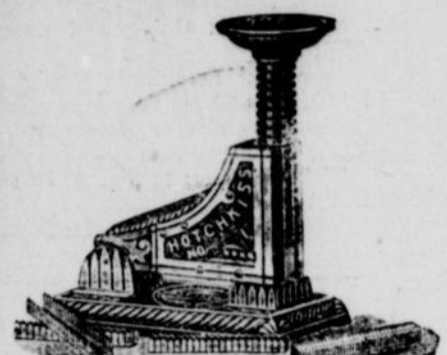

**BADLY REPORTED,  
SAYS CHOQUETTE**

PASSAGE MOST OBJECTED TO WAS QUOTATION FROM A LETTER.

Senator Choquette complains that the speech on recruiting which he made in the Senate lately was somewhat misrepresented. At his request, therefore, we publish the Hansard report of what occurred then:—

**Third Reading.**  
Hon. Mr. Loughheed moved the third reading of Bill No. 85, An Act for granting to His Majesty certain sums of money for the public service of the financial year ending March 31, 1917.

Hon. Mr. Choquette—As the Deputy Governor is coming at four o'clock to sanction this measure, I should like to occupy the time of the House for a minute or two in discussing the third item of the Bill, \$50,000,000, being one-fifth of the war appropriation of \$250,000,000. I suppose this amount is voted for two purposes, first, to carry on the war and second, to provide money to enlist men in addition to those we have at the front and the number already recruited that we have in Canada. I desire to enter my strongest protest against continuing this recruiting. We have already in this country too many enlisted men who will never reach the front to take an active part in the war. The right hon. the Premier recently said in the House of Commons that there are 135,000 enlisted men in Canada waiting to be transported to Europe, because we have no steamers to take them across the Atlantic. Under these circumstances, I ask if it is not the duty of the Government to stop recruiting. As has been said by Lord Shaughnessy and other people, it is a great waste of money, time and men to recruit more men, when we cannot send those already enlisted to the seat of war. Certain men are adopting the military profession and are willing to enlist. I congratulate them on that, if they feel it their duty to do something for the Empire. They are paid to do something, but probably some of them are adopting the calling for their own amusement, and to make a living.

Hon. Mr. Murphy—May I ask how many of the hon. gentleman's sons or relatives are recruiting?

Hon. Mr. Choquette—There are none. If I were eligible, I would go myself in preference to trying to send others there.

Hon. Mr. Murphy—The hon. gentleman would be no good.

Hon. Mr. Choquette—Perhaps I would be better than the hon. member who asked me the question. Some big men are not as good as the little ones. The big bottles do not always contain the best medicine. I say it is useless to spend money to recruit more soldiers when we cannot send them to the war. In Quebec I have seen men walking about the streets for twelve months. They are good men and I have nothing to say against them, but for the past year they have been putting in their time going to the theatres and cafes, and looking for the ladies in Quebec.

Some hon. Gentlemen—Order, order.

Hon. Mr. Choquette—That is true. We know the ladies like the soldiers. I am glad of that, but when, as has been said, we have 135,000 men already organized it is time to stop. The Government now have paid officers and paid lawyers—I see some of them not far from my place—going through the country parishes enticing men to leave their farms and enlist, telling them how well they will be paid and assuring them that they will not have to fight because before they reach Europe the war will be over.

These facts are taken from a paper in Quebec, which states that in Montmagny, Megantic and Bellechasse 49 young farmers have enlisted. These young men will stay in Quebec during the coming summer, and the country will have to pay six or seven dollars a day for each of these men employed to entice those young men off the farms. I say it is a crime to strip the farms of those young men, and also, as we are doing now, to form a battalion of shanty men. The young men who spend their winters in the shanties are nearly all farmers' sons, who in the winter time earn money in the woods and return to the farm in the spring. When they leave the farm and enlist to go to the war, they change their mode of life and habits, so that many of them will be permanently lost to the farm. While we are encouraging this on the one hand, on the other hand we are forming a committee to try and help the farmers to obtain farm labour. What do we see? At a meeting of the Board of Trade in Montreal, not later than last week, Sir George Foster was present, and what was the matter discussed? Another matter in which the aid of the Government was dealt with was a communication from the Toronto Board of Trade which set forth that, in view of the necessity for securing agricultural immigrants for Canada, the Government be "urged to at once give the matter of immigration its most earnest attention."

On the one hand we are asking the Governments to bring in farm labourers from abroad, while on the other hand the Government recruiting officers are inducing our own men to leave the farm. I say that is a crime, against which I, for one, must strongly protest. Moreover, what do we see in a paper published by the Government themselves, the Labour Gazette, for February and March? It says in the West, especially in Brandon, Regina, Edmonton, etc., they cannot get farm help to cultivate their lands. Of every two men that you take from the farm, one if not both are surely lost to the farming community. It is high time to stop that. The Government say that we must have recruits, and are spending enough money to secure them. Why spend money for this re-

cruiting when we have already more soldiers on hand than we can send to the other side? I take an extract from the Toronto Mail of the 15th March last about recruiting:

The 169th Battalion in recruiting to its strength of 1,131 men, examined 2,365 men, and therefore rejected as unfit 1,234. Another mounted squadron, amounting to 540 men, examined 1,744 and therefore rejected 1,204.

This is the class of men we are recruiting. Those men are paid to be brought to the city, the doctors are paid for examining them; and then they are found defective and rejected. I had a letter from a good Tory from the county of York in Ontario, an Englishman of the fifth generation on the land there, protesting against this recruiting of the so-called English immigrants; talking about Rev. Mr. Hincks as a faker, and asking me to give his name in the House. He is a good Anglo-Saxon who is proud of his nationality, and he refers me to General Mason, one of our worthy colleagues, or Col. Currie, for a recommendation as to his standing. He is in the riding of Mr. Maclean. I inquired about him, and was told that he is a first-class man. He says that those rejected recruits knew that they were unfit. The names of the writer is Robert Hazelton, and his letter is as follows:

Todmorden, Ont., Sunday, March, 19th, 1916.

In haste.  
These defectives are 99 per cent so-called English—are they English—or are they the offspring of foreign sailors and English "dock-prostitutes"! They are surely not descendants of cultured Anglo-Saxons that we Britishers of Canadian birth have heard so much.

Hon. Sir, you are not at all in error when you said what you are reported to have said in the enclosed clipping from "the Telegram" as to the defectives rejected in Toronto. How do the degenerate, defective and undesirable immigrants of this type escape the eye of our immigration officials at Quebec and Halifax? They are, 90 per cent of them, from the slums of England. They are diseased, depraved, deformed and many are illiterates and none are of the agricultural class, the element so much required in Canada. Their intemperance and their vile and filthy habits and their utter lack of all honesty are not such as we Canadians should have sent out to us as samples of the Englishman. They are not suitable for the British Army and, of course, are unfit to serve in ours. The "Rev" (?) Hincks is a faker. He is an adventurer and to the native born he is known as a "Broncho Bull-shooter" always blowing his own horn.

Our well bred, educated Canadians have no use for such cattle and refuse to enlist as comrades with such beasts.

The Government has made a mistake in not organizing regiments of "native born" for those of our sons to be separated and free from some of these immigrant swine who have polluted and destroyed the once very beautiful suburbs of Toronto and other Canadian cities with their unhabitable hovels. Our Irish, Scotch and Welsh from the British Isles are of a very different element to what is known as the "English" here. There are no complaints heard about Irish, Scotch or Welsh such as are heard of so-called English origin. The Salvation Army has brought most of these English to our land and from the very worst spots in older England have they been collected to defile our beloved Canada.

I see by the papers that there is no recruiting of good men in Toronto. Not one-third of the men recruited are able to pass the examination. This Government is taking from the farms of Quebec, Ontario and the West young men who ought to remain at home to assist the country. They are more useful on the farms to help the Allies than they can be in the city parading through the streets behind a band. I beg the government to call back those paid recruiters—agents, soldiers, officers and lawyers—from the parishes. If more recruits are required, let them be taken from the cities. I was asked by the hon. member from Tignish (Hon. Mr. Murphy) if I had not a son to go to the war. I have sons who are ready to defend this country should the occasion arise. If they feel it their duty to go to the war in Europe, I congratulate them, but it rests with them to say where their duty lies. Should the time ever come when men are needed to defend the country, to defend Confederation, and indirectly to defend the Empire, perhaps I will be in the front when my hon. friend will not be there.

Hon. Mr. Murphy—I do not think so.  
The motion was agreed to, and the Bill read a third time.
