FRENCH MARY'S WOES

ARRESTED ON A CHARGE OF SUBORNATION OF PERJURY.

CHARGED WITH TAMPERING WITH CROWN WITNESSES.

Fixed For Next Tuesday—Also Charged With Selling Liquor on Sunday.

Mme. Langevin, alias French Mary, was arrested yesterday morning by Assistant High Constable Lambert on a warrant charging her with having attempted to bribe a witness for the Crown in a case tried to-day charging her with having sold liquor on a Sunday.

French Mary was charged under Article 154 of the Criminal Code, which reads as follows:

"Everyone is guilty of an indictable offence and liable to two years' imprisonment who dissuades or attempts to dissuade any person by threats, bribes or other corrupt means from giving evidence in any cause or matter civil or criminal."

Lemieux, the witness in question, made his deposition to the effect that Madame Langevin, alias French Mary, had offered him \$25 not to appear in Court and testify against her. He had two witnesses present at the time who would bear out his testimony.

The two witnesses, it appears, had already given their testimony before Judge Desnoyers the previous afternoon, in which they had fully borne out Lemieux's statement.

French Mary was taken before Judge Desnoyers; she pleaded not guilty.

The Judge committed her to the Court of Queen's Bench.

She was immediately arraigned before Judge Dugas, sitting as a Session's Judge.

The deposition of Lemieux was again read over and in response to whether guilty or not guilty, she pleaded "not guilty."

Judge Dugas remanded her until Tuesday morning next and allowed her out on her personal bail.

CHARGED WITH SUNDAY LIQUOR SELLING.

The case out of which French Mary's arrest grew was one of selling liquor on Sunday, preferred against her by Chief Chevalier, of the Inland Revenue Police.

Judge Dugas tried the case.

Three witnesses for the Crown swore they had bought tickets at the door for 50 cents, and had gone into the saloon, where they had had three drinks a-piece without any food, even sandwiches.

French Mary as in the first case had a score of witnesses who swore the three witnesses for the Crown on the Sunday in question had eaten sandwiches with their drinks.

Judge Dugas dismissed the case holding that the tickets bought entitled them to a sandwich, which under the Act constituted a "snack."

NO DIPHTHERIA.

It is a Scarlet Fever Which is Troubling the Infants.

Dr. Laberge, medical health officer of the city, said in an interview yesterday, that he had been totally misinformed as to the nature of the disease from which the patients in the Infants' Home and Montreal Foundling and Nursery Institute were suffering.

"On making inquiries," he said, "I find that there have been no cases of diphtheria here at all. The cases were those of scarlet fever. At present there are 25 cases of scarlet fever in the city. We believe we have traced the entrance of the disease into both institutions. It was most probably carried into the Infants' Home by a woman living near Guy Street, who had a case of scarlet fever in her family, and who frequently visited the institution. From the Infants' Home the contagion was taken to the Foundling and Nursery Institute by an inmate of the former who was in the habit of visiting the latter. In the Foundling Institute there are no means of securing satisfactory isolation, and as the scarlet fever annex of the General Hospital is full at present, I think the civic hospital should be opened at once for scarlet fever patients. It is important to secure perfect isolation, so as to prevent an epidemic."

MR. McCLANAGHAN'S CLAIMS.

An Arrangement Come to With Him by the Park Committee.

The Mount Royal Committee met yesterday afternoon for the purpose of arriving at an amicable settlement with Mr. McClanaghan as to his claims against the city. The Sub-Committee appointed to confer with him reported that an arrangement had been arrived at on the following basis: Mr. McClanaghan will forego all his claims on receiving \$2,500 compensation, and \$500 for lawyers' fees, a remittance of rent to May 1st next, renewal of his lease for five years at the present rental, \$500, it being understood that he will have no rights over that part of the Mountain now used for exhibition purposes.

After a long discussion the sub-Committee's report was adopted. Ald. Lyall and Stevenson voting against it.

A SOLEMN HIGH MASS

For the Repose of the Soul of Honore Mercier.

The Chapel of the Sacred Heart, Notre Dame Church, was crowded with worshippers yesterday on the occasion of the celebration of a solemn High Mass of Requiem for the repose of the soul of the late Hon. Mr. Mercier. Grand Vicar Bourgeault was the Celebrant, with the Rev. Father Payette of Laval University and Rev. Father Bedard, director of the Seminary, as Deacon and sub-deacon. Amongst those in the choir were the Very Rev. Abbe Collin, Superior of the Seminary; two Jesuit Fathers, Rev. P. Desjardins and Rev. P. Brault, and a number of Sulpician Fathers. In the congregation were Judge Jette, Judge Dugas, Judge Barry, Recorder De Montigny, Hon. H. Archambault, the deceased's four brothers, J. A., X., J. P., J. Freschette, M. ST. LAWRENCE EXTENSION.

A Movement to Dismiss the City's Appeal.

In the Court of Appeal yesterday, Mr. R. G. Smith moved to dismiss the appeal taken by the city against the recent mandamus granted on the petition of Gauthier et al, compelling the extension of St. Lambert Hill to the river.

Mr. Smith argued that under section 1,033 of the Civil Code there was no right of appeal in a case of this kind, and he cited several cases in support of his contention.

L. J. Ethier pointed out the injustice to the city, and the trouble which would result if all right of appeal were taken away from it.

Mr. Smith replied that he did not contend that all right of appeal was taken away, but under the section there could be no appeal in special cases, of which a mandamus was certainly one.

Their Honors took the motion on deliberation.

OVERCROWDING CARS.

Street Railway Company Wants Protection From Law Suits.

The question of the overcrowding of street cars was raised at the meeting of the Road Committee yesterday.

Mr. Lusher asked the Road Committee to assist the Company in the matter. About a dozen actions had already been taken against the Company for overcrowding, and the Recorder in each case imposed the nominal fine of \$1 and costs. He understood that a hundred other actions were going to be taken. This would cause considerable inconvenience to the Company, which was doing its best to give the city a good service. There were now 110 to 115 motors running, besides trailers. So good was the service that physicians were selling their carriages and using street cars to visit their patients.

Ald. Lyall asked what sort of help the company wanted from the committee. Did they want a policeman placed at each car?

Mr. Lusher—"If you wish the Paris system to be adopted to refuse to take up more passengers when the sign 'complete' is put up—we will adopt it, but people will have to wait half-an-hour sometimes before they can get seats."

Ald. Lyall—"The Street Railway Company will have to obey the by-law. Let them put on more cars and run on shorter time."

Ald. Prefontaine said that the Road Committee should be reasonable, and should not prosecute the Company for overcrowding unless citizens went and complained before the Recorder. The Company had till December, 1895, to complete their system. He would have the detectives at present employed in watching for overcrowded cars called off.

City Surveyor St. George—"But I am responsible for the carrying out of the by-law. I am obliged to prosecute them and I cannot act myself as a policeman."

Mr. Lusher—"The city ought to treat us leniently, for it is the Company that has made the city."

Ald. Kennedy—"Not at all. It's the city that has made the Company." (Laughter.)

Ald. Prefontaine assured Mr. Lusher that the matter would be satisfactorily arranged.

Ald. Penny appeared on behalf of several of his constituents, who objected to snow being dumped on Fletcher's Field this winter.

The City Surveyor was instructed to report on the subject.

Ald. Turner presented a petition for the macadamizing of Ash Avenue, and it was sent to the City Surveyor.

A petition of the Stone Cutters' Association was received asking that contracts for cut stone to be used in the city next summer should be awarded at once, so that work may be provided during the winter.

The City Surveyor was asked to make an estimate of the probable quantity of cut stone required.

It was decided to ask the Finance Committee for a special credit, the money to be used for cleaning snow from the Street Railway tracks.

Ald. Lyall protested against the one-man policy persistently carried out by Ald. Prefontaine in regard to the Road Committee. The chairman, he said, went habitually to the Finance Committee and represented his Committee without consulting its members, and reports went from the Finance Committee to the Council as joint reports of the Road and Finance Committees, when the Road Committee had not been consulted at all.

Ald. Prefontaine admitted that there might be a little ground for complaint in this connection, and endeavored to explain it away. The matter dropped, as it was now after 12 o'clock.

FIRE AT ST. ALBANS.

Car Sheds of the Central Vermont Railway Destroyed.

St. Albans, Vt., Nov. 16.—Fire at 10 o'clock this forenoon destroyed the Central Vermont car sheds here. President E. C. Smith's private car and a number of passenger coaches. The loss is between \$50,000 and \$100,000.

DR. MCCOSH VERY ILL.

The Life of the Great Princeton Scholar Drawing to a Close.

Princeton, N.J., Nov. 16.—Dr. James McCosh passed a quiet night but is gradually sinking and has not long to live. Dr. McCosh was born in Ayrshire, Scotland in 1811. He was educated at the Universities of Glasgow and Edinburgh, and became a minister of the Church of Scotland in 1833. He took an active part in the organization of the Free Church in 1843 and was appointed Professor at Queen's College, Belfast. In 1868 he came to America and became President of the College of New Jersey at Princeton. He was succeeded in this position in 1883 by Dr. Patton.

But he continued to lecture until 1893, when his advanced age caused him to relinquish all active work. He has written many philosophical and religious works, and has long been regarded as one of the leading educationalists of this continent.

BURIED ALIVE.

Those Who Opened the Grave Found a Horrible Sight.

Detroit, Mich., Nov. 16.—A special report from Grand Lodge, Mich., says: Elam Muscott, a fruit tree agent, who for about two years past has lived in the home and headquarters, while on a trip to Alma a little over a year ago, was taken ill and died suddenly. Being among strangers he was buried hastily. Recently it was decided to take up the body and remove it to Williamstown. When the coffin was opened, the hands were clutched the hair, and the hands were full of hair which had been torn out, and the face was terribly lacerated. It is thought the supposed death was a case of suspended animation.

CENTRAL AMERICAN TROUBLES.

Great Misery Prevails in San Salvador—Preparing for War.

San Salvador, Nov. 16.—The greatest misery prevails here through the loss of crops as an effect of the late revolution and upon all this come threats that Guatemala is to aid a revolution against Guizot, because he refused to join the league proposed by Barrios of all the Central American States against Mexico.

Guatemala, Nov. 16.—Preparations for war continue here and recruiting progresses all over the country. American laborers on the Port Barrios Railroad have been offered and are drifting the natives. Special envoy Deleon has gone to Washington. He will stop several days in San Francisco. After conferring with the ministers of Guatemala and Mexico in the American capital, he will proceed to the City of Mexico.

SHIP NAUWAL DISMANTLED.

Plymouth, Eng., November 16.—The German steamer Barman, Captain Petersen, from Baltimore for Hamburg, passed Pwllbeil to-day and reported that when in latitude 49 N., longitude 8 W., she passed the British ship Narwhal, Captain Weston, from Liverpool, November 7 for Pensacola for Falmouth. The Narwhal had lost her main and mizzen masts.

PEACE IN NICARAGUA.

Washington, Nov. 16.—Dr. Guzman, the Nicaraguan Minister here, has received information that on September 20th the new constitution was proclaimed, firmly asserting Nicaraguan supremacy over the Mosquito preservation and that Cabezas, the first constitutional Governor, was formally installed in office.

PULLMAN WILL REPLY.

New York, Nov. 16.—George M. Pullman started for Chicago last night. He would not discuss the Strike Commissioners' report, but said he would devote much of his time after his return to Chicago to preparing a reply to the report. This will be made public as soon as completed.

HON. CECIL RHODES IN ENGLAND.

Plymouth, Eng., Nov. 16.—The Hon. Cecil Rhodes, Premier of Cape Colony, and Dr. Jameson, the Administrator of the South African Chartered Company, arrived here to-day from Capetown, and were welcomed by the Mayor and Corporation.

ONDERDONK IN OTTAWA.

[Special to the Herald.] Ottawa, Nov. 16.—Andrew Onderdonk, who built the British Columbia section of the Canadian Pacific Railway, arrived here this morning. He has a claim against the Government which he is pressing.

THE CHARGE WAS FALSE.

[Special to the Herald.] Toronto, Nov. 16.—Arthur B. English, who gave himself up yesterday on a charge of attempting to procure an abortion on Mrs. Elizabeth Gore for Miss Adgwell, was discharged in the Police Court to-day. Mrs. Gore having written from Chicago to the Crown Attorney to the effect that her information was untrue. If she returns to Toronto she will be charged with perjury.

THE DUKE OF ARGYLE.

He Will Soon Marry His Third Wife, Says His Daughter-in-Law.

London, Nov. 16.—The Realm, of which Lady Colin Campbell is the editor, appeared to-day, and was favorably received. In its first issue Realm announced that the Duke of Argyle is engaged to Miss Knox Little.

George Douglas Campbell, eighth Duke of Argyle was born in 1823, and is the father of the Marquis of Lorne, who married the Princess Louise, fourth daughter of Queen Victoria.

Lady Colin Campbell, the editor of Realm, is the wife of Lord Colin Campbell, fourth son of the Duke of Argyle, from whom she was separated in 1884.

The Duke of Argyle has been twice married; first, in 1844, to Lady Elizabeth Georgeina Sutherland-Leveson-Gower, who died in 1878. She was the eldest daughter of the second Duke of Sutherland. In 1881 the Duke of Argyle married Amelia Maria, daughter of the late Right Rev. Thomas Leigh Clouston, D. D., formerly Bishop of St. Albans, and widow of Colonel the Hon. Augustus Henry Archibald Anson. She died in 1902.

STEINITZ WON.

The Chess Tournament Finished and the Old Champion Ahead.

New York, Nov. 16.—The Chess Masters Tournament was finished to-day at the Union Square Hotel, when Steinitz took first prize. Albin was second, and Showalter and Hymes divided third and fourth prizes. The games in the final round resulted as follows:

ORDERED HIS COFFIN.

It Was Taken From Bowmanville to Plymouth, England.

Bowmanville, Ont., Nov. 16.—A special despatch announces the death at Plymouth, Eng., this morning, of W. P. Frower, undertaker, reeve of Bowmanville and ex-warden of the United Counties of Northumberland and Durham.

Mr. Frower, with his wife and two children, went abroad in the hope of recovering his health. Finding that he could not get better, he called three weeks ago for his foreman, John Bennett, to proceed to England with a metallic casket and embalming materials. Bennett reached Plymouth last week with the coffin. Frower's widow will sail for Canada on the 22nd with the body.

JAPAN WILL ANSWER.

The Cabinet Tomorrow Will Consider the Peace Proposition.

Washington, Nov. 16.—The State Department has received official information that a special meeting of the Japanese Ministry has been called for to-morrow to consider a final answer to the offer of the United States to mediate between China and Japan. The delay thus far is explained by the fact that the Cabinet meets at Tokyo, while the Emperor, who has been consulted, is at Hiroshima.

Yokohama, Nov. 16.—Despatches received here from the headquarters of the Japanese army operating against Port Arthur say that Field Marshall Oyama expected to attack that place yesterday or to-day. The Chinese force defending Port Arthur is estimated to amount to 16,000 men of all arms.

London, Nov. 16.—A special despatch from Shanghai says that General Wei, one of the Chinese commanders at the battle of Ping Yang, where the Chinese were utterly defeated with heavy loss, was beheaded to-day for cowardice during that engagement.

CASH FOR CANADA.

The Sum of \$200,000 Consigned to the Bank of British North America.

New York, Nov. 16. It is generally believed in banking circles that the \$200,000 consigned to the Bank of British North America is for the Canadian account and has no connection with the recent Government bond issue. It will be recalled that the Dominion of Canada recently placed an issue of bonds abroad on a four per cent. basis, and it is not unlikely that this shipment is in payment for some of these bonds.

PLEURO-PNEUMONIA.

The Standard Replies to Sir Charles Tupper's Scotch Speech.

London, Nov. 16.—The Standard, commenting on the speech delivered by Sir Charles Tupper, the Canadian Commissioner, at Dundee, Scotland, to a deputation of farmers of Forfarshire and Perthshire, says that it is impossible for Sir Charles Tupper to believe that the Government has any animus against Canadian cattle. The Standard adds: "He would do better service to the Colony if he multiplied the proof of his assertion that pleuro-pneumonia does not exist in Canada. We naturally prefer taking Canadian to the United States cattle, where the tariffs do the best they can to exclude our goods."

A POTTERY DESTROYED.

Lynden, Ont., Nov. 16.—The Lynden Pottery, owned by J. E. Tait, was completely destroyed by fire this morning. The cause of the fire is unknown. The property was insured.

WIMAN'S APPEAL DELAYED.

New York, Nov. 16.—The appeal of Erastus Wiman from the conviction and sentence in the Court of Oyer and Terminer to five years and six months in State prison for forgery, was on the calendar for argument in the general term of the Supreme Court yesterday. Presiding Justice Van Brunt announced that the case would not be reached that day, and must, therefore, go over until the December term.

FIRE IN WINNIPEG.

ONE OF THE WORST BLAZES IN THE HISTORY OF THE CITY.

THE TOTAL LOSS WILL BE MORE THAN \$200,000.

The Water Supply Gave Out and the Firemen Were Powerless.

(Special to the Herald.) Winnipeg, Man., Nov. 16.—This city had one of the worst fires in its history this morning. About 3 o'clock a fire broke out in the Western Canada Loan block, one of the finest on Main Street, and it was soon gutted. Wright Brothers, dry goods, occupied the ground floor, and above were numerous lawyers', insurance offices, and a beautiful Masonic Hall on the top story. All were destroyed.

While this fire was in progress another blaze broke out several blocks away, and wiped out Merrick Anderson's large wholesale hardware warehouse and offices. Flames spread across the street to the Grand Union Hotel burning it with several adjoining buildings.

The fire brigade was unable to fight the flames owing to the inadequacy of the water supply, and the second blaze was simply allowed to burn itself out, while the firemen directed their efforts to saving the Western Canada block from entire destruction.

The total loss is over \$200,000, insured for \$100,000.

Only one engine was available during the height of the fire, two becoming crippled.

THE LOSSES AND THE INSURANCE.

Winnipeg, Nov. 16.—The losses of this morning's fire cannot yet be stated accurately, but are estimated as follows: Western Canada Loan Company building, \$25,000, insured for \$30,000; Wright Bros., dry goods, loss, \$50,000, insurance, \$25,000; Mitchell's drug store, loss heavy. Other losses in Western Canada block were Western Canada office, W. M. Fisher, manager; Sutherland and Bain, Mandson and Allans, Standard Oil Co., W. J. Emmons, Masonic Library, and others. The Merrick and Anderson hardware warehouse was valued at \$25,000, and owned by Mr. Campbell, and was insured for \$13,000. Merrick and Anderson's stock was valued at about \$40,000. Loss on Grand Union Hotel and contents is \$20,000, partially insured. The other losses are: Miss McDowell, Mrs. Hunter and Dr. Dougall, who had a residence near the north end of the burned district.

WALES AND NICHOLAS.

Closer Relations Between Britain and Russia Suggested.

St. Petersburg, Nov. 16.—The Czar's constant and marked attentions to the Prince of Wales, here called Waleski, has been much noticed and are thought to preclude closer relations between England and Russia. The Prince of Wales and the Duke of York had a great reception at the Antichoff palace this afternoon. All the generals and staff officers now in St. Petersburg went ablaze with their medals and orders. The gorgeousness of the scene was hardly dimmed by the signs of mourning. The grand dukes assisted at the reception, and most of them signed the Prince of Wales' visiting book.

Although not officially announced, the wedding of the Czar and the Princess Alix is likely to take place on Wednesday 23rd or 24th. The foreign princes are expected to remain for the celebration. This is said to have been Alexander III's dying wish, but some one of the frequent and sudden changes of the court arrangements may prevent the execution of the plan. The date of the funeral is still unknown. It is as likely now to be the 17th as the 20th.

MURDER AND ROBBERY ATTEMPTED

JOHN BAPTISTE BOURGIGNON'S NARROW ESCAPE.

A MASKED ROBBER ENTERS HIS HOUSE AT NIGHT.

Twice the Intruder Fired a Revolver, but Missed His Aim—Police Have a Description.

At an early hour yesterday a desperate attempt at murder and robbery took place at the grocery store kept by Jean Baptiste Bourguignon, corner of St. Dominique and Napoleon Streets.

Mr. Bourguignon was awakened from his sleep by a touch upon the arm, and upon looking up saw a masked man standing over him. The stranger demanded that he should rise and get all the money in the house and hand it over to him or lose his life.

Bourguignon replied that he would grant his demand, and asked to be allowed to go to an upper room, at the same time asking that his wife should not be awakened.

Mrs. Bourguignon had, however, awakened before her husband, and lay beside him powerless to speak or act.

Bourguignon arose from his bed, and was about to leave the room, followed by the burglar, when he turned and seizing a chair made a blow at the intruder. The latter dodged and ran to the parlor. As Bourguignon advanced the masked man fired, but in the darkness missed his aim.

Then a fierce struggle ensued, and as the robber broke from Bourguignon's grasp he again fired, the bullet passing close to his cheek, through a picture, into the wall.

Bourguignon made another effort to effect his capture, but Mrs. Bourguignon recovered consciousness, and, rushing into the parlor, threw herself upon her husband. In a moment the robber was gone.

A search of the premises showed that they had been thoroughly ransacked, but nothing was missing. It was evident that the robber wanted cash only.

The detectives have a description of his appearance through the mask does much to hide his identity.

Mr. Quinn concurred in the request, which was granted by His Honor. The Crown is represented by Mr. M. J. F. Quinn, Q.C., and J. L. Archambault, Q.C., Crown Prosecutors. J. N. Green-shields, Q.C., appears for Mr. Grose. The counsel for the defence are H. C. St. Pierre, Q.C., Raoul Dandurand, and W. J. White.

BRITAIN'S NEW ALLIES.

Is Germany to Stand Alone Among the Powers of Europe.

London, Nov. 16.—The Vienna correspondent of the Standard sends a long despatch concerning the position of Germany in Europe and the relations of the Triple alliance to England, in the latter case being the observations on Lord Rosebery's allusions to Russia in his Guildhall speech. The impression that England is tending toward an alliance with France and Russia and an estrangement from the Triple alliance, he says, causes uneasiness and regret, which are reflected in the Vienna press.

Commenting on this despatch the Standard says: "Is Germany taking the place so long occupied by the isolated power of Europe? The events of the last few weeks undoubtedly strengthen the impression that Emperor William's recent policy has not tended to increase the number of his friends or the sense of security felt by his allies."

NO EXPORT DUTY.

The Chambre de Commerce Changes Its Mind.

The Council of the Chambre de Commerce held its regular weekly meeting yesterday afternoon. Mr. H. Lorette, president, presided, and among the other members present were Messrs. Hon. Tourville, Jacques Grenier, D. Parizeau, M. P. P., Jos. Contant, J. D. Rolland, F. D. Shallow, H. Catell, D. Gagnon, J. X. Perreault and G. Boivin, Joseph Fortier, A. Haynes.

Mr. Cassel, a trader of the department of Chateauguay, France, wrote asking for information about Canadian cattle and sheep. He says that he is ready to buy 150 head of cattle and 1,500 sheep monthly, paid at the wharf, if conditions are suitable. It was decided to refer the communication to the Cattle Exporters' Association.

The question of export duties on pulp wood was again brought up by Hon. Louis Tourville, who said that if export duties were put on this class of wood, it would simply provoke the United States Government into re-establishing the duties on lumber and thus practically ruin that important trade. These remarks were supported by Mr. Jacques Grenier and Mr. Mozier. Thereupon Mr. J. D. Rolland moved that the resolution adopted at the last meeting in favor of export duties be reconsidered. This was carried unanimously.

On proposition of Mr. J. X. Parizeau, it was decided to send a deputation to ask the Grand Trunk to run two Sunday trains between Longueuil and the city. Mr. Kleczowski, the French Consul, was present to thank once more the Chambre for the cordial reception which it had extended to him. He was very anxious to have a commercial museum in the city. Already the Chambre de Commerce of Lille has sent many specimens of French goods to Montreal and would be glad to receive Canadian specimens in return. The Chambre de Commerce is now awaiting an answer from the Dominion Government on its application for assistance in this matter.

The Consul also thought that there was a chance for a large exportation of wood pulp to France.

Durham Wants Fire Protection.

Durham, Ont., Nov. 16.—The vote here to-day on a by-law to provide fire protection was carried by a very large majority. The Board of engineers received 190 of a majority over the Waterworks.

THE TORONTO BOOBLING.

Toronto, Nov. 16.—City Engineer Keating has received a letter from President Hamill of the British Electric Co., of Cleveland, and sent it to Wallace Nesbitt. Mr. Keating refused to divulge the contents of the letter, but they were such as to lead to the conclusion that the agents of the concern are not likely to return to Canada to give evidence.

There is nothing definite as to the date for resuming the aldermanic enquiry, but it is expected that it will begin on Monday. The interval is being employed by the counsel in preparing his brief, and it is expected when the Court opens the investigation will be pressed with all possible speed.

Three Convicts Escaped.

Dorchester, N. B., Nov. 15.—Three convicts whose names are Carter, who tried to escape last summer, Johnson, a colored lad and Horne, made their escape from penitentiary this afternoon.

They had been working on the farm about a mile away in charge of Officer Legere, and were on their way to prison in a cart when they jumped and ran. Legere fired three shots out of a revolver at them but failed to bring them back. Guards are out searching for them but so far their capture has not been reported.

W.C.T.U. CONVENTION

DELEGATES FROM EVERY PART OF THE CONTINENT PRESENT.

Miss Willard Addresses the Meeting—She Traces the History of the Movement.

Cleveland, Nov. 16.—Under the national banner, "For home and native land" delegates representing every State in the Union and a following of thousands of wearers of the white ribbon, assembled this morning in Music Hall, to open the twenty-first annual convention of the Women's Christian Temperance Union.

The chief address of the day was given by Miss Frances A. Willard, who traced the history of the W. C. T. U. from its inception, 21 years ago. Said she: "The child of the crusade has lived out its eager youth and stands on the threshold of mature womanhood. On the weird day of December, 1873, the first praying band of Ohio bridged with faithful feet the distance between church and dramshop. As if by magic similar processions began to move throughout the west until in the fifty days of the unexampled faith and works the liquor traffic was banished from 250 towns and villages. We date our origin from that red letter day set like another Christmas in the dear December to show that dawn is sure to follow darkness. In the bright summer following (August, 1874) at beautiful Chautauque a committee of the crusade decided that this mode of the use of alcoholics and tobacco to the children in the public schools of all the fifty States and Territories except five, prohibition has gained ground in several northern States and throughout the South by means of local option. The recent plebiscites in Canada prove the growth of a strong sentiment in favor of the prohibitory law in Great Britain the prevailing sentiment is that the question of license or no license should be placed in the people's hands and in New Zealand.

The victory gained by Lady Henry Somerset, Mrs. Ormiston Chant and other White Ribbon women in bringing even to London County Council which caused it by a vote of 25 to 32 to refuse liquor and promenade hall licenses so that prominent places of amusement in London are closed, is perhaps the strongest proof that a better day has dawned and deserves to rank beside the victory of women in Kentucky over the perjured Breckenridge and of women in New York over the tiger of Tammany.

In conclusion the President said: "I remember that no subject ever vexed me more in my youthful days than why it was that men could range in the whole world their will and then have the home besides, while women did not have the world but the home only. CORRESPONDENCE.

The Grain Transportation Question. To the Editor of the Herald:

Sir—In your yesterday's issue you publish an important letter from Mr. James B. Campbell on the grain transportation question, and the loss of this trade to Montreal, which is directly due to the fact that a project that would place us in such a favorable position for the transport of the grain of the West that we would be entirely indifferent in our lake and canal trade whether the Americans granted us reciprocity in freights or not; for, after all, it is merely a wise selfishness on their part that has brought about the conditions referred to by Mr. Campbell.

Under existing circumstances we can hardly expect any amelioration, for the Americans will not permit our vessels to participate in carrying any of their internal traffic, either by lake or canal, and it would be simply ruinous to Canadian shipping to allow them to monopolize the whole of their own carrying trade, to participate in the smaller volume of trade open to our own vessels. So that unless we are willing to sacrifice the interests of our own vessel owners, which we are hardly prepared to do, we must, of course, submit to the unsatisfactory conditions now existing.

The project above referred to which would entirely relieve us from any concern in such matters is of course that of the Montreal, Ottawa and Huron Canal constructed suitably for the use of large barges, a project of almost vital importance to the shipping trade of Montreal. To all intelligent people outside of the city of Montreal the importance of the early construction of this canal, which would at once make us independent of the world, is so obvious, that the subject is never discussed, but one is asked why it is that the people of Montreal, who are so immediately interested, make no move in a matter of such supreme moment to the existence of this city as an important shipping port. But to recognize what little concern our people give themselves on matters in which their interests are directly involved one has only to consider the indifference manifested by them when, with hardly a word of protest, they saw our pine forests of the Georgian Bay District, our last immediately available pine resin, rushed away almost bodily to supply the mills, railways and vessels of Michigan, that should give employment to our own mills, railways and shipping. An indifference that will soon cause them to regret the loss of a trade that was naturally their own.

Had this canal been built, so soon as it was found practicable, we should have received millions of dollars that would have completed it, which have been virtually thrown away in the enlargement of the Welland and other canals, which became almost useless so soon as the States of Ohio, Michigan and Illinois ceased to grow wheat in excess of domestic requirements; and we would not

Instead of this the vastly superior route proposed by the late Hon. John Young from Montreal via the Champlain Canal to New York would have been constructed years ago by the people of New York in their own interest.

The construction of the Montreal, Ottawa and Huron Canal, suitable for large barges, the only class of vessels adapted for canal traffic, would almost wholly revolutionize the grain traffic from the west by sending it by its natural channel through Canada by way of the safest, shortest, cheapest and altogether best inland navigation that can ever be provided for the transport of the products of the west to the seaboard.

With the construction of this canal, which Montreal in her own interest could well afford to build if it could not otherwise be done, we would be so completely masters of the situation that in order to enjoy its advantages the Americans themselves would be forced to sue for reciprocity in freighting, not only on the lakes but on the American canals; and all such questions as those discussed by Mr. Campbell would be for all time satisfactorily settled.

The Day in Wall Street.

New York, Nov. 16.—The Evening Post in its financial article says: A factor somewhat unusual in our money market is introduced by the shipment of \$1,000,000 gold from London to New York. This shipment has for its consignee an important Anglo-American bank in New York City, and is designed for Government bond subscriptions. The transaction, doubtless a forerunner of others similar in character, is unusual, because sterling exchange rates rule to-day, even on a purely commercial basis, nearer the gold exporting point than to the specie import level, but though unusual, the movement is by no means unprecedented. Sterling exchange stood close to this week's level in 1878, when Secretary Sherman secured from Europe a large part of the gold necessary for resumption. Throughout the last two years Austria's currency conversion plans have repeatedly involved imports of gold from Berlin to Vienna, at times when Austrian exchange was relatively higher than our own existing rates. In all these instances the gold was shipped at a nominal commercial loss. But the shippers, who in each case were subscribers to the new securities, reckoned this loss as an incidental outlay which would be more than covered on the floating of the bonds. The real significance of such transactions as that of the British Bank of North America lies in their plain reflection of confidence in the value of the new securities. The fact that banks in this city are already receiving bids at 1.174 flat for the unsold bonds, show safely enough the local sentiment.

## WORLD-WIDE NEWS

### ENGLAND.

Mrs. Georgina Griffiths, a lady living in a large house at Kingston-on-Thames, and her daughter, Margaret Griffiths, aged sixteen, were remanded on bail at Kingston on the 23rd October, charged with threatening to murder a sheriff's officer. The allegation was that the accused, after ejecting the sheriff's officer and his assistant, had the situation subsequently reversed, but succeeded by a stratagem in entering the house with eight men, when the ladies were overpowered and disarmed.

Lord Rosebery has done nothing so popular since he became Prime Minister as to appoint Mr. Lockwood Solicitor-General. He was sorely tempted to give the post to Mr. Haldane, who was the unofficial legal adviser of the Cabinet in regard to certain constitutional points in the Home Rule Bill, and who is a close friend of Mr. Asquith, but the choice of another member for a Scottish constituency—Sir John Rigby and Sir Robert Reid—had already had their turn—more than the main body of Ministers could stand. Mr. Haldane is, however, next on the list for promotion, though Mr. Cozens-Hardy, Mr. Warrington and Mr. Montagu have their backers for judgeships; and as some of these posts in the course of nature or the pension provisions must fall vacant before long, all the aspirants may yet be satisfied. As for Mr. Lockwood, he is in the perilous position of one of whom all men speak well.

The ceremony in connection with the opening of the Law Courts on the 24th Oct. was for several reasons more interesting than for many previous occasions. The procession of judges from the House of Lords, where they had breakfasted with the Lord Chancellor, embraced the new Lord Chief Justice and the new Lord Justice of Appeal. Lord Russell, who has not followed the example of the late Lord Coleridge and remained absent from the pageants, was accorded a hearty welcome by the crowds of ladies and gentlemen who lined the fine central hall, and no less cordial greeting was extended to Sir John Rigby. The Master of the Rolls who has been longer on the bench than any other judge, though he is the junior in years of Sir Henry Hawkins, was, as usual, greeted with much enthusiasm. The two law officers, Sir Robert Reid and Mr. Lockwood, appearing at the head of the U.C.'s, were at once recognized, and received quite an ovation.

Lord Rosebery has bestowed the Garter, vacant through the death of Earl Grey, on the Marquis of Lansdowne. The appointment is not a political one, for Lord Lansdowne is a Unionist, though not of so rabid a type as some of the other recreants. He owes the honor to his meritorious services, first as Governor-General of Canada, and then as Viceroy of India—services which may be said to give him some of the recognition even at the hands of his political opponents. And there is a certain appropriateness in the honor so long worn by the head of the old Whig house of Grey being given to the head of the house of Lansdowne, so closely associated with Whiggism in its best days.

The Bishop of the Diocesan Conference held at Liverpool on the 30th Oct., said the Welsh Disestablishment, if sanctioned by Parliament and endorsed by a general election, would lead to an attack being made upon the whole body of the Established Church of England afterwards. The bill proposed a most uncalculated and unreasonable destruction of an institution which was doing good work for the cause of Christ, and would be a most serious departure from the great principles of the British Constitution and the recognition of God by the Government of this country. Referring to patriotism, His Lordship said the worst of all reforms, he believed, would be to allow parishes and congregations to elect their own ministers. He regretted that churches were far behind Nonconformists and Roman Catholics in recording their votes at School Board elections.

John Ashkan, the Northamptonshire poet, died at Wellborough, his native place, on the 26th October at the age of 69. He was the author of numerous poems and sonnets, his first volume being published in 1863. A second volume was published in 1866, whilst a few years later came a third entitled "Judith and other Poems," which contained the most ambitious of his compositions. His fourth volume came out in 1875; but after that his productions chiefly appeared in newspapers and periodicals.

Speaking at the annual meetings of the North Cumberland Liberal Association recently at Carlisle, Sir Wilfrid Lawson said he was in pretty good hopes about the future of the Liberal Unionists and Tories, because he saw signs of distinction or dry rot set in among those allies, the Liberal Unionists and the Tories, who had so long stood shoulder to shoulder in the way of progress. The air was clearing, and the Liberal Party could now see their way more clearly every day.

The London Anti-Gambling League have, it is stated, decided to take action at the coming races. Several courses are open, but it is not yet settled which will be adopted. A memorial was forwarded a few days ago to the Watch Committee asking, in view of the decision of the magistrates last June, to see that the law was not again broken. The reply received is regarded to mean that the police would not interfere; hence the league have decided to act.

A police constable of the M. Division, attached to the station in Upper Grange Road, Bermondsey, is reported to have come into a large fortune. His name was Wm. Taylor. He has been in the police service for seven years, and prior to that served 11 years in the army. The property he has come into is situated at Maidenhead, and is said to be worth over £100,000. It is being acquired by the London County Council, and the Council's solicitors are said to have been instrumental in discovering Taylor's right to it. Taylor has sent in his resignation as a police constable.

An extraordinary scene took place on a recent Sunday night in Seacombe Parish Church, near Lirkehead. A man named Samuel Spicer ran out of his pulpit, jumped on to the altar table, and pulled down a brass cross. Doubling it across his knee, he shouted "No Popery." He was given into custody, and on the following day was remanded to the workhouse for a fortnight, a doctor having certified that he was suffering from religious mania.

Every one will be sorry to hear less favorable accounts of the health of Mr. J. M. Barrie. Mr. Barrie and his bride

were just now to have been the guests of Mr. and Mrs. S. R. Crockett at Penicuik, but that Mr. Barrie's health will affect all compel him to go South. Thereupon these lines appeared, which are ascribed to Stubbs, the historian, now Bishop of Oxford:

While Frroude assures the Scottish youth That persons do not care for truth, 'Tis Reverend Canon Kinsley cries "All history's a pack of lies!"

What cause for judgment so malign? A little thought may solve the mystery: For Frroude thinks Kinsley's a divine, And Kinsley goes to Frroude for history.

Warwick, England, has just chosen the Earl of Warwick to be its mayor for the coming year.

Charles Dickens's Goshill collection of forty-eight tables, decorated with his left by will to the late Edward Yates, was recently sold at Brighton for \$1,150 in an auction sale of Yates's personal effects.

Further excavations made on the site of an Anglo-Saxon cemetery in High Down Hill, near Northampton, in Essex, England, numerous objects of interest have been found. The work itself has been carried out by Mr. C. H. Reed of the British Museum, who regards the find as forming part of the most important of Saxon cemeteries in Sussex. Among the objects in glass, these are a tall wine glass, ornamented with loops of white glass, and another with Greek characters. A number of beads were found with bronze disks, and a child's bauble, something in form like a teething ring. Most of the bodies in the cemetery were buried from east to west. The entire glass collection is said to surpass any in the British Museum of the same period.

Michael Davitt, speaking at Dungarvan on the 28th October, referred to the curious spectacle afforded by Mr. T. W. Russell fighting against Landlordism in Ulster, and Mr. Chamberlain threatening to secede from Lord Salisbury. He urged a determined effort should be made to limit the House of Lords vote.

Mr. John Dillon, M.P., addressed a Nationalist meeting at Mullinahone, County Tipperary on the 28th Oct. He contended that the Government had kept their pledges to the Irish people. He advised the latter to vigorously maintain their organization, and said he hoped the time would soon come when they could take just and reasonable revenge on the House of Lords.

By the death of Father James Healy, the parish priest of Killiney, Ireland has lost her most brilliant wit, and raconteur. He was a welcomed guest even at the viceregal tables, and numbered amongst his personal friends all the viceroys and Chief Secretaries for the past twenty years. Innumerable are the good stories that are told about him; and to show how impartial he was in distributing his favors a few of his political bon-mots are worth quoting. On one occasion Mr. A. J. Balfour, when Chief Secretary, said to him, "Is it true, Father Healy, that the people hate me as much as the Nationalist papers say they do?" "Hate you!" exclaimed the priest. "If the people hated the devil as much as they hate you, Mr. Balfour, my occupation would be gone."

A bridge on the Dundalk and Greenero Railway, near Omagh, was swept away by a flood recently. The traffic was stopped, and passengers went by the English boat round by Dundalk. During the heavy rainstorm and floods which occurred at Omagh, near Newry, recently, a woman named Mrs. Langhans and her sister were swept away, and the latter was drowned. Other people had a narrow escape, their houses being flooded and walls carried away. A second bridge on the Greenero Railway was carried away by mountain torrents, which did great damage.

The first conference of the British Iron Trade Association ever held out of London was held in Glasgow recently. Mr. Jacks, M.P., presided, and in his address referred to the period of depression recently encountered. The causes of that depression were mainly greater foreign competition, increased cost of labor, unhappy disputes between labor and capital, and high railway rates. With reference to the question of the eight-hour day, he said that all right-thinking men desired to see workmen employed under the best possible conditions; but, having regard to the keenness of competition, the limitation in question could only bring further disaster, and prove fatal alike to employer and employed.

The Customs revenue at Scottish ports for the past month shows a substantial advance all over. At Glasgow, with a collection of £153,033, the increase is £8,656 as compared with the corresponding month; at Leith, with £76,929, the increase is £9,919; at Granton, with £11,978, the increase is £1,301.

A shocking affair occurred early on the 20th Oct., near Carlisle in the night Scottish express from Euston to Aberdeen. In one of the compartments of a third-class carriage were seated Private Johns, of the Border Regiment, stationed at Carlisle, and Mrs. Sutherland, of Pitlochry, Perthshire, who had with her a young child. These had occupied the compartment together from Euston, but Mrs. Sutherland and the soldier did not know each other. While the train was running between Preston and Slap Mrs. Sutherland went to sleep, but she awoke as the express was approaching Fenrit, and was horrified to see blood streaming over the floor of the carriage. She saw that the soldier had cut his throat, and she commenced to shout and batter the wall of the compartment. By this means the attention of a medical gentleman who happened to be in the compartment was attracted, and he pulled the communication cord, and the train was stopped. On the arrival of the train at Carlisle he was taken to the Castle Hospital, and he will probably recover.

THE BRITISH COLONIES.

Mr. Seymour Allen, a resident of Sydney, S. Australia, has invented a submarine torpedo boat capable of sinking to any depth and travelling under

water as quickly as on the surface, without revealing its presence. A working model of the boat was tried in the Public Baths at Melbourne in presence of Lord Hopetoun, the Naval Commandant, and a number of naval and military officers. The experiments were a complete success, the model rising or sinking, steered or low turning, reversing or remaining stationary, in obedience to the electric current by which it is worked. The inventor claims that a submersible boat would be capable of remaining under water three days, and would carry torpedoes on the bow and stern decks. When fired the projectiles would be magnetically attracted to the bottom of the enemy's ships. The Admiral commanding the station, who inspected the boat at Sydney, declared that if a vessel would do what the model performed it would revolutionize naval warfare.

The Cape Town Highlanders have resolved to send a regimental team to compete at Bixley next year.

FOREIGN.

The Italian Government is keeping a sharp lookout on all ancient pictures, bronzes, missals, priests' robes, etc., which are in the churches, as these are well as the religious treasures, are now national property. Don Massimo Kesi, a priest in the Church of Ognissanti, has just been condemned to two years' imprisonment for having sold out of his church articles of the above class.

Dr. Wilhelm Koerner, professor at the Royal Academy of War in Berlin, writes the following interesting article on the new national property. It is the old Russian, or even Slavic, term for King, but has, in this meaning, been superseded by the word 'Korol' (pronounced Karol), which draws its origin from Karl, viz., Charles the Great. The Hungarian word 'Kiraly', meaning King, has the same origin. 'Tsar' now means in Russian (1) a king of ancient history—Xerxes, Lycurgus, Pharaoh, etc.; (2) a king of fact, fairy tale, etc.; (3) some of the dispossessed Russo-Asiatic princes; (4) a rather colloquial expression for the Russian Emperor. His consort is called 'Tsaritsa', a son of his, in the same popular language 'Tsarevich', a daughter 'Tsarevna'. But the official words are 'Imperator', Emperor, 'Imperatrix', Empress, their children are called 'Veliki Kniaz' (meaning Great Prince), and 'Velikaja Kniazna' (Great Princess). When Peter the Great returned to his new capital in triumph, after defeating Charles the Twelfth of Sweden, he was hailed by the Metropolitan with the title of Emperor, since that time the word 'Tsar', till then the only name denoting the rulers of Russia, is no longer their official title. In some Congress (if I am not mistaken it was that of Vienna), it had been expressly stipulated that though the Russian Sovereigns had the official title of Emperors, they were not to have the precedence of the Kings of Western Europe.

A very large collection of papyrus documents, running into hundreds, has come into the possession of the Royal Museum of Berlin. They are in Greek, and relate not alone to the private and legal details of Greek life, but there is a series of documents on the Hlad. Among the literary papyri, it is reported that there is a parody on the Hlad, a commentary on the Oration of Demosthenes, and an entire romance, which is believed to be the oldest example of Greek romance literature. If all are not of remote antiquity, at least the collection promises to give us a thorough insight into Greece in the first century after Christ.

The Wiener Extrablatt gives particulars as to the death of the opera singer Joseph Haydn which has recently become known up to this time. A Viennese musical writer found it in the archives of Prince Esterhazy, at Eisenstadt. The work is said to contain decided musical excellences, founded on a delicate dramatic idea. The humor and character of Haydn's work has been developed by the writer, and will doubtless be presented in an effective style. Pohl, in his biography of Haydn, has not mentioned this opera; it was spoken of, however, in contemporary writings. The Viennese will very probably have occasion to listen to this one-act opera this season.

A Frenchwoman, Marguerite Bouvenval, who fell into a state of catatony on May 25, 1892, is said to be still alive and asleep. Her parents refuse to allow her to be transferred to the Salpêtrière. The story would be scarcely credited if not attested by medical authority. Marguerite Bouvenval was delivered of a male child, which died two days after its birth. Suspicion was aroused, and a magistrate, accompanied by two gendarmes, visited the cottage of the Bouvenvals at Themelles, a village near Saint Quentin. The girl's fright was so great that she had a terrible fit of hysteria, followed by catatonic coma, in which condition, notwithstanding the efforts of doctors and electricians, she has remained for more than twelve years. On several occasions she has screamed audibly. She is fed on milk and peptone, and removed once a day from one bed to another.

Serum for the treatment of diphtheria has been obtained so far in France from old back horses. The French Government proposes to give the Pasteur Institute the first choice in the selection of

horses condemned as no longer fit for the French cavalry service, the price to be paid being the average price of the other animals sold.

A clergyman was recently explaining to the Crown Prince of Germany, who is 12 years old now, that all men were sinners, says the Ave Maria, whereupon the little fellow asked him if his father, the Emperor, was not an exception to the rule. "No, he is not," answered the clergyman. "The King is a sinner like every other mortal." "Well, I'm sure of one thing," said the little prince, "and that is that my mother is no sinner."

The Councillor-General of Dun-sur-Meuse (France), who lately died, was a descendant of the famous mayor who arrested Louis XVI. The deceased councillor bore the capery name of Mouton-Sauce.

Dr. J. L. Nevin, who was called as a witness in a Jersey City Court, declined to kiss the bible, having conscientious scruples against taking in any of the bacilli luxuriating in its covers. He was allowed to affirm.

## CURRENT LITERATURE.

### POEMS BY REV. MR. SCOTT.

My Lattice; and other Poems. By Frederick George Scott, author of "The Soul's Quest and other Poems," "Elton Hazlewood," Toronto, William Briggs. It is six years since Mr. Scott published "The Soul's Quest" and became known as a Canadian writer. He now presents us with another sheaf from his harvest. Some of the poems have been seen by us before in the Week and other publications, and some have already found their way into a Canadian anthology. We congratulate Mr. Scott on this being appreciated in the Dominion in which he lives, and wish his new volume published in Toronto all success, for his work shows decided growth. We believe that anyone who reads the first poem in this volume, "My Lattice," will not rest till he has read the others. This poem is simple and clear, the language of it possesses a gem-like transparency, and a liquid nature; it is a beautiful little rivulet of song. It is a vision or meditation of one who looks out through a common place square window into the vast dome of space. The writer has obeyed the injunction of one greater than himself who says:

"Take wings of fancy and ascend And in a moment set thy face Where all the starry heavens of space Are sharpened to a needle's end."

We have in this poem written in the metre of Tennyson's "Brook" a suggestive and beautiful poem, and we recognize our position, as we amongst the infinites and through our thought one to us forcibly and melodiously in these few verses. The same delightful quality of clearness and purity is to be found in "My Lattice" is observable in another short poem in this volume, like the last named, another recent production of the author, namely "In the Woods."

The woods are called God's house, but the poem will bear being quoted entire and our readers can thus judge for themselves: "This is God's house—the blue sky is the ceiling. This wood the soft green carpet for his feet. These hills his stairs, down which the brooks come tumbling. With noisy laughter making earth more sweet. And his friends come, clouds and soft winds sighing. And little birds whose throats pour forth their songs. And spring and summer, and the white snow melting. Penned with shadows of bare boughs above. And the sunbeams through the green leaves stray. And shadows from the storm clouds overcast. And warm lashed nights when mother earth is weeping. So long her morning candle burns till dawn. Sweet home of God, sweet earth so full of pleasure. I cannot say my gates are storm or calm; And every sunbeam is a joy and treasure And every cloud a solace and a balm."

Here we have the commonest materials, but the alchemist has worked these common elements into a lovely crystalline form. Possibly some may think the comparison of the greater to the less in this poem, the continual reference to parts of the house, ceiling, stairs and carpet somewhat of the nature of a conceit. Still it is so, we think it pardonable; the natural flow of the verse carries us away with it and we do not think the quaintness spoils the beauty.

Some of the sonnets call for notice, such as that on "Solomon": "His heart hath drained earth's pleasures to the lees. Hath overreached with life's finest ecstasies; Yet now some power reveals as in a glass. The soul's unrest and death's dark mysteries. Altho' the courts of wisdom and of love Retain their 'Omnia Vanitas.'"

The use of the Latin phrase reminds us of the use in Tennyson's sonnet to W. H. Brookfield of the Greek expression: "Skias omni—dream of a shadow, go God bless you. I shall join you in a day."

Though these classical expressions are foreign to our language, the English phrase is not made stronger by any phrase from another language. "Columbus" and "Idols" are both strong. "Idols" appeared originally in the Mitre, the Colledge magazine of Mr. Scott's Alma Mater, Bishop's College, Lennoxville.

The shorter poems of the volume seem to us more satisfactory than the longer ones. "Samson" is powerfully realistic, almost too much so in the description of the dungeon, which is made so repulsive as to cause us to question its artistic character. It almost reminds us of a picture of Wilkie. "Thor" is in some respects the most ambitious of the poems in this book; its metre is good. In fact, in most cases the form, the versification and metre of Mr. Scott's work are good, his rhymes generally are perfect; though we noted "below" and "mow" once. We know that "love" is a word often required by the poet, and we remember painfully that there are very few rhymes to "love," "dove" and "above" are certainly two; "above" is another, and Mr. Scott has got it in this:

"In his anger each ocean that roars, Each boulder the cataraacts above." Some one to whom this was read said it was "strong"; the reply was "No, that is a Canadian touch; the above is a well known phenomenon of a Canadian spring" but the use of such a word is a commentary on the barrenness in rhymes of our mother tongue. In "Thor" Mr. Scott shows that he can depict passion strongly, and yet without indelicacy. His tone is admirable. This verse is strong and worthy of any writer:

"Not a mere shadow is sin, Clinging like wine to the lip, To be wiped from the mouth and the chin. After man taketh a sip; But a poison that lurketh within."

It is hard to keep up to such a level as this; and in the very next verse after the one just quoted, Mr. Scott drops a little, and is not content to leave us with a strong line. In fact, the end of "Thor" is a little spun out, and rather disappointing.

"The Vision of Prometheus," or anything bearing on the story of that Titanic hero, suggests comparison with some of the greatest names in literature; and this is dangerous for the modern! There is much that is strong and suggestive about Mr. Scott's treatment, but we find some of his verses here somewhat confused, especially the paragraph ending:

"And a wild tempest blows the daylight out. We are inclined to give the pain amongst the longer poems to the invocation of the great ocean, called "In Via Mortis." The atmosphere of this poem recalls that beautiful translation of Longfellow from the German of Salis:

"The mildest herald, by our fate allotted, Beckons, and with inverted torch doth stand To lead us, with a gentle hand, Into the land of the great departed— Into the silent land. Every voice is vigorous and musical. The first verse we will give, and the last line of it is admirable:

"O ye great company of dead that sleep Under the world's green rind, I come to you With warm, soft limbs, with eyes that laugh and weep; For I love, and brain pierced through and through With lightning whose rapid lightnings make my day. To you my life stream courses on its way, Through mists and shallows of the eternal deep. Some pieces in this book may be regarded as experiments in metre such as "Sorrow's

Waking"—rhyming lines of four syllables each. The result is rather a toy than a poem. "Calvary" is a creditable attempt in hexameters: It treats of the most sacred of subjects in a reverent and thoughtful manner.

"Here in the hand of the Crucified, pulses of love in its veins; Human as ours in its touch, with the sinews of Duty bearing. The zones of the pendulous planets, the weight of the winds and the rains." We do not care much for the epithet "pendulous" here, or in fact anywhere. Nor are we sure it is strength to add the less, the winds and rains to the greater planets in speaking of the weight borne; it is tending to an anti-climax. The thought of the poem is however good and suggestive. Mr. Scott is a teacher as well as a singer. While we would say to him in the words of Carlyle, "Produce, Produce," we would also say, "Prune, Prune." We say this in a friendly spirit but because we believe that process will produce richer, fuller fruit. We trust that the Canadian people and other English speakers will read Mr. Scott's book for themselves. He is gaining in breadth and in depth and in sweetness.

A WORK ON CENTRAL AFRICA. Reality vs. Romance in Central Africa. By James Johnston, M.D. Toronto: W. J. Gage Co., Limited. Montreal: W. Drysdale & Co.

This handsome volume whose novel binding, superb illustrations, and beautiful print, prepossesses the reader at the outset, may unhesitatingly be pronounced one of the most important books that has appeared since Livingstone's pen became silent, on that continent whose problem divides human interest with the reaching of the North Pole.

The genesis of the work is worth recounting. The author, a doctor resident in Jamaica, had long cherished a deep interest regarding Africa and her people, and in the year 1890 was enabled to put to the test the theory he had formed, that the mission established on that island, would make the best possible assistants for white missionaries in Africa.

Fitting out an expedition himself, indebted to no government, commercial enterprise, or society for support, responsible to no one for its course or result, untrammelled as to time limitations, and at full liberty to tell the truth as he saw it, he certainly had advantages enjoyed by few of his recent predecessors, save, perhaps, Henry Drummond. And what was his experience?

During a period of twenty months he crossed South Central Africa, travelling 4,500 miles, mostly on foot, in anger, so far as white companionship was concerned, passing through numerous hostile and savage tribes, traversing Africa hitherto reported too pestiferous for exploration, penetrating regions where no white man had ever gone before. In all that long journey, once in an emergency, he himself prompted to fire, shot an angrier, or compelled to do so in self-defence against a human enemy; while he can say what perhaps no other man who has crossed Africa can—that of the many native carriers who travelled with him, he did not lose one by death. He went among the fiercest tribes, not in a conqueror and master, but as a friend, and seeking to leave a trail behind him not of blood and hate, but of peace and good will.

How all this was accomplished we must refer our readers to the book itself to learn, but is not the question a natural and pertinent one? If Dr. Johnston can, without fear of challenge, claim this most remarkable record for himself, what have the Stansleys, the Serpa Pintos, the Scobells, and the other swash-bucklers "of that ilk," to say in defence of their methods of African exploration?

This is one of the interesting problems treated by this book, which is a veritable mine of information, albeit the literary style is somewhat arid and devoid of distinction; and which has many plain things to say about the ways adopted by the British speculative enterprises to boom Mashonaland and other hopelessly valueless regions which have come within the old lion's "sphere of influence."

Dr. Johnston writes frankly, and fearlessly and most informally, and has provided a wealth of illustrations from his own photographs, that adds materially to one's enjoyment of his book, which deserves the widest possible circulation.

THE DEAR OLD LADY IS NO MORE A Charming Character Which is Not Now Recognized in Society.

A picturesque figure is passing out of society, if she has not already passed, says Harper's Bazar. We seldom, in the drawing-room, meet the old lady. At this moment she is to be found chiefly in villages remote from the railway, or, if in town, she is apt to belong to the distinctly poorer classes, and to be engaged in some humble occupation, as, for example, the keeping of an apple-stand, or the selling of newspapers around the ferries or elevated stations. Thus engaged she wears a distinctive dress, almost uniform. MUSICAL MATTERS.

The musical public had a great disappointment this week in the eleventh hour by the cancellation of the Melba concert. High-ho! I wonder if the true reason she did not come will leak out.

Johanna Wagner, niece of the famous Richard, died a few weeks ago at Wurzburg. The lady had an eventful career, and the following summary of it clipped from a recent New York paper will be of interest.

The lady was a singer of six when she appeared as Salome in the "Donauweilchen." She was a prima donna at Dresden when little more than eleven, and at seventeen she created the part of Elisabeth, in Wagner's "Tannhauser." She then went to Berlin, where for many years she was the petted prima donna, having six months' holiday in the year, was a close friend of Meyerbeer, and the protegee of Frederick William IV. and his Queen. In London she was unfortunate, for in 1852 she signed contracts with both Gye and Lumley, and was prevented by injunction from signing for either; while, when she returned in 1856, she was borne down by the superior popularity of Picozzini in "La Traviata"—then the latest of operatic wicks. Five years afterwards she wholly and suddenly lost her voice. With splendid pluck she thereupon turned to the dramatic stage, and was for eleven years chief actress at the Court Theatre, Berlin. On her retirement in 1872, her vocal powers partially returned to her, and she sang small parts of the first production of her uncle Wagner's "Der Ring des Nibelungen," at Baireuth, in 1876. Johanna Wagner had, in her prime, both a contralto and a soprano voice, and it was inherited from her mother, Elise Gollman, whose voice had been one of the most beautiful of three and a quarter octaves.

W. S. Gilbert, Sir Arthur Sullivan's collaborator, has evidently not lost his vein of humor. He was recently thrown into company with three cycling cyclists, and when afterwards asked how he felt, he answered in a demure "Danke." "I feel like a man in a demure." This is certainly turning the tables on the enemy with their own weapons.

I have felt convinced since the beginning of the season that Madame Bouit was worthy of good things, and she has proved this in her interpretation of Mignon. It is, in itself, for unfavorable comparison. I saw the Duff Company attempt grand opera once, and the result was a screeching farce. Yet she, supposed to be a soubrette, to portray the lightest roles of opera bouffe, can cast off the one personality, and appear as an interpreter of serious roles sufficiently well to fill the emotion of the listener with appreciation for the beauty of the role and the talent of the artist.

The production of Mignon was if not ideal, very creditable, and was a great surprise to those who had seen the company in such operas as "La Belle Helene" and "Mlle. Nitouche." Messrs. Girard, Vissiere and Milo were not cast, but the parts were well filled, and the selection was a good one. Mr. Girard certainly cannot play a serious role, and the others did not attempt it, though they perhaps might have been valuable.

Musical Montreal never seems to know its blessings. They have to be inducted into them by the pens of facile scribes before they realize that some organization has arisen or event is about to transpire, worthy to engross their attention.

An instance of this was the opening on Thursday afternoon of last week of the Montreal Symphony Orchestra under Professor Couture. This organization represents the resident professional instrumental talent in the city and it should be the pride of her citizens to foster such an institution in every way possible so that it may become a permanent shelter and food, and that they might have fuel for the cold weather.

Their programme was charming; it contained selections of first-class merit, yet not too profound to be understood by all. Such works as Rubenstein's Ball Costume, the Jubel Overture (Weber), and the Prayer from the Golden Legend, are what every musical soul needs for its recreation and refinement. If patronized, the orchestra will be a great advantage as it will not only introduce new music or familiarize that which should be well known in any musical community, but it will improve the musicians by giving them practice in fine music under a competent conductor who cannot fail to enlarge their experience.

If Montreal does not support this movement it will be guilty of great artistic apathy. I see "Hendrick Hudson" was advertised this week as an "Operatic Extravaganza." The advertisement though the poster would certainly have laid the emphasis on the "extravaganza" element. I remember seeing Corinne years ago in more serious roles of the lighter operas and always regretted her going to the burlesque stage. She has a charming exterior and would have drawn many to her houses by her personality. Her voice does not seem to have been taken proper care of, it was always weak, but it used to be of sweet quality.

The last Riebler concert in London, England, drew a \$5,000 house. Beethoven's Choral Symphony was performed, and the tickets for the forthcoming Wagner Motet concert have been almost all sold in advance. The same is the case with the New York Philharmonic Society under Herr Seidl, where it is said that some of the purchasers had to wait two hours to get at the ticket office and that there is scarcely a good single seat to be got now for the season. Some of our citizens might prick up their ears at this.

The Freidheim recital last Thursday evening was beautiful indeed. The pianist can be counted on the fingers of one hand who have been heard here, with the attributes of force and lucidity that Mr. Freidheim displays as yet, without there is no harshness about his playing, it is purely artistic though it can hardly be said to be of the romantic order. His Chopin selections which put a pianist quickly to the test of every necessary qualification were charmingly rendered and displayed largeness of conception, power to catch the varying expressions of the master's brilliant and erratic moods.

It is undoubtedly in Liszt selections, however, and pieces of that school that he shines brightest. Associated as he was with the Master for so many years 't would be hard if his natural refinement had not reflected some of Liszt's genius. Mr. Freidheim is a modest, retiring gentleman and does not speak much of himself or his art. He is more practical than plausible and it is hard to draw from him the record of the artistic moments of triumph he has had although they have been many. He has been before the public since 1869 and from

1878 to 1896 was continually associated with Liszt who was kind to him in the days of his obscurity (a record which many other living musicians can also call up). He travelled with him, lived for some time in his house doing musical work such as transcribing, orchestration, etc. Mr. Freidheim produced a concerto of his own composition which was played with the Damosch orchestra last spring with good success. He is about to start work on an opera.

which rightfully belongs to one of its chief characters, Wm. Shakespeare, (who is impersonated by Wm. Shakespeare Hart.) Rhea's Queen Bess is every inch a Queen; but while she bears herself with royal dignity; she also proves to be a true woman, by seeking to inspire Shakespeare with higher aims and worthier thoughts than come from loom companionship with tavern associates.

This most interesting theatrical news this week, as far as Montreal and Toronto is concerned, is the attempt in the latter city to convict a manager and bill poster of having put upon the walls "obscene" pictures. The "obscene pictures," I might mention, were those of a burlesque show, and were in all probability of the same character as those which have been upon the walls of this city during the past week. I do not want to argue on the merits of the Toronto conviction (if the plaintiff wins). The point I would rather make is that it would be better all round for the profession if a conviction were to be secured every time the litographs of a show do not give a fair representation of the performance.

Francis Olney will star season of 1895-96. Will her backer and manager please accept my sincere sympathy.

Col. John A. McCull, the well-known comic opera manager, died Nov. 12th, at his home in Greensboro, N.C., from paralysis. The deceased was born in Scotland, forty nine years ago, and was brought to this country by his parents when an infant. The family settled in Virginia, and at the breaking out of the Civil War, being then sixteen years of age, he enlisted in the Confederate army and rose to the rank of colonel. In 1873 he was elected a member of the Virginia Legislature, and was in the Assembly Hall at the time of its collapse, when so many lives were lost. In 1879 Col. McCull located in Baltimore, Md., and after practicing law for a few months he went into the theatrical business; he was one of America's pioneer managers of comic opera, and no man ever introduced more operas or brought out more stars than he. Among those who were first brought into prominent notice under his management may be named Marion Manola, Lilly Post, Marie Jansen, Annie Myers, Bertha Ricci, Jennie Reiffart, Mathilde Cottrelle, Francis Wilson, De Wolfe Hopper, Digby Bell, Harry McDonough, Sig. Perugini, and the late Eugene Oudin. Some of the operas produced by Col. McCull are "The Queen's Lace Handkerchief," "The Merry War," "Prince Methusalem," "The Princess Trechonda," "Falka," "Apajune," "The Black Hussar," "Belshazzar," "Cagliostro," "The Lady and the Tiger," "Die Fiedermaus," "The Beggar Student," "Desire," "Indiana," and "Josephine sold by her Sisters." Besides these he had produced up to the time of his retirement almost the entire series of Gilbert and Sullivan's operas. In 1890 Col. McCull was interested with James Barton Key in the production of "The Pirates of Penzance," at the Fifth Avenue Theatre, this city, and afterwards formed a partnership with Emily Melville. The McCull Opera Co. soon took its place in the front rank and for ten years under his management continued to be one of the most popular organizations of its kind. For a number of years the South Broad Street Theatre, Philadelphia, Pa., was conducted by him as the home house of his company. About six years ago, while stopping in Chicago, Ill., Col. McCull fell on the ice and shortly afterwards he was stricken with paralysis, when he was removed to the home of his sister-in-law, in Greensboro, where he lay up to the time of his death. On Feb. 11th, 1892, in this city and Chicago, and 18 in Philadelphia, benefits were tendered to the afflicted impresario, which netted him over \$10,000. He leaves three daughters Winifred and Angela, who are members of Richard Mansfield's Co., and Margaret, who is attending school.

It is announced that Manager John H. Russell is suffering from a serious attack of nervous prostration and will be taken to a sanitarium for treatment. The close application to business and business reverses are said to be the causes of his breaking down. Russell's comedies were produced Nov. 11, in Philadelphia, Pa.

A despatch has been received announcing that Mr. Russell's stage career is over, but a later wire denies this.

The coming production of "Gordon's Relief" for the benefit of the Free Coal Fund is going to be a big success. I attended rehearsal on Thursday night, and though it was practically the first, I saw evidences of such a hit as Montreal amateurs have not heretofore known. Of course the fact that Edwin Varney is doing the drilling and will also play the part of the Greek villain will take some of the amateurish tint from it. There are three or four others, too, in the cast who have been here before and know the business pretty well. Apart altogether from the object of the effort the performance will, I think, be well worth attending.

"A. A. M." asks if Charles Dickens ever played at the Theatre Royal. He bets a supper that he did not.

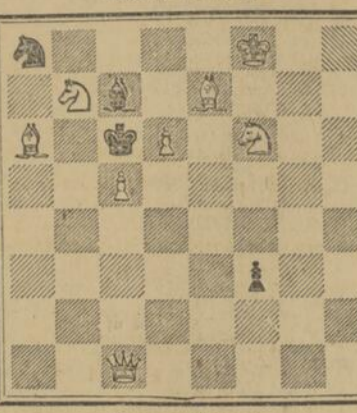
"A. A. M." loses the supper. Dickens certainly did play at the Royal.

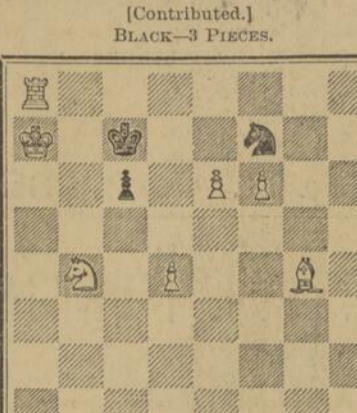

(b) White's last two moves are not to be commended, as they make it necessary to exchange B for Kt.

(c) Black should have retaken with the Kt, and not given the opponent opportunities to equalize the value of forces.

(d) Evidently availing himself of the adversary's omission to exchange that bishop, Black's game is manifestly superior.

(e) Apparently a mistake, which at least costs a pawn.

(f) Worse still, for he is now liable to the loss of a clear piece by the answer B—4.

(g) Black overlooks the right continuation, and is satisfied with a gain of a pawn, instead of winning a piece, as pointed out in the previous note.

(h) It lined now and, in fact, compromising. He should have played first Q R—4, threatening to again win a piece by exchanging rooks subsequently.
