To the Editor of The Herald: The Grand Trunk Boating Club had a meeting last evening which was attended with serious consequences to the club. It appears that one of the members requested a boat house to be built for him, and when this was done, refused to take it, having made some joint stock arrangement with another member owning a boat house, the precise nature of which was not ascertained, but which was unsatisfactory to the committee, who suspended him for violation of the rules in not acquiescing in the club. As he persisted in giving trouble, the committee desired to expel him altogether, and that was the chief object of the meeting, which was only attended by nineteen members. The majority were in favor of his expulsion, but not the necessary two-thirds vote, and the members passed such resolutions and expressed such opinions on the action of the committee, that Messrs. Michael, secretary, Dutton, treasurer, and Stewart, a member of the committee, resigned. Whatever the opinions of the members could have been it was an exceedingly rash proceeding to proceed to such a step, and to do so, when the man, who, whatever his stand may have been from a strictly legal point of view, was not acting fairly with the club. Not the history of the club has such a serious loss happened as this, following the action of the members in not sustaining the voice of the committee in suspending a member who had violated the rules and set the management at defiance. The resignation of Mr. Michael, hon. secretary, is extremely regrettable. He was accepted unanimously to that position, and has had much experience, and in this gentleman the club had one of the best and most valuable officers of any aquatic organization in the Dominion. All who have had transactions with him cannot but say he was always ready to assist them in any way in his power. His frank business-like principles and keen judgment at times when most needed, have proven his worth. The resignation of the other two officers is also very serious, and it will be difficult to replace them with equally hardworking and energetic officers. The resignations by a unanimous vote, were not accepted, but the officers were determined in the action they had taken, inasmuch as they could not remain as representatives of the management when they, as was proven by the vote on the point at issue, were shown that they did not enjoy the fullest confidence of the club. My recommendation is to have a hearing of the case and carry out the constitution to the letter, doing justice to every member, friend, or stranger. The success of the club depends upon the management being supported, and the club will find it difficult to proceed without these officers, followed as they will surely be by "ours truly." A MEMBER. BRIEFS. The Allan S.S. Austrian, from Glasgow via Halifax, arrived at Boston at 6 p.m. on Wednesday. A new mansard roof is being placed on the Notre Dame Hospital, in order that the accommodation may be increased. The inspectors to Sharpe's Express Company have decided to call for tenders for the winding up of the estate, which will be received until the 28th of July instant. It appears the Montreal pilots have had more work this season than they could comfortably and satisfactorily get through. Their number will shortly be increased. Philip Schneider, who was arrested on Wednesday at Chateaugay by Detective Carpenter, on a charge of robbery, was before the Police Magistrate this morning and remanded. Sergeant Baignet and Constable Beaudry confiscated 78 loaves of bread last night, belonging to Max Belanger, baker, of 594 Papineau road. They were not of the required weight. Some days ago the residence of Lucy Johnston was raided, a number of pills arrested and liquor found on the premises. Lucy has been fined \$100, and the others \$25 each. The liquor case will be heard on August 2nd. Mr. C. Desmarquet has been named curator of the insolvent estate of Mr. William Daoust, trader, while Messrs. Robitaille & Lefebvre received the appointment by the Hon. Judge Mathieu, of inspectors of the estate. Workmen clearing away the sugar refinery fire debris found another lot of charred human bones yesterday morning. They were placed in a barrel and taken to the morgue. They will be interred in the Mount Royal Cemetery. The new staples of the Montreal Street Railway are completed, and have been occupied since last Saturday. There are 400 staples, and the staples are claimed to be the most perfect on the continent. A blacksmith and a harness shop are to be erected on the premises formerly occupied by the old stables on Cote and Vitre streets, and the rest of the land will be used as yards. RA RAILWAY'S RESPONSIBILITY FOR PASSENGERS' BAGGAGE. Judgment has been given in the case of Bates and the Canadian Pacific Railway Company, setting aside plaintiff's verdict for \$1,077, and dismissing the action with costs. The plaintiff, Miss Bates, of Ottawa, sued to recover for a quantity of personal baggage lost through the alleged negligent construction of the company's road, whereby a train on which she was passenger was wrecked from the track. The case was tried at Ottawa and plaintiff recovered a verdict which is now set aside, on the ground that she had accepted a ticket, the conditions of which were that the company should only be responsible for baggage to the extent of \$100. The court, in concluding its argument, maintained that a passenger on board of a train should always be very careful as to what kind and class of tickets they assume, and otherwise there was no ground for action.

A PROVINCIAL BOARD OF HEALTH.—It is stated that a Provincial Board of Health will be shortly appointed from the Medical Council of Montreal and Quebec to deal with all matters affecting the Province in this respect. Matters which have recently been brought prominently forward by the press will also be dealt with. Mr. Gervais explains that what he has done has been done under the best legal advice; that he is contesting the *capias* under the same advice; and that he is not afraid to appeal to the law to justify his course. DYKE MATTERS.—The City Surveyor and Assistant City Attorney had a conference with the Mayor yesterday in reference to the levee at Point St. Charles. It was intended to have a conference with the directors of the proposed scheme, but as Mr. G. A. Drummond was absent from town the meeting could not be held. His Worship has, however, called a meeting of the Flood Committee for this morning at ten o'clock when, it is said, he will offer propositions that will likely result in a final arrangement with the Mayor regarding the dyke. The representatives of the scheme will be present at the meeting. NEW LAW BOOKS.—The members of the Bar will be pleased to hear that a large consignment of French law books has just been received. Among them are works of the leading French authors. The "Dictionnaire de droit commercial," in six volumes, by J. Ruben de Couder, and the "Manuel des lois du batiment," in five volumes, are among the lot. Ger works that have also been received are the "Precis de l'economie politique," in two volumes, by Paul Carrieries; "Precis de droit civil," three volumes, by G. Beaudry La Cauteris; and the "Repertoire general du droit francais," in five volumes. HORRIBLE FIRE.—An evening contemporary has the following—"A gentleman with the best opportunities to obtain information on this matter states that recently in the midst of the produce brought to St. Lawrence market by a French Canadian farmer, two baskets covered with white cloths and which were thought to contain eggs, were found, upon examination, to hold the bodies of four dead children, which were to be brought during the day to the nuns—a practice which he and many others, the farmer admitted, were in the habit of pursuing, as one journey served a double purpose. EXPLOSIONS.—For some time past the law of expropriations has been discussed in public and in private and in some of the French papers. M. Maurice Turneau, an advocate of France, has published a series of letters, the result of the close study which he has made of the subject. Naturally the subject has attracted the attention of other writers, and in a recent number of L'Etendard appeared a correspondence signed by several proprietors in the course of which the author said that at the head of the law of expropriation should be inscribed this principle: "The costs and expenses of expropriations are levied upon the public." It is a veritable mockery to impose upon certain proprietors who have already to bear all the annoyances of expropriations, the costs of such expropriations. On the contrary, it is but natural that the costs of the improvement of a town be borne by the whole community. Beside this great principle we ascribe a second, which is dictated by the respect we owe to the sacred and inviolable rights of proprietors. An expropriation cannot take place except upon the recognition of its public utility legally recognized and admitted by two-thirds of the expropriation proprietors."

Lacrosse was being pushed with considerable energy in Yorkshire, one of the results being the establishment of a flag competition open to the county. Harrogate and Leeds were drawn together in the first round, and played one drawn match on Saturday last. On Monday the clubs met again on the Spray, Harrogate. After the match had lasted about nine minutes, the ball was thrown up from the Leeds goal, and the struggle ended in favor of a Leeds player, who turned round and made an attempt to kick the ball to the other end. C. Trees, of Harrogate, who is a prominent Yorkshire player, and was elected on the reserve of the English team v. Ireland, endeavored to stop the ball, but missed it with his crosse. The ball, which was of course, travelling at great speed, struck him just below the ribs on the left side, and a feeling of helplessness at once came over him, he barely having strength enough to pass the ball feebly to a fellow player, when he sank to the ground—dead. All that could be done was done, but the shock had been too great for a heart that had previously been affected. From what we can gather, the ball, although a "standard" one as to size and weight, was of the compact description with which the market is now being supplied, and which, we have no hesitation in saying, are unsafe for match play.
