**SINN FEIN M.P.'S  
MANY ESCAPES**

Robert Barton Tried Before Court Martial—Nine Prisoners Released

Dublin, Feb. 12.—Robert Barton, Sinn Fein member of the House of Commons, who was arrested last March, escaped from the Mount Joy jail, was re-arrested and again escaped, only to be recaptured recently and tried today before court martial.

The charge against Barton was that at Shillelagh in February 1919 he delivered a speech in which, referring to the imprisonment of the local Sinn Fein Fleming he said: "I do not make a threat, but if Fleming dies in jail there will be reprisals against Lord French (Viscount French, Lord-Lieutenant of Ireland) and Frank Brooke (Member of the Viceroy's advisory council) who will suffer injuries as he did."

It is alleged that he repeated the same threat at Carnest. The court reserved decision. Barton offered no defence.

A report was in circulation after the trial that Barton had been released. This proved to be incorrect. Raiders intended to effect the release of the prisoner but attacked the wrong car and Barton was carried to jail and locked up.

**Nine Released**

Nine Sinn Feiners arrested in November last during a raid on the offices of the Sinn Fein "parliament," were released from the Bridewell Prison today. They included John O'Mahony, John Hayes and Frank Lawless, Sinn Fein members of the British House of Commons. O'Mahony, speaking on behalf of himself and the other prisoners at the trial which resulted in the Sinn Feiners being sentenced to two months' imprisonment, claimed that the court had no legitimate jurisdiction.

**Lord Mayor Elect.**

The King's Bench division court here today refused to grant an order for the release of the Lord Mayor-elect of Dublin, Alderman Tom Kelly, who is in Wormwood Scrubs Prison.

The refusal was on the ground that the speaker is out of the jurisdiction of the court.

London, Feb. 12.—Ian MacPherson, the Secretary for Ireland, was asked in the House of Commons today why Alderman Tom Kelly, Lord Mayor-elect of Dublin had been sent to prison.

Mr. MacPherson replied that Kelly had been arrested and deported under the Defence of the Realm regulations because he had been suspected of having acted in a manner prejudicial to the public interests.

A dispatch to the Evening Globe from Dublin says that the prisoner, rescued by the raiders in Berkeley Street in that city, was Robert Barton whose trial took place during the day and who was being returned to Mount Joy Prison after the court martial hearing.

**INFLUENZA IS  
STILL SPREADING  
THROUGH ONTARIO**

Thought the Peak Has Been Almost Reached in Many Places

**NOT SO MANY DEATHS**

Toronto is Suffering From Death of Volunteer Workers, Hastings Says

Toronto, February 12.—Influenza continues to spread throughout the Province of Ontario, but it is thought that the peak has been almost reached in many places and that next week may see a slight reduction in the number of cases. While the disease appears not to have abated, there are not quite so many deaths from influenza and pneumonia in proportion to the number of cases as was the case a few days ago. In Toronto twenty-five deaths were reported today as directly due to the epidemic. Yesterday there were forty-two deaths therefrom. Sixteen deaths were recorded today from influenza direct, and nine from pneumonia.

There is a serious dearth of help for new cases in Toronto and earnest appeals from the medical officer of health here, Dr. J. O. Hastings, has not been without effect. Volunteers have been asked for through the press two or three times within the past week and a registration bureau for the purpose has been established, but only a few volunteer nurses have put in an appearance.

In a report published today Dr. Hastings made the following scathing criticisms in this connection: "Probably the most appalling feature in connection with the present epidemic and the one that reflects most upon the people of the so-called 'Christian Toronto,' the City of Churches, is the fact that in a city of half a million people there can be found not a handful that are willing to come forward and register for volunteer service to their fellow-citizens who are in dire need and dire distress."

The Canadian Press correspondent at Cobalt wired tonight that the influenza situation there was serious. Chairman J. E. Holette, of the Committee appointed to Cobalt to fight the epidemic, this evening offered an emergency hospital opened to handle the steadily increasing number of cases.

In Brantford the influenza situation was reported as having improved today. A special meeting of the local board of health was held tonight to further deal with the epidemic. Two cases were admitted to temporary accommodation and the Board decided to convert the old Post Office into an emergency hospital.

Hamilton reported the total number of influenza cases to date as 273, an increase of 141 since yesterday. Twenty-one deaths have occurred from influenza in Hamilton so far.

St. Catharines is one of the few places in Ontario that has not yet reported any influenza cases.

Washington, D.C., Feb. 12.—The mortality rate due to the influenza epidemic this year was about half of that in 1918, said a statement today by the Public Health Service, announcing that the present epidemic apparently had reached its peak.

"A comparison," the statement said, "of the excess mortality rate per 100,000 of population for the respective peak weeks of 1920 and 1918 shows: Chicago, 1,585, compared with 4,629; Milwaukee, 1,434, compared with 4,012; Washington, 2,072, as compared with 9,789. These rates may be taken as a fair indication of conditions throughout the country. With the exception of some cities in Massachusetts and New York state, exclusive of New York City, practically all of the reports indicate a decline."

**MACKENZIE KING  
SPOKE TO OTTAWA  
RETAIL GROCERS**

Urges Downward Tariff Revision on Foodstuffs and Machinery

**GREATER PRODUCTION**

Energetic Campaign Needed to Get People Back to the Land

Ottawa, Ont., Feb. 12.—(By Canadian Press)—An immediate downward revision of the tariff on foodstuffs as well as on machinery to bring about greater production within Canada, together with an energetic campaign to get people back to the land featured the address of the Hon. W. L. Mackenzie King, Leader of the Liberal Party, to the Ottawa Retail Grocers at their annual banquet here tonight. Any revision of the tariff, however, Mr. King declared, must be carried out with the interest of all sections of the community in view. Only in that way could the present unduly high cost of living situation be overcome.

Anything artificial at present restricting the supply of the principal articles of food should be immediately removed. This brings us inevitably to a consideration of the tariff.

Mr. King's own conviction is that it is possible so as to reform the tariff as not only to diminish the high cost of living in a manner which would immediately benefit consumers, but also to reduce the cost of the instruments of production generally and so help agriculture and all the other industries based upon the natural resources of Canada.

In these words, Hon. Mr. Mackenzie-King outlined his cure for the present high cost of living.

"As the basic industries thrive," Mr. King continued, "all our other industries will thrive; all our interests, whether of agriculture, manufactures, commerce or transportation. Any revision of the tariff which fails to keep all these interests steadily in view would not be in the national interest. It is obvious, however, that such can be done through tariff revision by way of reducing the high cost of living, which will prove to the benefit of one and all; and foremost in this connection is any well considered step which will increase the supply of food to dwellers in towns and country alike."

Such expedients as boards of commerce were mere pretense of an endeavor to regulate prices in a manner which would benefit consumers generally.

Mr. King declared, however, useful investigating bodies of that kind might prove in helping to check individual abuses here and there. He likened the efforts of the Board of Commerce to those of the man who sought to consume the forests by shooting woodpeckers.

People living and working on the land were the greatest need of Canada and the whole world today. Instead of rural development having been fostered by the policies pursued during the last few years, the tendency appeared to have been entirely the other way.

In all parts of Canada the number of consumers demanding food in urban centres had steadily increased, while the number of persons producing food had relatively steadily declined.

Immigration was necessary to people Canada's unoccupied areas, but it was necessary to remember what the drain of war had meant to

**SAMSON REPLIES TO CHARGES  
MADE AGAINST HIM BY MAYOR  
LAVIGUEUR WEDNESDAY NIGHT**

Mayorality Candidate Addresses Large Audience at Classic Theatre—Several Statements Issued for Publication, Replying to Accusations—Samson Issues Challenge to His Worship the Mayor

Mr. Jos. Samson, candidate for the Mayorality, held a meeting in the Classic Theatre last evening, and the theatre, which has a capacity of about seven hundred people, was packed with enthusiastic listeners, who cheered the various speakers as they each spoke to the audience.

At the beginning of the meeting, Messrs. Leclerc and Lockwell were made Joint Chairmen, and the first named was the initial speaker to deliver an oration. He spoke for about fifteen minutes, and his remarks were all cheered to the echo. Among other things, he stated that Mr. Samson challenged His Worship the Mayor to prove all or any of the charges that have been made against him by the Mayor, and said that Mr. Samson would give \$1,000 to the poor of Quebec if any of the accusations that have been made against him were true, but that if none of them were proved, then the Mayor would pay \$1,000 himself to the poor of the city.

Mr. Dionne, who was the next to speak, said that he had no experience in municipal affairs. He was no representative of anyone, and had no interest in the City Hall, but came to speak as a simple citizen, to express his opinion of the Lavigueur regime.

The first question was if Lavigueur had carried out his duties as the First Magistrate of the City. His conviction was formed that he had not carried out his duties in a dignified or honorable manner. Lavigueur said in 1917 the tax toll of Quebec was lower than that of any other city in Canada. The speaker stated that Mr. Samson was a self-made man, that he had built a magnificent industry, and that if the Palais is what it is today, it is thanks to Samson.

Mr. Samson was next to speak. He addressed the audience in English, and said that he was unable to make an address in English, at the same time requesting permission to continue his speech in French.

The Mayorality candidate said that the City should be administered on the basis of a business house, with some system of order, and that defects should be wiped out. All branches that were not paying should be eliminated.

A question that had been asked for a long time is why Quebec has not advanced like other cities. The reason was that a thing that was never counted upon was the citizen's initiative. If Quebec was to be developed, the Mayor and Aldermen should concern the citizens.

Development was necessary. The steamers do not stop at Quebec enough. The city should also get its share of the Western trade.

An offer had been made by the Federal Government to furnish money to the city to build sanitary houses, and the city should take advantage of the offer. The question of the school tax was also touched upon by the speaker, and he said that he thought that the work of the School Commissions was conducted with too much expense. The speaker said that he thought that a School Commission could be formed which would do the work of the present Commissions with less expense.

In relation to the abattoir question, the Mayorality candidate said that he defied any one to come forth and prove that he helped the abattoir company in any form. He had always fought against the abattoir company because he thought that it was not a serious help to the city.

He then read a letter from Mr. Thomas Vien, stating that Mr. Samson had never been connected with the abattoir company, and issued a challenge to the Mayor.

He next touched upon the question of the property bought in 1315 of Mr. G. Madden, and said that he had purchased it and learnt later that des Prairies street was to be opened. He asked Mr. Drouin, who was Mayor at the time, if the street was to be opened, and the latter

answered in the affirmative. Mr. Samson dwelt at length on the subject of the purchase by the city of the land in the Palais, and said that Mr. Lavigueur had said that the city would have to buy land from Boswell's Brewery for \$150,000.

The land in question belonged to the Corporation, and Boswell's Brewery paid \$140 per year for it. The contract between them and the corporation was signed in 1882.

Mr. Samson went to dwell on various subjects, and terminated by saying that he was in the fight to help the city, to place it on a business basis and to diminish taxes.

Mr. Monaghan was the next to take the floor, and made a very able speech, stating that in 1911 and 1912 the city had expended a great deal of money, and that Quebec progressed, as everyone knows. The great trouble in Quebec, continued the speaker is that we do not exercise individual effort.

Mr. Leclerc, who was the next speaker, expressed himself as strongly against the tenant's tax and produced an affidavit, which is reproduced below, showing the injustices of this tax.

Alderman Fiset then took the platform. He stated that he had been attacked by the Mayor the other day but that he would be pleased to meet Mr. Lavigueur face to face, and to that end, invited him to meet him at St. Roch, St. Sauveur or Upper Town.

The Mayor had said that Fiset circulated a report that he was not looking after the interests of the city. The speaker stated that he had never said that. Mr. Lavigueur stated that he never missed a Council meeting. He could not, said Dr. Fiset, as his presence was always necessary before a meeting could be held.

Doctor Fiset was in fine form, and went on to dwell on various facts and items, concluding that the city wanted a business man at their head and that in his opinion Mr. Samson was the right man in the right place.

Mr. Belanger was the last orator to be heard, and during the course of a very eloquent speech, said that Mr. Lavigueur was Mayor simply for the honor that was in it, and liked to go round in an auto, with a silk hat on his head, to be admired by all the ladies on the sidewalk. He concluded by asking all present to vote for Mr. Samson.

**TENDERS RESIGATION  
TO SECRETARY DANIELS**

Washington, D.C., Feb. 12.—Commander Thomas Mott Osborne, commandant of the Portsmouth, N.H., naval station, has tendered his resignation from the naval reserve force and asked Secretary Daniels to accept it as soon as his successor at Portsmouth can be chosen.

Naval officials said Commander Osborne's resignation had no connection with charges of immorality among inmates at the prison submitted by agents of the department of justice several months ago. They said he first presented his resignation some time before the charges were made, but later withdrew it.

**ST. LAWRENCE  
DEVELOPMENT**

Internat'l. Joint Commission in Session Claim Project Would Cost \$250,000,000

New York, N.Y., Feb. 12.—Development of the St. Lawrence River between Montreal and Lake Ontario, which is being considered by the International Joint Commission on Waterways in session here, probably would cost more than \$250,000,000, Obadiah Gardner, former United States Senator for Maine and Chairman of the American section of the Commission, said today.

Making that part of the river navigable for deep draught ocean steamers would cost more than \$50,000,000 and development of unused water power—about 2,000,000 horsepower—would cost about \$200,000,000, according to rough estimates reported to Mr. Gardner.

Consideration of the St. Lawrence development includes a programme of commission hearings during April and May at "interested localities" on both sides of the boundary. Mr. Gardner said: A preliminary meeting in about four weeks at "some central point like Buffalo" probably will be called he added. Engineering surveys of the St. Lawrence by Government engineers will begin in the Spring.

The Commission devoted today to deciding on the best way to carry into effect its recommendations of last year to stop pollution of international streams at Detroit and Buffalo.

Consensus of opinion was said to favor drafting of a treatment for adoption by the Governments of the United States and Canada. Joint legislation by the two countries was called inadequate and the calling of a convention of representatives to consider effective measures was characterized as impracticable, it was stated.

**LOLD BYNG NEXT  
GOVERNOR-GENERAL**

Ottawa, February 12.—(By Canadian Press)—An important British paper, the Essex County Standard, announced a couple of weeks ago in an issue that has just reached Canada, the fact that Lord Byng of Vimy, would be the next Governor-General of Canada.

The newspaper in question which is well known in the British Isles, claims to have certain exclusive information that there is a strong desire in present British political circles that the next Governor-General of Canada shall be a man with military experience, and one who has come into close contact with the Canadian troops.

It will be remembered that Lord Byng, then Sir Julien Byng, was at one time Commander of the Canadian troops in the field.

**STATUTE OF LIMITATIONS**

Winnipeg, Man. Feb. 12.—Mr. Justice MacDonald today upheld the statute of limitations in a case which has aroused much interest among the legal profession. The question coming up for decision was whether a judgment recovered in Quebec in March 25, 1909, was valid in Manitoba, the present action being brought to the Manitoba courts to test its validity. The defendant in the case moved to Manitoba shortly after judgment had been given in Quebec. The judge held that the Quebec judgment was on a simple contract debt and that the debt would become barred after the expiration of six years.

**INTERVIEW WITH  
SIR SAM HUGHES**

Toronto, Ont., Feb. 12.—Sir Sam Hughes, who has been in Wellesley Hospital here for about two weeks, suffering from a run-down condition is quoted in an interview which the World will publish tomorrow morning, as saying that he favors the calling of a Dominion-wide convention of Conservatives in order that they could get together on a basis of the old Liberal-Conservative party that Sir John A. MacDonald formed in 1878. He suggested that the party should adopt a tariff policy which would embrace fair protection but not the bolstering of industries by too high a protection.

The World's interview concludes as follows: "Sir Sam believes the House should carry on for another session or two, a Federal election law be passed and arrangements made for a general election in 1922, if not in 1921."

Santiago, Chile, Feb. 12.—Lieut. Prieur, of the French Aviation Mission, made a successful flight across the Andes yesterday.

Leaving Mendoza, Argentina, he landed eighty kilometers beyond Ovalle, province of Coquimbo, Chile. He was slightly injured through a bad landing in which his machine was destroyed.

the nations of Europe and in particular to the British Isles. There were not the numbers of people there from which to recruit immigrants, nor were the countries of Europe too willing to part readily with their people. The necessity of some immediate action to reduce the very high cost of living therefore became all the more apparent and relief must be given by a reduction of the tariff of food supplies and on machinery for producing foods.

## OUR PROBLEMS OF IMMIGRATION

Instructive Address Delivered  
Before Women's Canadian  
Club by Mrs. Robson

The Quebec Women's Canadian Club held a meeting at the Chateau Frontenac yesterday afternoon, when Mrs. J. F. Robson of Ottawa, was the guest of honor and delivered a very interesting address on the subject of immigration and the measures of precaution that should be observed for the future in its regard.

Mrs. C. M. de R. Finnis, President of the club presided, and on taking the chair announced that at a joint meeting of the Women's and Men's Canadian Clubs of this city, it was decided to amalgamate for a luncheon and meeting to take place on the 11th of March at the Chateau Frontenac, when Mr. Douglas Johnston of Columbia University, and geographical adviser at the Peace Treaty, would be present as the guest of honor, and address the meeting. The President said she would like all members of the Women's Club who wished to be present to send in their names to the Secretaries by March 13th in order that provision might be made for the necessary accommodation at the luncheon and meeting.

Mrs. Finnis, next introduced Mrs. Robson, who treated the question of immigration for one hour in the course of which she went fully into the matter of life in the three Prairie Provinces, Manitoba, Saskatchewan and Alberta. She is a facile and descriptive speaker, and her illustrations of the new settlers in the West were luminous and educational. She told of the arrival of the immigrants at the Canadian ports, and their arrival and absorption in the life of the West with vivid illustrations, and the education of the foreigners who could not speak the English language.

Mrs. Robson laid stress on the fact, that now that the war was over, it was the work of the Women of Canada to aid in the amelioration of the social and economic conditions of the Country. She pointed out that before the war there were one and a quarter million more women than men in England, while there were 600,000 more males than females in Canada. The latter conditions were changed since the war by the loss of 60,000 men in the war and over 40,000 wounded. She told of the work done by the women of England and Canada in the war, and of the demobilization of the women in England that left them without occupation. These were now looking forward to being sent to Canada. She told of the great care that should be taken to keep out the undesirable, which called for the abolition of the pre-war system of bonuses and government immigration agents abroad, and assisted passengers.

Mrs. Robson also dwelt with length the domestic help proposition and the great demand for servants in every part of the country, on account of the girls seeking employment in the factories and other avenues of business, wherein they had a standard, and extended the domestic servant should also have a standard, and a wage that would induce them to follow housework. She dwelt on the matter of the young English girl induced to immigrate to this Country on account of the conditions in England brought on by the war, who were stenographers in their own Country, and ignorant of house work. She also spoke of the vast number of women in war work who had been demobilized, and their difficulty to again take up with civil life, and how they should be handled.

Mrs. Robson dilated on the activities of women organizers in Canada, and the duty that Women of this Country had to perform especially in immigration and the care for the settlement of the women in this country, which was not only a social but also a religious duty.

Miss Fitzpatrick moved a vote of thanks in a short well lauded speech saying it was the first time that she had met Mrs. Robson, she had met her at Ottawa on war and social work and knew of her efficiency, and in behalf of the Quebec Women's Club, tendered her a most hearty vote of thanks for her very interesting and instructive address.

Madam Roy, seconded the vote in a short complimentary speech in French.

### INDEMNITY QUESTION TO COME UP AGAIN

Members to Demand at Com-  
ing Session Their Stipends  
Be Raised at Least \$1,000

Montreal, Que., Feb. 12.—The indemnity question will come up again in the coming session of Parliament, says a despatch from Ottawa to the Montreal Star. The cost of living in Ottawa and the fact that members are regarded as legitimate prey for all sorts of demands are cited as reasons why the present \$2,500 is inadequate and should be raised. The agitation was strong last year but an extra session operated to relieve the situation and nothing was done. This time it may come to a head, with \$3,500 at least, if not \$4,000 as the objective.

Cabinet ministers modestly hesitate to raise their own salaries but the need of it is also urged. The \$7,000 they now receive is the same as at Confederation or soon after though they would benefit by any increase in indemnities at the present time.

There are cases where Deputy Ministers are paid higher salaries than the heads of their departments.

Final reading at the adjourned meeting of the city council held last evening. The bonds will be issued in a series of from one to fifteen years and will bear six percent interest and will be submitted to owners of property on March 3rd to approve or disapprove of this later.



TORONTO PLAY HERE MONDAY

N.H.L. Game Has Been Put Off Until Beginning of Next Week

As was reported in these columns yesterday morning, there will be no game at the Arena on Saturday. The management of the local club have received a telegram from President Frank Calder, stating that the request of the Quebec club had been accorded, and that the match scheduled for tomorrow has been postponed until the beginning of next week.

The players are all in good shape after their match at Toronto, and should win out against the Greenshirts.

That the hockey match between St. Patrick's and Quebec which was slated for tomorrow has been postponed to Monday next at which all the snowshoers, skiers, and members of the General Committee of the Organization will be the guests at reduced prices. It is expected that the same night the snowshoers will start from Berthelot Hall to the Arena in parade.

Invitations will be issued by the General Committee to the Mayor and Aldermen so as to give an official welcome to the visitors on Saturday morning.

For the great parade on Saturday night a change has been made in the itinerary, which is as follows:—

Everything, then, will go at full swing. The only thing to be adjusted definitely is the shopping public on Saturday night. The chairman of the retail merchants, Mr. Papillon, said last night that he will have this morning, at nine o'clock, the last meeting in connection with the closing of the stores at 7 P.M. on Saturday evening.

So now it belongs to the public to help and to shop during the day before seven, so as to allow the members of snowshoe clubs to take part in the parade and to allow the interesting class of clerks in the stores, ladies and gentlemen, to witness the spectacle.

ALLEGED ALLIANCE ABSOLUTELY FALSE

Published Reports of Idea Nationale of Treaty Between Franco-Jugo-Slavia Untrue

Paris, Feb. 12—The reports published by the Idea Nationale of Rome concerning an alleged alliance between France and Jugo-Slavia are characterized by the Temps today as "absolutely false." Two secret documents which the Idea Nationale says were exchanged last fall between the Serb and the French Governments, the Serbian document proposing a military alliance and the French document responding sympathetically but with reservations—were published by that newspaper today. The Serbian proposal, the Idea Nationale says, was entrusted to N. P. Frenklich and M. Trumbitch to submit to the then French Premier Georges Clemenceau.

FAIR INCREASE OF EMPLOYMENT

Disregarding Loss of Time Due to Strikes, More Men Working Than Last Week

(Special to The Chronicle) Ottawa, Feb. 12—Reports from employers to the Dominion Headquarters of the Employment Service of Canada, Department of Labor, indicate that, disregarding loss of time due to strikes, there was, as had been anticipated, an increase in the volume of employment as compared with the preceding week.

The actual increase again greatly exceeded that anticipated and would indicate a return practically to pre-holiday and inventory conditions. Increases were registered in all the Provinces, that in Quebec again being the most considerable. For the week ending January 31st, an increase on the whole was expected, the anticipated increase, however, being considerably smaller than that registered during the week of January 24th. With the exception of the Prairie Provinces, where a slight decline was expected, increases were anticipated in all districts.

All groups with the exception of building and construction, commercial and mercantile, railway construction and shipping and longshore, reported increases in staffs. For the week ending January 31st, declines were expected in six groups only, building and construction, chemicals, food, drink and tobacco, pulp, paper and printing, railway construction and railway operation. These increases were all of a nominal character.

Reports for the week ending January 24th, were received from 4,639 firms. Those firms reported 668,991 persons on their payrolls as compared with 662,490 on their payrolls for the week ending January 17th, an increase of 6,501 persons or one per cent. These same firms moreover, anticipated increasing their staffs by 801 persons or one-tenth of one per cent. for the week ending January 31st. The increase for the week ending January 24th, had been anticipated. Reports for the week ending January 17th, indicated an increase in staffs of 6,954 persons or one and one-tenth per cent, and an anticipated increase of 375 persons or one-tenth of one per cent, during the week of January 24th, which increase the actual figures for the week of January 24th, given above, show to have been greatly exceeded. Quebec firms reported an increase of 3,351 persons or one and one-tenth per cent for the week ending January 24th. An increase had been expected but the actual increase greatly exceeded that anticipated. Further additions of 49 persons were expected for the week ending January 31st.

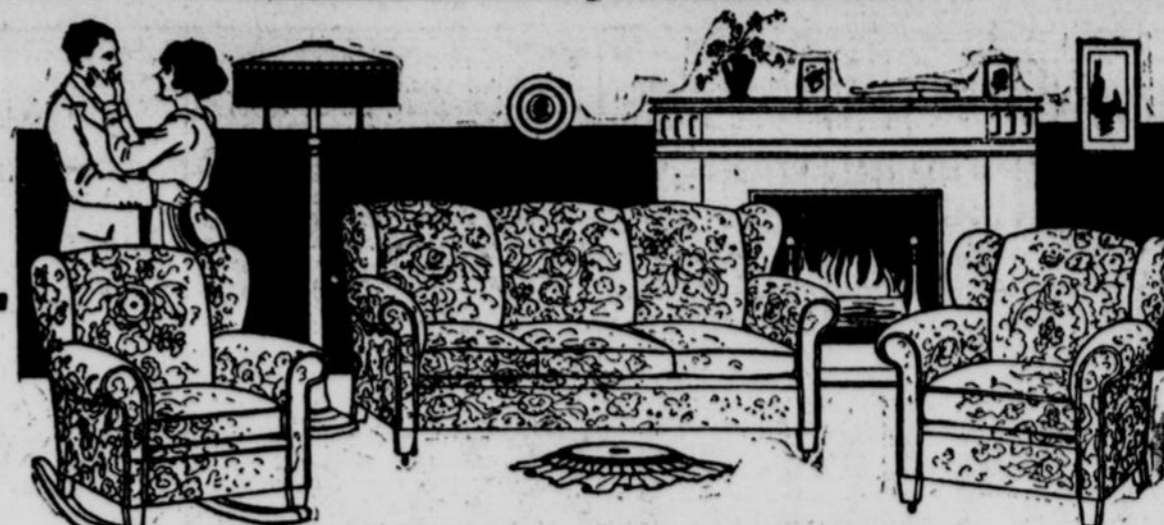

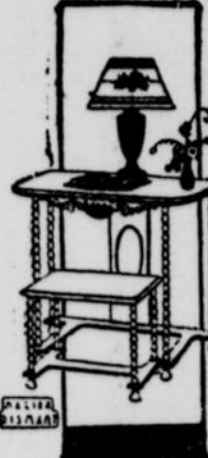

### EXPERT ISSUES PLAIN WARNING

Prosperity Indicated by Banking Figures May Become Deceptive

Washington, D.C., Feb. 12.—Warning that the prosperity and activity indicated by banking figures may become artificial and deceptive, was given today by John Skelton Williams, in his annual report as comptroller of the currency.

Remembering that in 1919 there was not a national bank failure involving loss to depositors in the United States and that the banking power of the country had increased nine hundred percent in the last thirty years, Mr. Williams added:

"A large volume of money cannot mean increase of real wealth while there is a decrease of population. The accumulation and movement of securities and currency represent abnormally inflated values, and no country can be enriched by merely putting on diminished supplies of essentials."

All the gold in the world aside from \$3,215,000,000 held by the United States, was estimated by the comptroller at six billion or only about forty percent of the credit balance of the United States in the last six years. For that reason he urged that America should adopt a policy of reasonable help and encouragement toward debtor countries with no assets immediately available but having fair prospects of being able to pay out if given time.

## DID IT HAPPEN IN LEAP YEAR?

Defendant in Breach of Promise Case Says Plaintiff Proposed

Toronto, Ont., Feb. 12.—Harvey William Curtis, aged 27, who was sued by Miss Janet Rachel Dickie, of about the same age, for \$10,000 damages for alleged breach of promise to marry, testified at the trial of the case before Mr. Justice Lennox at a non-jury sitting of the Assizes here today that Miss Dickie, had broached the question of marriage after they had been going together for several years and he had told her he was not in a position to marry. He testified that she had replied that he was as well off as he ever would be, and that he was not of much account anyway.

"Then, I suggested that we call the thing off," he stated, "and she agreed."

Miss Dickie's evidence was to the effect that she and the defendant had been engaged in 1911. For six years afterwards she had boarded with the defendant's mother. She left there last July, she stated, because she thought that as long as she stayed there the defendant would not marry her, as he lived with his mother. She alleged that Curtis broke off the engagement last August.

Judgment was reserved.

## ST. MORITZ SETS SPORT FASHIONS

Latest Styles of Dress For Both Men and Women Are to Be Seen—Bright Colors

St. Moritz, Feb. 11.—Through the development of winter sports through a period of fifty-six years St. Moritz has now become the world's fashion centre for sport costumes, just as Paris is the centre for all other kinds of women's attire. The result is that today many American buyers are here studying the latest in style in so far as sport costumes are concerned.

It may be said that today St. Moritz not only dictates style in women's sport wear, but also for men. Also it may be recalled that the first winter sports were born at St. Moritz in 1864, but the elaborate costumes which go with modern modern sports and which are essential to every sportsman's and sports-woman's wardrobe were, it goes without saying, unknown in those days. Indeed, the boys and girls of St. Moritz in 1860 just put on the warmest clothing they could find and coasted down the hill on a piece of wood.

Today all that is changed. Saint Moritz presents quite a different appearance from what it did in those old days. While the boys and girls of 1920 like to slide down the hill just as much as did those in 1860, they do it in a most luxurious way.

Clues in Costumes.

Today when the woman of fashion at Saint Moritz appears early in the morning with rosy cheeks, which, in contrast, make the snow look all the whiter, it is easy to tell by her costume exactly what sport she favors. By her boots it is easy to tell whether she will skate or ski, whether she will play tennis or ice games or go sleighing.

According to this year's styles at Saint Moritz all sport costumes must be of brightest colors, with a distinct preference shown for yellow and orange, with green in next favor. Then come purple, mauve, blue and rose in the order named.

Men as well as women here are wearing bright yellow sweaters and knitted scarfs with yellow or green stripes. Red "knickers" are more extensively worn by women here this season than ever before. They wear knitted stockings of wool and caps of either wool or silk, with dangling tassels. At a short distance it is difficult to distinguish a man from a woman, for the men wear the tasseled cap and knee length skirts made of woolen cloth called ergoline and of vivid stripes or checks.

Scarfs are made of coarse but soft wool and many of them in Roman stripes are shown. Ski socks are rolled over the top of boots and also are of bright colors—usually of yellow, rose or red—to match the sweater.

Negro women having their headquarters at one of the settlements, make soft toys and children's dresses and are thus contributing to the industrial art. The organization of these earnest workers is called the Colored Women's Guild.

### FRENCH COUNTER TRADE OFFENSIVE

Need for Increased Production Shown in Opposing Hun Commerce Propaganda

Paris, Feb. 11.—At a recent dinner in Paris, Edmond Chaix described some of the steps that were being taken to encourage foreign trade and again revive the trade position of France. He reminded his audience that Germany did not limit her efforts to military action.

"At the very moment," he declared "when she set in motion her military mobilization, Germany also began to invade the whole world with her powerfully equipped and well-financed propaganda organization to stir up public opinion and strive to influence it in favor of the pretensions of the Central Empires."

It was thought that with the end of the war, the propaganda would cease. But the Allies were soon forced to recognize that on the contrary Germany had not disarmed in this field of action. Mr. Chaix laid special emphasis upon the fact that "her propaganda services redoubled in activity during the execution of the armistice and the discussion of the Peace Treaty. Now that the economic struggle is beginning, Germany is preparing to place at the service of her industrial and commercial offensives in her desire for economic domination, the same methods of intellectual bluff that she used during the war. Nor does she hide her intention of doing this."

#### Strong Competition Needed.

"Must we allow her to do this, must we allow German kultur, German publicity to permeate everywhere and to impose itself upon the world without playing our hand and opposing these methods and a sufficiently strong competition to be victorious?" asks Mr. Chaix. "The answer to this question, asked in different French spheres, was unanimous. Never was the use of propaganda, the necessity of a general action for the expansion of French culture, influence and production more urgent than at the present."

A committee had been organized to arrange the plan of action best suited to insure the world-wide defense of the national interests of France. The creation of a vast organization of the "colossal" German type was rejected, but it was decided to appeal to all the forces of the nation, which should be guided, directed, and coordinated by central organization.

"Men, alone, however, are not sufficient to insure an active national expansion. Capital and production are also necessary," he continued, "and in her present situation, France needs to be encouraged toward an intensive production. Our country, can no longer live as it did of yore, when it was saturated with gold and was the creditor of the whole world. It can no longer, as before the war, depend almost entirely on itself. The gold is gone; the country's fortune has paid for the war. Now it must recover its gold, remake its future, but one can only grow rich by work."

#### Enterprise Indispensable.

"An imperious duty rests upon us. We must teach our nation the new conditions of life, prove to it the necessity of work and instill in its heart the will to live the hard years of labor which are necessary for the re-establishment of the economic life of France. Therefore it is indispensable to develop in the rising generations the spirit of enterprise."

"The conditions of life are today strikingly enlarged. One of the most immediate effects of the great war has been the apparent reduction of distances on our terrestrial globe. The Atlantic, which formerly constituted a serious obstacle to transactions, has become a mere ditch! It is no longer merely in his native land that a man must live and to which he must confine his thoughts. If he wishes to retain his rank, make his business prosper and consequently serve well his country, he must also be a citizen of the world."

#### CLOCK MAKING IN JAPAN.

In Nagoya, Japan, the clock makers last year turned out something over 300,000 clocks, and sent them off to tell the time of day even in England, Africa, and South America, although for the most part Nagoya is clock maker to the Orient. Tokyo is also a clock maker, but clocks are simply one item among many in the activities of Tokyo, while the 19 factories of Nagoya make about three-quarters of all the clocks manufactured in Japan. The United States is not yet acquainted with the Japanese made clock, but during the war the clock makers of Nagoya worked with wires and springs imported from the United States to take the place of material that could no longer be imported from England and Switzerland and so at present in many an odd corner of the Orient where a Japanese clock is ticking the hours, a proper arrangement of American springs and wires is busily working away inside to make it tick. The clock industry in Nagoya, says consul Hawley, who looks after American interests in that part of the world, grew out of successful efforts of a mechanically-gifted Japanese in the neighboring town of Ohazaki to make a new clock like the one that had been brought to Japan from the International Exhibition in Vienna, 1873. The ambition, it seems, seized him quite a while after the clock had been brought from Vienna, for once started it took him about a year to make two clocks, and 1888 "first heard them ticking. Then followed the first clock factory in Nagoya."

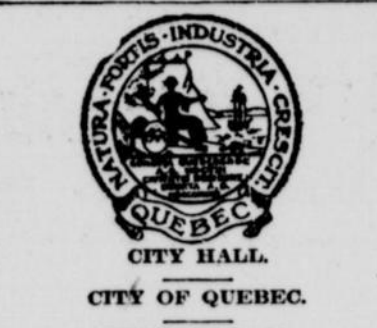

CITY HALL. CITY OF QUEBEC. BY-LAW NO. 38. Concerning the Removal of Snow by the City in Certain Streets.

At a meeting of the Municipal Council of the City of Quebec, held at the City Hall, in the said City of Quebec, on the twelfth day of December, one thousand nine hundred and nineteen (1919), in conformity to law and in virtue of a By-law passed by this Council, pursuant thereto, and after the due observance of all the formalities prescribed by the statute in such case made and provided, at which meeting were present the absolute majority of the members composing the Council of the City of Quebec, that is to say: His Worship the Mayor, Aldermen Bellard, Bertrand, Bouchard (S.R.), Collin, Lantier, Lesage, Martin, and Mercier.

It is hereby ordained and enacted by the Municipal Council of the City of Quebec, and the said Council ordains and enacts: 1o.—The City empowers the City Engineer to proceed with the removal of snow and ice on St. John street as far as the old city limits, before annexation of Montcalmville, on the streets: Mountain Hill, from Du Fort street to Dalhousie; Abraham Hill, situated between St. John and Ramparts streets; on that portion of Des Glacis street situated between St. John and d'Aiguillon streets; on that portion of d'Aiguillon street situated between Des Glacis and St. Eustache streets; Mountain Hill, from Du Fort street to Dalhousie; Abraham Hill and that portion of St. Vailler street between Abraham Hill and Crown street, and on Candiac, Dumont, St. Laurent, Crebeau, Saunders, Jeanne d'Arc, Dolbeaux, des Franciscains, Simard, Sirois, Brooks, Ste. Foyle road—on the Avenue to the Western limit of the city, Park Avenue, Holland, Moncton, Bourgainville, Murray, Marquette, Talix, Lavallee, Marguerite, Bourgeois, St. Louis Road, Joffre, Belvedere, Bell's Hill, Frontenac, St. Cyrille, Bourlamarque, Carter streets and all the other streets of Montcalm ward not above mentioned, except d'Alaberray Avenue.

2o.—The real cost of said removal of snow and ice on the streets and sidewalks on the above mentioned streets, shall be paid by the proprietors of land and buildings bordering on said streets, at so much a lineal foot, all to be based on the length of the frontage of immovables situated on said streets—deduction to be made of what the Quebec, Railway, Light Heat & Power Company has to pay in the streets where said tramway is running, according to the disposition of article 18 of By-law No 335—passed on the 28th June, 1895.

3o.—The collection of the real cost of said removal of snow and ice, as above mentioned, shall be done in the same way as the collection of municipal taxes on said immovables, and shall be collected on the first of June of each year. SHIPPING NEWS

FEDERATION OF SHIPPING REPORT Newly Elected President Says Future Prospects Are Not Bright

At a meeting of the Canadian Federation of shipping held at Montreal on Wednesday last, Mr. Robert Reford, the newly elected President presided, and in reading the Annual report, made the statement that the shipping prospects for the future do not look any too bright. A year or two of depression may be expected, as at present freight rates were on the downward grade, while operating expenses still continue to go the opposite way.

The report which had been prepared by the retiring President Mr. John Torrance was read in his absence by Mr. Reford. Speaking of labor conditions it went on to say that the port of Montreal was free from labor disturbances of any kind during last season; longshoremen, shippers and checkers having carried out agreements to the letter a fact that reflected great credit on the port.

SCHOONER TOTAL LOSS Miami, Fla., Dec. 12.—The schooner Leon, bound from Miami to Macapua, Bahama Islands, with a cargo of lumber, went ashore off Gun Key, Bahama Islands, according to advices received here today. It was said that the ship is a total loss. No report as to the fate of the crew has been received.

LINER MOVEMENTS The Baltic, White Star line, which left New York on January 31st, arrived at Liverpool on February 9. The Adriatic, White Star line, will sail from New York on the 14th for Cherbourg and Southampton. The New York, American line, is scheduled to leave New York on the 14th for Plymouth, Cherbourg and Southampton.

COAST GUARDS' HEROISM. Atlantic City, N.J., Feb. 12.—From Little Beach Station at the head of Great Egg Harbor Bay, completely isolated since the beginning of the storm last week, trickled the news yesterday of a tragedy in which three lives were lost and, through the heroism of coast guards 29 were saved.

DAILY GOSSIP ON THE LEADING STOCKS

As the Stock Exchange was closed yesterday, it being the anniversary of Lincoln's Birthday, the Montreal Exchange decided to close at 12:30 pm. for the day. America's foreign trade is decreasing as a result of the slump in exchange, and a steady decline in trade is expected by officials of the Department of Commerce. But they are not alarmed over the situation. In December, exports to Great Britain, France, and Belgium, dropped \$22,000,000, compared with November, and total exports to Europe decreased \$57,000,000. Several foreign countries not hit by the slump in exchange increased imports, namely, the Netherlands and Japan.

The Philadelphia Electric Company declared the usual quarterly dividend of 1 1/4 per cent, payable March 15 as registered February 13. The listing of a substantial block of new French internal loan bonds on the New York Stock Exchange is under consideration. The bonds will be free of French taxation to American investors, and it is thought the placing of them will provide a convenient means for speculation in exchange, and will help to correct the exchange situation.

SANCHO'S HOUSE. The Council of Perpignan has decided to preserve an ancient house in the town built at the beginning of the sixteenth century by a merchant of the name of Sancho. It is in the street known as Main-de-Fer, a survival of the heroic days of that independent little town whose bourgeois did not even hesitate to impose taxes upon the King of France, suffered a set at the hands of the French King in 1475. Handed back to Spa by Louis XI's successor, Perpignan saw the entry of Ferdinand the Catholic King of Aragon, accompanied an escort of monks; the inquisitorial tribunal which Ferdinand impudently established in the town, till 1642 the ecclesiastical tyrant continued, but the burghers of Perpignan had far too great a reputation for sturdy independence the monks to have had it all their own way. **AUSTRIA'S EFFORT TO SECURE PEACE**  
Prince Sixte's Attempt to Obtain Separate Peace Foiled by Italy  
Paris, Feb. 12— "Was a separate peace with Austria possible?" Such is the question which Jean de Pierrre proceeds to answer in "The Opinion," with the aid of documents concerning the secret mission undertaken in the spring of 1917 by Prince Sixte of Parma. The details of this mission were unknown until now, and these notes, written in the form of memoranda, throw full light on the interview which the young prince had with the highest personalities of the different countries and Clemenceau had revealed in part in April, 1918.  
It appears that in 1917 the former Emperor Charles was convinced that the certainty of ultimate victory still entertained at that time by his German ally was a dangerous illusion—and that in consequence he was seeking to save the integrity of the Dual Monarch. Prince Sixte, who was serving in the Belgian Army, was told by his mother, the Princess of Parma, that the Emperor Charles of Austria was anxious for him to enter into informal negotiations with the Allies.  
The Emperor begged his brother-in-law to do his best to obtain peace, but Prince Sixte pointed out that diplomacy had no chance of success, both Germany and Italy being determined to thwart it. He advised the Emperor to have recourse to straightforward method of confronting Germany with the accomplished fact in the form of an imperial edict by which, whilst saving the appearance of friendliness with Germany, Austria would offer peace to the entente on certain conditions.  
After various negotiations had taken place the prince repaired to Paris where he had another interview with Mr. Poincare, at which Mr. Cambon was present. Shortly after, Mr. Ribot met Mr. Lloyd George, who informed him that England was favorable to continuing the negotiations with Austria, but considered that the Allies should not delay any longer in advising Italy of the fact.  
But Italy was the cause of the failure of the negotiations. When Mr. Ribot, Mr. Lloyd George, and Baron Sonnino met at St. Jean de Maurienne on November 18, 1917, the last named maintained that the Italian government would not consent to the continuance of these negotiations, when Mr. Lloyd George informed since Sixte of this decision, the latter was not discouraged, but decided to pursue his efforts.  
On May 4th, he received an amazing piece of news, which was that the Emperor of Austria considered it unnecessary to take too much notice of the exaggerated demands of Italy, as three weeks previously an envoy from General Cadorna had pressed peace on the Austrian Minister in Berné on condition that the Italian Trentino should be returned to Italy. But the Emperor refused to treat with Italy without informing the Entente.  
The Sixte decided to return to Austria, and having again met his brother-in-law, at Laxenburg, he wrote memorandum in which he seems quite confident that peace would be concluded some time in June. His time the Prince brought back Mr. Poincare a letter from the Emperor, which the Entente never viewed, and an autograph note from Count Cernini. The text of the letter is particularly interesting, as it proves that, contrary to what M. Ribot's Count Cernini was fully aware of the negotiations conducted by his sovereign in view of a separate peace.
