THE EXHIBITION BUILDING AND DRILL SHED.

It is to be regretted that the Local Government apparently do not intend to fulfill its share of the arrangement as understood by the Federal Government. The new exhibition and drill building. We observe by the supplementary estimates that our Government will give towards the scheme the sum of \$15,000, provided the City of Quebec grants \$15,000 and the Dominion Government sixty thousand dollars. Now that is not the way the bargain was understood. The Federal authorities only promised \$50,000 and that sum is placed in their budget of estimates. This would be a suicidal policy to pursue. A good building, suitable for \$60,000, would satisfy us, and we hope Mr. WRETTLE will alter his conditions before it is too late, and let the sum of \$15,000 stand as written, provided, of course, that the city gives \$15,000 and the Ottawa Government \$30,000. Thirty thousand dollars was the sum named by Sir HECTOR LAMONTAGNE at the time, and that is all we were led to expect from him.

DEATH OF JOHN BROWN.

The great doctor came and ministered to the wants of JOHN BROWN, and then the grim old henchman was happy, and decided to get well. We may be sure such a man will be missed, but what a terror he was to the other servants. BROWN basked in the sunshine of the Royal favour, but below stairs he got few smiles. He was not a man to care much for smiles, however. He served the QUEEN well and it was enough for him to know that his services were appreciated.

THE TROUBLESOME SPARROW.

Boston has declared war on the English sparrow with a vengeance. It has been proved to a demonstration that the little bird is useless as a worm-eater or a songster, a law has been passed making it an offence for the feathered criminal to be about. The act comes into operation on the 9th day of April next, by which it will be permissible to destroy the English sparrow forthwith. In this connection a correspondent in the Advertiser writing on the subject says:—"It is hoped that some concentrated or, at least, simultaneous individual effort will be made hereabouts towards the destruction of this prolific and troublesome bird. This is the time and season to expect the arrival of other birds, and to encourage their stay near our homes once more, and especially of the songsters and insect-eating birds. Why would it not be an opportune time for the worthy president of the Society for the Prevention of Cruelty to Animals to name some expeditious and humane method of disposing of the English sparrow by a poisonous food, placed either in its nests, or bird-houses, or upon the ground? Then let every bird-house be removed from the trees before the blossoms burst forth, and thus every man could be decorated without pistol, gun or powder. To those who have been heretofore annoyed by the nasty droppings of the sparrows upon the blinds, doorsteps and window-cases of their dwelling-houses, not to say anything of their utter worthlessness as worm-eating birds or songsters, a word of wisdom is alone sufficient.
