150 PEOPLE BROWNED IN MARITIME DISASTER

Midnight Collision Between a Steamer and Lumber Laden Schooner on California Coast.

MEAGRE DETAILS OF TRAGEDY RECEIVED.

San Francisco, July 22.—In one of the worst marine disasters in the history of the California coast, between one hundred and one hundred and fifty lives were lost, as far as has been learned, by a midnight collision between the steamer Columbia and the steam lumber schooner San Pedro in Shelter Cove, 12 miles southwest of Mendocino-Humboldt county line, between 12 and 1 o'clock yesterday morning.

Shortly after the collision the steamers Roanoke and Geo. F. Elder and the steam schooner Daisy Mitchell, all southbound, came on the scene and stood by. The Elder took the San Pedro in tow and the latest report announces their arrival in Eureka. The stem of the San Pedro was smashed to splinters, one of her masts was snapped off at the deck, she was settling and she had a heavy list when taken in tow.

RETIRE FROM POST GEN. HAGRON RESIGNS

French Army Chief Would Not Be Responsible for Frontier

NEW LAW HAMPERED HIM

Situation Dangerous on Account of Temporary Reduction of Army to About 150,000 Men.

Paris, July 22.—Paris was startled to-day by the announcement that France's foremost military commander, General Hagron, had resigned. Although officially only an ordinary member of the War Council, General Hagron fulfilled the functions of the vice-president of that body, a post always carrying the command of the army in the field in the event of war. He would thus be the eventual commander-in-chief.

The reason of his retirement is Parliament's decision, shortly before the close of the session, to interpret the Two Years' Service law so as to release part of the troops before the next contingent joins the colors in the fall. As a consequence, the army strength has been reduced to about 150,000 men since July 12. On Monday General Hagron informed General Picquart, the minister of war, that he could not assume the responsibility of defending the eastern frontier with his battalions in such a depleted state; he also described the situation as dangerous.

SIR WILFRID BACK AT FEDERAL CAPITAL

Premier Received a Warm Welcome Last Night

ARCHIVES IN PARIS

Fined for Misbehaving on Street Car—Inland Revenue Receipts—A Drawn Battle in Hull.

Ottawa, July 22.—Two young men from Hull, who used insulting language to ladies on an electric car, were fined by Recorder Gault to-day. It cost one \$40 and the other \$30. Instead of appointing a Canadian agent for the Archives branch in Paris, where the late M. Tanel served Dominion interests, Dr. Doughty, C. M.G., has made H. P. Biggar, a Canadian in London, representative of his department. He will superintend the work of the archives in England and Paris. Mr. Biggar is a native of Belleville and a graduate of Toronto University.

The receipts of the Inland Revenue Department for June, 1907, were far ahead of those of June, 1906, the latter being \$1,171,319.66, while the former are \$1,265,200.86. Apropos of the visit of British newspaper men to Ottawa to-morrow and the need of knowledge of the importance of the Dominion, a story is being told. A correspondent in Canada offered to supply the Yorkshire Post of Leeds, Eng., with current Canadian news. He is exhibiting their reply to the effect that if they publish matters to boom a country they always charge for them as advertisements. It is well the Britishers have come. The spotters who descended on Ottawa on Saturday night also visited the suburbs. Three saloon-keepers found open after hours were this afternoon fined \$40 each at the County Court. The city cases will come up to-morrow.

DROWNED AT ST. JOHN'S

St. Johns, Que., July 22.—Two men, Gamache and Dextrax, started this evening for a row to Isle aux Noix, 12 miles south of here. When about a mile and a half out, Gamache suggested to his comrade that he would swim behind the boat. He then tied a small rope around his neck and got into the water, the rope being tied to the boat. Gamache sank to the bottom, strangled and drowned. Dextrax returned to town to advise Gamache's friends, and returned with several others to search for the body. Gamache leaves a widow and two children to mourn his loss.

A SHOCKING DEED

Sunderland, Ont., July 22.—The adjourned inquest in connection with the Valentine tragedy was concluded this afternoon. Several witnesses were examined, the chief one being the eldest daughter of the family, a girl of 16, who testified to hearing the report of a gun at daylight on Saturday, and on arising to investigate found her mother lying on the bed dressed with the body in her arms and the top of her head blown off. The father pretended to know nothing of the affair at all. The jury brought in a verdict to the effect that deceased had been shot by her husband, he being insane at the time.

YOUNG GIRL DROWNED

Toronto, July 22.—Irene Levee, aged 14 years, daughter of School Trustee Levee, who is in the hospital dangerously ill, was drowned off the Island this afternoon. She had brought her mother, in a canoe across to the city in order that the latter might visit her husband. On the return voyage her paddle caught in some weeds near the landing place, overturning the canoe. The girl went down several times. Some children finally gave the alarm and the body was recovered after being in the water an hour. Doctors and nurses said she was dead when they found her three hours in an attempt at resuscitation, but while at one time apparent signs of life were noticeable their efforts were without avail. Within an hour William Claude, the 11-year-old son of R. Armstrong, of this city, was drowned off the same spot, being seized with cramps while bathing.

HAD COUNTERFEIT BILLS

Lindsay, Ont., July 22.—Charles Dwyer, Robert Logie, Richard Wynn, Archie Bouyee and John Everleigh all pleaded guilty here this afternoon before Magistrates Moore and Jackson to a charge of having counterfeit Traders' Bank bills in their possession. All were remanded for sentence till Friday. Miller and Goshin, who will plead not guilty, will come up to-morrow.

THE SOLAR OUTBURST.

"Coming events," says the poet, "throw their shadows before," and the number and persistency of the reports both in Dominion and Provincial political circles are calculated to create a conviction that the general elections are not far distant in either case. Indeed Sir Wilfrid Laurier in his recent speech in Quebec not obscurely intimated that this was the case so far as the Dominion was concerned, and the Hamilton Spectator in a brief editorial which we reproduce elsewhere sees in the undertaking of Mr. Borden to make the tour of Canada from ocean to ocean within the next three months, a sign that the Opposition leader has made a pretty good guess as to the intentions of the Government. Another significant happening to which the Mail and Empire recently drew attention is the recrudescence in the columns of Le Soleil, Sir Wilfrid Laurier's special organ in Quebec, of the old party tactics of inflaming the people of this province against Ontario, and of the revival of racial and religious issues. Our conferees, commenting on Mr. Bourassa's declaration at Montmagny that the people of Ontario "are not the narrow-minded bigots depicted by the politicians who picture me as stirring up racial strife; they are fair-minded people willing to listen to reason and to give us a square deal. Let us only be frank and fair with them," says: "At the moment when Mr. Bourassa is making his remark, Le Soleil, Sir Wilfrid Laurier's organ in the city of Quebec, was publishing an article on the political situation for the information of its readers. That organ announced that Ontario, through the efforts of The Mail and Empire, is in a state of fury against the French 'province' and against the Catholic hierarchy. The Mail and Empire, it seems, is working the people of Ontario into a condition of intense hostility to 'the French province,' and to its clergy. Everybody who reads this journal knows that the story of Le Soleil is absolute fiction. It is a fraud of the same type as that issued with reference to Hon. George E. Foster, of whom it was said in one of Sir Wilfrid's papers that he had devoted himself in Parliament to assaults upon French-Canadians for racial reasons, and upon their religious teachers, whom he had called 'bigots and fools.' It is also an imitation of the usual pre-election reports floated through the Government agencies with reference to the attitude of Ontario and the Ontario people towards their compatriots of another origin. Invariably, when a contest is impending, the partisan press in Quebec is laden with blood-curdling accounts of Anglo-Saxon hatred."

COMING EVENTS.

Now we will do our French conferees the justice to say that in its calmer moments, and when it is in a state of political complacency, it is a dove and respectable sheet, and even goes so far at times as to deprecate any stirring up of racial and religious prejudices, but when the Liberal war-horse scents the coming battle from afar its imagination becomes inflamed, and it resorts to the tactics described by the Mail and Empire, displaying a beam of very considerable dimensions in its own eye under the pretext of having discovered a fancied mote in that of its brother. When Le Soleil begins to inveigh against Les Orangistes of Ontario, it is a sure and certain sign that Dominion elections are in the air.

We can scarcely blame it, for it is only by blinding the eyes of the electorate and stopping their ears by wild appeals to prejudice and passion that it can hope to hold Quebec for the Government party. Putting aside such appeals, the provinces of Quebec and Ontario have common sympathies, and common interests. They are both naturally Conservative in their ideas, and protectionist in their policies; indeed, it is the very Conservatism of the French race that lends force to the racial and religious appeals that its intelligence would otherwise instantly repudiate. And now that the weight of population is daily gravitating more and more to the West, it is more important than ever before that the Eastern provinces should be closely allied in sympathy if they do not wish to lose their political weight. Clear-headed men like Mr. Bourassa, perceive this, and deprecate anything that would engender bitterness and anger.

This, however, by the way; "to return to our muttons," it is more than probable that November will find the Dominion engaged in a political battle. The Cabinet will have to be reconstructed first, for it would be poor policy to go to the country, with a maimed and bemurdered Cabinet, and this will necessarily take some time, but when that is accomplished we may expect to see what we shall see. The Conservatives should lose

no time in setting their house in order we do not mean by organization, for we take it for granted that the leaders have not been unmindful of their duty in this respect, but by keeping themselves before the public. It is a fine time of the year for political picnics and similar demonstrations, and the gathering at Three Rivers the other day was a good commencement which we hope to see followed up in different localities from time to time, as well as supported by Mr. Borden's tour through the provinces. The late Sir John A. Macdonald knew well the importance of keeping the party before the public eye by these open-air demonstrations, but since his day the Conservatives have been remiss in this respect, and his mantle has fallen on the Liberal shoulders.

THE PROVINCIAL SITUATION.

As in the Dominion, so in Provincial politics there are rumors of strife which gather strength, and become more and more precise every day. The latest is, according to L'Evenement, that Hon. Mr. Gouin is determined to insist on a dissolution of the Legislature, and that His Honor, the Lieutenant-Governor, agreeing with Mr. Bourassa that such a course would be unconstitutional, is to be shelved and a more compliant substitute found in the person of Senator Shehyn, in other words that the old juggling between the Bench and the Upper House of the Dominion is to be resorted to again. It is not incredible, for the public has long been indoctrinated in the proposition that the prime reason for the existence of the Senate and the judicature is their convenience for smoothing out any little party difficulties. The question of dissolution being thus comfortably got out of the way, the next question is that of the reconstruction of the Cabinet, for it is obvious that Mr. Gouin would be considerably handicapped if he appealed to the country with the present Ministry, and accordingly we are told that it is the intention to put Hon. Messrs. Prevost and Turgeon into honorary retirement, the first as Sheriff of Montreal, and the second as Commissioner of Paris, whilst two other members are to play "Tommy make room for your uncle," and give place to weightier men. What things will be arranged in this precise manner it is impossible to say, Mr. Prevost instead of going to Montreal, for instance, might be found some congenial and lucrative employment in Brussels where he might renew his former friendship with Baron L'Epine, and Mr. Turgeon might go and sit on the Bench for a little while to be ready to change places with Mr. Gouin if that gentleman is successful in the coming campaign, but whatever may be the arrangement, something must be done to enable Mr. Gouin to appeal to the people with washed, if not absolutely clean hands.

The device is an ingenious one, but will it be successful. The only conceivable reason why Mr. Gouin should cut short the existence of the present Legislature is the charges that have been wought against two members of his Cabinet. He cannot get rid of that onus by pitchforking them into lucrative and honorable positions; on the contrary he intensifies it, and assumes the responsibility for himself. Neither Mr. Prevost nor Mr. Turgeon have been clearly and satisfactorily proved innocent of the charges that have been made against them; there has been no attempt to do so, and Mr. Gouin has been particularly careful to express no opinion on the evidence adduced at the Prevost-Asselin trial, beyond the personal one, that for his part he would rather take Mr. Turgeon's word than Baron L'Epine's. It is an outrage on public decency to put the two gentlemen accused into honorable positions before their innocence is established; if Mr. Gouin does this and refuses to go to the electorate with them in his Cabinet it is a tacit confession that he does not regard them as desirable companions, and that he is seeking to relieve himself of their burden. It is not a proclamation of his belief in their innocence; if he were convinced of this, and was satisfied that it could be proved, every feeling of justice and honor would compel him to associate them with himself before the electorate and to desert them would be an act of cowardice and treachery, not redeemed, but rather intensified by affording them a solatium at the expense of the public. Let Mr. Gouin make no mistake about this. If he appeals to the province, he appeals in consequence of the revelations made at the Prevost-Asselin trial, and he does so under the handicap of having purposely put Messrs. Prevost and Turgeon out of the way of politics.

STEAMERS COLLIDE IN THAMES

London, July 21.—The Atlantic Transport line steamer Minnesota, which sailed from this port yesterday for Philadelphia, collided in the Thames with the small steamer Zebra, of Hull. The Minnesota was considerably damaged and was compelled to return to her dock at Tilbury. The sustained damage is not known.

PRESS OPINIONS.

A GREAT ACHIEVEMENT.—Sir Wilfrid Laurier returns to Canada in excellent health, in spite of a somewhat exacting round of duty. For the privilege of being an honored guest at several banquets during every week soon develops into the sternest digestion of an ostrich. Sir Wilfrid is not blessed with an indelible constitution, so the contrary feasting was in reality a very serious and wearisome affair. Yet his speeches in London and Paris were not touched with any bitterness or satire. On the contrary, they were invariably graceful and pointed with a pleasant wit. A man who cannot enjoy the exuberant artistry of a college of French chefs must, surely, cultivate all the methods of diplomacy and all the distinction as an after-dinner speaker. Sir Wilfrid well deserves, even from this standpoint alone, the position he has won as an eminent man and a great Canadian.—Toronto News.

HON. MR. BORDEN, leader of the Conservative Opposition, has undertaken to make the tour of Canada, from the Atlantic to the Pacific, during the next three months, and to speak at such places as may hereafter be chosen for the purpose. Hamilton, of course, will expect a speech. We do not know that Mr. Borden has any direct knowledge of the intentions of Sir Wilfrid Laurier in the matter of the next election, but he is certainly in a position to make a close guess. And his determination to take the field may lead other guessers to infer elections this year.—Hamilton Spectator.

LIKE ALL THE WAR SCARE yarns published by the sensational press, the story of a Japanese spy having been caught making sketches of Fort Vancouver, California, and found in possession of plans, profiles, etc., of that fortress, turns out to be a mere fabrication. The War Department at Washington knows nothing of the alleged arrest. On the contrary, it is stated that if the nameless spy establishes his identity and proves that the fort he is reported to have sketched really exists, he can get a liberal reward from the United States Government, which previous to his discovery did not know there was such a fortress. It is added that he must have used a telescope or a microscope in making the wonderful sketches of the three small calibre guns used for target practice on the San Diego coast, dignified as Fort Rosecrans. Anyway, he need not have gone to all the trouble of secret sketching, as he could have had all the information he wanted by applying to the War Department. Such is the sort of villainous stuff out of which wildly sensational reports are sent broadcast over the country, with the purpose of exciting the public mind and promoting the sale of papers. The authors of them may think they are making pretty good jokes; but the widows and orphans of Germany whose securities are collapsing on the Berlin bourse are sufferers. Indeed, the war terror has added to the paralysis of enterprises not only in those countries where men give it credence, but in those upon which their credulous timidity reacts. This spy story was given to the world by a newspaper, the New York World, which makes a specialty of denouncing and ridiculing governments. It may become a question how far the competition between the yellows of both sides of the sea as to which can perpetrate the biggest and most mischievous war hoax can be considered as other than a crime against the public. This Fort Rosecrans story looks like an attempt to outdo the unscrupulous London paper, which told how the German Emperor had patronizingly undertaken to help the poor little United States against the terrible Japan.—Montreal Witness.

LEGEND OF SCREAMING-SKULL.

Weird Story of Famous Old Country Mansion in England.

The Screaming Skull of Burton Agnes Hall, the seat of the Boynton family, is one of the weirdest of the many weird and fascinating old legends that are told of the famous houses of Britain. An account, authenticated by Sir Griffith Boynton, the present head of the family, is published in Pearson's Magazine.

The story goes that in her dying moments a certain Anne Griffiths made her sisters promise that her head should rest for ever in the family mansion, but that after her death this was looked on as a mere dying fancy, and the promise disregarded.

Then comes the weird part of the legend: "About a week after the funeral, on the same night of the week as that on which Anne died, just as the inmates of the house were retiring to bed, they were startled by a loud crash in one of the upstairs rooms. Concluding that a picture or some furniture had fallen, two men-servants went to find out the cause of the noise, but everything was quite undisturbed. Full of anxious fear, the family kept vigil; but the night wore on without any further sounds, and the next morning there was no evidence of any disturbance.

"On the same night of the following week, at exactly the same hour, several of the heavy doors in the house began banging violently, with apparently no cause. The alarmed household rushed out of their beds, but everything was quite undisturbed. Full of anxious fear, the family kept vigil; but the night wore on without any further sounds, and the next morning there was no evidence of any disturbance.

"On the same night, the two sisters, horrified beyond measure, consulted with their neighbors, Sir William Quentin and the vicar of Burton Agnes. They confessed tearfully that Anne in her dying moment had laid on them a solemn injunction which they had promised to perform, but had afterwards ignored, and they also told of her threat that unless her body, or some part of her body, should remain in the house, she would haunt Burton Agnes till the Judgment Day.

"After hearing their story the vicar suggested that some light might be thrown upon the matter if Anne's coffin were to be opened, so this was accordingly done. When the lid was raised a ghastly spectacle presented itself. The body, it is true, lay peaceful and uncorrupted, but the head had fallen to decay, and a grinning skull, already severed from the trunk, struck terror to the hearts of the beholders. This was at once accepted as the sign for which the vicar had hoped.

"Let the skull be brought to the Hall," said the sisters, "for until that is done the soul of our dear sister will never rest in peace."
"The grisly relic was accordingly brought, with due reverence, to the Hall, and placed upon a table, and with its advent the ghostly nocturnal sounds ceased to alarm the sisters, and all was peace once more."

BUSINESS OVER TEA TABLE.

London's business is largely conducted over the teacup. There is no more profitable trade than the tea shop business in the city of London, where the consumption of tea and coffee, especially tea, is enormous.

It has enabled Lyons & Co., the great catering firm, who have tea shops everywhere in London, to pay 40 per cent. on their common shares and to reap a profit of about \$3,500,000. On an average, the Lyons people open a new depot in London every month.

Taking London as a whole, it is estimated that 2,000,000 cups of tea are consumed every day at the tea shops and cafes, representing a turnover of \$25,000,000 a year.

Tea time for the London business man corresponds with the Parisian's "green hour," when he sips his absinthe. Whether he is a teetotaler or otherwise, his afternoon cup of tea is indispensable, and this holds good throughout the scale, from Lord Rothschild to the clerk on \$5 a week. Incidentally it is interesting to note that the tea shop companies find it difficult to replace fast enough their waitresses who leave to get married.

PASSING OF THE CHIHUAHUA DOG.

(New York Tribune.)

The Chihuahua dog, which as late as twenty-five years ago was common to be found in Mexico, is rapidly becoming extinct. It is a curious little creature, popularly supposed to be a cross between the prairie dog and the jack rabbit. The animal resembles a small dog. Its weight is sometimes not more than a pound and a half, and it has a disproportionately large head, bulging eyes and long ears. The hair is usually scanty, showing the pink skin underneath, and from this characteristic it has been known as the Mexican hairless dog. One of its characteristic marks is said to be an unclosed cranial fissure, through which the brain can be felt throbbing beneath the skin.

The little animals are peculiarly destructive, and are constantly scratching at things with their long claws. They are easily tamed if taken young, and in numerous instances the breed has been domesticated, although they seldom show the usual dog traits of sagacious and intelligent attachment. In the last twenty-five years, unfortunately, the breed has become so largely mixed with small dogs of various mongrel types that it is now difficult to find in Mexico a purely bred Chihuahua dog, and those that are are often sold at prices ranging from one hundred dollars upward. Even in Chihuahua these dogs are rare. A few specimens sold in Mexico City recently are said to have been specimens of the true breed.

PUNTS VERSUS BATTLESHIPS

Cornish Smuggler Made Successful Attack on Cruiser.

The action of the hellish minister of the lonely island of St. Kilda, who recently boarded a British cruiser at the head of a boatload of members of his flock, and endeavored to forcibly prevent her from carrying off as a prize a friendly trawler found fishing within prohibited waters, has had many parallels in the past.

One notorious case was that of a Cornish smuggler named Tabois, who, early in the last century, fought a regular pitched battle with a Government revenue cruiser off Falmouth. He had fitted up a complete battery of cannon in a cave used for storing contraband goods, and from these he returned the fire of the man-of-war with considerable effect, killing and wounding a number of her crew.

In revenge, her commander landed a boat's crew, who stormed and burnt the bold smuggler's stronghold, whereupon Tabois retaliated by boarding the cruiser by night from an old punt, and carrying off the captain's gold watch, and a number of other articles of value.

Far more remarkable, however, than even this dare-devil exploit, was the capture of the Spanish admiral's flagship in the West Indies by Peter (Pedro) Vello, afterwards nicknamed "Peter the Great." The story is told in full in Esquemeling's "History of the Buccaneers," and makes thrilling reading.

Peter had neither arms, money, nor even clothes to cover him. He was just an escaped slave, skulking naked in the forests of Hayti. Yet he managed to possess himself of an Indian dugout canoe, and in this, with a dozen more desperadoes like himself at his back, he boarded the huge galley, killing every one of her officers and crew with their own weapons, and captured, beside the ship herself, stores and booty worth something like a quarter of a million sterling.

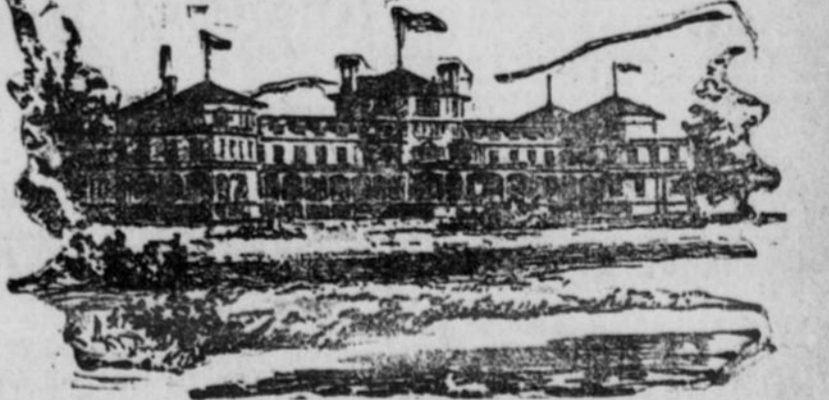

RIOTING IN SEOUL
THE CAPITAL OF COREA

Japanese Used Artillery to Disperse the Mobs

PLOT TO MURDER CABINET

Ex-Emperor Clandestinely Ordered the Imperial Guard to Wipe Out the Ministry.

Tokio, July 21.—Desultory rioting continues in Seoul, where General Hasegawa is in command of the Japanese forces.

At the suggestion of Prince Ito the various consulates have accepted Japanese guards. It is reported that three American warships and an English cruiser are expected at Chemulpo this afternoon, and that they will land marines to protect the consulates.

It is said that the rioters who were surrounding the premier's residence yesterday were dispersed by the Japanese police with the assistance of artillery. The Premier fled for refuge to the palace, and the other ministers went to the Japanese residency. It is alleged that the plot was reported to Marquis Ito and that it was to the effect that the Imperial guard had been clandestinely ordered by the ex-Emperor to enter the Palace at midnight and murder the whole cabinet, which was responsible for his abdication. This is the official explanation of the fact that the Japanese acted as a garrison for the police.

The ceremonies attending the accession of the Crown Prince were carried out at 10 a.m. In response to request 80 Japanese and other officials, including Marquis Ito, with his general staff, and many consuls, were received in audience by the Emperor at 4.30 o'clock this afternoon.

Tokio, July 20.—Fears are entertained here lest the Emperor of Corea, feeling too keenly the disgrace of his compulsory abdication, will commit suicide. Such an act would not be extraordinary in a man of his race, for since the Russo-Japanese War, several Korean officials have taken their own lives.

Despatches from Seoul tell that the actual process of abdication was not completed until this morning. The Korean Cabinet has asked the Japanese to announce the abdication to the powers.

Seoul, July 21.—There was some outward improvement in the situation today, and General Hasegawa, commander of the Japanese troops in Corea, withdrew one of the machine guns, from the palace square. He regards the situation now as being well in hand.

The Government arsenals are guarded by Japanese soldiers, although the number is not large, and they are under orders to explode the magazines if they find themselves unable to defend them.

The Korean troops are frequently harangued by civilian agitators at the entrances to the barracks. The Koreans possess ninety thousand rounds of ammunition, of which General Hasegawa has only 2,000 troops in Seoul, has been unable to obtain the surrender.

The Ping Yang Regiment, which was reported as having been disarmed, still refuses to surrender its arms or ammunition.

The Japanese commander is not able to assure safety in the streets, but he is making the best use possible of his men, while awaiting reinforcements, which are now on their way from Shimonsaki.

Marquis Ito, the resident-general of Seoul, will not consent to the enforcement of martial law, but he is re-garrisoning the country so far as possible, as a precaution.

The new Emperor's first edict orders the punishment of the Korean delegation to the Hague.

The abdication edict of the Emperor in his first communication to the world since the repudiation of the convention of 1905. A translation of the text of the edict follows:

"I have been in succession to my ancestors on the throne 44 years, and have met many disturbances. I have not reached my own desire. While ministers are frequently improper men and progress is not controlled by me, the times are contrary to nature's laws. A crisis extremely urgent in the life of the people has arisen at the progress of the state is more than before imperiled.

"I fear a danger like that that befalls a person crossing the ice. Fortunately we have a son endowed by nature with virtue, brilliant and worthy of being charged with the task for the development of the Government to whom we transfer our inheritances, sanctioned by the customs of ancient times.

Therefore, be it known that as soon as it is proper to be done we will hand the affairs of state to the Crown Prince as our representative."

Court usage is said to make the meaning of the above an actual abdication.

While insufficient time has elapsed to show the effect of the Emperor's action upon the situation, advisory opinion at the Japanese residence-general regards the abdication as taking away the force of Japan's intended blow.

The Japanese residency here has generally placed the whole responsibility for the arrests made this morning on the state, disclaiming intervention which it is asserted would be an unnecessary invasion into affairs which are purely Korean. On account of the fact that every Japanese soldier here is needed to guard the barracks of the Korean troops, guards have been refused to two houses of foreigners in the suburbs and their occupants, who have been threatened by anonymous communications have been given refuge in the foreign quarter of the city. Reinforcements of Japanese troops are not expected until July 24th, and it is impossible to adequately patrol the whole city so as to prevent the gathering of the mobs which have assembled during the last two days.

QUARANTINE OF ANIMALS.

Ottawa, July 21—By order-in-council the regulations relating to animals quarantined is so amended as to read: "Quebec is also declared to be an animal quarantine station in so far as importations into Canada by sea as importations. Animals, other than swine, may be admitted on inspection at other ports only, for purposes of exhibition, or other temporary stay, subject to the usual customs regulations."

SHIPPING NEWS

STEAMER QUEBEC

Completely Rebuilt and Improved Again on the Quebec-Montreal Route.

The Richelieu & Ontario Navigation Co.'s steamer Quebec, after being considerably lengthened and her upper works, cabins, etc., rebuilt, arrived here yesterday morning from Montreal, and berthed at the company's wharf. Shortly after the steamer reached port she was visited by a representative of the Chronicle who had the privilege, through the courtesy of Mr. M. P. Connolly, the gentlemanly agent here, of inspecting the vessel throughout. Boarding the steamer by the after gangway the visitor enters a large vestibule or sitting room. This apartment is plentifully supplied with large arm chairs, the floor being covered with linoleum. Off this room are the purser's and other offices, where passengers desiring information may obtain it. Immediately aft, on the main deck, is the dining room. This apartment is remarkably well lighted and ventilated. The ceiling is buff colored, the wall being in dark oak. There are twenty tables, each affording accommodation for five persons. Leaving the dining room and ascending a broad stairway one reaches the saloon which extends about three quarters the length of the vessel. It is richly carpeted in green, with the monogram of the company worked into the material at short intervals. The walls of the saloon are salmon colored. A gallery extends around the apartments for the use of passengers occupying the upper berths. The whole extensive cabin is brilliantly illuminated by electric lights placed in the corners of the ceiling. There are 202 staterooms and 12 parlor rooms, while there are eight bathrooms, four on each side of the saloon. On the boat or hurricane deck is placed the smoking room, neatly fitted up for the accommodation of the lovers of the weed. On this deck is a splendid promenade which extends from the wheel house to the stern of the steamer, and will no doubt be well patronized on fine evenings. While the steamer at present presents a splendid appearance it may be stated that the decorations intended for her are not nearly completed. The Quebec is well supplied with boats, life rafts, life preservers, etc., in case of accident. Life pumps, with hose attached, are to be met with at all points in the vessel. Before being placed on the route, the Quebec was tested by Mr. Angstrom, naval architect, and declared to be all in every respect. This is the gentleman who designed the company's steamers Montreal, Kingston, Toronto and Rapid King, which have proved so successful on their respective routes. The Quebec is commanded by Capt. Angus Baker, who has had extensive experience in command of steamers both in the upper and lower St. Lawrence, his present officers being men for many years in the employ of the company. There is little doubt but that the Quebec will become as popular as her consort—the Montreal.

To Make an Airship

Make two paper cones. Close the small end of each with a cork, as shown in Figure 1.

Thrust a needle through each of the corks. Bend the points of the needles that protrude from the corks toward the inside of the cones, so as to form hooks. Run a strong elastic from one to the other of these hooks.

Paste your cones together, joining them with a band of thin paper. Bend the part of the needle that sticks out from one of the corks at right angles to form a sort of handle.

Cut out a screw propeller like that shown in Figure 2. Attach it, between balls of wax, to the needle at the other end.

Cut out little wings and paste them at the middle of each side of the cones, so that they will serve to balance your airship in its flight.

Suspend a little "basket" to the cones by threads and your airship is complete.

To make it fly, turn the handle at one end, so that the elastic is twisted

tightly. Upon releasing it, the elastic will turn the corks, causing the propeller to revolve rapidly. Your airship will continue to fly until the elastic is unwound.

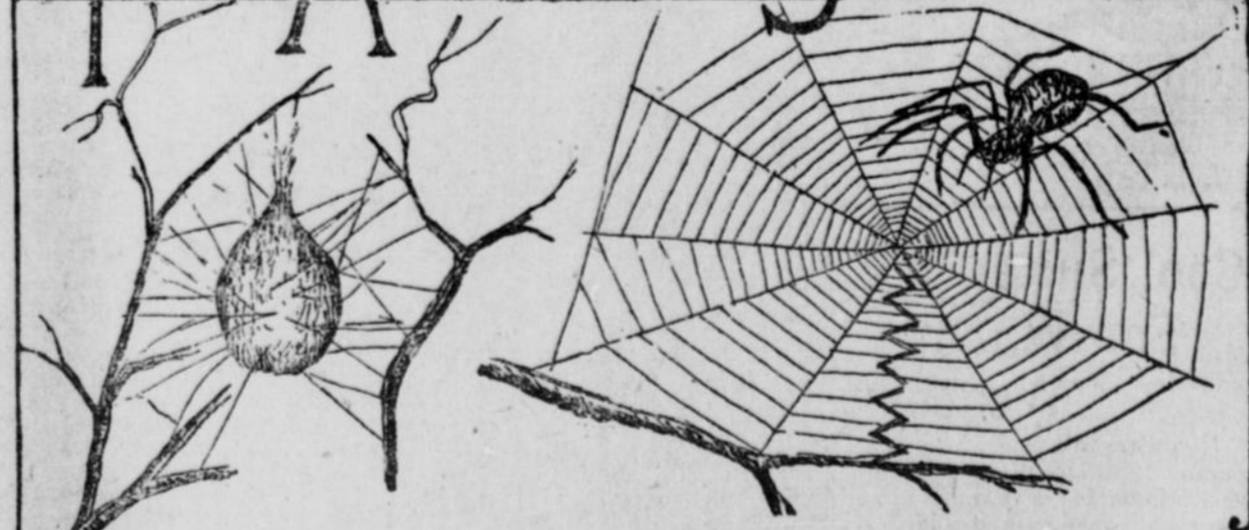

PLEADING FOR HAYWOOD'S LIFE

Addresses to Jury Now in Progress

CROWDS IN COURT-ROOM

Orchard had No Connection with the Defendant, whether Former was Guilty or Not.

Boise, Idaho, July 22.—For four hours and a half to-day E. F. Richardson pleaded with the jury for the life of Wm. D. Haywood. Under order of the court the hours for the day's sessions were changed and instead of sitting in the afternoon court met at 6 o'clock this evening. Judge Wood was informed by the jury that the extreme heat of the court room was too trying on some of the jurors and he complied with the request for a late evening session.

The preliminary hearing of the case of Dr. I. L. McGee, one of the witnesses for the defense, charged with perjury, came up this afternoon and will be continued to-morrow. Orchard was on the stand for over an hour and was given a severe grilling in the cross examination by McGee's counsel. The prisoner's witness, however, maintained his characteristic calm throughout. He denied that he was in the Coeur D'Alenes at the time McGee swore to a meeting with him at Wallace.

C. W. Aller, the other witness for the defense, who is under perjury charges, was to-day bound over for trial in the district court. The excellent character and consistent philanthropy of the Western Federation of Miners; the patient suffering of labor under lash of capital and perjury and perfidy of Harry Orchard were the main points in the opening argument presented this morning.

In spite of the sweltering heat, every seat in the court room was occupied long before the opening of the session.

Mr. Richardson had subdivided his argument under eleven heads, which he enumerated to the jury this morning. At the evening session he said he would do all he could to abridge his remarks on account of the heat and he believed he would be able to finish some time to-morrow.

The contention of the defense, Mr. Richardson declared, was that no matter whether Orchard committed the crime which he confessed or not, no connection had been shown between Orchard and the defendant. Discussing the "Indicator" mine explosion, Mr. Richardson declared that the preponderance of testimony showed it was an accident.

Orchard's testimony as to receiving money from the Western Federation of Miners for crimes was not corroborated by a single witness. Mr. Richardson asserted, and should not be considered. As to the coming of militia to Cripple Creek, Mr. Richardson said that they came at the behest of the Mine Owners' Association, whose members were assessed so much a month to buy the certificates of indebtedness issued by the State.

Mr. Richardson declared that while under the ruling of the court he was not allowed to discuss the deportations from Cripple Creek or the employment of detectives with various miners unions, he wanted to reveal as much as possible on conditions in Colorado. DEATH PENALTY

Decreed for Prof. Hau, who Murdered His Wife's Mother.

Karlruhe, Germany, July 22.—Karl Hau, a brilliant young law professor of Washington, D.C., was condemned to death this morning after a five days trial, for the murder of his wife's mother, Frau Molitor, a wealthy resident of Baden-Baden, in that city November 6th last.

The prisoner heard the verdict of the jury with perfect composure and chatted amiably with his counsel after the judges withdrew to fix sentences. Upon the return of the judges, Hau arose and standing erect with folded arms, listened to the sentence without moving a muscle. A moment later he was hurried away to prison by half a dozen policemen. The sentence is unpopular with the street crowds, which have been demonstrating more and more openly for several days in Hau's favor and against the Molitor family. After the adjournment of the court for an hour's recess at 8 o'clock last evening the women of the Molitor party were compelled to remain in one of the offices of the court house because it was dangerous for them to appear in the streets. A carriage waited for them in the court yard, and it was several hours before they were able to leave. Meanwhile, enormous crowds had assembled in the streets adjacent to the court house. Cordons of police kept the crowd at bay for an hour or more, but then lost control of them, the masses pushing and crushing forward to the doors, with the evident intention of storming the entrance.

A BLIND MAN'S SUCCESS

Kansas City, July 19.—T. D. Gore, nominated by the Democrats of Oklahoma for United States Senator, which action is equivalent to election, as the new State is strongly democratic, has been blind since he was 11 years old, when he accidentally shot his right eye out with an arrow gun. At that time he was a page in the Mississippi Senate. Three years before, a playmate while in boyish passion, had blinded his left eye with a stone.

Gore has won laurels in politics and the law. A page at 11, novice for the Legislature at 13, popular elector at large in Mississippi three years later, unanimously elected in 1900 for South Dakota speaking for the fusion ticket—such is the political history of Thomas Fryer Gore. But always he was defeated. He never held office since he was a page in the Mississippi Senate.

Gore's character is best portrayed by these instances: When told by his father that he must prepare to attend a school for the blind he replied: "I will go to school at home. A blind school will furnish neither the books nor the opportunity I seek." And he did. Charles Pitman read his books to him in the normal school he took first honors in his class. All through the normal and the university, memory was young Gore's reliance.

That acute memory defeated Congressman Money, now a United States Senator from Mississippi. The congressman was to speak in Hohenlinden. Gore then 20 years old, requested a division of time. Mr. Money, who had heard of him, rudely replied: "I will speak as long as I please; you may do the same."

Money harangued the voters for three hours, never dreaming that young Gore would reply. The young man waited patiently until his time, and then entertained the crowd for four hours. He quoted the Congressional record, page by page, of his celebrated antagonist, ridiculing him unmercifully. At the close the thoroughly enraged Money, remarked: "If you were not blind I would debate with you in another way." The reply was: "Congressman, blindfold yourself and march out." But the challenge went unheeded.

RECORDED COURT.

Yesterday was a record day at the Recorder's Court, no less than fifteen prisoners, who had been gathered in on Saturday and Sunday, being called on to explain why they indulged in something stronger than water, so freely. As they were all plain drunks, they were allowed to go on paying \$1 and costs each.

FIANCE JILTED FOR BRIDESMAID

Mariden, C ont., July 22.—Miss Sophia Victor to-day brought suit against Frank Mita for \$1,000 damages for alleged breach of promise to marry. There was to have been a June wedding. A week or so before the day set for the ceremony Miss Victor introduced her fiance to Miss Julia Rudolph, who was to be her bridesmaid.

The plaintiff says that Mita straightway became attentive to the maid-to-be. He postponed the wedding. When urged by Miss Victor to keep his promise to her she says he refused, and said that Miss Rudolph was his intended wife. The plaintiff further states that she gave Mita \$300 with which to buy household furnishings.

RECORD RUSH TO EUROPE

New York, July 22.—According to the figures of the North Atlantic conference the eastbound trans-Atlantic passenger traffic from this port for the last six months has far exceeded the corresponding figures of 1906. The report of the conference shows that, while there has been a remarkable increase in the number of first cabin bookings, the demand for the second cabin and steerage accommodations has been phenomenal.

Comparing the number of persons who sailed for Europe between January 1 and June 30 in the years 1906 and 1907, it is shown that there has been an increase in the first cabin departures of 2,768. The second cabin has increased 9,140, and the steerage demand has increased 31,204.

DISCOVERY OF PAPYRI

London, July 22.—An interesting discovery of papyrus was recently made at Edfu, Upper Egypt, near the site of an old Coptic monastery, and the parchments have been brought to England, where there is some disposition to regard them as a valuable addition

to the "Sayings of Christ" found by Grenfell.

At Edfu recently a native accidentally laid bare a small, tomblike receptacle. In this were found a number of parchment manuscripts bound in thick papyrus covers. The native sold them to an Arab dealer for a few dollars, and the Arab resold them to a Copt for \$2,500. Then the find came into the hands of Mr. De Rustafjaell, a well-known explorer, who brought it to England.

The manuscripts have already been identified as unique Coptic Greek ecclesiastical manuscripts of the ninth and eleventh centuries of great archaeological importance, and about a dozen rolls of sixth century Greek papyri. Among the latter are twenty-five leaves of apocryphal saying of Christ in a Coptic translation of the lost Greek original, of which previously only thirteen leaves were known, twelve in the National Gallery in Paris and one at Berlin. The discovery also comprised parts of the Gospels of Matthew, Mark, and Luke in Greek and Coptic; the Apocalypse of St. John in Coptic, a history of miracles of Cosmos and Damien dated in the sixth century, a sermon by St. Pisenstios in Coptic, and a unique manuscript in the Nubian language dealing with the life of St. Hecce and the orations of the Nicæan Council.

Only fragments of manuscripts in the Nubian language had been discovered hitherto. There are very few scholars in the language and scarcely any published literature. Hence the present volume, which is an excellent state of preservation, is of first rate importance.

From the dedication in one of the manuscripts the monastery on the site of which they were discovered is proved to have been named St. Marcurus of the Mount at Edfu. One of the volumes is a history of the martyrdom of St. Mercurius. A modern Coptic monastery stands near the site, but the name of the older foundation had been entirely lost until this discovery.

Egypt has also yielded another find to Mr. De Rustafjaell's researches. In the desert in Upper Egypt, on the left bank of the Nile, he found among the remains of palaeolithic flint factories a number of crude, weather-beaten limestone vessels resembling troughs and potlike ironstone concretions. He holds them to be of the palaeolithic age. They are certainly older than the Neolithic age, which covered a considerable period in Egypt before the advent of the first dynasty in B.C. 4400.
