THE TALK OF THE DAY.

Lieutenant-Governor SCHULTZ, of Manitoba, has been in Ottawa. It is said that his business with the Government was to obtain re-appointment to his present position for another term. But the Liberal press thought that it knew better, and quite a panic has arisen in the ranks of the Reformers, on account of His Honor's presence, at this time, at the Capital. They declare that a coup d'etat has been arranged between Dr. SCHULTZ and Sir MACKENZIE BOWELL, by means of which the GREENWAY Cabinet will be dismissed. The grounds set out for this alleged action on the part of the Lieutenant-Governor are silly enough, and the strange thing about the whole matter is that some really sensible people believe the story. It is said that a Attorney-General of Manitoba committed a serious blunder in interfering in the Haldimand election, and in speaking there against Dr. MONTAGUE. His conduct, it is said, enraged the Federal Government, and that steps were at once taken to cut off Mr. Sirron's political head, and along with his head those of his colleagues would have to go. Of course, this nonsensical talk had no foundation. The Federal Government is not composed of spoiled school boys, but of men, who care very little about Mr. Sirron and his inflammatory speeches. Dr. SCHULTZ has made an excellent Governor, and at no time has he come into unfriendly relations with his political advisers, no matter what side of politics they were on. It is not possible that he would end his career by adopting questionable tactics, a few weeks, perhaps days, before a successor steps into his place. The dismissal of the GREENWAY Cabinet would be a very different thing from the dismissal of the MONTAGUE Ministry. There is no similarity in the two cases at all. Mr. ASHES' course was thoroughly constitutional, and his act, though drastic, saved the Province from absolute ruin and destruction. The people, all over Quebec, applauded the conduct of the Lieutenant-Governor, and, speaking through the ballot box, they sent him a powerful support, thus sustaining his views on the constitutionality of his act to the very letter. Mr. Sirron may have lacked taste in invading a county of another Province and taking part in the election then going on. But he committed no offense against the Constitution, nor could his act be regarded as a crime. He was invited to speak in the county, and to present his view of the Manitoba School question to the electors. This he did, and he did it so well that Dr. MONTAGUE had the largest majority that he ever had in his life. The Lieutenant-Governor of Manitoba could not dismiss the GREENWAY Government on a question arising out of Mr. Sirron's conduct in Haldimand and expect the people of his Province to support him a single day. He is too sage a man of the world to try it. He is too fair-minded of a man to even think for a moment of doing such a thing. But the Liberals got a terrible fright over His Honor's little visit to Ottawa, and the Liberal newspapers, from the Toronto Globe to the Montreal Witness, went into hysterics. They are probably calmer now.

HOUSE OF COMMONS.

OTTAWA, April 29.—Private members had the House all to themselves this afternoon and managed to get through a very full order paper before the Speaker felt himself called upon to retire for dinner.

Mr. Geoffrion, the newly elected member for Vercheres, was introduced by Hon. W. H. Laurier and Mr. McLaughlin, and was received with loud applause from the Opposition benches.
