## World News In Brief

**Grandview, Mo., May 23.—(P)**—The "weak" condition of President Truman's mother raised the possibility today that he may remain in Missouri indefinitely unless there is a decisive change for the better.

While 94-year-old Mrs. Martha E. Truman was reported holding her own, there has been no perceptible improvement in the last 24 hours. She was "still very weak."

Brig.-Gen. Wallace H. Graham, presidential physician, informed newspaper men last night that her condition was "unchanged."

The president, after a week of long hours at her bedside, was torn between two roles. He had important affairs in Washington, but he feared the effects of his departure on his mother's condition.

**London, May 23.—(P)**—Workmen speedily unloaded three tons of strawberries from a wrecked airplane at Croydon Airport today while fire engines stood by in case of emergency.

The under-carriage of a freight-carrying Viking of Hunting Air Travel, snapped when the plane landed on a flight from Verona, Italy. The wheels were thrown up into the engine and the propellers buckled. The five crew members scrambled to safety. There were no passengers.

**St. Hyacinthe, May 23.—(P)**—Three Montreal men charged with the theft of approximately \$90,000 in cash and bonds from a wrecked airplane at Croydon Airport today while fire engines stood by in case of emergency.

**Montreal, May 23.—(P)**—Two men and a woman were arrested yesterday for the theft of Government cheques from a mail box as police probed a situation of mail thefts described as becoming so alarming that it is almost beyond control.

Police said hundreds of complaints have been received from persons whose mail boxes have been looted. They identified those arrested as: Fernand Drouin, 21, Georges Martel, 22, and Noella Larue, 21. They were charged with theft and receiving, false pretences and with cashing a stolen cheque and will be arraigned today.

## Judge Marier To Decide May 30 If Mrs. Ducharme To Stand Trial

### Non Confidence Motion May Be Submitted To Vote Today

**Ottawa, May 23.—(P)**—The government may face today the first vote on non-confidence motions moved during the debate on the budget brought down April 29.

Liberal members said last night they had been instructed to remain in Ottawa on the possibility that a vote will be taken on the C.C.F. motion of non-confidence.

This motion called on the House to express regret that the government had provided no relief for those Canadians who do not earn enough to pay income tax and that the basic exemptions for income tax payers had not been increased.

The motion was in the form of a sub-amendment to a Progressive Conservative motion which said the budget had provided no encouragement to agriculture and mining and given no indication that the government planned to reconvene the Dominion-Provincial conference.

Dominion-Provincial relations were brought into the two-week-old budget debate by several speakers yesterday.

Donald Fleming (PC—Toronto) said the Dominion should vacate much minor fields as those on amusements, parimutuels

and electricity. He said that the use of such fields was one of the few things which stood in the way of agreements with all the provinces.

He said some way had to be found to bring about agreement at a general conference, but the Dominion was persisting in its refusal to bring about such a conference. The fact that Liberal members were calling Premier Duplessis of Quebec and Premier Drew of Ontario "hard names" would not hasten agreement.

Frederic Dorion (Ind—Charlevoix-Saguenay) argued that under the British North America Act the provinces had a priority in direct tax fields. He said Privy Council judgments made it clear that the B.N.A. Act meant that the provinces were to satisfy their needs in the direct taxation fields. When those needs were satisfied the Dominion could move into the fields.

Gerard Cournoyer (L—Richelieu-Verchères) took issue with Mr. Dorion and said the judgments referred to were bankruptcy cases.

He quoted the same judgments

Judge Joseph Marier yesterday afternoon reserved decision on a motion for non-suit presented by the defence at conclusion of the Weston woman's preliminary hearing and said that he would make his findings known on May 30th.

The motion for non-suit was presented by Cesaire Gervais, K.C., defence counsel, when the Crown declared its case closed following the testimony of Emilien Guay, whose friendship with Mrs. Ducharme was claimed to have twice caused her husband to attempt suicide, and of Dr. Gerard Lemieux, who said that he had sold Guay's son, Fernand, an ounce of arsenic in November, 1945.

Mr. Gervais asked that his client be liberated at once and said that the Crown had failed to incriminate her in any way in her husband's death. On the other hand, Roland Dugre, K.C., crown prosecutor, said that a strong case had been built and that sufficient evidence had been produced to warrant committing the accused to trial.

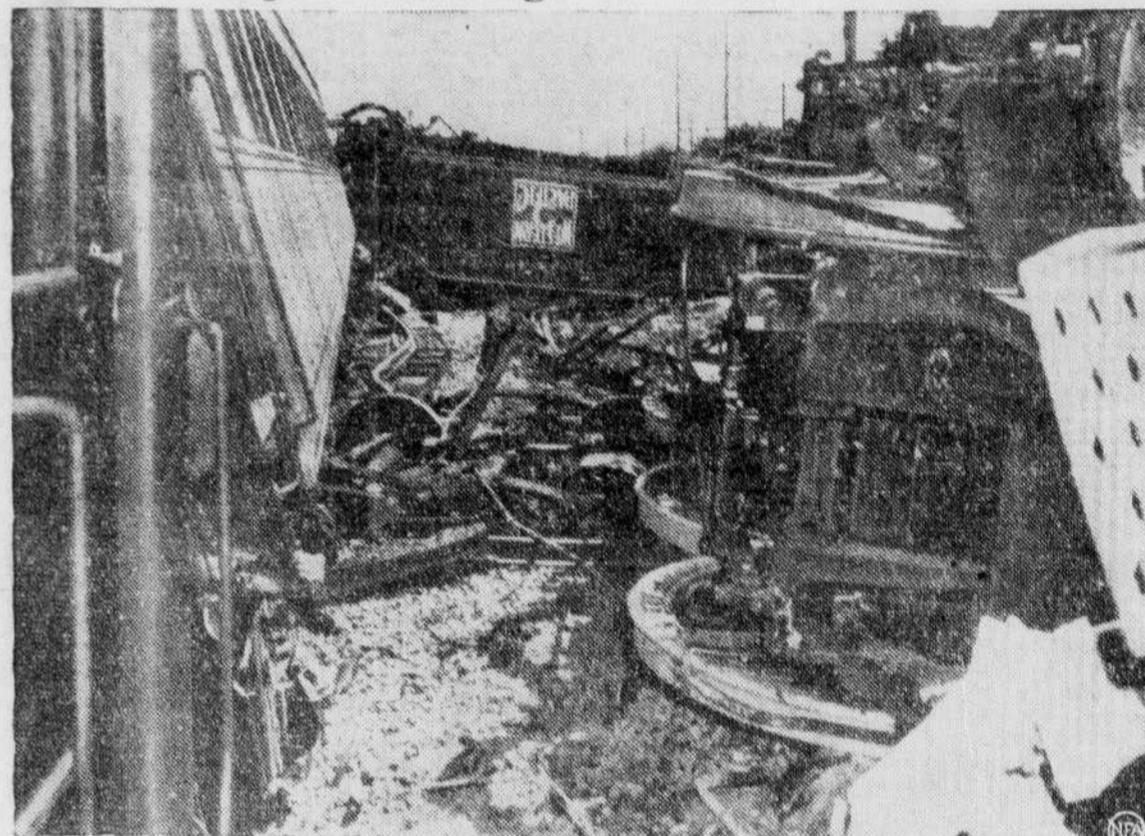
Yesterday's proceedings were featured by the testimony of Emilien Guay, who had thrice refused to give evidence and as a consequence had been confined to the jail on Winter street for the past two weeks. Guay was liberated after giving evidence.

Dr. Lemieux testified that he sold about an ounce of arsenic to Guay's son, Fernand, in November, 1945, and explained that he kept the poison for the convenience of his farmer-clients who used it to treat horses.

The formal charge of murder was laid against the Weston widow on March 1 after a coroner's jury had found her criminally responsible for the death of her farmer-husband who died February 5, 1946, of a dose of arsenic.

## Close Watch Will Be Kept Over Balkans

### U.N. Group of Trouble-Shooters Given Free Hand To Maintain Vigil Over Turbulent Frontier Areas.

**Lake Success, May 23.—(P)**—A special group of United Nations trouble-shooters was given a free hand today to maintain a close watch over the turbulent Balkan frontier areas.

The way was cleared for an indefinite vigil on the Greek northern borders when the United Nations Security Council rejected last night a Russian proposal which would have curbed the powers of a subsidiary investigating commission and ordered it to move from Salonika to Athens.

The council's action was taken after Albania, Yugoslavia and Bulgaria threatened to boycott the U.N. border group by refusing to cooperate with its members or permit them to cross their frontiers.

Most delegates believed that the Slav countries now would cooperate with the sub-commission, established last month by the council to carry on the border watch while the Balkan Investigation Commission drafted a report of an inquiry into frontier incidents.

The commission now is in Geneva preparing a report of its findings. The report is expected to be submitted to the Security Council by June 9.

By overriding the Soviet proposal, the council upheld a previous decision to permit the subsidiary group to remain on the Balkan borders until action is taken on the commission's report.

The United States and other countries on the council had charged Albania, Bulgaria and Yugoslavia with refusal to cooperate with the council and with defiance of the United Nations. The three countries answered that they never had refused to cooperate with the Security Council; that the commission had exceeded its authority in passing on its orders to the sub-commission; that the sub-commission was illegally created; and, finally, that the council should clear up the whole situation with precise instructions to the commission.

Meanwhile, the five major powers failed in another attempt to reach agreement on a candidate for the governorship of Trieste.

The five-power delegates interrupted their Balkan debate yesterday to discuss briefly this issue. But authoritative sources said Soviet Deputy Foreign Minister Andrei A. Gromyko rejected half a dozen candidates proposed by the western powers.

The western powers turned down two names submitted by Russia.

## Wider Powers Demanded By Ont. Indians

### Affirmation of Their Original Treaty Rights Also Sought by Delegations Representing Six Nations Reserve.

**Ottawa, May 23.—(P)**—Seeking greater powers of self-government and affirmation of their original treaty rights, Indians from most parts of Ontario will be cross-examined today on briefs they have placed before the joint Parliamentary Committee on Indian Affairs.

The delegations represent the Six Nations reserve, Brantford, and tribes at Manitowlin Island, James Bay, Lake Simcoe and Kenora-Rainy River.

Most of the briefs presented to the committee see today called for extended educational facilities, greater autonomy, tax exemptions, extended social services, abolition of parochial schools and reinstatement of "violated" treaties.

A minority group from the Six Nations reserve, one of the largest in the Dominion, asked for revival of the original treaties and the hereditary system of tribal government.

Sam Lickers of the Grand River Country, spokesman for the minority, said the Indian Act of 1924 was unconstitutional because it violated the treaties which had been made by the Crown and the Indian tribes on a "nation-to-nation" basis.

## Yugoslavia Blamed For Greek Clash

### U.N. Balkan Investigating Commission Finds Yugoslavs Primarily Responsible for Guerilla Warfare — Albania, Bulgaria Also Blamed.

**Geneva, May 23.—(P)**—Russian and United States sources said the United Nations Balkan Investigating Commission approved by an 8 to 2 vote today a conclusion that Yugoslavia was primarily to blame for support of guerilla warfare in Greece and that Albania and Bulgaria were blameworthy to a lesser degree.

The conclusion said conditions in Greece were a contributing factor.

By vote of 8 to 2, these informants said, the commission also approved a conclusion that such support of armed bands violating Balkan frontiers constituted a threat to peace.

Russia and Poland voted against this conclusion, the informants said, while the United States, United Kingdom, France, China, Belgium, Australia, Colombia, Brazil and Syria supported it.

On the conclusion concerning blame, they said, the same nations registered approval and Russia and Poland voted no, with France abstaining on the ground that such a conclusion should be left to the United Nations Security Council.

The actions were said to have been taken in a closed session of the commission, which came here to write its report for the Security

## No Arrests Made In Bride's Death

### Orillia, Ont., May 23.—(P)—The cryptic words that "the investigation is far from being completed" from Provincial Police Inspector Thomas Wright today left this report neighborhood keenly speculating on the mysterious case of the drowned bride. ## Recommend Higher Tax Exemptions

### Liberal Member for Shefford Declares Present Taxation Level Does Not Allow Workers to Meet Their Obligations.

**Ottawa, May 23.—(P)**—Marcel Boivin (L—Shefford) said last night in the Commons that workers should be given income tax exemptions which would allow them "to meet their obligations."

The present exemptions of \$750 for single men and \$1,500 for married persons were too low, said Mr. Boivin during continued debate on the budget. At present the cost-of-living and the low income tax exemptions made it impossible for workers to balance their budgets for a year.

If a change was not made married couples would be forced to take their children out of school to earn money which would be used to balance the family budget.

Mr. Boivin said he was a member of the working class until 1945. He knew the troubles of the worker. He had been told by a Granby, Que., merchant that goods were as much as 70 per cent higher than in pre-war years. And frequently higher prices had to be paid for products of inferior quality.

Mr. Boivin said he wondered if price controls had not been lifted too quickly.

He said he was not surprised to read that more than 300,000 had not paid in full their 1946 income tax. He believed the amount of arrears would increase unless the rate of exemptions was changed. Although the exemptions were too low, the budget was interesting in that it reduced income tax from 29 to 54 per cent.

Mr. Boivin said he was pleased with Finance Minister Abbott's announcement that Canada was not going to make any more long-term loans to other countries.

## Offer Made By Amputee To Aid Vets

### 35-Year-Old Housewife and Schoolteacher, Who Lost Both Legs and One Arm When Nine Years Old, Offers Farm Home to Help Disabled Veterans.

**Hazel Dell, Sask., May 23.—(P)**—A 35-year-old housewife and school teacher who lost both legs and an arm when she was nine years old, today is offering to leave her farm home to help in the rehabilitation of Canada's legless or armless veterans.

Mrs. George Taylor of this district 120 miles northeast of Regina, hopes to have her offer before the proper authorities before she gives up her teaching position at the end of June.

"What I have done for myself I can do for others," the attractive mother of two said. "There was a time when I was shy and conscious of my amputations but not today. I feel I could restore confidence in any of the boys who were overseas who have suffered amputations."

Mrs. Taylor, born Kate Gulka, who does her own housework, lost her legs and arm as well as a thumb and one finger on her left hand while on her way to school at Yorkton, Sask., in 1911.

A freight train started up while she was crossing the tracks beneath the cars.

When she left hospital three months later she continued her education, completing it at Normal School at Saskatoon. Her artificial limbs were changed as she grew.

She began to teach at the small Turnout school near Hazel Dell in 1931 and two years later married George Taylor, a district farmer. They have a son, Robert, 12, and a daughter, Lorraine, 10.

Mrs. Taylor, who knits, peels her own potatoes, and cuts her husband's hair, went back to teaching her class of close to thirty pupils in 1935 when a teacher was needed in the district and the family's finances needed bolstering.

The couple find that the farm is not producing as they had hoped and they are leaving the district. Mrs. Taylor hopes to find employment as a disabled veterans' instructor.

"It is merely a matter of one's approach," she said of the problem of rehabilitation amputees.

## BAIL GRANTED MADELEINE PARENT

**St. Jerome, Que., May 23.—(P)**—Officials of the United Textile Workers of America (A.F.L.) today expected the release of Madeleine Parent, charged with seditious conspiracy and intimidation in connection with the seven-week strike at Avers textile mill at Lachute, Que.

Miss Parent was granted \$5,000 property bond bail by Judge Aime Chasse yesterday but remained in a cell overnight. Miss Parent was released providing she did not continue to participate in the Lachute strike activities.

## Canadian Taxpayers To Pay Part Of Polish Girls' Way

**Ottawa, May 23.—Hon. James MacKinnon, acting Minister of Immigration, is expected to make a statement in the House of Commons today attempting to explain why the Canadian taxpayers should be called upon to pay a part of the cost of bringing 100 Polish girls from displaced persons camps in Germany to work in the spinning mills of Ludger Dionne at St. George de Beauce.**

M. J. Coldwell, C.C.F. leader, brought up the Polish girls issue in the House again yesterday when he said that many reports had been received on the movement and these were very conflicting and he believed that Mr. MacKinnon should make a statement clearing up obscure points.

Mr. MacKinnon is expected to give information asked by Mr. Coldwell on the terms of contract under which the girls are being admitted and also explain how Canadian taxpayers will be called upon to pay indirectly part of the cost of flying the girls to Canada through the contribution made by the Inter-Governmental Committee for Refugees. The bill for transportation, to be footed by Mr. Dionne, Liberal M.P., for Beauce, and the Committee, will total about \$42,500.

Canada makes contributions to the committee, which was set up by the Allied countries to look after displaced persons and refugees, but the contributions have not been large. Toward administrative expenses the Dominion pays about 4.4 per cent of the total budget. Last year the Canadian contribution amounted to only \$8,566.

The much larger contributions for operational expenditures are voluntary, each of the participating countries paying whatever it wishes. To this side of the committee's budget Canada has made only one contribution. This was made last year and amounted to \$48,263 (about \$211,000) of the organization's total budget of \$1,373,000. Bulk of the contributions are made by the United States and the United Kingdom.

One Government source said the contribution by the committee toward bringing the Polish girls to Canada would seem reasonable under the organization's aim of resettlement in new homes of refugees and displaced persons.

The Inter-Governmental Committee for Refugees was set up in 1938 at a meeting in Evian, Switzerland, called by the late President Roosevelt. At that time its purpose was to care for political and racial groups of refugees, many of whom had escaped from Germany. It is expected the committee will be replaced by the International Refugee Organization to be set up by the United Nations.

## MARTIAL LAW IN SHANGHAI

**Shanghai, May 23.—(P)**—Martial law was declared in Shanghai and Peiping today in an attempt to halt demonstrations in which students in both cities defied authorities in demanding an end to the civil war.

More than 40,000 students in Shanghai began a new two-day strike in protest against the beating of students by police during a demonstration in Nanking Tuesday.

Mayor K. C. Wu earlier invoked martial law and threatened severe punishment to any person instigating student or labor strikes, disseminating propaganda in schools, occupying school property or preventing anyone from attending classes.

Eleven law college students were reported arrested, but students went ahead with plans for huge demonstrations tomorrow. The government at Nanking also has issued a ban against demonstrations.

Officials have charged the student strikes and anti-war parades are communist-inspired.

## 13,000 NS Miners Are Today Voting On Settlement Plan

**Glace Bay, N.S., May 23.—(P)**—An added twist entered the Maritime coal strike picture today as the membership of district 26 United Mine Workers (C. C. L.) cast their ballots for or against a formula designed to end the 97-day walkout.

Following a meeting at Minto, N.B., where union heads met with independent operators, Minto Board Member Frank Guss said last night the full executive board of the U. M. W. would meet here Monday to decide whether Cape Breton miners would return to work pending settlements of the wage question in the Minto coal belt.

District President Freeman Jenkins, scheduled to arrive back here today after the Minto conference, said Minto coal miners would have to receive the same increase granted Nova Scotia miners. He had placed the union demands before the operators and expected the companies' replies at a further conference June 2.

Demands made to the operators were the same as those embodied

## Right Man Being Sought To Run Aid Program In Greece

**Washington, May 23.—(P)**—President Truman's difficulty in finding a top-notch man to run the new United States aid program in Greece threatens some delay in getting the operation under way.

The State Department already is reported acquiring a \$100,000,000 Reconstruction Finance Corporation loan to finance the start of the \$400,000,000 undertaking to buttress Greece and Turkey against any extension of Soviet power over those countries.

But officials made it clear that despite the availability of money and the authority granted by Congress in the bill which Truman signed yesterday, nothing really substantial can be accomplished until an administrator is appointed and takes over his duties.

Diplomatic officials were hopeful this might be done today. But they were uncertain whether it could be. At least five men have been considered but for a variety of reasons each has proved unavailable. Inside speculation at the moment concerns Paul Hoffman, president of the Studebaker Corp. No hitch is anticipated in carrying out the \$100,000,000 Turkish part of the program. That involves mainly supplying military equipment to the Turkish army under the general supervision of Ambassador Edwin Wilson at Ankara.

But the program for Greece is much broader, embracing not only military assistance, but economic rehabilitation as well. In addition

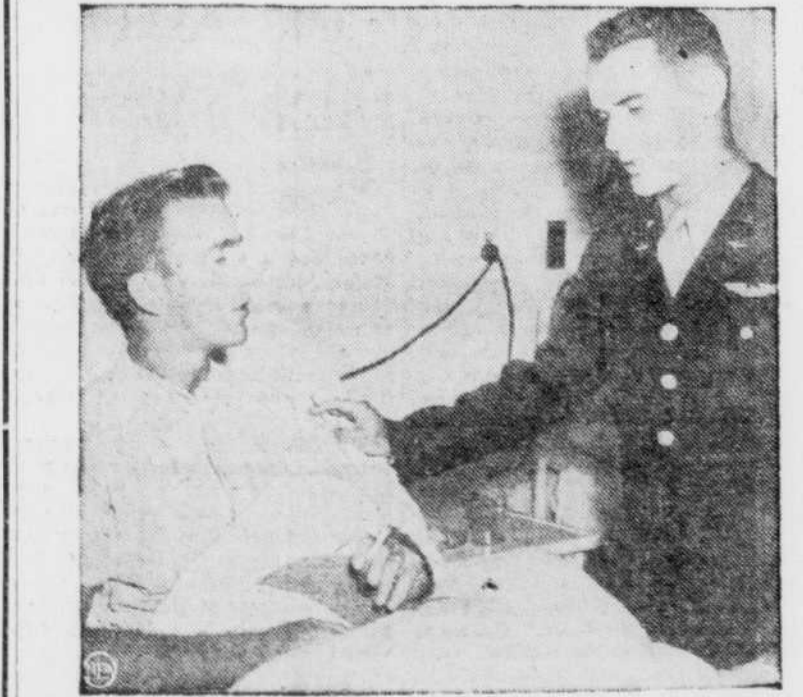

## 'Buzz' Beurling In Sherbrooke To Consider Airways Co. Offer

Tales of spectacular behavior and wild antics weaved around George F. "Buzz" Beurling were recalled today as the 25-year-old holder of the D.S.O. and bar, the D.F.C. and bar and the D.F.M. came to Sherbrooke to consider an offer from Sherbrooke Airways Company.

Tall, blond and sun-tanned, the modest "hero of Malta" said that the official count of 37 enemy planes shot down which he chalked up in Africa, the Middle East and the Mediterranean theatre of operations, is by no means a record according to fighter pilots' standards. "I know of many pilots who flew on the same squadron as I and who shot down

twice as many planes," he said, "but unfortunately no one happened to be around to confirm their report."

"Buzz" Beurling, who was at one time a "grease monkey" at the Dorval airport, picked up flying in 1936 and soloed at 14. At the outbreak of the war, he worked his way across on a merchant ship and reached England with the intention of offering his services to the R.A.F. He was turned down because of his youth. Undaunted by this first setback, the then eighteen-year-old Verdun boy with the flying bug, came back to Canada, secured letters of recommendation from local flying authorities and with an impressive log-book tucked under his arm once again crossed the Atlantic, to be this time accepted.

What followed made history. The young pilot proved to be a dead shot besides a remarkable flier. Time after time Nazi planes patrolling European skies went down flaming from a burst of "Buzz" Beurling's machine guns. Subsequently transferred to the R.C.A.F., he was sent back to Canada in 1943 and participated in war loan campaigns. Discharged in 1944, he did some more flying for American and Canadian airplane manufacturers and was recently employed at Grey Rocks Airport near St. Jovite, Que.

Asked if he had considered a career with peacetime establishment of the R.A.F., the young flier, who has more than 3,000 flying hours to his credit, said that he had, but finally decided against it when he realized that peacetime pilots flew too seldom.

"Buzz" Beurling was particularly enthusiastic about the future of Canadian flying, especially as an instrument to further the development of the northern mining country.

"Bush flying is on the upgrade," said Beurling, "and is the most interesting aspect of flying today. The bush pilot requires skill, judgement, a good sense of direction as well as a thorough knowledge of navigation and has the thrill of exploring country, wild and untouched, where no human has set eyes before."

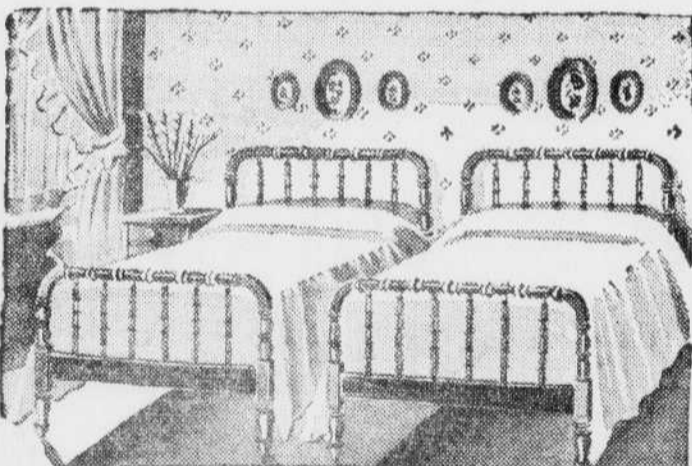

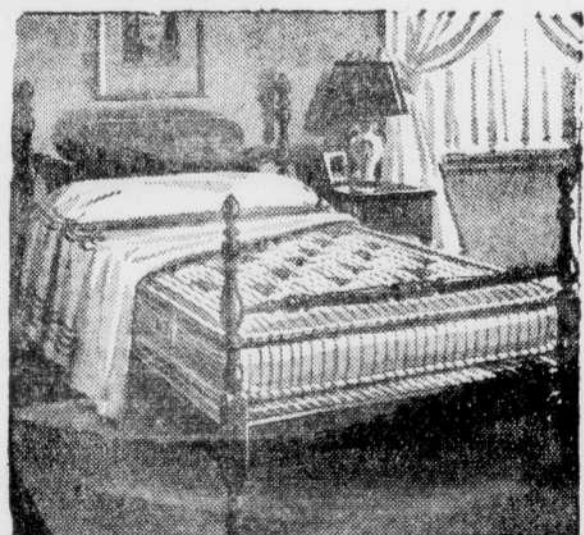

## VICTORIA DAY OBSERVANCE NOT GENERAL

Confusion about the status of Empire Day in Quebec arises from a bill approved by the Provincial Legislature last March, "to clarify the provisions of the Revised Statutes relating to holidays."

The civil code was amended in a manner which deleted Victoria Day and Armistice Day from Quebec official list of non-judicial days. Unless it is so proclaimed by the Lieutenant-Governor, Victoria Day which falls on Saturday, May 24, will not be a legal holiday in Quebec.

The holiday, however, will be observed by many. The Court House and City Hall will be closed, as well as all banks in Sherbrooke, which recognize Victoria Day as a National Bank Holiday. Post Office windows will be opened from eight to twelve in the morning and the lobby from eight a.m. to six p.m. One mail carrier delivery will be done in the morning.

No parade or public demonstration are contemplated by military authorities.

No commemoration will be held in honor of D'Orleans des Ormeaux, historical hero of Long Sault rapids, whose anniversary also falls on Saturday, May 24.

Victoria Day will provide many with an opportunity to enjoy a long week-end in the country, by motor or rail. Both C.P.R. and C.N.R. will have special low weekend fares for the holiday.

Many stores plan to close on Saturday, others on Monday, while another group plans to ignore the holiday altogether.

## STIFF SENTENCE IS PRONOUNCED BY RECORDER

The maximum penalty for a vagrancy charge was applied yesterday in Recorder's Court by Recorder Raoul Gagne in the case of Gordon Martin, alias Gerard Perrault, 23, of Montreal, who had been previously jailed for theft on three occasions.

Martin, who will spend the next six months in the district jail, had been remanded last Friday when he appeared in court following his arrest at 11.30 the preceding night at the back of the Shell Oil Garage on Wellington South on a vagrancy charge.

Recorder Gagne remanded the case pending receipt of the accused's criminal record from Ottawa, after questioning had revealed that Martin had been previously condemned on theft charges.

The dossier disclosed that Martin's first offence took place in Ottawa in 1941, when arrested for theft, he benefited from a suspended sentence. The following year he was sentenced to 18 months in jail following conviction on a charge of car theft with violence at Barrie, Ont. Paroled in January, 1942, Martin was again arrested three weeks after and sentenced to one year in jail as he pleaded guilty to two theft charges.

Martin who was without money at the time of his arrest in Sherbrooke, could give no explanation for his presence here.

## SENTENCED TO 6 MONTHS FOR FALSE "SALES"

Pleading guilty to several charges of obtaining money under false pretences, Romeo Fortier, 31, of Disraeli, this morning was sentenced to six months in jail by Judge Joseph Marier. He had obtained a total of \$900 through a series of ostensible sales of wood.

He had received \$550 from four out-of-town "sales," with the balance collected in Sherbrooke.

On March 12, he approached Marcel Lemieux, of East Angus, and asked him if he needed any logs. When he said he did he collected fifty dollars from him for transportation. On December 31, 1946, he obtained \$100 from Paulo Jacques, of Garthby, in the same manner. The \$200 he collected each from M. Theriault, of Bromptonville (April 23) and J. E. Lemieux, of Windsor Mills (May 2) was advanced for delivery of pine wood.

In Sherbrooke he received \$125 from a Mr. Roberge, \$125 from Joe Grenier and \$100 from Sisters on McManamy street.

He pleaded guilty to the out-of-town counts last Thursday.

## No Danger Of Floods Noted In E.T. Area Despite Big Rainfall

Although the Eastern Townships, in common with other parts of Eastern Canada and the United States, has experienced consistent rainfall in the past few weeks, flood conditions prevailing elsewhere have not been felt in this locality.

According to Hornidas Pepin, Running Streams surveyor for the Sherbrooke district, the St. Francis River was measured this morning at a height of 15.2 feet, this figure being only a few feet above that normally recorded and considerably below the more than 20 feet recorded about two weeks ago. From Lennoxville, too, came a report that the river, although high, was considerably below flood level.

A general forecast of rain, however, today promised no relief for flood-harassed communities in Ontario and other parts of Quebec, one of the most severely threatened points being the town of New Liskeard in northern Ontario.

Swollen by recent rains and, in the north, by late-melting snows, rivers were bursting their banks at many points in the two provinces.

In the north, large areas were flooded on the outskirts of New Liskeard by the floodwaters of Lake Temiskaming. Fear was expressed that if the Quinze dam at the north end of the lake should collapse under weight of river waters from the north, the business section of the town would be inundated with heavy losses.

Around Timmins farmers were getting emergency supplies by boat as the Mattagami floods covered a wide area. The Missinabi was also in flood at Kapuskasing in northwestern Ontario.

The Grand and the Nith rivers were in flood in western Ontario, with large areas in Waterloo County under water. A new residential suburb of St. Thomas was turned into a series of miniature

lakes by the flooding Kettle Creek.

In eastern Ontario, the Ottawa and Gatineau Rivers were in flood with the Ottawa at 25 feet above normal and many summer cottages damaged by floods from the Gatineau.

In northern Quebec the Harricana at Amos was flooding roads and low-lying land over a vast area and tractors were being used to get stalled cars along a highway stretch that was under several feet of water. A great log boom broke away on the Harricana and crews were being flown by air in an attempt to divert the logs before they are swept into James Bay.

Damage was also caused to the lower town in Quebec City yesterday by high water of the St. Lawrence, which also flooded sections of Levis on the south side of the river across from Quebec. A quantity of grain and flour was destroyed in warehouses and sheds at Quebec City.

WHY THE DELAY?

Prime Minister King, in urging the House of Commons to speed up its discussions in order to pass some fifty important measures still before the House or yet to be introduced by the Government, failed to mention one important fact. Why the delay in introducing so much legislation which the Government deems to be of major import.

This might be good politics but it is a dangerous threat to the democratic system. The very essence of parliamentary government is that each and every measure should receive close attention by the elected representatives of the people.

There is no apparent reason why the Government cannot introduce more legislation in the opening weeks when the proceedings are dragging instead of waiting until the final month.

THE HOUSING CONTRACT

Once again the citizens of Sherbrooke have received a lesson as to the importance of persistence, the decision of the Central Mortgage and Housing Corporation to provide cellars and suitable chimneys for future houses erected by them here resulting directly from the determination of a group of aldermen that buildings constructed should be of the best possible quality.

For reasons best known to themselves, Central Mortgage and its predecessor, War-time Housing, have been building houses without these features and despite repeated protests by the Council refused to alter their plans.

The project itself is of the greatest importance to Sherbrooke, which already faces an acute housing shortage, which threatens to become worse as the industrial expansion of the city continues. The new agreement provides for fifty additional dwellings here, with the possibility of the number being increased to seventy-five if suitable land can be obtained.

THE COAL STRIKE

The imminent return to work of the Nova Scotia coal miners, who have been idle for the past three months, is a matter of supreme importance not only for the districts immediately affected but for the Dominion as a whole.

Furthermore, the importation of coal into Central Canada provides one of the greatest individual drains upon the limited United States exchange resources of Canada.

if this country is compelled to increase its foreign purchases of basic steel products.

The direct loss to the miners is tremendous. Reports from the colliery districts indicate that business is virtually at a standstill, with the savings of the men having been used up to maintain a bare existence level, while the union has already been compelled to pay out in the vicinity of \$700,000 for strike relief.

The real tragedy is that the offer now being given serious consideration with every possibility of acceptance is almost identical with that offered by the operators prior to the strike. Thus the men have "enjoyed" three months of enforced idleness without pay in return for nothing more than they would have received by taking the original proposals.

Washington Column BY PETER EDSON

Possible need for revision of the regulation of the Lobbying Act is seen in a study of the 543 lobbyists' reports to Congress on their operations for the first three months of 1947.

Lobbyists are required to register as individuals. The quarterly reports on income and expenses as made public in the Congressional Record are not summarized or cross-indexed or classified to show who really runs the big pressure campaigns in Washington.

There are too many blank spaces in the published report summaries. In case after case registrants attach detailed statements to their reports. They then fill in the blank spaces on the forms with notations like, "See attached statement" or "See previous report."

By registering only Washington representatives, top men in an organization escape responsibility and the bad publicity label of "Lobbyist," which is a nasty word.

In spite of all these dodges, by dint of a lot of reading of fine type, checking, and tabulating, it is possible to make a fairly accurate summary of who runs the most powerful lobbies.

FUR COAT AND SALMON LOBBYISTS

Among the traditional lobby groups, the biggest are the tax reduction outfits with 27 registered lobbyists, the railroads with 20, the so-called "water lobby" of irrigation and flood control interests with 19, real estate and building associations with 20, oil and gas interests with 18, shipping interests with 12, sugar 11.

National Association of Manufacturers registers only five lobbyists. Their pay and expenses for the first quarter totals nearly \$18,000. Top man is \$25,000-a-year Walter Chamblin, whose lobbying expenses were reported at over \$300 a month.

U.S. Chamber of Commerce registers two lobbyists, topped by \$15,000-a-year Clarence R. Miles, whose reported lobbying expenses for the first quarter were \$21,800.

Wholesale Grocers, Retail Federation, Dry Goods, and Retail Creditmen's Associations registered lobbyists. Three small business organizations registered. F. A. Virkus, of the Conference of American Small Business Organizations, reported receipts of \$36,000 and expense of \$26,000 for the first quarter of 1947.

Trade associations maintaining lobbyists include the rubber industry, Alaska salmon, optometrists, hotel, laundry, ice, heating and cooking, margarine, fur coat, meat packing, movie, wine, and liquor business. Each had one or two lobbyists at work during the quarter.

IT'S A MULTI-MILLION-DOLLAR BUSINESS

Four lobbyists reported working for passage of the St. Lawrence Seaway law. One lobbyist registered as working against it. Eleven lobbyists reported individual interest in passage of one or more particular pieces of legislation, of varying purpose.

Big money men of all the lobbyists appears to be \$65,000-a-year Purcell L. Smith, and \$52,000-a-year Stephen M. Walter, of the National Association of Electric Companies—the so-called power lobby.

J. Carter Fort of American Association of Railroads reported income at the rate of \$40,000. In the sugar lobby, Ernest W. Greene of the Hawaiian planters reported income of \$45,000 a year, and Robert H. Shields of the U.S. Beet Association reported \$40,000.

Inland Steel, J. L. Case, Allis Chalmers, Freuhauf, and others reported income for the quarter of \$14,200.

These, however, appear to be the exceptions. Only a dozen of the 795 registered lobbyists reported income of more than \$20,000 a year. Only 50 reported income of more than \$10,000 a year. Most of the lobbyists report no pay at all and little expense. Nevertheless, when all these "pittance" are added up, they reveal lobbying to be a multi-million-dollar business.

The most fascinating aspects of the lobbying lists are the names of the well-known lobbyists who have not registered. They are absent because they claim lobbying is not their principal business, and that their work with Congress is purely in the public interest as private citizens.

THE UNMASKING

Kingston Whig-Standard. A court case in Hollywood is going to shatter the illusions of millions. Forty-two make-up men are suing to obtain full membership in a film union.

The shrieking followers of Frank Sinatra, if they read the newspapers, have now learned that their idol's ears have a "handle cup appearance" and have to be taped back, and that his face cavities have to be filled in with grease paint and shadow.

These things left us unmoved, but when our eyes skipped a line or so and saw the name of Ingrid Bergman we were ready to operate on the debunker with a blunt instrument. Then we read the context, and learned that Miss Bergman had trouble crying at the proper time; a menthol inhaler did the trick. We were relieved. We don't care if they stick pins in Miss Bergman to make her cry, as long as they don't tell us her appealing beauty is a matter of grease paint, shadow and false hair.

These revelations will be a blow to many. It is common knowledge, of course, that Jack Benny, Bing Crosby, Edgar Bergen and Charles Boyer wear toupees; for that matter, these revelations about the falsity of masculine glamour fail to excite us, although women may feel differently. It is different, however, when they start pulling the female stars apart. We hope the suit is settled before even more intimate revelations are on record. We want no confirmation of certain dark rumors that Art and not Nature is responsible for the symmetry of form so modestly displayed by a number of the leading ladies of the screen.

ON THE 'BAN' WAGON

Christian Science Monitor. There was once a little tramp, with baggy trousers and indomitable walking stick, who started off gaily by throwing custard pies in slapstick comedies, and won his way into the affection of millions of people all over the world. Off the screen, the little tramp did and said some things that a good many people didn't like, and as time went on he seemed to grow farther apart from his great public.

Finally he produced a picture which almost everyone thought was silly and pretty pretentious. So a group of movie-house owners in Ohio urged: "Let's have a nation-wide ban of it." They denounced the comedian for "again attempting to reach into the pockets of American moviegoers while choosing not to become an American citizen."

We make no defense of Charles Chaplin's last picture, "Monieur Verdoux." It is far below the old Chaplin level, and deserves to be a commercial flop. We make no defense of his curiously immature political views. But we do question the growing tendency to "ban" whatever or whomever one disapproves on patriotic grounds.

We do not find ourselves in sympathy with the 150-wing views of Paul Robeson, but we deplore the attempt to freeze him out of the use of a public hall for a concert. We have not joined in the current cheers for Kirsten Flagstad, remembering her countrymen's feeling that she did not help in time of crisis, but we would ardently defend the right of anyone to hear her sing who wished to.

CHURCHILL'S CITATION

New York Times. The text of the French Government's official citation of Mr. Churchill, which accompanied the Military Medal follows:

Called during a critical hour to direct the struggle of the United Kingdom forces against a powerful enemy and filled with confidence in his arms he succeeded in grouping round him, with the same ideas, all the energies of the British people and their Allies and caused the world to understand the issues at stake.

By his audacity in the conception and in the execution of the gigantic operations which unfolded in all corners of the globe, he was one of the artisans of France's liberation and of the unconditional surrender of the enemy.

Equally unaffected by bitterness in temporary defeat and by over-confidence in success, he incanted the fierce energy and the unconquerable courage of a friend from whom he springs. A friend of our country, he fought on French soil in the trenches of the First World War. He never ceased to display in the darkest moments of the struggle as in the joy of victory, his attachment to a nation which finds itself honored to have fought beside him for the defense of liberty and civilization.

3 NO TRUMP IS IN, BUT IT'S TRICKY

Lieut. George S. Coffin has concluded six years' Army service and is back home in Fitzwilliam, N.H. His book on poker will be published this fall, and Coffin himself will publish in October a book entitled "Sure Tricks," by Ivan Anderson of Stockholm, Sweden.

Today's hand is one from Mr. Anderson's book. If South plays carefully, he can make nine tricks against any defense. He must not win the opening lead of the king of hearts. His refusal to do so is the famous Bath Coup play, to make sure of two heart stoppers if West leads hearts again. Probably West's best defense is to shift to a club, which declarer wins with the ace.

If South cashes the king and queen of diamonds, hoping that the diamond suit will break, he will lose the contract. He must cash the king of diamonds, lead the diamond queen and overtake in Gummy with the ace, then lead ten of diamonds. Thus he can establish the diamond suit with the loss of only one trick, and make one spade trick, one heart trick, five diamonds and two clubs.

## Destruction of Potatoes Is Protested

Torch Set to Surplus Potatoes Dumped in Alabama - Would Prohibit Destruction of Edible Food, Donate It to Charity.

Washington, May 23.—(AP)—Aroused by the burning of surplus potatoes, Senator Edwin C. Johnson (Dem.-Colo.) and Rep. Reid F. Murray (Rep.-Wis.) introduced bills yesterday to prohibit the Agriculture Department from destroying any edible food.

Murray's bill would authorize the department to donate to charitable and welfare institutions and agencies and to needy individuals.

Johnson and Murray assailed the department's destruction of surplus potatoes in Alabama. Rep. George Grant (Dem.-Ala.) who likewise called it "most deplorable," announced that the agriculture department has issued orders that kerosene is not to be poured upon any more potatoes dumped in Alabama.

Grant said that gutted market conditions prevented sale of the highly perishable spring potatoes and that an embargo prevented their shipment to Canada.

An Agriculture Department spokesman said Wednesday that Canadian potatoes were being sold at high prices in the southern states adding that it was a case of the consumer wanting top-quality potatoes.

An Agriculture Department official said Canadian embargo prohibits the import of United States early spring potatoes into that country from Manitoba eastward.

He said it is "expected to be removed about June 30," and is intended to "protect" marketing of Canadian potatoes in the area. He said United States west coast potatoes are being allowed to move into Western Canada.

as Mr. Dorion and said they showed that the Dominion and the provinces had the same rights in the direct taxation fields. Where equal operation was not possible the Dominion had a priority.

The debate was resumed after these developments: 1. Agriculture Minister Gardiner announced the Federal Government was prepared to discuss with the provinces plans for the development of certain agricultural lands across Canada, such as the marshlands of the Maritime provinces, the principle of the Prairie Farm Rehabilitation Act would not be extended to all parts of the Dominion, as had been suggested.

2. External Affairs Minister St. Laurent announced that Mr. Justice I. C. Rand of the Supreme Court of Canada will represent Canada on the United Nations committee charged with finding a solution to the Palestinian problem. He will be assisted by Leon Mayrand of the External Affairs Department.

3. Finance Minister Abbott promised to give consideration to a question as to what the government planned to do about the announced intention of McIntyre-Porcupine Mines, Ltd., to store gold in anticipation of a higher price.

4. Trade Minister MacKinnon said he had no comment to London on a news dispatch from London which said that Canada was considering a drastic reduction in her imports from the United States.

Besides his reference to Dominion-Provincial relations, Mr. Fleming said the government was offering the people \$160,000,000 in income tax reductions with one hand and was asking away \$208,000,000 in terms of increased cost-of-living with the other.

Other speakers in the debate included E. D. Wylie (SC—Medicine Hat); J. A. Bonnier (L—Montreal St. Henry); Duncan McCaig (CCF—Maple Creek); A. L. Smith (PC—Calgary West); Marcel Boivin (L—Sherford); Julian Boivin (PC—Simcoe North); Matthew McLean (L—Cam. Bay North—Victoria); William Byrce (CCF—Selkirk); and Joseph Fontaine (L—St. Hyacinthe).

Mr. Smith said the Canadian Wheat Board's audit should be taken out of private hands and placed under the auditor-general. He said the board's accounts should be examined by the House Agricultural Committee.

sufficient to have killed three men. Guay was in the witness box for two hours yesterday afternoon. Crown Prosecutor Dugre questioned him about the funeral arrangements and asked him if he were not true that at time of the visit of detectives in July he had said to Mrs. Ducharme: "They must think that he died of poisoning."

Guay: "I did not say that because I never thought that he died by poisoning." Mr. Dugre asked him if he had been surprised when he learned that the body had been exhumed. Guay said that he certainly was.

Mr. Dugre: "Did it surprise you that he died so suddenly?" Guay: "He did not die so suddenly."

Mr. Dugre: "You saw him Monday night. Did he have the appearance of a dying man?" Guay did not answer and Mr. Dugre asked him if he had been surprised to learn that Ducharme was dead on Tuesday night. Guay said that it did not "because I had seen others die as quickly before."

Witnesses admitted that he had gone to Joseph Nadeau's in St. Remi with Mrs. Ducharme in July. (Mrs. Nadeau is a daughter of accused).

sought of German fugitives. He had been commander of Security Police in Holland and Belgium and also combat commander of Nuernberg.

Neumann now is in custody of American war crimes prosecutors at Regensburg. He was found using an assumed name and working as a farmer near the Austrian border in the neighborhood of Berchtesgaden.

The arrest was made May 9, but not disclosed until today. Neumann was reported to have had Swiss and British money amounting to about \$60,000 in his possession when caught.

An unofficial report said an associate of Neumann, a Major Eichler, was picked up at the same time on a farm on the Austrian side of the border near Salzburg. It was assumed Neumann would be held for trial either at Dachau or Nuernberg as a war criminal, but there was a possibility that the Dutch or the Belgians might ask his extradition.

Answer: I should have to monopolize all of the space in this paper if I printed even a partial list of the bills that a married man must meet. I should have to tell of butcher bills, grocery bills, milk bills, light bills, fuel bills, rent bills, bills for clothing, medicine, cosmetics, shoes, stockings, lingerie—oh, what's the use? Nobody can know how many bills and ills there are in matrimony until they try it, and then it is too late.

**METHODS VARY**

**Tested Recipes**

**Try Improved Canning Methods**

By GAYNOR MADDOX

Asparagus and garden peas come first on home canning schedule. New and improved directions are based on three years of intensive scientific study of home canning low-acid vegetables by the USDA's Bureau of Human Nutrition and Home Economics.

For pint jars, the processing times recommended are now shorter than in the past. This means the vegetables will look and taste better. For asparagus home-canned in quart-sized jars, longer processing has been found necessary, to insure the food keeping.

The research scientists stress the necessity of using a steam pressure canner for low-acid food. This is the only practical method of guarding against the serious food poisoning known as botulism. The

directions given here are for this method of canning only.

**Asparagus:** Wash asparagus, trim off scales and tough ends and wash again. Cut into 1-inch pieces. Cover with boiling water and boil 2 or 3 minutes. Pack hot asparagus to ½ inch of top of glass jars. Cover with hot cooking liquid, or, if liquid contains grit, use boiling water. Leave ½ inch space at top of jar. Add ½ teaspoon salt to pints; 1 teaspoon to quarts. Adjust jar lids. Process in pressure canner at 10 pounds pressure (24 degrees F.) in either pint or quart jars, 40 minutes. As soon as jars are removed from canner, complete seals if they are not the self-sealing type.

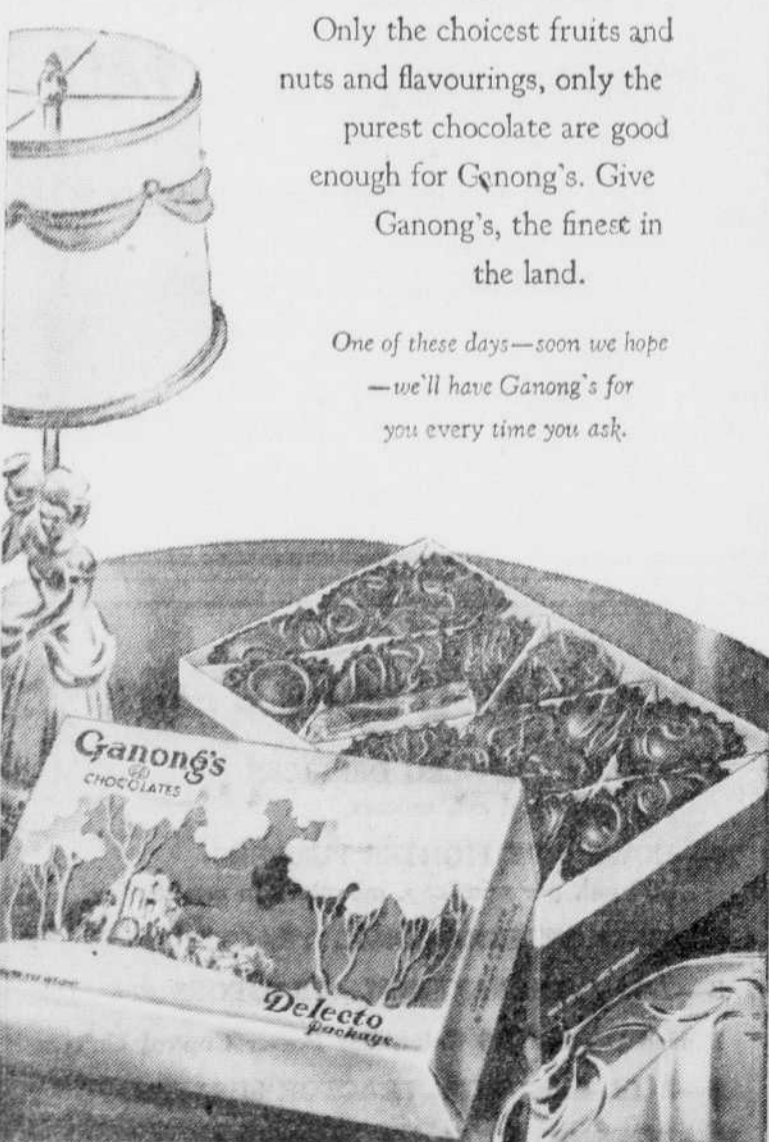

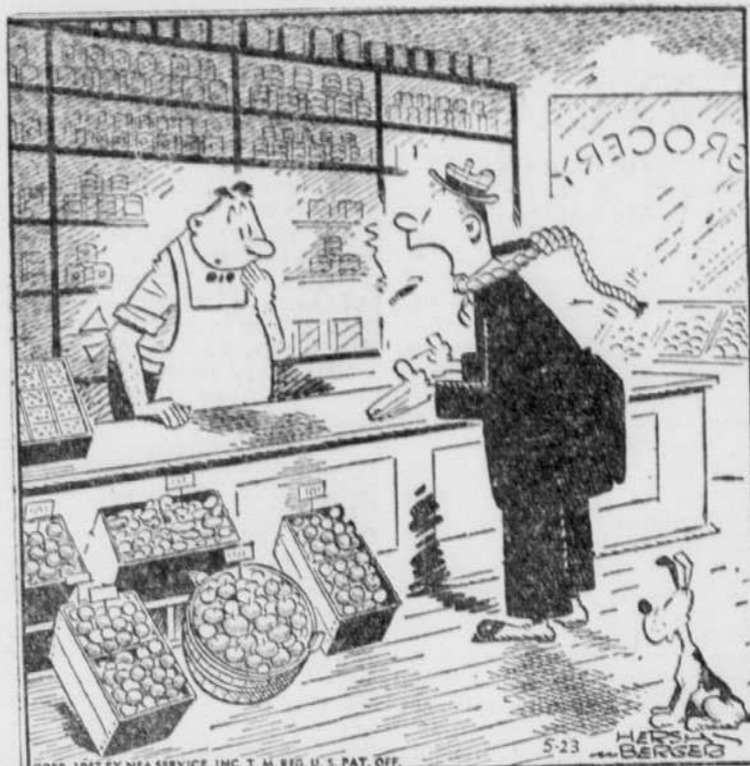

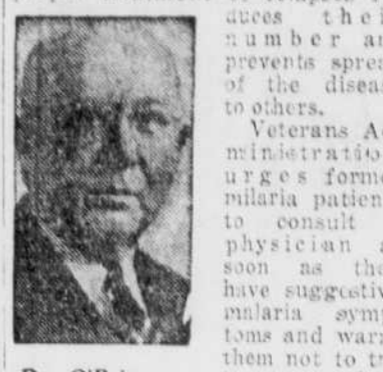

## The Doctor Says

### RELAPSES ARE COMMON IN MALARIA

By William A. O'Brien, M.D.  
Common malaria may relapse for two or three years after the original infection and then disappear. The disease is not fatal, and proper treatment of relapses reduces their number and prevents spread of the disease to others.

Best treatment for relapses is to go to a hospital and stay in bed while the physician administers atabrine over a seven-day period. If nausea and vomiting are troublesome, injections of the drug can be given into the muscle.

This treatment also is recommended for those without malarial symptoms in whom the parasites are discovered in the course of a general examination. It may not be necessary for those patients to go to bed, as they can be given the medicine while they are up and around.

Veterans who have had four or more relapses can be given a different treatment for which they should report to their physician or go to a veterans hospital.

**Develop Immunity**

Service men in malarial districts were given suppressive treatment of atabrine which helped to hold the disease in check. This method is not recommended in a non-malarial district unless relapses are coming so close together that they are disabling. Most veterans who contracted malaria in service are not having any difficulty with each month the possibility will become less.

Patients with malaria develop an immunity for it, just as they do for other contagious diseases. The effect of relapses on the body is slight, providing the patient eats a good diet and takes the recommended diet.

# SHERBROOKE COPS INITIAL NIGHT TILT WITH ACTON VALE

## Normie Dussault Paces Locals To 6-4 Win With Perfect Night At Bat

After two unsuccessful attempts to open night baseball, the Sherbrooke Baseball club finally staged its initial tilt, last evening, and downed Acton Vale to the tune of 6-4.

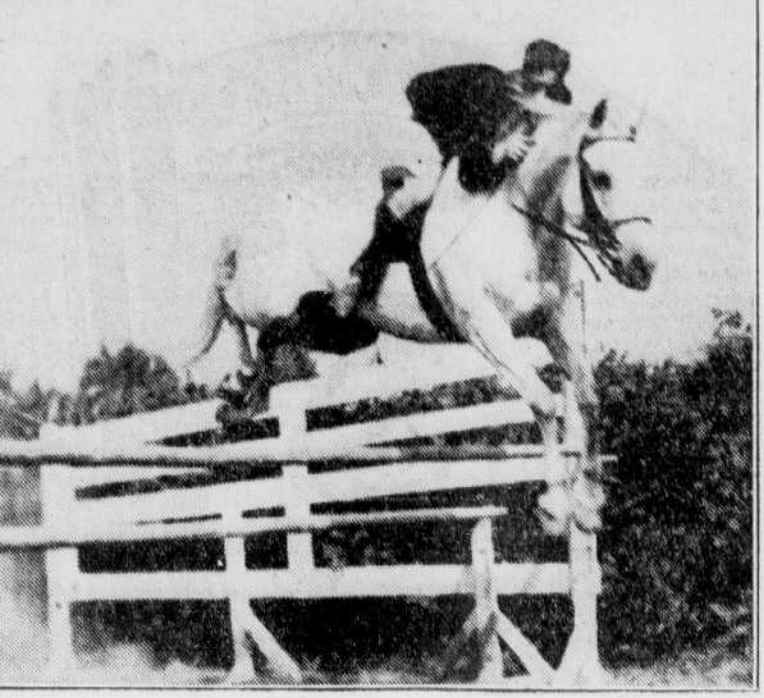
## LANDS 64-LB. MUSKIE, THINKS IT NEW RECORD
