

# IMMENSE NEW CUSTOMS EXAMINING WAREHOUSES

## Government's Purchase of Property Near Water Front and Projected Building Will Cost Between Two and Three Million Dollars.

The Dominion Government's purchase of property in Montreal for the largest and most magnificent examining warehouse is being prepared by the department of the building that will be situated on a block bounded by McCord, St. Lawrence and Normand streets and extending to the water front. The site is about 150 feet wide and 550 feet in length. The building the department has in mind for the block has not been decided, but it is said that a structure of three million dollars is involved in the purchase and the erection of the building.

The property is within one block of the water front and immediately in the rear of the customs building and opposite the old block on McCord street. The removal of the present structures on the site is being done by a contractor who is rapidly becoming a commercial one in Montreal. A block of it are the main offices of the Grand Trunk Railway and the Canadian and Canadian Pacific buildings.

Part of the block was purchased by the Hon. Mr. Fielding, Minister of Finance under the Laurier administration, about four years ago, while the balance has been acquired recently very quietly. When the purchase was made by the Hon. Mr. Fielding, the tenants were informed that they might have to vacate the premises at any time, but it is said that a lack of cash was the cause of the ambitious building scheme of the government being deferred.

Now, however, the development of the port of Montreal renders such a building an absolute necessity.

Recently notice was served on the tenants of the block by the Federal authorities that they must be out of the buildings by May 1st last. None of them have removed to other quarters, however, but, as one said to a "Witness" reporter this morning, "we do not know what day we will have to go."

That the government proposes to erect a mammoth office and warehouse on the site is indicated by the fact that it is taking with the foundations of the building. Numerous holes have been drilled recently by a drilling company to determine the nature of the sub strata of the lot. # CITY WORKING ON OVER-DRAFT

## Owes About One Million Dollars to Bank of Montreal

The city has an over-draft of about one million dollars on the Bank of Montreal as a result of the delay in floating a loan of seven million dollars through the weakness of the London money market. This over-draft, it is said, is the negative any person unassisted by the bank is not charging more than four percent interest, and it is as good as floating a temporary loan. With its borrowing power limited to the credit of the city, it is explained, was never more sound.

Of the seven million dollars required by loan, about five million dollars has been advanced by the bank in the form of loans, and when these and the over-draft is paid it will leave only about a million dollars more available.

The city is now awaiting a favorable change in the money market to float its seven million dollar loan.

# MR. TRAVERS ON BANKING

## Mr Hodgins, K.C., Simply Could Not Understand Business

### MR. TRAVERS DID.

#### But Why Did the Farmers' Bank Smash? He Was Asked.

Toronto, May 22.—Little fresh evidence of importance was elicited at the Farmers' Bank inquiry before the House of Commons this morning, the most interesting event being a tilt between F. E. Hodgins, K.C., and W. R. Travers, over the advantage to a bank in getting its circulation increased by the issue of the Farmers' Bank bills.

In the course of his examination, Mr. Hodgins asked Travers for an explanation of the deal with the Trust and Guarantee Company, and the former manager replied that it was partly for the benefit of getting the Farmers' Bank bills circulated, but that he made an arrangement with Mr. Travers, who had deposited their bills with the Trust Company, who paid them out over the counter, when cheques drawn on his institution were presented for payment. In addition, the bank was allowed three percent interest on the account, but this privilege was later withdrawn, as it was felt that the advantage of the arrangement was entirely with the bank.

In addition Travers explained that frequently the Trust Company let him have a cheque on the Bank of Montreal when it was needed to square their account with the Clearing House.

"What advantage was it to the bank to have the Trust Company paying out their circulation?" asked Mr. Hodgins.

Travers went into details and showed that it was worth at least five percent to the bank.

"I can't see it," was Mr. Hodgins' reply.

"This is because you don't understand the business," retorted Mr. Travers.

"It seems perfectly plain to me, interrupted the chief justice who undertook to elucidate the question for the investigating counsel.

But Mr. Hodgins persisted in further explanations.

"I can't make it any plainer," said Travers, "because you don't understand banking."

"Well," said Mr. Hodgins, "you understood all about banking and look what happened to the bank. I would rather have a cheque on the Bank of Montreal than a cheque on the Farmers' Bank, because you might have done much better, was Travers' retort amid laughter.

Before Travers was called W. J. Lindsay explained a cheque for \$3,000 that he was questioned about yesterday, but he said he was unable to get any information from the Trust and Guarantee Company.

The commissioner then suggested that some of the bank might be subpoenaed to straighten the matter out.

# DEATH OF MR. C. R. TAYLOR

Mr. Taylor was well known in business circles not only in Montreal, but throughout the province, where his business confined him most of the time.

He lived at 28 Arlington avenue, Westmount, with his brother, Mr. A. M. Taylor, and a sister.

# PRESIDENT UNDAUNTED

## After Crushing Defeat in Ohio Mr. Taft Plans to Win New Jersey

### RETURNS TO WASHINGTON.

#### Colonel Roosevelt and Mr. Harmon Victorious—Mr. Taft Won Only 10 of 42 Delegates.

Washington, May 22.—President Taft returning from his campaign tour to Ohio, reached Washington at 8:50 a.m. today. He plunged into a busy day at the White House, and has planned to leave on Thursday for New Jersey, to travel through that State, campaigning for delegates to Chicago, who will be elected at the primaries next Tuesday.

The President had no statement to make this morning concerning the result of the Ohio primaries. He has made known to his friends that he is still in the fight and believes he will have enough delegates to secure the nomination at Chicago.

MR. ROOSEVELT'S VICTORY IN OHIO.

Columbus, Ohio, May 22.—A sweeping victory for President Roosevelt for Republican choice was the result of the State wide primary held in Ohio yesterday.

With the probability that there may be an increase as later returns come in, it is estimated that Roosevelt has a plurality of approximately 20,000 over President Taft in the popular vote as expressed through the selection of the delegates to the National Convention. Taft so far has carried but three entire districts. There is a division in two.

In Ohio's first presidential preference primary, which was conducted by the Democrats, Harmon is far in the lead of Governor Woodrow Wilson of New Jersey. Despite the fact that their names were not printed on the ticket, Mr. Bryan and Mr. Champ Clark received scattering votes.

On the force of returns up to 7 a.m. from about 70 of the 88 counties of the State, President Taft will have but ten of 42 delegates to the National Convention.

# SUFFRAGETTE LEADER GETS NINE MONTHS

## Mrs. Pankhurst, and Her Lieutenants Found Guilty of Conspiracy and are Sentenced

London, May 22.—Mrs. Emmeline Pankhurst, the militant suffragette leader, and Mr. and Mrs. Pethick Lawrence, joint editors of "Votes for Women," were all found guilty at the Old Bailey sessions to-day and each sentenced to nine months' imprisonment, on the charge of conspiracy and inciting their followers to malicious damage to property.

SCENE IN COURT.

The two women in the dock were pathetic figures when the verdict was brought in by the jury. Mrs. Pankhurst clung to the edge of the prisoner's enclosure trembling visibly and pleaded to be treated as a first class felon. Mrs. Pethick Lawrence, rising both hands in the attitude of prayer, swayed as she uttered the phrase: "May God defend us, as our cause is just."

The prisoners were all sentenced to be confined in the second division, which does not involve hard labor.

The jury in handing down its verdict of guilty accompanied it by a recommendation that leniency should be shown to the prisoners, and Justice Coleridge in delivering judgment took this into consideration.

# PUBLIC'S ONLY PROTECTION IS GOOD FAITH OF CABMEN

## Licenses Granted by Police Supposed to Guarantee Worthiness of the Driver—Police Comment on Alleged Kidnapping and Assault of a Woman at Bonaventure Station.

Chief Carpenter, of the detective department, said this morning that there were no new developments in the case of the alleged robbery and assault on Mrs. Malvina Goyette on the mountain last Saturday night. The other two men had not been taken into custody.

Chief Carpenter was asked by the reporter if the police at the stations should allow cab drivers to pick up women passengers, as happened in this case, but he refused to be quoted in the matter. He said, however, that Segouin, the cab driver now under arrest, had nothing previously against him as far as the detectives were concerned.

Chief of Police Campeau was not at his office, having been confined to his home the last day or two with a temporary indisposition, and Deputy Chief Hobart said that he had not followed this particular case. The facts had been placed in the hands of Chief Carpenter, of the detective department.

Speaking generally, he said the police and the public had to depend on a good deal on the good faith of the cab drivers. They were refused license if there was known to be anything against them, or if they were not believed to be reliable and honest men. If they ever got into trouble the court was liable to cancel their license, and the police would not grant them again.

In the case of a woman who had been in any part of the city the police could not interfere unless there was reason to suspect the intentions of the cab driver, and ordinarily they could not do so.

Another police official remarked that the protection of the public is, or is supposed to be, in the refusing of licenses to men who should not get them. Even if a woman were under the influence of liquor, if the cabman was thought to be all right, the police could not interfere with her going in a cab. And the fact that the cabman had a license was supposed to show that the police department considered him a reliable man.

# MYSTIFIED OVER MURDER

## Boston Police Find Resemblance to a Former Tragedy

Boston, May 22.—The mystery surrounding the murder of Mrs. Lillian Jewett, formerly of Montreal, who was strangled at her apartments in the South End, probably on Saturday, was still far from solution at noon today.

Several clues have been run down without producing any tangible results, and these included the examination of Charles W. Hopkins, a waiter, and his release last night from detention.

Several of the police inspectors pointed out to-day that the circumstances surrounding the discovery of Mrs. Jewett's body yesterday resembled closely those attending the murder of Laura Chamberlain in a water front hotel last September. Both women were seen during the evening in various resorts, but no clue could be discovered that would lead to the identification of their companions in the room where their bodies were subsequently found.

Hopkins told the police last night that he called at Mrs. Jewett's apartment on Saturday night, but could not get in, so he left a note under the door. The note was found as indicated by Hopkins. Two women who were examined stated that they accompanied Mrs. Jewett to one of the subway stations late Friday night, and as far as known this was the last time she was seen alive. They said that Mrs. Jewett had spent part of the evening with them in a palm garden, but that she entered the subway station alone.

# CHINESE WITNESSES

## Arrested on Charge of Perjury in Gambling Case.

Four Chinamen were arrested and arraigned before Judge Lafontaine in the Arraignment Court to-day, charged with perjury. They gave their names as Hoo Yank, Peter Soong, Wing Tai and Hum Wing, and are alleged to have perjured themselves in giving testimony against Sun Hon Sook, who yesterday was found not guilty of purchasing a gambling house on Levesque street west, and who was discharged. The four Chinamen were arrested on warrants obtained by High Constable St. Mars. They pleaded not guilty and were held in custody until examination on Tuesday next.

# KNOX CHURCH BOYS PROPERTY

## Trustees Acquire Houses at the Corner of St. Luke and Fort Streets.

Knox Church has purchased property at the south-west corner of St. Luke and Fort streets. Whether the new Knox Church will be erected in that site or not is a matter for the future, as one of the conditions of sale to the Sun Life Assurance Co. was that the congregation should have undisturbed possession of the present church at the corner of Dorchester and Mansfield streets until 1918.

The property just secured is regarded as a good investment in any case. It includes eight or nine houses, yielding good revenue, and it is in a part of the city in which development has been rapid.

The property has a frontage of about 115 feet on Fort street and about 102 feet on St. Luke street. It extends to a line twelve feet in width running off Fort street and to the residential property of Mr. McGillis on the other street. For the entire area of nearly 12,000 square feet the trustees paid in the neighborhood of \$60,000.

The property is within one block of St. Catherine street, and is practically in the center of the district in which the members of the church reside.

# SUBSIDY RENEWED

## Mancheater Steamship Line Continues to be Helped by Government.

Ottawa, Ont., May 22.—The Department of Trade and Commerce has renewed its subsidy contract with Messrs. Furness and Withy, of Manchester, England, agents for the Mancheater Line on the Liverpool, St. John, Montreal, and Halifax route. The contract is for four years. At the present time there are seventy steamship lines subsidized by the government.

# BUSY WITH CELEBRATIONS

## Liberals Jubilant Over Provincial Victory Look Forward to Federal Election

### REFORM CLUB EXUBERANT.

#### Claim Next Annual Meeting Will Be Held in New Club-house.

The Liberals of Montreal district have been in a "jubilant" and "exuberant" mood ever since the sweeping endorsement of the Provincial Liberal Administration at a week ago and the next Federal elections, following a redistribution bill based on the recent census, are brought on within the next year or two there is sure to be a battle royal.

Just at present the Liberals of the city and district are busy with celebrations and banquets. The greatest of all, of course, will be the banquet at the Hotel Windsor, at the Windsor and flower of Canadian Liberalism will gather to honor the revered chief of the party, and it will be a feast of an inspiration that will go forth from that assembly to stimulate the party to greater efforts and greater conquests in every part of the Dominion.

Mr. Napoleon Seguin, who won such a notable victory in St. Mary's division, is also to be feted by the Liberal clubs in that division, and Hon. L. Decarie will be honored with a banquet last Saturday night, and other celebrations have been or are about to be held.

The first steps were also taken to increase the membership of the club by a campaign to bring in young men, and by providing special meetings for their benefit where they would address on suitable subjects and exercise their talents in debate. It was also predicted that the next annual meeting would be held in the new club house for which the charter has lately been secured.

The fact that every candidate in the recent elections who was assisted by Hon. Messrs. Monk, Pelletier and Doherty, had gone down to defeat, was referred to by one of the speakers, and this was taken as an indication of what would happen at the next Federal elections.

# MONTREAL WOMAN MURDERED

## Young Widow Found Strangled in Her Apartments in Boston.

Boston, May 21.—After six hours' investigation of the death of Mrs. Lillian Jewar, formerly of Montreal, who was found strangled in her apartments in the south end, early to-day, the police took into custody as a suspicious character Charles W. Hoppling, a waiter.

Chief Inspector Dugan stated that Hoppling had known the woman for some months, that he was with her in New York last winter, and accompanied her to visit her mother in Montreal on Friday night. Medical Examiner Leary, who performed an autopsy on the body of the woman, notified the police that the woman probably died early Saturday morning.

The body of the woman was found by R. A. Bassette, a milkman. The police were notified, and the medical examiner, after a hasty examination, stated that death was due to strangulation from a towel knotted about the neck.

In their investigations, the police discovered that Miss Pearl Charrette, also formerly of Montreal, knew the woman, and from her it was learned that Mrs. Jewar came here from the Canadian city in 1910. Miss Charrette also stated that the dead woman had an eight-year-old daughter in Connecticut.

The trail soon led to a small saloon on Broadway at the corner of Hopping street, where the woman was found. Hoppling was still at the police headquarters under examination.

When Bassette entered the widow's apartment he found the woman's body on the floor of the bed room under conditions which he believed suggested murder. Apparently she had struggled, and her hands were tightly knotted about the neck, and the pieces of string in the neck-trails three pillows were heaped on the floor. Evidently the murderer left the apartment in haste, as the gas was found burning.

There is but one family by the name of Jewar in the Montreal city directory, and they deny any relationship with or knowledge of the murdered woman. Chief Inspector Charrette believes that he does not know anything of her.

## STUDENT RATES

Were Made Originally For Westerners Attending Eastern Universities.

Ottawa, May 21.—Rates on everything from university students to the carriage of coal were discussed before the Railway Commission at this morning's sitting of that body here. A number of important applications came up. The complaint of various universities that the railways proposed abolishing after July 1 next, the one-half the one-way fare at which they have hitherto carried students to eastern universities was next heard. The Hon. E. H. Phlippen, K.C., for the Canadian Northern, explained that the rates originally been made to allow western students to attend eastern universities. Now, however, these institutions had been established in the west.

He was of opinion however, that the rates might reasonably be allowed to remain in force in the case of students from the west who had already started their course here, and the matter was left over for discussion between the railways and universities with that end in view.

## TEST NEW LIFEBOAT

On Sunday, May 19th, a test was made on the East River, New York, below Blackwell Island, of a new type of lifeboat, known as the Lundin, decked lifeboat. The trial, which was carried on by Captain Henry M. Seeley, Supervising Inspector of the U. S. Steamboat Inspection Service in the district, and Captain Charles E. McKay, of the U. S. Army Transport Service, was in every way successful, and the Captain of the inspector of the craft, seems to have solved the problem of the seaworthy boat, and one which can be stowed easily. With 65 passengers aboard the boat was rowed easily and rapidly by six men at the oars, and the united efforts of all on board to upset it or dip the gunwale were unsuccessful.

The boat decked hull with sides extending above the deck about fifteen inches, and protected by fenders of wood. Folding boards of substantial material are hinged on the top edges of the sides, and may be raised in a second, automatically locking themselves in an upright position. Protecting boards are then dropped in the edges and the boat is ready for sailing. The boat is 28 feet long, and has a 9 foot beam, and though built to carry 60 persons, will hold one hundred. The deck is watertight, compartments are under the deck, and the floor of the boat is 5 inches above water level, with a double bottom under it.

At the luncheon which is provided daily for the workers for the Diocesan Campaign Fund, Bishop Farthing made the gratifying announcement that as the result of one of his letters he had received a cablegram from a lady and gentleman abroad that they would be willing to subscribe \$5,000. In addition to this amount Mr. Edgar Judge announced a further sum of \$200; Dr. Paterson Smyth, \$1,000, and the Rev. A. E. Shattford announced that he had received promises of \$1,150, so that the fund at present stands at about \$18,000.

Mr. Wilson Smith again presided, and there was a very fair gathering of workers. The campaign, he said, was still going well, and everything pointed to a successful Monday night. Mr. and Mrs. C. W. Lindsay, and many additional subscriptions had been received that morning, including one from the Ladies Guild, and another from the Chamber of Commerce, Quebec. It was evident that they were arousing greater sympathy for the movement, and people were beginning to realize that they were going to succeed.

Dr. Paterson Smyth urged the necessity for further large subscriptions, adding that intending subscribers should remember that big subscriptions could be spread over any period up to five years. The occasion was the chance of a lifetime when they should liberally show their regard for their church. He was confident that the fund would be realized.

At the conclusion the chairman extended a fresh invitation to lunch to all the workers adding that if they could only \$5,000 each their goal would be in view. He wished to thank the press very much for their kindness in bringing the matter before the public as they had.

## ARGUE OVER INSURANCE

Heir of Dead Priest Sues to Recover \$1,000 on Policy.

A case is being argued before Mr. Justice Greenhalgh, in which plaintiffs are attempting to secure payment of a sum of \$1,000 from an insurance company which refused payment on the ground that the insured prior to taking out the policy was suffering from a disease, angina de pectoris.

The plaintiff is Mederic Greigore, the heir of the late Rev. Father Greigore. Greigore has taken action to recover a sum of \$1,000, the amount of a policy issued by "L'Assureur" on the life of the deceased priest.

The company refused payment on the ground of misrepresentation, but evidence was introduced to show that although Father Greigore may have had "angina de pectoris," he was unaware of the fact. Fifty percent of the people are walking through life with diseases that they do not know anything about, said His Lordship. The case was adjourned and will be taken up at a later session of the court.

## TRAVEL PICTURES

Lyman H. Howe's travel pictures are the attraction at the Princess Theatre again this week, and all Montrealers who had not seen them would lose none of their effectiveness if the ridiculous shouting and talking maintained behind the scenes were omitted. The color affects in some of the views are very fine. The pictures take one through Southern France, the Mediterranean and Malaya. There were some really remarkable pictures of Mount Etna in eruption. Some of the other pictures shown are Easter Sunday on Fifth Avenue, New York; views of some of the European cities; a view of the action and of some daring riding by Italian horsemen. ## MOTOR SPEEDER FINED

Arthur Courtenaie appeared before Magistrate McMahon in Westmount, yesterday, charged with violation of the motor speed limit on Westmount avenue, Sunday afternoon. The accused was fined \$20 and \$5 costs.

## WESTERN FREIGHT RATES

Ottawa, May 21.—The Railway Commission to-day laid over until June 15 the western freight rates investigation, as the western sitting will be held to hear it.

# FINANCE

## WILL STEEL CO. OF CANADA JOIN DOM. STEEL CO.?

There is a report on the 'Street' that some interests are already working with a view of trying to get the control of the Steel Company of Canada over to the Dominion Steel Corporation.

It is believed that Sir Max Aitken, the Bank of Montreal, and Wilcox Investors of Hamilton, control the majority of the shares of the Dominion Steel Corporation control of the company.

The 'Street' has it that the exchange basis would be the two shares of Steel Company of Canada for one of Dominion Steel Corporation.

## POWER HIGHER SPANISH AND SAO PAULO RISE

The star actors in the stock market yesterday were Power and Spanish River Common, both of which rose to more expensive levels. The former opened at 205 3/4, and ascended steadily to 207 1/2, while Spanish advanced from 57 1/4 to 62—which, however, was a half point below the high mark touched in Toronto during the morning session.

Sao Paulo made a mercurial flight from 236 3/4 to 241 1/4, with a turnover of only two hundred shares. This was due to the rumor of a new stock issue, which will, in effect, mean the doubling of capital stock to be placed on a six percent basis.

Richelleu was firm, Steel Common somewhat weaker, while Detroit showed a tendency to advance.

Southern Railway active, while bank shares were quiet.

## G.T.R. DEALING WITH NEW YORK BANKERS NOW

The Grand Trunk Railway has made a departure by selling to an American brokerage house a large issue of equipment bonds. It is believed that this is the first time the Grand Trunk has done any financing in the United States.

By the transactions, Blair & Company and the Bankers Trust Company, of New York, take an issue of bonds for the amount of \$4,687,500, dated May 1, 1912, being the cost of 5,000 cars to be divided between the Grand Trunk Railway and the Grand Trunk Western Railway.

The amount to be paid is \$4,675,000 cash, and the balance 5 percent each six months for ten years.

## TREASURY BILLS LESSEN MONEY SUPPLY IN LONDON

London, May 21.—Money was scarce to-day owing to the payment of \$15,000,000 for treasury bills. Discount rates were firm. The stock market was again depressed, and all foreign shares lower. Home rails depressed 1-2 to 3 points on account of troubles and dividend fears, and underwriters sold gilt edged securities.

Another speculative advance in copper metal appears to exercise no influence. Bonds were steady.

SHARP ADVANCE IN SAO PAULO IS DUE TO LONDON

Toronto Brokers Believe that Something Good is Coming—What Rumors Say on Issue

Toronto, May 22.—At its top price this week Sao Paulo stood better than six points in advance of the closing quotations on Saturday, and thus demonstrated the most remarkable rise for one day witnessed in the Toronto stock market during the year to date.

REGINA SELLS DEBENTURES TO MERCHANTS BK

Regina, May 22.—The City Council has agreed to the sale of city debentures amounting to \$224,000 to the Merchants Bank for \$72,288.40, at the rate of 96 1/2. Other bidders were: G. A. NO BUTTER TO U.K. THIS YEAR --- CHEESE FIRM

One of the largest of the local produce exporters gave it as his opinion this morning that there would be no surplus of butter to England this year. The demand from the west, he said, has this season, up to proportions far exceeding that of any previous season. This demand is mainly from Vancouver, Edmonton, Calgary, Winnipeg, and the grain growing countries do not balk at the price which is necessary to pay for the freight and other charges are added to the purchase price. This, of course, keeps prices up locally, and leaves the local warehouses pretty bare of stocks. So much is now being consumed at home that it is very doubtful whether any shipments will be made abroad.

BROKER MAKES A FEW GUESSES

Following the rapid advance in Sao Paulo, which is closely in touch with the affairs of the company, says that he has been informed on the best of authority that there is a special reason for the present movement, and that an announcement would be made shortly. In his judgment the stock would go to a good high level. "It is clear," he added, "that when the plan is placed before the shareholders, it will be quite different to what the public has been led to expect."

DOMINION STEEL CO. ISSUES Selling at High Prices

Dominion Steel bonds sold up to 95, and preferred stock up to 106. The confidence that foreign interests seem to have in Dominion Steel Corporation is resulting in Canadian investors taking a more optimistic view as to the outlook for the company.

CHIEFS STORY IS COMBATED

The question to be determined, said Mr. Ames, is who ordered the goods. Mr. D'Amour said that it was not his place to pay for the goods after Mr. Stanton was appointed. He brought the bills upstairs for Mr. Stanton to initial. This Mr. Stanton refused to do, because he had not ordered the goods, Mr. Pelletier, city comptroller, refused to pay them because no money was provided for them in the estimates.

All I could do, said Mr. D'Amour, was to give the bills to the chief. That was a year ago. Mr. D'Amour said that after Mr. Stanton was appointed his duties were merely to make out requisitions for goods ordered for the fire department. He then before Mr. Stanton, and have him initial them. AIMED TO END DUELLING

German Reichstag Resolution Against Practice.

A CASE IN POINT

Chancellor Asked to Take Steps to Stop Army Custom Which Makes Fighting Compulsory.

(Special Correspondent of the New York Evening Post.) Berlin, April 20.—One of the unlooked-for results of the new army and navy bills has been to bring the question of the official recognition of the duel into the forefront of public attention. The passage of arms between the Minister of War and the Catholic party during the debate in the Reichstag on the army bill has again shed sharp light on the yawning gulf between the view of the great mass of the German people and the official attitude and the ideals cherished by those in authority over them.

The question is almost the only one on which the Catholic and Liberal opinion are agreed. The Catholic Church forbids the duel as a contravention of the divine law. Liberal opinion is divided on a general ethical grounds. The official, and aristocratic opinion defends it as indispensable in a cultivated society, where the ideas of courage and honor are constantly being assailed by the materialistic influences of civilized life. The case over which Gen. von Heering drew the heavy artillery of the Catholic party is typical of the situation in which the duel as an institution lives itself. The affair occurred some two years back, but the facts about it have only recently become known. It has the special interest of having been the subject of an imperial pronouncement, and affords a striking example of the conflict of view between the uneducated and enlightened civilian opinion of the day.

Two physicians, Dr. Schumm and Dr. Sambeth, practised in the little town of Mergentheim in Wurttemberg. Both were medical officers of the reserve (Landwehr). Dr. Schumm was a member of the liberal party, and Dr. Sambeth was a member of the conservative party. The volunteer ambulance association. RICH PAY FOR GERMAN NAVY

Passing of Navy Bill Shows that Wealthy Class Will Bear Increased Cost

Berlin, May 22.—That the contention that part at least of the cost of the increases in the army and navy should be borne by new taxation imposed on the wealthier class has prevailed, is made evident in the passing by the Reichstag yesterday of the third reading of the bill increasing the German army and navy.

The Reichstag adopted the two laws first on the condition that it would grant the necessary funds upon the introduction by the Government of legislation providing for some form of general property tax and its enactment before October 1, 1913. Its second condition was that the Government should reintroduce the inheritance tax Bill, the rejection of which overthrew Chancellor von Buelow, and which was one of the principal issues at the last general elections.

The Secretary of the Treasury announced that the Government accepted the first condition, which was interpreted as demanding some form of taxation of wealth or inheritance and would introduce a measure to that effect, but it was unwilling to bind itself to the inheritance tax contemplated in the second condition.

The Reichstag nevertheless adopted the second condition by a vote of 184 against 189. The majority comprised Social Democrats, National Liberals and Anti-Semites. The result of the vote was a clear victory over the old anti-Buelow 'bloc' and a vindication of Adolf Wermuth, former Imperial Secretary of the Navy, who resigned office because the Government's proposals for financing the army and navy measures were inadequate.

The Reichstag cut in half the expected revenue from the abolition of the distillery rebates and found the additional revenues required by postponing the promised reduction of the sugar tax until after the enactment of the property tax demanded by the majority.

The navy bill, as passed yesterday, provides for an extra battalions squadron for which three additional battleships and two cruisers are to be constructed before 1920. The estimated additional cost is \$24,250,000 this year, \$31,750,000 next year, and \$28,500,000 yearly afterwards.

The army bill provides for an increase of 29,000 men, excluding officers, non-commissioned officers, and details in the peace footing in the army.

MR. HALDANE'S MOVEMENTS. London, May 22.—Viscount Haldane, Secretary of State for War, left for Germany last night. It was surmised that he would continue his mission, begun in the early spring, relative to international relations and the restriction of armaments. But it was officially stated last night that Mr. Haldane's visit to Germany was purely of a personal nature and was undertaken for his health. It is announced further that the secretary is not going to Berlin.

ELLIS ISLAND National Manufacturers' Association Want \$1,000,000 for Better Immigration Facilities.

New York, May 21.—Steps towards the formation of a new political party were taken at today's session of the National Manufacturers' Association. John Kirby, Jr., president of the association, spoke in favor of a new party, and a committee was named to draft resolutions and to plan ways and means of inaugurating the movement.

James A. Emery, of Washington, D. C., general counsel for the national committee for industrial defense of the Manufacturers' Association, reviewed legislation pending in Congress which relates to labor difficulties and injunctions.

One of these pending bills provides that no injunction shall be issued in disputes between employers and employees except upon property rights, and then it provides for the purpose of that bill no right to enter into the relation of employer and employee, or to do business in any particular place, or the good will of any business should be considered as property rights. That is, it does not propose to wipe out the protection of property rights by a court of equity, but it proposes to wipe out the property which the court has the power to protect. The Judiciary Committee of the House has agreed upon a bill which provides that no injunction should remain in force for more than seven days of its issuance, without extension.

Exemption of labor organizations from the operations of the Sherman Anti-Trust Law was denounced in a speech at the meeting of the Association. Another resolution called for the appointment of a permanent non-political tariff commission. Congress was urged to appropriate \$1,000,000 to provide better facilities for the reception of immigrants at Ellis Island.

THE NEW BY-LAW. Seven Carters Fined for Not Stopping Behind Stationary Street Cars.

In the Recorder's Court yesterday seven men were fined for violating by-law 450, respecting the stopping of vehicles behind stationary street cars. Jacob Goldstein, Hain Tesler, Joseph Belanger, Alfred Lavepui, Henri Leclair, John Sullivan and John Murphy were each fined one dollar or eight days in jail. For being drunk while in charge of a vehicle, Albert Rousseau was fined \$20 or one month in jail.

QUIT-TAM ACTION DISMISSED. Two 'quit tam' actions were dismissed with costs by Mr. Justice Ritchie yesterday. The cases were those of F. Hurtubise vs. G. W. Faust and vs. G. W. Faust, Limited. The plaintiff seeking recovery of a penalty of \$100 from the first defendant and \$200 from the second on the ground that statements showing the date of incorporation of the company had not been filed with the prothonotary within the legal period of sixty days. It was shown that at the time of the institution of the action the company had not been sixty days in existence, and the suit was premature, being accordingly dismissed.

MAJORITY WAS 551. Mr. Philomen Cousineau's official majority in Jacques Cartier was 511.

ELECTION TANGLE

Judgment Reserved in Two Mountains Case.

The Two Mountains election case was heard on Monday and Tuesday by Justices Robidoux and Laurendeau, sitting at St. Scholastique, and judgment was reserved.

In this case Mr. J. A. C. Ethier, the Liberal candidate in the federal elections last September, was declared by the returning officer to be elected by acclamation, as the nomination paper of the Conservative candidate, Mr. G. A. Fautoux, did not indicate his occupation or place of residence.

It was argued for Mr. Ethier that the law, as found in section 94 of the Dominion Election Act, strictly required that the residence and occupation of the candidate to be specified on the nomination paper. On the other side it was held that this was not a matter of strict law, but that the only intention was to ensure identification of the candidate, and in the present instance there was never any question about that. Mr. Fautoux was well known in the county and was conducting a public campaign. He was recognized by the returning officer when he submitted his nomination paper. His \$200 deposit was received, and he was given a receipt for the money. The declaration accompanying the nomination paper also stated that Mr. Fautoux was an advocate and resided in the county.

Mr. Perron, K.C., appeared for Mr. Ethier, and Messrs. P. B. Mignault, K.C., and F. J. Bisson, K.C., for Mr. Fautoux.

CHANGING HIS CLOTHES.

So to Prevent Possible Desertion, Stoker Was Sent to Jail.

Thomas Connor, a stoker on board the steamship 'Laurentic,' was yesterday sentenced by Judge Lanctot to pay a fine of \$5 and to go to jail for five days until his ship sailed. Connor, who had been warned three times against desertion, was arrested when he was changing his clothes, with the object, the prosecution maintained, of deserting.

THE LATE MR. W. WHITAKER.

His many friends will learn with regret of the death in the city yesterday, of Mr. William Whitaker, who was closely connected with the band of Ulstermen, who, in 1829, came from Ireland and settled in the district of Rawdon, Que. He was a son of the late Mr. William Whitaker, who was a member of the Rawdon pioneers. He was born at Rawdon 72 years ago and educated at 'Joliette' College. After he had been practised for many years as a civil engineer and surveyor. He took a prominent part in the life of the Ulster settlement, and for 22 years was secretary-treasurer of the township of Rawdon. He retired from business life 17 years ago, and since he has resided quietly in Montreal. He was a brother of the late Rev. George Whitaker, of St. Bridget's Church, and also of the late Rev. Jas. B. Whitaker, formerly of St. Ann's Church, and later of Burlington, Vt. He is survived by a widow, one son, Mr. James A. Whitaker, of Lachine, two daughters, the Misses Maude and Lillian Whitaker, living at home, and a sister, Miss Elizabeth Whitaker.

OPENS NEW HEADQUARTERS.

The Young Women's Hebrew Association is growing rapidly.

The Young Women's Hebrew Association has been successful in obtaining a room for the summer as temporary quarters, in the Baron de Hirsch Institute, which will be open to the members every evening. During the last fortnight the membership list has rapidly increased. Social evenings will be held every Saturday in the club rooms, and meetings the first and third Sunday of each month, at which all are welcome.

COLORED WOMAN IN TROUBLE.

Evelyn Madden, a colored woman, of 412 Notre Dame street West, pleaded not guilty to a charge of larceny when arraigned before Judge Lanctot. She is alleged to have stolen \$495 from a trunk in the room of Joseph Garris, also colored, of 488 Notre Dame street West. She pleaded not guilty, and was remanded for enquete on the 29th.

ITALY NOW HAS ELEVEN ISLANDS

The 'Temps' Says She Has Changed the Whole Political Map

Paris, May 22.—The extension of the Turco-Italian war is awakening the powers to the necessity of making renewed attempts to bring the conflict to an end. Italy's steady occupation of the Turkish islands in the Aegean Sea, which Turkey has, angered by expelling Italians from the Ottoman Empire, is regarded here with considerable disquietude.

Italy is in control of eleven Turkish islands in the archipelago, and this, it is pointed out, totally modifies the equilibrium of force in one section of the water route round the world, which, with the completion of the Panama Canal, means a continuous global marine movement.

The 'Temps' declared last night that Italy's occupation of the archipelago changes the whole political map, as the eastern Mediterranean enters into the dominion of the Triple Alliance. The turn of events, therefore, is distinctly against the interests of the triple entente and chiefly against those of Russia, and the time has arrived for the members of the triple entente to examine the situation seriously.

Various suggestions for mediation between Turkey and Italy have been proposed, including the convening of a congress of the European powers and a proposal to allow Italy to remain in Tripoli, as England has remained in Egypt, with Turkey retaining her legal claims on the islands and receiving additional economic compensation.

FARMERS' BANK.

Travers Accuses Wishart, a Mining Man, of Blackmail.

Toronto, May 21.—Testifying at the afternoon sitting of the Farmers' Bank enquiry before Chief Justice Meredith today, W. R. Travers accused George Wishart, of New York, of blackmail in connection with the Keeley Mines. He said that Dr. Nesbitt had proposed the organization of a company in which Travers, Wishart and Travers and the bank were to hold equal shares. Travers had thought Wishart was an exceedingly wealthy man, but when his turn came to advance \$50,000, all he could give was a note for \$25,000. The bank had loaned him \$25,000 to make up the payment, and when the next payment came due the bank put another \$50,000 where the first had gone because Travers had believed the property was good.

'And I still believe it is good as it ever was,' he said. The Keeley Mines, Limited, was reorganized from a company with \$1,000,000 capital to one with \$250,000, the balance to be unloaded on the public. Travers said that Wishart insisted upon having his note returned in order to get his consent to the reorganization. The note was returned and Wishart retained his interest in the company. This was the blackmail which Travers referred to.

Several other witnesses, including Messrs. Fitzgibbon, Town and Hunter, were examined regarding minor points in Travers' evidence. The hearing will be resumed at 11 to-morrow at Osogode Hall.

DEATH OF WERNHER.

Wealthy Knight Who Was Victim of Clever Swindle.

London, May 21.—Sir Julius Charles Wernher, head of the De Beers Diamond Syndicate, and of the firm of Wernher, Beit & Co., died to-day.

It was Henri Lemoine, a Frenchman, who succeeded in swindling Sir Julius Wernher out of more than \$500,000 by pretending that he had discovered a method of making diamonds by a chemical process, for which Lemoine in July, 1909, was sentenced at Paris, to six years' imprisonment. The case bore a resemblance to all the great swindles, such as the Humbert safe mystery in France, the Chadwick case in the United States, and the Druce affair in England.

DESIRED ONLY ONE COMPETITOR Attempt of American Bridge Co. to Combine Small Companies Revealed at Inquiry

New York, May 22.—Mr. Percival Roberts, Jr., director of the U. S. Steel Corporation, at the hearing of the Government suit to dissolve the corporation and under the Sherman Anti-Trust Act to-day, testified concerning the organization of the American Bridge Company.

Mr. Roberts, who was president of the bridge company when it was taken over by the U. S. Steel Corporation in 1901, denied that the company was essentially organized with the object of monopolizing the industry. He said that at that time (1900) the company's output amounted to only 28 percent of the entire output of the country, that this percentage had fallen to 22 percent a year ago, and that the company now only owned about 29 plants against 275 independent plants.
