

REFORM VICTORY

Anti-Tammany Sweep in New York.

HILL IS DEFEATED.

An Immense Majority Rolled Up for Morton.

GRANT IS DEFEATED BY STRONG.

The Entire Tammany Ticket in New York Snowed Under.

LARGE REPUBLICAN GAINS.

They Are Reported from all the Atlantic and Western States.

Wilson's Probable Defeat.

New York, Nov. 6.—To-day the elections of Representatives in Congress were held in all the States of the Union, with the exception of Maine, Oregon and Vermont, which had already chosen their Congressmen.

The greatest interest has centered on the result in New York State, where the excitement has been intense and the fight the hottest.

In all States but Tennessee there were three or four tickets. In Tennessee the Republicans and Democrats had the field all to themselves, as the people's party in that State endorsed the candidates on both tickets.

The fact that women had a vote this year in some of the States made the outcome unusually uncertain, as, while the Populists were the staunchest advocates of woman suffrage, it was thought by many that the greater conservatism of women would tilt in favor of Republicanism.

New York, Nov. 6.—The election in New York City has been of exceptional interest, and the Republicans have gained a victory far above their wildest anticipations. The Democratic party has been badly beaten, and the only national issue of any consequence, the election of Congressional candidates, every Tammany nominee for any municipal office has been defeated, and the vote that has been polled for Assemblymen is so insignificant that it can have no weight against the overwhelming majority by which the Republicans will carry the State outside New York and King's County.

THE TAMMANY DEFEAT. New York, Nov. 6.—Tammany is defeated. The nominal majority of 60,000 usually polled by that organization in New York City has been obliterated; an opposition non-partisan majority of 40,000 to 45,000 has been piled up, making the net opposition gain more than 100,000. Never since 1871, the year in which the revelations concerning the operations of Tammany were made, have the people been so thoroughly aroused against Tammany Hall, and the returns to-night show that a severe blow has been struck at the foundation of the most powerful local political organization in the country.

Two years ago the Rev. Dr. Parkhurst delivered a sermon in his church, Madison Square Presbyterian, in which he charged Tammany with mis-government in all the departments of the city, and particularly charged the Police Administration as corrupt. He was elected President of the Society for Prevention of Vice, and began a remarkable crusade against Tammany. His course was so extreme that some of the best citizens publicly stated that his ardor for reform was ill-advised, and they deprecated the means he has adopted to prove his assertions. Now in the least deterred by the flood of abuse which he had evoked, he pursued the course he had mapped out for himself. He would point out to the authorities the existence of an illegal election. The police would report that the place specified did not exist. Then the society of which Dr. Parkhurst is the head

would procure warrants and raid the place. In many instances the proprietors were convicted on the evidence of the society, thus conclusively proving that the police were making no attempt to uphold the law. The fight was waged with great bitterness. At the last session of the Legislature the matter was laid before the Senate with the result that a Committee was appointed to examine into the various New York City departments.

John W. Goff, who was to-day elected Recorder on the Independent ticket, was selected as counsel to the Committee. The result of his labors was the presentation of evidence which, in the popular mind, and in the expressed view of the New York City and State newspapers, implicated public officials in corrupt practices. The campaign culminated in the creation of an independent party of seventy citizens, and under its leadership a concentrated political movement was directed against Tammany Hall, in which the Good Government Club, the German Reform Association, the State Democracy and the local Republican organizations joined in endorsing a

non-partisan ticket, headed by William L. Strong for Mayor and John Goff for Recorder.

Prior to this year the revolts against Tammany had been made in what are known as the "Brown Stone" districts. The revelations made before the Senate Committee caused a revulsion of popular feeling, not only in their districts, but also in the tenement districts on the east side of the city.

A feature of the canvass on the east side was the part women played in it. Women of the highest social standing formed themselves into an organization to aid in the war against Tammany and they carried the war down into the tenements.

There seems to be no doubt that their action added in a measure to bring about the result of to-day's election. So complete is the downfall of the great political organization that its nominees for Congress are involved in the catastrophe. With the exception of one of its Congressional candidates, the Tammany Congressional candidates have been defeated. Mr. Strong's plurality for mayor exceeds 40,000.

A VERITABLE CYCLONE. Albany, N.Y., Nov. 6.—The story of a political cyclone following a landslide of a year ago marks the election in New York State to-day. The most sanguine political observer had failed to find in the past election indications of anything that would allow a forecast of such a result as complete as the battle-ballet in this State. Even those who believed in the success of the ticket that places victory at its top to-night were but sanguine that the usual result of depreciated majorities below the Harlem for the dominant party there and increased majorities above that river's banks for the party of the majority in that section. And the most sanguine of these people expected that the

It can have no weight against the overwhelming majority by which the Republicans will carry the State outside New York and King's County. Of the nine Congressional districts in this City, Tammany has only carried three, the eighth, ninth and twelfth.

ANALYSIS OF RESULTS. An analysis of such figures as are obtainable to-night shows that the Republican party alone gained by the increased registration for Mr. Morton's vote in all of the up-country districts shows large gains over the Fasset vote of 1891, while the Democratic vote is not out in any great measure from its hitherto normal condition. In the cities this same increase in registration appears to have been general, but even in the Democratic, for in a great many cases in strong Democratic quarters there were many voters unable to exercise the right of franchise. Indeed, it was claimed by Gov. Flower and Clerk De Forest, of the State Committee, that by reason of the large registration of from 1,800 to 3,500 more voters than in the normal election of 1891, the number of ballots to be voted 80,000 Democratic voters were unable to cast their ballots. That the depression caused by tariff or national matters had little to do with the general result was evident from the fact that in manufacturing districts there was no very great defection from the general run of voting. But there were individual counties where the vote was perplexing for the way in which it deflected. Albany County led these. A Democratic stronghold with few manufacturing interests it has held true to its principles and in wavering times such as occurred in 1891 it gave normal De-

Despite the fact that it is the home county of the Democratic candidate it gives Mr. Morton a plurality. Rensselaer County, the home of Senator Murphy, stuck as closely to Democratic principles as any in the State, which was

surprising in view of the sentiment that had been appealed to by the death of Robert Ross.

The results of the sweeping victory are more far-reaching than simply the election of the Republican State ticket. While the returns are very incomplete on the constitutional amendments, it is probable that the per centage of loss as compared with the vote for the head of ticket is not nearly so large as it was supposed to be, and the result, therefore, is that the Legislature will consist of fifty Senators and 150 Assemblymen, that pool selling or races will be prohibited, that the canals will be improved, and that a new judicial system will be inaugurated. The sweep means also that for the first time in many years the Republicans will have control of the State Legislature, and at the same time a Governor in the chair in political harmony with them.

In addition to all these decided gains, the State Congressional delegations being changed materially acts in a political sense, and it may be said with the election of a majority of Republican Congressmen New York State throws control of the National Legislature into Republican hands.

Governor Flower gave out the following statement at midnight: "The elections show that a tidal wave of Republicanism has swept the country from Maine to California. Our party was dilatory in repealing the silver bill and tariff law, business has been disorganized, and when the tariff bill was passed no one seemed willing to father it, or call the question settled. The result shows that business men have voted the Republican ticket in order to give their interest a rest. The result in Brooklyn and New York shows that the people want a purer and better government for those cities. The result shows that Senator Hill's vote and Mr. Wheeler's combined vote would lack over 100,000 of carrying the State."

HOW HILL TOOK HIS DEFEAT. Albany, N.Y., Nov. 6.—As has been the custom for years, the State officials gathered to-night in the Executive Chamber to receive the returns from the various parts of the State. Senator Hill arrived at 7 o'clock. He was accompanied by his private secretary and Col. McEwan. He was the first to arrive. Col. Williams, the Governor's private secretary, came next. At 7:30 o'clock, all hope of saving the State was given up by those who had thus far arrived.

It was even feared that New York City might go Republican, and it was conceded that Hill would not carry the city but by a few thousand votes.

Governor Flower arrived at the Executive Chamber at 7:45. He said that it seemed as if a great tidal wave had been sweeping across the State. He did not know but that it had been brought about by the police investigation. He said that he felt that the wave was coming when he was in New York this morning. All the time Senator Hill said not a word, but read the Associated Press returns and consulted the manual containing the votes of former years. As the country returns from up the State arrived he shook his head and said: "Well, they did pretty well by me." To the consoling remarks of friends he made no reply except to smile.

REPUBLICAN HOPES. New York, Nov. 6.—Joseph H. Manley, Chairman of the Republican National Executive Committee, has sent the following telegram of congratulation: "Hon. J. W. Babcock, Chairman Republican Congressional Committee, Washington, D. C. I heartily congratulate you on the result of to-day's election. Our victory is complete from Maine to California. The result in New York is the grandest victory of all. We have laid this day a solid foundation upon which to erect, in 1896, the structure of national victory for protection and prosperity." SCENE IN NEW YORK. New York, Nov. 6.—The scene on News-Park Row at 8:30 to-night, when it was conceded by the Democratic organs that Morton had won the governorship and Strong the mayoralty, was one of wild enthusiasm. When the newspaper bulletins and stereopticons began to display the returns about 6 o'clock, there were about 2,000 people on Park Row, but during the following two hours the crowd was augmented by a continuous stream of people from the up-town districts. By 8 o'clock fully 10,000 people thronged the thoroughfare, blocking the cars and impeding the horse and cable cars.

When the concessions by the Democrats were announced, there seemed to be three Republicans to one Democrat present. The assemblage was a very orderly one, and seemed to be composed of a more respectable class than that which usually visits Park Row on election night. The Tammany men who were down town had no excuse to offer for their overwhelming defeat, and one of the leaders said: "This will lead to a thorough reorganization of the Democratic party in this State, and it will bring about good results two years from now."

ILLEGALLY EXEMPTED

THE HERALD'S DISCOVERY CONFIRMED BY THE SCHOOL BOARD.

The Catholic Commissioners Take Steps to Collect Taxes Legally Due.

When the Herald stated a few days ago that there were many properties on the list of exemptions which had no legal title to be exempted from taxation, it was not to be expected that the statement would soon be confirmed by the authorities of the Protestant and Catholic School Boards. Yet such is the fact.

At the time the Herald's article was published Mr. U. E. Archambault, Secretary of the Board of Catholic School Commissioners, and the Treasurer of the Protestant Board, were investigating the assessment roll. Last evening, Mr. Archambault made his report before the meeting of the Catholic Board. He found, he said, that many properties were marked exempted, while there was no specific reason given. In other cases, property belonging to private individuals, but rented to the Government, the corporation, ministers or religious bodies was equally exempted. Now the law says clearly that the school tax is to be levied on the property, and that every piece of real estate belonging to private parties and rented for revenue is taxable for school purposes.

The Protestant Commissioners had consulted Mr. Robert Greenhalgh in the matter, and he had given his opinion as above. Another indication of the carelessness which sometimes prevails in the preparation of the rolls is that several proprietors have part of their property placed on the Protestant list and part on the Catholic list. That is the case of Mr. Jas. Baxter, among others.

The members of the Board present: Rev. Canon Bruchesi, President, Rev. Cure Quinlan, Rev. Monsignor Leclerc, Dr. Desjardins, Dr. Brennan, Mr. F. D. Monk, and Alderman Beausolil, considered that the question was a very important one, and decided to refer it to the Finance Committee with instructions to secure legal advice and to see that the tax is collected wherever it is due.

As to the proprietors whose religion is not ascertained, the City Treasurer has volunteered to send them a circular inviting them to make a declaration of creed. The question of pooling the school tax collectors from the two again came up, owing to a letter from the Protestant Board asking for an immediate and definite answer. Rev. Canon Bruchesi said that he had seen Superintendent Quinlan and Attorney-General Casgrain at Quebec about the legal difficulty in the way of forming a pool, and that he awaited their answer. It was decided to write accordingly to the Protestant Board, at the same time expressing surprise at the demand for an immediate answer.

Mr. Levesque, cure of the parish of St. Vincent de Paul, writes to the Board explaining the many inconveniences resulting from the fact that part of his congregation belong to the school municipality of Hochelaga and asking to be annexed to Montreal.

Mr. Monk remarked that the annexation of Hochelaga school municipality to Montreal had been prevented by the Cure of Hochelaga. It was resolved to write to Cure Levesque, and if his parishioners were willing to take the necessary steps prescribed by law for annexation, the Montreal Board would be happy to receive them.

The final financial statement for 1893-'94 was submitted. It showed that the reconstruction of Sarsfield School has cost \$46,000 up to date, and that of Montclair School, \$41,830. There is now a deficit of \$14,962 in the fund applicable to capital. This deficit has been covered by drawing on the ordinary receipts in anticipation of the new issue which the Board will be authorized to make in 1895.

A letter of the parish priest of St. Ann's, praying that \$10,000 be granted to his school, was read, which led Rev. Cure Leclerc to again submit his proposition for a general readjustment of the grants given to various schools. The consideration of this important question was left over for a special meeting.

St. George's Society. The Board of Management of the St. George's Society met at the home last evening. The following gentlemen were present: Jos. Richards, Chairman; R. S. Cliff, Treasurer; Jas. Mitchell, Secretary; Edgar Judge, Wm. Nivin, E. G. Penny, C. Slater. Mr. Mitchell read the monthly report, showing that during the month 56 individuals were received at the home, while 37 persons received outdoor relief. The Chairman of the Charitable Committee reported a disbursement of \$128.41.

A COMMISSION REFUSED.

It May Have an Important Bearing on a Criminal Libel Suit.

H. C. St. Pierre, Q.C., made an application in the Court of Queen's Bench yesterday, which, although Judge Hall admitted the reasonableness of it, could not be granted, as it involved an important precedent. In the case of the house of Channon against Bertin for criminal libel Mr. St. Pierre asked that a commission be granted by the Court to examine one of the most important witnesses for the defence, one Devasseaux, who leaves to-day for France, where he will be while the trial is in progress. As it was impossible for the Court to detain him, and as otherwise a commission should be wanted for his examination when out of the country, the counsel asked that it be granted before the man left the country. Mr. Bisailion, for the prosecution, objected, and as the Judge stated he had not time to consult the Chief Justice and other judges, he had to refuse the application.

Carolina Elton, charged with obtaining goods under false pretences from J. J. Ogilvie, was found guilty. The trial of John Madigan, for theft of liquor, was commenced.

BROACHING CARGO.

The Charge Against Six Cattlemen on the Oregon.

On arrival of Dominion Line steamship Oregon last evening, there was a flutter of excitement when six cattlemen were marched off, each in charge of a policeman. The men were arrested by Lieut. Reid, of No. 15, and were taken to that station. The charge laid was broaching cargo on the steamer, an offence said to merit severe punishment in the Old Country. The names given were Ernest Burton, Wm. Burdick, Irwin Reeves, resident in Montreal; Chas. Sweeney, a coal trimmer of Londonderry; Jno. Caldecott, a Toronto carpenter; David Roper, a merchant from Brampton, Ont. Some of the goods found in the possession of the men were a lot of towels, some hats and a box of figs. The method of stealing was to open the hatches of the ship and go down below. Only for the shrewdness of Chief Officer Jones it is quite likely the pilferers would have escaped and the ship would have been black mailed. It is expected that only one or two did the stealing, while all are charged with complicity.

NEWS FROM QUEBEC.

An Imposing Memorial Service to be Held at St. Roch's.

[Special to the Herald.] Quebec, Nov. 6.—In a large number of parishes of this district resolutions of regret and condolence at the death of Hon. Mr. Mercier were passed by leading citizens of both parties and it is intended to have masses celebrated for the repose of the soul of the lamented dead. At St. Roch, Quebec, the Hon. Mr. Laurier's Electoral Division, a service will be sung on Friday next which will be one of the most imposing funeral ceremonies ever witnessed in this country. It will be celebrated by Archbishop Beaudry, Coadjutor of His Eminence Cardinal Taschereau, officiating pontifically and Hon. Mr. Laurier and quite a number of prominent Liberals will be in attendance.

The presence in Quebec of Hon. Mr. Angers, Minister of Agriculture, creates a certain group of local Conservatives, the opportunity to call a private meeting at Mr. Bellefleur's, Q.C., Mayor of Lévis, where the Minister was tendered the candidacy in Lévis County, but he positively declined, preferring a shelter in the Senate. Sir Adolphe Caron, it is said, will be invited to Lévis County instead of Rimouski, where he finds no chance of being re-elected. Mr. Bellefleur objects with obstinacy.

Outside of the Hon. Mr. Joly de Lotbinière, Mr. Tarte, M.P., Hon. Chas. Langlois and Mr. J. C. Langlois are being talked of in connection with the vacant Liberal candidate for the bye-election in Bonaventure County. But if Mr. Joly accepts the candidature he will be unanimously and enthusiastically appointed.

Mr. W. C. Edwards, M.P. for Russell, has subscribed \$100 towards the funds of the Champlain Monument, to be erected here, and suggested, it should be a national and not a provincial affair, promising he would gladly support an application made to the Dominion Parliament for assistance. The suggestion is said to be very favorably looked upon by it is considered it would be to a certain extent a step towards better relations between the different nationalities of this country at large.

On Sunday burglars paid a night visit to the Parsonage of St. Valier de Bellechasse and left with \$200 belonging to the Cure, Rev. Mr. Rainville. It was reported that a virulent type of fever, commonly known as "black" fever, is prevailing in Valcartier, Port Neuf County, and that three or four persons have already fallen victims to it. It appears that the report originated in the following manner: A young man named Clark, aged 22, yesterday dropped dead at dinner-time from a fit of indigestion, and his brother, who was at the table with him, was so overcome by the shock that he also died an hour after. The former's body turned black after his death, which gave rise to a report of black fever.

BOODLE INVESTIGATION.

Toronto Probing the Aldermanic Proceedings for Ways That Are Dark.

(Special to the Herald.) Toronto, Nov. 6.—The principal feature of the evidence taken before Judge McDougall in the boodle investigation to-day was that all the roofing of the buildings of the Street Railway Company since they secured the present franchise has been done by Ald. W. T. Stewart. Wallace Nesbitt, counsel for the city, had some difficulty in eliciting his testimony, but the determination which he showed to get it out, indicates that he attaches considerable importance to it. The whole of this morning's sitting was given up to the hearing of the President McKenzie, Secretary Grace, and Electrician David of the Street Railway Company had to say.

Toronto, Nov. 6.—This afternoon's evidence in the enquiry being conducted by Judge Macdougall, elicited further interesting evidence. Mr. George Bertram, of the Bertram Manufacturing Co., one of the tenders for the establishment of a civic lighting plant, testified that Mr. Wheeler, of the Brush Electric Co., Cleveland, O., told him about the "financing" business, but he placed little faith in the yarn until Col. Rogers came with Mr. Wheeler and corroborated the latter's statement. Mr. Bertram produced a copy of the council resolution sheet showing the names of the thirteen, with ticks opposite them. Both men promised earnestly that they would appear at the investigation and give evidence.

The next witness was Silas H. Wheeler, an employee of the Toronto Electric Light Company, no relative of Mr. Wheeler, of Cleveland. About October 19th, a letter was delivered at his address, addressed to Mr. Wheeler. It was not for him, however, but another Mr. Wheeler, and he, after opening it, returned it to the post office. At this stage of the enquiry Mr. Nesbitt produced photographs of the identical envelope and letter. The former was postmarked "Cortland, N.Y., Oct. 17th," and posted "Toronto, Oct. 18th." It bore the address, "S. M. Wheeler, Trenton Electric Co., Toronto, Ontario, Canada, 28 Seaton Street." The address, "28 Seaton Street," is obliterated, and was put on the envelope by the P.O. people. The letter was read by Mr. Nesbitt, counsel for the City Council. It was written by W. S. Rogers to S. M. Wheeler, and opened out with a reference to general business matters. The concluding portion of the letter contained the following sentences:

PEACE PROPOSALS.

Openly Made by a High Chinese Official.

London, Nov. 6.—A dispatch to the Times from Pien-Tsin, which will be published to-morrow, says that the representatives of all the powers were assembled on Saturday last by the Tsung-Li-Yamen, to hear the Chinese Government's statement respecting the critical situation of affairs. Prince Kung, President of the Tsung-Li-Yamen, the dispatch adds, calmly avowed the impotence of China to withstand the Japanese attack, and appealed to the Powers to intervene, saying that China was willing to abandon her suzerainty over Corea and pay a war indemnity.

The Ministers applauded the frankness of this confession, and promised to support China's appeal to their respective Governments with a view to the restoration of peace, and in order to avert the dangers threatening all interested. The French Minister believed in taking a leading part in the proposed intervention.

THE CAB BROKE DOWN.

A curious incident occurred on Craig Street, in front of the Herald Building, shortly before 3 o'clock this morning. A cab was being driven along when, with a crack, one of the springs gave way, and the occupants at once commenced to get out, and no less than nine women made their appearance from inside, while there were two men on the box with the driver, making a load of twelve people. GREAT STORM AT ST. JOHN.

WIRES ALL OVER THE CITY IN A HELPLESS MESS.

NO ELECTRIC LIGHTS OR STREET CAR SERVICE.

Big Poles Snapped Like Pipe Stems—A Heavy Fall of Snow the Cause—New England Storm-Swept.

St. John, N.B., Nov. 6.—St. John to-day is undergoing a look backward of about forty years. To-night it has no street cars, no fire alarm or no electric lights. All this is in consequence of a howling snowstorm, which set in about 2:30 this morning. The snow was of the heavy, sticky order, and the many thousands of electric light and telephone wires which are strung in our streets, proved unequal to the task of supporting the weight of snow that clung tenaciously to them. They snapped in all directions, and falling on the trolley wires of the street railway, made things lively for a while. Live wires were plenty, but the people profited by Saturday night's accident, and were very careful, so no accidents are reported.

The strong current from the trolley wires made sad havoc in the telephone exchange. A number of switches were burned out, and some of the lady operators had narrow escapes. On Union and Dock Streets—where the telephone company has a large number of very tall poles, which contain many wires, they met with severe losses. The giant poles could not sustain the terrible weight of the ice-bound wires, and one by one they broke off like pipe stems, leaving the wires in a tangled mass and making the streets almost impassable. Seeing this state of affairs, and the great danger that threatened life and property from electric light and trolley wires, Mayor Robertson ordered the Street Railway Company and Gas and Electric Companies to turn off all electric currents in their wires. The companies complied willingly with the order, so there is no further danger from live wires. The stoppage of the street cars was a great inconvenience, but was nothing compared to the loss of lights, for many persons relied on the incandescent lights all together. The Opera House, where T. D. Sullivan is giving a grand concert, to be lighted by oil lamps. Hardly any telegraphic news was received by any of the papers of the wires being down from the West. The loss to the telephone company by the storm is said to be as much as \$10,000.

Halifax, N.S., Nov. 6.—Last night about midnight a hurricane struck this coast and raged with great violence for the remainder of the night. Sch. Annie M. Priddle is reported a total wreck at Bear Cove, 10 miles from this city, and all her crew of four men drowned. She was bound to Halifax from Mabou with lime and is completely ground up on the rocks. She is insured for \$1,600 in the Nova Scotia Marine. Telegraphic communication was badly demoralized by the storm.

STORM IN NEW ENGLAND.

Portland, Maine, Nov. 6.—The severe storm which has been sweeping over New England, reached this city about 10 o'clock last night. No vessels dare venture out of the harbor.

Boston, Nov. 6.—A severe northeast gale threatened the city last night. Shipping is badly delayed in the harbor, and telegraphic service is paralyzed this morning.

Lynn, Mass., Nov. 6.—A severe storm accompanied by rain and snow reached here last night.

New York, Nov. 6.—Almost complete prostration of the telegraphic and telephone service exists in New England this morning, as the result of last night's furious storm which swept over that section of the country, it being particularly heavy along the coast. Large forces of linemen from the various companies are hard at work, and it is expected that communication will be restored this afternoon. The last word received from New Haven, was that the wind was blowing 72 miles an hour. No reports of disasters, by land or sea have been received.

APPLICATION TO LEGISLATURE

The City of Montreal shall apply to the Legislature of Quebec, at its next session, for an Act to amend its Charter as well as for the different Acts amending the same, as follows:

1. To change and simplify the mode of expropriation, and to ask, among other things, that the assessment roll serve as a basis of valuation in cases of expropriation; to ask the right to acquire in whole the immovable property subject to expropriation, and to determine the powers of the Commission in relation to the claims of tenants.

2. For the re-distribution and representation of the different Ward of the City.

3. To legalize the Municipal Lists; change the system of preparing said lists, and to amend the law concerning Municipal Elections.

4. To impose new taxes on certain branches of Commerce and Industry, places and objects of amusement, and also purely personal taxes.

5. To amend the law concerning the expropriation and widening of St. Lambert Street, and to regulate the cost of such improvement.

6. To authorize the Council to grant an indemnity to the Aldermen for their services.

7. To regulate and modify the tax imposed upon telegraph, telephone and electric posts and wires, and upon the wires and apparatus connected therewith, and also upon gas pipes.

8. To authorize the Council to grant \$1,000 to the heirs of firemen mortally wounded or killed in the discharge of their duties, and to authorize the Council to pass a by-law compelling the firemen to insure themselves.

9. To grant to the Council control over all electric wires, as well as the power to cause these wires to be placed underground.

10. To give the Council the power to change the name of the City Surveyor to that of the "City Engineer."

11. To obtain the means to meet certain obligations imposed upon the City by the Legislature, and to improve the financial position of the City.

12. To amend the law concerning the qualification of the Mayor and Aldermen.

13. To simplify the mode of annexation to the City of certain lots of land or portions of territory adjacent thereto, and to obtain the power to annex all the property belonging to the City outside the limits of the said City.

14. To amend the law concerning chimney sweeping.

15. To amend the sections of the Charter concerning the preparation of the Assessment Roll, and the delays within which complaints are to be made, and to authorize the City to appoint a Chairman of the Assessors to be appointed by the Council.

16. To amend the law concerning the change or closure of the line of streets on the homologated plan.

17. To legalize certain expenditure beyond the appropriation voted, and to relieve from any responsibility the Aldermen who voted for such expenditure, the latter having been informed by the City Engineer that such expenditure was necessary and in the interest of the City.

18. To be authorized to place on the list of Annual Expropriations the land or part of land which appear on the lines of the homologated plan.

19. To extend the powers of the Milk Inspectors beyond the limits of the City.

GRAIN MEN MAD.

THE WINNIPEG GRAIN EXCHANGE LETTER THE CAUSE.

EASTERNERS ACCUSED OF ADULTERATING MANITOBA WHEAT.

Local Shippers Say the Statement is Ridiculous and Make Counter Charges.

"Mind your own business." That is the way the reply of the Winnipeg Grain Exchange to the resolutions passed in Montreal and Toronto was construed on change yesterday.

The reply was, of course, upheld by a few dealers, but they were mighty few.

The accusation that the good efforts of the Manitoba trade to introduce Manitoba wheat on the English market have been paralyzed by disreputable adulteration of Manitoba wheat in Ontario and Montreal by the mixture of it with low grade flour of southern grown wheat called forth denials.

"Let me say," said a leading shipper, "that up to three years ago when Montreal dealers handled all the Manitoba wheat and shipped it to England, it brought a premium, or at least sold equal to the Duluth product, but since Western people have practically taken hold of the crop it does not bring with it 3d to 1 shilling of No. 1 hard Duluth, and of that I have positive proof, and so has any other dealer who ships wheat. See the New York Journal of Commerce of to-day. No. 1 hard Manitoba wheat is selling in that market 2 to 2 1/2c under Duluth grade in Duluth. Their assertions that prices are identical in England are downright rot."

Mr. A. G. Thompson, one of the largest shippers on the Board, said: "No man need think that Ontario wheat has been mixed with Manitoba wheat, as there is as much difference between the two as between white and red, and the mixed wheat would be instantly detected. The letter practically admits the fact that scoured wheat is being mixed with a superior grade, and this is contrary to the Inspection Act, which states all scoured wheat shall not grade over No. 3. The manipulation is strictly prohibited by law."

Mr. MacFarlane, according to a letter I have received from a large and reliable firm in Liverpool, the difference in the price of the two wheats does not exceed 1 1/2d to 3d in favor of the Duluth grade, and it has not yet been proved whether or not the difference is due to the irregularity of the grading. I consider the contentions made in Manitoba quite correct, and as long as no complaint criticising the work of the Inspector has been made there should be no interference."

J. B. Campbell said: "The rule of inspection board to work on a trial basis, and the fact that it should be applied throughout Canada. If Western men had the rules applied to Fort William, buyers on the other side would demand Western inspection, and not care a rap what Montreal men said. The inspection certificate accompanying Chicago wheat is only endorsed at this port in order to preserve the identity of the grain."

LILY HALE IS GUILTY.

Judge Wurtels sentenced her to nine months in jail.

The trial of Lily Hale, charged with procuration, and which had occupied the whole of Monday, concluded yesterday.

Judge Wurtels charged the jury against the accused. The jury after a short deliberation, found her guilty, but recommended her to mercy.

Judge Wurtels at once pronounced sentence in the course of which he said: "Lily Hale, you have been found guilty of procuring a young girl to be a prostitute, and you have been found guilty of this most heinous offence. You have pleaded that she was an immoral girl and that it was no harm in making her like what you have owned yourself to be. That is nothing in your eyes, but it is in the eyes of the law. If you were leading, should have been the first to stop this young child in her downward career. I knew you were guilty, but as you see they also are of my opinion. I recommend you to the mercy of the Court. I am disposed to consent to that request and although you deserve the same sentence as Clara Smith, namely, 18 months, the woman to whom you sent the child, Blanche Lemieux; I now sentence you to 9 months' imprisonment with hard labor."

The prisoner wept bitterly when taken in charge of the police to be taken to the jail.

Judge Wurtels then left the bench and was succeeded by Judge Hall, when a new jury was empanelled to try Caroline Embley, alias Church, etc., for obtaining goods by false pretences from J. Ogilvie & Sons, dry goods merchants, St. Antoine Street.

OUR AESTHETIC RAILWAY CO.

With a laudable desire to elevate the aesthetic taste of the Montreal public the Street Railway Company have painted the poles supporting their wires on Bleury Street a beautiful pearl gray.

A Wild rumor Promptly Denied by Mr. Fry.

Messrs. Marler and Fry, the well-known notaries and commissioners, are without a bookkeeper. He has left for parts that are as yet unknown.

Stephen Roberts had been with the firm for three years and was looked upon as a good young man. He was not known to drink or gamble, in fact his habits were thought to be just proper.

On Friday morning he disappeared leaving behind him a letter stating that he was gone. Judging by what Mr. Fry said yesterday "poor fellow," etc., he must have also asked forgiveness for his misdeeds.

He has not been seen since and an examination of the books of the firm shows that he is short about \$1,000.

It is thought that this was taken in small sums and that Roberts has gone away with very little money in his pockets.

There was a wild rumor about town that Roberts had removed the stamps from certain deeds, which would mean great trouble to more than one corporation. Mr. Fry, on being seen by a Herald representative said there was absolutely no truth in this.

Roberts was a prominent son of England man. He was married and lived on Hanover Street.

ARCHBISHOP OF ST. BONIFACE.

An Intrigue to Prevent the Appointment of Cure Cherrier.

THE FUNERAL TRAIN.

Special Services Will be Held en route From Livadia to St. Petersburg.

Livadia, Nov. 6.—It is officially stated that the body of the late Czar, after lying in state in the church of the rance, here, will be taken to Yalta, and from there conveyed to Sebastopol on the board the Russian cruiser Panayot Mskoviova. On the funeral train to Moscow the escort will include Czar Nicholas, the Czarina, the Czarewitch, Grand Duke George, Princess Alx of Hesse-Darmstadt and other members of the Imperial family and the Prince and Princess of Wales and the members of foreign royal families related to the Imperial family of Russia.

At Moscow the body of Alexander III. will lie in state for several days at the Archangel Cathedral and at St. Petersburg the remains of Alexander III. will repose in state in the Cathedral of St. Peter and St. Paul.

At the towns where the funeral train stops on its way to Moscow and to St. Petersburg, dinners for the poor will be provided at the expense of the Czar and at each stopping place a requiem mass will be celebrated.

POLES OBJECT TO THE BULLDOY.

Vienna, Nov. 6.—There was a noisy scene in the Reichsrath yesterday. The President of the House delivered a eulogy of the late Czar, and during his address the Polish members hotly protested against his praise of the dead Emperor. Finally, the greater number of the Polish members withdrew from the Chamber. The incident was an unpleasant one for the Governor, and Emperor Francis Joseph is likely to take it as a personal offence.

Odesa, November 6.—A firm belief prevails here that Czar Nicholas will partially or totally abolish the press censorship.

MEMORIAL SERVICE IN LONDON.

London, Nov. 6.—The Duke of York, the Duke of Connaught and other members of the Royal Family, members of the Cabinet Ministers and the Diplomatic Corps, all wearing full uniform, attended a memorial service to-day in honor of the late Czar of Russia. Among those present were Mr. James R. Roosevelt, Secretary of the United States Embassy; Col. W. Ladlow, the United States military attaché, and Lieutenant Commander W. S. Cowles, the United States naval attaché.

THE ANONYMOUS WARNING.

The P. P. A. Said to Meditate Stealing Mercier's Remains.

The following is a copy of the communication which was received yesterday by the Mayor about the alleged intention of some members of the P.P.A. to steal the body of the late Hon. Mr. Mercier.

Montreal, Friday Night.

The P.P.A. had a meeting to-night, and a plot was made to blow up or to rob your late friend's vault—Mercier. A committee was appointed to pick true men for the job. After they get the contents it will be shipped to a small village in Vermont, where the organization is strong. They will try their best to do it. I am sure, on Sunday at midnight, as a desperate character of theirs is coming from Buffalo to superintend. Now is the time to show what you are worth. Save the friend you boast to love. You are warned.

When questioned as to whether he had received the above letter His Worship appeared very tremulous, and nervously turned over the communication. "I once gave the press an anonymous letter I received, and the next day I received ten of them." He would not say, however, whether he had or had not received such a communication.

"The War Cry's" Editor Coming.

Colonel Nicol, of London, England, editor of the British War Cry, the official organ of the Salvation Army, will deliver an address at the local barracks on Thursday night. The Colonel who is making a business tour of Canada at present in Kingston, Ont., and will be assisted at the meeting by Brigadier Scott of that place.

The first of a series of special meetings at the Salvation Army barracks drew a very large crowd last night. The meetings will continue throughout the week. On Thursday night the city officers and soldiers will unite to give Colonel Nicol a welcome. These meetings are open to the public.

A Cote St. Antoine Expropriation Case.

By section 61 of Chapter 64 of the Statutes of Quebec, which refer to Cote St. Antoine, this town was authorized to open streets according to the plan of the city. Section 62 empowered the Council to levy taxes for that purpose. Section 65 imposes a share of the burden on both sides of a street, and by section 66 the Council was authorized to declare that the cost of the ameliorations may be borne only in part by proprietors. In the case of complaint in regard to the apportionment of the cost, council may have the matter settled by arbitration.

George B. Bradley, a proprietor on Sherbrooke Street, presented a petition to a Judge in Chambers, alleging that on 26th day of January Cote St. Antoine began to expropriate his property; the town was to pay the costs of the said expropriation. Mr. Bradley presented another petition, alleging that Cote St. Antoine took proceedings to establish the percentage of the cost of the widening of the street to be borne by the other proprietors. Petitioner wanted to have his legal costs taxed, but the town opposed this because a Judge in Chambers had no jurisdiction to do so. Judge Mathieu decided that he could not include the legal costs in the cost of the expropriation.

Assessment Rolls Deposited.

The amended assessment roll for the extension of St. Catherine Street between Harbor and Desery Streets was deposited yesterday in the City Clerk's office, having been signed by the Expropriation Commissioners, S. H. Ewing, A. Trudeau and J. Beaudry. The total cost is \$101,320. It is divided into one-half and the proprietors the other half. The incidental expenses are \$3,500, made up as follows: Commissioners' fees, \$1,044; advertising and printing, \$500; signorial dues, \$536; office work, \$637; contingencies, \$45; witnesses' fees, \$729; assessment plan, \$55.

HERALD MARINE RECORD.

PORT OF MONTREAL.

Dominion line SS. Oregon, Capt. Gibson, was docked last evening shortly after 4 o'clock. She left Liverpool Oct. 26th, at 8 p.m., and had fine weather all the way across. A cargo of 2,100 tons general merchandise was carried, and there were in all 104 passengers. A strong gale was met in the Gulf Sunday. This is the last trip here for this season but the many friends of Capt. Gibson will be pleased to learn that the ship will run to Portland and Halifax during the winter.

The Harbor Commissioners. At the weekly meeting of the Commissioners yesterday, Henry Palmer presided. Much routine and other business was transacted.

The Chief Engineer reported his recommendations regarding the wintering of the dredging plant. He suggested that the land derricks, locomotives and cars in use on the pier at their present level and near the trestle work or down stream end of the bank, explaining the safety there. The remainder of the dredging feet should be wintered in the canal as usual. In this the Board concurred.

The Chief Engineer also reminded the Board that it was his duty to arrange for being made for the supply of macadamizing stone for 1895. The Board decided to take all the stone the mill could furnish and then rent a quarry as usual. The Engineer also reported officially the arrival of dredger No. 2, and that same was ready to be put to work by the end of the week. The secretary announced that a monthly pilot chart of the North Atlantic had been forwarded the Commissioners by the Hydrographic office at Washington and that it is open for inspection at their office.

Forecast for November. Shows frequent gales between Newfoundland and the British Isles, and as far south as the 40th parallel. Between latitudes 20° N. and 40° N., and east of longitude 70° W. occasional gales, some of which may be quite severe. Fog on the Grand Banks, but at intervals only. Some fogbers in the vicinity of Belle Isle; probably none south of the 50th parallel.

As there are many ships sailing from here with lumber for Buenos Ayres, this forecast will be valuable. The Hydrographic office directed attention of sailing men to the uncertainty of the weather for the remainder of the month. It explained further that attention is subject to aberrations and under circumstances where little expected. The chart shows that the excessive number of abandoned vessels on the North Atlantic is due to the heavy storms of the past few weeks.

Notes. The depth of water in the channel yesterday was 28 feet 6 inches, at Sorel 29 feet 4, at Lotbiniere 24 feet 8, at Sorel 29 feet 8 inches. The Allan SS. Assyrian for Glasgow, this morning took the following amongst a general cargo, 10,000 barrels apples, 240 cattle, 71 horses and 3,000 boxes cheese.
