CLERMONT.

Quebec, January 20.—The special committee appointed yesterday to consider the Montreal City Bill met this morning at 10.30, Mr. Duplessis in the chair.

Mr. Martineau urged strongly the immediate passing of the bill, as Montreal was ready for the general elections, the candidates having been already chosen, and money spent. In fact, the Montreal people were ready for and expected the general elections on March first.

After considerable sharp speaking right and left, Mr. Cook proposed, seconded by Mr. Villeneuve, that the clauses of the bill be considered in order.

Mr. Kennedy said that he would throw no obstacles in the way of the general elections on March 1, and that his record was clear.

Here a passage of arms took place between Mr. Kennedy and Mr. Stephens.

Then Mr. Ange rose and in solemn tones said: "I withdraw my bill."

Objections being raised, the chairman ruled that he could not do so.

Mr. Ange voted authority to prove that he had a right to raise his bill, which he had not yet taken into consideration.

Finally it was decided to postpone the consideration of the bill till Tuesday morning next.

Aide-Clémentine and Harteau and Mr. Blais, accompanied by Messrs. E. Lavigne, Laporte and Emard, represented the city of Montreal.

Messrs. Ange and Kennedy were the only Montreal members who voted for the postponement of the bill till Tuesday.

He said he also considered it an honor to number Mr. Clemenceau among his friends, although the connection was proving fatal to his interests.
