

JEROME SEES HIS PREY SLIPPING FROM HIS GRASP

Thaw Goes to Littleton For Hearing on New Habeas Corpus Writ To-Morrow. If Sustained Will be Free in All United States. Scores of Petitions Going to Governor on Thaw's Behalf. W. T. Jerome Restless and Fears Outcome. Outlook To-Day Bright For Matteawan Refugee.

Colebrooke, N.H., Sept. 15.—Thaw will appear before Judge Aldrich to-morrow at Littleton, N.H., in the morning for hearing on new habeas corpus writ as reported below.

His lawyers will ask for adjournment of hearing, owing to the fact they must appear before Governor Felker on Wednesday.

JEROME FEARS OUTCOME.

William Travers Jerome appears restless and apparently fears the outcome of this writ. If liberated by Judge Aldrich, who is a Federal Judge, Thaw will be free in any state in the union. This is Jerome's greatest fear.

THOUSANDS SIGNING PETITIONS

Public feeling in favor of Thaw is growing. Voluntary expression is given favor by scores of petitions on his behalf now being circulated in New Hampshire towns, including Pittsburg, Stewartstown, Colebrooke, Errol, Stratford, Columbia, Northumberland, Lancashire, Littleton, Lisbon, Whitefield, Woodsville, Berlin, etc. All ask Governor Felker to refuse permission to extradite Thaw and to declare him a free man in New Hampshire. These will be sent to Governor Felker to-morrow or Tuesday.

SHERIFF HORNBEC ON HAND.

Sheriff Hornbeck is here. He says he will take Thaw back if he can do so according to law. Otherwise Jerome, Lanyon or no one will carry him back. The sheriff's sense of fair play is appreciated here as at Sherbrooke.

THAW'S REGRET.

Thaw, in a statement last night, referring to Canada's action, said: "My only sorrow is that I should be the avil upon which the vaunted British fair play should have been broken."

FEELING IN STATE WILL HELP THAW.

The feeling here is that Governor Felker will be greatly influenced by public opinion. Jerome fears this and will use every effort to get his man.

LOCAL CONSTABLES WATCHING JEROME.

Special constables are as watchful of Jerome and Lanyon as of so-called Canadian kidnappers. "We will shoot one as quick as the other," they say.

THAW'S QUIET SUNDAY.

Thaw spent a quiet Sunday. He did not even go out for a walk. He expressed a desire to attend the Methodist Church, but the sheriff said that he (the sheriff) had not been going to church much of late and feared if he went to-day it might establish a precedent under which his wife would compel him to attend regularly hereafter. He said later that his real reason for not taking Thaw out was that Colebrooke had seen upset enough over the fugitive.

As it was, the corridors of the Monadnock House, where Thaw is held, were crowded with country folks throughout the day. They had driven or motored in from their homes in the hope of getting a good look at Thaw. But only those who were willing to pay for a meal had their curiosity satisfied.

GROSSMAN AND JEROME.

The statement of Moses Grossman, of the Thaw counsel, that the Federal writ was obtained not because Thaw's liberty was sought now, but as an emergency measure to checkmate New York State, should Governor Felker honor the request for a writ for Thaw without a full hearing, developed into an open controversy between factions yesterday. Jerome last night characterized the move as a breach of faith and yesterday he procured a number of affidavits from newspaper reporters setting forth what Grossman had said. It was understood that he obtained this for use in a move to sustain his contention that Grossman and his associates had "trifled" with the federal courts and were perhaps liable for contempt.

"This is absurd," said Grossman. "I shall go before Judge Aldrich myself on Tuesday. He understands thoroughly our motives and we are prepared to meet any allegation that we did not act in good faith either with Mr. Jerome or the court. Any suggestion from Mr. Jerome that I agreed not to get this writ must have been made under a misunderstanding. It is ridiculous to assume that I, as a lawyer, could make any agreement that would jeopardize the position of my client. Mr. Jerome, as a lawyer, should know this."

Unless Jerome has some power con-

cealed somewhere, Thaw will be taken to Littleton on a train leaving here early Tuesday morning. The habeas corpus argument is set for 11 o'clock that morning. The Thaw lawyers will ask for a continuance, thus leaving the writ hanging over the heads of their opponents, and then proceedings will be transferred to Concord, the capitol, for the hearing before the Governor.

E. P. Nute, U. S. marshal for this district, will serve notice of the writ on Sheriff Drew and from the moment that service Thaw will be in the joint custody of the U. S. Government and the authorities of Coos County, New Hampshire.

The marshal has been directed to use "such force as necessary to protect Thaw from violence and indignity if such be attempted."

This will be a new experience for the slayer of Stanford White, and he is pleased at the prospect. Having Federal interference in his case gratifies that peculiar love for show and publicity he has so often shown. Besides, there is great comfort in the thought that any infringement of the writ by anyone whatsoever would mean serious consequences inasmuch as the writ carries with it an injunction which says in effect: "Hands off!"

WRIT WILL BE SERVED THIS AFTERNOON.

Harry K. Thaw anxiously awaited to-day the arrival of U. S. Marshal E. P. Nute, bearing notice to Sheriff Drew, of Coos County, that the fugitive must be produced on a writ of habeas corpus before Judge Aldrich in the United States district court at Littleton to-morrow morning. Thaw will then be under the protection of the United States pending disposition of the writ. This guarantee of safety, in the face of so many kidnapping rumors, was a relief to him.

Nute did not arrive on the morning train, and Thaw's custodian, Sheriff Holman Drew, said he did not expect him until late this afternoon.

THAW'S NEW CHANCE OF FREEDOM.

Colebrooke, N. H., Sept. 15.—(Special)—Harry K. Thaw now has a chance for absolute freedom.

A writ of habeas corpus was issued Saturday afternoon by the United States District Court, returnable at Littleton, N. H., to-morrow. If this writ is sustained, Thaw will be a free man in the State of New Hampshire. The writ, also, restrains Jerome from touching him. If the writ is not sustained Thaw may still continue his fight before the Governor.

The Canadian writ of habeas corpus comes up in Montreal today and it is understood will be proceeded with even though Thaw has been removed from the jurisdiction. Should it be sustained Thaw would be a free man in Canada. If successful in both courts he could pass too and fro between New Hampshire and Canada at will.

THE NEW HAMPSHIRE WRIT.

In the United States District Court Saturday afternoon, Judge Aldrich, on the petition of counsel for Harry K. Thaw, represented by Hon. Nathaniel E. Martin and Merrill Shurtless, granted a writ of habeas corpus, returnable at Littleton, N. H., on Tuesday, at 11 a. m.

With the writ was issued an injunction restraining all persons from interfering with the service of the process and from interfering with the person of Thaw while he remains in custody.

The rescript handed down by Judge Aldrich follows:—

"The petition of Harry K. Thaw for a writ of habeas corpus, under United States authority, invokes the fourteenth amendment to the Constitution of the United States, which among other things, declares:

"That no state shall deprive any person of life, liberty or property without due process of law, as well as other Federal laws with reference to the restraint of personal liberty.

"It is not necessary for present purposes to consider the allegations of the petition, other than that based upon the fourteenth amendment, because under Federal statutes, the writ upon such an allegation as that contained in the petition issues quite as a matter of course if not as a matter of right.

"It is ordered that the writ issue and be made returnable before me at Littleton, New Hampshire, September 16, 1913, at 11 a. m., at which time unless this order be extended, the respondent will make proper answer."

THREE MEN KILLED BY ELECTRIC SHOCK

Cable They Were Grasping Came In Contact With High Voltage Wire

THE THREE WORKMEN WERE FLUNG WRITHING TO GROUND WITH CABLE IN HANDS.

Montreal, Sept. 15.—Pulling on a wire cable, while moving an engine at the works of the Harris Construction Company, Ltd., in St. Laurent, three men were electrocuted yesterday afternoon when the cable which they were grasping came in contact with a high voltage wire suspended upon a pole nearby.

The dead are: Richard McEvoy, 45 years of age, foreman, married.

Frank Brabant, 27 years of age, an Indian of Cartierville, married.

A young Pole is as yet unidentified as the timekeeper could not be found last night.

The Harris Construction Company have the contract for laying the trunk sewer between St. Laurent and Cartierville and have excavated and laid the sewer to about midway between the two towns. A gang of about a dozen men under foreman McEvoy were detailed yesterday to move the excavating engine to a point farther along the line of operation. All went well until 3.35 yesterday afternoon, when in steady- ing the engine by means of pulling upon a length of wire cable attached to the upright of the derrick, there being three such cables attached to the mast, the cable being handled by Foreman McEvoy and the two other victims, was pulled under a string of wires conveying electricity from the plant of the Public Service Corporation at Cartierville. Headless of their danger, the three men strained at the cable, which as they drew it back steadily, came nearer to the high voltage wires above it. None of the workmen, intent upon getting the engine placed correctly, noticed the danger. The derrick swayed, bringing the cable into contact with the wire and down went the three workmen flung writhing to the ground by the fatal charge with the cable still in their hands.

"Thaw is perfectly satisfied with the way things are going, and you couldn't get him to attempt an escape. Two offers have been made him, and in either case all he would have had to do would be to jump into an auto and be whisked away. Both of these he has refused.

"It is very likely the question of the lawful governorship of New York may come into this, for even if Governor Felker does not raise it, that can be made a part of the defense under court proceedings.

"There is one possibility of even more serious complication and that is the great likelihood of action from Canada with, perhaps, a demand on Washington that this man be returned to the Dominion. There will be no action there until Monday but when the immigration board of inquiry fails to produce the body of Harry Thaw on order of the Court of King's Bench, there are liable to be more serious proceedings than contempt of court.

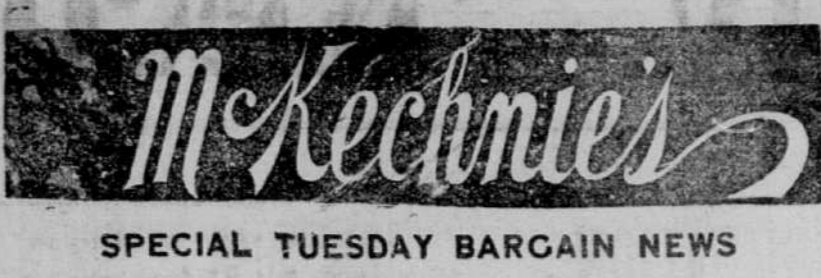

WANTED—A TIPLESS HOTEL

Where Guest Pays One Price and Gets What He Wants

WHERE THE ROASTER ROASTS NO LONGER AND THE FEE IS MET WITH SCORN—WHERE THE DINER EATS IN COMFORT.

(From the New York Commercial) Somewhere up in the mountains an experiment in hotel keeping is being tried, and it is said that results have proved very satisfactory to both the proprietor and the guests up to the present time. This hotel is a sort of Elysium in which no tips are allowed, and the guests do not have to think of anything except the fixed price they pay by the day or week. For a certain consideration the guest can eat, drink, smoke, walk, drive, or do anything else that he pleases. It costs him just the same whether he smokes a pipe or an imported cigar, whether he drinks champagne or cold tea. Of course the price is high enough to cover the loss that may come from an individual with an over-developed thirst for expensive wines.

In addition to giving a man all the comforts of the home without his having to think about too many details, it is said that this method of running a hotel tends to promote sobriety. Everything in the shape of liquor is included in the price of accommodations by the day, therefore the guest can buy nothing whatever in the house. He pays for it all in the lump sum charged by pre-arrangement. This puts a stop to treating. Each guest drinks or smokes whatever he pleases, and is under no obligation to others and places others under no obligation to himself in the ordinary silly American way of treating all around.

It is unlikely that many hotels of this class will be established in this country, and it is a certainty that the present hotelkeepers of New York will not entertain such a proposal. But it would be a comfort to have a few hotels in this city in which the guests could be let alone. The constant attentions of the porters, bell boys, wash room attendants, when not asked for, become an intolerable nuisance as well as a considerable expense to the class of men who think they lose caste by not tipping without any reason for doing so. Many of the large hotels and restaurants are now being run on the basis of extracting every possible cent from anyone who enters their portals. The coat room, with its strong-arm gang of highbinders from southeastern Europe, is a comparatively modern affair with us. The older hotels always provided check-rooms, but they permitted their guests to say whether they wished to avail themselves of the convenience. To-day the guest who enters a dining room is told he must leave his hat in check room, and if he eludes the entry at the door, the head waiter or captain swoops down on him and tells him he is breaking the rules of the house, and whether he wishes or not the hat is taken from him and deposited with the rest.

Quite recently a man entered one of the largest lobster palaces in this city, which has at least three separate entrances. He succeeded in getting into the dining room without being detected, and he seated himself at an empty table, after putting his hat on a chair which no one else would occupy while he remained there. The hat was not in

view distinctly, and he was lucky enough to have ten minutes of peace before the head waiter spied it. This terrible offence against the rules of the house was quickly pointed out and the hat carried away. When the guest finished his repast and was ready to pay his bill he asked the waiter to find the hat, for which a check had been left on his table. The waiter went out with the check and came back an old man, that he could not get the hat, that it was against the rules of the house for him to bring it back into the dining room; the guest asked the waiter at which of the three entrances his hat had been checked, and the waiter could not give him the desired information. Now this particular lobster palace occupies the interior of a whole block front in this city, which means that its side entrances are two hundred feet apart and the enterprising management left this guest to wander around and find his hat as best he could. If this is accommodation for guests, the average man would prefer to shift for himself.

Suppose that someone tried the experiment of running a hotel in this city which would leave guests in peace when they wished to enjoy their own belongings at the same time. Several cases have occurred where valuable overcoats have been stolen from the check room and it is all nonsense for the hotels to say that checking them affords any extra protection. The class of men and boys who usually have charge of the coat room does not lead the public to place much confidence in the system. In some hotels men are permitted to please themselves within narrow bounds in the bar room or in grill rooms adjacent to the bar, to which ladies are not usually permitted. Dangerous symptoms of revolt have caused some of the best hotels to modify their check room tax to some extent, but when a man appears in one of these places with a lady or ladies he is helpless and the way tips are extorted from him is nothing short of a con game. The waiter in a dining room has been tipped for so many years that it has attained the dignity of a custom that runneth not to the contrary in the recollection of man; but the one tip given to or extorted by the waiter should cover everything and the waiter should certainly be able to recover the hats and wraps of guests from the check room where little chance of putting an end to tipping, but the hotel that will see to it that the system is not abused instead of trying to make a revenue out of its abuse should receive enthusiastic support. Why should ladies be forced to stand in a lobby while their escort waits for his hat?

Many other things irritate guests in our hotels. Newspapers are double in price when bought at our hotel news stand, as a rule, and this is such a small matter that it is hardly worth while creating ill will over it. There is also no reason why a hotel should allow a bell boy to stay in the room of a guest who has just arrived and been shown to the boy hangs around until the guest either kicks him out or gives him a tip to go out, and as the boy acts usually like a potential thief, the very fact that he has made such a close examination of the guest's belongings arouses suspicion and creates some degree of nervousness.

Upon the summit are the ruins of a fortification. Recently the Turkish soldiers, who are stationed on the summit of the rock, discovered among the ruins the greater part of a large black stone statue. Too heavy for them to carry away, or ignorant of its value, they left it there among the rubbish, where I found it. It is headless; the body is broken into two parts; its feet, or the pedestal into which they were embedded, had disappeared; the arms, bent at the elbows, are built into the body; in the hands are two implements, probably the symbols of office; the dress is a long tunic, open in front, with fringe along its edge. Though the head is missing, the hair was long; traces of it still appear on the shoulders.

The date of the statue is certainly the same as the ruins in which it was found, and about 751 B.C. It comes from the time and people of Semiramis, and though probably not of that queen, it is the only known Vannic statue, and as such, is of unusual historic interest. Research in this almost unknown land of Semiramis promises to restore the lost history, art and literature of the empire of this once supposed mythical queen.

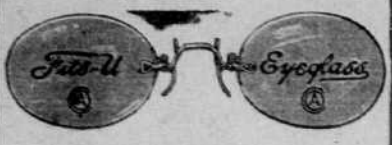

THE CHILDREN'S THEATRE IN PARIS

LA FONTAINE'S FABLES AND "VEGETABLE TRAGEDIES" ACTED THERE. Over in the Jardin des Plantes in Paris, away from the play-going centre, M. Philippe Garnier has built a marionette theatre for children, where the fables of Fontaine will take into themselves living and breathing personalities, where the fox will persuade the crow to continual song, the lion lie down with the mouse, and the wolf and the too lean canine repeat their jeu de mots to a credulous and numerous audience of juvenile theatre-goers. The La Fontaine Fables are the Mother Goose Tales of the French, that of the fox and the crow is as familiar to tiny Jacques Bonhomme as Old Mother Hubbard ever was to an American child. The fables are taught in the first grade schools and in the classes of French literature. They have been set to music, and have supplied the action for many a nursery picture book, but this is the first time that they have contributed

nearly the entire repertory of a theatre. The new theatre has the air of a seashore cottage with one side left open to the breeze. From the peak of the roof a huge golden eagle, its wings protectingly outspread, peers down upon the stage. A carved wooden monkey perches at one end—composite mass of comedy and tragedy—while a seal balances himself at the opposite corner. Below this unusual decoration, a painted frieze of children frolics its way round the sides of the building, entwined with gold lettered rhymes of the poet Fontaine. This is the stage itself, the stalls are out under the trees in the fresh air. Lilac bushes shelter the stage entrance from a too curious public and drop over the active dressing-rooms, while nearby fountains babble an orchestral accompaniment.

The Guignol of the Jardin des Plantes is, before all else, in the eyes of its creator, M. Garnier, a theatre for poor children. The garden that shelters it is in one of the oldest and poorest sections of Paris, and the price of admission has been arranged accordingly, at four cents. The Luxembourg Garden, the Tuilleries, Parc Monceau, and other of the Paris gardens have theatres for children, but up to the present time Punch and Judy, properly Latinized, have been the only stage characters, and the children of well-to-do parents, accompanied by smart nurseries, in long streamers, have been the only spectators.

M. Grenier, who is a playwright as well as an impresario, wrote the comedy with which the theatre opened. It was called "The Bird's Residential Election." And the lark, symbol of the arts and made up to resemble President Poincare, was elected to the presidential chair. His rival, a bluejay, disguised in the plumage of a peacock, was unmasked and defeated before the delighted eyes of the audience. Later, a fable after Fontaine was mimed by a heron, a rabbit and a duck, at least anyone would have testified that a live and exceedingly lively heron pursued a real duck and a real rabbit about the stage. But they were only marionettes manipulated by the clever fingers of M. Grenier, who was hidden behind the scenes. The illusion was, however, perfect, and no one questioned its veracity for a moment.

Adaptations of "L'Oiseau Bleu," "Chanticleer" and "The Two Pigeons" might be brought within the scope of the marionette. Even the vegetable kingdom is to have its share in the children's theatre. The artichoke, giving itself leaf by leaf in unappreciated self-sacrifice, and a drama between the rivals, lettuce, romaine and spinach are two of the tragedies under consideration and will furnish infinite scope for the spirit of the modern French dramatist.

But plays are the least of Mr. Garnier's cares. Not only has he the wealth of his own imagination as well as La Fontaine's to draw from, but several well-known playwrights in Paris have signified the desire to write a play for the Children's Guignol which promises to be as brilliant in its natural history way as the Grand Guignol for grownups is as the "Chamber of Horrors."

Will be Used by Artillery Units From Kingston to Halifax

PROPERTY SO FAR HAS COST MILITIA DEPARTMENT QUARTER OF A MILLION.

Quebec, Sept. 15.—(Special)—William McBain, acting for Canadian Militia Department today deposited with the registry office in the Court House plans for a projected artillery camp in the parish of Valcartier, on the line of the Quebec and Lake St. John Railway, 18 miles north of Quebec City in the County of Quebec. The camp will be ten miles in length, and four miles in width and will be used by artillery units from Kingston, Ont. to Halifax, N. S. The property so far has cost the militia department \$250,000.

RAILWAY BRIDGE ATTACKED BY FIRE

Structure on Quebec Central Railway Was Partially Damaged

WORKMEN HURRIED TO SCENE AND SOON HAD FIRE UNDER CONTROL.

The bridge on the Quebec Central Railway, which crosses the road between Sherbrooke and Lennoxville, about two miles out of the city was partially damaged by fire between Saturday night and Sunday morning.

NO HOME RULE BY CONSENT

Recent Appeal by Lord Loreburn Finds Little Favour

LIBERALS AND UNIONISTS ARE VERY FAR APART. PLEA CAME TOO LATE.

London, Sept. 15.—The recent appeal of Earl Loreburn, formerly lord high chancellor, that both the great political parties confer, with a view to a settlement of the Irish question by consent, on the ground that the present home rule bill cannot provide a permanent solution, has excited tremendous interest throughout the country and will have considerable influence in future discussion of the Liberal bill in Parliament. As a practical suggestion, however, it is believed that it will prove unavailing. The attitude of the liberals is that the proposal, coming now when the home rule bill is nearing a successful issue in its stormy career, is altogether too late. On the other hand the Unionists would only be inclined to enter such a conference as Earl Loreburn suggests if the Government first of all consented to drop their bill, which is an altogether impossible condition from the Liberal point of view. John Dillon, on behalf of the Nationalists, says a conference would be utterly useless unless the Unionists first admitted the principle of home rule. Thus all the parties are opposed to a conference, and it is believed there is no chance for it to materialize.

BREAD COMPETITION AT FAIR

taining New York's much-desired end will be made effective.

THAW'S STATEMENT.

"I am perfectly satisfied with the outlook. Everything seems to be framing in favor of my contention, and I believe that Jerome already sees his strength on the wane. Escape? Why, that would be the most foolish thing that could be tried now. We are winning. I have had two offers made to me either of which would have landed outside the reach of the authorities, but I felt no fear in declining them, even without conferring with my counsel. Things are going finely."

A NEW YORK VIEW

THAW'S PERSECUTION A LEGAL FARCE.

(From New York American)
Harry Thaw is being hounded as relentlessly in Vermont and New Hampshire and he was in the Dominion of Canada. The story of Thaw's pursuit and prosecution, with sheriffs, constables, immigration officers and high priced lawyers joining in, makes about as disgraceful chapter of the attempted administration of justice as could be supplied from the annals of the Middle Ages.

First, Thaw is seized illegally in Canada and held illegally till W. T. Jerome has an opportunity to get on the State payroll and hurry to Canada, there to continue the bedeviling of Thaw begun seven years ago.

Nest Jerome, holding a commission as a deputy attorney-general of the State of New York, gets himself arrested as a common gambler and locked up in a cell that first held Thaw—a shameful performance. Once out of jail he jumps into the automobile in which he had intended to rush Thaw through two States, and hastens out of Canada, despite the warning of the authorities that he would be jumping bail.

While Jerome was crossing and recrossing the border, the Canadian immigration authorities took Thaw by force out of his prison and dragged him over the line. This was done despite a solemn writ from the King's Bench ordering Thaw to be produced for a Habeas Corpus hearing in Montreal. Jerome's part in this high handed proceeding was to be at the line waiting for Thaw when he was ejected from Canada. His own troubles, however, had mixed his plans, and he was not present.

In spite of the flouting of the law by the Canadian immigration officials, inspired by Jerome, Thaw was out of Canada and once more free. There was no immediate necessity for his deportation. He was doing no harm in Coaticook, and in a position to do no harm. He objected strenuously to being freed in such a manner, yet here he was, an American citizen, in his own country, convicted of no crime, and beyond any recognized power of extradition.

You would imagine that he would have at least received fair treatment in his own country. But you would be wrong. In every part of Vermont and New Hampshire deputy sheriffs swarmed on Thaw's trail, and within a few hours he was arrested, without warrant of extradition papers, and again held until the always tardy Jerome should appear and take charge of him.

Why were the Canadian immigration officials in such a hurry to deliver Thaw into the hands of Jerome that they rose superior to the courts of their country?

Why were the New England sheriffs obsessed with such a mad desire to lock up a man who had never violated a statute of their State, and never, according to a jury, committed a crime in any other State?

Why have precedent and order and decency and law been calmly set aside in the shameful pursuit of a citizen to whom the Constitution of the United States supposedly guarantees the rights and privileges of all citizens?

Why does the chase of one man, already punished by seven years of jail and madhouse for ridding the world of a white slaver, cause authorities in two countries to abandon their regular duties as if an outlaw were devastating the countryside?

ONE KILLED EVERY 7 HOURS

A MEMBER OF THE BROTHERHOOD OF TRAINMEN IS KILLED EVERY SEVEN HOURS.

New York, Sept. 15.—"A member of the Brotherhood of Trainmen is killed every seven hours and fifteen minutes and every nine minutes a man is maimed." This was the testimony of William Lee, representing the Order of Railway Trainmen at the meeting of the Arbitration Commission in the controversy between forty-two Eastern railroads and their conductors and trainmen over the employees' demands for more pay and shorter hours. When this statement was later challenged by Elisha Lee, counsel for the railroads, Mr. William Lee cited the statistics in the Inter-State Commerce Commission's report. This report on June 30th last gave 3635 railroad employees killed in the United States during the year.

William Lee in further testimony said: "We want standard rates throughout, and that includes the black man. If he does the work of the Northern railroad man we would be willing to see him receive equal pay."

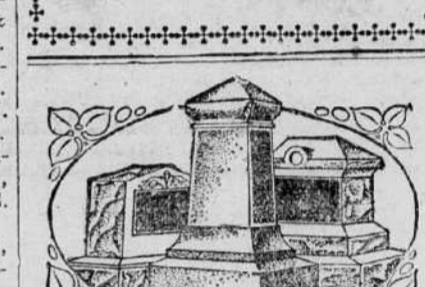

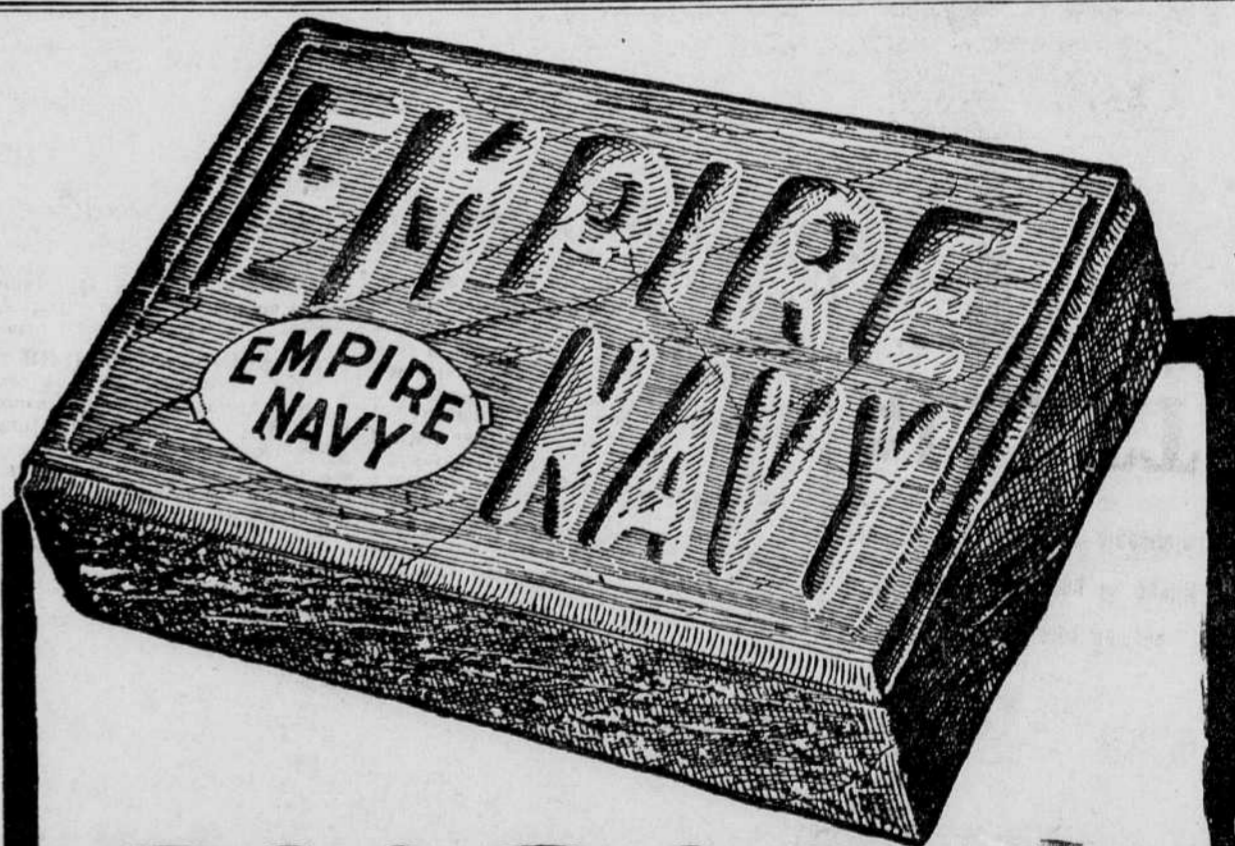
