RELATIONS BETWEEN GERMANY AND HOLLAND SEEM STRAINED; FRENCH MAKE IMPORTANT GAINS

German Wedge Is Forced Back—Austrians Claim To Have Repulsed Russians In Laboreza Valley—Attempt Is Made To Assassinate The Sultan Of Egypt

London, April 9, 4.31 a.m.—Italian steamers in American ports have been ordered to postpone all sailings until April 20, according to a Rome despatch to the Exchange Telegraph Company.

London, April 8—There were persistent rumors in London this evening that Germany had either declared war on Holland or that her troops had occupied that strip of Dutch territory that extends from the Belgian frontier on the coast to the river Scheldt. The reports lack confirmation and are not credited by those who should know if either action had been taken.

It is possible that the reports arose from the news received in the last few days from Dutch sources that the Germans were strengthening their positions around the Dutch frontier and that much uneasiness prevailed at The Hague and other Dutch cities as a result of the seizure or sinking of Dutch steamers by German submarines.

The Dutch are strongly opposed to intervention in the war, but their army is ready to repel any invasion of Dutch territory, complete preparations with that object having been made long ago.

Another diplomatic report which has created immense interest is that from Rome to the effect that Austria is seeking a separate peace with Russia. This, likewise, lacks confirmation, and is not credited, as it is not considered likely that Germany would be sending reinforcements to the Carpathians if there was any doubt of Austria's loyalty to her ally.

Italy takes the matter more seriously than the other nations, for should it prove to be true it would end her hopes of gaining territorial accessions from Austria. However, the stubborn way in which Austria is resisting the Russian advance in the Carpathians seems to contradict the suggestion that she is ready to seek peace at Russia's terms.

The fighting in the mountain passes continues as fiercely as even and although Austria claims that her troops, with the assistance of Germans, have gained success on both sides of the Laboreza valley during Easter, the Russians are, on the whole, much further advanced than they were a week ago and have now forced the Dukla, Lupkow and Rostock Passes, and are pouring troops into the region of Uzsok Pass, where the heaviest battle is now in progress.

So far as the rest of the eastern front is concerned the only battle of any importance is that in Bukovina, where the Austrians are thrusting at the Russian positions in the hope of compelling the Russians to send reinforcements from the Carpathians. In west Galicia and Poland, the overflowing rivers and bottomless marshes prevent movements on a large scale.

These same conditions are hindering the French operations between the Meuse and Moselle rivers, the French official report today stating that heavy rains have rendered the ground difficult for the movement of troops and the employment of artillery. There is a very important battle in progress in this region, however, and the French claim to be making advances—a claim which is contested by the Germans, who declare that all the attacks have been repulsed. Whichever report is correct, there is little doubt that a sanguinary battle is being fought and that in the attacks and counter attacks very heavy losses have been sustained.

The people of Europe are expectantly awaiting a renewal of the attack on the Dardanelles, this time with land and sea forces. But the only news from that part of the world today is that Turkey has decided to call up all men capable of bearing arms, an indication that she expects the Allies to bring exceedingly strong forces against her.

OFFICIAL WAR SUMMARY

FRENCH STATEMENT.

Paris, April 8.—via London, April 9.—12:15 a. m.—The following official statement regarding the progress of the campaign was issued by the French War Office tonight:

"Despite the continued bad weather fresh successes were won yesterday and today between the Meuse and the Moselle. At Eparges a night attack enabled us to make a step in advance and we have maintained our progress notwithstanding three violent counter attacks. We have already counted on the field more than a thousand dead bodies of Germans.

"Further to the south, near Lamorville, in a spirited infantry action we wiped out a German company, and took prisoners the ten survivors.

"In the Ailly wood we carried additional trenches and repulsed two counter attacks. In the forest of Montmare, north of Flirey, we gained a footing in the enemy's defence works and held our ground there in spite of the efforts the enemy made to regain them.

"To the north-east of this wood the cable of a captive balloon was severed by one of our shells and the balloon drifted across our lines towards the south-east.

"To sum up: The offensive reconnaissances and attacks which we have carried out since April 4th between the Meuse and the Moselle have given the following results:

"First.—On the north east and east fronts of Verdun we have gained on a front of twenty kilometers and occupied the heights which dominate the course of the Orne river, and carried the villages of Gussainville and Fromezey.

"Second.—On the heights of the Meuse, at Eparges, we have carried almost the whole of the strong positions held by the enemy on the plateau which commands Combre, and we retain the ground captured in the face of numerous and very violent counter attacks.

"Third.—Further to the south, near St. Mihiel, we have captured the entire south-western portion of the Ailly wood, where the Germans were strongly established. This they have been unable to retake, despite repeated counter attacks.

"Fourth.—In southern Woevre, between the forest of Montmare and the forest of Le Preire, we have gained on a front of seven to eight kilometers a distance of three kilometers (nearly two miles) and have taken from the enemy the villages of Fey-En-Haye and Regnieville.

LIBERALS WOULD DENY SOLDIERS CHANCE TO VOTE

ARE AFRAID THAT ONLY CONSERVATIVES ARE FIGHTING FOR EMPIRE.

(Special to The Chronicle)
Ottawa, April 8.—The government's bill providing that Canadians who volunteer for military service during the war will not be deprived of the right to exercise their franchise provoked a spirited debate in the Commons today, the Opposition coming out flatly footed against the proposal. The heavy artillery on both sides were brought into action and the cannonading continued until the early hours of the morning. In the course of the discussion Sir Robert Borden made a statement which will be read with more than passing interest by the country. Interrupting Hon. Frank Oliver, who in a most violent speech charged that the proposal to give votes to the soldiers indicated an intention on the part of the government to hold an election this year, the Prime Minister said: "I would like to say to my honorable friend who has just appealed to me that the question of a general election will stand on its own merits when the time comes. We have been too busy with other things. But I desire to tell him this: "That, including the vote of want of confidence which his leader moved and which he supported in every move during the past six weeks of this House, Honorable Gentlemen on the other side have been actuated purely by a desire so greatly lauds at the present time and that any man who has followed the course taken by Hon Gentlemen in this House and in the Committees of this House during the past six weeks knows absolutely the full truth of what I have just said."

The only Liberal to support the measure was that sterling imperialist and Col. H. M. McLean of Queens-Bury, who will himself soon be at the front as commander of a brigade. He approved the general principle, and would discuss details in committee.

Sir Wilfrid Laurier objected to the bill on the grounds that its provisions were inconsistent with the demands of responsible government, that it imposed duties upon British officers which the Canadian parliament was without right or power to impose, that it aimed to introduce passion and dissension where unity of thought and action should prevail that it would interfere with army discipline and that it would interfere with the paramount duty of the soldiers at the front.

Sir Robert Borden made a strong attack upon Sir Wilfrid's position. He took the ground that men who were risking their lives for the cause of human freedom should not be denied the right of franchise. The fathers and mothers and sisters and brothers of the men who had gone to the firing line would not look upon the measure in the "cold-blooded way" that the leader of the Opposition looked upon it. The Premier pointed out that New Zealand polled her soldiers votes and maintained that there was no reasonable reason why Canada should do the same.

CRUISER KENT AT FERNANDEZ PORT
Collao, Peru, April 8.—The British cruiser Kent, one of the vessels which recently sank the German cruiser Dresden near San Juan Fernandez Island, arrived here this morning. The cruiser and the forts exchanged salutes. The Kent will leave tonight.

FRENCH SOLDIERS FROM AFRICA WILL FIGHT THE TURK

EXPEDITIONARY CORPS OF ORIENT HAS EFFECTED PAS SAGE OF THE LEVANT.

Paris, April 8.—11.05 p.m.—French troops from Africa are ready to assist the Allied fleets and British expeditionary forces against Turkey. The following official statement was issued by the War Office tonight:

"The expeditionary corps of the Orient, which was placed under command of General A. G. L. D'Amade and concentrated at Bizerta (a fortified seaport of Tunis, Africa), to perfect its organization has effected the voyage of the Levant under the best of conditions. It had been ready since March 15th, to aid the Allied fleets and British expeditionary corps.

"In waiting, it was deemed advisable not to prolong the stay of the troops aboard the transports, and, for this reason the hospitality of Egypt was accepted. The French forces have been debarked at Alexandria and are installed at Rameleh, where they are resting and perfecting their organization and cohesion. They are ready to proceed without delay to any point necessary."

SENATE ADJOURNS BILINGUAL DEBATE

SUCH ACTION IS PRACTICALLY TANTAMOUNT TO SHEL VING IT ALTOGETHER.

Ottawa, April 8.—The bi-lingual school resolution of the Senate is not likely to be voted on this session. It was practically shelved today by a resolution adjourning it for a week. Prorogation is expected before that time.

On the bi-lingual resolution being called Senator Beique reviewed the discussion which had already taken place. It was significant that all parties seemed to be agreed upon the principle embodied in the motion made by Senator David. The amendment offered by Senator Bolduc contained the principle but avoided mention of any particular province. The sub-amendment also recognized the governing principle of Senator David's resolution. Therefore he failed to see why there should be division in the House.

Senator Choquette quoted Father Quinn's address to the French Canadian Congress at Quebec in favor of the French language. He asked the people of Father Quinn's faith and blood to vote to give justice to French-Canadians in the question now before them.

Senator David said that he had been influenced by no one in the preparation of his resolution and no one had suggested he should introduce it. He had prepared the resolution himself and no one knew that he proposed to introduce it. Neither had he been influenced by political motives. He maintained the Senate had no right to deal with his resolution. Senator David thought the soldiers now in the trenches and the Fathers of Confederation would favor his motion as amended by Senator Bolduc.

On motion of Senator Daniel the debate was adjourned for a week.

FRENCH WOMEN RECRUIT MOTORISTS.

Paris, April 8.—The French Women's Automobile Club has commenced the recruiting of women motorists, aviators and balloonists to form a brigade of ambulances for the French army. Applications are coming in at the rate of 100 per day.

The organization aims to find enough capable women conductors to replace all the men at present driving ambulances who are capable of rendering better services at the front.

Four women aviators including Madame Pallier, Baroness de la Roche, and Mlle. Helene Dutrieu, who had been refused admission to the aviation corps, have joined this movement. Many applications for enrollment have been made by women motor cyclists, who want to act as despatch bearers at the front.

REPAIRS STILL ON AT SPENCER WOOD

LT. GOVERNOR WILL NOT OCCUPY QUEBEC RESIDENCE FOR THREE WEEKS YET.

It is now a certainty that His Honor the Lieutenant-Governor, Hon. P. E. Leblanc, and family will not move into their residence at Spencer Wood before the latter part of this month or early in May. The extensive repairs that have been under way at Spencer Wood for some time will not be completed for at least two weeks.

His Honor, the Lieutenant-Governor will not return to Quebec before next week. Major Victor Pelletier, A.D.C., is leaving for Montreal this evening and may remain there and accompany the Lieutenant-Governor to the city on his next visit.

While the war is in progress there are not likely to be any social events arranged at Spencer Wood. Both the Lieutenant-Governor and Mde. Leblanc are very much concerned over their son, Lieut. Beaudry Leblanc, who is fighting in France with the Royal Canadian Dragoons.

CITY SAVES \$15,000 ON BOND ISSUE

VARIOUS IMPORTANT QUESTIONS STUDIED BY CIVIC FINANCE COMMITTEE.

The question of salary increases for Civic employees was brought up at a meeting of the Finance Committee last night when Ald. Lockwell asked Mayor Drouin if it was true that he had said there would be no increases granted this year. Ald. Lockwell regretted this stand, in view of the large number of substantial grants which had been made by the City. There were many employees who had been promised increases, and if he had known that they would be refused, he would have voted for smaller grants than had been made.

Mayor Drouin pointed out that he had taken the stand against salary increases in view of the financial crisis. He stated that he anticipated a deficit in the finances this year, not because the expenses would be in excess of the revenue, but because the collection of the dues was more difficult than other years. He also reminded the committee that there would be an increase of 5 cents in the school taxes due to the loan of \$185,000 for the School Commission, and thought that under the circumstances it would be very difficult to grant any salary increases.

Pleas for increases for the police, the firemen and the employees of the Health Department were made by Ald. Verret, Cote and Martin respectively. The question was left over to a subsequent meeting for further study.

The Bond Issue.

City Treasurer Blais, who accompanied Mayor Drouin to New York to sign the favorable exchange, in view of the favorable exchange, the City had saved \$15,854.75 in the payment of the Treasury Bills on the London market and the Bond issue in New York, which would increase the bid which was made from the City from \$97,079 to \$97,70. A report to this effect will be made to the Council.

Technical School Grant.

A letter from Mr. Art. Picard, president of the Quebec Technical School asked that the City's grant to that institution be increased from \$10,000 to \$25,000. He pointed out the good which the institution had done in the city, and the small means which it had for maintenance.

Ald. Verret explained that a Provincial law obliged the City to grant a sum of \$10,000 annually to the Quebec Technical School. This law, he said, had been amended since and empowered the City to increase. This question was also left over until a subsequent meeting.

Ald. Verret brought up the question of reorganizing the Recorder's Court, and this was referred to a sub-committee composed of Mayor Drouin, Ald. Cannon and Ald. Verret who will study the situation and report to the Committee.

The suggestion of the Board of Trade relative to taxes on insurance companies was also left over to another meeting, when the Board of Trade will be invited to send representatives to discuss the matter with the committee.

In connection with the proposition of Controller McDonald, of Montreal, for the raising of a sum of one hundred million dollars, to supply labor for the unemployed, it was resolved to write him admitting that the suggestion had its merits, but that the city was not prepared to concur in it just at present.

Mr. J. B. Morissette, insurance agent wrote the City, giving notification that the insurance premium against accidents would be due on May 1st. The amount of the premium is \$950, and as the City Attorneys wish to make certain changes in the policy the notice was referred to them.

The committee unanimously voted three months' salary to the widow of the late Constable Prustian, who served 26 years on the Municipal Police Force.

BRITISH SCHOONER LOST.

New York, April 8.—The loss of the schooner Edna M. Smith with her mate and four of her crew was reported tonight when the Norwegian steamer Petra arrived from Guantanamo, Cuba. The Petra had on board Capt. Farrell and eight survivors of the crew of the Smith, rescued from an open boat by the Petra. They had had nothing to eat for four days.

Capt. Farrell said that he had left Gullport, Miss., on March 16 with a cargo of lumber for Portlhead, England. On April 2 he encountered a severe hurricane and his vessel soon became unmanageable. During the storm the mate and four men were lost overboard. After all hope of saving the vessel had been abandoned Capt. Farrell and his eight men took to the lifeboat. Soon afterwards the vessel turned turtle.

The Edna M. Smith was formerly a British bark hailing from St. John, but had recently changed her rig to that of a schooner and come under American registry. She was built at Harvey, N.S., in 1903 and had a tonnage of 736.

VALCARTIER CAMP UNDER INVESTIGATION

"I ought to, I was one of the assessors" (Prolonged laughter).

"I guess, 'witness insisted,' nine hundred dollars was fair valuation".

Frank McLaughlin had been offered \$5,800 for his farm by the government, had four hundred acres which he thought was worth \$7,300.

Thos. Neil thought his farm was worth \$6,300. The government only offered him \$4,600. He felt his 150 acres was worth forty dollars an acre. Matthew Woodcock, a white haired patriarch, was the next witness. The government took his property of 350 acres. He wanted \$8,670 which included crops and damages for fishing privileges. He was not allowed to fish in his lake; a notice was put up forbidding anyone to fish. However, later he saw officers fishing, including Sir Sam Hughes.

Canteen Privileges.

Col. McBain was called to the stand again and examined in regard to the canteen privileges.

"Do you get anything for canteen privileges?" asked Mr. Carvell.

"Not one cent," declared Mr. McBain with emphasis.

"Did anyone else get anything for canteen privileges?"

"Not one cent so far as I know. I did hear a rumor about a clerk, Archambault, in my office. I know he disappeared and I reported it to the commanding officer. I was very busy and it is possible he got something. However, I don't know."

Uniforms Burnt.

Col. Hallick of the Ordnance department said he had investigated reports that new clothing and stores had been burnt at Valcartier, when he had investigated he found that a certain amount of old blue or red uniforms which some units had worn into camps, and some of which was verminous, had been destroyed but no new clothing. He read of a report on the matter which he and other officers had made stating that the rumors referred to were without foundation.

Col. Hallick had heard rumors as to the burning of harness but on investigation could find no foundation for them.

"IT'S AN ILL WIND."

Wilmington, Del., April 8.—All salaried employees of the Dupont Powder Company have been granted a cash bonus of twenty per cent of their salary for a year, it was announced tonight by Pierre S. Du Pont, president of the company. About 2,500 persons are affected.

The company recently granted a 20 per cent. increase in wages to its 15,000 pay roll workmen at plants throughout the country.

CARPATHIAN BATTLE FOR POLITICAL ENDS.

London, April 9.—341 a.m.—"The battle in the Carpathians is being fought for political ends first of all," says the Morning Post's Hungarian correspondent. "Nothing would suit the Russians better when established on the Hungarian plains," he adds, "than to begin negotiations with the Hungarian leaders and, if possible, detach Hungary from Austria in a separate peace. To delay this is the reason Germany is making such great efforts to hurry troops into the Carpathians."

"The Russian advance into the plains will at best be slow, for every hill is a miniature Przemysl."

PANAMA CANAL IS CLOSED AGAIN.

Panama, April 8.—A new movement of the old Culebra Cut slide on the west bank of the canal occurred today and has closed the canal. Several ships are tied up, among them the Ken'on Maru, the first Japanese ship to use the waterways. She is bound for Newport News.

The slide was not expected. The channel will be cleared and the canal reopened tomorrow.

VALCARTIER CAMP COMES UNDER INVESTIGATION

LIBERALS HAVE TO ADMIT THAT FISHING FOR CAMPAIGN MATERIAL IS POOR—SOME HUMOROUS INCIDENTS IN THE COMMITTEE.

(Special to The Chronicle.)
Ottawa, April 8.—The Liberals had to admit today that the "Fishing" was poor in the public accounts committee, for the inquiry has developed into a fishing expedition for campaign material on the part of the Opposition. All yesterday afternoon they investigated the purchase of Valcartier camp. A dozen odd farmers were on the stand. Their chief complaint was that the government purchaser, Col. Wm. McBain, had not offered them enough. Apparently the government drove too hard a bargain to suit the Liberals.

Mr. Adam Aitkins of Valcartier was first on the stand in the afternoon. He could neither read nor write. He signed a receipt for the sale of his farm for which he was to get \$3,050. The receipt read the farm was to be sold for \$2,600 plus \$450 for damages for the crop. Witness claimed that there was nothing on the receipt about damages. He admitted that he might have misunderstood the receipt. He was given a drink when he got the option although he was a "Prohibitionist".

The next witness was Wm. Lyons of Valcartier. He was a farmer and baker. He gave an option for his farm to Mr. Deschenes, a "Horse Doctor". The witness also could not read or write. His house was near the place where the soldiers had their shower baths and, for a week his girls had to keep in the house as there were always naked men in the baths. Witness said that he was to get \$4,500 for his farm and damages for his crop, although he had not got his money yet. His property was expropriated, although he admitted he intended to remain in his house until disposed. He had a canteen where he made \$300 profit.

"Did you sell any whisky," asked Dr. Reid.
"No."
"Are you a prohibitionist too?"

Mr. Hugh McLaughlin of Valcartier was the next witness. The government had his property but he had not yet been paid. He was to get \$550 for damages for oats. He thought it was not enough but he needed the money. He put in his bill. He waited and waited but could not get a settlement.

TRYING TO REPLACE GERMAN DYE STUFFS

AMERICAN CHEMICAL COMPANIES USING ARTIFICIAL DYES WITH HOME PRODUCTS.

Washington, April 8.—American chemical companies are bending every effort towards supplying textile mills and industries using artificial dyes with home products to replace German dyestuffs, shut off by the European war.

Reports to the Department of Commerce made public today show that at least six plants are in course of construction for the manufacture of the coal tar derivatives upon which the colors used in cloth manufacture, varnishes and other products are based. Approximately \$6,000,000 is to be expended and within a few months it is estimated that much of the material for the simpler dyes which heretofore was purchased in Germany at a cost of \$12,000,000 annually will be turned out in the United States.

A report of the dyestuff situation, called for by a resolution of Congress, was given out today by the Department. It was compiled by Thomas H. Norton, a commercial agent of the department, who formerly served as consul in Germany and is familiar with the industry.

Mr. Norton estimates that American coke ovens are wasting annually \$100,000,000 in by-products that could be saved and employed in other industries, it having been preferred heretofore upon German chemicals rather than develop an American dyestuff supply. The American coke industry, the report states, could produce twenty times as much coal tar as the world needs for dyes.

In his report, Mr. Norton calls attention to the fact that England has already taken steps to free herself of dependence upon the German dyestuff mills, and that similar steps have been taken in France, and are contemplated in Russia.

Mr. Norton estimates that American coke ovens are wasting annually \$100,000,000 in by-products that could be saved and employed in other industries, it having been preferred heretofore upon German chemicals rather than develop an American dyestuff supply.

BRITISH STEAMER IS MYSTERIOUS

Much Curiosity Over Arrival of the Ismaila at Rio Janeiro.

Rio Janeiro, April 8.—The British steamer Ismaila came into Rio Janeiro today, and no sooner had she dropped anchor than speculation was rife as to her real character.

She has on board 146 passengers, and the captain declares his destination is the Falkland Islands. Lack of coal compelled him to come in here. He declined any further explanation, nor has it been possible to learn why such a large number of passengers are going to the Falklands.

THE HARBOR COMMISSION

It is much to be regretted that Sir William Price's decision to resign the presidency of the Harbor Commission must be considered as final and irrevocable, though it can well be understood that a man with such extensive business interests can with difficulty find time to devote to other activities. In any event, Sir William can pride himself upon the fact that no other man ever accomplished so much for the welfare of the port of Quebec within so short a time. From the moment that he took over the administration of the Harbor Board the old haphazard and dilatory method of worrying along somehow ceased to exist. Almost as if by the touch of a magician's wand the whole harbor front was galvanized into motion and transformed with the most modern equipment into a scene of enterprise and efficiency. A gigantic elevator soon arose, new sheds were constructed, more docks were prepared, the system of railway communication in the harbor was vastly improved, dredging was carried on apace, in short everything possible was begun that might, as we have already pointed out, set the Ancient Capital well on the way to realize her position as one of the greatest deepwater ports on the American continent. To that position the many indisputable advantages with which she has been manifestly endowed by Nature should justly entitle her. All that remains is for man to implement those advantages. So far as Sir William Price is concerned, he has done his share a hundred-fold. And the city of Quebec is greatly indebted to him. There can be no gainsaying the fact.

Sir William has done a lot. It should be the care of Quebec that his work should not be undone, rather that it should be carried to a successful finish. It is incumbent, therefore, on the citizens of Quebec to get the right man in the right place.

The news from Ottawa is to the effect that Mr. J. G. Scott of this city is looked upon there as the most likely selection for the position. So far as we are concerned, Mr. Scott will have our most hearty approval and we sincerely hope that he will succeed Sir William as the new chairman of the Harbor Board. Mr. Scott has many qualifications for the role and it is evident that the Government is as well aware of them as are the citizens of Quebec. He is one of the most public-spirited residents of the Ancient Capital and has done great service in her cause.

It was Mr. Scott who was the means of constructing the Lake St. John and Great Northern Railways which have done so much to open up our back country. These roads, in all some five hundred miles in length, have, it is calculated, caused an expenditure in our city and district of some fifteen million dollars, an expenditure which came at a very opportune time as Quebec had just lost the timber trade and shipbuilding industry. They have developed the great spruce forests to the north of Quebec and have been responsible for the building up of prosperous manufacturing towns at Shawinigan, Grand'Mere, La Tuque, Jonquieres and on the Saguenay. It was the Great Northern which brought to this city the grain trade from Parry Sound and for several years furnished a regular line of ocean steamers, as much as three million bushels of grain being transhipped here in a single season. Indeed, much of the present prosperity of Quebec may be attributed to these two railways which have become quite prosperous, with gross receipts of nearly three millions.

Since retiring from railway management Mr. Scott has been very active as Vice-President of the Quebec Board of Trade and has constantly urged the necessity of building docks and elevators on the St. Lawrence front so as to enable the Transcontinental Railway to bring to Quebec the grain trade of the West, the object for which the line was built. It has always been his contention that this traffic can be brought here, all rail, at cheaper freight rates than by the present rail and water route to Montreal. If this should prove the case, then Quebec will become the chief grain-shipping port for the prairie provinces and a new distributing centre for their trade.

It should also be remembered that it was the Trans-Canada Railway, originated by Sir William Price and Mr. Scott, which was the means of bringing to Quebec the terminus of the Transcontinental which might otherwise have gone to Toronto.

Under the circumstances, we are fully confident that Mr. J. G. Scott as the new chairman of the Harbor Commission would be the right man in the right place.

GIGANTIC CHARITY SCHEME IN VIEW

NEW YORK WILL RAISE A MILLION FOR UNEMPLOYED AND BELGIANS.

New York, April 8.—To raise within one week at least a million dollars for the combined benefit of unemployed in New York, destitute Belgians and non-combatants in the European war, is the plan announced tonight by the Belgian American Relief and Unemployment Fund Committee.

Beginning Monday, a thousand women, many of them wealthy and socially prominent, will open a campaign to raise funds by personal solicitation which will continue until April 29. The funds will be turned over to the several committees which in this city are dealing with problems of distress. The campaign will be inaugurated with a dinner on Monday night to arouse enthusiasm. The women workers will be divided into teams of ten each, with a captain, and will report progress at the fund's headquarters.

CHINA RECEIVES AMERICAN NOTE CONCERNING JAPAN

United States' Note Covered Twenty Pages and Specifically Asked Five Questions.

THE JAPANESE REPLY.

Japan's Replies to All Five Questions Are Also Set Forth in America's Note.

Peking, April 8.—The Chinese government received today an outline of the note of the United States government to Japan concerning the demands made upon China by Japan, and of the reply of the Japanese government. It is said this reply was made on March 22nd, by Takaai Kato, Japanese Minister of Foreign Affairs.

The Chinese report says that the American note covered twenty pages and specifically asked five questions. These questions are set forth as follows: The United States inquired concerning Japan's demand that in the province of Fukien, Japan shall have the right to work mines, build railroads and construct harbor works, and in case of the employment of foreign capital that Japan shall be first consulted. The Japanese government replied that these concessions were desired for the primary purpose of preventing other nations from acquiring special rights there, Japan understanding that Americans wish to build dock yards in the harbor of Santuao. This position is of great strategic importance, Japan pointed out, on account of the possibility of its use for directing operations against Formosa in case of war.

The second question concerning the Japanese demand for supervision over the manufacturer or purchase of munitions by China. The Japanese government expressed the opinion that this question could be solved most satisfactorily by the employment of mixed forces of Japanese and Chinese; a system which, Japan says, already exists.

The third question dealt with the Japanese demand that the Chinese police in certain places be administered jointly by Japanese and Chinese officials, or that China shall employ numerous Japanese to organize the Chinese police. The Japanese government replied that this demand applied only to southern Manchuria.

The fourth question concerned the demand for employment by China of Japanese political advisers. Japan replied that political advisers will not be imposed upon China but merely recommended.

The fifth question related to the demand Japan was said to have made that "no land, port or harbor along the coast shall be ceded or leased to any third power." The Japanese government replied that this proposed restriction would apply to Japan as well as to other powers.

He left with the First Canadian Contingent, a member of the 14th Battalion. He is a patient at the Royal Pindi General Hospital, Boulogne, with a wounded neck.

WAR REVENUE TAXES WILL BE EFFECTIVE APRIL 15TH

SPECIAL WAR REVENUE ACT RECEIVED ROYAL ASSENT YESTERDAY—PROVISIONS OF ACT COME INTO FORCE THURSDAY, 15TH APRIL.

Ottawa, April 8.—The special war revenue act received the royal assent today and is now the law of the land. Its provisions, by the terms of the act, come into force on Thursday, the 15th instant, so that on and after that date a war tax postage stamp of one cent or a one cent postage stamp in lieu thereof will have to be affixed to all letters and post cards before mailing. The extra cent will not, however, have to be placed on circulars, because a circular is not a letter within the meaning of the post office act. On checks and drafts and promissory notes issued after the 15th and negotiated through a bank a two cent stamp will have to be affixed. Any person sending a telegram will have to pay an extra cent to the telegraph company for His Majesty's treasury. Purchasers of railway tickets will have to pay five cents extra for the treasury on all tickets costing over one dollar and up to five dollars; and an additional five cents for each five dollars or part of five dollars of the cost of the ticket.

Druggists selling proprietary or patent medicines and perfume costing twenty-five cents or less will have to affix a one cent stamp to each bottle or package sold. If the bottle or package costs more than twenty-five cents, then one cent will have to be affixed for each twenty-five cents or part of twenty-five cents of the selling price. On every bottle of wine and champagne sold special stamps will have to be affixed.

There are heavy penalties for any violation of these requirements, except in the case of the war tax on letters and postcards. If the stamp is not affixed to a letter or postcard, the only penalty is that the letter or card goes to the deadletter office.

While special inland revenue stamps with the words "war tax" upon them have been prepared and will be found on sale with inland revenue offices and with postmasters in many centres, postage stamps will serve the purpose if the war stamps are not readily available.

Last evening at the Y.W.C.A. Hall, Mr. W. H. Wiggs repeated the interesting lecture he delivered in the Y.M.C.A., some weeks ago on "The Great War." He was introduced by Miss K. Glass, who in her remarks stated what pleasure it afforded the Association members and audience to have the speaker deal on a subject that was claiming the attention of the whole world. During Mr. Wigg's lecture, 154 slides, including maps and charts, illustrating the war zone, etc., were exhibited. At the conclusion of the lecture a hearty vote of thanks was proposed by Mrs. Darlington. At the intermission Miss Townsend played the Belgian National Anthem in honor of the birthday of King Albert.

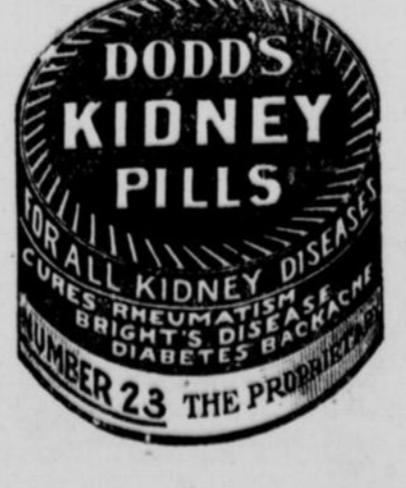

BULGARIA'S GRIEVANCE.

The filibustering expedition of Bulgarian irregulars to Serbian territory is the result of the injustice of the settlement of the last Balkan war. The Balkan States fought like wolves over the carcass of the Turkish empire when the first war finished, and Serbia wrested from Bulgaria much territory which should have remained Bulgarian. Macedonia should never have been taken from Bulgaria. It is Bulgarian in population, language and tradition. If the wishes of the people themselves had been expressed by plebiscite, Macedonia would, without question, be now part of Bulgaria, not of Serbia. That some hotheads, smarting under the humiliation Bulgaria then suffered, should now attempt to regain the lost province is not surprising. The ministry disclaims responsibility. The experienced men of affairs in the government are too wise to be mixed up in an event which, if official, would commit them to war with the Allies. The fact remains that Bulgaria is a nation with a grievance. Ill-treated by Serbia and Greece, and not supported in her claims by the present Allies, she is certainly ill-disposed to assist them. But her rulers are too astute openly to side with Austria and Turkey. To assuage the sullen ire of Emperor Ferdinand's people is a task the Allies must assay. The guarantee of a suitable extension of territory, which in the event of the expected victory of the Allies, might come either from Turkey or Austria, perhaps from Serbia, would assure Bulgarian neutrality, and would leave Roumania and Greece free to follow their national inclinations.

RETALIATION IN THE WAR.

War is terrible, appalling, conducted according to the most enlightened and humane international code. But the European war is relapsing into one of medieval times or worse. It is becoming a war of reprisals, of revenge to a bitter, unrelenting hate lashed to unreason and fury by ambitions thwarted and dreams of conquest and supremacy defeated. It is becoming more and more a feud in which the innocent, unoffending and helpless must take their chances in a war from ambush, so far as they are concerned. If these unsuspecting or of necessity fall into an ambush and there is no rescue near, they must pay the penalty with their lives. The violation, real or alleged, of the international practices of war by one belligerent exempts the other from the obligation of observance, is in effect the doctrine proclaimed from Berlin. But as it has happened in this war what is alleged retaliation has more often than anticipated any alleged violation of the international war code. The submarine war zone decree preceded by many weeks the order in council, or so-called starvation blockade. The war zone decree has been supplemented by another order, if the words of a German submarine commander are correctly quoted by British fishermen whose trawlers were sunk. Those words were to "sink everything." Three trawlers were therefore sent to the bottom last week by a submarine, notwithstanding that The Hague convention to which all the belligerents are signatories specifically exempts the fishing vessels of one enemy from attack by another. The fact that the German submarines have thus far spared no sort of enemy craft they could overtake in the new method of warfare, indicates that the "sink everything" order has been promulgated and is being followed.

Britain in retaliation for the indiscriminate sinking of vessels of all kinds by German submarines, with its menace to non-combatant lives announced that captured crews of submarines would not be accorded the honors of other prisoners of war, but would be kept apart. Germany has transmitted to British government through the United States a threat that should different treatment and segregation be accorded captured submarine crews then Germany will visit upon an equal number of captured British army officers correspondingly harsher treatment. In answer England gives no intention of a change of policy with respect to segregation of captured submarine crews, though otherwise they are to be fed, clothed and given medical attention as are other prisoners of war. The British reply to the threat, also sent through the United States, is that the submarine crews engaged in warfare upon non-combatants "can not be regarded as honorable opponents, but rather as persons who, at the order of their government, committed offenses against the law of nations and contrary to common humanity." Incidentally the reply

mentions the significant fact that, whereas the British navy has rescued more than a thousand officers and men of the German navy, not one English officer or man of the British navy during this war has been saved from death by the Germans sinking of a British warship. Men aboard warships take the chance of perishing with their vessel, naturally, but a belligerent sinking an enemy merchant ship, by all the laws of nations, is bound to safeguard the lives of non-combatant passengers and crew. They may be captured with the ship and, if enemy subjects, be deprived of their liberty. But they may not be killed. The submarine, as a new instrument of war with some restrictions upon which it may do with a captured prize, is not exempt from observing rules of common humanity in its disposition of innocent lives. It is a weapon of stealth and, though a legitimate one in warfare, its attack is, after all, cowardly, since its stroke is dealt in the dark and from ambush whether the victim is dreadnought or merchant ship.

PRESS COMMENT.

Last August a million French and a hundred thousand British soldiers blocked the westward advance of the German armies. Then the Kaiser's war-machine was in the pink of condition, perfectly equipped, unimpaired, unscarred, and glorying in its strength. But the German progress was arrested and the invaders thrust back, with appalling loss, by the Allied troops. Now the "machine," weakened and reduced in morale after eight months' futile campaigning, is confronted by eight million British and French troops, who are preparing for a forward movement on a scale beside which last season's operations will appear like preliminary skirmishes. If the war continues throughout the remainder of the year, the losses on both sides will be staggering, but with the numerical advantage now so strongly in favor of the Allies, the outcome can no longer be regarded in doubt. Last year Belgium was the chief victim of the war. This year the greatest sufferers will be the war-mad Kaiser's own subjects, and there is nothing in the record of past wars to enable the world to anticipate the weight of the scourge that is about to fall on the people of Germany. When this season's campaign is over, "the horrors of war" will have a new meaning for the nations of the world—Sydney Post.

Every dog has his day. Jack Johnson's day as a champion prize fighter has been rather longer than usual, but his term has also come. His age, apart from his habits, was against him in his last contest. Youth must have its way. The wisest and strongest go down before wiser and stronger, and some men grow sour over the inevitable destiny. There are only a few years, sometimes only a few months, when a man is at his best in any particular line. It is rarely that a man who has found himself at the top of his special tree, prepares to climb a new one, or substitutes some other line of achievement for that in which he has been distinguished. It is not possible, of course, for all men to be Admirable Crichtons, but it is possible for men of any other to develop more than one side of their natures and to cultivate more than one latent talent. Unfortunately, gentlemen of the calibre of Mr. Johnson do not usually regard eminence in any other profession or pursuit than their own as desirable or sufficiently attractive to stir up their energies. The tremendous persistence, courage, discipline, training and hard work put into the career of a champion prize fighter would probably enable him to succeed in many other ways. It was one of the mistakes of a past generation to imagine that a prize fighter could be nothing more than a brute. Nothing could be more erroneous. But it is true that many prize fighters, like many men in other professions, have degraded themselves with bad habits, and spent their strength and their skill on pleasure, or voluptuousness, on what saps the brain and the mind as well as the muscles and sinews. Possibly had Mr. Johnson lived according to the regimen of the trainer's camp since he first won championship honors, he might have been able to defend his title for some years to come. His successor may or may not reflect upon this view. It is one that is generally held in professions other than that of prize fighting. The man who wants to keep at the top must always keep at his best. Mr. Willard steps into the arena of fame with his great six feet six inches splendidly controlled and developed. He also will have his day, and then another champion will reign in his stead. It altogether depends upon himself whether he maintains a state of honorable

efficiency or whether he shortens his course by less rigid and sensible attention to the rules of health and science. There will be less concern in British lands than in American over the racial aspect of yesterday's fight. It is only in a nation where the Scriptural belief that God made of one blood all the nations of the earth is inherent, that white men and black men, cream-colored men and red men, brown men and Germans, are regarded with the same feeling, and estimated according to their merits and not according to their color. Canada is in danger of being tainted with the United States slave-owning view of people of a different race, and there should be no rejoicing over the fall of a negro prize fighter more than over the fall of a Caucasian. We should all be able to admire a man. Mr. Willard appears to be a considerable realization of manhood, and we trust he will maintain his title to manhood, whatever else he may hold.—Exchange.

Among the famous pantries of the world is that of Queen Mary at Windsor. This pantry comprises two rooms of no great dimensions, but it contains treasures in the form of plate and household articles that are valued at more than a million pounds sterling. Many of these possess historic interest. For example, there is a conspicuous exhibit in the form of a table of solid silver. This is nearly a yard in length, and its top, with an area of several square feet, bears the royal arms and exquisitely chased designs of the symbolic rose, thistle, harp, etc. Every reign since that of Elizabeth has contributed to this table a design of some sort. The most imposing of all the dazzling array of plate is the so-called gold dinner service for occasions of the highest state. The walls of the two rooms of this royal pantry, the larger of which is 30 feet by 16 feet, and the smaller a square of 16 feet, are lined with cases of plate glass and mahogany, and in these and similar cases, occupying the center of each room, are some of the most extraordinary examples of art in gold, silver and precious stones that the world has ever seen. There are tall, graceful epergnes, each of which take the strength of two men to lift it; there are dishes in gold and silver, any one of which would be too heavy to run away with, dainty toilet services in gold and silver, candelabra, communion services, flagons, vases, punch bowls, wine coolers, fountains and fonts, in silver, wrought in designs of great beauty by the most skillful of artists.—Washington Post.

MR. J. G. SCOTT AND HARBOUR BOARD

IS COMPLETELY IN THE DARK CONCERNING RUMOR OF HIS APPOINTMENT.

Mr. J. G. Scott, interviewed by a Chronicle reporter, as to the rumor that he was likely to succeed Sir William Price, as Chairman of the Harbor Commission, said that he knew nothing about the matter beyond what he had seen in the newspapers. He had not applied for the position, nor spoken to anyone about it, nor had it been offered to him.

He hoped that Sir William Price would reconsider his decision and withdraw his resignation. The chairman had been more successful in obtaining large grants of money for the port and had pushed on the excellent work done by the Harbor Board during the last three years with wonderful energy. The most difficult and costly part of the work still remained to be commenced, either by the Government or the Harbor Board, namely the docks and elevators for the Transcontinental, without which that railway would be useless to us.

"Quebec will need great influence and energy to bring this about," said Mr. Scott, "and Sir William Price has both these qualities in a marked degree, so I hope in the interest of Quebec to see his resignation withdrawn. He would be difficult to replace."

THE DEATH OF LANCE-CORPORAL SEARS.

He was shot in the knee while going into the trenches on the evening of the 13th of March, and reached England on the 17th of the same month, when he was placed in Chatham Hospital. In a letter to his wife, which she received last Monday, Lance-Corporal Sears told her that the doctor had said that while his fighting time was finished, the wound was not dangerous. On Wednesday, Mrs. Sears received a telegram from Ottawa, stating that her husband had died of the wound on Monday last.

IMPORTANT FINDING IN APPEAL COURT

Q. R. L. H. & P. CO. WINS FIVE CASES WHICH IT HAD BEFORE THE COURT.

A number of important judgments were delivered in the Court of Review yesterday, among them being the appeals of the Q. R. L. H. & P. Co., from the decision of the Superior Court in the cases of Mr. G. A. Vandry, the Guardian Fire Insurance Co., the Liverpool, London & Globe Fire Insurance Co., the Phoenix Assurance Company of England and the Queen Insurance Co., versus the Electric Co.

The appeals in question arose out of the destruction a few years ago of the premises of the Quebec Hunt Club on St. Foye Road. It was claimed that the fire was due to electric wires of the appellant company, and suit was taken against it. The case was heard in the Superior Court, and the respondents were successful but the Q. R. L. H. & P. Co. took the matter to appeal, with the result that it won all five cases, yesterday.

The appeal Court was presided over by Chief Justice Sir Horace Archambault, with Hon. Messrs. Cross, Carroll, Lavergne and Pelletier.

Other Decisions.

The Shives Lumber Co. and Chateaux Bay Mills, Ltd.—Appeal rejected, with costs.

Bouchard et. vir and the city of Quebec—Appeal maintained in part and judgment against the city for \$613.30.

Savard, esqte. and Lacasse et al.—Appeal rejected without costs.

Letarte and Turgeon—Appeal maintained with costs.

ALDERMEN APPROVE HOME GUARD GRANT

FINANCE COMMITTEE UNANIMOUSLY RECOMMEND PAYMENT OF \$5,000.

The Civic Finance Committee last night on motion of Ald. Lockwell decided to make use of the power granted by the Provincial Legislature and to grant the sum of \$5,000 to the Quebec Home Guard which had been promised by the Committee several months ago.

Col. Wm. Wood, Commander of Home Guard, and Major A. E. Doucet, Paymaster, appeared before the committee to give whatever explanations the committee desired. It was pointed out by Col. Wood that on the strength of the promise made by the Finance Committee the Home Guard had purchased Mauser rifles, but he reminded the committee that the cost of equipment for the guard would greatly exceed \$5,000, as a large portion of the members had not the means to buy their own equipment, but they willingly gave their time to drill and other exercises. He affirmed that history proved that Home Guards dated back to the time of Guy Carleton. He said that there were now 360 men in the home guard of whom 90 per cent. were all properly enrolled and equipped. The rifles purchased were German Mauser arms, a model which had been discarded by the German army. The rifles purchased by the Home Guard were quite new and had never been issued to the German troops.

He explained that the Home Guard did not want to keep any equipment after the war was over and all the accoutrements up to a value of \$5,000 would revert to the city. He desired that this be specifically mentioned in the resolution for the grant.

Asked by Ald. Collier what percentage of the members of the Guard were over seventy years of age, Col Wood replied that when he gave the command to "Ground Arms" several times in succession, it was not hard to see what members had reached the three score and ten mark. He instanced one exception of a member who is nearing the eighty mark and who insists upon doing all that the younger members do, and can walk down to his office as sprightly as ever the next morning.

Ald. Verret who was acting chairman in the absence of Ald. Cannon explained that it was never thought for a moment that the Home Guard organizers wanted to make money. He was convinced, however, that if the organization of the Home Guard was to be started over again there would never be any guard.

Major Doucet also gave the committee some explanations and after a short discussion it was decided on motion of Ald. Lockwell to recommend the grant to the Council and to embody in the resolution the specifications that after the war the equipment up to a sum of \$5,000 will revert to the City.

Another \$5,000 Grant.
The committee also decided to recommend the granting of a sum of \$5,000 to the Franco-American Committee, which had already been promised.

WOUNDED CANADIAN REACHES QUEBEC

GUNNER JEWETT, OF FIELD ARTILLERY, INVALIDED HOME TELLS EXPERIENCES.

The first Canadian soldier wounded in the trenches in France, to reach Quebec, is now here visiting friends, in the person of J. E. Jewett, of the Canadian Field Artillery.

Mr. Jewett, who is twenty-two years of age, belongs to Smith's Falls, Ont., where his wife and parents reside. He joined the first contingent, and after going through training at Valcartier, left for England and subsequently went to France.

At the end of January, his battery was in the trenches, when they were ordered to cover an attack of the Princess Patricia's Regiment. The firing became hot, and Jewett was struck in the hip by a piece of shrapnel. About an hour afterwards he was taken to the base hospital, subsequently being transferred to Shorncliffe Hospital.

In the fight, in which Jewett was wounded, his battery did not lose many men, but the Patricias lost about fifty killed and wounded.

In answer to the Chronicle, Jewett was very reticent about where the fight took place. He said that life in the trenches was rough at times, but there was a good deal of excitement about it, and, when in billet things were quite enjoyable. The people in France, particularly the ladies, were very kind to the soldiers. Some of the latter were making great efforts to learn French, and when they pick up a few words, were not the least bashful in airing them in public.

Jewett speaks highly of the treatment the sick and wounded receive in the English hospitals, the greatest care being bestowed on the patients. When he was able to leave the hospital, he was granted eight weeks holidays to visit his family. He left England for New York in March and on arrival there came on the Canada to his home at Smith's Falls.

Although Jewett is still somewhat lame, he expects that by the time his leave expires, he will be well able to take his place on the firing line. He is very modest in regard to his personal experience at the front, but it was evident that he feels that life is very tame here when compared with what is taking place on the other side of the Atlantic.

34 NURSES HERE FOR TRAINING

FRENCH CANADIAN LADIES WILL FORM PART OF 2ND. CONTINGENT.

The nurses who will be attached to the French Canadian military hospital now being organized have arrived here and will be stationed at the local military base of the Quebec garrison to undergo the required preliminary training.

The nurses are in charge of Miss Casault, who is the matron. They will remain in Quebec for several weeks and while here will be supplied with their trousseaus and their uniforms. On leaving Quebec they will return to Montreal where they will be definitely attached to the staff of Col. Mignault, before sailing for France.

WING WHEELERS DECIDE NOT TO JOIN PROPOSED NEW LEAGUE.

Montreal, April 8.—That the Montreal Lacrosse Club will not figure as a member of the proposed new league this season, was assured at a meeting of the Winged Wheelers, held at the Peel street club house Wednesday. The decision reached at the meeting was that the club should remain as members of the National Lacrosse Association, if that body is re-organized at a meeting to be held at the M.A.A.A. on Saturday afternoon. Word has been received from the other affiliated clubs of last season, Cornwall, Shamrocks, and Rosedale, that they would send delegates to the meeting to discuss the lacrosse situation.

Although numerous discussions took place at last night's meeting only the announcement that the winged wheelers would stand by the N. L. U. was made public. It was learned that one of the members suggested that the Montreal Club play this summer as free lances, devoting their time to playing exhibition games. Should the N.L.U. disband, it is likely that this plan will be followed out.

Tom Carling and John Davidson were appointed delegates to the N.L.U. meeting. A special meeting of the Shamrocks will be held tonight, when the lacrosse situation will be dealt with.

WILLARD'S POPULARITY.

Case of "Hail the Conquering Hero Comes" Everywhere.

Savannah, Ga., April 8.—The progress of Jess Willard, victor over Jack Johnson in the battle for the world's heavyweight championship at Havana, on Monday, through Florida today on his way north, was one continuous ovation. Not since the days when John L. Sullivan held sway as the king of the glove yielders, have similar scenes and excitement been created by the advent of a fighter.

The day's trip was made amid a succession of spontaneous receptions in which the populace of each succeeding city seemed anxious to surpass the enthusiasm of those places just passed. Word of the approach of the new champion was flashed ahead and as a result flags and bunting were flying, bands playing and hundreds waiting in the heat at every station between Dayton and this city. As every cross road and depot were throngs numbering from a few score to thousands. In many cases it was apparent that the spectators had travelled considerable distances, for dust covered automobiles and horse drawn vehicles of all descriptions formed a conspicuous feature of the background.

Just before reaching Savannah, where another great gathering cheered Willard, it was reported that the pugilist had been offered \$100,000 for his share of theatrical receipts for the next year. Willard refused to discuss the report or state who had made the offer.

MOVIE SNIPER PUTS ONE OVER ON BLACK

Havana, April 8.—A "movie sniper" who eluded the vigilance of numerous scouts, ambushed Johnson and Willard as they battled on Monday last for the heavyweight championship of the world and obtained pictures of the contest.

This is the opinion of Jack Johnson, who, learning that films of some of the rounds of the fight were to be shown at several Havana theatres tonight, started right out to stop what he termed an infringement of his property rights. He consulted the secret police and applied to the judge of the night court for an injunction.

The merits of the complaint could not be acted upon immediately and the judge advised the ex-champion to serve a written notice of his claim on the firm of theatrical managers who had distributed the films, promising to issue an injunction tomorrow should the law warrant it.

DID NOT INSULT WORKING CLASSES

LOYD GEORGE REFUTES A CHARGE MADE BY KEIR HARDIE.

London, April 8.—David Lloyd-George, Chancellor of the Exchequer, replied today to a charge made by James Keir Hardie at the meeting of the Independent Labor party at Norwich that the Chancellor had maligned and insulted workmen and that as a result word had gone around the world that "the working classes were a set of drunken wasters."

The Chancellor declares that he particularly said it was a minority of the men against whom the charge of excessive drinking was made and repeats the statement that the "drinking habits of the minority have the effect of seriously diminishing the output of war materials at a time when the success of the Allies depends entirely upon that material being largely increased."

Mr. Lloyd-George says this fact has been established by independent inquiries made on behalf of the government, the results of which will soon be published.

From the Files of THE CHRONICLE, April, 1885 and 1815.

THIRTY YEARS AGO TODAY

City Councillor McLaughlin.

Thirty years ago to-day it was with very great regret that we had to inform our readers that Councillor McLaughlin, of this city, was at the point of death. Our respected fellow citizen has been in failing health for some months past. He has been unconscious for a couple of days, and has received the last rites of the Church.

A Squaw's Opinions.

With regard to the Riel insurrection in the North-West, we have the following from a gentleman just arrived from the Rockies. He gives an interesting account of a conversation he had with an intelligent squaw, whose acquaintance he formed on the train after leaving Regina. The Indians, she said, intended taking no part in the trouble, and that all of the chiefs, with the exception of Pecau and one or two others, were contented, and regarded the present difficulty as in no way affecting their interests. The half-breeds, she said, resolved upon securing all the furs on the Saskatchewan and appropriating the supplies, and then retreat in the direction of Edmonton into the heavily timbered country there, where they would give battle. The insurgents imagine they would have no difficulty in repulsing the volunteers from such a vantage ground and under no circumstances will they give battle on the open prairie. The opinion exists among the half-breeds that the Indians of Montana will join their standard, and that with the allegiance of these influence would be successfully brought to bear upon the disaffected tribes in the west to join Riel. The half-breeds now in arms secure a subsistence by fishing, reside in log huts by the lakes, and are thoroughly conversant with the country. They are armed with Winchester rifles and ordinary guns.

A HUNDRED YEARS AGO TODAY

Justices of the Peace Oath of Office.

One hundred years ago Justices of the Peace in the Colonies had to subscribe to the following oath of office: "You shall swear that you shall do equal right to the poor and to the rich after your cunning (learning) wit (knowledge understanding) and power and after the laws and customs of the realm. And ye shall not be of council of any quarrel hanging before you; all issues, fines and, amercedments that shall happen to be made, and all forfeitures which shall fall before you, ye shall cause to be entered without any concealment or embezzling and truly send them to the King's Exchequer. Ye shall not let neglect hinder, obstruct, delay, for gift or other cause, but well and truly ye shall do your office of Justice of the Peace in that behalf. And that you take nothi g of your office of Justice of the Peace to be done, but of the King's fees, accustomed, and costs. And ye shall not direct, nor cause to be directed, any warrant (by you to be made) to the parties, but ye shall direct them to the bailiff or other of the King's officers or ministers, or other indifferent persons to do—execution thereof. So help you God."

Justices of the Peace are strongly protected by law in the execution of their office, but, like all other persons in authority under the law of England, they are responsible for their acts, and punishable for refusal or neglect of duty, or wilful misconduct in the execution of their office.

supply of clothing and comforts for the troops, etc.

At Devonshire House, before Christmas, a special collection of socks and belts was made to the number of 970,000, and these were sent as a present from the Queen and the women of the Empire to our soldiers at the front. That organization is now closed, and it is considered better that in future any comforts required by the men on active service, supplemental to the War Office issue, should be supplied direct from the Queen Mary's Needlework Guild.

The Guild was initiated by Her Majesty the moment war broke out, and is still actively engaged in the collection and distribution of clothing of all kinds. The demand has been enormous, but the response to Her Majesty's appeal has been remarkable. From all parts of the Empire, from every continent, from the United States of America, and from every country where English is spoken, gifts of clothes have been forthcoming in generous measure. No less than 901,633 garments have been received, and \$29,867 distributed in six months. A constant distribution has been maintained, and for some weeks past it has varied from 21,000 to 50,000 a week.
