THE QUARANTINE OF INFECTED HOUSES TO BE MORE THOROUGH.

The "Normania's" Passengers at Last Released from New York Quarantine.

New York, September 17.—The case of Asiatic cholera officially reported late Thursday afternoon was in the tenement house, 692 Second avenue. The victim is Mary Corry, seventeen years old, who arrived from Ireland about six months ago and went to live with a family named Lyon, on the third floor of the house mentioned. There are eight other families in the tenement. The girl obtained employment six weeks ago as a dish washer in the boarding house of Mrs. Maria L. Finn, at 221 East Thirty-third street, at 10 o'clock Wednesday evening, who left the second avenue house, where she had been visiting Mrs. Lyon, and returned to her place of employment. Mrs. Finn said last evening that the girl had been complaining of cramps for two weeks, but that she did not think it light enough to report to the health officer. She was seized with a violent headache and fever, and died at 10 o'clock, when she was taken to the hospital. The girl's body was found with her, the couple walking through the streets.

Mrs. Corry continued to grow worse, and Mrs. Lyon sent Dr. Courtney, who has an office in the house, to see her. He could not be found. It was two hours before another doctor was summoned. This time Dr. Courtney came to the house, and he called in. He found the woman suffering fearfully with cramps and vomiting, and he ordered her to be taken to the hospital. The patient being in the second stage of the disease, he applied the usual treatment, and she died at 10 o'clock. She was buried in the cemetery of the Holy Trinity church, at the foot of the Sixteenth street. Officers from the health department then visited Mrs. Finn, who said she had never seen Mrs. Corry since she had been taken to the hospital.
