SUMMARY OF NEWS.
CANADIAN.
 —Dr. Pelletier, of Levis, has been ap-
 pointing visiting physician to the immi-
 grants landing at Quebec.
 —A lad named Landy from Joliette
 was arrested by the police at Quebec on
 Wednesday for stealing a sum of money
 from a boarding-house.
 —Passengers arriving by the Grand
 Trunk Railway from the West yester-
 day report the ground covered with three
 inches of snow in the vicinity of
 Methow's Mills.
 —The Provincial Board of Health of
 Ontario have adopted a complete set of
 rules for the sanitation of schools, which
 will be issued by the Education Depart-
 ment for the guidance of school trustees
 and teachers.
 —Yesterday afternoon at Levis, a
 young lad named Pelchat, had one of his
 legs horribly crushed by a Quebec
 Central train. The unfortunate boy was
 indulging in the dangerous practice of
 endeavoring to steal a short ride by
 clinging to one of the cars as the train
 started. He is not expected to survive.
 —General Middleton and staff visited
 the warship *Caroline* at Victoria yester-
 day morning, and the proposed sites of
 fortifications, in a steam launch. The
 salute of thirteen guns was not fired un-
 til the General's departure from the ship.
 At the ninth gun the breech was blown
 out and struck Thomas Drury, a blue-
 jacket, blowing his right arm and leg
 and maiming his head from the body.
 Another blue-jacket, named William
 Langley, was struck and had both feet
 seriously injured.

EUROPEAN.
 —The Bank of England has advanced
 its rate of discount from four per cent.
 to five per cent.
 —An international congress will be
 held in Switzerland in 1889 to discuss the
 suppression of immoral literature.
 —In a speech at Inverness, on Wed-
 nesday, Lord Hartington said he saw no
 possible chance of a re-union with the
 Gladstonians.
 —The Communal Council of Rome
 yesterday adopted a resolution in ap-
 proval of the Emperor's visit as tending to
 knit the ties of friendship between Italy
 and Germany.
 —The Bechuana chiefs claiming that
 Lord Salisbury intends to annex their
 territory to Cape Colony, have sent a
 protest declaring that they will never
 submit. They desire British protection,
 but wish to remain separate from Cape
 Colony.

A rumour was flying about London
 yesterday that at an early hour a watch-
 man followed a man and woman into a
 dark alley in Whitechapel and then gave
 the alarm, whereupon the man turned
 and stabbed the watchman with a knife,
 killing him. The police arrived and cap-
 tured the murderer. No confirmation of
 the story is given at present hours.
 —The *Vossische Zeitung* thinks the de-
 cree is rather directed against Italians.
 While admitting that the decree is a sign
 of weakness in the French Government,
 which gives way to the Chauvinism of
 the masses, it says Germany has no right
 to complain, as the decree simply
 enacts what has been a long time in
 force in Germany.
 —The *North German Gazette*, referring
 to the French decree regarding immi-
 gration, recommends Germans hence-
 forth to avoid living in France. It says:
 "Every German who crosses the French
 frontier will understand that he has re-
 moved from culture to barbarism, and
 he has no right to complain if he comes
 into disreputable contact with national
 customs and instincts."

AMERICAN.
 —Prairie fires are raging in various
 parts of Dakota.
 —The Georgia State election took
 place yesterday. The Democratic State
 ticket had no opposition.
 —On Wednesday afternoon, in Chicago,
 a young man named Clark, an employe
 of the Thomson-Houston Electric Com-
 pany, was instantly killed by an electric
 shock from a wire.
 —The following notice was issued yester-
 day at San Francisco by Collector of
 Customs Hager: "No Chinese return
 certificates will hereafter be issued, and
 the Chinese bureau will remain closed to
 the public from this date."

Wheat Corners Rob the Poor.
 WASHINGTON, D.C., Oct. 4.—The bakers
 in this city have combined to raise the
 price of bread from five to six cents a
 loaf in consequence of the advance in the
 price of wheat.

WHAT REPUBLICANS WANT

Their Tariff Bill at Last Be-
 fore the Public.

Fiendish Murders by a
 Woman.
 A Blow at the Sauer Kraut
 Interest.

REPUBLICAN TARIFF BILL.

The Republican Mountain Has Been
 Blanking for Months and Now It
 Brings Forth a Little House of a
 Tariff Bill.
 WASHINGTON, Oct. 4.—The Republican
 tariff bill at last seen the light of day. It
 was reported by the Finance Committee
 to the Senate this morning, and Senator
 Sherman gave notice that he will call it
 up for debate on Monday. The reports are
 held back until to-morrow in order to
 give them a chance for more space in
 the newspapers than if they were made
 public at the same time with the
 bill. The measure falls rather
 flat here. Its main features have
 already been known and it is
 being little discussed even among the
 politicians. Nobody expects that it will
 ever be enacted into law. Senator
 Sherman characterized it truly when he said
 to-day that it is "a very Conservative
 bill." It may be said to be so conserva-
 tive as to lean over backwards. Its es-
 sential provisions, as already set forth in
 these despatches, are the reductions of
 sugar, tobacco and alcohol. Senator
 Sherman stated the figures in his speech
 to-day as \$27,000,000 on sugar, \$24,370,-
 000 on tobacco, \$6,428,000 on alcohol
 used in the arts, and \$8,100,-
 000 on other articles. These figures
 differ slightly from those made by other
 members of the committee, who figure
 the total reduction made by the bill at
 \$75,000,000. The bill has three merits:
 It is convenient in arrangement and pre-
 cise in terms; it makes reductions in the
 revenue which can for the most part be
 exactly calculated; and it has valuable
 administrative features. In its classifica-
 tions and definitions it approaches
 what its framers design to be—a model
 high tariff bill. Senator Sherman takes
 exception to the provisions regarding al-
 cohol used in the arts, however, and be-
 lieves that they will lead to frauds and
 revenue. The bill has another merit in
 Republican eyes. Most of its tariff fea-
 tures, except on sugar, conform to the
 demand of the Chicago platform for
 "such revision of the tariff laws as will
 tend to check importations of such articles
 as are produced by our people."

The Republican senators have not
 hesitated to raise the taxes on wool,
 woollens, hats and many other articles
 which enter into the daily service of the
 people, and they have ruthlessly applied
 the specific system of duties to the
 cheapest fabrics which go to make the
 clothing of the poor, thereby enhancing
 their cost enormously in proportion to
 that of more valuable fabrics charged
 the same specific rate. The bill is framed
 from beginning to end to catch the votes
 of the protected interests. At the last
 the committee even yielded to the de-
 mand of the cigar manufacturers that
 the tax on cigars be retained, although
 they have reduced it from \$4 to \$1.50
 per thousand.

A brilliant programme has been out-
 lined for the Republican Senators now
 that their tariff bill has been reported. It
 is to shut their mouths, close their eyes
 and pass the bill next week. A Republi-
 can Senator said tonight that his party
 would be ready to vote when the bill
 was called up on Monday, and he doubt-
 ed if even Senator Allison would take
 time to say anything. Other Re-
 publicans say that there may be
 some amendments to the bill
 by Messrs. Allison, Aldrich and a few
 other Senators, and that then the re-
 sponsibility of further delay will be
 thrown upon the Democrats. If this
 plan can be carried out, all Democratic
 amendments will be silently voted down,
 the bill will pass the Senate by a party
 vote, and the House will be brought face
 to face, three weeks before election, with
 the problem of how to meet the Republi-
 can measure. There will be a hasty
 gathering of Democratic representa-
 tives from the four quarters
 of the Union to make a quarrel,
 and the members of the ways
 and means committee will have to
 suddenly cancel campaign engagements
 to attend to their duties here. It would
 be a measure to retrieve the Republican
 position to pass a bill and send it over
 to the House, and there is little doubt
 that this will be attempted. The plan may
 fall through the desire of the Senate
 Democrats to debate the bill, but then
 they will be charged with having pre-
 vented its passage. The fact that Sen-
 ator Sherman made his speech to-day be-
 cause of his intended absence next week
 indicates that the Republican Senate
 is in earnest in this programme and
 that they have not been advised by Matt
 Quay in vain.

A SHE FIEND.

Burns Her Two Step-children to Death.
 CLEVELAND, Oct. 4.—Mrs. Mary Garrett,
 convicted of burning her two idiotic step-
 children to death was sentenced to-day
 to be hanged on Jan. 24, 1889. Motion
 for a new trial was denied. The crime
 was most brutal. She shut up two
 grown up weak-minded step-children in
 a room, saturated the room with coal oil
 and setting it on fire, both were burned
 to death. The condemned woman has a
 babe eight weeks old, which will accom-
 pany her to the penitentiary where she
 will be hung.

LATEST THING OUT IN TRUSTS.

Farmers in Northwestern Ohio Combine
 to Secure Five Cents a Head for
 Cabbage.
 FINDLAY, O., Oct. 4.—The cabbage-
 growers in the neighbourhood of Weston,
 Wood County, who grow large quantities
 of this vegetable for the Findlay, Toledo
 and Cleveland markets, have organized a
 trust which embraces all the large cab-
 bage-growers, who refuse to sell that
 product, which has yielded immensely
 this year, for less than five cents a head
 in the field. The trust controls the en-
 tire cabbage product of Northwestern
 Ohio.

**Reports Current in Germany that the
 Kaiser's Life is Threatened.**

LONDON, Oct. 4.—South German news-
 papers report that the German police
 have been warned of an anarchist plot
 against the Emperor William, and that
 the plans for his journey have been
 altered in consequence.

GENUINE MAN AND DOG FIGHT.

The Bull Dog Gets the Worst of It.
 COLUMBUS, Ga., Oct. 4.—A negro named
 Springer, living in the country near here,
 was attacked by a mad bull dog to-day,
 and discharged at his throat, but he
 threw up his arm, which the dog caught,
 tearing the flesh to the bone. Then
 followed a fight for life that lasted half
 an hour, but Springer finally choked the
 dog to death. He is badly torn and
 hydrophobia is expected.

JACKSONVILLE STILL HOPEFUL.

Only One Death Yesterday—225 Patients
 Discharged Cured.
 JACKSONVILLE, Oct. 3.—The day has
 been dreadfully warm. The mercury
 went up to 87° at noon. This was good
 weather for convalescents, and fully 225
 were discharged to-day. The situation
 is decidedly more hopeful. The board
 of health reports 75 new cases of
 yellow fever for the twenty-four hours
 ending at 6 p.m. to-day, and only one
 death. Total number of cases, 2,971;
 total deaths, 71. Mr. Martin, editor of
 the *Times-Union*, turns out to be a genu-
 ine case of yellow fever, though he is
 doing well.

A DELIGHTFUL MOUTHFUL.

A Town of Lake Men Deliberately Bites
 Off a Companion's Ear.
 CHICAGO, Oct. 4.—Charles Waring, of
 No. 516 Rock street, is minus an ear, and
 Steve Murphy is locked up at the Town
 of Lake Station charged with biting off
 the member. The men board at the
 same house and two weeks ago got into
 a quarrel at the Stock Yards, where they
 are employed, and during the fight Mur-
 phy seized Waring and jabbered lib-
 erally but the latter's right ear off.
 Officer Clancy witnessed the crime and
 immediately arrested the man. Waring
 was taken home. Dr. Miller was sum-
 moned and dressed the wound.

GEORGIA STATE ELECTION.

The Democratic Ticket has No Opposi-
 tion—Sam Small Defeated.
 ATLANTA, Ga., Oct. 4.—The Georgia
 State election took place to-day. A light
 vote was polled and the Democratic
 State ticket had no opposition. It is as
 follows:—Governor, John B. Gordon;
 secretary of state, C. B. Barre; trans-
 porter, R. U. Hardeman; comptroller, M.
 A. Wright; attorney-general, Clifford
 Anderson. In many counties independ-
 ent candidates for the Legislature ran,
 but indications point to the election of
 all the regulars. In the Atlanta
 senatorial district, Sam Small, the Re-
 publican, was defeated by F. B. Rice,
 Democrat, after a hot contest.

THE ASSASSIN STILL FREE.

Red Dog, the Murderer of Wain and
 Strong, Eludes Capture.
 RAWLINS, Wyo., Oct. 4.—Red Dog, the
 supposed murderer of S. Morris Wain
 and C. Livingston Strong, has not been
 apprehended, and is supposed to have
 escaped into Montana. Five different
 men have been arrested on suspicion and
 released after examination by the crim-
 inal court.
 A man answering to the name of D. H.
 Brazill is now under arrest, having been
 apprehended with property in his posses-
 sion answering the description of Wain's
 and Strong's. He is believed to be in-
 nocent of the crime, but is held to
 await further developments.

NOT AN AGE OF DICTATORS.

Judge Anthony Decides a Quarrel Be-
 tween Neighbours.
 CHICAGO, Oct. 4.—John Bailey is a
 wealthy teamster in Hyde Park; Frank
 A. Putnam is shipping clerk for Keith
 Bros. The men were neighbours and
 quarrelled. "Don't speak to me,"
 Bailey one day in 1885. Putnam refused
 to obey the command, and was knocked
 down. The quarrel was taken to a
 justice of the Peace, and then appealed.
 The judge ordered Judge Anthony heard
 the case and rendered judgment.
 "Bailey's words," he said, "were dicta-
 torial, and represent more those of the
 higher class of ancient times than those
 of a citizen of a free country. He had
 no right to command any man not to
 speak to him, and then he was a citizen
 who broke his command." It shows that
 Mr. Bailey is not possessed of all the
 qualities of a good citizen. The court
 will find for Mr. Putnam, and assess his
 damages at \$100." Mr. Bailey's attorney
 prayed an appeal.

AMERICAN INTERESTS IN SAHOA.

Germany is Likely to be Called to Ac-
 count.
 WASHINGTON, Oct. 4.—The "Samoan
 Question" has reached a point which
 makes its satisfactory settlement a mat-
 ter of very great concern to the United
 States. The most careful attention is
 now being paid to it by our Government.
 President Cleveland has recently taken
 hold of the subject, and there is reason
 to believe that it will soon be laid before
 the Cabinet for consideration. The re-
 cent course of Germany in seizing and
 occupying the Samoan Islands, and set-
 ting up an insurgent in his place, cer-
 tainly appears to be in flagrant viola-
 tion of the agreement between that
 Government and Great Britain and
 the United States, that the
 Samoan Islands shall not be disturbed. At last accounts
 the Samoans had revolted against the
 king set up by the Germans, and had
 him and his party cooped up in the cap-
 ital. It is easy to see that complications
 more serious than any that have gone
 before may follow the present situation,
 and there is a strong feeling here that
 it is time for the United States to take
 decisive steps towards curbing Germany's
 aggressions. The continued independ-
 ence and neutrality of the Samoan
 Islands is of high importance to this
 Government especially, because the
 islands will lie practically in the track
 of all vessels using either of the projected
 isthmian canals. Opinions are divided
 as to the best course for this Govern-
 ment to adopt, but from what can be
 learned in State Department circles, a
 move of some kind may be expected
 soon, and it will not be in the direction
 of consenting to any further aggressive
 violations of Germany's agreement.

Majority and Minority Reports.

WASHINGTON, October 4.—Both majority
 and minority reports on the Senate tariff
 bill were submitted to-day. The former
 reviews the House tariff bill in exten-
 sive and charges that it was prepared in
 the interest of free trade, and if adopted
 would ruin the interests of the entire
 country. The minority report defends
 the House bill, and alleges that even
 where the Senate substitute makes any
 reduction, it is in the interest of man-
 ufacturers and against the poor.

COMPLICATIONS IN CHINA.

The Celestial Government
 Getting Restless.

Dodging the Parnell Enquiry.

The "Times" Reserving It-
 self for the Edinburgh
 Trial.

JOHN BULL'S CHINA SHOP.

Serious Complications in the Celestial
 Empire.
 LONDON, Oct. 4.—Private advices from
 English merchants at Chinese ports show
 that the traders there do not regard the
 recent success of the British troops over
 the Tibetans as conducive to the glory
 or the interest of the mother country.
 The disciplined European soldiers have
 slaughtered a few hundred half-armed
 barbarians, thereby earning the undying
 hatred of the remainder of their country-
 men, and have also increased the Chinese
 by the discomfiture of their dependents.
 The victors have reported that com-
 plete proof has been obtained that hos-
 tilities were brought about by the machi-
 nations of the Government at Peking,
 and the English Cabinet is greatly vexed
 at the unnecessary disclosure. There is
 no doubt of the correctness of the accusa-
 tion, but the proclamation of it was a
 blunder which will probably cause the
 quiet shelving of at least one military
 dignitary.

England wants a great deal of China,
 and any interruption of the trade be-
 tween the two countries would bring ruin
 to many commercial houses in London;
 close dozens of cotton mills in the North,
 and bring about a clamour on Parliam-
 ent that would prove the downfall of
 the party responsible for it.
 On the other hand, in case of an open
 rupture the Chinese Government would
 be sustained in its efforts to stop the
 importation of English goods by the
 mass of the people whose hate of all
 foreigners includes, with a special detes-
 tation, British subjects, those living at
 the treaty ports being regarded as repre-
 sentatives of the entire nation.

The Chinese have played a cautious
 game as yet, not feeling sufficiently
 strong to openly defy the intruders who
 have coolly walked into and appropri-
 ated such territory as suited them at her
 best harbours, and abused her subjects
 abroad, but there is an increasing sus-
 picion that the Emperor is meditating
 the Empire think it is time that China
 asserted her rights to be treated with
 equal terms by the Western Powers.

The Celestials have been close students
 of all improvements in the military art
 of late years, and if they should resolve
 upon a policy of isolation they can, while
 existing without the products of other
 nations, defy all attempts to penetrate
 into the interior and by steadfast deter-
 mination force the negotiation of new
 treaties.

THE PARNELL INQUIRY.

Printing House Square Decides to Re-
 serve Its Forces for Edinburgh.
 LONDON, October 4.—It is reported that
 the *Times* has resolved that, as it has in-
 curred great expense in bringing wit-
 nesses to London to testify in O'Don-
 nell trial, and as it is ready to
 pursue the same course in con-
 nection with the trial of Mr. Parnell's
 suit against it for libel, which is to be
 tried in Scotland, it will not in-
 cur large expenses in appearing before
 the Parnell inquiry commission, but will
 simply supply evidence enough to justify
 the commission in summoning Mr.
 Parnell to the witness box and to compel
 him to show his hand. The *Times*, it is
 said, will furnish the commission with
 the names of other witnesses to testify.
 The Parnell indemnity fund has
 reached the sum of \$29,000.

FREDERICK'S DIARY.

Labouchere Says the Extracts Pub-
 lished are Garbled.
 LONDON, Oct. 4.—Emperor Frederick
 undoubtedly kept a daily journal, and it
 is now in the possession of his widow.
 But I fancy that while the published
 extracts are authentic, many others have
 been interpolated, and that there has
 been extensive garbling. So the diary
 may be regarded as not altogether genu-
 ine. It is inconceivable that the Emperor
 could cause a diary to be printed and
 privately circulated containing so many
 extracts calculated to seriously prejude-
 dice the cause of German unity and al-
 together damaging to German interests.
 Prince Bismarck is thoroughly justified
 in prosecuting the persons responsible
 for the publication, for they have cer-
 tainly been guilty of treason to the State,
 as nothing but mischief could result from
 the premature appearance of a portion of
 the late Emperor's diary. It is still
 worth publishing extracts cooked up with
 additions and suppressions, the former being
 of the most objectionable kind.

THE EMPERORS AT VIENNA.

Mutual Felicitations and Good Will.
 VIENNA, Oct. 4.—The Emperor of Aus-
 tria entertained Kaiser William at a
 state dinner this evening. He gave as a
 toast the health of his distinguished vis-
 itor, to which the latter replied in a speech
 replete with evidences of the most cor-
 dial feeling and good will, both on the
 part of himself and his people to-
 wards the Emperor and the Austrian
 people. He said: "I come, not as a
 stranger, since I have been the recipient
 of kindness from my host for many
 years. I am also fulfilling the sacred in-
 junctions of my grandfathers, thus
 seeking to cultivate friendly relations
 with Austria." After this Francis
 Joseph gave the toast, "The German
 Army," to which the Kaiser replied and
 gave "Our Comrades of the Austrian
 Army." There was great enthusiasm and
 an unusual amount of good-will exhib-
 ited.

MR. GRAHAM'S REPLY TO MR. BEAUFORT. To the Editor of THE HERALD: Sir,—Replying to Mr. Beaufort's proposal, I can have no objection whatever to leaving to the Rev. Jas. Barclay, if he has been asked and is willing to act in such a case, or any gentleman of like fairness, a decision of the question whether or not *La Patrie*, Mr. Beaufort's paper, has not been guilty of anti-English sentiment; also the question whether or not the *Star*, in its translations of paragraphs from *La Patrie*, has made substantially correct translations of the selections, etc.; if not to state in what respect they are incorrect. I published willingly and without a moment's hesitation, Mr. Beaufort's letter of denunciation, and I repeat that it is not sufficient, I repeat an old offer that the *Star's* columns are always open to him to any reasonable extent, so that he need have no unnecessary fear about getting before the English people. I have sent to Mr. Beaufort a deposit of \$100, one hundred dollars to cover Mr. Beaufort's and that Mr. Beaufort may have the benefit of the doubt, I now authorize the arbitrator who may be appointed to declare my deposit forfeited to the hospitals if it is found that *La Patrie* has not been guilty of making appeals to the race prejudice, and this without letting technicalities or niceties of language operate against it or in my defence. It will of course be necessary to draw up a proposition which I am ready to sign on information from Mr. Barclay, that he is prepared to act. I will leave the duty of seeing the proposed arbitrator to Mr. Beaufort, himself. As there might be some question of translation involved, it will be proper that a translator for each side and a third for the arbitrator should be present as well as the managing editors of the two papers concerned and any others Mr. Beaufort may choose. As the whole question in dispute is whether or not Mr. Beaufort's paper appealed to race prejudice, I repeat that it will be proper for the arbitration to decide against me if they find it has not made such appeals, and to go further I authorize the arbitrator to point out the exact mistakes in translation in the *Star's* columns if any.

LABOUR HURT BY PROTECTION. Wonderful Experience of the English Operatives at Thornton.

PROVIDENCE, R. I., Oct. 4.—One of the prominent examples of the "beneficent operation of a protective tariff" which was made much of by high tariff advocates at the time of its establishment late in 1884, was the history of the establishment of Thornton, a suburb of this city, which was represented as having moved capital, plant and operatives from Nottingham, England, in order to enjoy the privileges of a high tariff. Very little has been heard about it since, and from protection theorists and admirers made upon the ground would seem to reveal as the cause that they have discovered the brain with which the doll is stuffed.

These concerns were started with a considerable flourish of trumpets, and Thornton was blazoned forth as a model manufacturing place. Before the English operatives had been here very long it began to dawn upon them, before their contracts expired, that as there was a difference in the wages here and England, so there was also a difference in the cost of living. Still they were not really dissatisfied, but after a while their manager informed them that a reduction of wages would be necessary for the mill could not compete in the market while such high prices were being paid for labour. Gradually they found their wages descending to the level paid in England, and as it was costing considerably more to live here the bright prospects of prosperity they had pictured in their fancy, that the tariff controlled labour's price, began to fade, and many of them returned to England. Their places were filled with fresh importations of operatives from the old country, and a constant coming and going of help and workmen has been the history of the first year of the mill's existence until very few of the original party remain.

Over 300 who came to Rhode Island to better their fortunes under the beneficent provision of American protection, now half have gone back to England disgusted with the protective system, which they have found protects the manufacturers but not the workmen.

These operatives are an intelligent lot, and they will go through the prices paid in the different departments and the differing rates and contrast them with current prices paid in Nottingham and living rates in the old country, and give figures which are ample authority for the statement that the American workers are a trifle worse off under protection than the English operative under free trade. The hours of labour are bad, being divided into day and night shifts, and while the contracts called for 5 per cent. for night the protective tariff does not sufficiently brace up the market to afford the extra price. The families are lodged in furnished cottages owned by the company, and by the time the furniture is paid for the family has begun saving money to return to England.

One of the operatives when asked what he thought of the protective tariff, said: "It's a grand good thing for the manufacturer. The manager at Thornton soon moved from his cottage to a fine house, and under protection though he had to cut our wages, he is prospering so well that before four years have passed he has built a wing on the mill as large as the old mill was, and is putting in very costly machinery, which will double the product. Yes, it is a good thing for the manufacturer; but while he is building new mills and getting rich I have worked these four years here and have not earned enough above the cost of living to own the furniture in my own house."

DESERVED HEN FOR GAMBRINUS. Martin Judge Made His Love Wait Until Morning. To become a bride.

New York, October 4.—It was with a sad heart and eyelids heavy with weeping that Sarah Burke, of No. 451 East Sixteenth street, entered the Twentieth street station house late Tuesday night and asked Sergeant Lynch to send a policeman with her to find her intended husband, Martin Judge, who, she said, was kept a prisoner by his sister.

"To-night was to be my wedding night," she said, "and oh, what made them keep my boy away from me?" The tears flowed down her cheeks and she was a picture of distress.

The Sergeant's heart was touched, but he saw a possible five or ten days' fine if he interfered, so he advised Sarah to go home and wait and perhaps Martin would make his appearance in the morning.

Sally she did go, but oh! what a sad awakening awaited Sarah. Martin, instead of being imprisoned by his sister, had gone off early in the evening to prepare for the ceremony. He looked upon later here, and when the time set for the marriage arrived, Martin

was at his sister's home, dallying with Gambrinus and Morphine. Early yesterday morning everything was set right, for as soon as Martin had awakened and dressed he hurried to the home of his betrothed and at once repaired the wrong. A visit was made to the house of Father O'Callaghan, and in a few moments both were joined in the bonds of matrimony, the witnesses being two servants of the priest.

FALLER MAY NOW LAND. Assistant Secretary Maynard So Advised in the Detained Socialist's Case.

WASHINGTON, Oct. 4.—Assistant Secretary of the Treasury Maynard wrote a letter to Collector Magone to-day in regard to the case of Oscar Fallier, the emigrant from Belgium, who is detained at Castle Garden on the ground that he is a convict. Mr. Maynard reviews the evidence in the case and concludes as follows: "While there are some things in the case which tend to the conclusion that the immigrant is liable to deportation under our laws, yet in view of the grave doubts which exist in regard to the material questions involved, and in a case where the personal liberty of the individual is at stake, it would seem to be proper to permit Fallier to land. It is suggested that such course be taken."

In addition to the facts already submitted, ex-Judge Gedney, Fallier's counsel, yesterday received through the Belgian Consul here a telegram from the Belgian Minister of Justice, touching Fallier's alleged banishment. Here is a translation of the message: "Fallier was not condemned to banishment. The law of May 31, 1888, does not provide banishment."

Le Baron, Minister of Justice. One of the points raised by Judge Gedney in his arguments before the Collector of the Port was that the Minister of Justice had no right under the decree to banish Fallier from Belgium.

Pastor Wins the \$25,000 Prize. PARIS, Oct. 4.—Prof. Pasteur has received advice from Sydney, N.S.W., to the effect that his method for the extermination of rabbits has been tried experimentally on Rhode Island, in Port Jackson Harbour, and has proved a perfect success. It will be remembered that the Australian Government offered a prize of \$25,000 for the discovery of a remedy against the rabbit plague.

WHITECHAPEL MURDERS.

A Variety of New York Theories About the Outrages.

He Must Be a Lunatic.

And Dr. Hamilton Thinks He May Live

In the Aristocratic West End

[New York Herald.]

And now New York has become a great whispering gallery since the latest news about the Whitechapel butcheries. These awful crimes are becoming the general topic of conversation. You hear it at home, you hear it in the street cars and on the ferryboats. Lawyers, detectives, judges and doctors wrangle over theories. All agree in denouncing the London police.

Put who and what is the murderer? Is he an injured man who seeks revenge upon the low women of the slums? Is he a religious fanatic who thinks he has a divine mission to decrease the social evil by slaughter? Is he a raging madman who chuckles night and day over the details of his bloody deeds? Or is he a man who slays his victims under a sudden and uncontrollable homicidal impulse, and is then tortured by remorse till another frenzy drives him forth again to seek blood?

These are the questions that ring in one's ears almost every hour. The knowledge that the assassin is still at large, and that he may be and is almost certain to repeat his crimes, has created a public excitement even in the metropolis of America that is not hard to account for.

THE MURDERER IS A LUNATIC. "Can conceive of these crimes being done only by an insane person," said Dr. Allan McLean Hamilton, the well known alienist, "and they were very probably committed by a man belonging to a class of insane persons known as perverses. It is a form of insanity manifested by a variety of impulsive desires to do mischief, such as to destroy property and cut and mutilate. With this condition is associated a homicidal tendency and a state of sexual aberration. It is a form of mental disease that leads to peculiar impulsive acts, such as cutting off women's hair, or the use of acid, or the use of vitriol and other destructive substances. The very pleasure of the act is the motive for it. The homicidal acts are nearly always connected with mutilations of the corpse or very dramatic surroundings. There are cases on record where women have been enticed into caves and mutilated in a disgusting way, the same marks being present that are found in the Whitechapel murders.

Two or three years ago a man named De Bourke was arrested through a Fourth-street attack and cutting people. That was a case of the kind I refer to. "These men are usually sane on all other subjects. They belong to the class of monomanias. It is generally a congenital state existing from birth. They are mentally in some respects like a certain class of depraved men who are stigmatized by society."

"Do you think, doctor, that these Whitechapel murders are the result of a desire for revenge on the class to which the victims belong?" "I do not. A prominent physician advanced that theory to me to-day, but it does not strike me as probable. Assuming the correct account of the facts, there are some things about these murders that indicate the kind of insanity I have mentioned. The regularity of the acts and the peculiarity of the mutilation point strongly in this direction."

A MENTAL PORTRAIT OF THE MONSTER. "Assuming the murderer to be a madman, what is his probable mental condition?" "Oh, he is probably reading the newspaper account of the murders and enjoying it, going all over the crimes again in his imagination. But he may belong to another class of lunatics who have awful spells of remorse, and who only kill when the impulse seizes them. He may suffer great mental anguish. There is another class of lunatics whose lust is excited by the personal peculiarities of their victims who will be seized with a fury on seeing a woman with a peculiar kind of hair or a peculiar figure. In these Whitechapel cases there are strong signs of sexual aberration in the manner of mutilation. I think the murderer will do a great deal more killing. The more he gives way to his passion the more pleasure it is likely to give him. His mental condition at the time he sheds his victim's blood is one of extreme exhilaration. There are authentic instances where this insanity is accompanied by a cannibalistic instinct, where the murderer drinks the blood. These madmen generally devour the bodies of their victims or commit fancy, picturesque crimes. Some men are not liable to do such things."

"Doctor, you have spoken as though you assumed the murderer to be a man; might it not have been a woman?" "It is very, very improbable. Women who suffer from the form of insanity that the defilement of these bodies indicates do not commit homicide; men who suffer from it do."

DOES HE LIVE IN THE WEST END. "If you were looking for the Whitechapel butcher what kind of a man would you expect?"

"He belongs very likely to either one of two classes. He is either a low, coarse sort of idiot or an intensely refined, over-educated man, who has degenerated into a condition of ultra sensuality. He may be a common laborer, or may be a man from the west end of London. I should not be at all surprised to hear that he is a man living in an aristocratic part of the city who secludes himself all day and goes out at night to gratify his strange and horrible desires. He is likely a man who is eccentric in his dress or has the insane physiognomy. Every human being has during his or her life some insane or morbid appetite. It may be a flash or it may be a permanent disease. This is unquestionably an extreme case."

"What I fear, sir, is that this man is probably a lunatic who has become epileptic by butchering may become epileptic. You know we had an epidemic of clothes tearing in Paris, and every one is familiar with the frequent epidemics of suicide."

DR. SPITZKA'S THEORY. Dr. Edward C. Spitzka, who is known far and wide as a tireless and advanced investigator of mental diseases, also believes that if the cabled stories of the Whitechapel murders are true, the murderer is probably a man of

version, what the old French writers called instinctive monomania," he said. "It is so the murderer is just as cunning and deliberate in his crimes as an able, sane man would be in doing so. It is not in the nature of a madman to be in the habit of perpetrating his lawless deeds. This London murderer shows skill, daring and the power to conceal his crimes. It is usually the particular thing on which the madman stresses that betrays his insanity, and the fact that this murderer has cut out and taken away the same part of each body shows his mania. In Berlin for instance there was a young man who had a mania for cutting women's breasts. There was also a German professor whose insatiable perversion led him to throw vitriol on dresses. He derived a pleasure from the act itself. There are several well known cases in which men had an insatiable passion for throwing down women and taking away their shoes. One of these men used to sit in his room and stroke himself with these shoes.

THEY LOVE TO SEE BLOOD RUN. "The way I account for the Whitechapel cases is this:—The two fundamental passions of all animals is the sexual passion and hunger for food. One covers the species and the other preserves the individual. They often intervene. Many persons have a desire to bite those for whom they have an affection. There is a much larger number of persons than you dream of who, if they could take a knife and cut and scarify (not kill) and see the blood run, would experience great delight. In my book on insanity I quote the confession of one of the class of instinctive butchers, who said:—

"I first opened her chest and divided the fleshy parts of her body with a knife. Then I dressed this person as a butcher dresses cattle and chopped her body into pieces, so as to get them into a hole which I had dug on the mountain. I felt so ravenous that I trembled and cut out and ate a piece."

"So far we cannot say that these persons are of unsound mind. It is simply a higher sexual fury. But as soon as it becomes a matter of method and not of the instinct, it becomes a matter of butchery and the suspicion is that we have to deal with a very cunning and lucid madman."

HERE'S A PLAN TO CATCH THE ASSASSIN. "How would you search for the man?" "If the police of London go to all the dives in the Whitechapel district and find out what men had strange desires they might be able to trace the monster. I think I know another good plan."

"What is it, doctor?" "I would dress stout hearted men in women's clothes and send them with concealed arms to protect the neck and the rest of the body. These men could loiter about so as to invite the approach and attack of the assassin."

"You suppose he manages to cut the throats of these men?" "I think I know another good plan."

"Do you think he enjoys the notoriety which the newspapers are giving the cases?" "Very likely that does not affect him at all. He enjoys reading the details of the crime and the corpses looked, but probably has no lawless ideas. If this man is like the other cases we know of, he will be remarkably careless when brought face to face with the enormity of his deeds. He will recognize as an abstract idea that it was not right, but there will be no inward conviction. As a member of society, he may express regret, but his conscience will not trouble him. He will very likely possess in a faint degree the moral qualities of Dr. Jekyll and Mr. Hyde. I should not be surprised if he was similar to the man who committed these crimes by reading Mr. Stevenson's morbid and unhealthy story, which is likely to have a bad effect upon a previously morbid mind. I have had in New York a case of this dual nature and sent him to the asylum. He confessed to me his horrible craving: 'When I walk in the street,' he said, 'I feel as if I could cut the flesh of the people I see.' He was certainly one of the most singular looking persons I have ever seen. The expression of his countenance was indescribable; in ordinary language it would be spoken of as at once repulsive, comical and weird. This effect was heightened by involuntary grimaces, resembling vacant smiles or sarcastic grins. Occasionally an expression of intense loathing would pervade his countenance; in the next moment it would look almost childishly open and appealing. His gait was sliding and swift—he appeared to pass along without steps, and I could not resist the impulse to ask him to step on my foot. Such a state of affairs in New York city would be simply impossible. The first offence might have remained undetected, although I scarcely think even that, but in less than a week after the second murder the criminal would have been run down. The London police, it seems, have simply held up their hands in horror with each successive murder and simply waited for the next one. morbid appetites in Rome and pronounced of the persons insane." "When overgratified he may be beside himself. What will be the probable effect of a continued exemption from detection upon the brute who is terrorizing Whitechapel? Will he grow bolder?" "He may, and yet it is not impossible that this man may suddenly subside and be heard of no more. He may become overgratified. He very likely has exhausted himself till he is capable of no other form of pleasure, and from too great indulgence may become even incapable of that. In Westphalia three or four years ago a man killed thirteen innocent country girls and defiled their bodies by mutilation to gratify the same extraordinary passion of fury that has in all likelihood inspired the Whitechapel crimes. They were all stabbed in the back in the same way. He was arrested, and no one has ever discovered who he was. He was satisfied."

LAWYER HOWE THINKS IT IS A LUNATIC. Of all the criminal lawyers in New York who have studied the motives and methods of murderers, William F. Howe is probably the most experienced and astute. He has set up the plea of insanity in homicide cases ten times as often as any other explanation of crime.

"I believe that the Whitechapel murderer is a man who has become insane from brooding over some wrong done to him by one of the class to which his victims belong," he said. "There are all about these crimes the signs of a madman. All the authorities—Fabre, Esquirol, Trousseau, Bucknill and Take, Mandley, Gray, Balfour Brown and the others—will give you such cases. The New York police could very soon locate this man."

"What is my theory?" said Recorder Smyth. "I have none except that the heads of the London police must be five feet thick all around the neck. The murderer must have been bathed in blood. They cannot for a moment be compared with the New York police."

"My idea," said Police Justice White, "is that these crimes are being committed by a maniac. It is possible that a sane man would kill so many women and mutilate them all in the same way. But it seems to me that whoever did these murders must have been going when he left his victims. How it is that the London police do not track and understand. Seven such murders in succession would be impossible in this city. Inspector Byrnes would have had the man locked up long ago. All this simply goes to show us what a well policed city we live in."

Warden Osborne of the Tombs said that from his experience in the Randall's Island Insane Asylum and then in the county prisons he was satisfied that there was in the circumstances of the Whitechapel murders evidence that the criminal was a lunatic. Such acts, he said, were never committed by sane men.

SOME MEDICAL CRANK. Mr. Robert W. Todd, of No. 229 Broadway, who is considered an authority on criminal matters, was inclined to the belief that the Whitechapel murders were committed by some medical crank, whose morbid anatomical ideas led him to commit these fiendish deeds with the view of increasing his stock of surgical knowledge.

"If this man is sane," said Mr. W. J. A. Fuller, of No. 229 Broadway, "he must reveal himself. Sooner or later remorse must overtake him and he will seek to escape mainly from himself, leaving no refuge from confession but suicide, and suicide will no doubt be the confession by which he will identify himself."

"The man is unquestionably a lunatic," said ex-Governor Leon Abbott. "It seems to me that some lunatic who considers himself wronged by some one uses this means as an indirect revenge upon those whom he thinks have wronged him."

"I can only say of the matter," said Judge Martin, of the Court of General Sessions, "what, no doubt, most people say in regard to it, and that is that it is the work of some crank."

Said Assistant District Attorney Semple:—"Some man, evidently the victim of a fanaticism amounting to insanity, has committed these fiendish assaults, and I think that this theory would be corroborated and supported by the fact that he appears to operate by a system. The difficulty of apprehending this man arises, no doubt, from the fact that his character is such as to place him above suspicion. No criminal would or could do such work, nor could he have been detected in such a number of crimes committed within so short a space of time."

"PERHAPS IT IS A WOMAN. "This person," said Mr. A. W. Case, a merchant, of No. 194 Duane street, "is always referred to as 'he' the man; it is absolutely impossible that these deeds might have been committed by a woman? Some woman, perhaps, with a fancied wrong against her sex seeking this means of revenge."

"I suppose you know," said Assistant District Attorney Lindley, "that in the early part of this century there existed in London a person whom they called 'The Terror.' This man, it seems, was the same species of crank as the Whitechapel fiend, only not so dangerous. His mania was to cut ladies' dresses, and would way richly dressed women and slash their dresses into shreds, and always managed to make his escape."

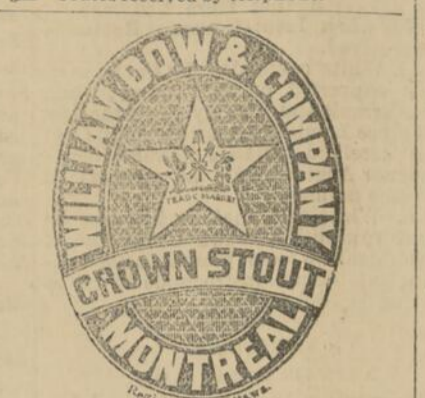
