LETTERS OF RESIGNATION FROM MEMBERS OF BOARD OF COMMERCE MADE PUBLIC

Sugar Order Merely Implemented Undertaking Of Former Commissioners To Which No Exception Was Taken At Time—Full Responsibility Accepted By All Three.

Ottawa, Ont., Oct. 26.—(Canadian Press).—The letters of resignation of the members of the Board of Commerce, together with the Order-in-Council accepting those resignations and providing that no further appointments should be made pending the result of the appeal now before the Judicial Committee of the Privy Council were made public this afternoon. In his letter of resignation Captain Wm. White, the Chief Commissioner, declares that in passing the sugar order the Board merely implemented the undertaking of the former Commissioners. In view of the present price conditions he expresses serious doubts as to the ability of the Board of Commerce to fulfill any useful purpose in the future.

F. A. Acland, in his letter of resignation, accepts his full share of responsibility for the action taken, while Major G. A. Dillon, the third member of the Board, expresses himself as being in agreement with his colleagues on the Board.

Captain White's letter to Premier Meighen is as follows: With respect to part II. of the "Combinés and Fair Prices Act 1919," which has to do with profit control, I have for some time past had this aspect of the Board's activities under my consideration. The jurisdiction of the Board in this respect has been repeatedly questioned and in view of the divergence of opinion of the judges of the Supreme Court, it is apparently open to grave doubt. It has been brought prominently before the public attention as a result of the recission by Council of the recent sugar order on the advice of the Minister of Justice, on the ground that the Board lacked jurisdiction to make it. As this order for the most part followed along the lines of similar orders by the former Commissioners, it is possible that many of these are invalid for the same reason.

"Further, it may still be considered a moot point whether prices can be equitably and effectively regulated by such a board in normal times which we are now approaching, or whether it is not better to leave them to be adjusted by the economic law of supply and demand. I do not wish to be understood as stating that the Board has not served a useful purpose in the past; such was far from being the case, for example, apart from investigations and control, it served as a very salutary deterrent to profiteers, but I have serious doubts of the ability of the Board to fulfill any useful purpose in the future.

"Furthermore, while it would be rash to speak with any degree of precision, it is possible that the upward trend of prices has come to an end, and if such should be the case, the usefulness of the Board will so far as profit control is concerned, be almost extinguished.

"As the sugar order above mentioned has been the subject of so much public criticism, I would ask before closing to be permitted to point out on behalf of my fellow-commissioners and myself that in passing the above order we merely implemented the undertaking of the then Commissioners, such undertaking being set out in an order on the 11th day of June last, to which no exception was taken and which reads as follows:

"The Board will not recognize prices based on replacement values on a rising market. It will be its duty in good time and it hopes to do so carefully protect the trader on a falling market by permitting him to average his costs down as it must now carefully protect the consumer in compelling the trader to average his costs up."

"It will prohibit all refiners from selling to other than wholesalers, it will prohibit wholesalers from buying from other than refiners, it will prohibit speculators from buying or selling at all."

would, in my opinion, serve that purpose, eg., a single judge with right of appeal to a superior court. "Entertaining the views expressed, I feel it my duty to forward them to you, and I, at the same time, beg to tender my resignation as Chief Commissioner."

The order referred to in Captain White's letter, and from which quotations are made, was issued on June 11, 1920, in the case of Durocher and Gosselin on complaint for sugar profiteering by the then Commissioners, W. F. O'Connor, K.C., and James Murdoch.

Mr. Acland's letter of resignation, addressed to Senator Robertson, Minister of Labor, stated that he had accepted the place on the Board with some reluctance, because of pressure of Departmental work. He had asked on more than one occasion to be relieved of these duties.

With regard to the sugar order Mr. Acland said he desired to accept his full share of responsibility for the action taken. It was taken, he says, without instructions or suggestions from the Government or from any member of the Government.

The Order-in-Council making permanent the suspension of the sugar order covers practically the same ground as the official announcement from the Prime Minister's office. The Government disavows, however, with the contentions of the Acting-Commissioners that the order "followed along the line of similar orders, by the former Commissioners, and it is possible that many of these are invalid for the same reason."

"This is not in accordance," says the order-in-Council, "with the understanding of the Minister of Justice, who has not had brought to his attention any previous order of the Board, the purpose of which was to enhance or maintain prices, and it was the fact that the said order relating to sugar was intended to have the effect of enhancing or maintaining prices that in the judgment of the Minister made that order unquestionably ultra vires of the Board."

WOULD START UNIVERSITY WITH SMOKING ROOM Montreal, Que., Oct. 26.—Professor Stephen Leacock, of McGill University, to-night addressed the members of the McGill Literary and Debating Society at the opening of their season, heralded by an inaugural dinner at the McGill Union.

"If I had my way," said Prof. Leacock, "I would start a university with the establishment of a smoking room. Then I would establish a reading room, then a dormitory and, last of all, the ordinary equipment of class rooms and professors."

Of all adjuncts to university life, nothing, in his view, ranked higher than a good literary and debating society.

SUGAR STILL FALLS. Vancouver, B.C., Oct. 26.—Another drop in the wholesale price of sugar of \$1.00 per hundred pounds to \$17.00 was announced here this morning by the British Columbia Sugar Refinery.

St. John, N. B., Oct. 26.—A cut of \$1.40 a hundred pounds in the price of sugar was made by wholesalers and jobbers in the city late yesterday, bringing the wholesale price to \$18 a hundred pounds.

PRINCE PAUL IS OFFERED THRONE

Youngest Brother Of Late Greek King To Succeed Him.

Athens Oct. 26.—The throne of Greece, made vacant by the death of King Alexander, will be offered to Prince Paul, third son of former King Constantine, it is officially announced.

The funeral of the late King Alexander will take place Friday afternoon. The Chamber of Deputies will be convened Thursday.

The Greek Cabinet assembled immediately after the death of King Alexander last evening and drew up a message to the people expressing the grief felt at the monarch's death and adding:

"In conformity with the Constitutional order of succession the youngest brother of King Alexander, Prince Paul, is called to succeed him. However in view of his absence and the relations existing between the nation and the House of Ex-King Constantine, the Government has decided, in conformity with Article Fifty of the Constitution, to convene the Chamber just adjourned to proceed to the election of a regent until the arrival of the new King."

"Meanwhile, and until the oath is administered to the regent in compliance with the same article of the Constitution, the royal and Constitutional powers will be exercised by the Council of Ministers."

The Cabinet decided that King Alexander's body shall lie in state Wednesday.

France Agrees. Paris, Oct. 26.—At the Foreign Office it was stated today that the French Government is quite in agreement with the policy of Premier Venizelos in offering the Greek throne to Prince Paul as he is logical, as well as the dynastic successor to the late King Alexander, owing to the elimination of former King Constantine and Prince George, who is also Duke of Sparta, from the succession.

The French Government, it was stated, is convinced that the alternative of a foreign prince is not realizable, owing to the fact that no foreign prince is available, as those available will not accept. The French policy will be that of watchful waiting, it was added, and as the French Government does not anticipate any menacing move from Constantine, it will not take any action unless the latter should attempt to return to Greece when "it would take such measures as it deemed proper to prevent the return of Constantine to the throne."

Lucerne, Switzerland, Oct. 26.—Former King Constantine of Greece burst into tears today upon learning of the death of his second son, King Alexander of Greece, news of which was received last night, although it was withheld from the deposed monarch until this morning. The former King has not seen his son in several years.

Many telegrams and letters of condolence have been received at the Hotel National, where the ex-King and his family are staying.

Prince Paul was non-committal when asked, recently by a newspaper correspondent whether he would accept the Greek Throne in the event of the death of his brother, then still living.

"I will leave matters in the hands of my father," he replied.

It is understood that the marriage of Prince George, Duke of Sparta, and eldest son of former King Constantine to Princess Elizabeth of Rumania, has been indefinitely postponed.

HON. A. MEIGHEN GIVEN WELCOME AT MOOSE JAW

Calder Says He Is Completely Changed Mentally And Politically.

NOT AN AUTOCRAT. Premier Discusses The Sugar Order Of Defunct Board Of Commerce.

Moose Jaw, Sask., Oct. 26.—(By Can. Press).—The Right Hon. Arthur Meighen, Premier of Canada, and Hon. J. A. Calder, Minister of Immigration, addressed in the Armories here tonight, their second audience in their Western tour, which opened at Winnipeg the previous evening.

Mr. Calder, speaking in his own constituency, which elected him to Parliament as a Union candidate, dealt frankly with the tariff question, which featured also the Prime Minister's address.

The meeting was opened with upwards of 4,000 men and women present. Mr. Calder, speaking first, said he was to give a "straight political talk." He said the old political lines had been shattered and men and women should not get back to the old rut. He declared that in these strenuous days no man remained in public life because he sought power or salary or for any other reason than to render public service. No field of work was so nerve-wrecking.

Mr. Calder emphasized his statement that he had never regretted his stand for Union Government.

"I am," said Mr. Calder, "an entirely different man mentally and politically from the man I was when I appeared before you three years ago. No man could have gone these years without change. I went down to Ottawa a Liberal, having lived among Western Liberals all my life, and I found the Eastern brand of Liberalism entirely different from that to which I was accustomed. I found that the Cabinet whom I had looked upon as Liberals, were what we had called Tories and I found men whom I had thought old-crusted Tories were as Liberal in their sentiments as I was."

Mr. Calder quoted demands for an election made by Hon. W. L. Mackenzie-King and declared that Liberal Candidates had been missing at most of the recent by-elections.

"To my mind," he said, "Liberal members of the House are the last people in the world to want an election."

The new Franchise Act was denounced by the speaker as a "Canadian ever had." The Minister asked Mr. King to be more explicit as to details in his quoted statement at Regina, that a Minister of the Crown had proposed to split an unnamed riding to make a safe seat.

"I have been claimed," continued Mr. Calder, "that I have become a Tory. Well, I have not, and don't intend to."

"What are you?" shouted someone in the audience.

"There is one thing I am not, and that is Mackenzie-King Liberal. On the other hand, I am a Liberal and was good a Liberal as I ever was."

"I am inclined to think," continued Mr. Calder, "that many of the farmers have been badly advised and badly led, and I am inclined to think that when the time comes many thousands of them will refuse to follow those who are attempting to lead them at the present time. They have created a class movement (cries of "No, no") that is bad for themselves and bad for Canada as a whole."

The Minister then dealt with the tariff policy.

"I stand," he said, "on the tariff plank in the policy adopted by the National Liberal and Conservative Party. If that plank is carried out in the spirit in which it was conceived it will, in my judgment, be the best policy for Canada."

He denied that the Prime Minister was a high protectionist in any sense of the term.

"Do I believe," he continued, "in free trade? I say no. More than that, you don't. You may, theoretically, but Canada cannot continue to exist industrially unless she has a tariff. (Cheers.)"

"I don't believe in high protection. I believe in tariff for revenue. I believe in a tariff for protection of Canadian industries. You cannot have a tariff for revenue without it being at the same time a tariff that gives protection. I don't believe in the tariff plank in the Farmers' platform. I consider it too extreme."

Mr. Calder appealed to moderate public opinion to seek the middle ground between the extreme views of free trade and high protection, and to defer final judgment until the tariff had been brought down next session.

WAS VANDERLIP HARDING'S AGENT?

U.S. Commissioner At Regina So Advises Secretary Colby —Direct Denial.

Washington, D. C., Oct. 26.—Secretary of State Colby announced today that Commissioner Young, at Regina, had informed the United States State Department that D. Vanderlip, of California, who recently obtained concessions in Siberia was reported to have told Nikolai Lenine, Russian Bolshevik Premier, that he represented Senator Harding, the Republican presidential candidate.

The Commissioner's despatch dated October 20, said Lenine had informed H. G. Wells, a British writer, that Mr. Vanderlip had made certain proposals to the Soviet Government at Moscow looking to the recognition of the Bolshevik Government by the United States.

Dispatches from London yesterday said that Mr. Vanderlip had reached an extensive agreement with the Russian Soviet authorities by which an organization of Western States financiers acquired a sixty year lease on a vast tract in Northern Siberia, opposite Alaska, with exclusive rights to develop coal oil and fisheries.

Commissioner Young's despatch stated that Mr. Vanderlip also was negotiating for concessions about Kamchatka, Siberia.

Earlier in the day State Department officials on the basis of the London despatches said that since the United States had not recognized the Bolshevik Government, no contract entered into by its officers would be regarded by the United States Government as binding.

It was pointed out that the Department's announced attitude toward concessions granted by the Bolshevik authorities was first signed on April 25, 1919, in a warning to United States business men and repeated on July 27, 1920.

Harding Denies. Marion, Ohio, Oct. 26.—Direct denial was made by Senator Harding today of reports reaching the United States State Department that Washington Vanderlip was acting as his agent in Russia.

"I have never heard of Mr. Vanderlip," said the Senator. "He is not my agent, and I have no agent. I know absolutely nothing about any such matter as is discussed in these despatches and have no interest in it whatever."

The Republican nominee declined to make any other statement regarding the Vanderlip story or to comment specifically on the reported negotiations relating to possible American recognition of the Soviet Government of Russia. He said he considered his denial broad enough to make his position entirely clear and serve notice to every one concerned that he was not a party to any of Vanderlip's reported activities.

Soviet Confirmation. New York, N.Y., Oct. 26.—A cable message received today at the Russian Soviet Government Bureau here, confirmed the report that Washington D. Vanderlip, of California, representing a syndicate of Coast Coast capitalists, had concluded an agreement with the Russian Soviet Government for the development of the natural resources of North-Eastern Siberia.

The message signed by George Tchitcherine, Commissioner for Foreign Affairs at Moscow, was addressed to Ludvig C. A. K. Marten, representative of the Soviet Government in the United States.

The message said negotiations are successfully whereby this syndicate will become "our fiscal agents in the United States, financing purchases up to \$50,000,000; all purchases to be made through your office."

Sugar were lower in Canada than in the United States. The Board of Commerce was constituted by Parliament and there was interference by the Government. When prices of raw sugar dropped, the refiners sought assistance from the Board of Commerce, but the Government held that there was no authority for the Board's order, suspended the order after it had existed twelve hours, and wiped it out in a hearing lasting twenty eight minutes.

"In no country," said Mr. Meighen, "have big interests been taxed as in Canada."

The Premier endorsed Mr. Calder's views on tariff, which, he said, were the honest views of 75 per cent. of the members of the Canadian House of Commons. He was glad to say he believed in protection and expressed his disbelief in free trade.

Mr. Meighen declared that Mr. Mackenzie-King had advocated "free fruit," but had supported a candidate in Yale, because, in whose platform, was a clause favoring a duty on fruit which would be high enough to prevent dumping.

"Political vandals," commented the Premier. "Mr. King wants two platforms," he continued, "as against that the Government presents one platform and we all stand on it."

"When the contest comes I intend to appeal, and to direct my chief efforts to the rural communities of the country."

The speaker forbade dissent in an attempt by the Farmer or any other class to say that a line of policy was good for them and then seek power to put it into effect. "The worst thing that can happen is occupational division."

WHEAT MADE A SUDDEN ASCENT

Offerings Fell Off On Account Of Southwestern "Farmers' Strike."

Chicago, Oct. 26.—Wheat prices made a sudden ascent today and trade authorities ascribed as one of the reasons a falling off in offerings from the southwest apparently due to the "farmers' strike." An extensive advance of 10 3/4 cents a bushel took place. December delivery touched 210 3/4 as against 199 1/2 to 199 3/4 at yesterday's finish.

The "strike" or stoppage of selling by farmers was announced some time ago by officials of the United States Wheat Growers Association as against the continued cutting down of prices until it was cented by the farmer that it was below the cost of production. Yesterday was the day set for the strike to begin but no action had been taken it was said.

Strike Notice. Wichita, Kansas, Oct. 26.—The United States Wheat Growers Association, with a membership of seventy thousand in Kansas, Oklahoma, Texas, Nebraska and South Dakota issued a proclamation from its office here on October 9 urging all its members to refrain from selling wheat after 3 p. m. October 25 until such time as the price of good wheat is increased to \$3.00 a bushel at growers' terminal markets. The proclamation sets forth that the wheat growers' expenses for labor and equipment were the highest in average in ten years and that with reduced prices for wheat the farmer stood to lose half his investment.

Kansas Joins In. Topeka, Kansas, Oct. 26.—Farmers' organizations throughout Kansas generally have adopted resolutions favoring holding back their wheat until they can get a "fair price" for it. This week's official crop report by the State Board of Agriculture mentioned that wheat shipments were slow. Farmers' organizations have set from \$2.70 to \$3.00 as a "fair price." Grain dealers say the volume of wheat now moving to market is less than a fourth the amount normally shipped at this time of the year. However, car shortage is officially reported and it also has been instrumental in preventing shipments.

The afternoon was filled in with a visit to the Robin Hood Mills and Gordon Ironsides plant, an address to the college students, while at 4:15 the Premier gave a public address to the women in the Public Library.

A reception to Mrs. Meighen by the ladies of Moose Jaw was also held from 4 to 6, which was very largely attended.

It was a charming little bungalow of five rooms and bath, nestled in the palms and blossoms of a California garden. There were two small boys of school age, and a real story-book husband, too, who loved the little family and worked hard to provide every necessity and some of the luxuries, too. But the wife— She looked old for her years. She grumbled at her housework — in fact, she was always grumbling, for she was always doing housework. And the trouble? Well, Mrs. Jones just lacked that glorious thing we call system. She poo-pooed the idea of doing a particular task at a definite time. But when Mrs. Jones "broke" and her sister came to take charge there was a vast change in that household. And the sister stayed long enough to show Mrs. Jones "the way to leisure, through system."

Leisure time—a certain amount is the birthright of every individual. Upon what we do with our leisure time frequently depends the health and advancement not only of the individual but of the community as well. And so it is the duty of every housewife to so arrange her household that there shall come to her leisure time. Mrs. Jones began her day by nerve straining hustle to get breakfast. She arose early enough, but even at that she had so much to do that it required much hurrying to accomplish it if she were to get the family out in time. And just how did her sister change this? Sister planned a simple breakfast to begin with. One breakfast might have consisted of apple sauce, oatmeal, toast and cocoa. The apple sauce was prepared the day before while she had to be at the cook stove watching something else. It was set aside ready to be dished at a moment's notice. The oatmeal was put into the fireless cooker and was nicely cooked when the family arose in the morning. The bread was cut and trimmed and placed on plates ready to be shipped into the broiler of the gas range and toasted next morning. The table was set and covered. And this arrangement allowed the housewife to sleep at least one hour longer than she had been sleeping each morning and still gave the family a simple, nourishing breakfast before they left home. Sister requested the children and the husband to throw back the bed covers so that the beds might air thoroughly until the appointed time for making them. By 8.30 in the morning she was ready to wash dishes. For this task she allowed one hour. But she had more than the breakfast dishes to wash. She stored the dishes from luncheon and evening dinner of the previous day in a zinc-lined covered box under the drain board of the sink. By this system she washed dishes intensely, just once each day, and devoted a full hour to the performance. Next the living room was put into order and the beds made. By 11 o'clock she was ready for the market. Luncheon, consisting of left-overs usually plus a warm milk soup or drink, was on the table by 12.30. The dishes were scraped and stacked in the box. From one o'clock until two thirty, she arranged some particular task for each day. One day it might be a thorough cleaning of the bathroom or one of the bedrooms. From 1.30 until 5, until it was time to begin preparations for dinner, in general she was free. And she kept this time free from household duties. This time allowed for enjoying the sunshine or for leisurely tub bathing or the witnessing of a motion picture or a visit or the developing of some talent.

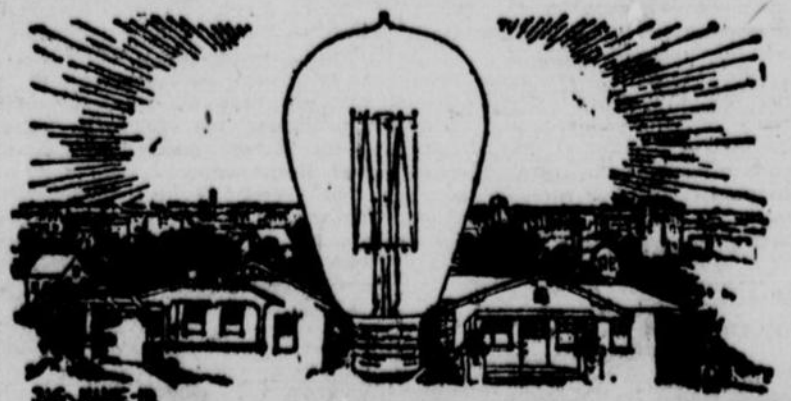

HALFPENNY IS STILL MATTER OF CONCERN

To Certain Classes in London —To Introduce New Nickel Coin?

London, Oct. 26.—(By Canadian Press) — The elusive halfpenny is still a matter of much concern to travellers, booking clerks and conductors of omnibuses and tramcars alike, and the necessity for the introduction of a nickel three-halfpenny coin is still exercising the public mind. Although the inconvenience that was felt earlier in the month has to some extent been detected. Moreover, it resists abrasion,

more rapid distribution of the halfpenny, difficulties still frequently arise.

In most countries of the world copper nickel is used for small currency. Pure nickel was first employed by the Swiss government in 1881, and before the war it had been adopted by various other countries, including Austria-Hungary, Denmark, France, Germany, Italy, Montenegro, Mexico, Turkey and Spain. When war broke out there were nearly 8,000,000 pure nickel coins in Austria-Hungary and they proved of great value to the Central Powers in the manufacture of munitions their supply from Canada being cut off. Nickel has several advantages. It has a bright and pleasing appearance; and as it is subject to magnetic attractions counterfeit coins can be readily detected. Moreover, it resists abrasion,

a source of considerable loss to the states in the case of other metals; and it is peculiarly resistant to oxidation. It takes the impress of the die with a distinctness unapproachable by any other metal less costly than silver.

CHILDREN LOST LIVES

MAY ABANDON HUNGER STRIKE

As Protest After Present Experiments Involving Remaining Cork Strikers.

London, Oct. 26.—Deputy Lord Mayor O'Callaghan, of Cork, informed the Associated Press this afternoon that it was his personal view that the hunger strike as a weapon of protest would be abandoned after the present experiments involving the remaining Cork hunger strikers.

He declared, however, that the spirit of Irishmen is no more broken than that of Lord Mayor MacSwiney and the determination of Ireland for complete independence was never more earnest than now.

"The United States, by a formal protest to Great Britain," said he, "could obtain justice for Ireland, and until she does that we consider her protestations of little value."

The police guard at Brixton Prison was again increased today. The total number of the guard there is unknown as most of the troops are kept under cover, but there is a considerable garrison inside the gates.

Sinn Feiners who arrived from Cork and other parts of Ireland for the obsequies went to Brixton Prison in little parties throughout the day to see where the Lord Mayor had died. They were all wearing Sinn Fein colors draped with mourning.

Deputy Lord Mayor O'Callaghan and other members of the Sinn Fein Corporation visited the prison this afternoon and were granted permission to view MacSwiney's body.

Funeral Sunday. Dublin, Oct. 26.—The funeral of the late Terence MacSwiney will probably take place Sunday. The Sinn Feiners are arranging for a monster demonstration along the whole course of the railway between Dublin and Cork while the train bearing the body passes.

Cardinal To Precede. Baltimore, Md., Oct. 26.—Cardinal Gibbons is expected to preside at a 30-minute Requiem Mass for Lord Mayor MacSwiney, of Cork, at St. Cathedral at 10:30 a.m. next Wednesday.

The service was arranged today by representatives of local Irish societies who conferred with Cardinal Gibbons at his residence. The names of Michael Fitzgerald and Joseph Murphy, two Irish hunger strikers who died in Cork jail, also will be remembered in the prayers.

RESIGNED FROM TRADE COMMISSION

Ottawa, Ont., Oct. 26.—(By Can. Press)—The resignation of J. H. Wilkie, as a member of the Canadian Trade Commission, has been placed in the hands of Sir George Foster, Minister of Trade and Commerce, and Mr. Wilkie will finish his duties with the commission at the end of this month. From that time on there will only be a staff of about half a dozen remaining to conduct the contracts still on hand, and it is expected that they will be occupied until about the end of the year.

U.S. STEEL HAS DECLARED DIVIDEND

New York, Oct. 26.—The U.S. Steel Corporation at its quarterly meeting here today declared regular dividends of 1-1/2 percent on its common and 1-3/4 percent on its preferred stocks.

AFTERMATH OF DRY REFERENDUM

Quebec Provincial Law To Be Amended Next Session Of Legislature.

Montreal, Que., Oct. 26.—Inter-viewed today, D. R. Murphy, K.C., the general administrator of the Prohibition Law in this Province, stated that changes in the law will be made in the next session of the Provincial Legislature with a view to the better carrying out of the law.

It is regarded as likely that this is the last year of the licensed vendors system which is generally admitted to be working out badly, says a writer in the Montreal Gazette. The Quebec Government, he states, is averse to going into the liquor business and there may be changes involving the handing over of licenses to hotel men of proven high reputation.

In the meantime the law is being strictly enforced as it stands, many business men found out today that the obtaining of liquor meant the furnishing of a doctor's prescription, a formality with which the majority were wont to dispense.

In connection with the prohibition law two important appointments will be announced from Quebec tomorrow. These are Dr. J. A. Quintal, of Maisonneuve, and Dr. Larue of Quebec City. These two, with Mr. Murphy, will form a board for the due enforcement of the law.

Bone-Dry Canada

Toronto, Ont., Oct. 26.—That the "dry" victories in the Western Provinces and Nova Scotia are a definite pronouncement by the people of Canada for a bone-dry Dominion and a demand for Federal action to bring about that end, was the opinion expressed by Rev. Ben Spence, Secretary of the Dominion Alliance, when interviewed today.

"It is an indication clear and unmistakable that the people of Canada not only want the provincial legislatures to exercise their powers but want the Federal authorities to act. It must be remembered that this is a Federal vote, although taken by the Provinces and the resultant action will be Federal Action. This, then, is not the latest shot in the provincial campaign in the various provinces, but rather the first broadside in the nation-wide battle."

Conflicting Views

Winnipeg, Man., Oct. 26.—Official statements concerning yesterday's referendum given out today by wet and dry forces conflict in interpreting the meaning of the vote. Rev. Thomas Neville, leader of the Manitoba Campaign for dry forces, declared the vote clearly indicates a desire on the part of the majority voters for absolute bone-dry conditions.

Dr. A. Grant, Chief Executive of the Dominion Prohibition Party, declared to be another step in the direction of Dominion-wide bone-dryness. R. T. Ferguson, representative of Canadian liquor interests here claimed that the Manitoba Government now has a mandate to hold another referendum permitting the electorate to say exactly what it does want, by way of liquor legislation.

Special consideration for Winnipeg as regards Provincial liquor legislation in view of the heavy wet majority may be asked for in the next session, Mr. Ferguson intimated.

Will Assume Control

Edmonton, Alta., Oct. 26.—The Alberta Government will now, as a result of Monday's vote, assume full control of and responsibility for the administration of the liquor laws within the Province. New legislation will be introduced into the session of the Legislature in the way it is expected, of amendments to the present liquor law, but just what will be the nature of these changes in the law has not yet been determined.

Premier Stewart, when asked today for a statement of what his Government would do in the matter, said that no policy had been decided upon and that the entire question would have to be dealt with in Cabinet before making any public announcement. He stated, however, that the question would be brought up in the early stages of the Legislature.

With the issue decided beyond all doubt on the side of prohibition in later-Provincial liquor traffic, full official returns of the referendum taken in Alberta, Monday, will not likely be available for two or three days. Approximately 75,000 people voted on the question in the Province as nearly as can be ascertained from the complete records and the dry majority will be somewhere between 12,000 and 15,000, if the polls yet to be heard from maintain the average prohibitory margin established by the representative centers already reported.

"The result is in no way a surprise to me," Premier Stewart stated today "for I fully expected to see the people of this Province stand out for the control of the liquor problem within our boundaries."

When pressed as to whether or not he regarded the majority in the Province sufficient to warrant the enactment of bone-dry laws, the Premier said he was not prepared to make a statement on the matter at the moment. First of all he pointed out the vote would have to be analyzed when full returns were available.

Regina, Sask., Oct. 26.—With scores of country polls still to be heard from, Saskatchewan's majority against the importation of liquor is now slightly more than 10,000. As

ANOTHER DAY OF DEADLOCK

Strike Conferences Abruptly Adjourned Till Today—Are In Critical Stage.

London, Oct. 26.—Another day has passed without a settlement of the strike. Unexpected difficulties apparently are being met and it seems almost impossible that the miners could resume until next week if a settlement were reached.

After the day's conferences, a Cabinet Council was held at six o'clock. At 7:30 the conference between the Government, the miners and mine-owners, was resumed at the Premier's residence in Downing Street. This was followed at eight o'clock by another Cabinet Council for which it was announced that negotiations were adjourned until noon tomorrow.

The strike conferences were abruptly adjourned. Negotiations as it was stated, are now in a critical stage.

Emergency Bill

The House of Commons tonight was occupied in passing the emergency bill through all stages after the second reading.

The emergency bill provides for all contingencies arising in the United Kingdom should be miners' strike involve the railway and transport workers.

In consequence of the strong opposition met in the Committee stage last night, the bill has been considerably modified. Parliament must be summoned within five instead of fourteen days, after the proclamation of an emergency, and any regulations made under the bill will be valid only for seven, instead of fourteen days, unless they receive the sanction of both Houses of Parliament.

Further, the proclamation of an emergency shall be in force for only one month, when if the Government considers that the emergency still exists, a new proclamation must be issued.

An Opposition amendment proposing to limit operation of the bill for one year pending a review of the whole position was rejected by a vote of 300 to 70.

NEARLY FIFTY THOUSAND TROOPS IN IRELAND

Emphatic Denial Given To Allegations Of Flogging Outrages By Military.

London, Oct. 26.—(Can. Associated Press)—In reply to questions in the House of Commons to-night it was stated that there are 49,000 troops in Ireland at the present moment.

An emphatic denial was given to allegations of flogging outrages in Ireland by the military. Newspaper photographs representing such incidents were unhesitatingly denounced as fakes.

Barracks Attacked. Enniscliffen, Ireland, Oct. 26.—The police barracks at Tempo was attacked by Sinn Feiners yesterday. The attack was repulsed. One sergeant is reported to have been wounded and one Sinn Feiner killed and another wounded.

Tallow, County Waterford, Ireland, Oct. 26.—One hundred men last night attacked the Tallow barracks, but were repulsed after a strenuous fight. The casualties, if there were any, have not been reported.

NECESSITY OF MORE ACCURATE INFORMATION

Winnipeg, Oct. 26.—(By Canadian Press)—Dr. J. A. Allan, of the Alberta University, who was the chief speaker at this morning's session of the second annual western convention of the Canadian Institute of Mining and Metallurgy. The necessity for more accurate information on Canada's mineral resources was emphasized by Dr. Allan. He declared that accurate information was required with reference to Alberta because that province was on the verge of what might be the greatest oil boom that ever occurred in this continent.

The prospects were most promising. Dr. Allan said, for the occurrence of a large producing oil field in the Far North and that already a rush of oil seekers were preparing to strike north as soon as the ice was thick enough for traveling. The great problem for the immediate future to be solved was that of transportation.

SEVERAL TREATIES TO BE SIGNED

London, Oct. 26.—(Canadian Associated Press)—Several treaties in which Canada is interested are due for signature early in November. The continued absence of the Canadian High Commissioner, Sir George Pailey, has created speculation as to who will sign them on behalf of the Dominion, but it is anticipated Sir George Foster, Minister of Trade and Commerce, will then be here on his way to the League of Nations conference at Geneva which will do the signing.

CRITICISM OF HANNA'S ORDER

Law-Making Bodies May Be Composed Of Employing Classes Alone.

Ottawa, Ont., Oct. 26.—(By Can. Press)—The law-making bodies of Canada would be in danger of being composed of the employing classes only should President D. B. Hanna order to the effect that Canadian National Railway employees must keep out of politics as adhered to was the opinion expressed tonight by L. G. Pelletier, Canadian Deputy-President of the Order of Railway Conductors. Mr. Pelletier remarked that the effect of Mr. Hanna's order has been to throw the "so-called Government Railways into, instead of out of politics."

"I feel," Mr. Pelletier added, "that the action is a vicious one and that its establishment would be a dangerous precedent. While the C. N. R. Railways are nationally owned, a holding company, as it were, was created by Parliament and the Board of Directors are largely in relation to politics, in the same position as the Board of Directors of any privately owned railway, or at least this is the claim that has been set up."

Mr. Pelletier remarked that Parliament has established the quality of citizenship and Parliament and the law and not the Board of Directors of the C.N.R. or any other corporation are supreme or ought to be supreme in Canada. In other words, the rights C. N. R. employees have acquired under the law cannot be taken away by Mr. Hanna or anybody else.

"No stipulation as to political activity," said Mr. Pelletier, "was made when the employees entered the service, and if there had been such a stipulation it would have been, it appears to me, ultra vires of the law. This action if Mr. Hanna's is permitted and if it is adopted by other corporations and employers, our law-making bodies all over the country will ultimately be composed of employees only. This is vicious class-conscience action. I believe that the Federal Government should protect its own laws and the rights of its citizens by advising the C.N.R. Board of Directors that they have transgressed the law by putting conditions above it, and that they should be made to climb down again where they belong. No body of men, however, should be allowed to overstep the Government or the law, by being a law unto themselves."

Mr. Pelletier referred to the interview given by Mr. Hanna in the West. He said that the present action was but a revival of the old Canadian Northern policy and noted that Mr. Hanna had put forward the claim that the management had a clear understanding in regard to the matter in dispute.

"But he does not say," remarked Mr. Pelletier, "that the employees had a clear understanding of any such policy. When was such a policy given publicity and when was it enforced?"

Touching on Mr. Hanna's references to Parliamentary honors and party affiliations, Mr. Pelletier said that some may be ungenerous enough to assume that he has the Labor Party in mind, and that by Parliament he means the Federal Parliament. They might assume that this is but the forerunner of other steps, in other directions to control or curtail the anticipated efforts of labor to secure representation in the next Federal Parliament.

Mr. Pelletier said he believed Mr. Hanna to be an honorable man and he did not charge that he had ulterior motives but he thought his action to be ill-advised. Instead of improving the morale of the Government Railway employees it is likely to have an opposite effect.

"Mr. Hanna," he said, "would be well advised to retrace his steps in this matter, which is a glaring contrast to the liberal and far-sighted policy they pursued in years gone by and to present by the Canadian Pacific Railway Company."

COALS TO NEWCASTLE

New York, Oct. 26.—(Carrying coals to Newcastle) is no longer a mere figure of speech, according to J. W. Forgie, an exporter of that city, who arrived here today on the steamer Saxonia. Already, because of the British miners' strike, a shipload has been sent to Newcastle from China and until more coal is imported into the famous coal center, the fuel will be rationed, Mr. Forgie predicted, adding that the supply assumed against the strike will last only six weeks.

CO-OPERATIVE BANK RECEIVES ITS CHARTER

Cleveland, Ohio, Oct. 26.—The Brotherhood of Locomotive Engineers Co-operative National Bank of Cleveland, today received its charter from the Comptroller and will open its doors for business November 1. This, it is said, is the first Labor Bank and the first co-operative commercial bank in the United States. The capital of the bank is \$1,000,000 with a paid in surplus of \$100,000. The stock is owned exclusively by the Brotherhood and its members and was subscribed in excess of \$300,000 despite the fact that the annual dividends are limited to ten percent.

WHISKEY RUNNERS' ACTIVITIES DENIED

Spokane, Wash., Oct. 26.—Denial that whiskey runners from across the Canadian line are interfering with the movement of freight over the Spokane international road or that armed guards have been sent to protect freight cars from their attacks was made here today by E. L. Carle, Traffic Manager of the road.

SENATOR PRINCE DEAD

Baskinboro, Sask., Oct. 26.—Senator Joseph B. Prince, of Baskinboro, died here today of a second paralytic stroke.

OTTAWA GREETS GENERAL BOOTH

Salvation Army Head Warmly Received At Capital Yesterday Morning.

Ottawa, Ont., Oct. 26.—General Bramwell Booth, head of the Salvation Army, arrived in Ottawa early this morning. After Government and civic welcome had been extended to him this morning and at the city hall, General Booth received ovation. Few public men arriving in Ottawa in the last decade have received as enthusiastic a cheer.

General Booth's first official visitor this morning was Right Hon. Sir Geo. Foster, representing the Prime Minister, who is absent in the West. Sir George was received by General Booth in his room in the Chateau Laurier and there Sir George conveyed to him the greetings and good wishes of the Canadian Government.

At 11:45 the General and his staff, escorted by the massed Salvation Army bands of the city, proceeded to the City Hall, where Mayor Fisher met him on the steps and escorted him to the Council Chamber where the Mayor and General Booth both spoke.

With the general are the following high Salvation Army officers: Commissioner David C. Lamb, Chief of Army Immigration Work; Staff Captain John Smith, Commissioner Lawley, all of London; Brig. Tuley of India, and the General's personal secretary, Colonel Robert Perry, editor of the War Cry.

General Booth spoke tonight in Dominion Methodist Church, under the chairmanship of His Excellency the Duke of Devonshire and attracted an audience such as has rarely been brought together in Ottawa.

At 7:30 although the meeting did not commence till 8, every seat in the church was occupied and hundreds were left outside. Special police and number of Salvationists took their places at the door and refused further admission. At five minutes to eight, when the General arrived, the crowd outside must have numbered as many as those inside. The streets were filled from sidewalk to sidewalk with a cheering struggling mob.

General Booth saw that this was an over-riding meeting and standing on the steps of his car, he addressed a few words to the crowd, thanking them for their cordial cheers for him and the Army he represented.

PROPERTY OF THREE RIVERS SHIPYARDS

French Company Claims Steel Tanker—Contested By The Molson's Bank.

Montreal, Que., Oct. 26.—Hearing was commenced today in the Superior Court at one of the series of motions which have been presented under the Dominion Winding Up Act by claimants for possession of property in the Three Rivers Shipyards, Limited, in liquidation.

The whole of today's proceedings were taken up by the claim of La Societe Navale, of Versailles, France for possession of a 5,000 ton steel tanker. This ship is nearly completed and \$600,000 has been spent on it. It was pointed out that if the work on the vessel were rushed, the ship could be finished at an early date but if left untouched it would be likely to deteriorate badly when the ice breaks up next spring.

The claim is contested by the Molson's Bank which claims to have a mortgage on all the assets of the Three Rivers Company.

There are several other claims to be heard, including one by the French Government which seeks possession of five steel barges. The barges are nearing completion.

DRUG CLERK IS SHOT BY THIEF

Two Bullets Extracted But Plucky Old Man's Condition Serious.

Montreal, Oct. 26.—Louis A. Hoerner, 70 years of age, for many years the head clerk in Tremble's drug store, situated on the corner of Crescent and St. Catherine Streets, was this morning shot and seriously wounded in a struggle with an unknown man, who had entered the store with the intention of robbing it.

The shooting occurred at about six thirty this morning when a young man, evidently about 20 years old, entered Tremble's and order Hoerner to throw up his hands. This the latter refused to do and in the struggle that followed the gun went off, wounding him seriously in the abdomen. The thief immediately bolted, while the old man just managed to telephone the police before collapsing.

The condition of Louis Antoine Hoerner, 63 years of age, of 2266 Esplanade Avenue, who was shot in the abdomen and back by a man so far unknown to the police in the Tremble Drug Store, corner of St. Catherine and Crescent streets, this morning, was reported to be serious at the Montreal General Hospital. The victim had been operated on during the day and both bullets had been removed. His name was placed on the danger list, however, and it is thought that there is not much chance for his recovery.

HAS CONFESSED TO CHICONE SHOOTING

Toronto Star Quotes Alleged Statement Of Jail Farm Prisoner.

Toronto, Ont., Oct. 26.—The Toronto Star publishes this story today: "A prisoner undergoing a sentence for forgery at the Burwash Jail Farm recently made a confession that he had been connected with the shooting of Police Constable Chicone of Montreal in July last when the constable was killed while attempting the arrest of robbers. A religious meeting was being held at Burwash under the supervision of the Salvation Army about two weeks ago. The meeting had concluded, the prisoners dismissed to their section of the jail, when the man approached the Salvation Army officer and made his confession. Although he had not done his shoot-

ing the man stated he had been in the group effecting the robbery and disclosed the name of the man who had actually done the shooting. "The man wanted for the shooting was located in prison in Vancouver also undergoing a sentence for robbery. Both men were recently taken to Montreal, where they will appear tomorrow in the police court."

WILL BE HERE NOVEMBER 11

Tariff Commission Resumes Its Travels Monday, Proceeding To Charlottetown.

Ottawa, Oct. 26.—The Tariff Commission resumes its travels on Monday. It will proceed direct to Charlottetown, where it will sit on November 4, and then come to Nova Scotia and New Brunswick, then to Quebec. Commenting tonight on the Commission, said that from the different representations made before the Commission during its Western trip it was obvious that the new direct methods of taxation had evoked considerable interest, particularly the income tax and its enforcement.

In this connection, Sir Henry made public a hitherto unpublished tabulation showing in what proportion income tax was assessed last year on income derived in 1918, among different occupations. The tabulations show that 20,445 mechanics were assessed for income tax last year. Their assessments did not amount to more than 1.4 percent of the whole income tax assessment, although mechanics constituted 20.5 percent of the total number of income tax payers.

Agriculturists numbered 6,492 their assessments being 2.2 percent of the whole. Manufacturers assessed numbered 931. "It is to be noted," Sir Henry remarked, "that in addition to paying taxes under the income tax Act, corporations also paid taxes under the Special War Revenue and Business Profits Tax Acts, which, in the last fiscal year, amounted to \$46,223,254. The Eastern itinerary of the Commission is as follows: Charlottetown P.E.I., Thursday, November 4; Sydney, N.S., November 6; Halifax, November 8; St. John, N.B., November 9; Moncton, November 10; Quebec, November 11; Sherbrooke, November 13; Three Rivers, November 13; Montreal, November 15.

PASSPORTS AVAILABLE

London, Oct. 26.—(Can. Ass'd Press)—The Can. Ass'd Press is informed that the Colonial Secretary, acting on the proposal of Gen. Smuts has arranged that British passports shall be available for any part of the British Dominions within two years of issue without further endorsement.

AN UNEXPECTED DISCOVERY

Even before the war Canadians hunting for causes of and remedies for the high cost of living were accustomed to point to the exodus from the farms to the cities as a prime factor and to urge the undertaking of a back-to-the-land campaign by way of corrective.

Now this popular belief has received a rude shock for no less an authority than the farm Journal published by the Agricultural Department of this Province tells us that recent investigations carried out in the United States, far from showing that in the rural districts the death-rate of both children and adults is considerably lower than in the cities, have proven the reverse to be true, so far as the children are concerned at any rate.

There is something discouraging about such an unexpected discovery but it must be self-evident that the fault, whatever it is, resides with the upbringing of the children and not with the country atmosphere and environment that are known to be infinitely more salubrious than city surroundings.

Mr. F. T. Meredith, Secretary of Agriculture for the United States, in a recent pronouncement, cautioned the people against encouraging any back-to-the-land ideas injudiciously pointing out that as soon as population in the cities gets to such proportion that it will demand more food than the present number of farmers can supply, there will be larger prices for farm products and a natural increase in the proportion of farmers—a sane back-to-land movement.

It seems to the Editor of the Provincial Journal that we should have data upon which to base an opinion before advising anyone to stay on the land or in any other position for that matter if he thinks he sees greater prospects for his future in some other place. What we need, in his opinion, is good sound figures on the profitability of farming such as can only be obtained through efficient farm surveys.

"Think not that we are lacking in loyalty to the great rural community," he asserts, "in throwing these few thoughts into the discussion. We are whole heartedly and enthusiastically for the country and the country life. But it is not loyalty in a physician to close his eyes to symptoms of disease in a friend—the true loyalty will make him want to diagnose carefully the extent of the disease so that it may be successfully treated. And in like manner we would like to see these economic, hygienic and educational problems probed. We would like to have definite data before preferring advice on a back-to-the-land or a stay-on-the-farm policy, and having found out definitely how things lie we shall then know how to set about to correct these conditions that may now be driving men from this, the oldest and most honorable occupation in the world."

COL. BURNHAM AGAIN

Not long ago reference was made in these columns to the fate of Col. Fred E. Burnham, of Winnipeg, President of the Canadian War Hospital Fund, who was supposed to have been expelled from Montenegro by the Serbian authorities. The Serbian Consul at Montreal, Capt. Seferovitch, had made an official denial, asserting that Col. Burnham had left the country of his own free will, but the Chronicle was able to show by means of letters written personally by the latter and transmitted to us by the Montenegrin Consul General, Mr. J. Eugene Corvieux, that the facts hardly bore out such an interpretation of the undoubted departure.

More recently the Montreal Star has published a letter received by the sister of a well-known Montreal journalist from Mrs. Burnham which throws further light upon present conditions in the Balkans. This plucky Canadian woman writes as follows:

"Since Col. Burnham left wrote to you, things have been going from bad to worse, and the Powers are 'fiddling' while this small nation is going down to death. The strangle-hold the Serbs have on Montenegro is being tightened, and when the veil is lifted, there will be found a condition of affairs that will make the stoutest heart quail, and people will ask why we allow this?"

"After the organization of this Fund, Fred (Col. Burnham) came from Canada with enthusiasm for Serbia, but has since turned from her with loathing and disgust. The 'reign of terror' is almost complete. It is no longer possible for the population to earn a living except those in the Serbian employ. People are in dire distress and many—particularly women—are losing their reason. This I know personally and the women of Montenegro who are imprisoned, starved and flogged, cry out for justice. Col. Burnham was told a few days ago that no foreign missions were needed now, as Serbia has abundance of money, medicines and supplies. If she has, the Montenegrins are no benefitting by it. The majority have not a second garment to their backs, and many express a doubt that death will come soon; all this in spite of the fact that the Premier of the British Empire acknowledged to a delegation of prominent men that 'Serbia had no

right in Montenegro," and that he also knew of the atrocities. Why is this? Fred (Col. Burnham) has been threatened with assassination because of his sympathies with these poor stricken people, forsaken by the powers who claimed they were fighting for small nations.

"We know the entire Mission is in danger, but the flag still flies, for when we go we know the key will be turned in the lock in this part of the country, and God alone knows what the atrocities will be. They will not allow anyone to leave the country, not even women or children, and why? Because they are afraid of what they will tell."

If this is not sufficient to satisfy our readers as to the circumstances under which a Canadian citizen engaged in humanitarian work was driven out of an allied State, they will hardly be able to read unmoved the eloquent farewell to Montenegro penned by Col. Burnham on the eve of his departure for Albania, and published at the time by Italian and Slovak newspapers. It is a document well worthy of so dramatic an occasion and the Dominion should feel proud of one of her sons capable of producing it. Thus it runs:

"To His Majesty King Nicholas, son of Nyegosh, the father of his people; to Her Majesty Queen Milena, the adored of his people; and to all true hearted Montenegrins now refugees from their native land, I bring you tears and greetings from the Land of Cragora.

"With you I have shared the exultation of success, and the anguish of retreat. With you I have suffered, and with you I mourn.

"War, famine and pestilence have taken a mighty toll of your heroic people. And the dawn of Allied Victory brought murder, arson, outrage and extortion. Betrayed by friends,—terrorized by Serbia,—the key is turned in the lock that the world outside may know nothing of the atrocities within.

"In your rugged passes for five centuries the Crescent, red with blood, reeled from fight. In this rock strewn home of freedom, where the only thing of value is the indomitable spirit of its people, the Serb received a hospitable welcome. Unwittingly you harboured a Serpent which returns to sting you to death.

"By the dying embers of the hearth, the old folks, smoken of eye and hollow of cheek, keep silent vigil. They may wait a little longer—just a little. Soon the Great Pilot will guide the little craft through storm and surf to The Promised Land where there is neither grief, nor pain, nor suffering, and where the only sound is of joy and everlasting gladness, the reward of those who put their trust in Him.

"A cry for justice comes from a land drowned in blood and tears. The glorious dead call to you that they may not have died in vain.

"Your homes are passing through long dark hours. May the Star of Faith, Hope and Charity redeem the dark ridges of Cragora from the blackness of night. No nation has fought harder to maintain its existence and independence, and this tragic sequel of the Great War will excite pity and sympathy among the lovers of liberty the world over.

"Hold high on Lovchen the torch of Liberty. Your race of mighty mountaineers has kept faith. Montenegrins, courage. The morning cometh. God lives. Truth shall not be destroyed, nor Justice, nor the breath of a prayer.

"May the spirit of your fathers sustain you without faltering to the end. Farewell!"

(Signed) FRED E. BURNHAM. Very fortunately the personnel of the Canadian Hospital appears to be safely lodged in Albania at the present time but no thanks are due to Serbian benevolence on that account, nor does it lessen the indignity offered to Canada in the person of one of its citizens. Capt. Seferovitch, the Serbian Consul at Montreal, has remained silent since making his first perfunctory statement, nor has he made an effort to refute the charges contained in the letters of Col. Burnham already cited by the Chronicle. A further opportunity of vindicating the actions of his country now presents itself: should the Consul fail to take advantage of it, Canadians will be able to make up their minds as to the reality of the "Serbian atrocities" to which both Col. Burnham and his wife refer.

In connection with the result of the prohibition referendum in British Columbia we observed that it was just as impossible for a community as for an individual to maintain a pose of unnatural virtue for any length of time. It now appears that the virtue of four other sister Provinces, Nova Scotia, Manitoba, Saskatchewan and Alberta, is not unnatural but supernatural.

A London despatch states that the Congregational Union of England and Wales has decided to omit the word "obey" from the marriage service. We do not believe that the bride of today bothers very much whether it is put in or left out, being fully decided to follow her own sweet will in any event.

The Chronicle learns that work has been started in Etozer upon the Speaker's Chair for the new Ottawa Parliament Buildings, which is to be a gift from the British Members of Parliament to the Canadian people, and will be a replica of the famous chair in the House of Commons at Westminster. The original is of great artistic beauty and contains examples of the finest Gothic architecture. In the replica the ornate canopy and Royal Arms which surmount it, will be fashioned out of the ancient oaken beams which have been taken from the old roof at Westminster Hall, thus linking up the young Parliament of Canada with the ancient and historic Palace at Westminster. The work is being carried out under the direction of the Lord Chancellor and the Speaker, as joint Presidents of the United Kingdom branch of the Empire Parliamentary Association. In accepting the historical gift, Sir Robert Borden, on behalf of the Dominion Parliament, remarked that the chair would "furnish another illustration of the spirit of comradeship which prevails between the Members of this Parliament and the Members of the old Parliament in the United Kingdom."

Fresh complaints have been received in regard to the locking of one half of the Postoffice door on DuFort street, which is said to lead to awkward incidents when two people are trying to get in and out at the same time.

NEW ZEALAND TRADE GROWS

Business With Great Britain Lost During War is Now Returning.

(Christian Science Monitor)

British manufacturers are rapidly reestablishing themselves in the New Zealand market. They lost a great deal of ground during the war, owing to shipping difficulties and to the concentration of effort on war work, resulting in inability to execute orders.

New Zealand importers had to look elsewhere for goods that they were in the habit of getting from Britain, and much of this diverted trade went to the United States and Japan. Imports from the United States rose from \$2,282,966 in 1914 to \$4,980,748 in 1918, and imports from Japan rose from \$187,501 in 1914 to \$1,214,000 in 1918. Imports from Britain declined from \$11,955,946 to \$8,077,725 in the same period.

During 1919 New Zealand's import trade remained to a large extent in the channels that it had found during the war. British manufacturers needed time to adjust themselves to peace conditions. But since the beginning of 1919 the trade was swung back quickly to the old channels, and it is noticeable that the change has been accompanied by a big increase in New Zealand's imports, due probably to the filling of delayed orders in Britain.

The Dominion's imports during the first six months of 1919 amounted to \$15,876,502 and during the first six months of 1920 to \$24,195,674, an increase of \$8,322,172. The 'United States' share of the trade was almost stationary, while the item of motor cars shows a big increase, indicates that in other lines the American exporters are losing ground in this Dominion. The British manufacturers, it may be noted, are promising the New Zealand market cheap standardized motor cars in the near future.

The adverse exchange rate is an important factor in discouraging trade between the United States and New Zealand. The money order exchange is on the basis of 24 to the pound at present, and the New Zealand buyer, thinking in terms of the pre-war exchange, objects to paying 20s. for 16s. The bank rate has been a good deal worse than this and may get worse again.

Another factor is the charging of customs duties on a preferential scale in favor of the British manufacturer. The extra duty on American goods, in conjunction with the bad exchange, makes a serious charge.

Just as important, for the present, at any rate, is the pro-British sentiment that animates New Zealand business. The people of this Dominion like to do business with the mother country, and British manufacturers are showing that they consider the trade to be worth developing. The New Zealanders are proportionately a large buyer.

EFFECT OF NEW PHONE RATES

MAY EXTRADITE PRIZE FIGHTER

Abe Attell May Be Taken Back Into States Over Baseball Scandal.

Chicago, Ill., Oct. 26.—Arnold Rothstein, of New York, and Joe Gedeon, St. Louis American League second baseman, today testified before the Cook County Grand Jury investigating the baseball scandal and the State Attorney's office afterward announced their evidence had "exonerated the two men from completely in the throwing of games in the 1919 world's series, but had materially strengthened the case against some of the men already indicted."

The jury today completed the taking of testimony in the investigation which has lasted more than a month and resulted in true bills being voted against thirty men on charges of conspiracy to do an illegal act, but will hold a final session Friday to finish up clerical work.

Gedeon and Rothstein testified against Abe Attell, Ilna Chase, Wm. Burns and others whom the jury already had acted. Their testimony probably will result in an attempt to have Attell brought back here from Canada for trial, officials said. It being believed here that he can be extradited.

Supplementing the announcement by the State Attorney's office, President Ban Johnson, of the American League, declared he felt that Gedeon was entirely innocent and Alfred Austrian, attorney for the Chicago American League Club, issued a statement declaring that "Rothstein in his testimony today had proved himself a quack."

Attorney Austrian declared that Rothstein, who had been mentioned in some quarters as the man who financed the bribing of Chicago White Sox players, not only had not helped "fix the series" but "had done everything he could to prevent the fixing."

Gedeon told the jury of being tipped by a White Sox player that the series was "fixed," but declined to tell the jury the name of the player who tipped him off and the question was not pressed, State officials saying they "already knew."

"Sport" Sullivan, of Boston, and R. Brown, of New York, against whom the jury has voted true bills, were mentioned by Gedeon as men he understood were back of the bribing.

Both were named by Claude Williams, White Sox pitcher, in his confession. Attell and Chase, Gedeon told the jury he believed, were the instigators of the game selling and his statement was borne out by Rothstein.

Rothstein said he lost \$6,000 on the series but not saying whether it was on one game or all. Gedeon said he won \$400.

Gedeon said the gamblers got a "bad bumping" on the third game of the series, which Dick Kerr pitched and the White Sox won. "This game frightened the gamblers and they met to raise \$25,000 still due the White Sox players."

Harry Redmond, of East St. Louis, Ill., corroborated some of Gedeon's testimony.

HUNGER STRIKE AS WEAPON DESTROYED

British Government Has Letter Written By Sylvia Pankhurst To Lenine.

London, Oct. 26.—Sylvia Pankhurst, the militant suffragette, in a letter which she wrote to Nikolai Lenine, the Bolshevik Premier, and which is in the hands of the Government, is said to have made this interesting comment:

"I expect six months imprisonment. I have considered the hunger strike, but I am afraid that weapon has been destroyed, since the Government is letting the Irish hunger strikers die."

Miss Pankhurst was arrested last week charged with publishing seditious literature. She was admitted to bail pending trial.

Several years ago Miss Pankhurst was among the first of alleged offenders against British law and order who went on hunger strikes after they were arrested and secured their release from prison.

SUIT AGAINST THE U.S. SHIPPING BOARD

New York, N.Y., Oct. 26.—Suits for \$2,352,416 damages against the United States Shipping Board and the Emergency Fleet Corporation, was begun here today by the Huron, Minneapolis, St. Paul and Birmingham Steamship Companies. The four companies allege they lost this amount through failure of the two bodies to keep an alleged promise to transfer to Canadian register twelve steel freighters and to advance \$750,000 to facilitate the construction of the vessels last year at the Virginia Shipbuilding Corporation's yard at Alexandria, Va.

SUDDEN SUICIDE

Negaunee, Mich., Oct. 26.—Called to come downtown where friends were waiting to witness his wedding, Dr. B. J. Miller, aged 40, prominent dentist, repined "I'll be ready in a minute," then killed himself with a shotgun. Miss Viola Connors, his fiancee, daughter of the Postmaster of Negaunee, and other members of the wedding party were waiting for Dr. Miller to appear.

No reason for the suicide is known.
