

MAYOR'S CASTING VOTE RULES CITY COUNCIL

Allies Reparations Plan Handed To Germans Today

First Council Meeting In Three Months

Council Divides Evenly, Five to Five, on Question of Secretary Gaten's Suspension, and Mayor Gives Casting Vote, Thus Confirming His Own Action in Dismissing Auditor Bryce's Audit Report Tabled—Routine Business Conducted Smoothly—Large Attendance of Public.

All aldermen, the Mayor and an exceptionally large number of interested citizens were present, last night, at the City Hall, when the City Council sat at the first regular Council meeting which has been held in the city for nearly three months. There was considerable discussion on several points, but in the main the meeting was very orderly, and the different questions which came up were given the immediate attention of the Council.

The chief question of the meeting and the one which apparently interested the citizens most was the reasons which the Mayor was to give for his action in suspending Mr. Gaten as Secretary-Treasurer of the city. It will be remembered that several weeks ago the Mayor suspended Mr. Gaten and informed the Council that at its first regular meeting he would put before them his reasons for so doing. Since that time no regular meeting has been held and Mr. Gaten has remained on suspension. Last night however, the Mayor had his first opportunity to explain his actions, and the following reasons were given to the Council by the Mayor:

1st.—Being assured that some one, not known, entered my office and took several important papers from my desk drawers. I made enquiries to find out who had keys to my office, and after finding that only two employees had keys, I questioned one of these employees who swore that he had never touched anything in my desk drawers. I concluded that these letters could not move themselves, and that they were taken by some one who needed them.

2nd.—On a certain occasion, contrary to my usual custom, I came to my office before 8.30 a.m., and had the big surprise of my life at 8.40 on that day to receive a visit from a person having a key to the first door of my office, and with sufficient curiosity to push his way into the second door. Seeing me in my office at this hour in the morning he was so surprised that he did not take time to say "good morning," but went through another door so as to get out immediately. This confirmed my first suspicion, and I immediately had new locks placed on the doors in order to avoid future visits.

3rd.—For failing to carry out on time an order which I gave him to call a meeting.

4th.—For trying to weaken public confidence in me, and to humiliate and ridicule me.

5th.—For the reason that he is the same man who had complete charge of the accounting from 1913-1920 inclusive and that he mixed the said accounting to such an extent that it was necessary to make a change.

6th.—For not having given to the accounting department extracts from the resolutions of the Council. It is the duty of the secretary after each assembly of the Council to advise all departments which are affected by the resolutions of the Council.

7th.—For having tried to have expelled by constabulary force a temporary employee and by so doing wished to use power which he did not possess.

For these reasons I felt it my duty to use the authority given to me by law to suspend this employee and I leave it to you, Messrs. Aldermen, the care of confirming or annulling my decision.

Ald. Skinner Moves Motion to Sanction Mayor's Action.

Following the reasons given by the Mayor as to why he suspended Mr. Gaten, Alderman Skinner arose and made a motion to the effect that the council sanction the mayor's action. "It is evident from the date on this letter, (June 24th.) that this letter was not sent during a time of anger or on the impulse of the moment, but after due consideration, and acting upon what was thought to be to the best interests of the city, and I have no hesitation at all in saying that the council should confirm your action and the city do without the services of Mr. Gaten. I, therefore, make a motion to the effect that the mayor's action in suspending Mr. Gaten be sanctioned by the council." This was seconded by Ald. Langis.

Ald. Fortier Objected to the Motion.

Alderman Fortier rose before Mr. Skinner's motion was seconded and said that he considered that discussion on the matter should be in order. "Alderman Skinner, would never let an opportunity of throwing dirt at Mr. Gaten go by," Mr. Fortier said. Mr. Fortier said that he thought serious consideration should be given to this matter before the council was called upon to act. He therefore, made a suggestion that this question be left over until the next meeting.

In his remarks Alderman Fortier brought up the question of nationality, and accused Alderman Skinner of being prejudiced against the French speaking people. Alderman Skinner objected to this accusation, saying that on the contrary he had on several occasions been accused by his own people of favoring the French.

Ald. Crepeau in Favor of Leaving Motion Over.

Alderman Crepeau advised the council to leave the question of Mr. Gaten's suspension over until the next meeting. Alderman Newton like himself had not considered the circumstances, and therefore

Motion Put to House and Carried.

Following the discussion on the question as to whether or not the mayor's action would be sanctioned by the council the motion of Ald. Skinner was put to the house. Aldermen LaCombe, Labrecque, Fortier, Crepeau and Bourque voted against the motion. Aldermen Skinner, Houlahan, Newton, Langis and Treault voted for it. Thus the vote stood 5-5 and the mayor cast the deciding vote in favor of the suspension.

Immediately following the passing of the motion it was decided by the council to issue a notice that tenders would be received for the position of secretary-treasurer of the city.

Auditor's Report Submitted.

The mayor presented the auditor's report which has been ready for some time awaiting a meeting of the council. A motion, however, was passed to the effect that this report be left over until the next meeting in order that aldermen might have a chance to examine it before passing its adoption by the council. It was

Russians Break In London

Negotiations With British Fail—Refuse to Accept Conditions.

(Associated Press Despatch) LONDON, Aug. 5.—The negotiations between the representatives of Great Britain and Soviet Russia have broken down and the projected treaty will not be signed, it was announced this morning by the Foreign Office.

The British and Russian delegations were in session all night until 7.15 o'clock this morning, the announcement said. The Soviet representatives were unable to accept the amendment and concessions offered in regard to article 14 of the draft treaty. No agreement could be reached, it was stated.

The Anglo-Russian conference in London was convened in April 14, following recognition of the Soviet regime by the Labor Government under Premier MacDonald in fulfillment of what was virtually a campaign pledge. The purpose of the conference was to settle all the outstanding claims between the two countries, some involving pre-war debts on the part of Russia and others growing out of the Soviet Government's seizures, under its nationalization policy, of property belonging to British subjects.

The proceedings dragged from the start, despite the efforts of the British to speed them up. The Russians made efforts to secure a loan, which they desired the British Government to guarantee. This guarantee the British flatly refused to give. Mr. MacDonald declaring that the British bankers demanded recognition of Russia's pre-war debts as a prerequisite to any advance.

Another of the stumbling blocks was the Russians' insistence that the British recognize extensive counter-claims based on damages suffered in consequence of armed foreign intervention in Russia after the revolution. The campaigns of General Denikine, Admiral Kolchak and other anti-Bolshevik leaders were cited in this connection.

Christian Rakovsky, the chief Soviet delegate, after a hurried trip to Moscow, returned to London last week bearing a new set of proposals, which it was hoped, according to Moscow dispatches, would remove the obstacles to an understanding. It was thought by the Russians that these terms, described as more liberal, would satisfy the British holders of the old Russian bonds and result eventually in a loan under British Government guarantee.

In framing the new proposals, however, the Russian commissars, it was added, were particularly careful to observe the Soviet laws on nationalization of property, as they were against sacrificing any of their revolutionary principles.

The Anglo-Russian treaty negotiations collapsed, according to authoritative information on the refusal of the Soviet representatives to accept an article in the agreement which they insisted left the way open for Great Britain eventually to demand compensation for foreign property nationalized by the Soviet Government. In other words, the explanation runs, it was a flat clash between communism and capitalism, although there had been many evasive discussions of other features of article 14, which the Russians found objectionable.

BRITISH WAR SHIPS GREETED AT HALIFAX

Special Service Squadron Reached Nova Scotia Today.

(Associated Press Despatch) HALIFAX, N.S., August 5.—(By Canadian Press)—The British special service squadron under command of Vice-Admiral Sir Frederick L. Field, K.C.B., C.M.G., and consisting of the battle cruisers Hood and Repulse and the Australian light cruiser Adelaide, arrived in Halifax harbor at 1.15 o'clock this afternoon to the accompaniment of guns from the citadel and a deafening roar from the whistles of the shipping in port. The city is in gala attire for the festivities arranged in honor of the visit. Admiral Field has announced that he will meet the newspapermen collectively at six o'clock this evening.

The body of one of the crew of the cruiser Adelaide, who died from natural causes while en route to Halifax, was landed on the arrival of the warship.

J. H. Bryce Report Is Submitted

Recommends Monthly Audit—Stores Account Does Not Balance—Staff Members in Arrears for Light and Gas—Notes from the Report.

The report of Mr. J. H. Bryce, chartered accountant, who has recently concluded an audit of the books of the City of Sherbrooke, was submitted to the Council at last night's meeting and was held over until a later meeting for closed consideration. Mr. Bryce's report has been awaited with a good deal of interest by those who have been following the progress of the affairs at the city hall during the last few weeks.

The first part of the report contains a summary of the accounts of the various departments at the City Hall, including the Tax Department, Electricity and Gas Department and Water Department, for the year ending December 31st, 1923. The second part of the report contains the balance sheets of the various departments and their profit and loss accounts.

Amounts Overdue for Wood.

Referring to the Tax Department, under the heading of "Cash and Banking," Mr. Bryce states: "We have verified the cash income from the various sources and found same correctly entered in the cash books and promptly deposited in the city's banking accounts. Our examination of the cash collections by the Police Departments included the income from weigh scales, which we checked in from serially numbered scale slips and found correctly entered; the Recorder's Register, where the fines are recorded, and proceeds for sales of wood. The books are efficiently and neatly kept by Capt. Camirand. In regard to wood sales, we would here call your attention to the fact that sales have been made on credit to men who are well able to pay and a considerable amount is overdue and unpaid."

Some Missing Cheques.

Vouchers for disbursements, etc., were duly examined by the auditor and were found in order, with the exception of some nine cheques, aggregating about \$160, which were missing. Payments for these amounts were supported by vouchers, however, with the exception of one account of the Sherbrooke Undertaking Parlors, for which both general Bank and Petty Cash cheques were drawn and cashed for the same bill. Only one payment had been received by the Sherbrooke Undertaking Parlors. Petty Cash vouchers for five cheques, were not available and with regard to this, the report states: "Cheque No. 249 for \$19.31 is missing and we cannot say whether it was payable to Louis Grenier or not. The last four cheques, aggregating \$40.00 were drawn in favor of A. A. Gagne, Petty Cashier, and duly paid at bank."

"This irregularity we promptly reported to the Mayor, who undertook to investigate the matter. We have been informed that earlier in the year it was discovered by Mr. Dubois that advances on Salary Account had been made by the Petty Cashier to himself and others in the office and in the case of Gagne the advance were charged against Expense Account in an apparent attempt to

Argument In Case Of Mayor

Attorney for Accused Asks for Dismissal of Action—Argues No Wrongdoing—Attorney for Complainant Pleads for Conviction and Reviews Evidence to Support Charge—Adjournment at Noon.

The hearing in the case of Eugene Lemelin vs. Mayor William Brault was resumed before District Magistrate Emile Maril this morning.

Mr. Lazure Pleads Case of Mayor

Mr. Wilfrid Lazure, counsel for the accused, opened the proceedings and in a spirited plea for his client contended that the evidence showed that Brault had made arrangements with the road superintendent, J. T. Martel, to take a number of loads of stone at a dollar a load. He held that the evidence of Mr. H. C. King, acting secretary-treasurer, corroborated this contention, King stating that Martel had told him these facts. Mr. Lazure observed that members of the road committee had been called as witnesses for the plaintiff, but pointed out that Alderman Langis, chairman of the committee, had not been examined. He admitted Langis had been out of town, but suggested that had he been placed on the stand it might have been shown that he had granted permission to Mayor Brault.

The District Magistrate disagreed with Mr. Lazure in his argument to the effect that the mayor had absolute control and had no need to ask permission from employees. The Court pointed out that the mayor was governed by the city's charter. In conclusion, Mr. Lazure held there had been no wrongdoing and that the charge against the mayor should be dismissed.

Col. Rioux's Address

Col. Emile Rioux, K.C., appearing for the plaintiff, observed that he would not present his argument until later, as it was evident from what Mr. Lazure had said that there was something in the wind and that Alderman Langis would be brought out by the defence and probably made to say that he had given Brault permission.

"The main question," said Mr. Rioux, "is, did Brault have the right to take that stone? I say no. Only a few months before—why, only a few weeks—a resolution was passed by the council, presided over by the accused, by which it was strictly forbidden to dispose of any city merchandise without order and without paying cash for same. Mr. Lazure states that Martel gave Brault permission. Martel, however, denies absolutely having given permission."

The documentary evidence was looked up and counsel for plaintiff cited certain paragraphs relating directly to this particular issue. Continuing, Mr. Rioux remarked: "The mayor tried to exert pressure on a civic employee for the sake of getting an extra miserable 50c a load, but Martel told him the stone was needed by the city. To show the generous heart of the mayor of Sherbrooke, you will see from the evidence that he asks Martel, 'If I had a bigger load, would I pay the same price?' What do you think of your client, Mr. Lazure?"

Mr. Lazure: "I think he is a good business man."

Col. Rioux: "Martel says he did not give permission, although he did not actually forbid him from taking it. It was up to the council to fix the price. Counsel for defence allows it to be implied that the chairman of the road committee, a friend of Brault, will state he gave Brault permission to take the stone. He wants to uncover my argument, but nothing doing."

Lazure: "That is not customary with me."

Col. Rioux: "No, you are not respectable, but your client would."

Col. Rioux—"On July 2nd, Langis telephoned Martel and told him not to sell any stone, therefore Martel could not have given him permission a couple of days previous. If Langis comes and swears to this, as is likely, because there is an agreement between Langis and Brault to get the latter out of the hole, I am waiting for them and that is why I will not present my argumentation. Langis phoned Martel and told him not to sell the stone. Martel called up the mayor and asked him how many loads he had taken. What did Brault say? 'I took eight loads.' He had then taken sixteen loads and if the city employees had not investigated the matter he would have been so many to the good."

"Martel went to his foreman, Travello, and asked him how many loads Brault had taken. He was told twenty-five. Martel called up Brault

GERMAN DELEGATES AT LONDON FOR INTER-ALLIED CONFERENCE; SOME OBJECTIONS ARE EXPECTED

Americans Believe There Are Only Two Controversial Points—Allied Programme Is Placed Before Them—Germans Expected to State Views Tomorrow.

(Associated Press Despatch) LONDON, August 5.—The German delegates arriving here today to attend the Inter-Allied Conference are expected by noon to have before them the programme for launching the Dawes plan which has resulted from the allied statesmen's labors of the last few weeks.

That they will object to certain features is a foregone conclusion, but, according to a high American authority, there are but two points to which they can technically do so. One of these is the provision for extension of deliveries in kind of coke, dyes and coal beyond the Versailles Treaty date of 1920, and the other is the agreement on arbitration of the question whether financial manoeuvres are taking place in Germany to defeat the Dawes plan.

The Germans will formally receive the programme at a plenary session of the Inter-Allied Conference in Premier Macdonald's official residence in Downing Street, after an official address of welcome by the Premier. This ceremony over, the conference will adjourn until Wednesday, when the Germans will be requested to state their views.

PREMIER MACDONALD HANDS GERMAN SETTLEMENT PLANS

(Associated Press Despatch) LONDON August 5.—Premier Macdonald, presiding at a plenary session of the Inter-Allied Conference at noon today, formally handed to the German delegation the protocol embodying the programme of the conference for putting the reparation experts' report into effect. He asked the Germans to study the report and be ready to express their opinions tomorrow. The Premier said he wanted to bring the conference to an end by Friday night.

The session, which was held at the Premier's official residence in Downing Street, lasted but thirty minutes, and was opened by a welcoming address delivered by Mr. Macdonald. The German delegates, headed by Chancellor Marx, Foreign Minister Stresemann, and Finance Minister Luther, arrived in London at 8.30 a.m., fully prepared for the meeting. They were accompanied from Harwich by Dr. Gustav Sthamer, the German Ambassador in London.

Replying to Mr. Macdonald's welcome, Chancellor Marx said the German Government had accepted the Dawes plan and was putting through the necessary legislation to make it effective. The German representatives, he said, hoped to maintain the friendly spirit of the original experts and hoped the allies would do the same.

PROGRESS OF LOEB - LEOPOLD TRIAL IN CHICAGO

State Attacks Testimony—Dr. Healy, of Boston, Alienist, Witness in Case—Give Opinions Re Youths' Motives.

(Associated Press Despatch) CHICAGO, Aug. 6.—The state's second attack on the defence alienists' testimony that Nathan Leopold, Jr., and Richard Loeb, kidnapers of Robert Franks, were victims of "childish phantasies" and were bound together by "an absurd childish compact" was to be launched today in cross-examination of Dr. William Healy, of Boston.

The psychiatrist, whose findings with others are offered in mitigation of the punishment Judge John R. Caverly will impose, was to complete his direct testimony within an hour after today's session opened after which the prosecutors would question him.

Robert Crowe, state's attorney, who has contended against admitting the expert testimony, subjected Dr. William A. White, of Washington, D.C., who took the stand first to a lengthy examination, but expected to devote only an hour to Dr. Healy. Both experts stated that the undeveloped emotional sides of the youths' personalities overshadowed their mature intellects to the extent of making them incapable of resisting committing the crime which they built up in their childish phantasies.

The prosecution, foiled so far in attempts to turn the hearing into a jury trial on an insanity plea, is preparing rebuttal evidence of its own alienists to show that the slayers were intellectually capable of plotting the mental irresponsibility defence theory.

Both conscienceless, egotistic and selfish, Loeb would have killed members of his family or his counsel if pleasure of publicity was to be gained thereby and Leopold thought he was always right and the world was wrong, according to Dr. Healy's testimony. Each had peculiarities in his mental life, each arrived at these peculiarities by a different route, and each supplemented the other's already abnormal needs in a unique way, he said. The Franks murder was the result of a diseased motivation, he averred.

OTTAWA DENIES BELCOURT REPORT

OTTAWA, Aug. 5.—Official denial of reports that Hon. N. A. Belcourt has been selected for the post of Canadian Minister at Washington was made this morning. It was stated that no decision has yet been arrived at in regard to filling the position. It is possible that the matter will receive consideration at one of the Cabinet meetings which are scheduled for this week.

Counting the distance as nothing, Mr. Mousley returned to "Beaumont," and with his camera retraced his steps, securing at the same time both this floral treasure and its fascimile.

MOTHER WON 16 YEAR FIGHT FOR CONVICTED SON

Son in Jail Since 1908 for Murder of Minister Is Pardoned.

NASHVILLE, Tenn., Aug. 5.—An aged mother from the Tennessee mountains has won a battle that she has fought single-handed against the powers of the state for the last sixteen years. Her plea that her son, a prisoner in the state penitentiary here, be pardoned, was granted recently.

Mrs. Sam Hatfield, 63, the mother, appeared before the parole board and addressed Governor Austin Peay as "son" and the members of the parole board as "children."

Her son, Lon Hatfield, was convicted in 1908 for the murder of a minister. The sole tangible evidence was a twenty dollar gold piece, said to have belonged to the minister, which was found in Hatfield's pocket after the murder. Hatfield declared that the coin belonged to him, but the jury rejected this claim and convicted him on circumstantial evidence.

Immediately after the sentence was passed on her son the mother began her battle for his freedom. She sold her little farm and during the last sixteen years she has made at least fifty trips to the penitentiary to present her plea to the authorities and to see her son.

At last she obtained from both the trial judge and the prosecuting attorney requests that Lon Hatfield be pardoned. These requests were joined by the widow of the slain minister.

Mrs. Hatfield was told by Governor Peay that he would make her a Christmas present of her son.

QUESTION OF TARIFF TO BE IMPORTANT

This Question Will Not Likely Be Answered Until After the Speeches of Acceptance by the Candidates for President.

WASHINGTON, Aug. 5.—(By Canadian Press).—Apparently the tariff questions will become of much prominence before the presidential campaign is over. This question will not be clearly answered until after the speeches of acceptance by the candidates for president and until after the democratic nominee, John W. Davis, enters actively on his speechmaking campaign. Present signs are, however, that the tariff issue will be up, as it usually is.

One evidence of this is that the extreme high tariff interests are already attacking the position of the democratic party and of Mr. Davis on the tariff. It is the understanding that Mr. Davis is not a radical low tariff man, but that he believes in greatly moderating the duties and in such rates as will enable that degree of competition from abroad as will tend to prevent monopoly in this country. In other words, he does not favor prohibitive tariff rates. Naturally, his position is not satisfactory to the ultra high tariff elements and they are already firing at him through the American Protective Tariff League and otherwise.

Senator La Follette, as is well known, though he is by no means a free trader, has long fought excessive tariff rates and there is no doubt will stand against them in the campaign. His recent statement charging that the tariff commission report on sugar duties was being unduly delayed is an indication of this.

President Coolidge's whole course while in the White House has left no doubt that he holds the New England idea of high duties. Under his administration the flexible tariff has been practically a nullity so far as the lowering of rates is concerned.

As another piece of evidence that the tariff is to be in the campaign, the high tariff leaders are hastening to take advantage of the recent increases in the prices of grain and hogs in this country. They are trying to show that the tariff on farm products is not a failure and that for natural economic reasons the prices of the farmers' products are being equalized with those of manufactured products. In other words, they are seeking to allay the feeling of the farmers that they are getting the worst of it under the existing tariff arrangement.

One purpose of this effort of the high tariff interests is to hold back the farmers from bolting the republican ticket in this campaign and another purpose is to try to block the idea of enacting such legislation as that proposed in the McNary-Haugen bill, which would encourage exportation and practically shut off importation of farm products.

BELGIANS CONFER DOUBLE HONORS UPON HUGHES.

BRUSSELS, Aug. 5.—Charles E. Hughes, American Secretary of State, was signally honored Friday when two new titles were conferred on him—Doctor of Laws of the University of Brussels, and Doctor of Laws of the University of Louvain. The first was conferred by the Belgian ambassador to the United States, Baron de Cartier de Marchienne, at the American embassy, and the second by Cardinal Mercier, the Archbishop of Mechlin (Malines) serving as the setting for the ceremony.

The chime of the palace at Mechlin pealed out "The Star Spangled Banner," and an American flag presented to Cardinal Mercier in 1919 by a group of New Yorkers flew over the palace as Secretary Hughes accompanied by Mrs. Hughes, William Phillips, the American ambassador, and Mrs. Phillips, was conducted to the throne roof. There Cardinal Mercier, assisted by Monsignor Ladouze, rector of the University of Louvain, and Chancie Dessain, the cardinal's secretary, handed the diploma to the Secretary of State in a most impressive ceremony.

The cardinal said he was happy to be able to confer the degree in the name of the university to one "whose conscience as a jurist and experience as a diplomat are so justly renowned."

"Belgium and her allies," he added, "owe you a debt of deep gratitude, because, if the United States saved them, everyone knows that it was because her entry into the war was due, in large part, to your clear-sightedness, your candor, your courage. When you entered this room I lived over again the moments of emotion I experienced in New York when I was received by the Bar Association of which you were then president. It is with joy as well as with gratitude that I hand you this diploma."

In a private talk just after the ceremony, Secretary Hughes thanked Cardinal Mercier and the university, through him, for the honor. The visitors then went through the archiepiscopal gardens, where they listened to the Belgian and American national anthems and Flemish airs played on the chimes.

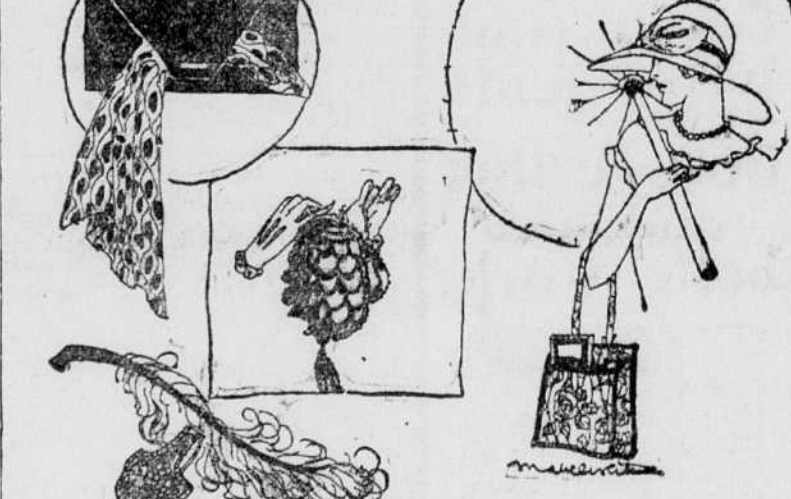

IMMIGRATION LAW NOT VERY SATISFACTORY

Has Only Been in Force for Two Weeks—Some Change Will Be Necessary, It Is Thought.

WASHINGTON, Aug. 5.—(By Canadian Press.)—The new immigration law is proving difficult to administer. Many new and knotty questions are arising in connection with it, and although it has been in force for two weeks, it is declared that it will be necessary for Congress when it meets in December to pass a bill designated to correct some of its provisions.

One of the embarrassing features of opening up the new law for correction next December is that it will make it impossible to open up the whole immigration question, and it is not improbable there will be attempts to change the status in vital particulars.

One of the difficulties which is presented by the new law is that it has practically placed a premium on the smuggling in of aliens across the Canadian border. The great reduction in the number of persons who can enter the United States naturally has a tendency to increase the disposition of aliens to enter the country by evasion of the law. It has to be borne in mind that the reduction in total immigration under the new law is so great that only about one-sixth as many immigrants can enter now as many entered the country before the war.

When Congress passed the new law it recognized that the difficulties of protecting the Canadian and Mexican borders against smuggling in of aliens would be increased. It made an appropriation of \$1,200,000 additional for border inspection service. This, however, is really but a drop in the bucket. As a practical fact, it is impossible to guard the thousands of miles of border in such a way as to prevent immigrants entering contrary to law.

WASHINGTON, Aug. 5.—President Coolidge on Saturday completed his first year in office, sticking to his desk through most of the day as he has throughout the entire period. President Harding died a year ago Saturday at San Francisco and Mr. Coolidge, then Vice-President, took the oath of office early the next morning at his father's home in Plymouth, Vt. He came immediately to Washington and has been here almost constantly since.

When asked recently what he considered the outstanding points

of his first year in office the President replied that the general public, perhaps, was a better judge of that than himself.

SHERBROOKE HOSPITAL.

The report from the Sherbrooke Hospital for the month of July includes the following statistics: On the first day of the month there were 34 patients in the hospital which number had reached 43 on July 31st. During the month 97 patients were admitted, of whom 29 were men, 52 women and 16 children; of these 33 were from Sherbrooke and 64 from out of town. During the month there were seven births and three deaths, one of the latter being within 24 hours of the admission of the patient. Seventy-five operations were performed and twenty-four emergencies treated. In the X-ray department there were 38 cases and 3 fluoroscopic examinations. The diet kitchen reports 8,438 meals served, of which 3,426 were to patients and the balance to the staff and help. During the month considerable work was done in the direction of improving the interior appearance of the hospital, all of the walls and ceilings having been retinted and the floors painted in the halls of the main building.

CLOUDBURST DID GREAT DAMAGE THIS MORNING

Many Bridges Washed Away—Two Lumber Mills Destroyed—Railroads Suffered—Highways Made Impassable.

The heavy rain of last night and early this morning, which in some localities assumed the proportions of a cloudburst, did a great deal of damage at various places throughout the Townships. At North Coaticook, Coaticook, Moe's River, Hyatt's Mills and other places, the reports indicate a serious loss. Bridges have been washed out, lumber mills wrecked and highways washed out. Washouts on several railway lines have interrupted the train service.

Coaticook and vicinity seem to have suffered the worst damage from the storm, where the rain fell steadily all night until about two o'clock this morning when a cloudburst swept over the district. Several bridges over brooks at North Coaticook have been washed out, and the main highway between Sherbrooke and Norton Mills was thus made impassable. At the time of the cloudburst the water on Compton Street was two feet deep, and the street was gullied out and rendered impassable for a distance of a quarter of a mile. Bridges on Regent and Riverdale Streets and below the LeCour residence were washed away. The new bridge over the Coaticook River was completely swept away, only a trace of the concrete abutments being left. The road on the hill between Riverdale and St. Jean Baptiste Streets has been completely washed away.

At Coaticook also considerable damage was done. A large Red car which was standing behind the LaBarre store was swept away by the flood, carried under two bridges and dashed against a concrete culvert. From Hyatt's Mills comes the report that the lumber mill and a considerable quantity of lumber have been lost, resulting in a great deal of damage and property loss. At Moe's River, the bridge was

swept away, and at one end the road swept away, and at one end the road a depth of some ten feet. Here also a lumber mill situated at the end of the bridge toppled over by the torrent and broke up in the river. Quantities of logs and lumber were also carried off. The Sisco bridge below Moe's River was carried out. At Milby the bridge known as the McClare Bridge, is reported to have gone out.

Washout on C.N.R.

The Canadian National lines suffered about a mile this side of Waterville near what is known as the Prouty Crossing, where a washout occurred. The early morning express narrowly escaped being wrecked at this spot. The train approached the crossing soon after the storm had occurred and the engineer perceived the break just in time to prevent a serious accident. He slowed down, but was unable to stop before the locomotive had passed over the break. The tender left the rails and broke the coupling with the rest of the train which came to a standstill before the cars reached the washout. The wrecking train from Richmond was soon on the scene and the damage was repaired temporarily, the express passing through Sherbrooke at about eight o'clock this morning. A small washout occurred on the Canadian Pacific line near Delaire, but it was repaired at once and trains were not delayed.

On the Boston and Maine a serious washout occurred between North Hatley and Eustis, delaying the early morning express from Boston some four hours. The Quebec Central Railway suffered no damage and service was uninterrupted, but the Maine Central line was washed out at Beecher Falls, Vt., and all trains from Lime Ridge today were cancelled.

GOVERNMENT ROADS ESCAPED

The government highway between Sherbrooke and Stanstead escaped serious damage, as did the highway between Sherbrooke and Quebec, both of which are none the worse as a result of the storm. The road leading from the government highway into North Hatley was gullied at one side but is still passable, a distance of about a half a mile in the vicinity of Hatley Centre. The damage was caused by falling trees.

All the small rivers and brooks in the vicinity have taken on greatly increased proportions overnight, and where twenty-four hours ago there were only little rivulets, today there are rushing torrents which have swept away many dollars from the pockets of the residents of the townships. Even the larger rivers show the effects of the storm and have swollen considerably already. The waters in Lake Massawippi have risen and are still rising as the many streams from the surrounding hills pour into its midst.

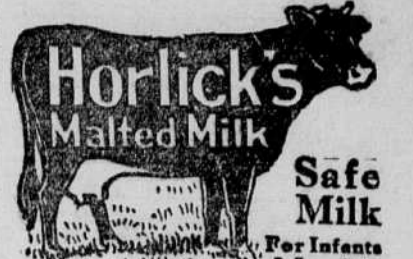

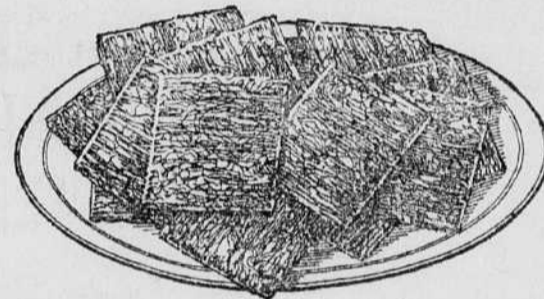

GARBAGE DISPOSAL.

Complaints have been made to the civic authorities with regard to the garbage or waste dump on the Brompton Road and to the annoyance resulting from the open burning of this. Residents in the vicinity have made well founded protests in this connection, thus far without results.

Reforms in the handling of garbage and waste have been brought about with difficulty in many towns and cities. A campaign of protest in St. Johnsbury, Vt., has just resulted in a clean-up.

The Quebec Telegraph referring to the problem in some other cities says:

"The question of garbage disposal is one that is constantly arising in the majority of Canadian cities, and the unsightly and unsavory garbage dumps that disfigure the neighborhood of many of them and poison the air for a considerable distance around, lend special interest to the suggestion of the correspondent of an Ottawa paper, who points out that it is perfectly possible for large cities to adopt modern scientific methods of garbage disposal that would cost less for themselves and leave a substantial revenue to the good. The refuse dumps of Birmingham, England, are now paying that city \$180,000 every year. A few years ago the city built a salvage plant at a cost of \$2,000,000. This will be paid for in a few years, after which the profits will be used for the reduction of the city debt. The city also saves \$260,000 annually which it formerly cost to dispose of refuse. Birmingham has a population of 919,488. The salvage plant last year produced many tons of tin, 5,000 tons of fat, and several boatloads of fertilizer. Food for pigs and poultry and oil products for candle and soap making also were sold and the clinkers and stone were used for repairing roads."

Sherbrooke's problem is not as great as that of some larger cities, but there are matters of equal importance in connection with the disposal of waste which should be looked after.

COL. BADEN-POWELL ON HEALTH AND ATHLETICS.

The value of sports, of good healthful exercise as body building agencies is generally accepted. Col. Baden-Powell, founder of the Boy Scouts, in a letter to the London Spectator, points out that the exercise of reason and common sense is as necessary in sports as in anything else. In this connection he writes:

"Dr. Saleeby is right when he urges that this subject is one for inquiry and study. In the present day physical training of our youth we go forward in all the valor of ignorance. We gaily drill our youngsters in gymnastics and 'physical jerks' on the same lines as in the army, but without regarding any distinction between immature growing boys and formed adults. Our instructors are in many cases selected for their splendid muscle and activity but with no inquiry as to their knowledge of physiology of anatomy. More harm than good is done in the world of athletics through this blindness."

"A man wrote to me once reporting that he and his son of 12 had cycled some extraordinary distance in record quick time, and he wanted me to publish the fact for the inspiration of other boys. I only published the fact that the man was too big a fool to be a father. Endurance is not gained in the immature youth by putting it to the strain, but by building a good foundation of health and strength to begin with. This fact is too often forgotten in promoting rowing, long-distance running, tug-of-war, marching order field days, etc., among growing lads."

"An education authority once asked me whether I did not agree that the provision of gymnasia in every school would change the physique and stamina of our manhood for the better. I said it might, but that the finest national physique I had come across was among the Zulus and the best stamina among the Gurkhas; but in neither country had I ever noticed a gymnasium. Plain, wholesome food, constant open air, proper clothing, regular habits, and natural exercise had more to do with health and development than all that gymnasia could do. By natural exercises I mean such games and activities as are natural to the young animal. For example, climbing is the natural attribute of the ape-shaped creature from babyhood. Where it is indulged in it develops every part of the body, it so interests the boy or girl that it is carried out wherever opportunity occurs; it is a useful accomplishment, and, moreover, it has moral value as well in giving courage, caution, self-confidence, etc."

"The same is the case with swimming. Games like tennis, cricket, baseball, etc., have also their moral as well as their physical value (at the least they teach people to be quick rather than dead in this motor-driving age.) But more especially they have this value where, like football, they are team games, involving individual discipline, fair play, unselfishness, 'playing the game,' and playing it for side and not for self. So in the Boy Scout and Girl Guides training we encourage as far as possible those team games and activities which appeal to the enthusiasm of the young people and tend to develop them morally as well as physically by natural and not artificial methods, acceptable to all and without undue strain—activities where proficiency comes by desire from within and is not a task imposed by order from without. The Scoutmaster or Guide who is not a trained physical instructor can thus carry out physical development without danger to the child, since he has merely to encourage the necessary enthusiasm rather than to give orders and corrections. The boy thus trains himself in the attributes desired almost without knowing it. The various methods by which this is accomplished will be shown at the Boy Scout Empire Jamboree at Wembley every day between August 1 to 8 inclusive. This will be the largest pageant of the boyhood of the Empire that has so far been brought together, but, apart from its interest in that direction, it will give many displays of physical and moral training through athletics which should have their suggestion as well as their appeal to all parents and educationists."

RADIO AT 60 MILES AN HOUR.

The wonders of radio will never cease even though interest in "listening in" may laz. A

new development in radio is reported in the London Observer: "At the end of the London-Newcastle train which left King's Cross at 7.30 on Friday evening there was attached a combined guard's and luggage van bearing the letters on its side, '6 Z.' This was the wireless coach being run by the Radio Society and the London and Northeastern Railway to test the practicability of using wireless on a train to keep in touch with fixed radio installations. The interior of the car was fitted with long benches down the centre, and on these were placed a four-valve receiver for broadcast, a special three-valve receiver for short-wave reception of 185 metres, and a one-valve transmission set. Seven well-known amateurs were in charge of the apparatus. As soon as the train started telegraphic communication was established with the Radio Society's station at Shepherd's Bush and with the exception of the time when the train passed through the many tunnels and deep cuttings, was continued uninterruptedly until broadcasting started at eight o'clock. When the train was travelling at 60 miles an hour between Potter's Bar and Hatfield, Big Ben was heard chiming the hour and for a while the London broadcast programme was listened to. Communication was next made with Bedford; and later an hour's entertainment from London and Birmingham was enjoyed, most stations coming in well. Special precautions were taken to prevent the aerial swaying about and all the apparatus was mounted on springs and soft pads of felt to damp out the vibration of the coach. As far as the preliminary part of the test was concerned it was reported to be quite satisfactory."

PRESS COMMENT

IS IT WORK OR IDLENESS?
(From the Lowell Courier-Citizen)

What times lie ahead? Unfilled orders of the steel corporation are said to be at a lower figure than at any time since 1914. A lull in building such as has been noted from other statistics must be portended. As commitments for fabricated steel are ordinarily made some time in advance, the outlook for big building in the immediate future is probably dubious. How about other basic activities? If the nation has on the whole, about caught up with its present housing requirements, a lot of income that in the past five years has been going into construction may be released for other expenditures. Even though building projects very usually mortgage future earnings over a considerable period, it is the first payments that are the heaviest. After the structure is partly paid for a disposition appears to acquire improved equipment, whether for cash or on credit. One might expect the furniture and automobile trades to hold up well as building slacks off. The man who has worn one suit of clothes three winters in order to get his new house started will be in the market for a good suit and overcoat next winter. His wife and daughters will have to have clothes befitting the better residence which the family now enjoys. In brief a depression in building may prove to be a stimulus to others of the great staple activities of the nation.

WAR AND CAPITALISM.
(Toronto Globe)

Speakers at a peace meeting in Toronto said that the only way to insure world peace was the abolition of capitalism and the assumption by the worker of the reins of government. This does not hold out a rosy prospect for the friends of peace. The possibility of overthrowing the capitalist system and putting the proletariat in power is exceedingly remote in this country and in the United States. On the other hand, it may be pointed out that, in spite of the evils or defects of the capitalist system, there has been peace between Canada and the United States for more than a hundred years. Capitalism is quite as strongly entrenched over the whole Continent of America as over the whole Continent of Europe, yet the new continent is to a far greater extent than the old free from war and from the fear of war.

It is not to be denied that the greed for territory and for such resources as coal, iron and mineral oil is one of the causes of war. But the European example shows that other causes have been at work. In the old days wars were largely due to dynastic ambitions. The Great War has thrown a good deal of this material into the junk heap, but there remain national and racial hatreds and fears which cannot be ascribed wholly to competition for material resources. No doubt much light is thrown upon history by the economic interpretation of events and movements, but the economists are apt to ignore other elements of human nature. Man is an acquisitive animal and a pugnacious animal, but he is a good deal more than that. The problem to be dealt with by seekers of peace is not simple, but exceedingly complicated.

THERE IS A REASON

Editor of Record.
Sir:—When 95 per cent of the newspapers of Canada and 98 per cent of the Canadian people are in favour of prohibiting the export of unmanufactured wood from Canada—when practically all the outstanding men of the country are in favor of an embargo—when the Government's own Pulpwood Commission, in its report, states that "Canada is dissipating her woods capital more than any other nation in the world" and further, that "definite, radical and constructive steps are of transcending importance if Canada is to protect and further develop her forest industries—when the Chief Forester of the United States, Col. Wm. B. Greeley, tells us that Canada has no more than sufficient wood for her own needs, that wood shortage is world-wide and that the only country that the U. S. can possibly look to for any relief is Siberia, and further that even that country, if the wood were available, could not supply the U. S.

with 25 per cent of its annual requirements when pulp and paper mills are clamoring for locations to build new mills in Canada—fourteen having already applied to the Minister of Lands and Forests in Ontario, (several want locations in Quebec, four in New Brunswick and three or four in Nova Scotia)—and the Government at Ottawa still declines to prohibit the export of raw wood, there must be a reason and a very potent reason and it is now high time for the voters of Canada to demand what that reason is. What influence is it that is being exercised with the people's representatives at Ottawa, representatives who were employed by the people of Canada to look after their interests, and not the interests of American paper manufacturers. Recently I received an illuminating letter from a prominent American from which I will here quote just one passage:—"The people of the United States ought to feel as much interested in the preservation of the forests of Canada as in the preservation of the forests of the United States. Climatic influence know no boundary line. Economic results produced by those influences are neither kept in nor kept out by lines on the map. The whole continent

of North America is vitally interested in the preservation of Canadian forests—and the work that you are doing should have universal support without regard to politics, selfish business interests, or any other consideration". It is time for the Canadian people to realize what is going on and demand that their representatives at Ottawa immediately pass an order-in-council prohibiting the export of unmanufactured wood from Canada, under the power which was given to them by Parliament itself and to immediately rescind the iniquitous and secret ten years exemption order which was passed without any authority from Parliament and which is consequently ultra vires.

HIRAM SHULTZ DISAPPOINTED WITH JUDGMENT

Was Ready to Plead Guilty and Have Everything Over, When Judge Suddenly Changed His Plans.

(Associated Press Despatch)
BLOOMSBURG, Pa., Aug. 5.—Disappointed because he "called the turn" wrong when taken into court to answer a charge of driving an automobile while intoxicated, Hiram Schultz, of Millville, is in the county jail eagerly awaiting expiration of his sentence.
Schultz went to jail when three commitments were issued for him on two charges of driving while intoxicated. He was taken from the jail before a local justice for hearing and decided to plead guilty.
"Court's in session. We might as well go over and get it over with. I'll plead guilty, pay a fine and take my car back home," he said. However, an officer told him to "wait a little." When the evidence had been presented Judge Potter sentenced him to two years in jail and assessed a fine of \$400, instead of permitting him to take his car home.

RAILROAD ISSUE TO THE FRONT IN U.S. ELECTIONS

Labor Party Will Make Attack on High Freight Rates.

WASHINGTON, August 5.—(By Canadian Press)—The La Follette leaders have determined, among other things, to force to the front in the coming presidential campaign the issue of high freight rates and the question of a sweeping revision or repeal of the Cummins-Esch law, which is a large part of the law governing the railroads.
They have come to this conclusion for a variety of reasons but the particular thing which has prompted it is the recent decision of the Interstate Commerce Commission refusing a reduction of rates to the farmers on grain products and hay. This action of the commission, which was by a bare majority, with five of the eleven members dissenting, has disappointed and angered the farmers in the grain and hay states. The situation is therefore ripe for an attack on the pending railroad law.
In this connection, with the railroad issue being forced to the front, it is interesting to know that increasing attention is being given in Washington and in the country generally to the workings of the Canadian government-owned railroads. Various members of Congress are studying the Canadian railroad system and seeing how it compares with the United States system. Farmers' organizations are keenly interested because of the fact that the Canadian roads allow rates more favorable to agriculture than the roads in the U.S.
Senator Cummins, former chairman of the Senate Interstate Commerce Committee, is one of those who has undertaken a study of the Canadian roads. Comparisons of Canadian and American railroad policies are likely to be frequent in House and Senate whenever revision of the railroad law here is taken up in earnest. The believers in government ownership here, not to mention opponents of that policy, are narrowly watching the affairs of the Canadian roads and how government ownership succeeds. In the present perturbed state of public thought on the railroad question in this country, it is apparent that if the Canadian roads forge ahead under the control of the government, a strong impetus will be given to government ownership here.

SEEKING AID AT QUEBEC FOR TOURIST TRAFFIC

Delegation Waits Upon Premier—Cost Set at \$60,000 a Year—Favorably Received.

QUEBEC, Aug. 5.—The increasing importance of tourist traffic to the Province of Quebec and the need for supplying further information and accommodation to tourists were brought to the attention of the Provincial Government when Mr. Joseph Beaubien, president of the Association of Quebec Tourists' Association, and a number of directors of the Association waited upon Premier Taschereau and his colleagues of the cabinet. The delegation asked the Government to provide a monthly subsidy of \$5,000, of \$60,000 yearly, in order that the aims of the Association might be realized.
In presenting the request of the Association, Mr. Beaubien, the president, said in part: "The Tourists' Association is glad to see the increase of tourist traffic to this province, a condition that has been brought about by the good roads provided by the Government. The larger cities are well organized to receive and look after tourists; our association is now organizing a bureau in Montreal, and Quebec already has an information bureau which is rendering excellent service. But in the smaller cities and towns and in the country there is not sufficient organization to care for the tourist traffic.
To Classify Hotels
"It is our aim to have an information bureau in all the principal centres of the province and we wish to make a classification of hotels. There are many hotels in the province which do not possess prepossessing exteriors but whose interiors provide comfortable accommodation to the tourists; there are others which could be improved. It is the purpose of the association to have inspectors visit all the hotels, make helpful suggestions and so raise the standard. To each hotel, that adopts the standard laid down, the

association will give a flag signifying that the hotel operates with the approval of the association.
"After having made the classification the association will be in a position to recommend them to tourists. With this accomplished the country will profit no less than the cities but in order that the project may be realized we must have the aid of the Government. We ask you, therefore, to grant \$5,000 monthly, or \$60,000 yearly, to defray the expenses of the enterprise. We feel that if the province is recognized along these lines a greater number of tourists will be attracted not only during the summer months but in the winter."
Hon. Mr. Taschereau asked if the association would have only the subscription advanced by the Government and Mr. Beaubien replied in the affirmative, saying that the association thought the Government should launch the project. Later, when the hotel owners saw the good work that was being done, they would also tender their aid.
Hon. Mr. Perron, Minister of Roads, recalled that in the state of Maine the government had advanced a subsidy and two years later the hotels became the sole support of an association similar to that of this province.
Montreal Mayor's Opinion.
Mayor Duquette, of Montreal, was invited to give his opinion and he stated that he was altogether in favor of the aims of the association. The one thing the province lacked was good hotels. "The Americans know," he said, "that we have splendid roads but we must also teach them that we can give them accommodation in the country places as well as the cities. Mr. Beaubien has submitted a plan to me and I think it is practicable and if the Government sees fit to tender its aid it will be reimbursed in a short time. The increased revenue from gasoline alone should make up for the money granted for the encouragement of tourist traffic.
Premier Taschereau asked what Montreal was doing toward bringing about the realization of the project and Mayor Duquette replied that while he could not speak in the name of the city he felt sure that Montreal would back the project to the limit.
Mayor Samson added a few words in support of the association's demands, and Mr. Auguste Pion, president of the Quebec Automobile Club, was invited to express an opinion. Mr. Pion recalled that Quebec was

well organized to receive tourists, but that this was not the case in the country. The Hon. Frank Carrel, M.L.C., quoted statistics to show that the States in the American union which had spent money for the development of tourist traffic had been well recompensed for their expenditure. The State of Maine in particular was cited. There \$75,000 was spent last year and the tourist revenue amounted to \$60,000,000.
Premier Taschereau wished to be assured that the hotels would later take over the expenses of the association and Mr. Beaubien expressed confidence that once the hotel owners were assured that they would make money by encouraging the tourists they would be willing to contribute toward efforts to bring a greater number of people to the province. There would be a certain rivalry that would tend to raise the standard of accommodation offered.
Other members of the delegation spoke briefly then Premier Taschereau assured the members that their request would receive earnest consideration from the Government.
"You ask us for a considerable sum of money," he said, "but our province was the pioneer in the matter of good roads and it cannot ignore a movement such as the present one." The matter will be studied by the cabinet before a decision is reached.
Will Build Up Trade.
It is well known that the big city hotels spend many thousands of dollars in advertising in the United States, thereby attracting thousands of tourists to the cities, but no information is given or effort made to influence these visitors, many of them motorists, to see more of our province outside of the cities. In other words, the chief aim of the new Association is to build up a large country tourist trade for the rural population.
It is considered that if the Tourist Association is financially encouraged by the Governments, which reaps the entire benefit of an increased trade, it will eventually develop business, which it is estimated will leave \$75,000,000 to \$100,000,000 annually in this province. This huge sum will prove an increased benefit to the people. Everyone will benefit directly or indirectly. The Government has already spent many millions of dollars in building good roads and steel bridges. The scenery and other attractions are beyond comparison with any other part of

America. Why not fill the roads with tourists and derive the benefit from their presence. It will lead to the investment of large sums of money for the development of the natural resources as many of our wealthy visitors see opportunities for commercial profit which sometimes escape those residing near at hand.
A Costly Undertaking
To keep up a tourist association is a costly affair. Someone must bear the expense. As the Government derives the greater benefit it is expected to be liberal in its consideration of the request made to it yesterday by the delegation, with the Mayors of the two largest cities in the Province of Quebec.
It must not be forgotten either the tevery state and province surrounding Quebec is now spending huge sums of money for this purpose. Chicago alone are spending \$800,000 in advertising their city in order to fill the hotels with visitors. Almost every city with a population equal to that of the city of Quebec is spending \$25,000 to \$150,000 per year to attract visitors.
If Quebec does not keep up with the times it will not be long before she will regret any inaction in this direction which may ultimately lead to a falling off in the gradually increasing tourist trade to this province. As previously stated, she is in a position to reap a greater harvest from her summer and winter tourist trade than any other part of the continent owing to her many attractions to lure the weary business traveler of rural life.
WIFE USURPED HUSBAND'S DUTIES AS SHERIFF
NEW YORK, Aug. 5.—(By Canadian Press)—John F. Kelley was sheriff of Norfolk county from 1920 to 1922, but his wife usurped his functions so frequently that he had to dismiss her as matron of the jail.
The ex-sheriff gave this information in an answer filed in a separation suit brought by his wife in the Supreme Court in Brooklyn. Mrs. Kelley in her suit had said that she found it necessary on several occasions to lock her husband in a room in the jail at times when he had been drinking. It was in her official position as jail matron, she set forth, that she imprisoned the sheriff on what she alleged were frequent occasions.

A NEW NEGRO DOCTRINE ADVANCED
URGED THAT NEGROES ABANDON GOD OF THE WHITE MAN—A NEW YORK CONVENTION.
(Associated Press Despatch)
NEW YORK, Aug. 5.—The astonishing doctrine that the negro should abandon the God of the white man and set up a God of his own color for his future spiritual guidance was proclaimed yesterday at the fourth annual convention of the Universal Negro Improvement Association in which Marcus Garvey, self-styled "prophet-general" of the proposed "African republic" is the chief motivating spirit.
Addressing the convention, Garvey said: "We have been worshipping a God not in our own image. If man is created in the image of God, how could I have a white father? My God, spiritually and physically, must look like me. When we start to worship anyone not in our own image we are worshipping a false God."
Other speakers expressed similar views.
ALLEGES SPANISH GOVERNMENT UNDER MILITARIST HEEL.
PORT VENDRES, Franco-Spanish Frontier, Aug. 5.—The present Spanish Government is in the hands of a "notorious military officers' committee," by which the directorate is the servant, former Premier Antonio Maura of Spain declares in a letter replying to the requests of many of his followers for his attitude on the present political situation in Spain. The letter was not published in Spain, but copies of it have reached the French side of the frontier despite the strict Spanish censorship.
The former premier assures his inquirers that he will respect any decision they may take although it may be contrary to his own. He says that he considers that the purification and ratification of Spanish official life should be undertaken by a majority of the most sensible individuals of the nation, which cannot be replaced by dictatorship.
Senator Maura expresses his admiration of the directorate from which, he asserts, he separated himself throughout his entire political career. He argues that the directorate, although confessing itself transitory and abnormal, has

\$1,000 PAINTING TO PAY FOR FUNERAL EXPENSES
(Associated Press Despatch)
SYRACUSE, Aug. 5.—A painting valued at \$1,000, entitled "The Shepherdess and the Sheep," is to become the property of a Syracuse undertaker as the result of the recent death of Benjamin C. Frasee, 87, of Baldwinsville, after he had been struck by an automobile in that village. DEVELOPMENT IN IRISH SITUATION CAUSES ANXIETY

Ministers Make Hurried Trip to Dublin—Free State Demanding Immediate Action—Republicans Active.

LONDON, Aug. 5.—(Special) The sudden and unexpected journey to Dublin over-night of the British Colonial Secretary, J. H. Thomas, and the Home Secretary, Arthur Henderson, caused foreboding in political quarters and the newspapers today, where it was regarded as a dramatic development portending a gravor turn to the Irish boundary crisis.

Officials would not talk for publication, but the consensus of opinion of informed newspapermen was that William T. Cosgrave, head of the Free State Government, had found upon his return from London that his ministerial colleagues were not prepared to support the British Government's proposal to introduce in the present session of Parliament a bill amending the Anglo-Irish treaty but to defer its passage until October.

According to this version the Free State ministers insisted that immediate action was necessary to prevent the republicans taking things in their own hands and overturning the Dublin Government. Mr. Cosgrave, it was added, accordingly telephoned Premier MacDonald, who conferred hurriedly with the Colonial Secretary and arranged that he and Mr. Henderson should go forthwith to Dublin.

According to the Westminster Gazette, the British ministers will tell the Irishmen that the Government is powerless to enact the proposed bill now because it is aware that if it attempts to do so the House of Lords will adjourn consideration of the measure, thus blocking its progress.

As an alternative, the paper says, the English emissaries were to tell Mr. Cosgrave that the Government was prepared to introduce the bill immediately as arranged and antedate the reassembly of Parliament by a fortnight, namely on October 14, instead of 28, so as to deal with it. It is reported elsewhere that the Government will also intimate its readiness to summon Parliament even earlier, if events in Ireland make this desirable.

The British ministers are to return tomorrow, when an announcement is expected in Parliament. Anxiety as to the outcome is manifest in many quarters. The attitude of the Conservatives toward the projected bill is uncertain, but there is undoubtedly considerable division of opinion. About 80 Conservatives met last evening and decided to oppose the bill unless it is limited to rectification of the boundary between Ulster and Southern Ireland without the transfer of territory.

"CAL'S" FRIEND WILL BE A CANDIDATE

COBBLER JIM LUCEY OF NORTHAMPTON, MASS., WILL RUN FOR STATE REPRESENTATIVE.

BOSTON, Aug. 5.—"Jim" Lucey threw his hat in the ring yesterday. Widely known as the cobbler-philosopher-friend of President Coolidge, James Lucey of Northampton, finally yielded to the suggestion of friends that he enter politics. He has filed his papers for the Republican nomination for state representative from the first Hampshire district.

LIEUT. LEIGH WADE TRAINED IN CANADA

WAS AT CAMP OF ROYAL AIR FORCE IN 1917.

(Associated Press Despatch) NEW YORK, Aug. 5.—Lieut. Leigh Wade, the United States round-the-world flier who was forced down while attempting the hop from the Scottish coast to Hornafjord, received his first air training in Canada. Lieutenant Wade was one of a number of United States officers sent to the camp of the Royal Air Force at Toronto for preliminary training in December, 1917. Immediately after qualifying as a pilot he was assigned to duty as an instructor. After some time spent in the Canadian flying camp he was transferred to the United States army air service where he continued in the same work. He served in France from August, 1918, to July, 1919.

SIR GEORGE VERY MUCH ALIVE IN TORONTO

(Associated Press Despatch) TORONTO, Aug. 5.—Sir George Greenhill, aged 77, of Woolwich, England, member of the British Association for the Advancement of Science, who has been missing from the party for some days, is in Toronto and has reported at the local headquarters of the annual meeting here. Sir George is well and appears surprised that any anxiety should have been caused by his disappearance.

WORLD FLIERS MEET WITH MORE MISHAPS IN AIR

British Round-the-World Flier Homeward Bound on Canadian Trawler—Argentine Flier Makes Progress.

(Associated Press Despatch) CORDOVA, Alaska, Aug. 5.—Major A. Stuart MacLaren, British around-the-world flier and his companions, are en route aboard the Canadian trawler, Thiepval for Dutch Harbor, Akaka repair in a forced landing in a fog near Nikolai, Komandorski Islands, Siberia, Saturday. In a terse message to the Air Ministry, London, Major MacLaren declared his world flight was abandoned, after flying nearly three fourths of the way around the globe.

Other messages trickling through from the Russian coast told of damage to the wings, floats and tail of his airplane. The messages also declared that no spare parts were available and the world encircling trip would have to be abandoned. Major MacLaren and his companions will return to London via Vancouver.

U. S. FLIERS CROSSING ICELAND

(Associated Press Despatch) HORNAFJORD, Iceland, Aug. 5.—The United States army airplanes on their world flight hopped off from Hornafjord at 9.15 o'clock this morning for Reykjavik, on the west coast of Iceland.

The United States cruiser Raleigh, which has been on station here attending the fliers, proceeded to Reykjavik, where Lieut. Lowell H. Smith, the flight commander, will decide upon the further plans for the flight.

At 10.25 o'clock the fliers passed Skaftaros, 70 miles west of Hornafjord, flying in a strong gale. In the getaway the Chicago, with Lieutenant Smith and Lieutenant Leslie P. Arnold, his mechanic, took the air first. Lieutenant Eric Nelson and Lieutenant John Harding, Jr., in the New Orleans, followed a moment later. They circled the harbor for a moment, waved farewells, and then headed along the Iceland coast toward their destination.

It was the best day since the Raleigh arrived with the sun shining brightly over the glaciers and no trace of fog. From the north came a stiff breeze which it was felt might somewhat impede the progress of the planes but the reports from the destroyers stationed along the route indicated excellent visibility with a generally calm sea.

CHILDREN LOST IN WOODS ARE FOUND

HAD BEEN MISSING SINCE FRIDAY FROM NEW BRUNSWICK HOME

(Associated Press Despatch) ST. GEORGE, N.B., Aug. 5.—Alva Cook, aged four, and Annabelle, aged five, were found yesterday in a weakened condition about four miles from here, after being missing from their home since last Friday. More than a thousand people took part in the search for them.

AGED MAN WAS BURNED TO DEATH

CAUGHT IN FOREST FIRE NEAR SYDNEY, N.S.

(Associated Press Despatch) SYDNEY, N.S., Aug. 5.—Angus McNeill, 90, was burned to death when his house and two others were destroyed in a forest fire which yesterday threatened to wipe out No. 17 section of New Waterford, near here.

(Continued from Page 1) misled. The advances mentioned have been deducted from salary earned and the practice of making such advances prohibited by the Mayor.

Regarding Tax Arrears.

With regard to tax arrears, the report says: "The Tax Collection Rolls for 1923 were correctly posted and balanced with the Controlling Ledger Accounts, the 1923 arrears being \$185,857.02, as per Schedule "A" appended.

"We have carefully checked over the Collection Rolls for 1922 and prior years, which have been out of balance with the General Ledger Controlling Accounts for several years, and have ascertained the correct amounts outstanding as shown by the Rolls aggregating \$151,789.73, as per Schedule "B" appended hereto.

The report states that interdepartmental accounts have been adjusted to agree, many entries having been necessary to affect reconciliation. "Charges considered assets in one department were not entered as liabilities in another department. Certain charges of several years' standing for work done by the Road Department for other departments were adjusted at a meeting of the Finance Committee and the Chief Accountants."

Sinking Fund Accounts.

The sinking fund accounts were thoroughly dealt with in the report. With regard to the Workmen's Dwellings Loans, the auditor states: "There existed for some months a discrepancy in the reconciliation of the bank account, the balance at the bank being \$42.78 less than the Ledger Account, representing two monthly payments of \$21.39."

Removeable Equipment.

"Under the heading of Removeable Equipment, \$218,139.33 is included Road Department equipment in the amount of \$130,311.33. We have been advised that no depreciation has been written off this account for many years and that an actual physical inventory would reveal a considerable shortage. We have, after consultation with the Mayor, set up a Reserve Account of 10 p.c. of the amount for 1923 and would suggest that at the close of this year an inventory should be taken off all road equipment.

Electricity and Gas Dept.

Discussing the Electricity and Gas Department, the report states: "That everything was complete and in order. More attention to collections, however, is urged. The arrears in this department total \$50,886.12, including accounts in litigation, \$23,658.64 and accounts of bankrupts \$5,606.48.

Many City Office Staff Members In Arrears.

"Many of the present City Office Staff are in arrears; one account alone amounting to \$173.70 accumulated over a period of three years; another account in arrears of \$171.75. Former members of the office staff have gone leaving unpaid accounts; one in the sum of \$181.65, for coal.

"We reported personally to the Mayor the condition of the staff accounts and orders were issued to retain 10 p.c. of the salary cheques of those owing accounts until paid in full.

Recommend Monthly Audit.

"We would suggest that the sure method available to the Department for enforcing collection of accounts be used more frequently and more promptly than it is; that of shutting off the supply."
