MEETING OF CITY COUNCIL

Number of Interesting Matters Were Considered at Sitting Last Night.

After an adjournment of a couple of weeks, the City Council held a meeting last evening when several matters of routine were disposed of. There was only a few items on the order paper, but the principal feature of the evening was a violent personal and cowardly attack upon the manager and City Hall reporter of the Chronicle by Mr. Monaghan, B.A., "the gentlemanly representative of Montcalm Ward," as he has frequently been designated by an anonymous letter writer, who seems to have the bump of hero worship phenomenally developed and whose effusive missives have recently appeared in the columns of one of Quebec's leading family journals.

Mayor Drouin presided and among those present were Ald. Cannon, Lavigne, Campbell, Mulrooney, Morin, Pouliot, Cote, Collier, Delisle, Bergevin, Sink, Guillet, Cummings, Lamontagne, Levallee, Messervy, Verret, Ninan, Madden, Barbeau, Goulet, Gosselin, Beaumont, Emond and Uld. Gauvin.

Mr. Aug. Malouin, Assistant City Clerk, announced the election of Mr. Uld. Gauvin as Alderman for No. 2 Seat, St. John's Ward, to replace the late Ald. Matte. Ald. Gauvin was then introduced by Aldermen Lavigne and Delisle and took the seat lately occupied by Ald. Matte.

A letter was read from the Mayor of Campbellton, N.B., thanking the city for its subscription towards the fund for the aid of the victims of the late fire.

A letter from Mr. A. J. Gauvin asking for leave to erect a marquee over the entrance to the Theatre Populaire was referred to the Market Committee.

A petition from Mr. J. E. Bouchard, barber and tobacconist, complaining that By-law No. 277 was not observed, was referred to the By-law Committee. In his petition Mr. Bouchard draws the attention of the Council to the above by-law passed in 1888, and which enacts that from and after the adoption of the by-law all stores, shops, photographic establishments and barber shops in the city of Quebec, shall be closed on Sundays during the whole day and that anybody infringing on that by-law shall incur a fine of \$40 in each case. In his petition Mr. Bouchard requests that instructions be given the city police to see that the by-law was carried out and that such stores be closed on Sundays.

A largely signed petition asking that Mr. W. H. Childs be appointed bread inspector was referred to the Finance Committee, as was also a letter from the secretary of the Trades and Labor Council asking for a grant of \$300 towards the expenses of Labor Day.

Several reports adopted at recent meetings of the Ferry, Fire and Waterworks Committee were adopted as was also the report of the Ferry Committee protesting against the new ferry boats and ordering Mr. Bernier to have them built according to contract.

The by-law concerning the abolition of Champlain market was read and adopted. The principal clauses of that by-law are as follows:

1. Champlain market, in this city, designated in article 2 of By-law No. 394, passed by this Council on the 24th of March, 1905, shall, from the 30th October next, be declared abolished, also the cattle stand thereon, and the market hall and its dependencies.

2. Notwithstanding said abolition of Champlain market, the wharfage dues collected by the city on the wharves of said market shall continue to be collected by said city after the first of November, 1912, unless the city discontinues to use such wharves. An amendment was added by Ald. Verret to the effect that the city would still continue collecting taxes and wharfage dues, until they were removed.

When "Questions" were reached, Michael Monaghan, B.A., rose to a question of privilege and attacked the manager and City Hall reporter of the Chronicle, claiming that this paper did not render him justice. Now Ald. Monaghan was at the meeting apparently bound to have trouble with the Chronicle reporter, as it was well known before the meeting started that he was going to attack this paper. He spoke overtime and the long drawn agony of his speech, which has been accumulating gall and vehemence since February last, reached its

culminating point in the grand finale and which electrified the City Council last evening. Taking advantage of the fact that reporters are not entitled to take part in City Council discussions and are only there to record what happens, Mr. Monaghan, B.A., opened the sluice gates of his macrology, thus giving full play to his torrential abuse, which immediately poured forth like a muddy stream on its natural course and now unrestricted path.

Growing emboldened by the success of his one-sided tirade he then ventured to include several of the English speaking Aldermen amongst the targets of his pent up venom and scholarly wit, including Ald. Cummings, Collier and Messervy, but was somewhat surprised when confronted with a high tariff fence of retaliation. These gentlemen, one after another, interrupted "the gentlemanly representative" of Montcalm Ward and brought him to time for his cowardly attack on those who could not defend themselves in the Council Chamber.

Even Mayor Drouin took a hand in the discussion and informed the fiery Alderman that he had no right to attack other members of the Council. Ald. Collier remarked that Mr. Monaghan, B.A., should be called to order as his remarks were a personal matter between himself and the Chronicle.

Ald. Cannon remarked that Ald. Monaghan had a right to explain, but the latter before proceeding much further was again called to time by Ald. Cummings, Collier, Dinan and Pouliot, who drew the attention of the Mayor to the fact that "the gentlemanly representative" had exceeded his time limit and the latter resumed his seat shortly after.

A lengthy discussion arose on a motion of Ald. Lavigneur that Mayor Drouin and Ald. Gosselin represent the city on the Technical School Commission in the place of Sir Geo. Garneau and ex-Ald. Galipeault, but Ald. Morin objected to the motion and moved as an amendment that Sir Geo. Garneau and ex-Ald. Galipeault be reappointed as the city's representatives.

Ald. Cannon, Madden and Lavigneur favored the change on the ground that the city should be represented on the commission by members of the Council, while Ald. Verret and Morin took an opposite view and referred to the civic representatives on the Board of School Commissioners.

Mayor Drouin considered that he had enough to do without being appointed on this commission and suggested a postponement of the matter and this was agreed to.

Ald. Morin, seconded by Ald. Madden, moved that the Mayor be authorized to appoint a committee composed of five members of the City Council, members of both Parliaments, Board of Trade, Manufacturers' Association and Press to take the necessary means to induce industries to do business in this city.

Both mover and seconder congratulated Mayor Drouin on the efforts he had made in the past to get manufacturers to bring their business to Quebec.

Mayor Drouin, in reply, spoke strongly in favor of the motion and added that something should be done to bring more industries to this city and with that object in view proposed the following committee, which was accepted by the Council:—Ald. Lockwell, Pouliot, Madden, Cote, Trudel, representing the City Council; Wm. Price, M.P., and Ernest Roy, M.P., the Federal Parliament; Eug. Leclerc and L. Letourneau, M.P.P.'s, the Provincial Legislature; O. W. Bedard and W. H. Wiggs, the Board of Trade; Geo. E. Amyot and J. A. Moisan, the Canadian Manufacturers, and Messrs. D'Hellencourt and Watson the Press.

Ald. Messervy gave notice that at next meeting he would move "That the City Engineer be instructed to ascertain the price at which the different proprietors will sell their properties facing the Finlay market square and the adjoining properties facing Sous-le-Fort street as far as Langlois & Paradis with a view to re-establishing a market site to replace Champlain market on Finlay market square.

The Council then adjourned to the 20th September next.

THREE MEN SHOT IN AFFRAY WITH BLACKS. New York, Aug. 12.—Three white men were shot, perhaps fatally, in a shooting affray and hand to hand fight late to-night in the Douglas Club, a negro resort in West 28th street. Sixty men, whites and blacks mixed, participated in the struggle.

BIG SHOW SUNDAY MONTMORENCY FALLS. WAGON LOAD OF ARMS WERE SEIZED. Madrid, Aug. 12.—Advices received by the Imparcial from Vittoria, the capital of the Basque Province of Alava, 30 miles south of Bilbao, say the police to-day seized a wagon load of arms and ammunition destined for the monasteries.

FIRMS WHO WISH TO BUILD CANADA'S NAVY. Ottawa, Ont., Aug. 12.—In connection with the Canadian Navy, parties desirous of tendering were notified recently to send their names to the department. When the admiralty plans are ready they will be exhibited privately to such firms as have asked to be inscribed on the list are Harland & Wolff, Swan & Hunter and Vickers, Son & Maxim. The Canadian firms are the British Columbia Marine Works, Victoria; the Polson Iron Works, Toronto, and the Collingwood Shipbuilding Co. Other British firms have been making inquiries.

INSPECTOR DEW IS AT FATHER POINT

Scotland Yard Man is Awaiting Arrival of Detective Mitchell.

Father Point, Que., Aug. 12.—Inspector Dew, of Scotland Yard, is in Rimouski to-day, and was seen by several on the street in company with Chief Charles Gauvreau, of Rimouski town. As the steamship Lake Manitoba, of the C. P. R. Steamship Company, from Liverpool, is reported in the Gulf, and will be at Father Point to-morrow about noon, and it is said that Constable Mitchell, of Scotland Yard, is coming out in that steamer, this leads to the conclusion that Inspector Dew is coming to meet his colleague and consult with him in reference to the proofs and documents that the latter is supposed to be bringing out in reference to the Crippen-LeNeve case.

Inspector Dew left yesterday for Father Point to meet the incoming steamer Lake Manitoba, upon which Detective Mitchell is now a passenger on his way to Canada, with the necessary papers for the transfer of Dr. Crippen and Ethel LeNeve to England.

The steamer is expected to reach Father Point some time Saturday night. With the arrival of Detective Mitchell the last chapter in connection with the Crippen case so far as Canada is concerned will come to an end, and interest in the matter will then be transferred to London.

Lindsay, Ont., Aug. 12.—The famous detective of Scotland Yard, Inspector Dew, arrived in town yesterday afternoon incognito and will spend a few days fishing on the Kawartha Lakes in the vicinity of Fenelon Falls. He was met at Toronto by Mr. Archibald Clarke, of Oklahoma, a brother of Mr. Alexander Clark, of Lindsay, who is at present summering at Fenelon Falls, and the party motored to Lindsay and through to Fenelon Falls. Mr. Dew stated that he was only enjoying holidays and that his visit had nothing to do with the Crippen case.

QUEBEC MAN FOUND STARVING

Discovered in a Warehouse at Niles, Mich., After Four Days.

Detroit, Mich., Aug. 12.—Benjamin Dewitt, an elderly man, giving his home as Quebec, was discovered last night in a warehouse at Niles, Mich., where he had been for four days and nights, and when rescued was in a dying condition from starvation. Men with a moving van stopped opposite the shed, heard moaning sounds and discovered Dewitt. He had been working on the Beebe Mint farm east of here and wandered away. It is said he has children and relatives living in Quebec.

SUDDEN DEATH OF MRS. GRUNDY AT SHERBROOKE. Sherbrooke, Aug. 12.—Mrs. Frank Grundy, wife of the Vice-President of the Quebec Central Railway, died here very suddenly this morning. She had been enjoying her usual health until the time of death. Mr. Grundy is very feeble, and has to be wheeled out in an invalid's chair.

C.M.B.A. VOTES RELIEF TO FIRE SUFFERERS. Ottawa, Aug. 12.—At the C.M.B.A. convention to-day the old officers were re-elected and installed. After a discussion the delegates voted \$500 to the Roman Catholic sufferers from the fire at Campbellton, for whom Hon. John Morrissey, Minister of Public Works for New Brunswick, made a strong plea.

BRITISH TEACHERS LEAVE FOR HOME

Sailed for England by the Steamship Tunisian Yesterday.

Some 50 British school teachers, who have been making a tour of several weeks in Canada, sailed for home on the steamer Tunisian, which sailed yesterday. Everybody in the party was greatly impressed with their trip.

The party was in charge of Mr. T. Gautrey, Secretary of the London Teachers' Association, and also a London County Councillor, who was unanimously chosen as the mouthpiece of the concrete impressions of the rest.

"I hope," said Mr. Gautrey, "that I have sense enough not to dogmatize on this very brief impression of Canada. The first impression we gained was the vastness of everything as compared with the concentration in the old country. When you consider that within 120 square miles of London we have a population equal to the whole of your vast Dominion you can appreciate this feeling.

"The next point that struck us very strongly was our vigorous climate, which should assuredly produce a vigorous race. Wherever we went we were followed by thunderstorms. But instead of the lingering rains that we were used to in England there were violent storms, and then bright sunshine, which proved most agreeable to all of us.

"But perhaps the most remarkable thing we observed everywhere was the intelligence and alertness of the people. Everywhere the citizens seemed to be well trained, keen and on the lookout for something better."

"But," said Mr. Gautrey, "the widest impression we gained was that of the intense patriotism of the people, not only to Canada but to the Empire, which struck us everywhere, particularly in Ontario."

STURGEON JUMPS INTO MOTOR BOAT

Injures Woman, Wracks Engine and Nearly Causes Craft to Drift Over Niagara Falls.

Niagara Falls, Aug. 12.—A sturgeon, measuring six feet eight inches in length and weighing 150 pounds, jumped into a motorboat last night at 11 o'clock near La Salle, two miles above Niagara Falls, seriously injuring a woman occupant of the boat and disabling the engine so that the whole party would have been swept over the cataract had not help arrived just in the nick of time.

Sebastian Smith, the owner of the boat, set out from La Salle about 9 o'clock with a party consisting of Nellie Johnson and Frank Lonsdale of Niagara Falls. As the boat was returning down stream the huge fish jumped for the bright searchlight on the boat and struck Miss Johnson on the back, seriously injuring her. The fish then lurched against the engine, disabling it, and was only subdued after twenty minutes' hard work by the men of the party.

All this time the boat was drifting nearer the Falls and would have been swept over them had not George Allen of La Salle heard the cries of distress and towed the drifting craft to safety with his motorboat.

IRISH CASTLE DESTROYED

Daughter of a Baronet Burnt to Death in Her Room.

Two terrible fires have occurred in Ireland. Menlough Castle, Galway, the seat of Sir Valentine Blake, Bart., was burnt to the ground, his eldest daughter perishing, while two servants sustained fatal injuries by leaping from the turret. Away up north, Kelvin Hotel, College Square, East, Belfast, was destroyed. Here also three lives were lost, and in addition, five persons were seriously injured.

The awful feature of the fire at Menlough Castle was that Miss Blake was an invalid, and practically unable to move. Sir Valentine had gone with Lady Blake to Dublin for an operation for eye trouble, and, besides Miss Blake, two female servants and a coachman named James Kirwan, who occupied a top room over the hall door, was awakened at half-past five in the morning by the women's screams. On opening the door he was almost blinded with the onrush of smoke and flames. Escape by the staircase was completely cut off.

The man burst out the window sashes, and flinging a few articles of clothing on the ground below, climbed out. Then, seizing the ivy which grew in profusion on the walls, he proceeded to lower himself to the ground in his night attire. He had not got very far when a portion of the ivy gave way, and he fell, alighting on his head. Luckily, the ivy partly broke his fall, so that he was only momentarily stunned. The window from which he emerged was fifty feet from the ground.

Desperate Leap.

Quickly donning the clothes he had thrown out, Kirwan rushed around to the castle frontage on Lough Corrib, where Miss Blake's apartments were situated, and found that this wing of the building was a seething mass of flames. He ran on to the south end, and there saw the two servants on the roof of a wing overlooking the courtyard. They were in a terrified condition, and were screaming at the top of their voices. Behind them were hissing torrents of flame, leaping nearer every minute, and in front was a jump of forty feet. The girls shrieked to him to save them.

Kirwan ran to the lodge close at hand, rapping up Ward, the gateman. The two returned, and procured a ladder, which, unfortunately proved too short by about twenty feet. The girls were still screaming, and their agony was intensified by the heat, which was now overpowering. The ladder proving useless, the two men gathered bundles of hay close to the wall, and the girls, now frantic with terror, jumped to the ground. Both alighted on the hay. Miss Early was killed on the spot, while the other girl's neck was broken. She only lived a few hours. The firemen arrived from Galway, three miles distant, to find the castle a smouldering ruin.

Efforts were made repeatedly to find some trace of the remains of Miss Blake, but they proved fruitless. The unfortunate lady was a sufferer from rheumatism, and could move only with difficulty. The floors had all fallen in, and nothing remained but a smouldering heap of debris. It is believed that the fire broke out in her apartments.

The castle, totally demolished, was a splendid mansion, built on Loch Corrib, seven centuries ago, by an ancestor of the present baronet, who is the fourteenth of his line. The founder of the family is said to have accompanied King John to Ireland in 1185. All the family heirlooms, the accumulations of ages, have been destroyed. So, too, has a valuable collection of paintings and armour and rich and rare tapestry.

Topics of the Day

MAYOR GAYNOR, A POSSIBLE PRESIDENT.

Mayor Gaynor, of New York, who has been laid low by an assassin, has been one of the bright hopes of Democracy for some years past. Should he survive his wound he seems destined for high honors, and some such programme as that followed by Grover Cleveland has been mapped out for him. Were it not for the fact that the powerful Hearst influence has been strongly opposed to him, his path to a Presidential nomination by the Democratic party would seem comparatively clear. It is a question whether the implacable hostility of Hearst could defeat an ambition which Mayor Gaynor is known to have cherished. The attempt upon his life, should it not have a fatal ending, will be a great stimulus to the Gaynor boom, since it can easily be argued that to protect the New York taxpayers from incompetent and dishonest service he risked his life.

A Bitter Campaign.

No sketch of Judge Gaynor's career can properly ignore the accusations that were brought against him last Fall when he became a candidate for the Mayorality. It was then claimed that almost every single item in his official biography, from the spelling of his name to the date and place of his birth was inaccurate. The muck-rakers failed to show any reasonable motive for the deception said to have been practised by Judge Gaynor, and the charges were generally disbelieved. The candidate denied them at any rate and entered suit against the newspapers that he said had libelled him. What has become of these suits is unknown, but the probability is that they were dropped after he attained office.

Reform from Within.

Leaving aside the dispute points in his career, one of which concerned his early education in a Roman Catholic seminary (his accusers intimating that he had become a priest), we find him a practising lawyer in Brooklyn in 1875. He made a success of his business and became deeply interested in politics. His political career greatly resembled that of Folk, of St. Louis, for he was a bitter antagonist of the rings within his own party and was responsible for securing the conviction of the notorious John Y. Kane for election frauds. In 1893 he was elected to the Supreme Court of New York State, and later on became a justice of the Appellate Division of this court.

The Famous Duffy Case.

In this position he came into national prominence through his decision in the famous Duffy "mugging" case, which provided the impetus that landed him in the Mayor's chair a year or so later. The Duffy case was that of a young man, who had been arrested on some minor charge, which was dismissed by the magistrate. In the meantime his photograph and Bertillon measurements had been taken by the police. Young Duffy found himself being closely scrutinized by every policeman he met on the street. He was treated as a suspicious character, and found the attentions most annoying. His father appealed to the police to destroy the photo and records, but they refused. Then he interested Gaynor, and the result was a judicial order for the surrender of the police dossier of young Duffy. Accompanying it was a severe condemnation of police methods generally, which resulted in the dismissal of Gen. Bingham, Chief of Police, and the subsequent censure of Judge Gaynor.

Tammany Defied.

Because he was elected on the Tammany ticket, his opponents predicted that he would become a mere tool of Charley Murphy, the boss of Tammany Hall. These prophecies have not been realized, and the Tammany appointments of Mayor Gaynor have been few. His whole attitude has been that indicated in the Duffy case—that of an opponent to officialdom—that of an opponent to officialdom. About his latest public utterance was a condemnation of the practice of the police making arrests for minor offences. He wanted the Cleveland plan of Chief Kohler to be adopted, and in this course, as in all his other clashes with the police, he had the great bulk of New York public opinion solidly behind him. Since he has been Mayor two of his daughters have eloped, thus adding to his other perplexities and worries. Though his term in office has been short, the general impression is that not in a generation has New York had such an energetic practical reformer. His re-election was a foregone conclusion.—Toronto Mail.

GOLF CHAMPION YOUNG IN EXPERIENCE

Robert Gardner First Gained Fame in the West Last Year.

Robert Gardner, the present U. S. national champion, gained his first renown last year in the Westward Ho tournament by defeating Charles Evans by 1 up in the thirty-six hole final round. He proved his ability before the shadow of a doubt in the amateur championship at Wheaton, when he did nothing but beat good men. His first victim was Hugo R. Johnston, Myopia Hunt Club, whom he beat by 1 up. In the second round he met his easiest mark, L. H. Rein-king, Wheaton, whom he took into camp to the tune of 6 up and 5 to play. Walter J. Travis, Garden City, was his opponent in the third round, and the old warrior had to succumb to youth and vigor, being beaten by 2 up and 1 to play. Mason E. Phelps, Middletown, a former Western champion, was his opponent in the semi-finals and he beat him by 2 up, while his opponent in the final round was H. Chandler Egan, several times intercollegiate and Western champion, and the national champion of 1904 and 1905. Egan had disposed of such cracks as "Chick" Evans, the Western champion; D. E. Sawyer and Warren K. Woods, and his defeat at the hands of Gardner was unexpected and the surprise of the tournament. Gardner proved himself a great match player while at Yale during the past year and his victory last Saturday over Walter J. Travis, in the final round of the Glenview invitation tournament, showed clearly that he is a golfer of the first rank and that he will make a strong fight to defend his title in the sixteenth annual championship, which is to be played next month at the Brookline Country Club.

AMERICAN YACHTS CHOSEN FOR BIG RACE.

Marblehead, Mass., August 12.—The Harpoon, owned by C. F. Adams, and the Beaver, owned by C. H. W. Foster, both of the Eastern Yacht Club, were chosen to-night as two of the American competitors in the Spanish American condor yacht races off here next week. The third American boat will be chosen after to-morrow's trials.

MAHARAJAH SAYS FIGHT WAS TAME

Visitor from Bengal Tells of Contests There with Steel-Spiked Gloves —Pitties Newport Society.

New York, Aug. 12.—"Perhaps it will please your Royal Highness to discuss prize fighting, and especially the action of Newport society people in applauding the reproduction of the brutal Jeffries-Johnson battle," suggested a visitor to the Maharajah of Mourhanj at the Waldorf yesterday.

The Indian ruler's blackest of black hair bobbed in animation and his brown visage took on a grin. "Certainlee, I will discuss that," he answered. "But, oh yo Americans. You are so funny. You get your fun out of words which you mistreat and place around one another. For example, you said 'brutal' battle when you mean anything but that. Oh, it is funny."

"But," protested the visitor, "I said brutal battle and I meant it." "But do you mean to say you call that brutal?" The Maharajah's tone was puzzled as he went on. "Why that fight was—what you might call a rabbit's paw to some we used to have in India. You know in the provinces where I come from there were and still are some real fights. Over the hands of the warriors is a steel glove and in the knuckles of the glove are deeply imbedded nails and spikes. Then the men are ready for a real battle. And when one gets a blow like this"—the Maharajah illustrated with a swift lunge in the visitor's direction—"why one feels it."

"Sometimes even"—the Maharajah's voice was almost apologetic, "sometimes even one of the fighters is killed. Yes. You don't kill them here, I understand. This Jeffries, he was not even badly hurt."

"But the people at Newport, I do pity them. Have they really nothing better to do than watch pictures of such tame encounters? Can't they find something really exciting? This talk about this prize-fighting reminds me of a story someone told me the other day. Once, so the story says, there was a man—a white man—travelling about in India with two of your prize-fighters. There was in a nearby province a wise old Rajah who was fond of pugilistic encounters. The white man heard about this and approached the Rajah, with the result that the latter offered a large sum of money to the winner of a fight between these two men. Fifty thousand dollars was to be the price to the winner and nothing to the loser.

"Well, the two fighters being wise, agreed to—what do you call it?—stall, yes, loaf on the job. They would go easy, the one with the other, and then each would take half of the Rajah's money. But the Rajah had also much wisdom and he suspected the plot and made plans also.

"Well, the day of the encounter came. Just as the two battlers were to go into the roped-off enclosure, a bag of money was brought in and \$50,000 counted out on the floor. 'This is for the winner,' said the Rajah, and 'this,' he added, 'is for the loser,' and he drew his rapier and made a motion as though stabbing a man. "Just then the signal was given and the men forced into the ring before they could say a word. Well, there never was such a bare-knuckle fight seen in India before. It lasted for hours. Then the winner was given the money.

"And was the loser given the rapier?" broke in the visitor. "That I know not," smiled the Maharajah, "but I do know your fight here are oh, so tame."

The Maharajah has decided now not to sail until next week on the Mauretania. Since he was taken to Coney I land on Tuesday by John Heitmann, he has expressed a desire to stay here a month. Mr. Heitmann said last night that the Maharajah was as tickled as a boy at the sights of Coney. "I saw my old friends of the jungle, the elephants," said the Maharajah. "Everything else was intensely American and ripping. We had a most nobby time, but it being my first visit, I rather feared to try the 'chutes' and some of the other slides in your Dreamland."

RESTIGOUCHE WON THE FEATURE AT SARATOGA

Saratoga, N.Y., Aug. 12.—Restigouche, outclassing his field, easily won the Schenectady selling stake, one mile, the feature card, here today. He was ridden by Shilling and the boy put up a fine ride. Shilling had a good day, riding the winners of the second, third and fourth races. Butwell was severely criticized for his ride on Herkimer in the second. He was riding the best horse, but he pulled on the rail in the deep going, which brought about the defeat of the colt.

IT'S AU FAIT FOR WOMEN TO SMOKE

Criticism is Resented in Washington Where the Practice is General.

Washington, Aug. 12.—In this city where society is tinged with the foreign habits of the diplomatic set, and where cigarette smoking is so common among society women that it is no longer a matter of much comment, there is a strong feeling that the anti-cigarette crusades have been unfair in directing their criticism at one or two individual women. Among the clergy, none could be found to-day to defend or condone the practice, but there was a general opinion that recent criticism has been unjust in a personal way.

The practice, it was pointed out, was not confined to any especial few, but was quite general among fashionable women. As a regular feature of practically every ultra-fashionable dinner party here cigarettes are usually provided for the women. The old-fashioned idea of the women leaving the men at the table to smoke their cigars has almost entirely disappeared, as now the men have their cigarettes and liquor in one room, and the women have theirs in another. When the occasion is informal and the company is intimate, it is not unusual for the women to smoke at the table with the men.

THEY CARRY CASES.

A cigarette case as a feature of the fashionable woman's chateleine is not a sufficient rarity here to attract attention. At a recent amateur theatrical performance a purse was stolen from a prominent feminine member of the "younger set." The loss was advertised in the papers, and among the contents of the purse was a jeweled cigarette case. The name of the owner was given without any apparent thought of embarrassment. All the fashionable jewelers here carry a large stock of women's cigarette cases. As presents from men, they are quite common. It is not a rare sight to see the wife of a foreign diplomat smoking complacently as she sits on the lawn of her home on a pleasant evening. Some foreign women, prominent here, have been known to smoke cigars. Though these facts put the Washington situation in a light different from that in other American cities, the local clergy fail to find any defence for the habit.

PASTOR CONDEMNS IT.

The habit of cigarette smoking among women is to my mind a thoroughly pernicious one from any standpoint, said Canon Austin, of St. Thomas' Episcopal Church, recently.

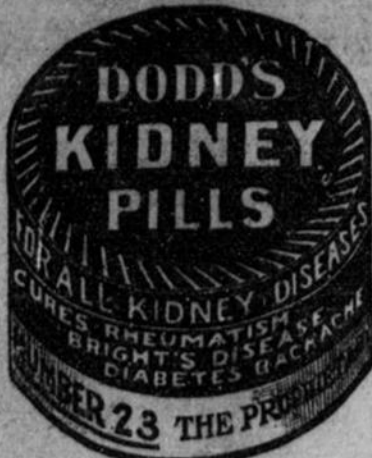

QUEBEC SHIPWRIGHTS PRAISED.

The Montreal Gazette of yesterday, speaking of the arrival there of the steamer Prinz Oskar, says: "To-day the Prinz Oskar is lying at Windmill Point, and to all appearances is as good as a new ship. With plenty of new paint and a general scouring, she looks as unlike the boat that crept up here two months ago after a strenuous time of it on the rocks in the Gulf as can be imagined. Now that it is all over, her officers are by no means reticent in speaking of their experiences, as they were when she came here as a lame duck, and by all their accounts the experience they went through on the Flower Ledge is not one that any of them will care to repeat. The position in which the ship lay after she struck was a bad one, and had there been much wind on any one of the three days that they were fast on the reef nothing could have saved the ship, in their opinion, from becoming a total wreck. As it was, said one of her officers last night, when we got a good look at the coast line, none of us ever thought we should get off at all, much less bring the ship off, and be sailing home in her within two months. It was a great piece of luck. The only thing that made it possible for the ship to be salvaged was the fact that the whole time she was on the rocks hardly a breath of wind blew, never more than sufficient to ruffle the surface of the water. While disclaiming any credit for themselves, the officers are loud in their praises of the way in which the Prinz Adalbert and the Sicilian stood by them at the start, the latter taking off the passengers, while the former spent hours in an endeavor to get her sister vessel off the reef. Nor could anything well have been done better, in their minds, than the work which was done by the two wrecking tugs which were sent out to their assistance from Quebec, and which, after almost superhuman efforts, succeeded in getting the Oskar off, just a few hours before a strong breeze blew up, which would undoubtedly have made scrap iron of her, had she still been on the reef. The work of repairing the ship had been done in a most efficient manner, quite as well, said Captain Bramber, as any yard in Europe could have done, and infinitely better than he had expected."

HUMORISTS IN OLD QUEBEC

One of the Press Jokers who has Been Doing Canada Writes About His Trip. (H. E. W. in Baltimore Sun) Last week the eighth annual convention of the American Press Humorists, organized in 1903 in Baltimore, was held in Montreal. From Baltimore to Buffalo, across suspension bridge to Toronto, on to Montreal and down the St. Lawrence to the Far North city of Quebec, with a frowning Citadel and picturesque people, and then to Montmorency Falls, where the home once occupied by the father of Queen Victoria has been turned into a boarding house, and still on to the shrine of St. Anne de Beaupre, the Mother of nuns, were pilgrims wear a path in the hope of health—it is a wonderful trip. The ride down the St. Lawrence from Montreal to Quebec is a wonderful scenic delight. Quebec itself is an intensely interesting city. Old Quebec lies along the water front, under the Citadel, low and rakish. The streets are narrow and board-paved; the inhabitants are chiefly French. In the Sous le Cap we were climbed upon and bailed about by dozens of children, who begged for pennies and sang the "Marseillaise" for a half-dime. On the Citadel the soldier guide accepted a half-dollar tip without embarrassment, and then seized a whole roll of films because a camera fiend shot the barracks. The Citadel stands high over the Old Quebec on a mountain of slate. Not long ago the slate slipped and 10 lives went out, caught in the humble homes below. Volumes have been written about Quebec. All the written history has not scraped the human interest. Montmorency Falls, seven miles from Quebec, stand 109 feet higher than Niagara, but narrow, and there is no whirlpool; there are no rapids, for all the tons of water go into Hell Hole and are seen never again. A suspension bridge over the falls broke on the day of its opening and let an inhabitant, his wife and child down into Hell Hole. No sign of them was ever recovered. The massive pillars stands on either side, left there as monuments of the catastrophe. St. Anne de Beaupre, the shrine of the faithful since grateful shipwrecked sailors erected a small church in the sixteenth century, is a marvellous exhibition of human faith in supreme power. The railroad runs that way chiefly for pilgrimages, tourists being a side issue. Processions of monks and nuns pass around and through great bodies of kneeling pilgrims, come there to drink the holy water, offer their devotion and be cured miraculously. At the altar there is a stack of crutches and bandages left by suddenly cured cripples; in the foyer another great stack gives silent testimony to the healing power to the Mother of Mary. A case filled with jewels, watches, coins, vestments, silver and gold stands for the gratitude of the healed. Father Apollinaris took us around and asserted nothing. "I show you the evidence," he said "and you must reach your own conclusions." H. E. W.

WILL BUILD RAILROAD TO HELP FIGHT ON CARLISM

Statistical Line to Aid Government in Suppressing Disorder in Navarra. San Sebastian, Aug. 12.—The alertness of the government at the present juncture is evident by the publication in the Madrid Gaceta, the official organ, of an invitation for tenders for the construction of a strategical railway line from Pampluna through Estella to Logrono, which is well known as the Carlist zone.

Baron de la Torre, the civil Governor of San Sebastian, says he is quite unconcerned about the decision of the Catholic juntas to keep up their organization permanently, for he is convinced that they will not make any attempt at further political action. The Governor states that the situation is so tranquil that tourists have no need to feel the least apprehension. Though the weather is unsettled there is already much animation here and the season will be in full swing when the King returns at the end of the month.

The old Kingdom of Navarra, on the northern and southern borders of which are situated, respectively, Pamplona and Logrono, has long been noted as one of the chief centres of Carlism in the North of Spain. It adjoins the Basque provinces where the present agitation has its strongest supporters. Excepting the railroad line from Saragossa, which joins the main line from Madrid to the French frontier at Miranda de Ebro, after passing through Logrono, and a short line on the northern boundary of Navarra, from Alsasua to Pampluna, the district is without railway communication. This fact has increased the difficulties of the government in dealing with local disturbances. The length of the proposed line would be about fifty miles.

Estrella, midway between Pamplona and Logrono, is in the very heart of the district. Here it was that Don Carlos had his headquarters during one of his attempts to seize the Spanish throne. It was at Estrella, too, that Captain Schmidt, a German officer attached to the republican army as a war correspondent, was shot by order of the Pretender in 1874.

HAPPENINGS IN EUROPEAN CAPITALS

Noted English Practitioners Who Qualifiedly Endorse Faith Healing.

London, August 12.—A recent issue of the British Medical Journal contains a remarkable collection of articles on faith healing by leading surgeons and doctors, the substance of which the Journal summarizes thus:

"There are bodily ills which cannot be cured by pills and potions, but which yield to methods which, for want of a better word, may be called 'mental.'"

"In suggestion, then, lies the secret of faith healing. But it must be applied by the right person."

"There is not the least excuse for branding every person who assists in spiritual healing as a fool or a rogue," says Mr. Butlin, President of the Royal College of Surgeons of England. He reminds us that cancer, on which he is an authority, sometimes gets well spontaneously.

Sir Clifford Allbutt, Cambridge Professor of Physics, says that "probably no limb, no viscous is so far a vessel of dishonor as to lie wholly outside the renews of the spirit." Sir Henry Morris, ex-President of the Royal College of Surgeons, holds that there is nothing in the "cures" at Lourdes that cannot be matched by the operation of natural causes, and brings forward in illustration some striking cases of the immediate and spontaneous cure of diseases which had brought the patient to death's door.

Both Sir Clifford Allbutt and Mr. Geoffrey Rhodes suggest that the explanation and justification for some cures may be found in the quickening of some sources of psychic energy of which very little is known at present, but the existence of which is proved by the task, for instance, that a feeble woman may perform for her child, entailing a herculean effort on the part of mind or body.

Students in Airtight Box Withstand Excess of Carbonic Acid Gas

The danger of an excess of carbonic acid gas in the air, the property which makes an overcrowded, stuffy room so unpleasant, has been robbed of all its terrors as the result of an experiment carried on recently at the London Hospital.

To eight perspiring, shirt-sleeved students, crowded in an airtight box five feet long, five feet wide and seven feet high, breathing their own expired air over and over again, at a temperature of 85 degrees Fahr., is due the proof that carbonic acid gas, formerly considered such a deadly poison, can be breathed with impunity in doses forty times as large as the law allows.

In their hermetically sealed box the eight students experienced all the sensations of gradual suffocation for three-quarters of an hour, until the carbonic acid gas rose to four per cent. A stuffy theatre atmosphere might contain one-thirtieth of one per cent. Peering through the large glass windows in two walls of their prison we could note their perspiring, flushed cheeks, quivering nostrils and general air of physical discomfort.

When the temperature from their breathing and the radiations from their bodies drove the thermometer up to 88 degrees Fahr. (most people keep their rooms at about 68 degrees Fahr.), Prof. Hill shouted: "Are you ready for the fans?" A chorus of "Yes" from the prisoners, and three electric fans were turned on from the outside. No fresh air was admitted, the fans simply stirring up the moist carbonic-acid laden atmosphere.

The effect was little less than magical. The students immediately stood more erect, breathed more easily and deeply, and began once again to chat and joke with one another. On coming out none of the men showed any signs of the trying ordeal he had just gone through.

"This experiment," Prof. Hill stated, "proves conclusively that the carbonic acid present in a stuffy, overcrowded and ill-ventilated room is not the cause of the unpleasant symptoms we formerly associated with these conditions. It is the moisture, high temperature and stagnation of the air which gives us the headaches and dullness."

How Pluviose Heroes Died.

at the point where his duty set him. Lieut. Callot, officer commanding, was taken from the spot where he stood watching the mirror of the periscope. Lieut. Engel was in the fore compartment by the torpedo tube; Le Breton, the helmsman, at the wheel in the conning tower; and the mechanics by the engines.

The holes in the hull of the Pluviose cut by the keel of the Pas-de-Calais are both aft, and the officer commanding a Calais torpedo boat explained there was no doubt that the submarine was diving below the channel steamer to display her capabilities to Commander Pratt, in charge of the second submarine flotilla, who was on board making an inspection, and, the distance being misjudged, was brought to the surface too soon. Her bows went under the Pas-de-Calais. Her after compartments were caught and ripped open by the force of the collision.

So quick was the rush of water that the doctors state death must have been instantaneous to all except Le Breton.

At 1.53 the collision occurred, and yet the watches upon the officers were stopped at 2.10 and 2.18, but this discrepancy in time is set down to the fact that it would take some minutes for the water to percolate to the inner watch pockets.

Neither of the two officers, therefore, had time to write a message setting forth the cause of the disaster. Perhaps Le Breton had time, but he had nothing wherewith to write. No communication, if made, could have lasted against the action of the water, for even the markings upon the binnacle card were obliterated when the compass was taken out.

Bisley's First Chinaman Crack Shot.

A slim khaki-clad figure lay for hours in the long grass of the Bisley ranges, recently, striving hard to understand the vagaries of the English winds. It was Tan Cheow Kim, the first Chinaman to shoot at Bisley, and a member of the Singapore team, who have travelled many thousands of miles to take part in the contest for the Empire Cup at the forthcoming meeting.

Nine years ago, when the first battalion of Singapore native volunteers was enrolled, Cheow Kim, then a youth of 17, was the first to enlist. His enthusiasm carried him far, for to-day he holds the rank of sergeant, and has won the reputation of being one of the finest Chinese shots in Asia.

Though he has now been in England a week, he has only twice left Bisley to visit London and see the sights. "I must practice, practice!" he said yesterday, in excellent English. "It is very difficult to shoot in England, so varying are the winds, so peculiar the vision. There is much work to do, and afterwards I shall play." He promptly followed these remarks by scoring four bull's-eyes.

Catholic King Defends Reformation Leaders.

King Frederick August of Saxony, the Catholic monarch of a Protestant realm, has become the most popular Prince in Germany as the result of his action in personally protesting to the Pope against His Holiness' "Borromeo" Encyclical, which attacked the characters and morals of the reformation leaders. When the King appeared in the streets of Dresden recently he was the object of remarkable ovations.

Tragedy of the Alps.

An Alpine tragedy of peculiar pathos is reported by the Grenoble correspondent of the Matin. Two climbers, M. Allimand and Mme. Baroumet, set out recently to follow the course of the River Roize, to follow their way in the fog, and fell 30 feet on to a ledge just by a waterfall. M. Allimand expired from his injuries and from the effects of exposure and starvation. They were finally seen by peasants. Mme. Baroumet was rescued and carried to a chalet, but M. Allimand's body could not be found.

Before his death M. Allimand wrote a message for help and pinned it to his hat, which he cast into the stream. The hat was eventually found, the message still being perfectly legible.

Repics of the Charleses at Auction.

A Scotch sporting estate, seven and twenty thousand acres of forest and moor, was recently advertised for sale. Also Strathhallan Castle, the Perthshire home forfeited by the Drummonds of Strathhallan when their chief fell in Culloden leading Prince Charlie's Scots, and bought back by them from the Crown after the forfeiture.

Another sale announced was that of an heirloom which has never before come to the dealer's hands. This is the Symons bowl. Its owner styles it a "mazer," but it is, perhaps, better described as a deep punch-bowl turned in hard wood and set, like a burly wine-glass, upon a squat stem and a broad foot.

When King Charles II. was in flight after the battle of Worcester with Cromwell's horsemen at his heels, he had one welcome night's lodging in the old house of Hampledon, in the heart of Hampshire, belonging to one Thomas Symons, who, although he took His Majesty for a wandering Roundhead, plied him hospitably with ale and stronger drink.

Symons' wife, Ursula, the sister of a Cavalier colonel, may have made a better guess at the quality of the stranger. "In any case, they were both enlightened when the King came to enjoy his own again, this bowl, with its wooden ladle and cups and royal arms in gold on the side of it, being the King's gift to his Hampledon hosts.

Thomas Symons' granddaughter carried the famous bowl to her husband, a Blackman of Chichester who is now ready to part with it.

IRISH LOVE TRAGEDY.

Stung by Reproach, Girl Drowns Herself in the Night.

A pathetic love story came from Bushmills, in the romantic Giant's Causeway district of County Antrim.

One evening recently Miss Matilda Armour, the handsome nineteen-year-old daughter of an extensive farmer in the district, walked home from a Good Templar meeting with her sweetheart. He is a well-connected young fellow named Stewart Christie. The girl's mother, who had been visiting a friend, arrived home shortly after ten o'clock, just as the young man was leaving the house. 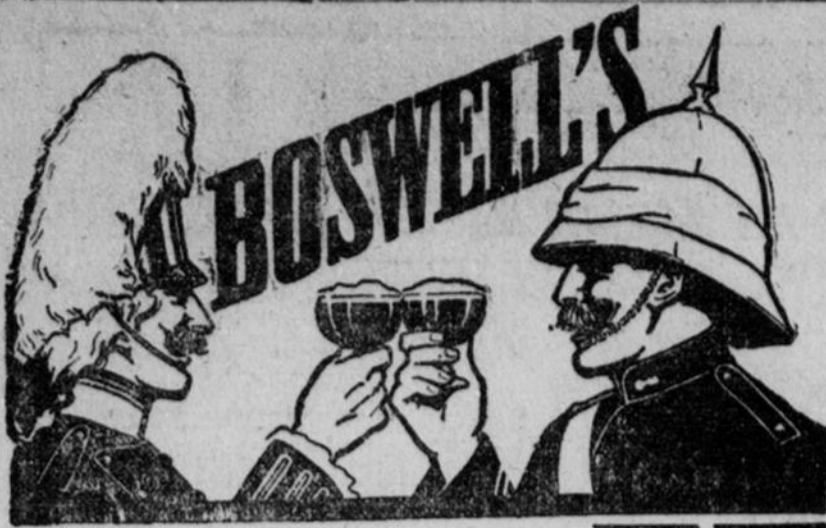

GREAT TICHBORNE TRIAL RECALLED

Death of Sir Henry Tichborne, a Baby When Claimant Appeared.

The death has occurred of Sir Henry Alfred Joseph Doughty-Tichborne, at his seat, Tichborne Park, Alresford, Hampshire, from a paralytic stroke.

He returned a few days previous from a big game-expedition in Africa, where he had spent some months, apparently quite well, and motored from Southampton to Tichborne, but after dinner he had a seizure. His condition rapidly became critical. Lady Tichborne was present at his death. His only son and heir, Lieut. Joseph Doughty-Tichborne, 8th Hussars, is in India with his regiment.

Sir Henry, who was only forty-four years of age, had been a baronet since his birth, and was the infant over whose head was fought the celebrated Tichborne case, which lasted several months, in 1872, and was the longest modern trial before an English court. The summing up of Lord Chief Justice Cockburn occupied a month.

The Tichborne case is, perhaps, the most famous romance in the annals of the law. Sir Henry's Uncle, Roger Charles Doughty-Tichborne, son and heir of Sir James Tichborne, was disappointed in love. In January, 1852, he placed a will in a sealed packet, and, after having seen his father and mother in Paris, sailed for Valparaiso.

From that port he wrote many letters home, and in the last he announced his intention of returning to England in a sailing vessel known as the Bella. The ship never reached port, and it was supposed she had gone down with all on board.

Mother's Credulity.

The Tichborne family, all save the mother of the unfortunate Roger, believed that he had gone down in the Bella. Lady Tichborne advertised for many years for information concerning her missing son, and every night a lighted candle was kept in his bedroom as a beacon for his return. Meantime the death of Roger had been legally proved and the estates and title had passed to his brother, Alfred Joseph, who died in 1866, the year of Henry's birth.

In 1869 a butcher of massive proportions, who had read in the newspapers an advertisement seeking information about the missing heir to the baronetcy, came to London from Australia, and professed that he was Sir George Tichborne. It was one of the most audacious claims ever made, and its author came to be known as "The Claimant."

He pretended to have gone through wondrous adventures, finishing up with his settlement as a butcher at Wagga-Wagga, in New South Wales. The pretensions of the man were supposed chiefly by the fact that Lady Tichborne "recognized" him as her son.

It was shown, however, at the trial that her mind was so possessed by the belief that Roger Tichborne was still living that her recognition was of no legal value as evidence.

One witness who called himself

Jean Luic, swore most circumstantially to the story told by the Claimant, but he was convicted of perjury and sent to prison.

The cause was first heard in the Common Pleas, before Chief Justice Bovill, where, strange to say, it attracted only a moderate amount of attention, though it lasted 103 days. At the end of this period the claimant elected to be non-suited. He was immediately arrested on a charge of perjury, and brought to trial before Chief Justice Cockburn.

This was in 1873, and the case, full of dramatic surprises from day to day, lasted for 188 days, from May, 1873, till February, 1874. Eventually the jury found that the pretended Roger Tichborne, was in fact Arthur Orton, a native of Winnipeg, and, being found guilty of perjury, he was sentenced to fourteen years' penal servitude.

Death of the Claimant.

The trial provided a crescendo of sensations. Not the smallest of the remarkable features of the case were a famous speech of Sir John Coleridge, of almost unprecedented length, in the Common Pleas, the persistency of Dr. Kenealy, the claimant's counsel, and a remarkable summing-up by the Lord Chief Justice.

The two trials are said to have cost something like £200,000, and of this the Tichborne estates were mulcted to the extent of £90,000.

The claimant was liberated in 1884, and died in obscure lodgings in Marylebone, April 2, 1898, having admitted some time before his death that he was Arthur Orton.

Sir Henry Tichborne was the twelfth baronet, the family being an ancient one, said to have been of great importance in Hampshire before the Conquest, and to have derived its name from the River Itchen, at the head of which it had estates.

Sir Henry was a keen traveller, and fond of hunting big game in India and Africa. Lady Tichborne shared her husband's interests and pursuits, and accompanied him on his expeditions. While High Sheriff he went away on one of those tours, and was fined £500 for not attending the Judge of Assize at a court. It is said that the late baronet possessed one of the finest collections of guns and other firearms in England.

One of the famous traditions of Tichborne Park is the Mabella Dole, which comes down from the days of Henry III. Mabella was the wife of the head of the Tichborne family of those times, and when dying she is reported to have pleaded with her husband to give the poor annually a certain part of the produce of the estate, predicting that if the pious duty were neglected certain grave misfortunes would befall the family.

It is said that at one time the doles were intermitted, and, of course, the curse came, as curses do—in legend. At any rate, the Mabella Dole has, it is understood, been revived.

A "CHARACTER" IN FRANCE

The Complications Resulting From An Unwritten Law.

(Paris Correspondence of London Globe.)

It is an unwritten law in France that you must never say anything bad about a servant or employe in his "character"—that is to say, if you cannot say anything good you must content yourself with a non-committal statement which will not compromise his prospects. For instance, if you have caught your cook robbing you in such a shameful and impudent fashion that you are obliged to dismiss her, you may not state on her "certificat" that you have dispensed with her services because you found she was dishonest. That, it is held, might prevent her obtaining a situation elsewhere, and as everyone has to earn his bread the cook must be given the opportunity of recommending her larceny elsewhere. All that you are entitled to say on her "character," if you will not lie and pay her compliments, is that she entered and left your service on certain dates. But apparently it is just as dangerous to give flattering information regarding an ex-employe when it is not justified.

Some years ago Mme. Cheremetteff, one of the few lady horse owners in France, had a trainer in her service, a man named Juillard. Believing she had been cheated by him, the lady dismissed him and lodged a complaint against him with the authorities. But the charge was never followed up. Three years later an honorable family asked Mme. Cheremetteff for some particulars as to Juillard's character, he having requested the hand of Mile. M. in marriage. The young people seemed to be very fond of each other, and the parents of the young lady were apparently desirous of obtaining complimentary "renewals."

Mme. Cheremetteff responded by giving her ex-trainer a first-class character. The marriage took place. But as a husband Juillard left much to be desired. Not content with squandering all the money he could lay his hands on, he persuaded his wife to confide to him her "dot" of £2,400, and scattered it to the four winds in a very short space of time. The father of the bride learning later that Mme. Ch. remetteff had every reason to regret that she had employed Juillard, and that she was not justified in giving flattering "renewals" concerning him, brought an action against her, making her responsible for the union which had ruined his daughter, and as compensation he claimed the reimbursement of the £2,400 which she had advanced to her spendthrift husband and the payment of a further sum of £400 damages.

The case has just been decided in the courts, and the judgment shows the necessity of being careful in the matter of giving information regarding former employes. The court considered that, as the

couple Juillard was married under the regime of the "separation des biens," Mme. Cheremetteff could not be held responsible because the young wife, "sur l'oreiller," abandoned her "dot" to her husband. But it came to the conclusion that the fact of giving, in view of a marriage, favorable reports regarding a man of whom nothing good could be said, constituted a fault which made the person who supplied such information partly responsible for the unhappy consequences of the marriage. Therefore the tribunal, while it refused to order Mme. Cheremetteff to reimburse the "dot" of Mile. M., condemned her to pay the sum of £400 damages. Moral: When you are asked for "renewals" regarding a young man, give him a good character if you can, in all liberty of conscience. But if you can't, then give an evasive answer. It will save you trouble and perhaps money.

Mr. Quessel will be heard here with Melba on the 8th of September at the Auditorium.
